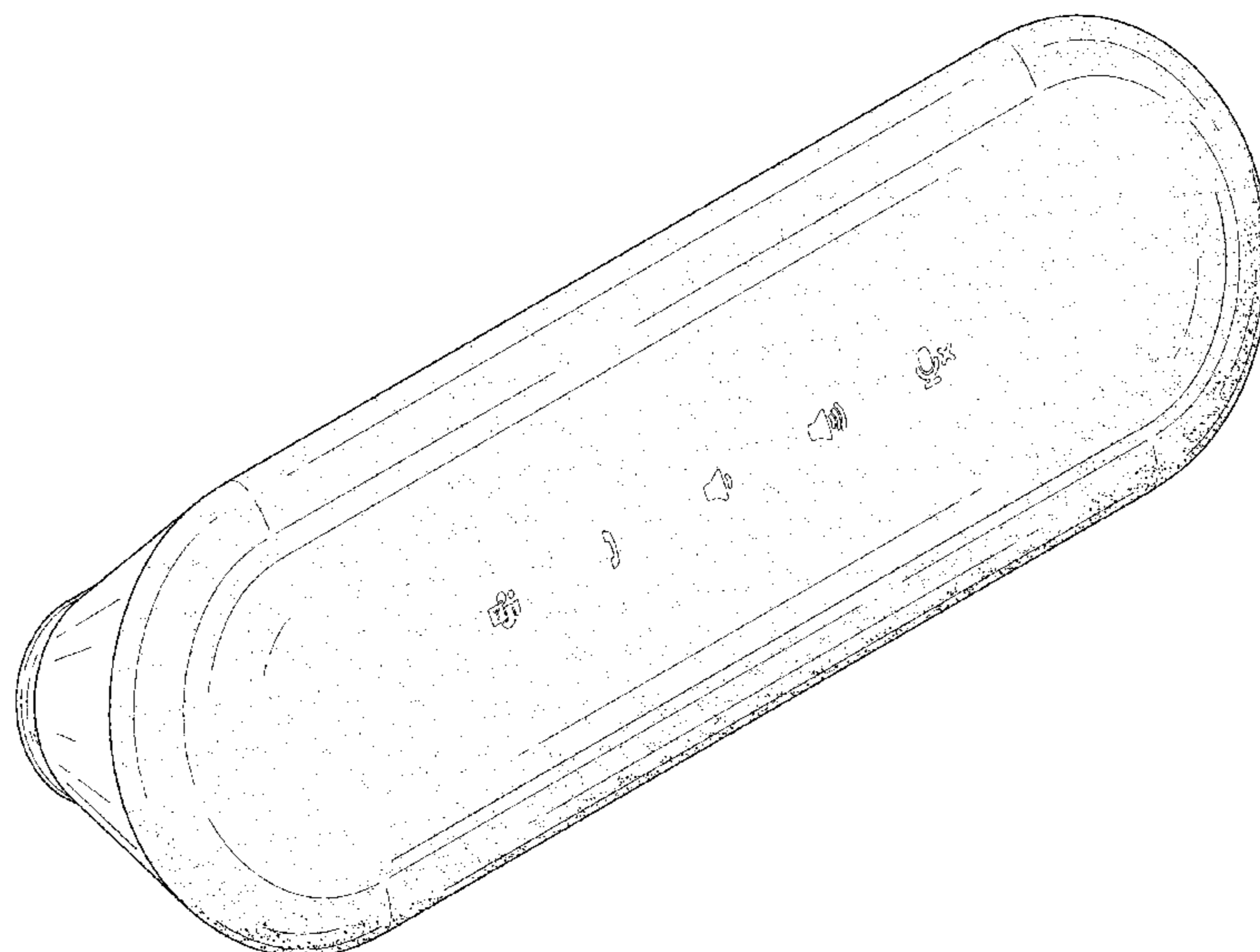
(57) **CLAIM**

We claim the ornamental design for a speakerphone, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the speakerphone comprising the present invention; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof. Broken lines shown in the drawings depict portions of the speakerphone that form no part of the claimed design.

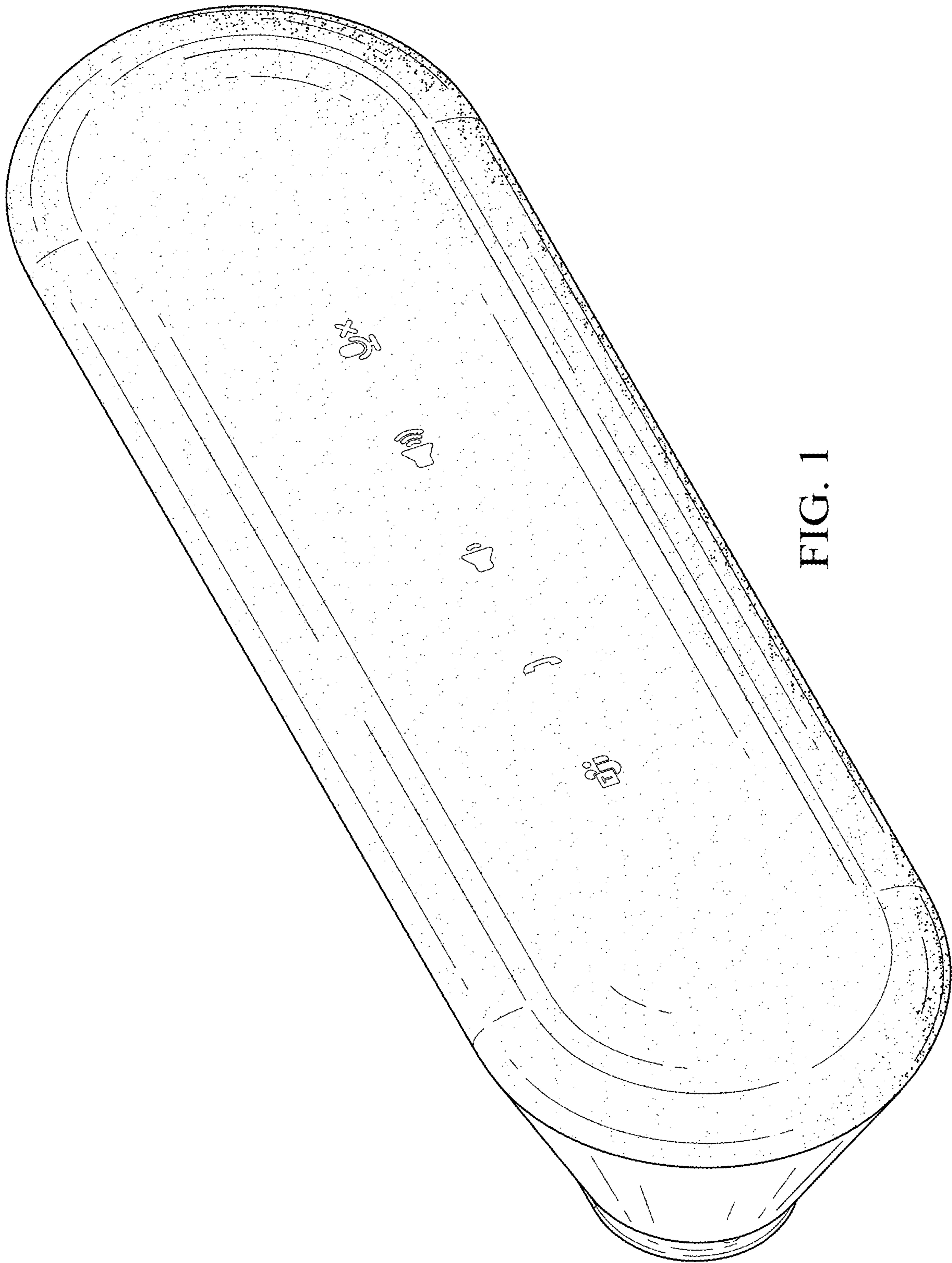

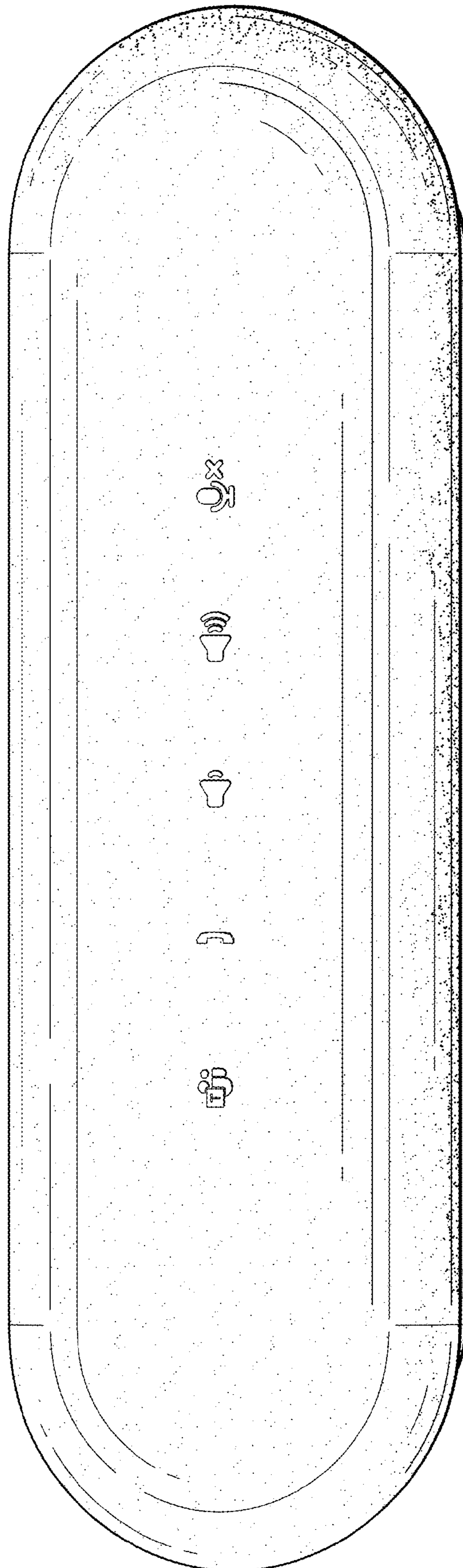

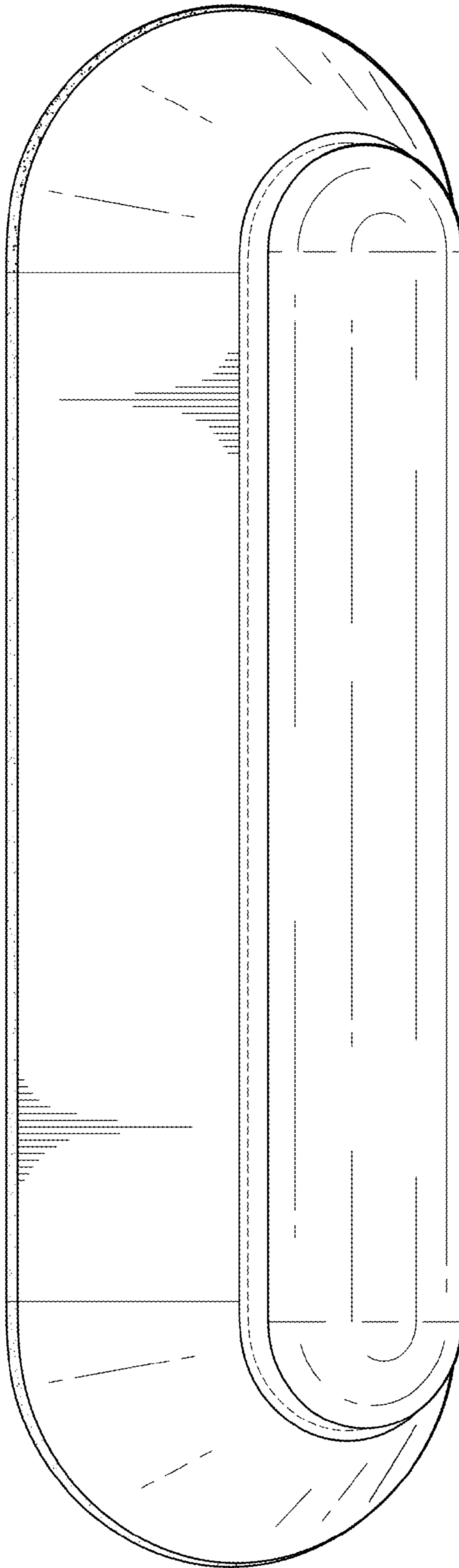

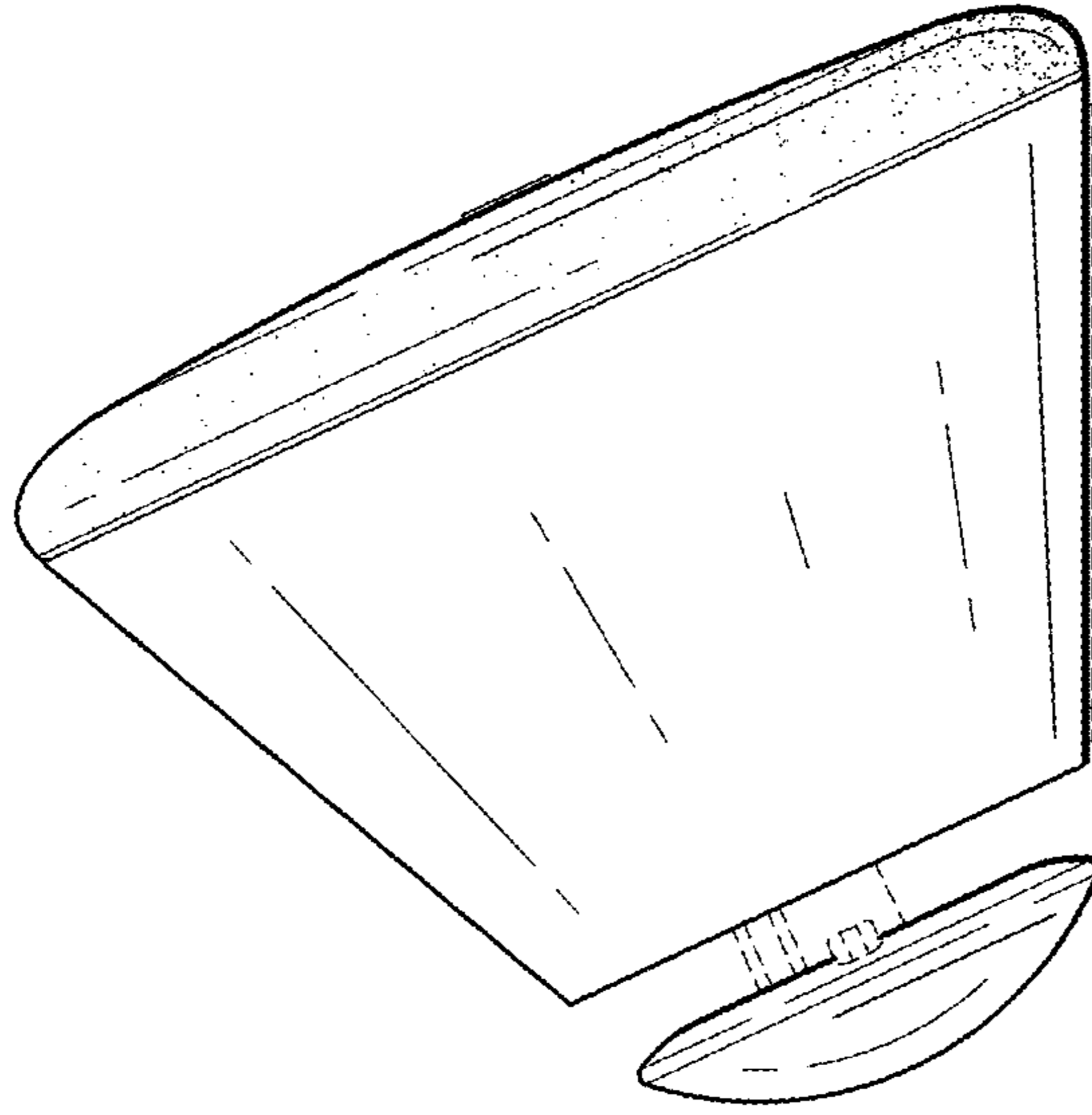

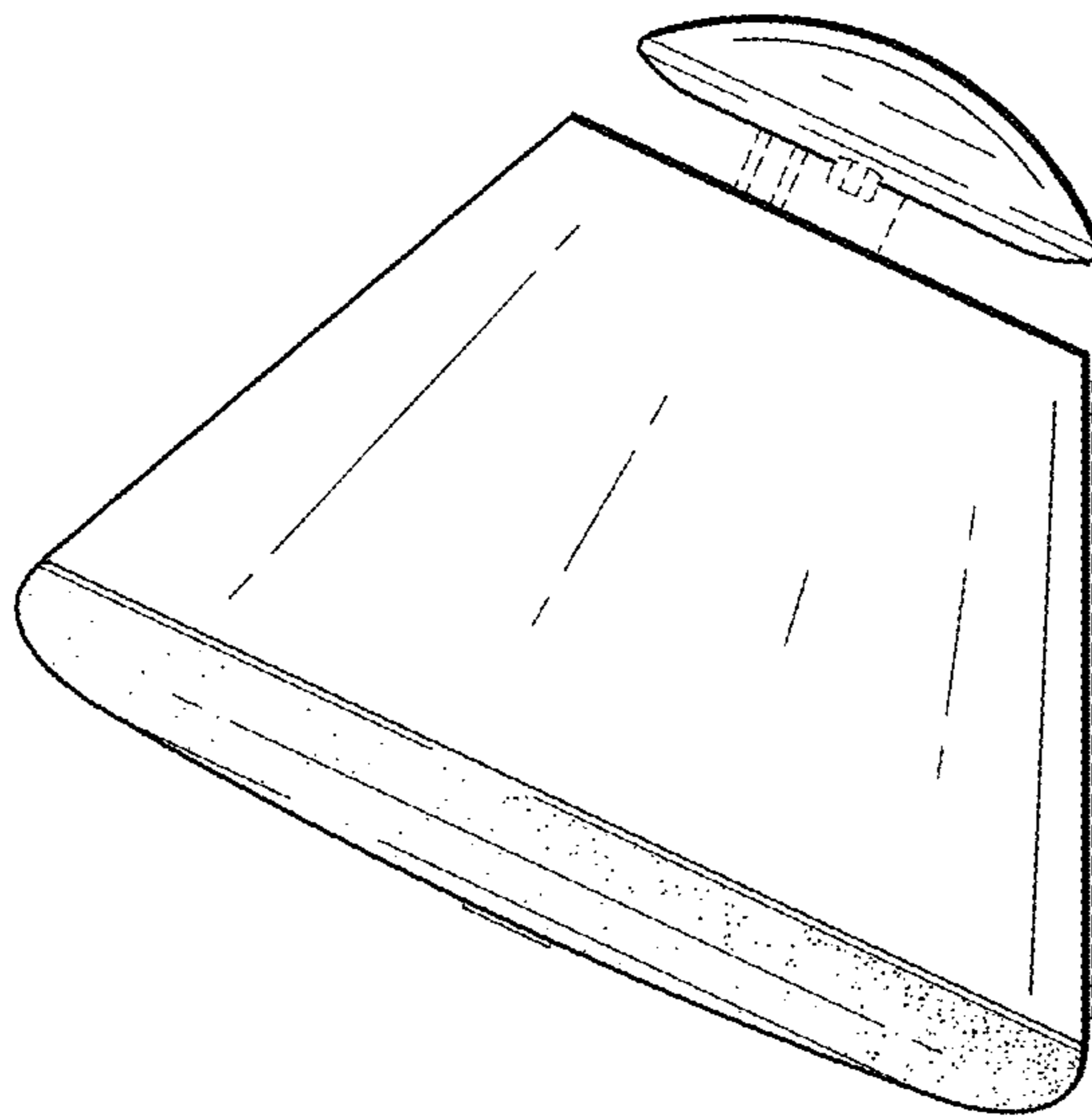

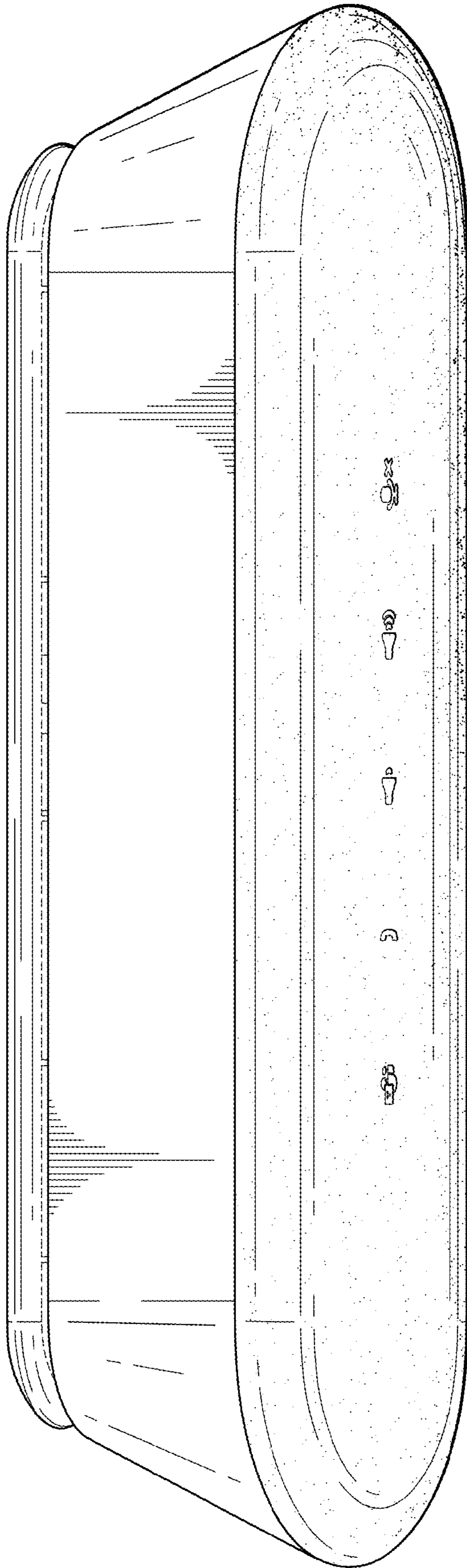

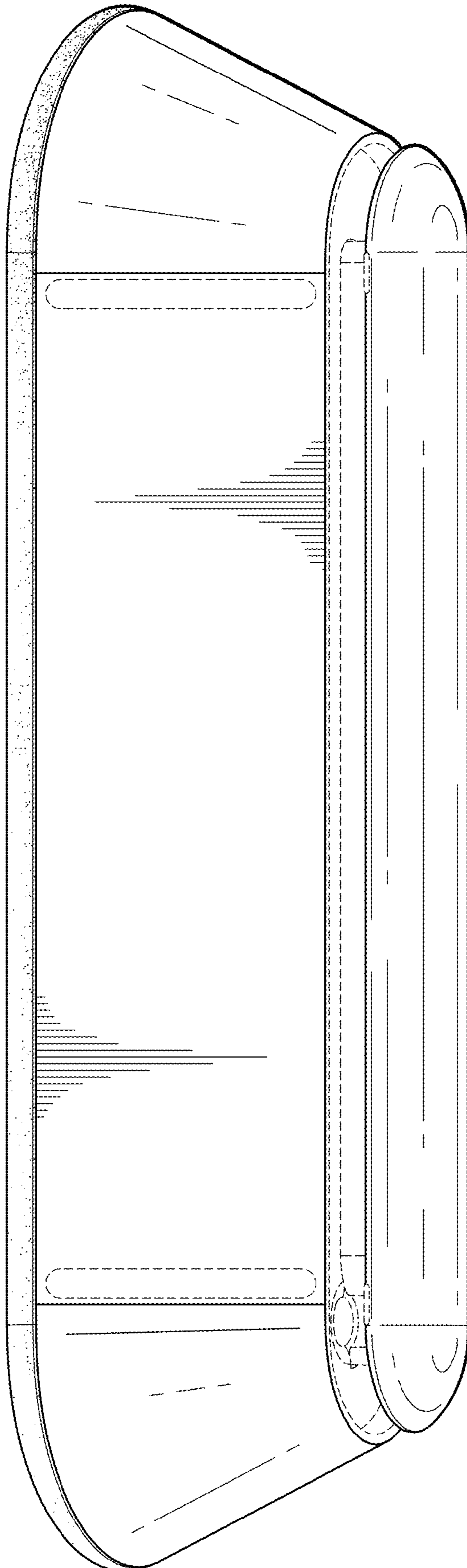
