(57) **CLAIM**

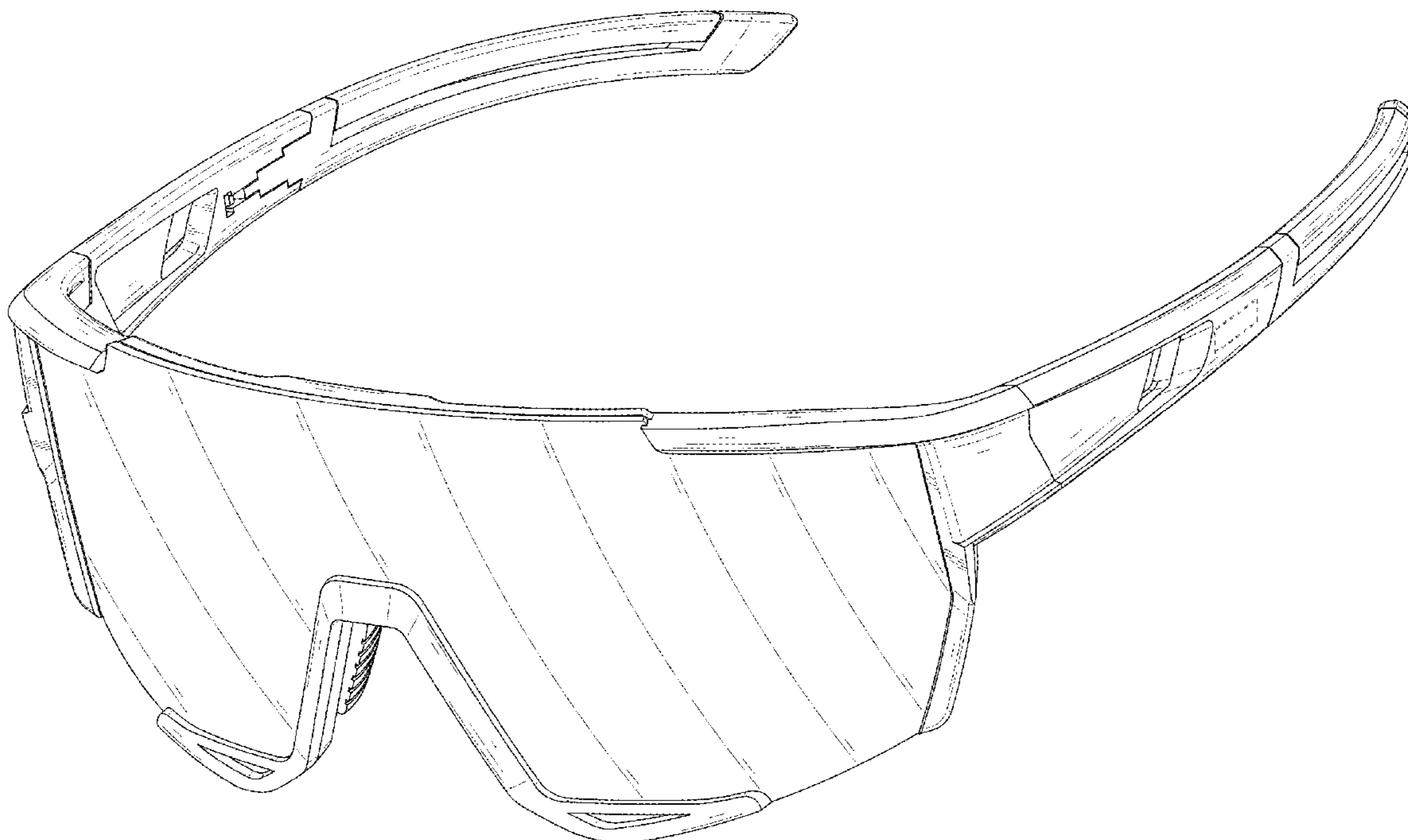
The ornamental design for sports glasses, as shown and described.

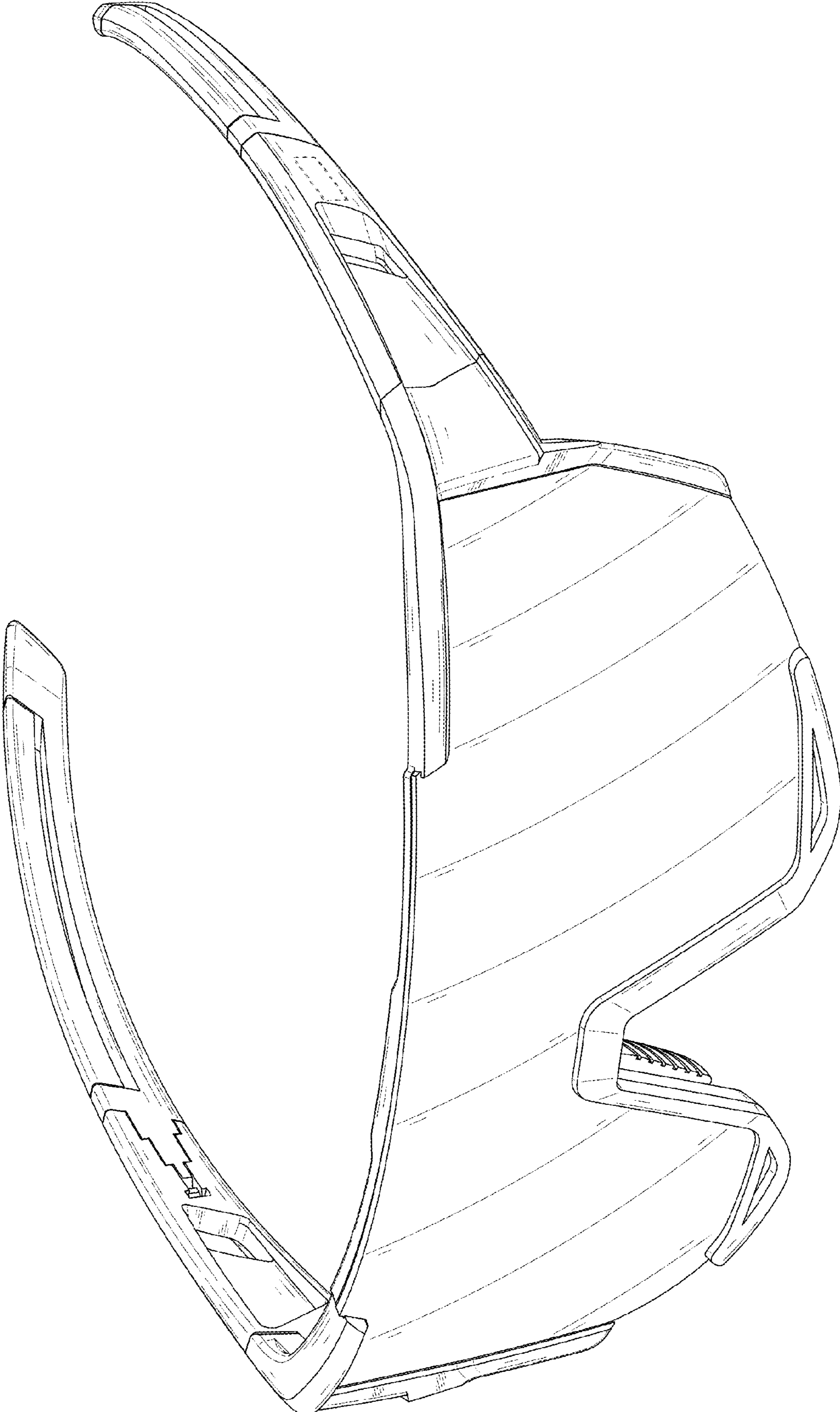

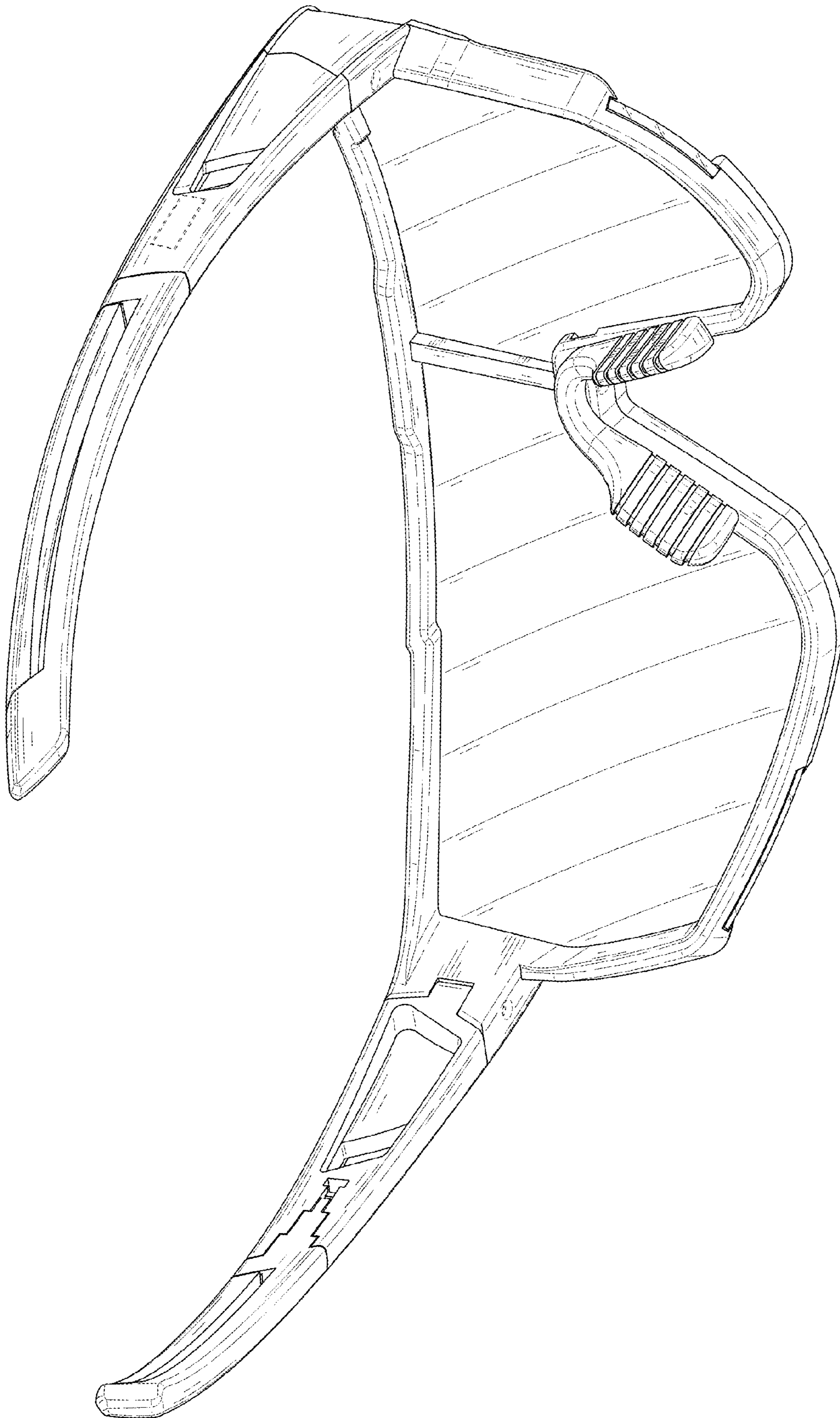

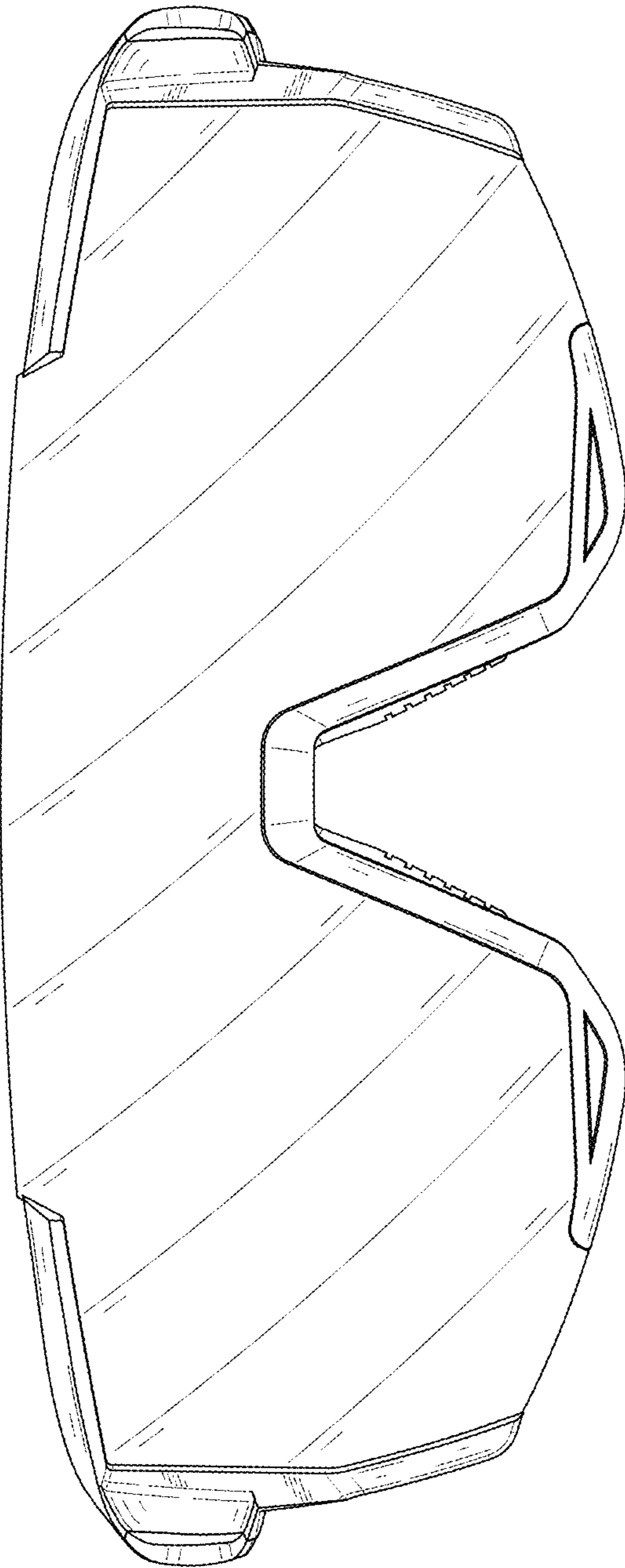

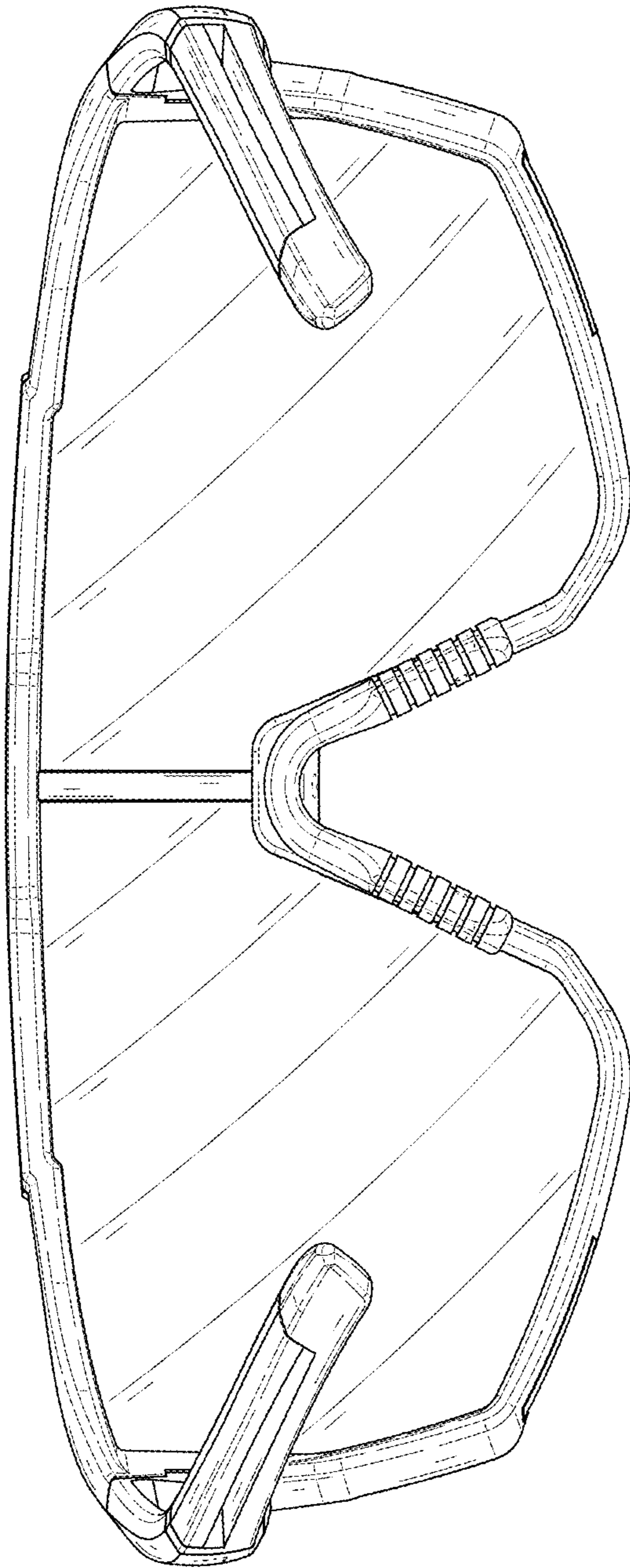

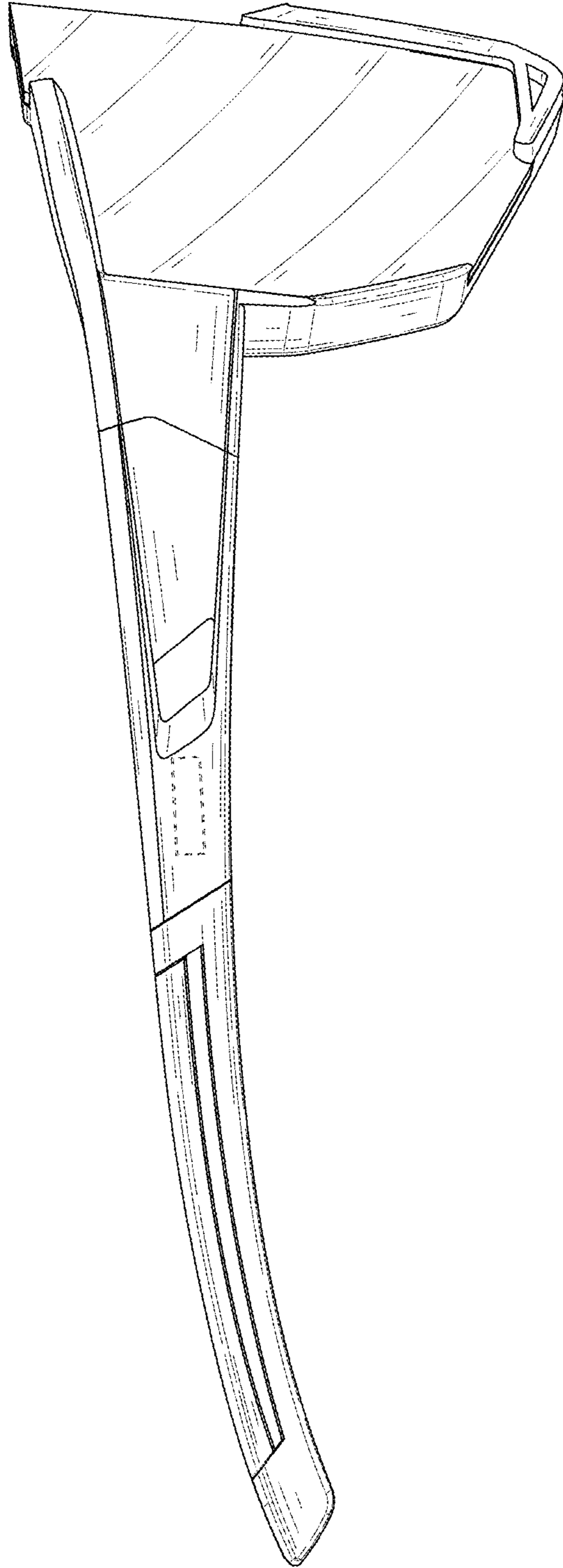

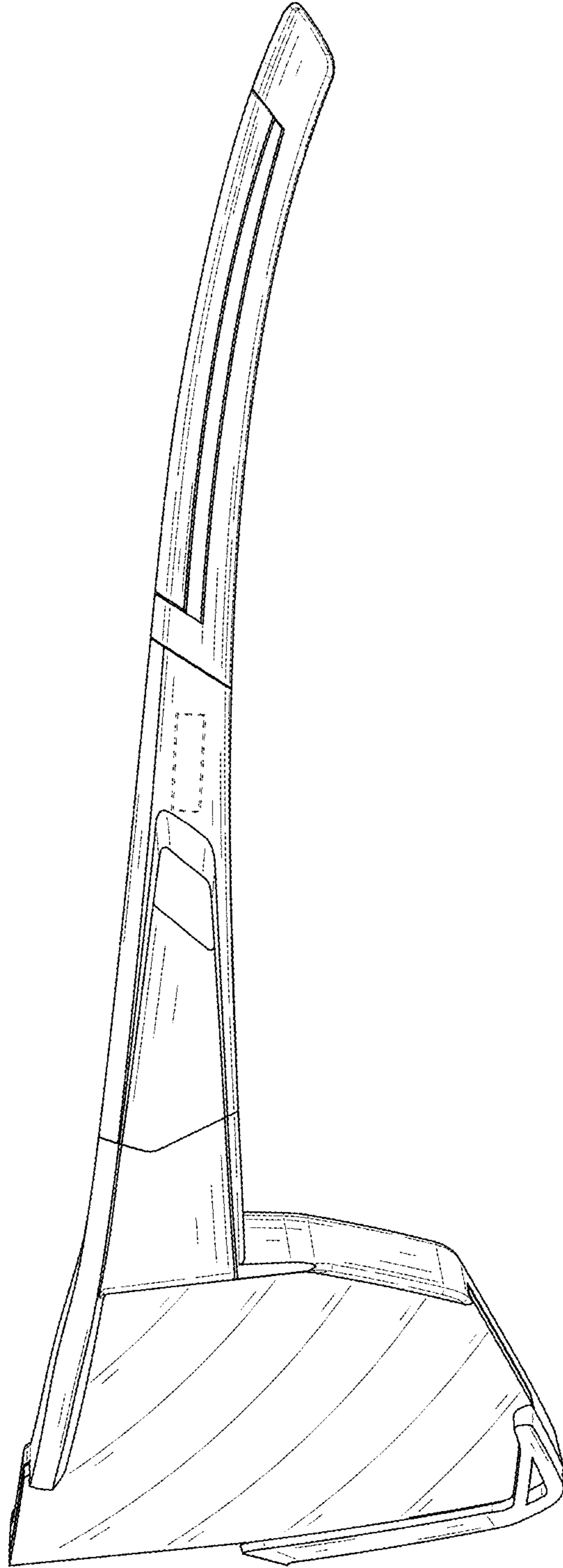

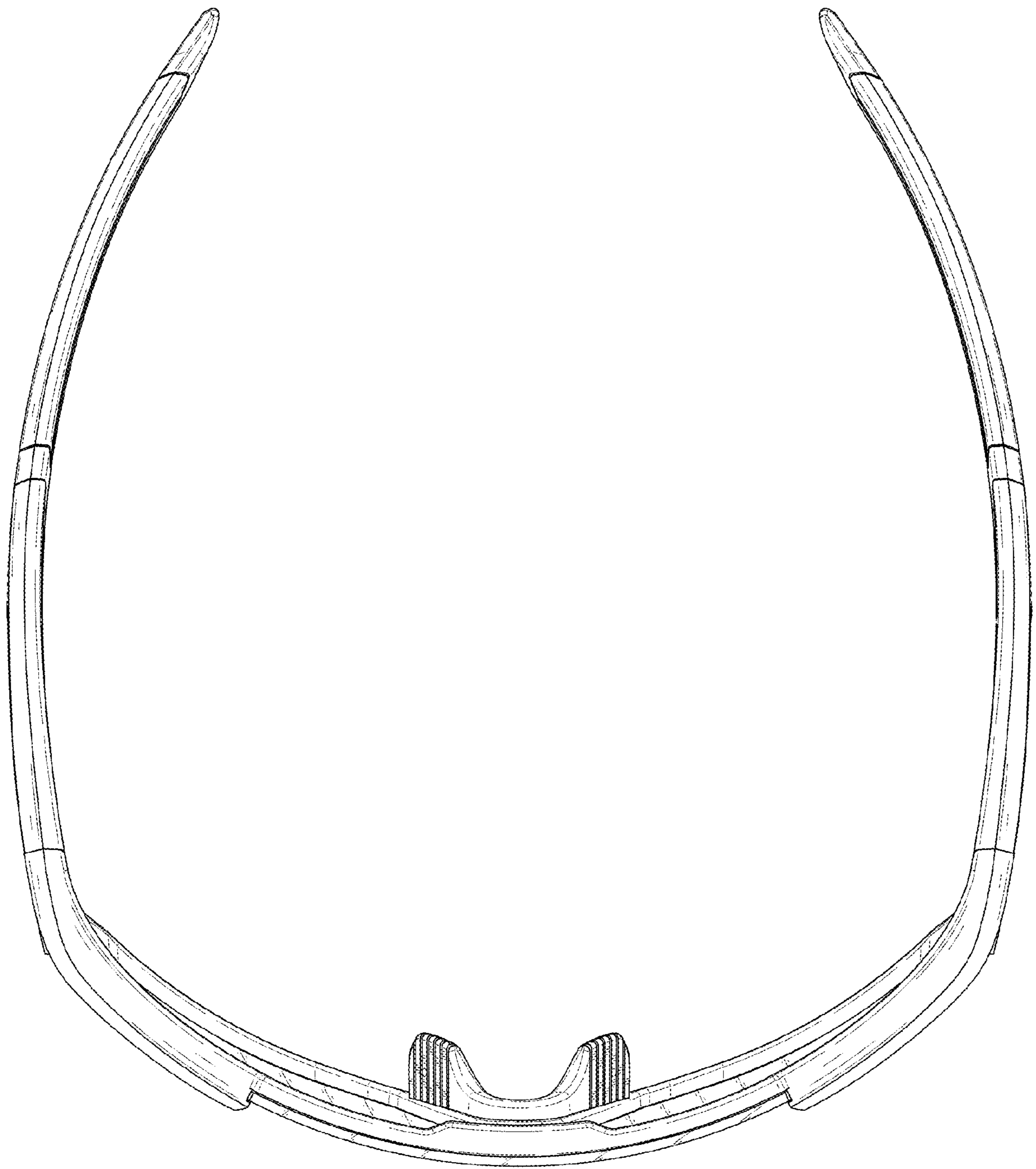

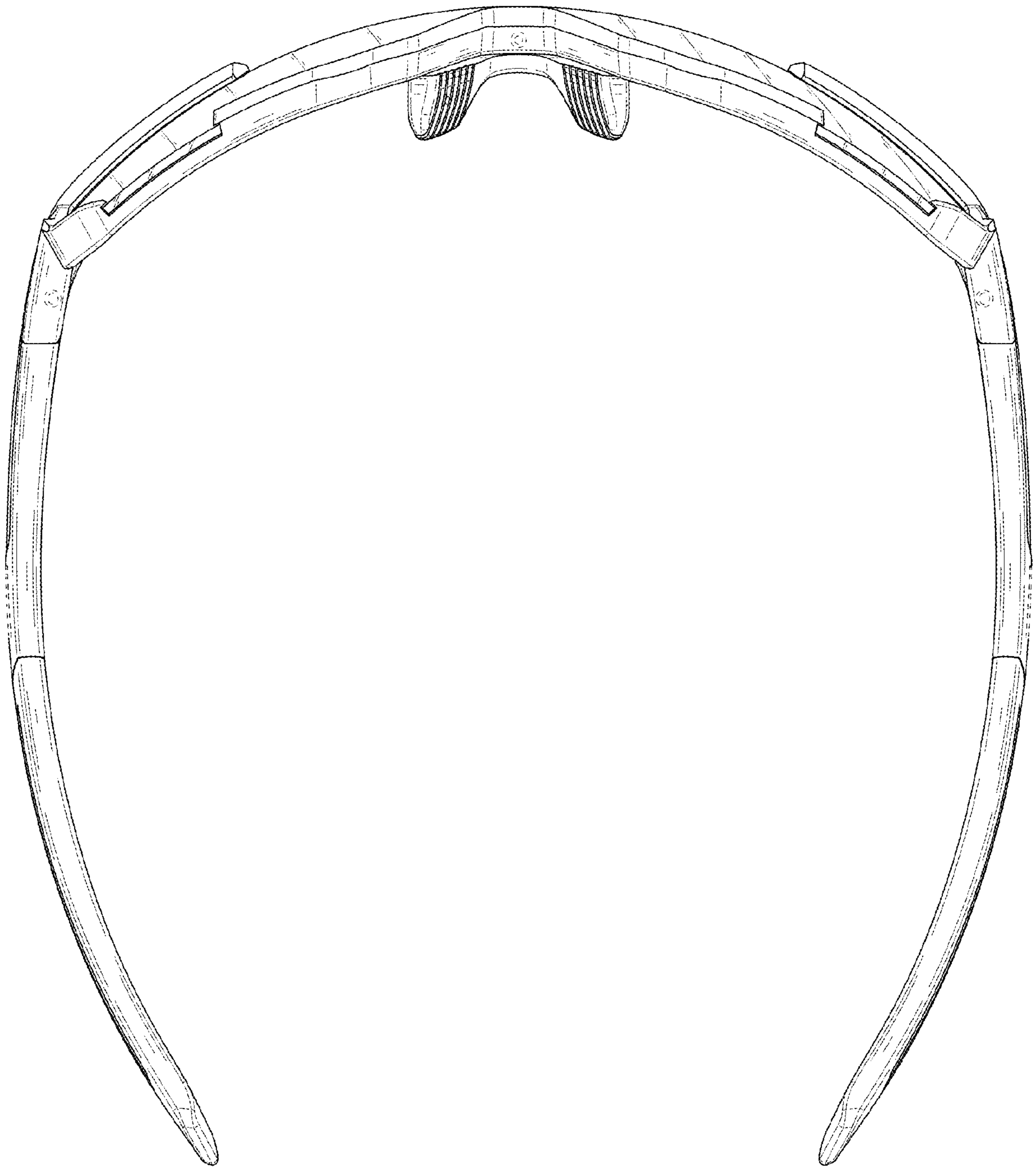
