FIG. 1.7 is a right side perspective view of a water purifier and dispenser.

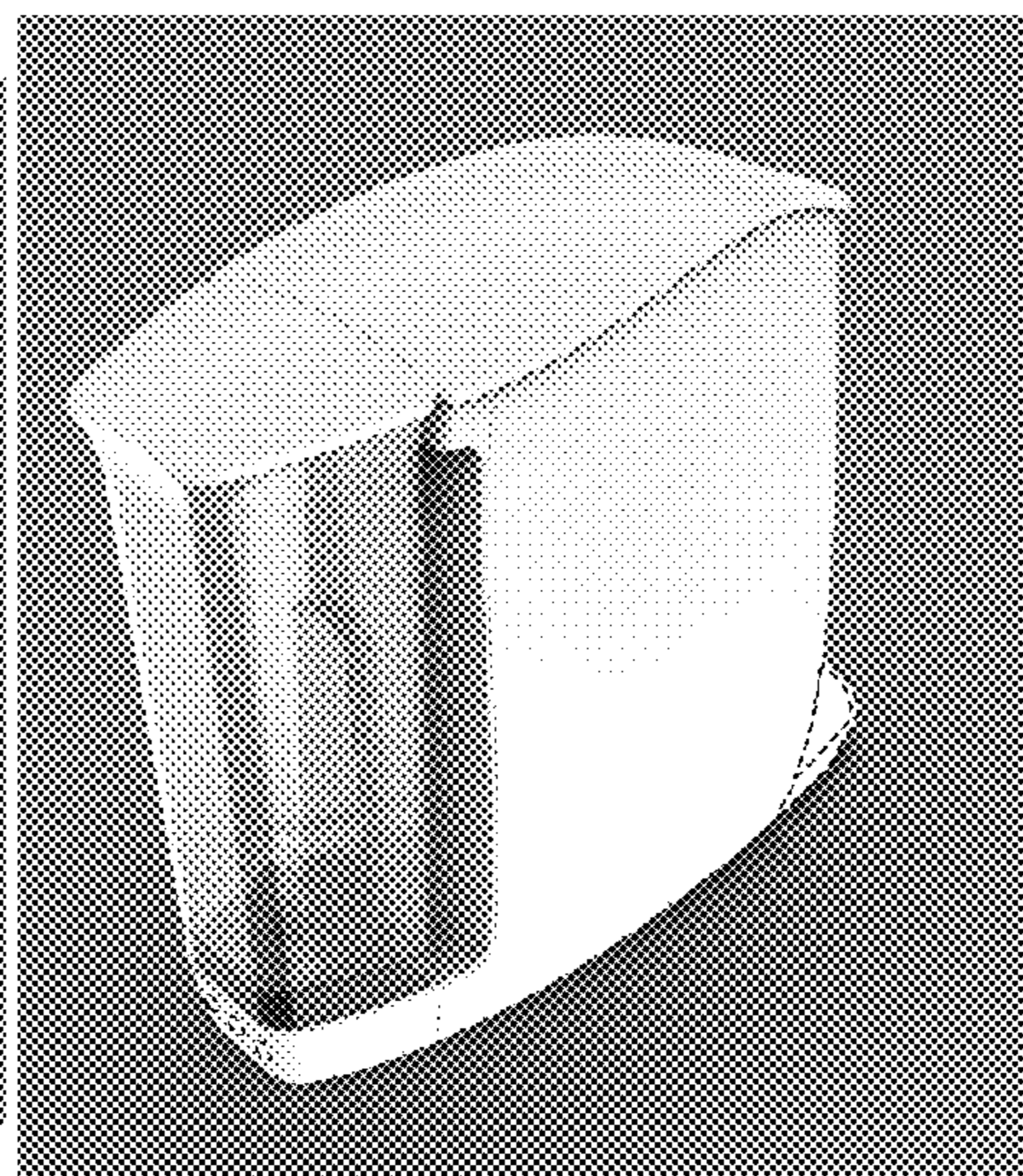
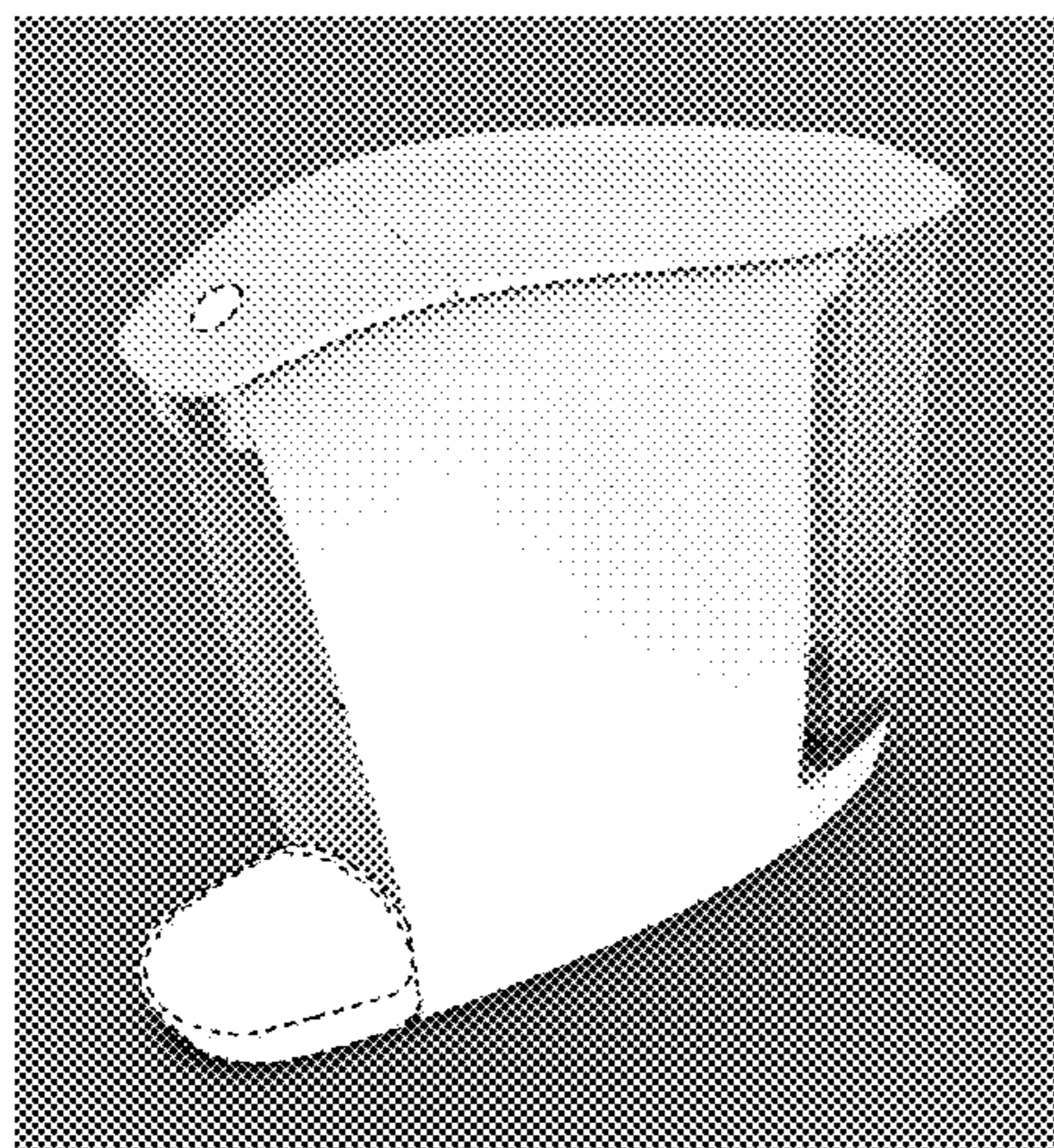
FIG. 1.8 is another top view of a water purifier and dispenser.

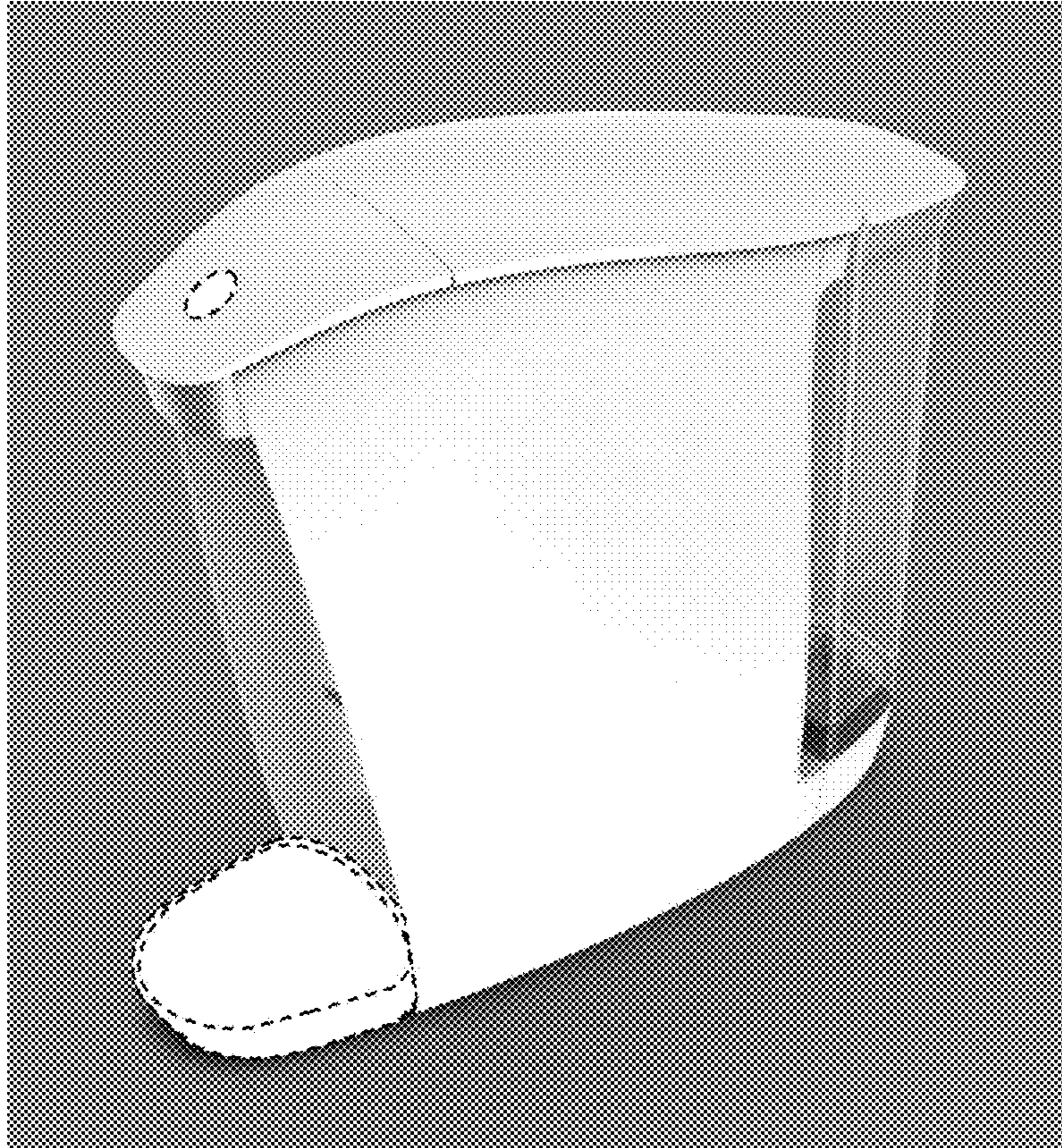

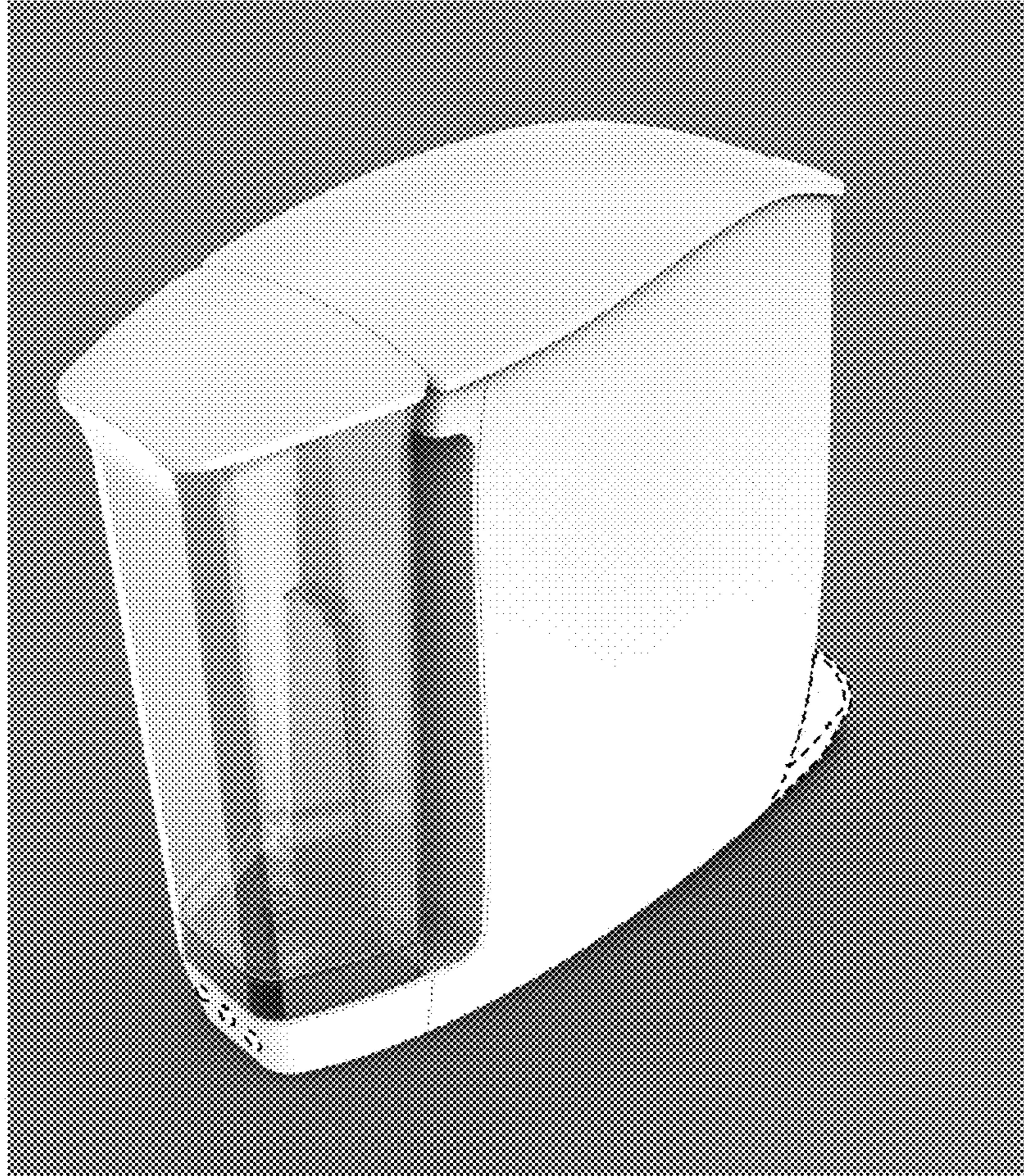

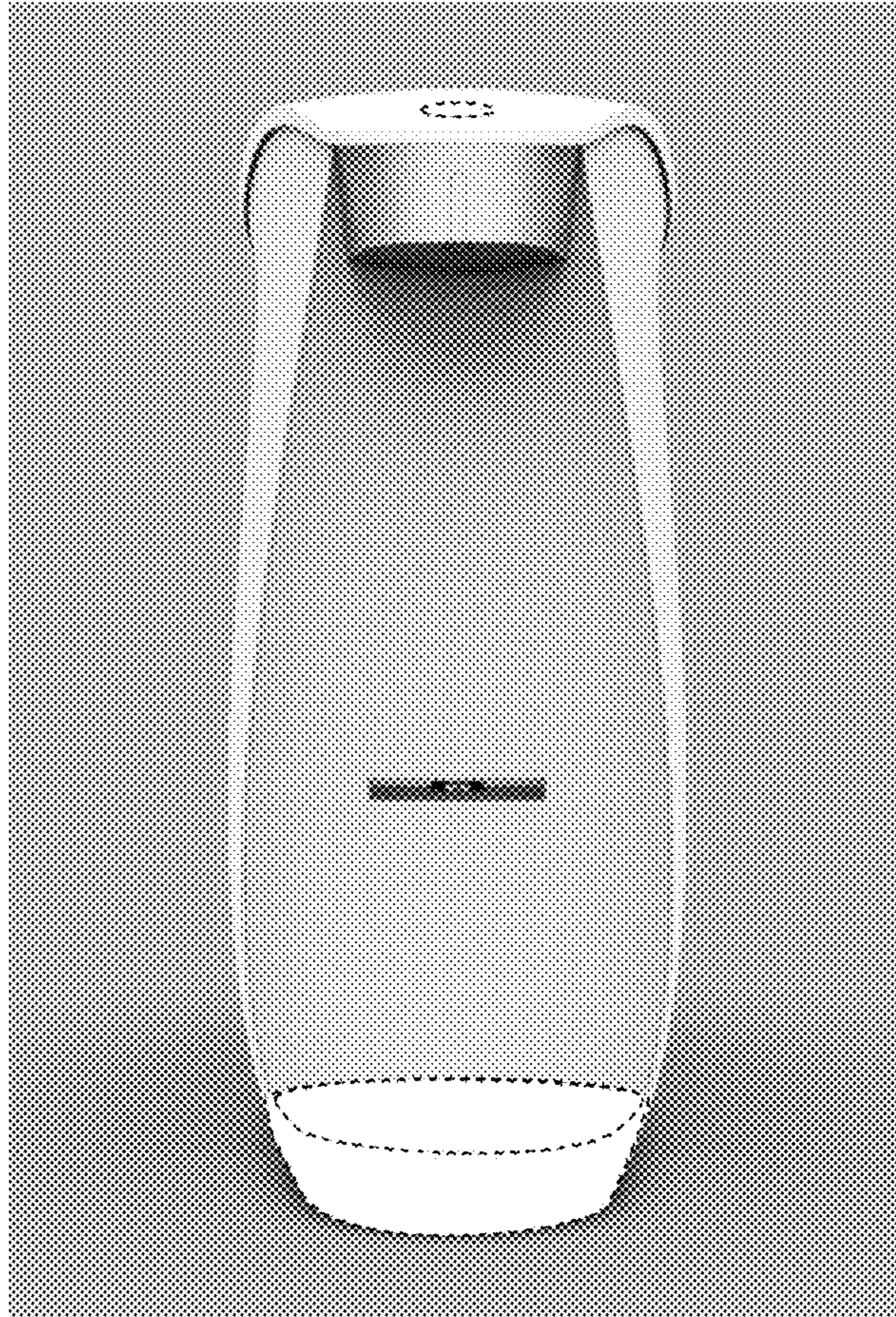

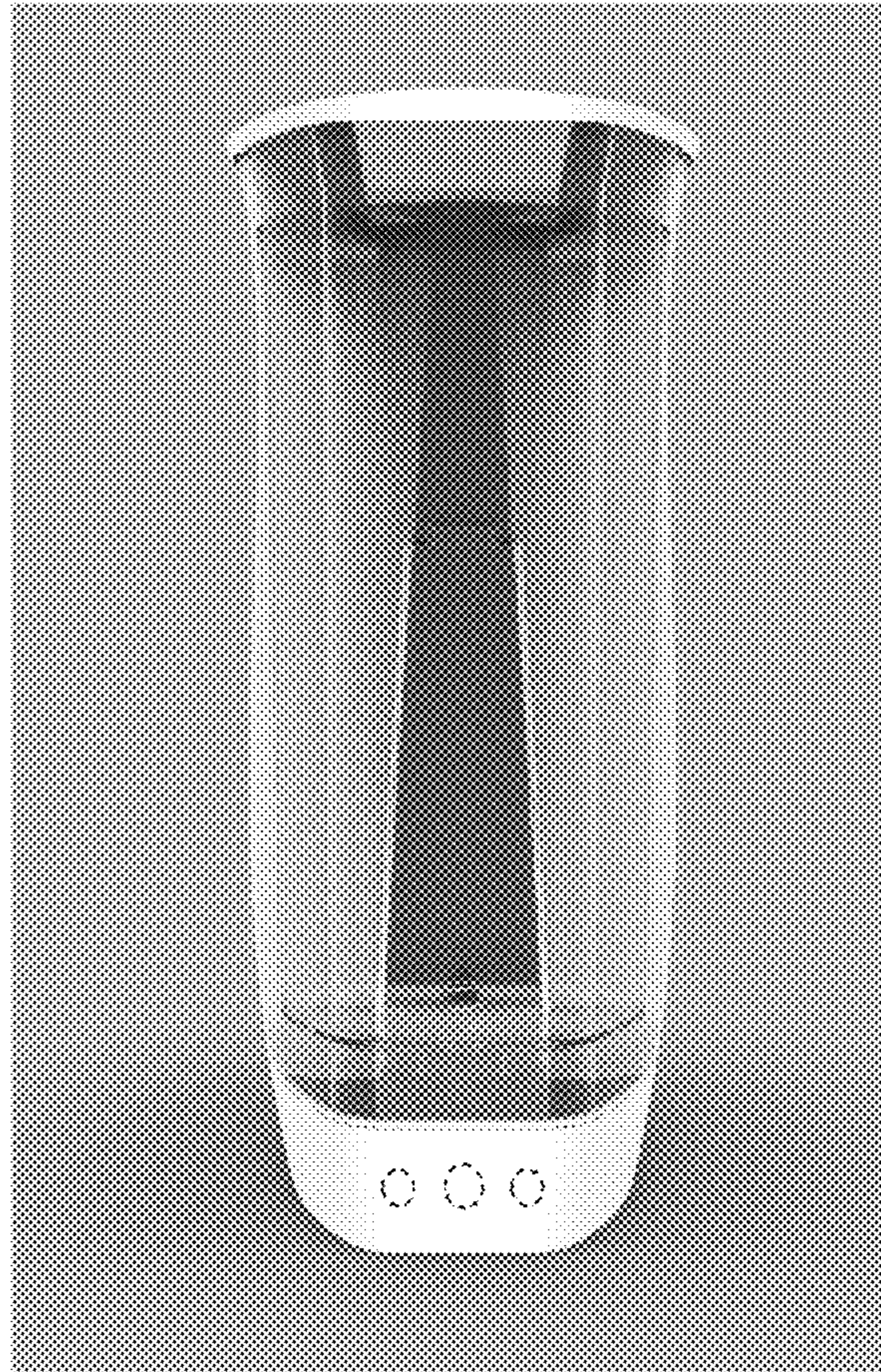

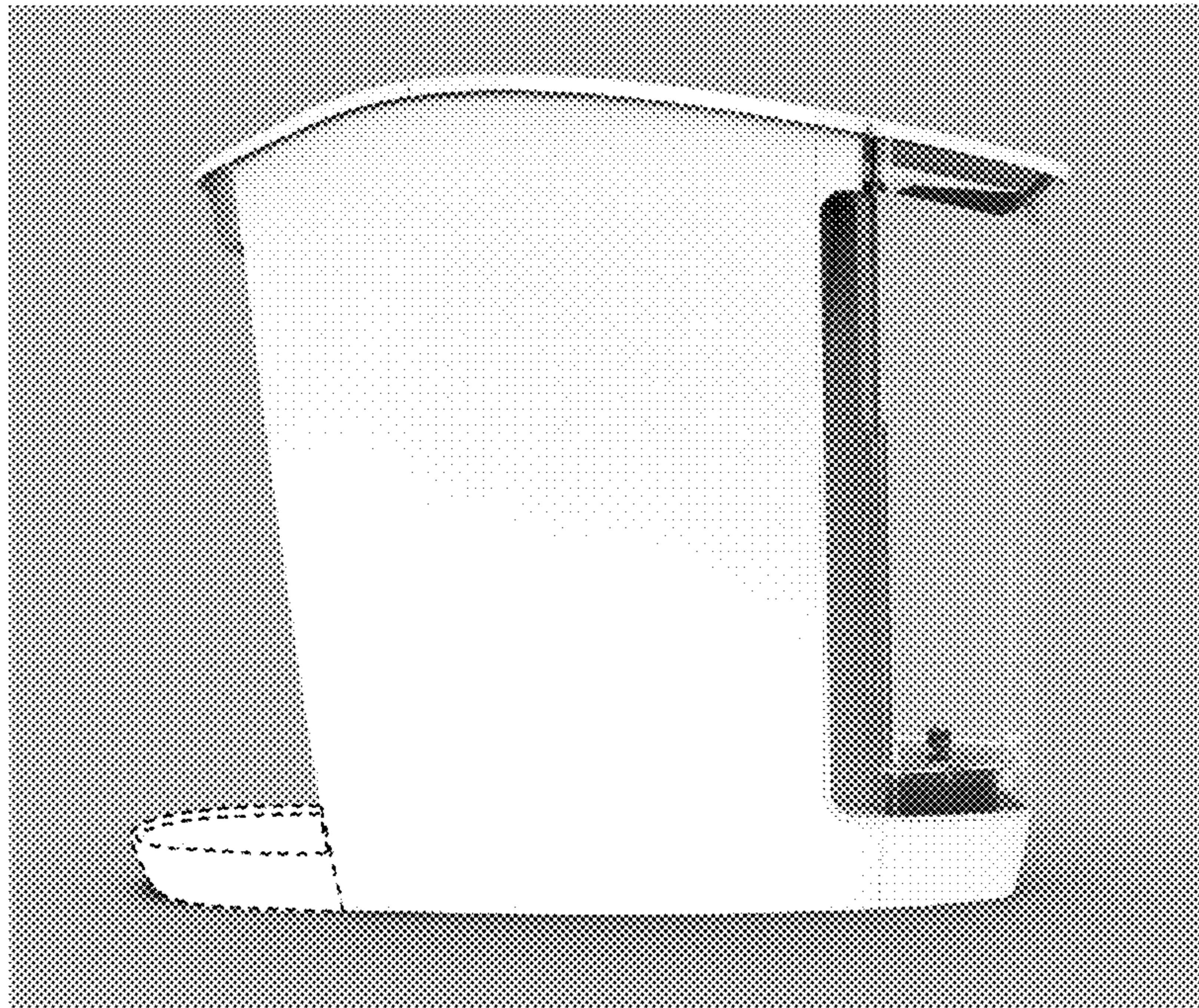

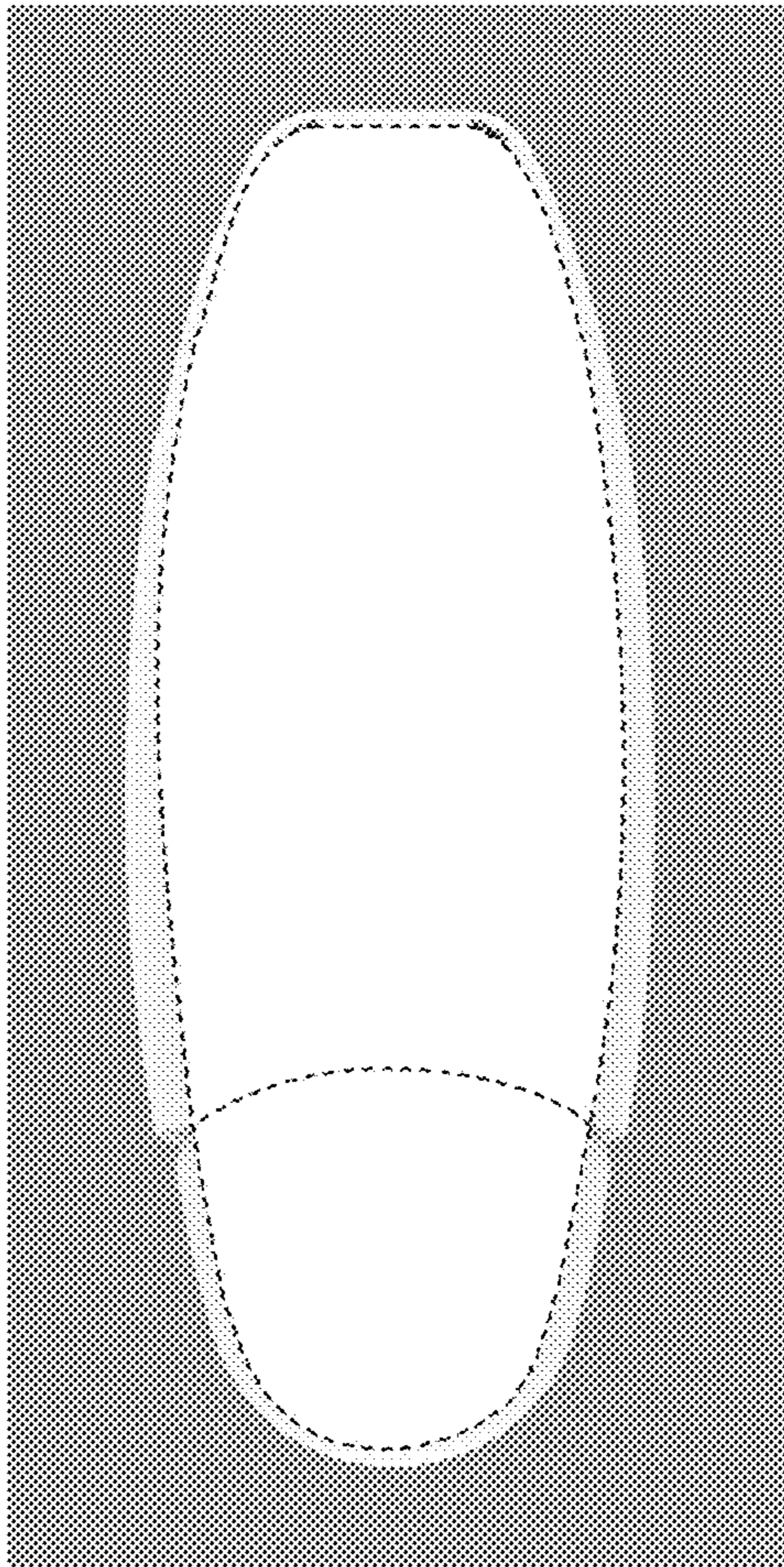

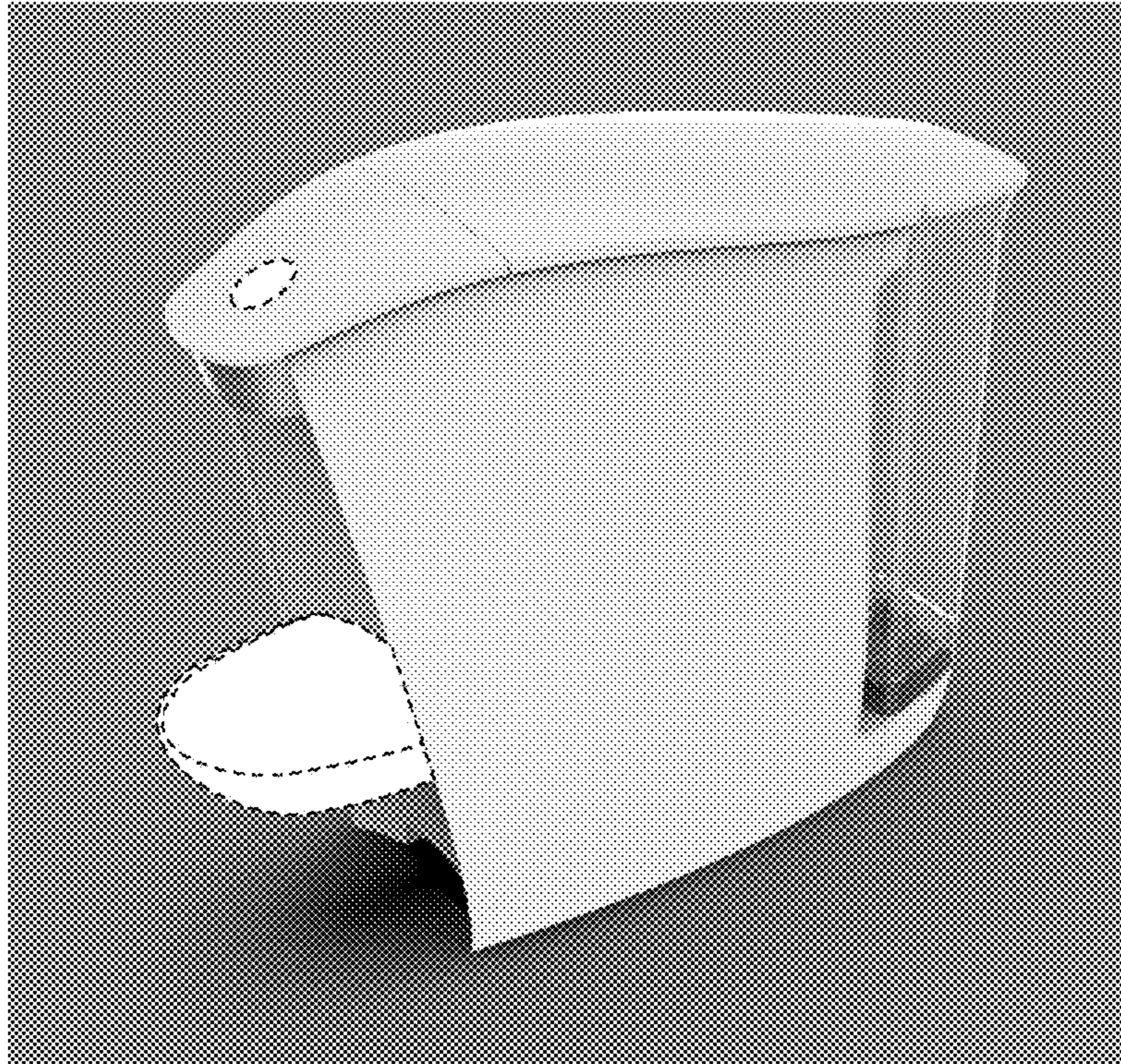

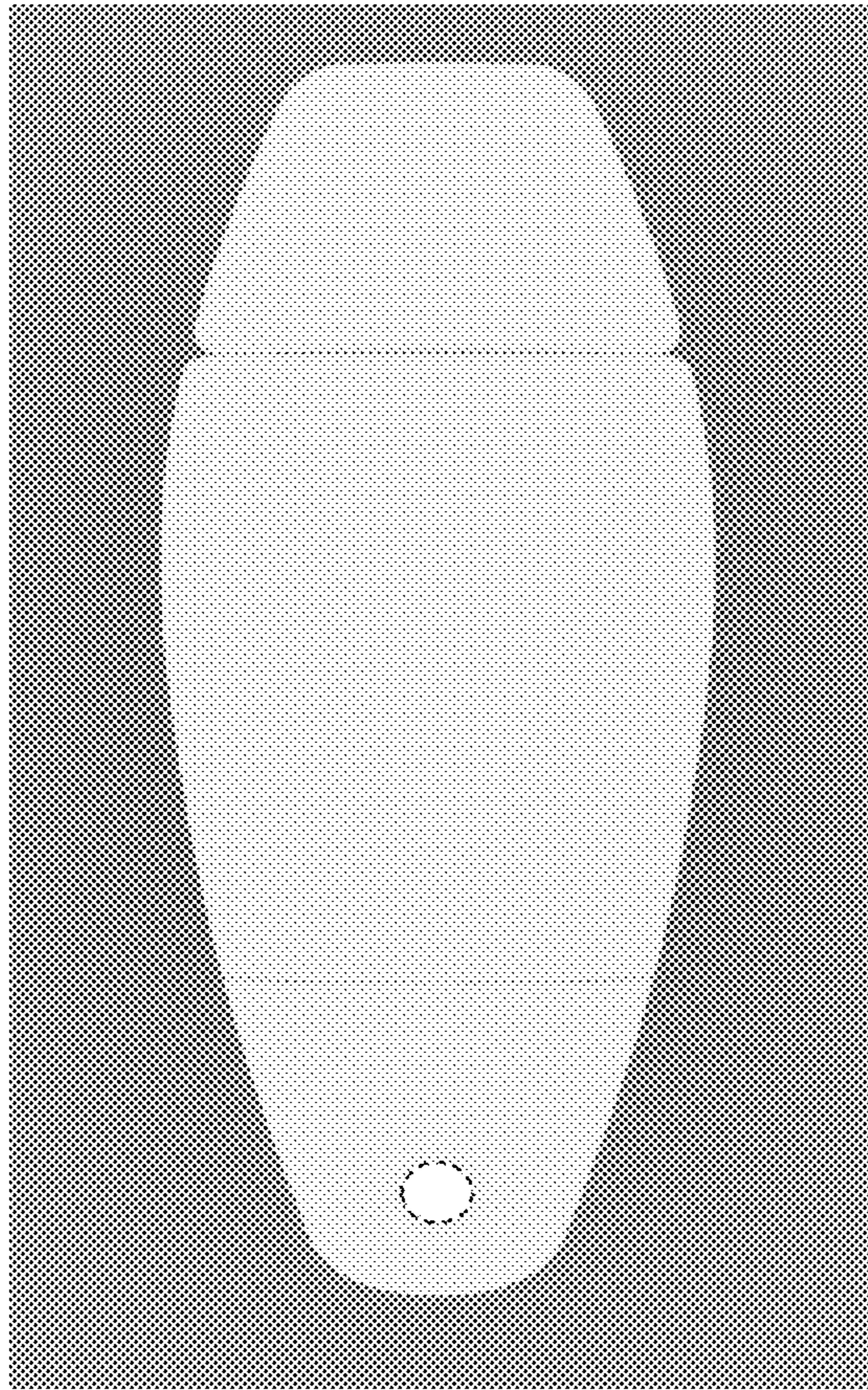

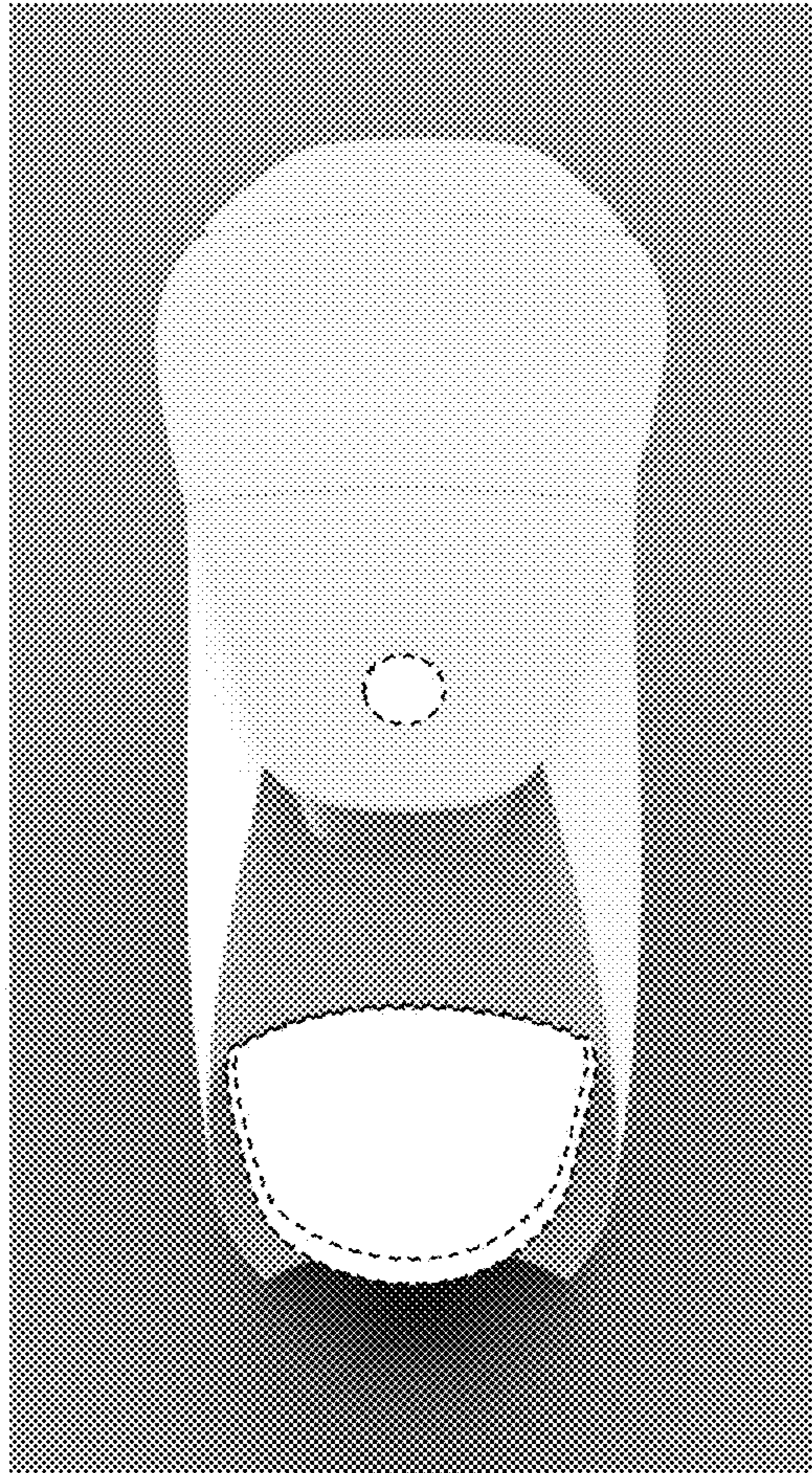

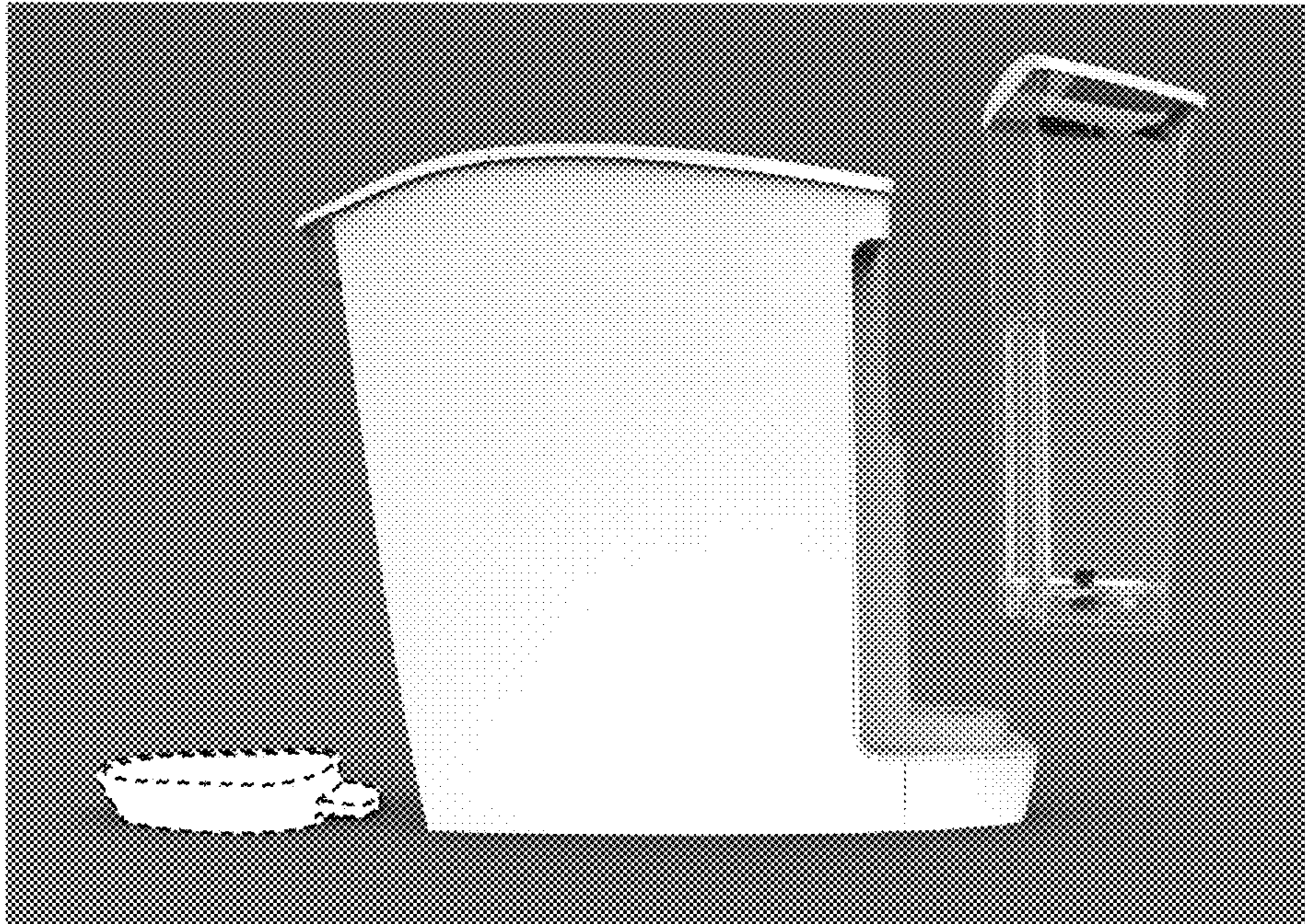
