FIG. 8 is a front perspective view thereof.

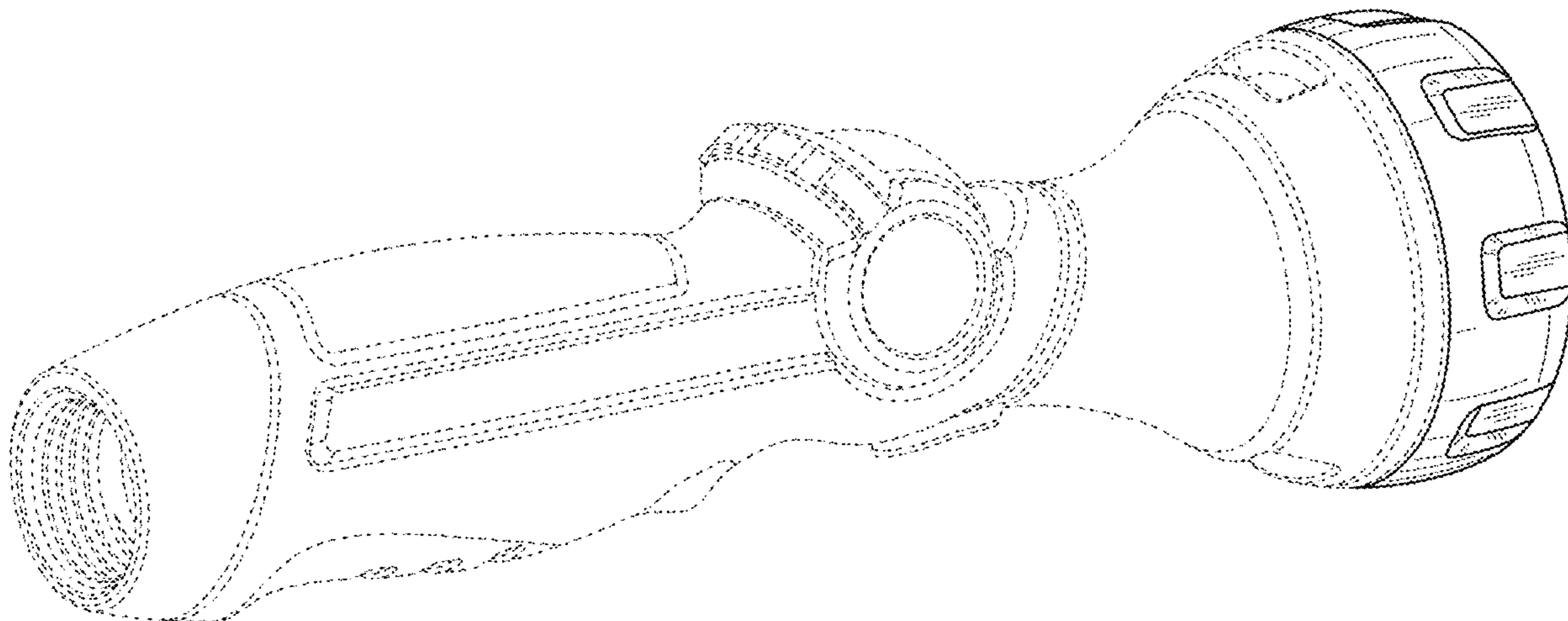

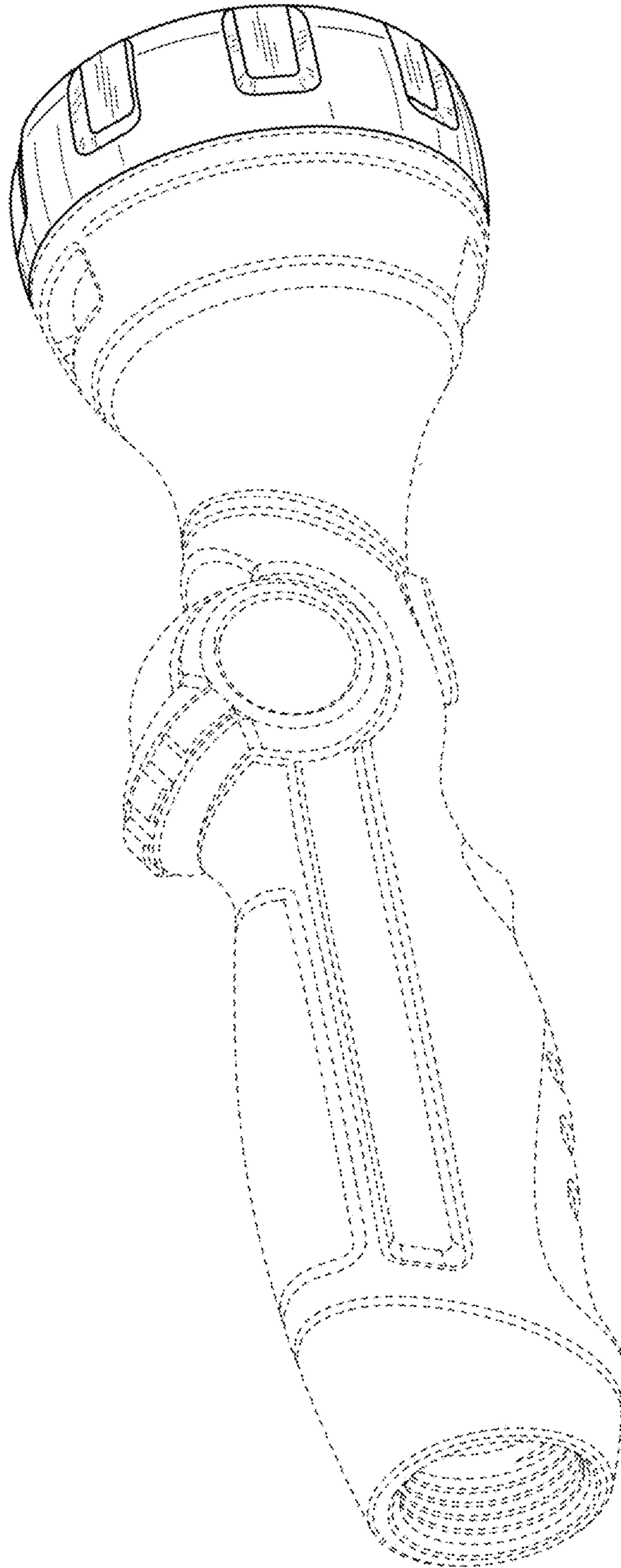

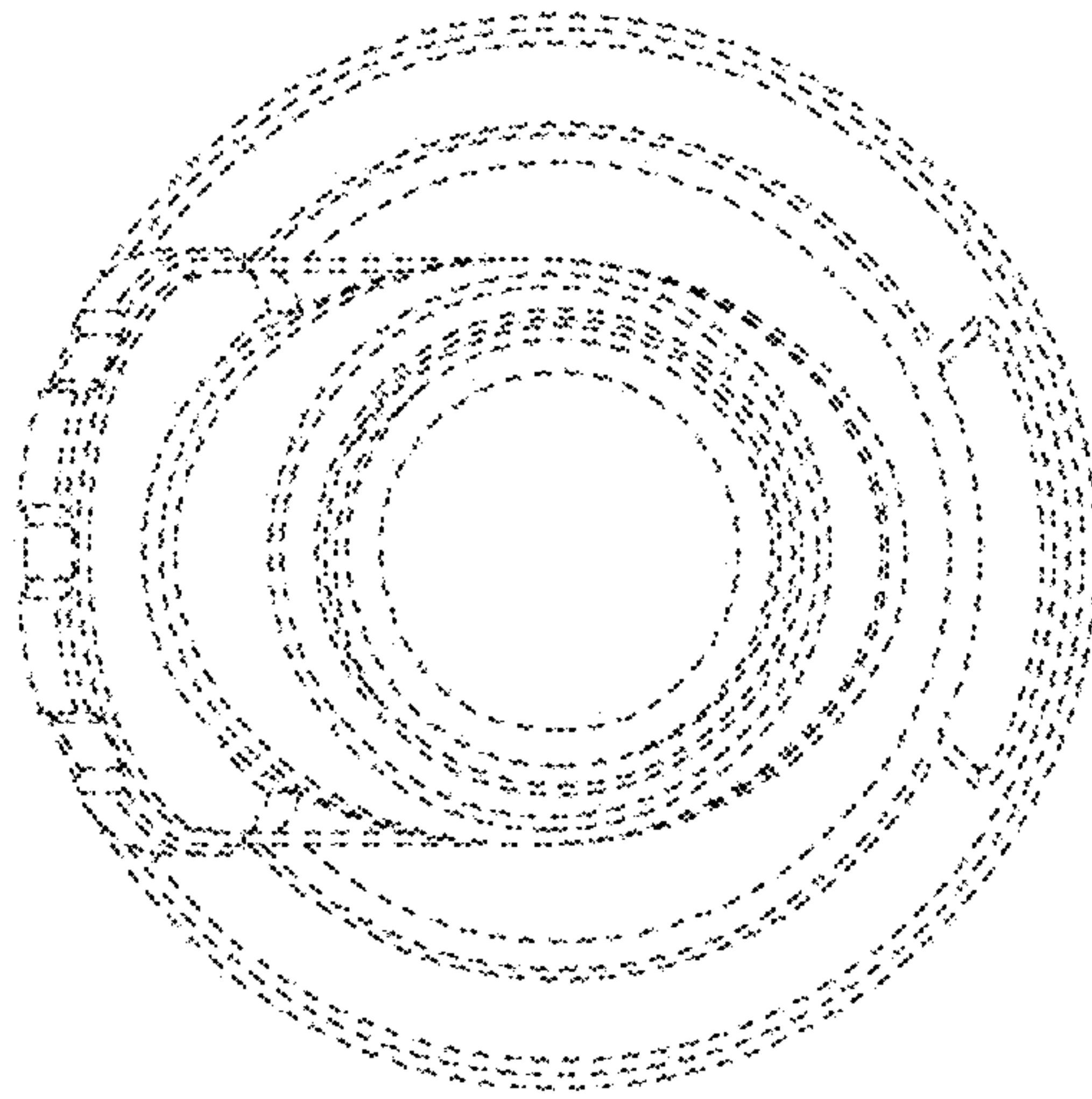

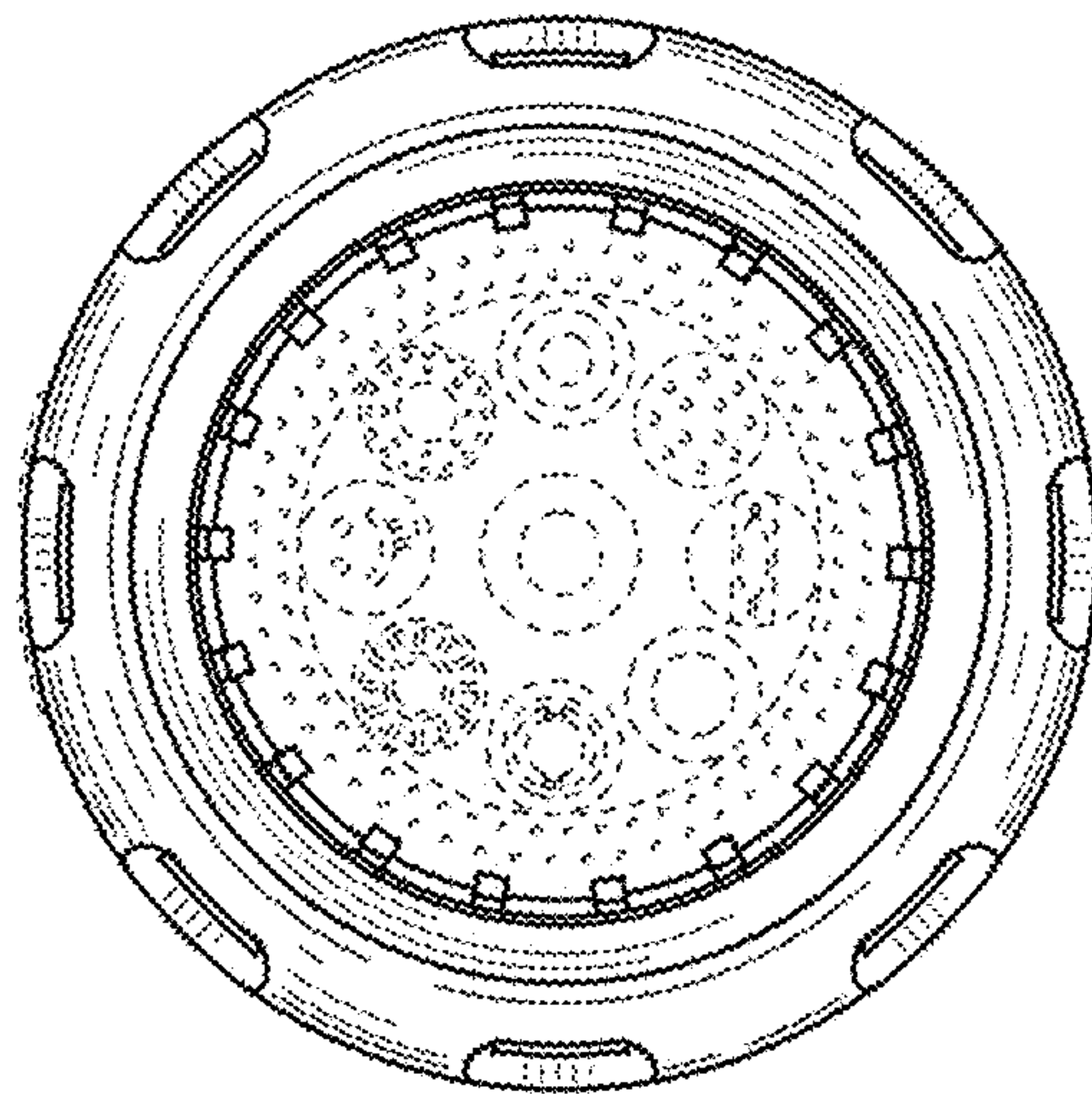

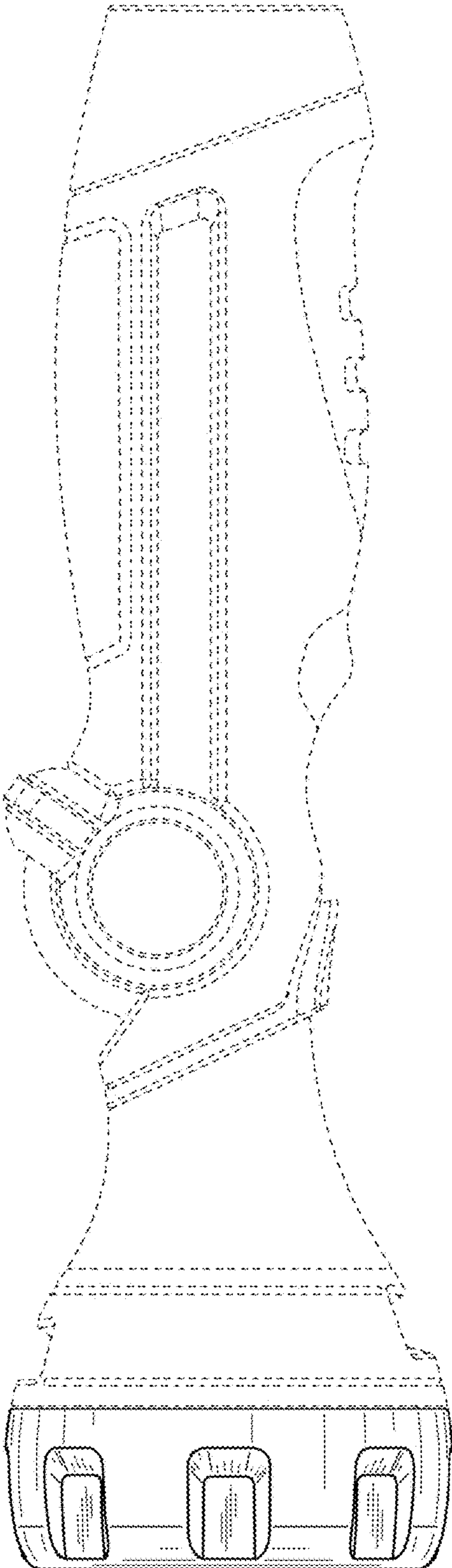

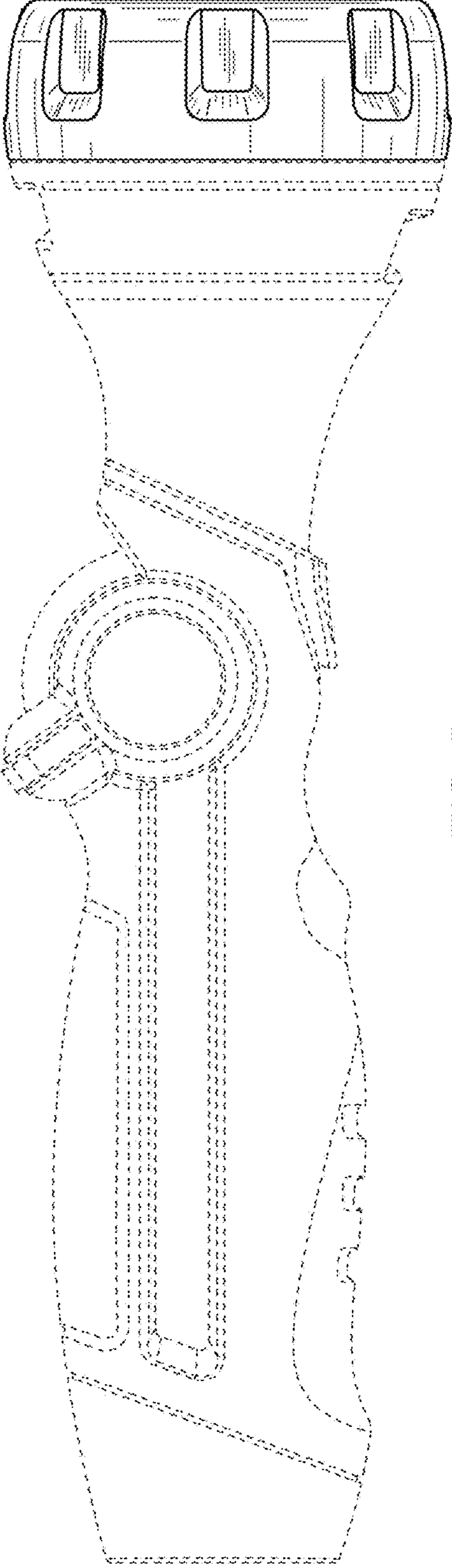

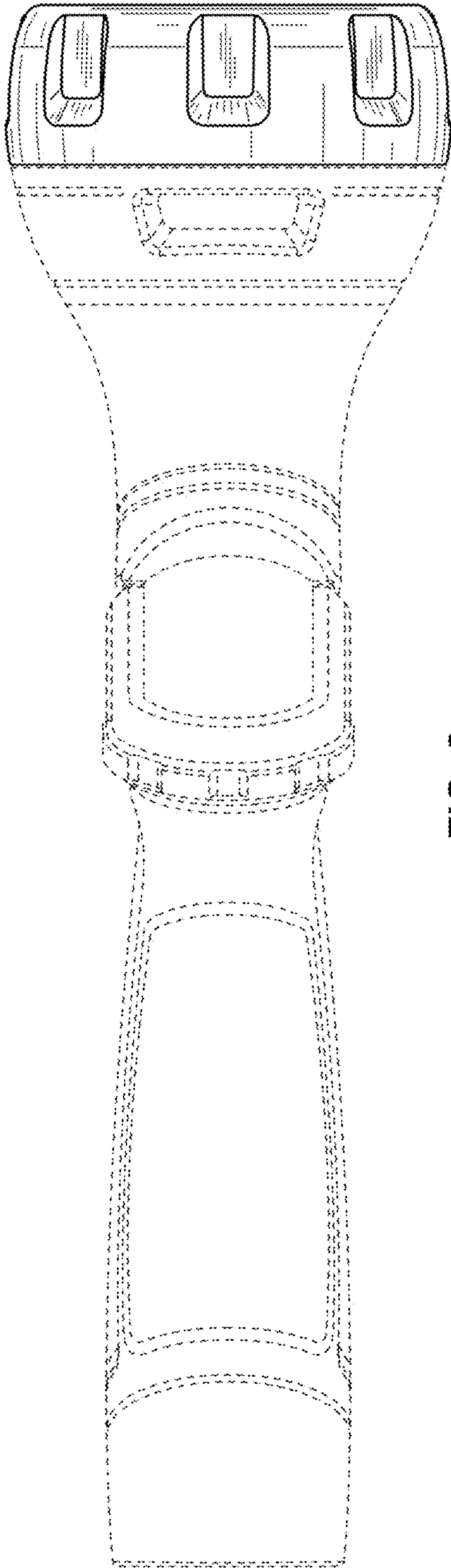

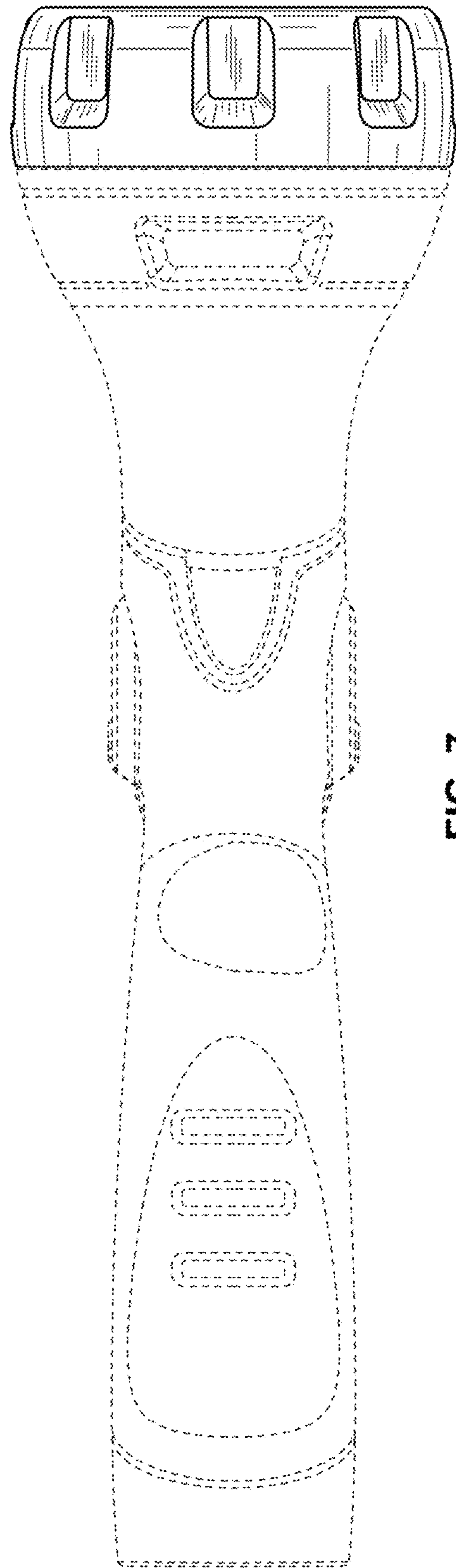

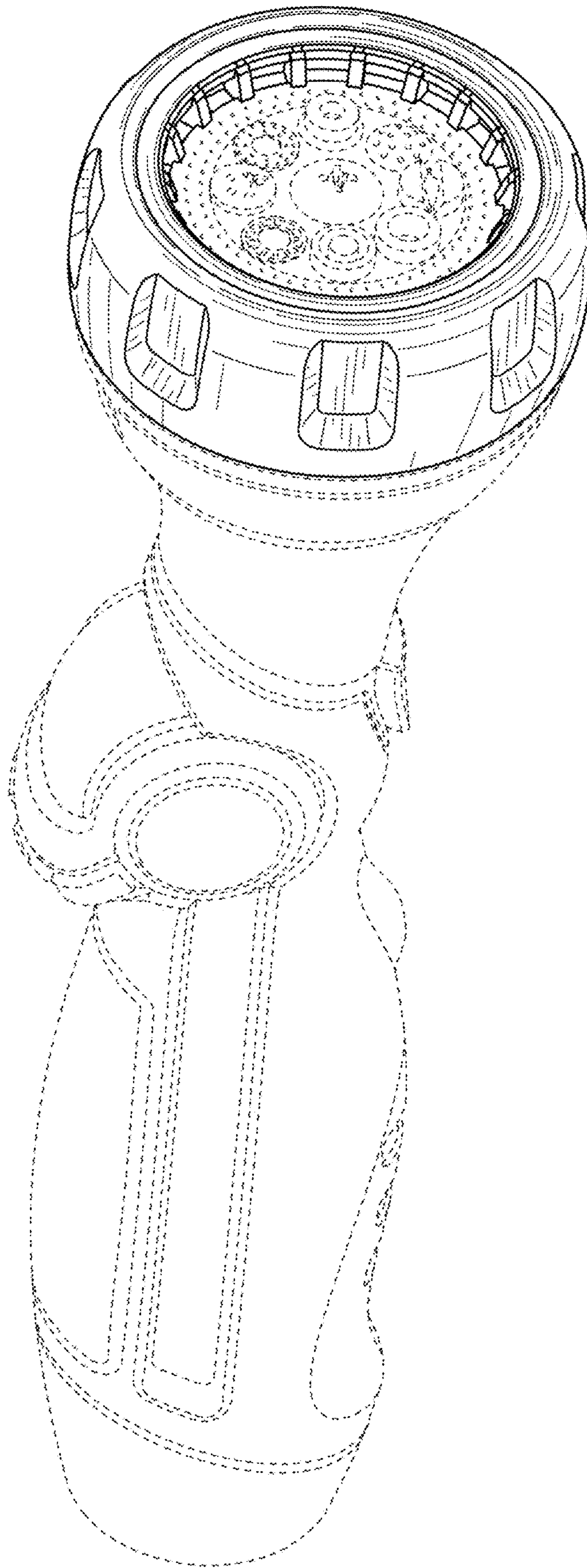
