FIG. 7 is a view of the bottom side of the absorbent article of FIG. 1.

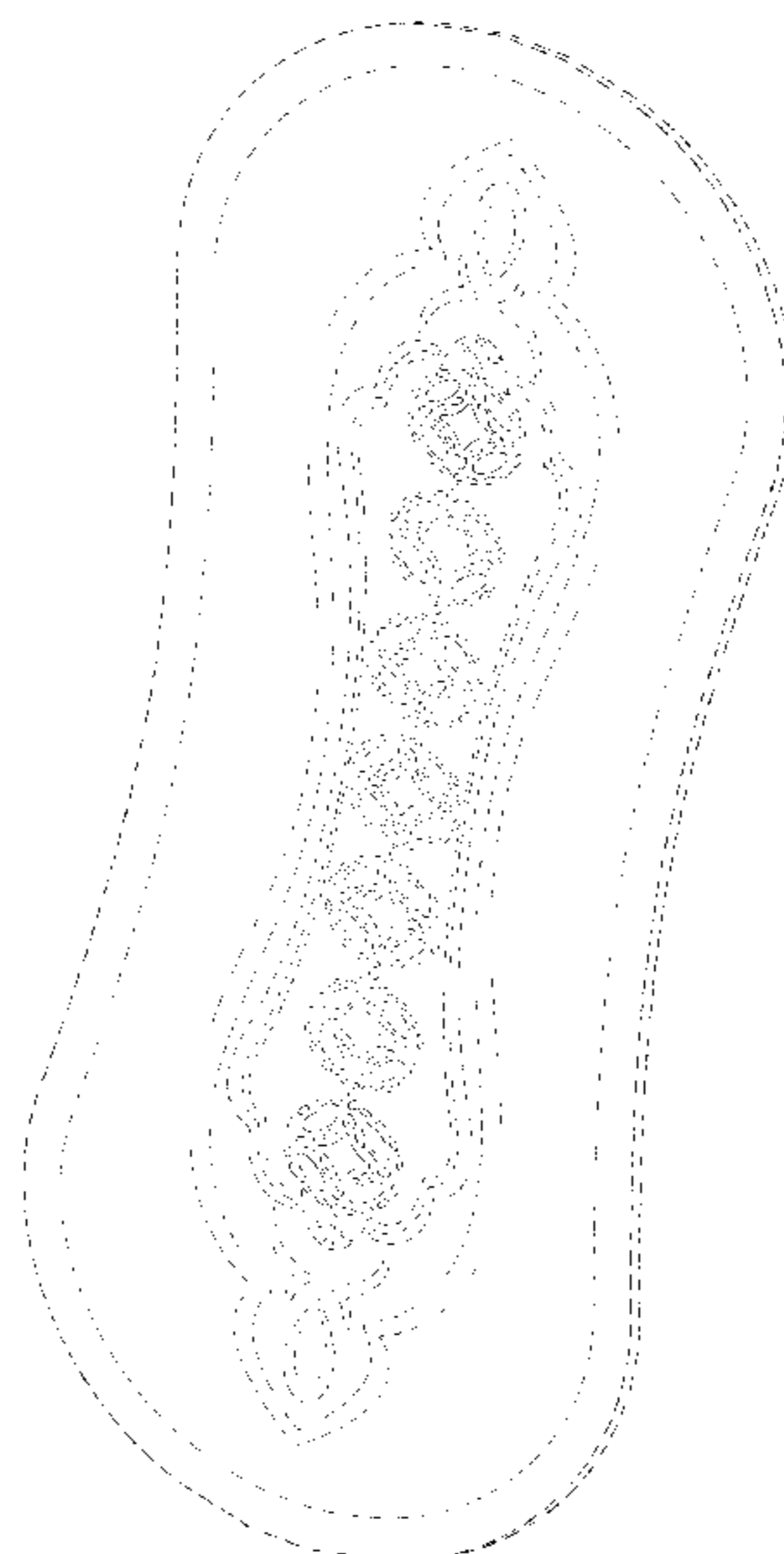

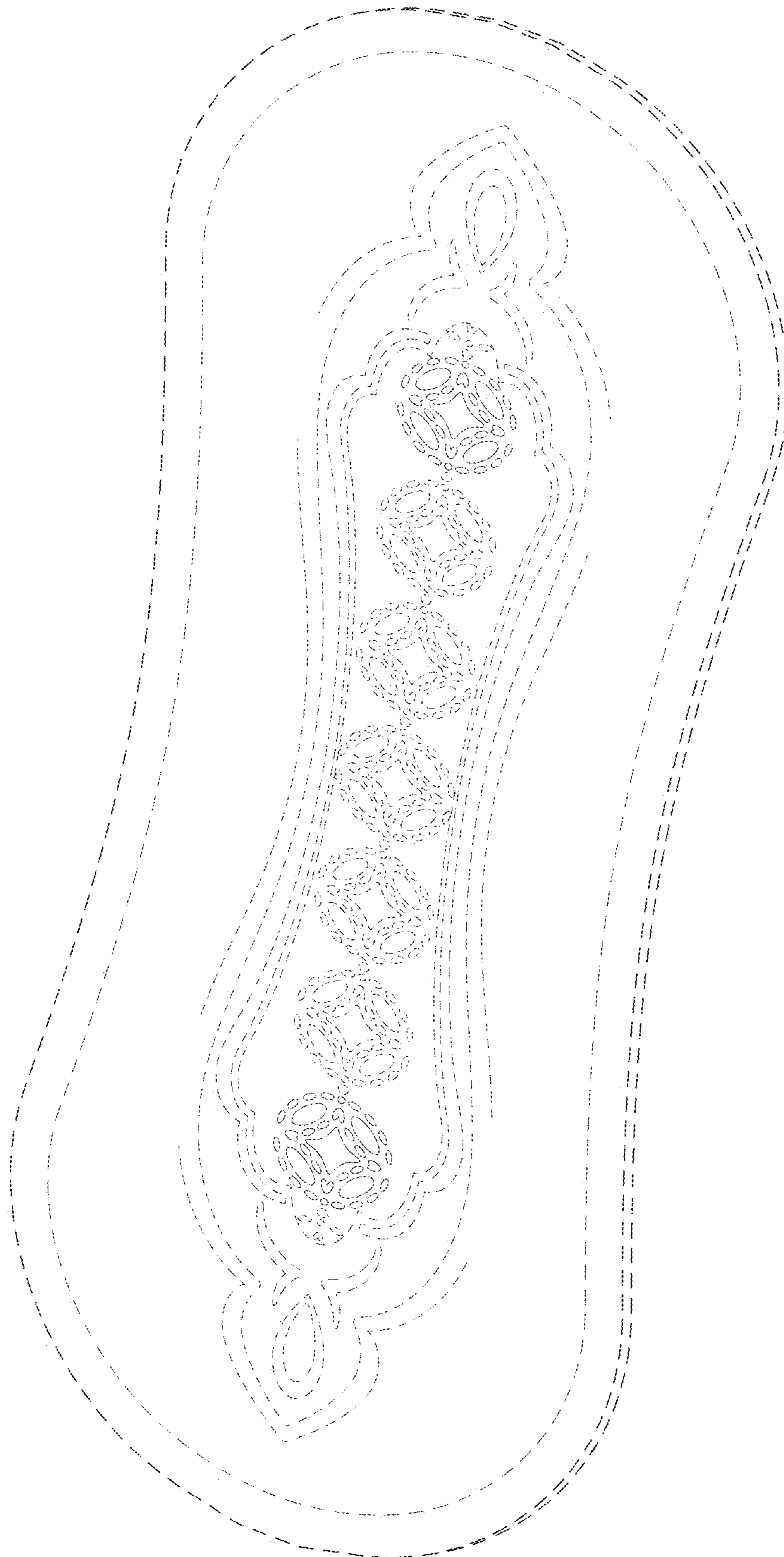

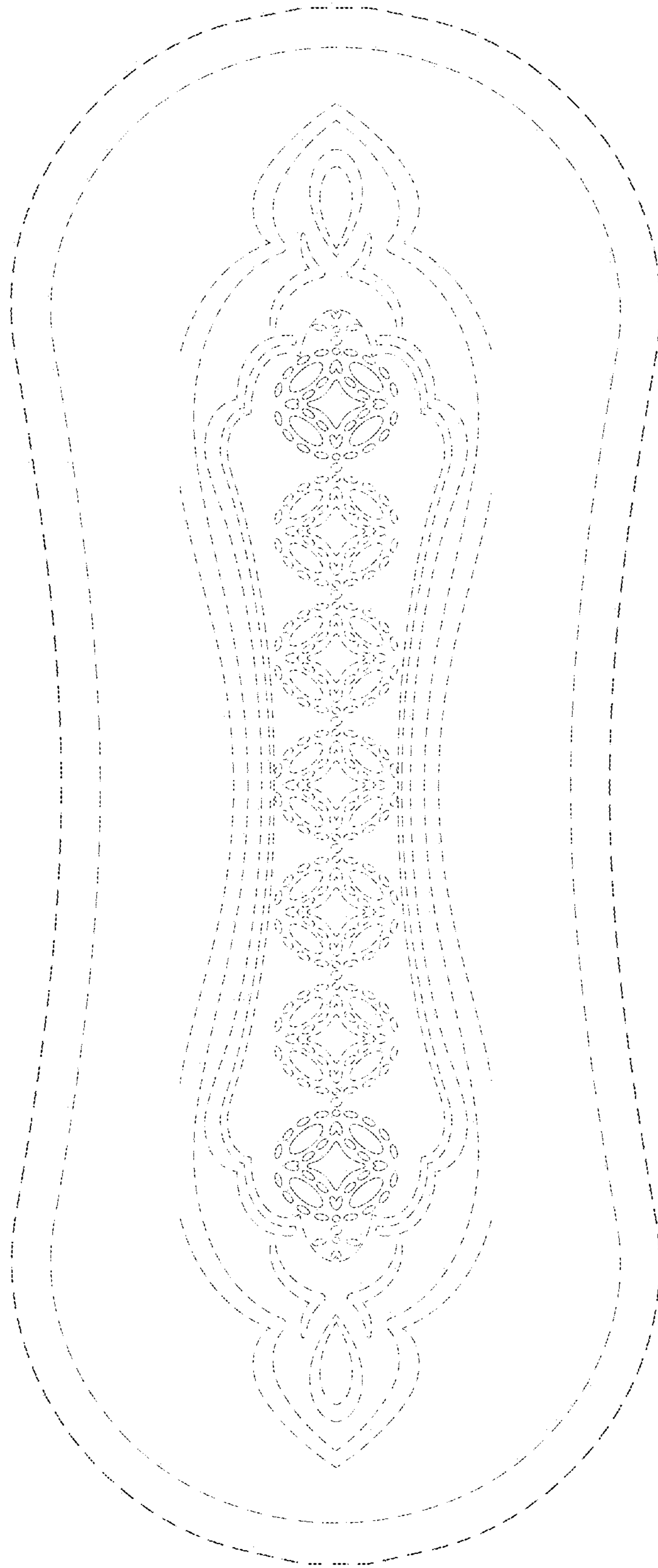

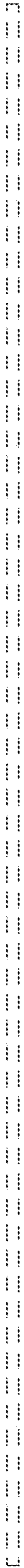

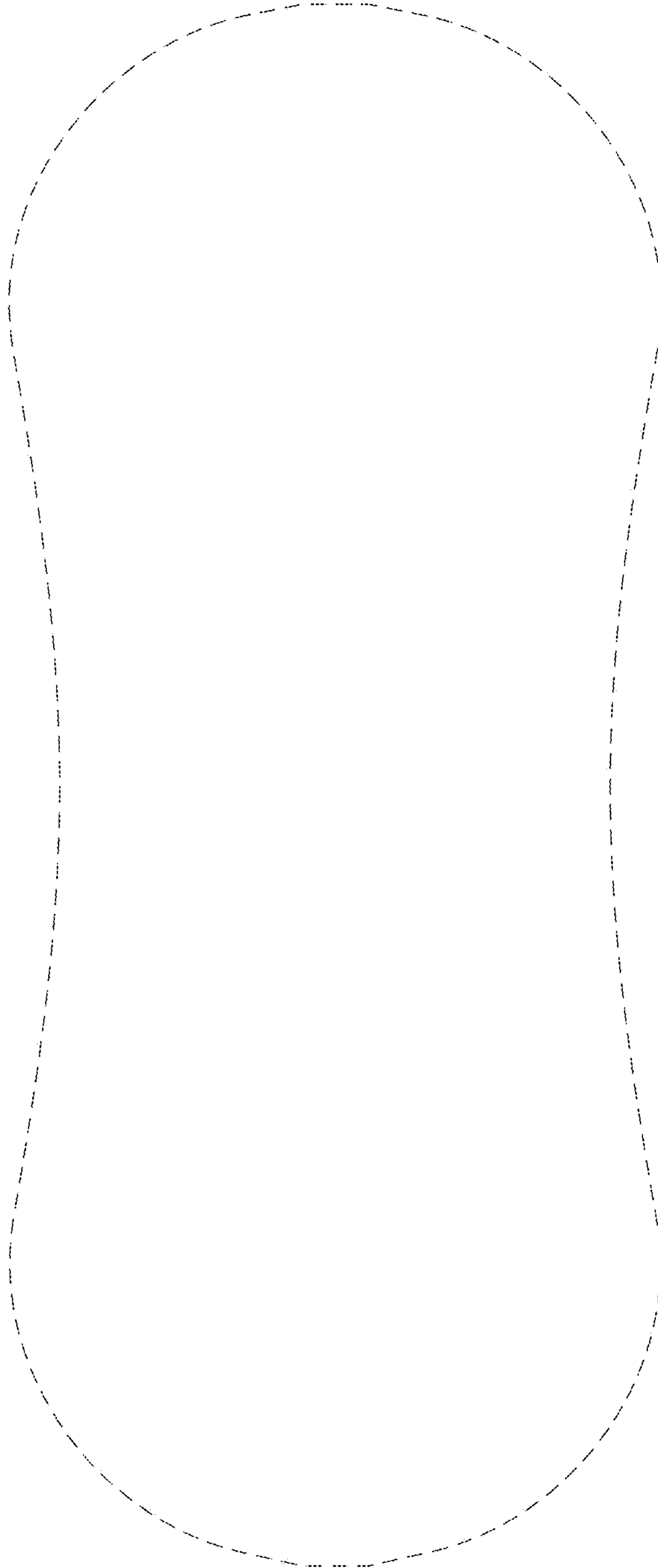

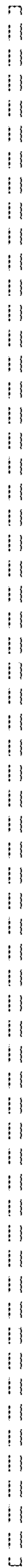

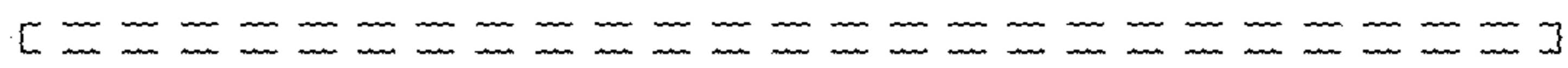
