FIG. 9 is bottom view of the gate insert.

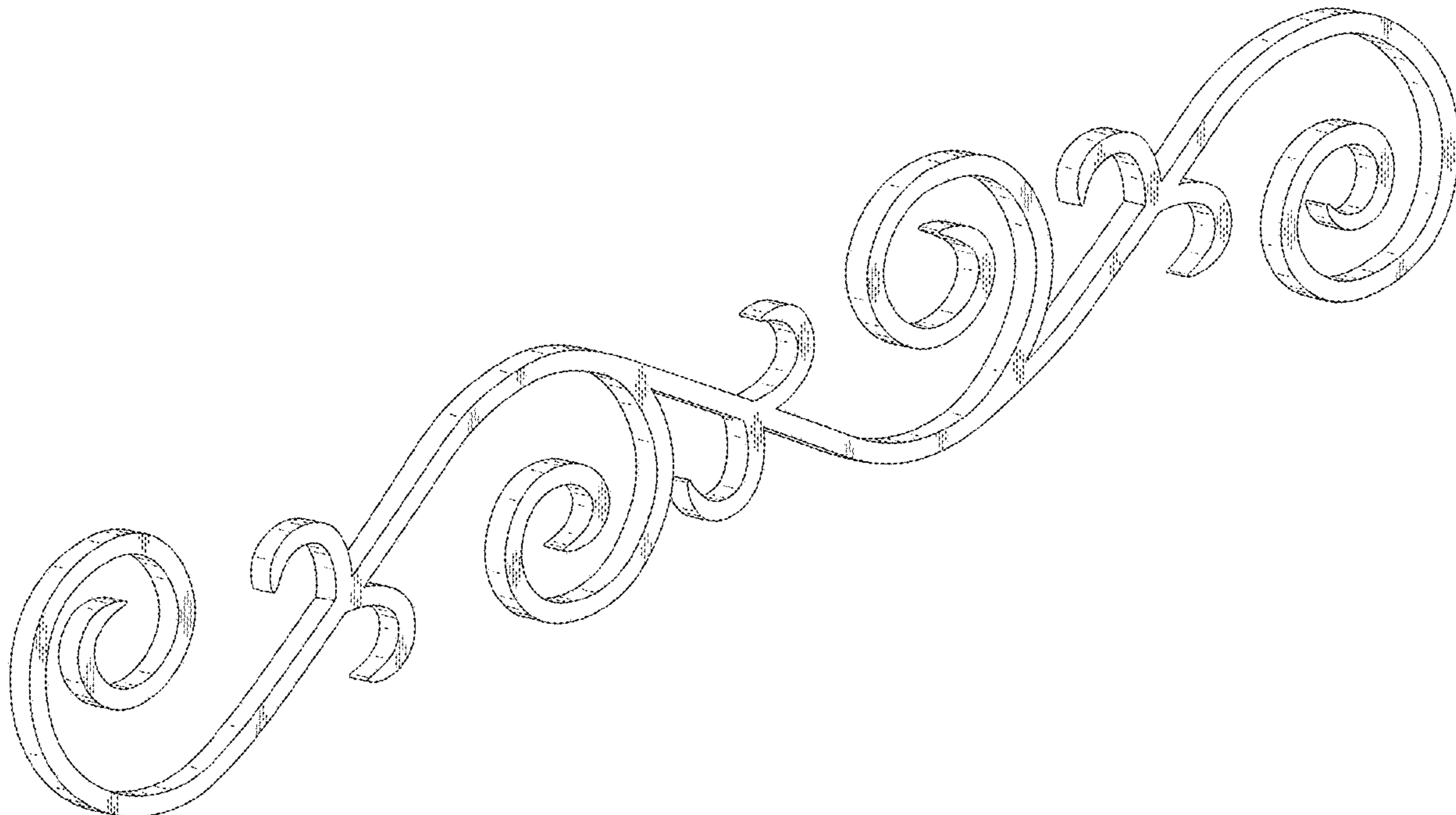

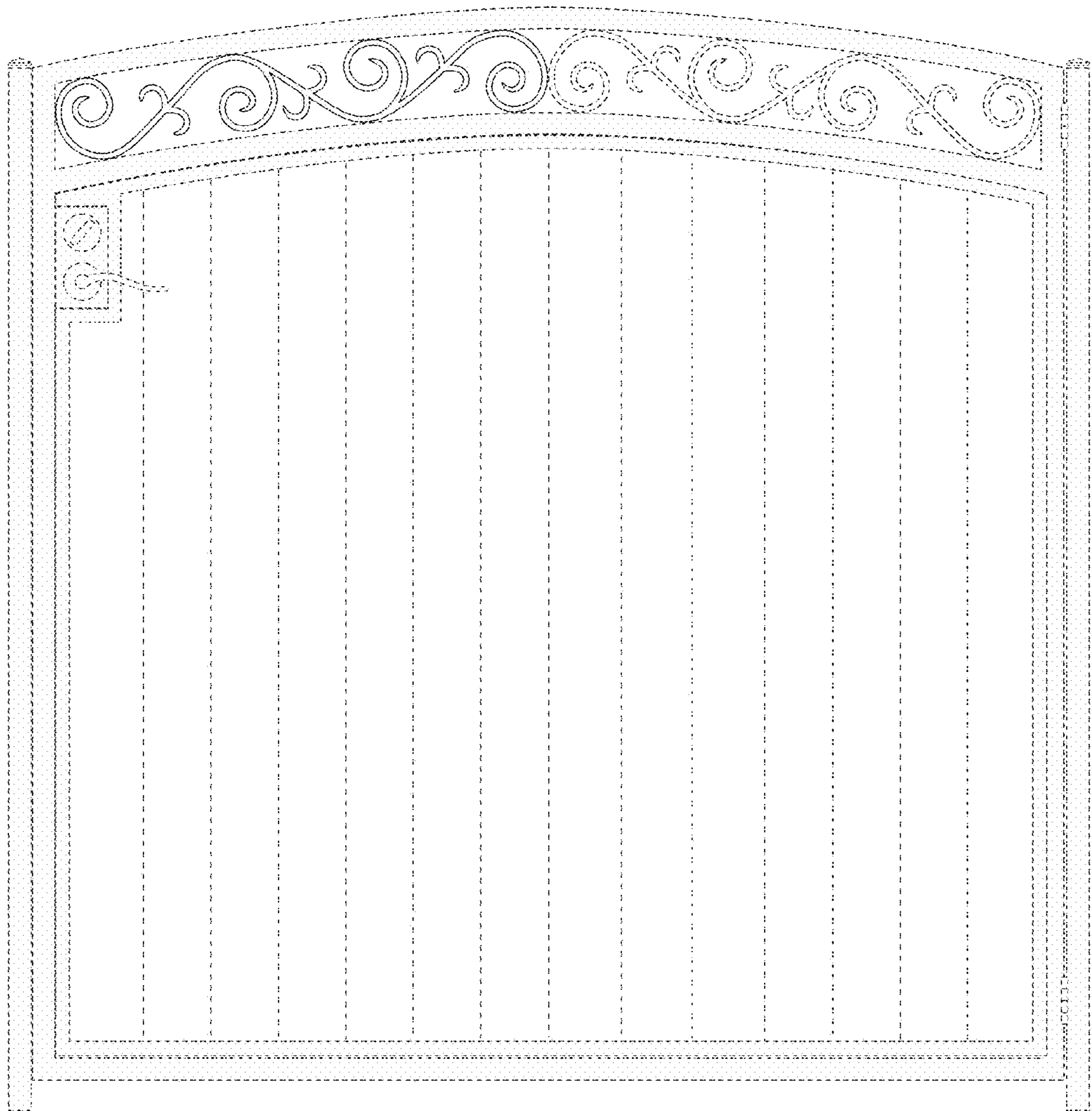

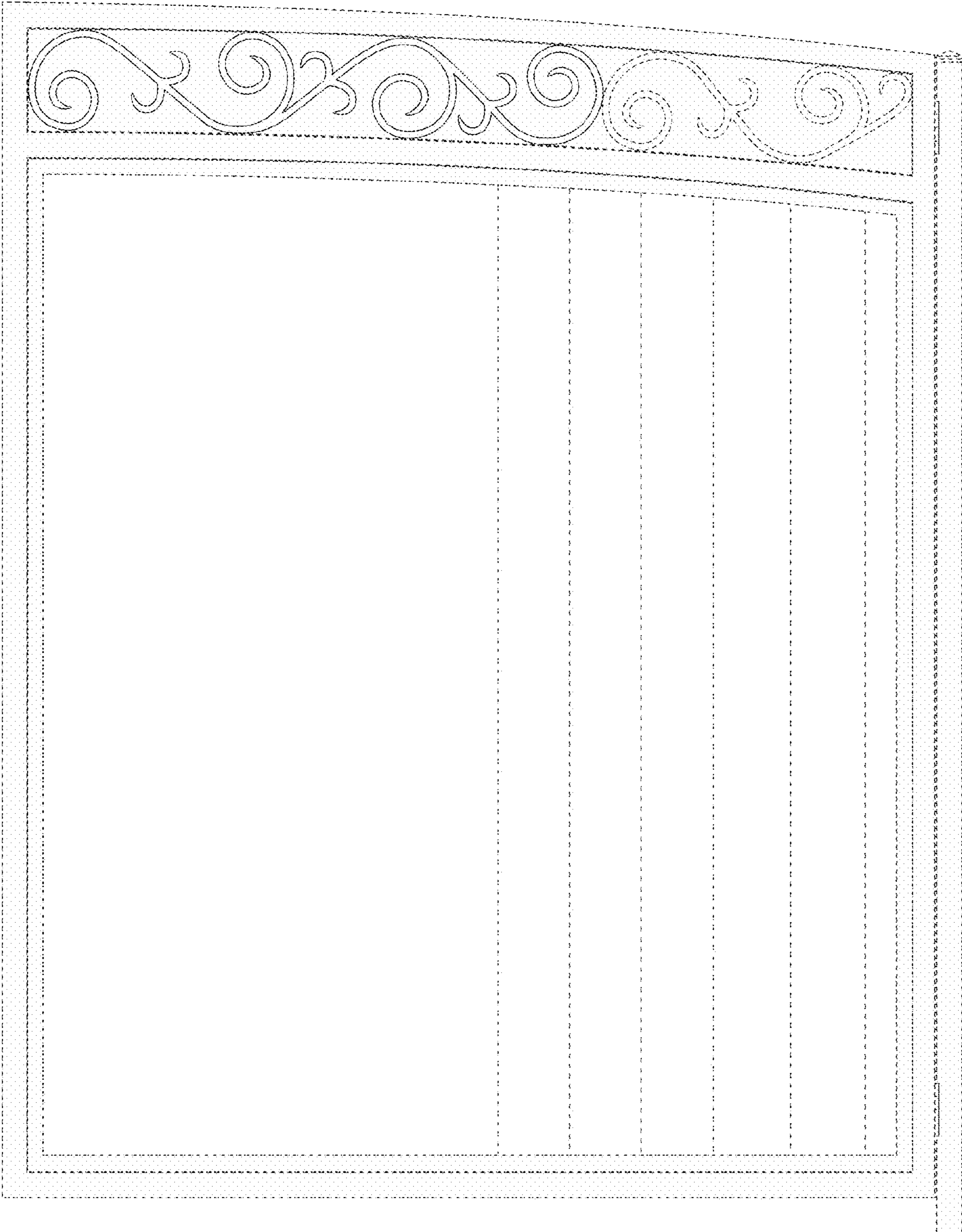

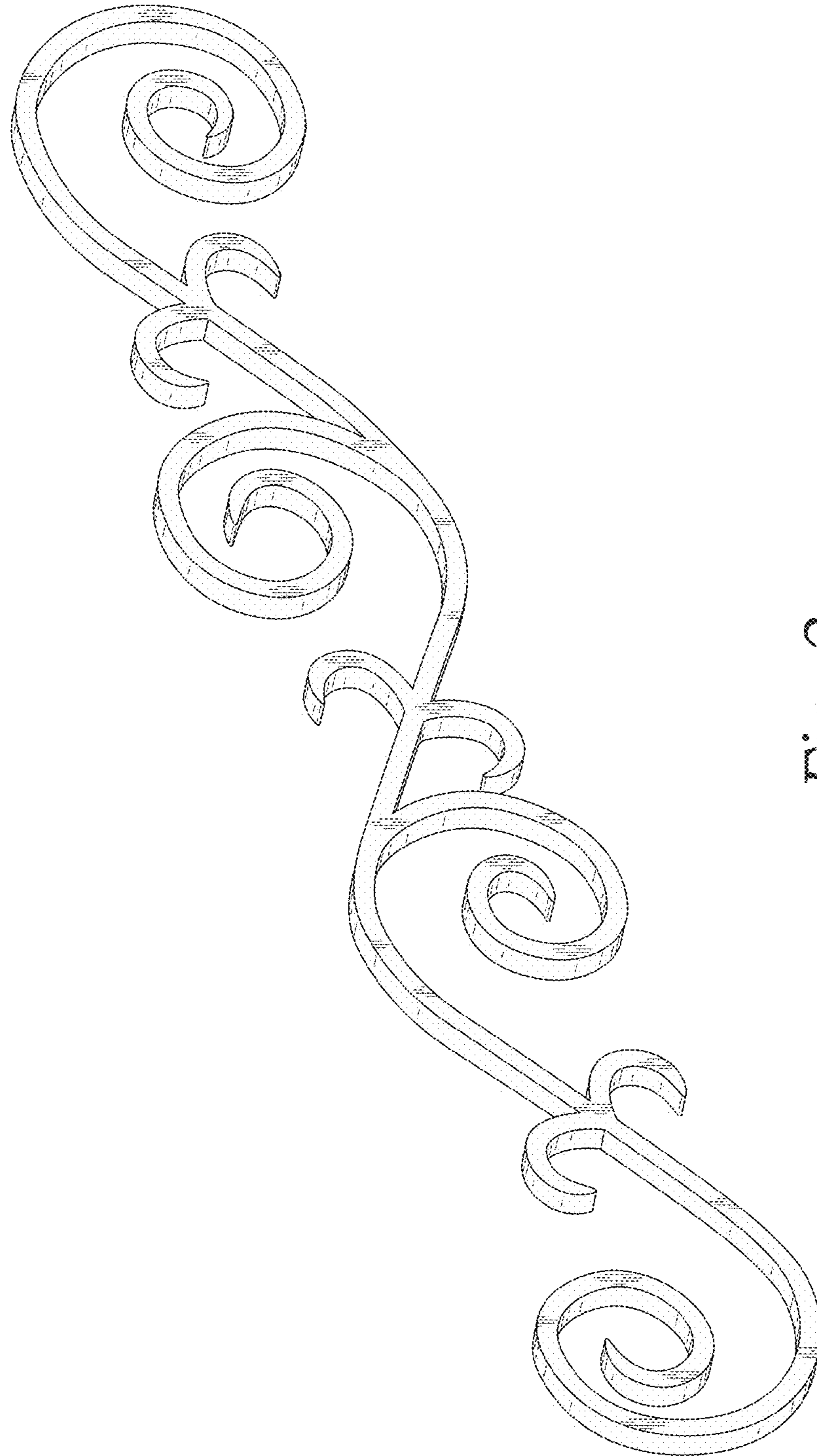

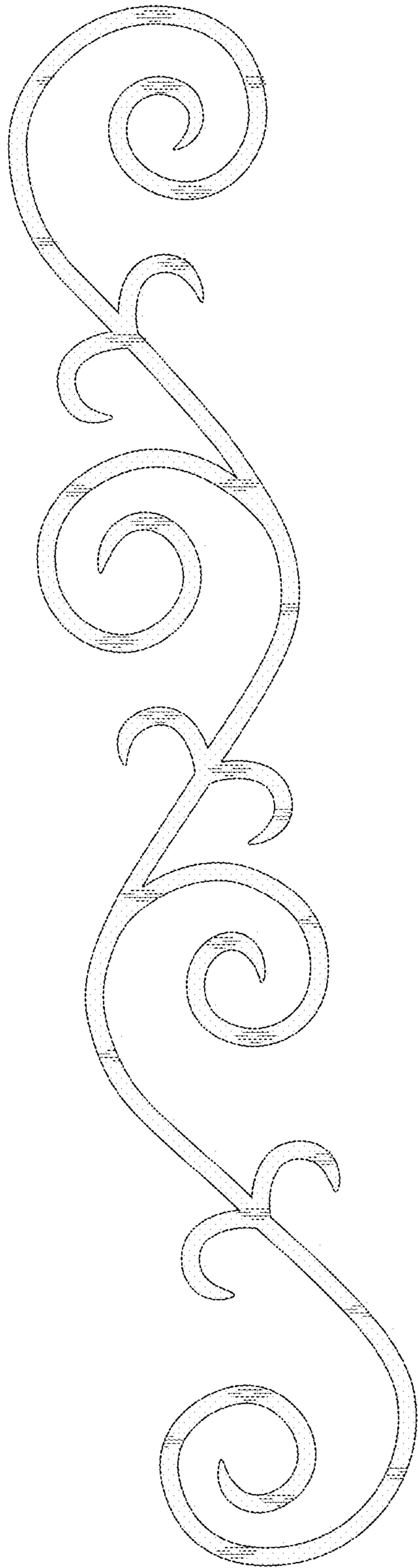

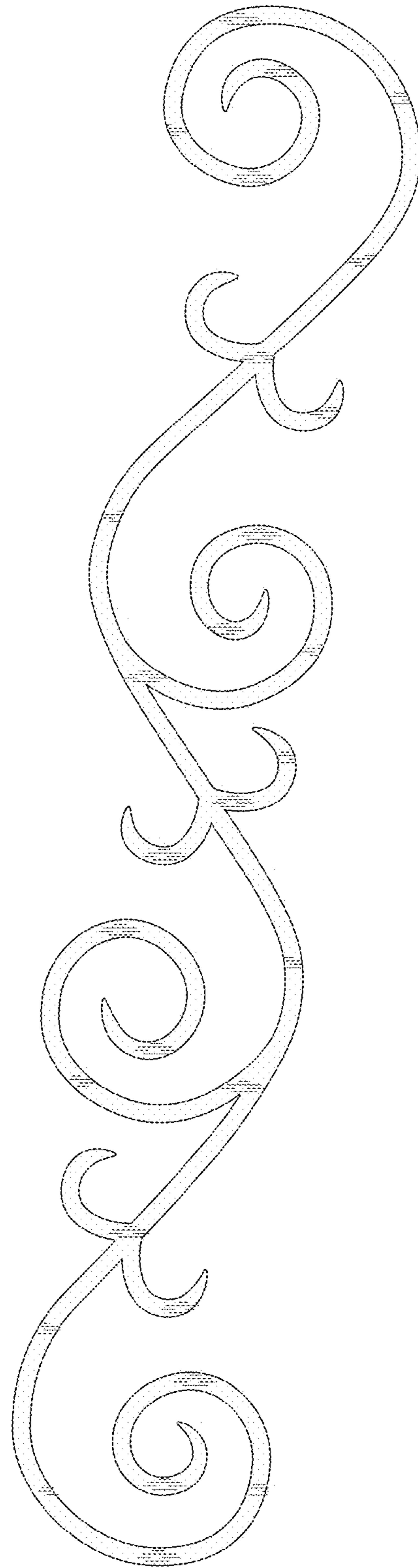

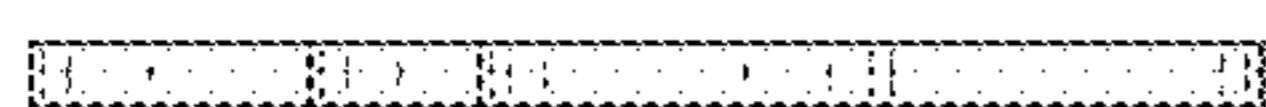

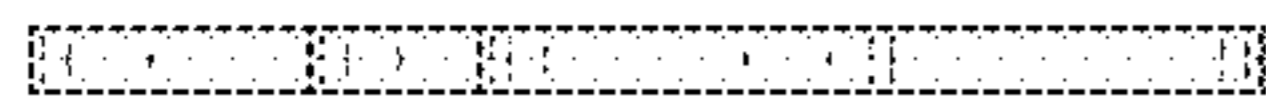

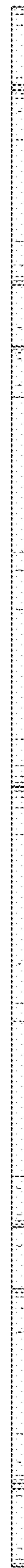
