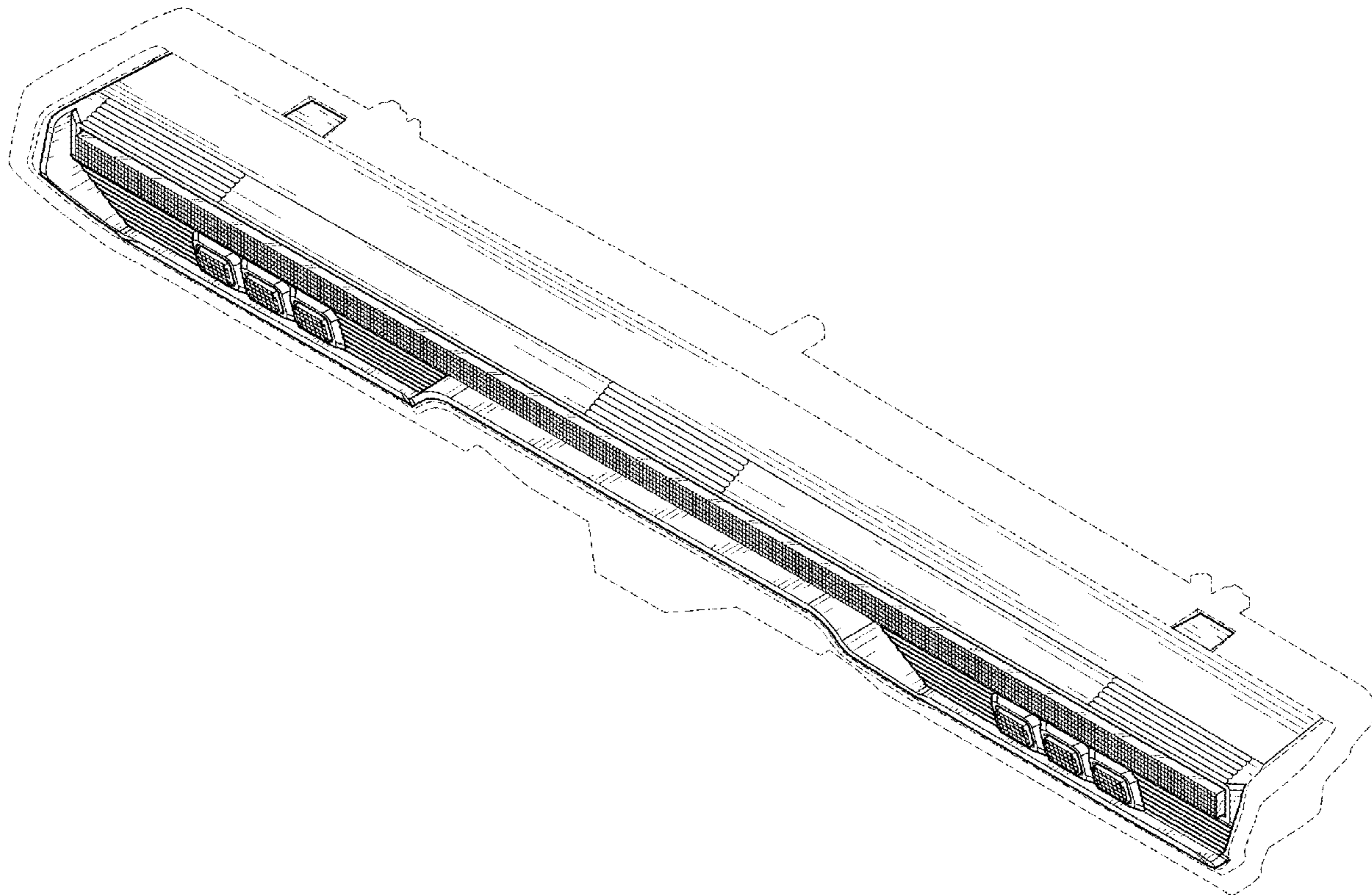
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front, right side, top perspective view of a vehicle  
light showing the claimed design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a top plan view thereof; and,

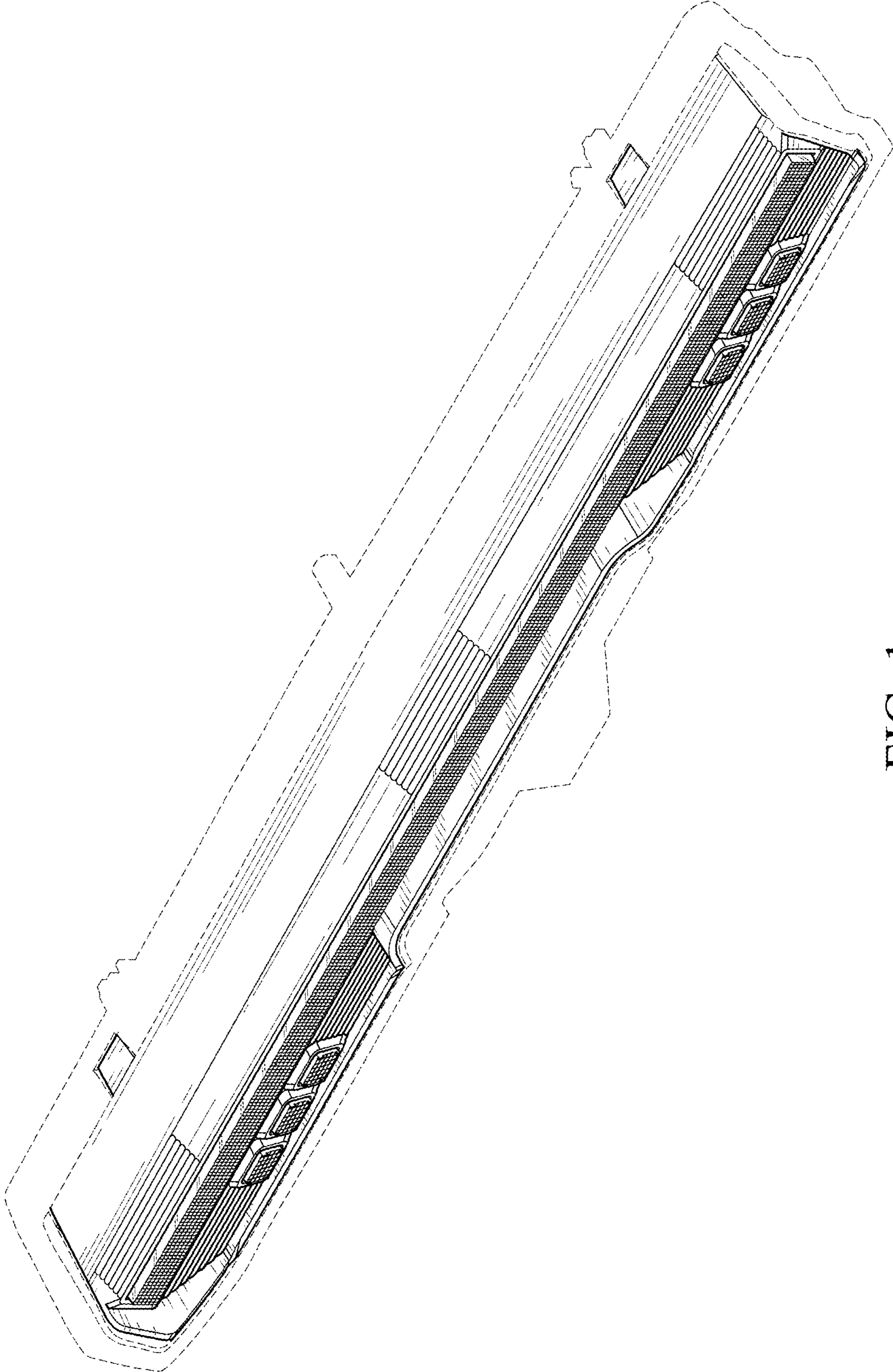

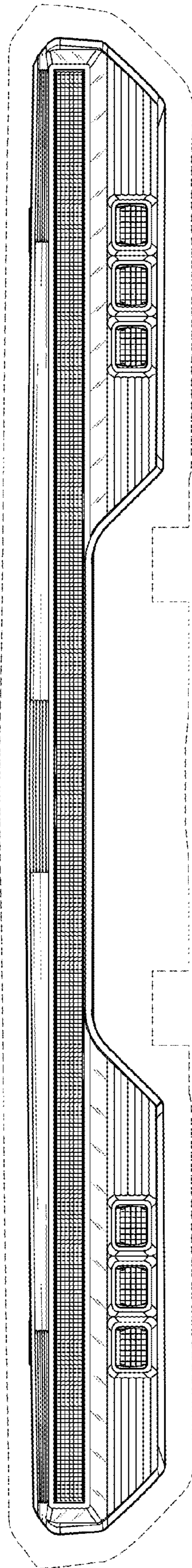

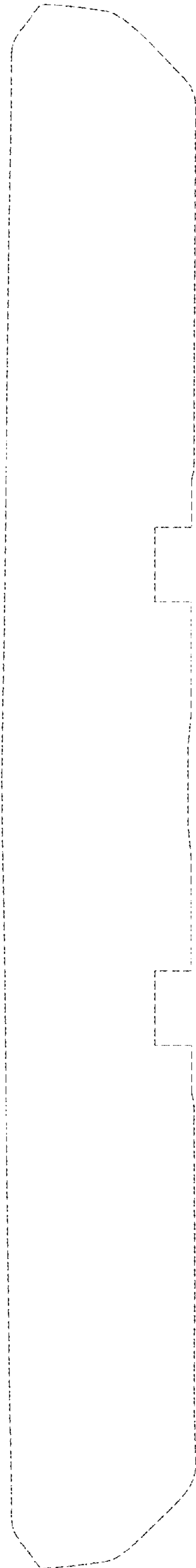

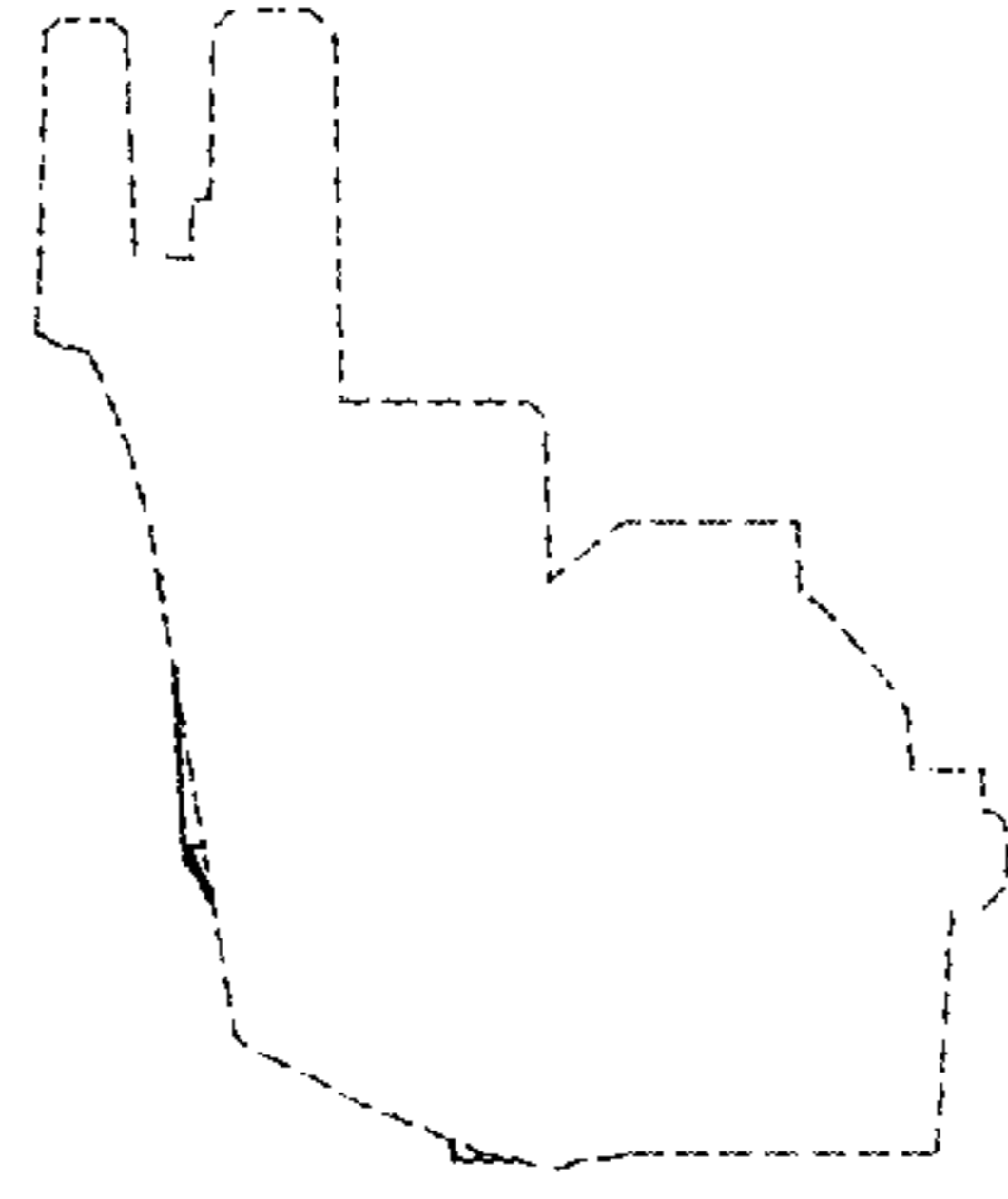

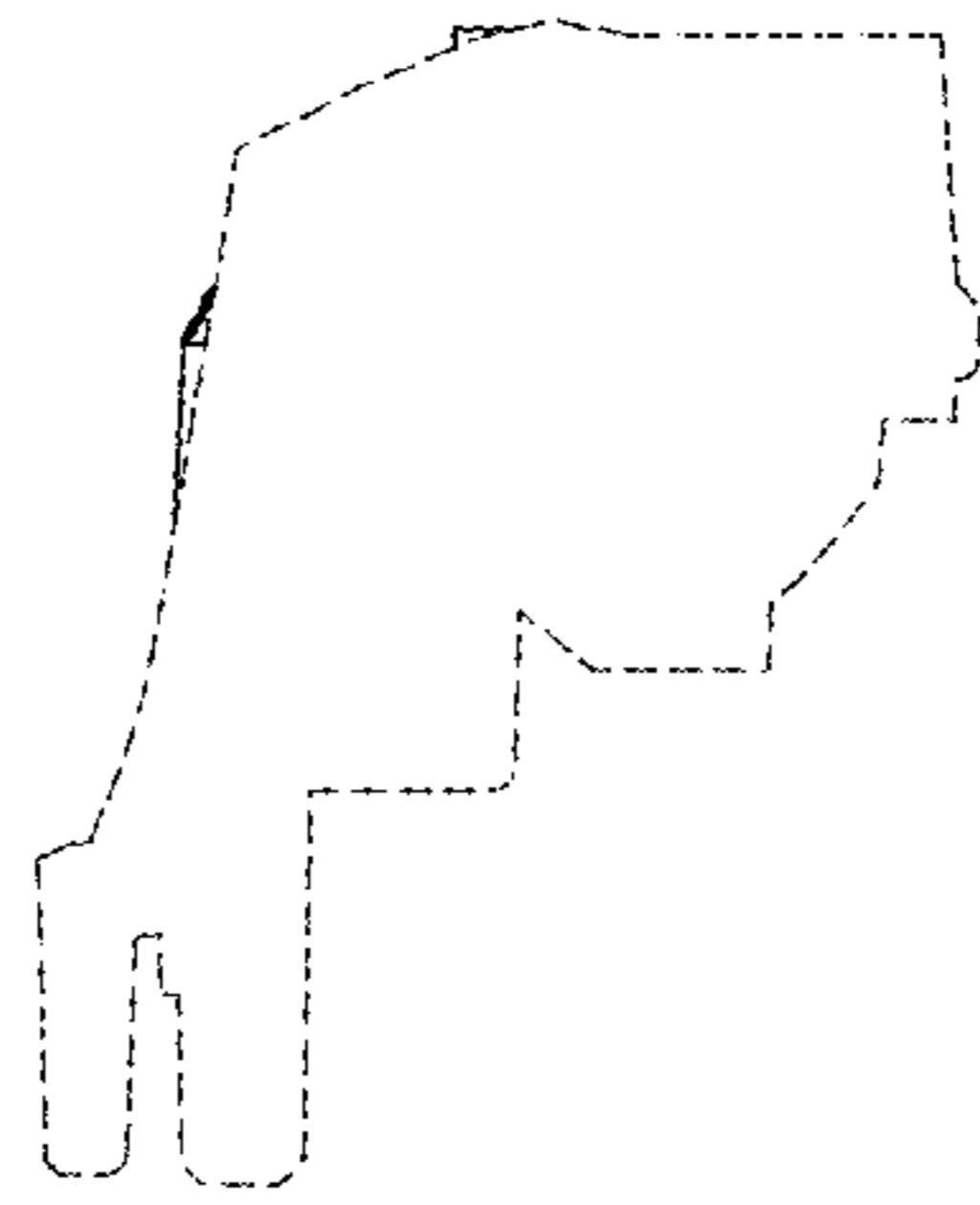

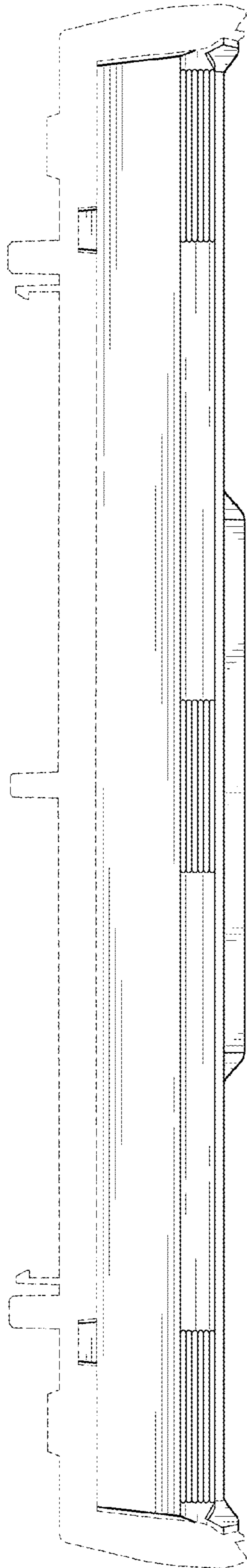

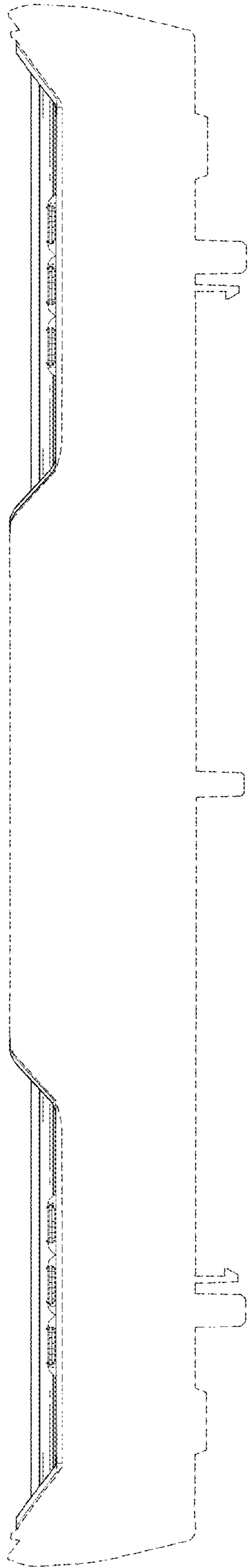
