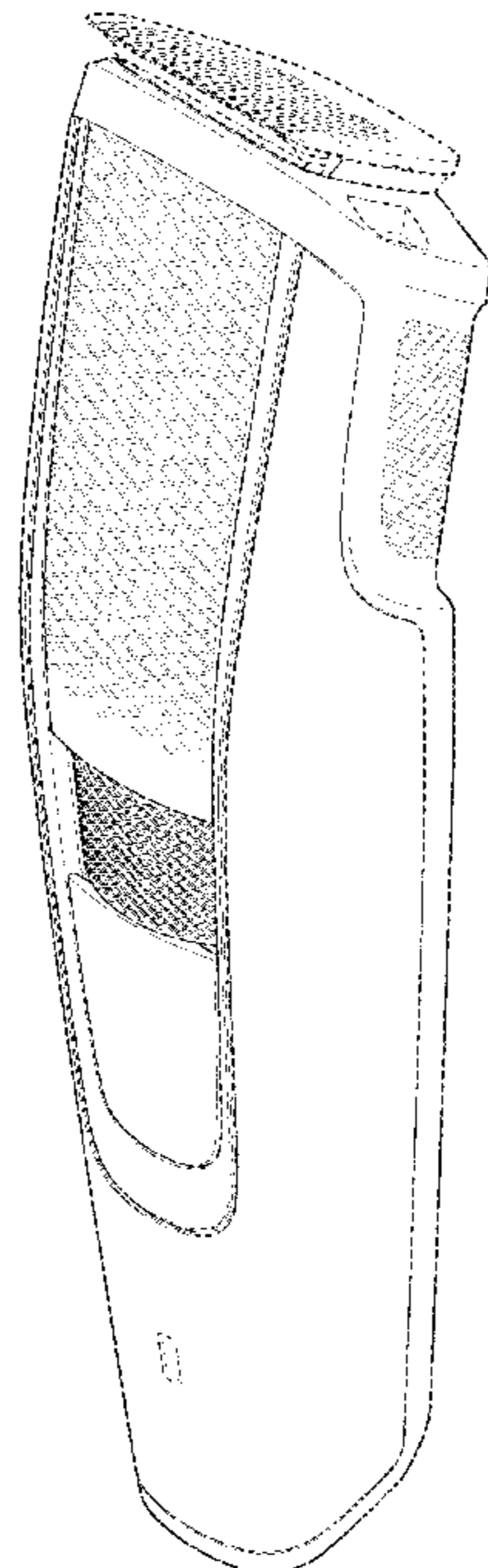
The ornamental design for a beard trimmer, as shown and described.

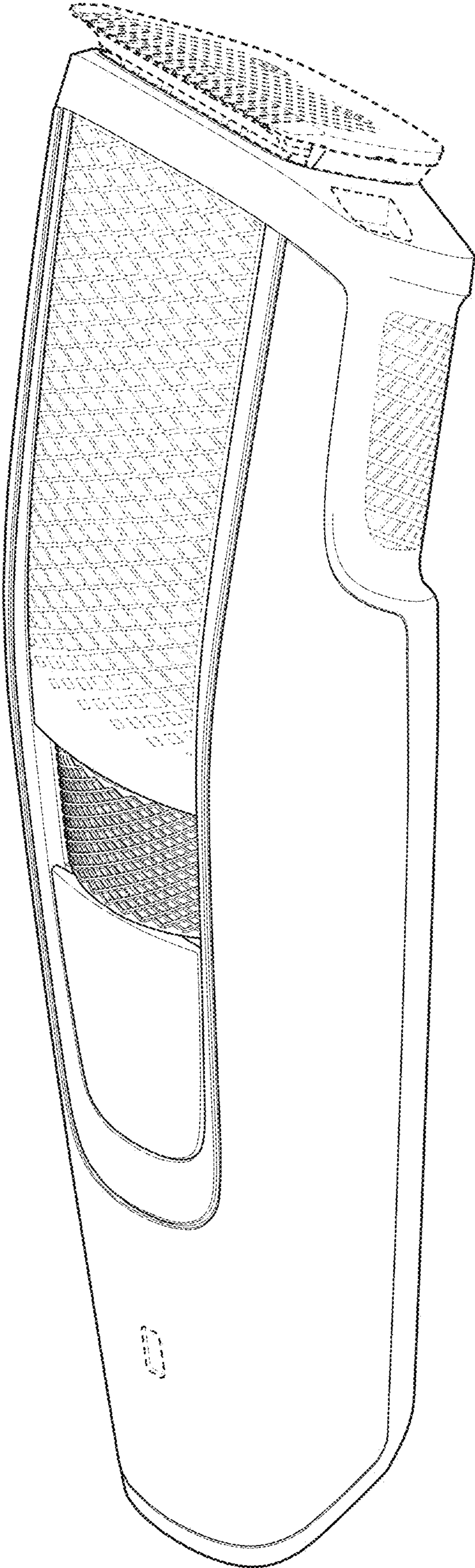

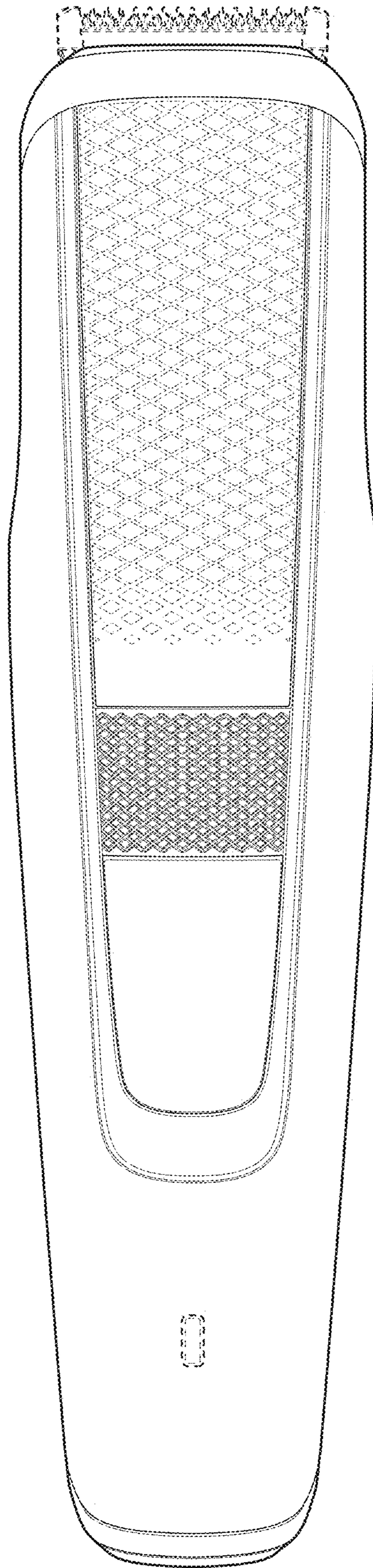

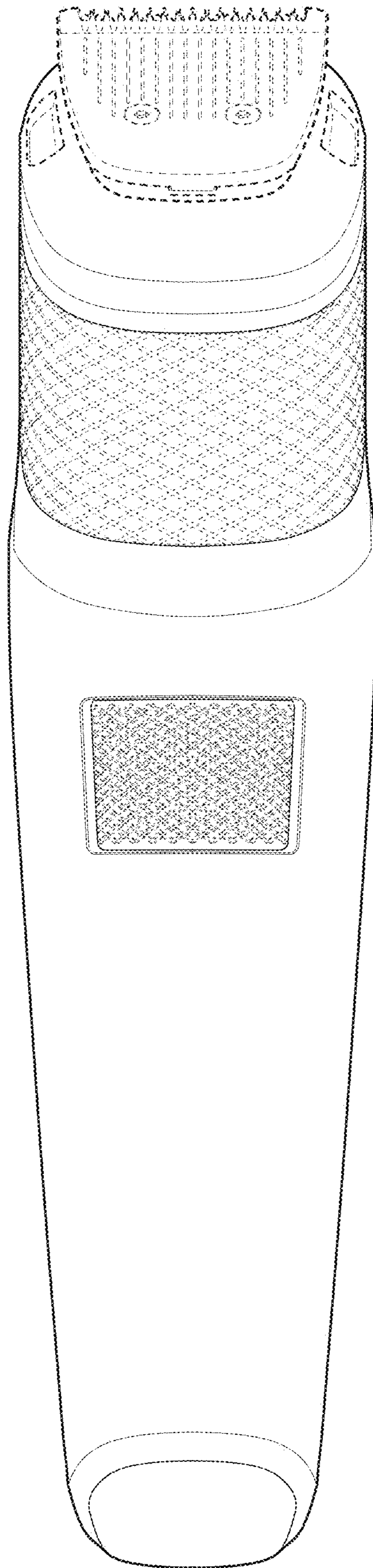

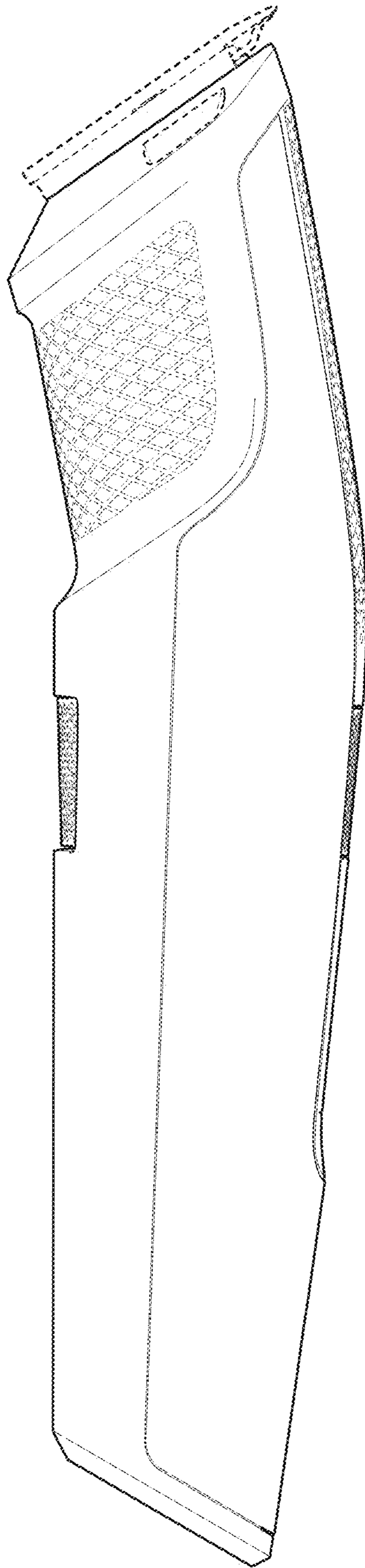

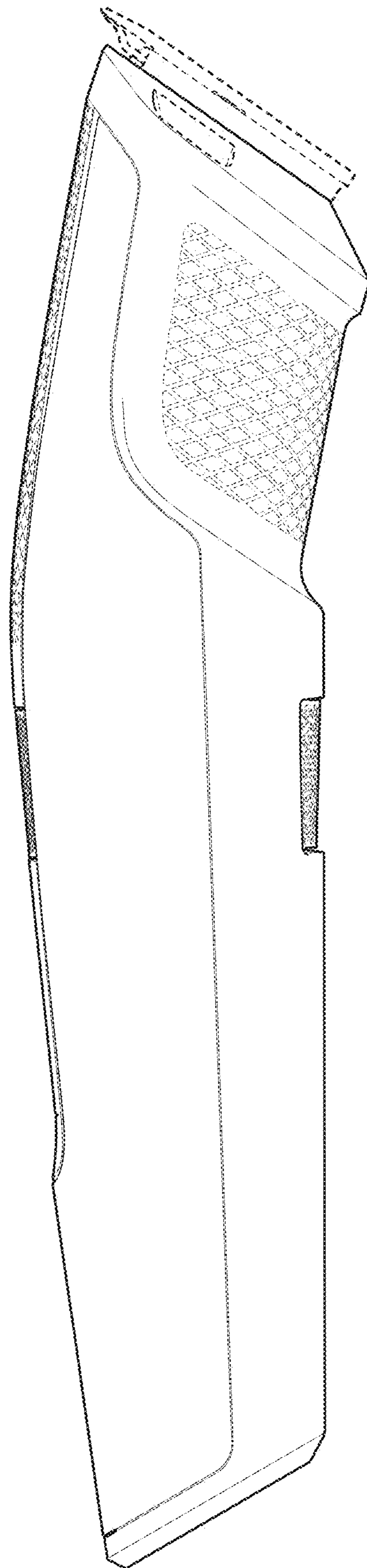

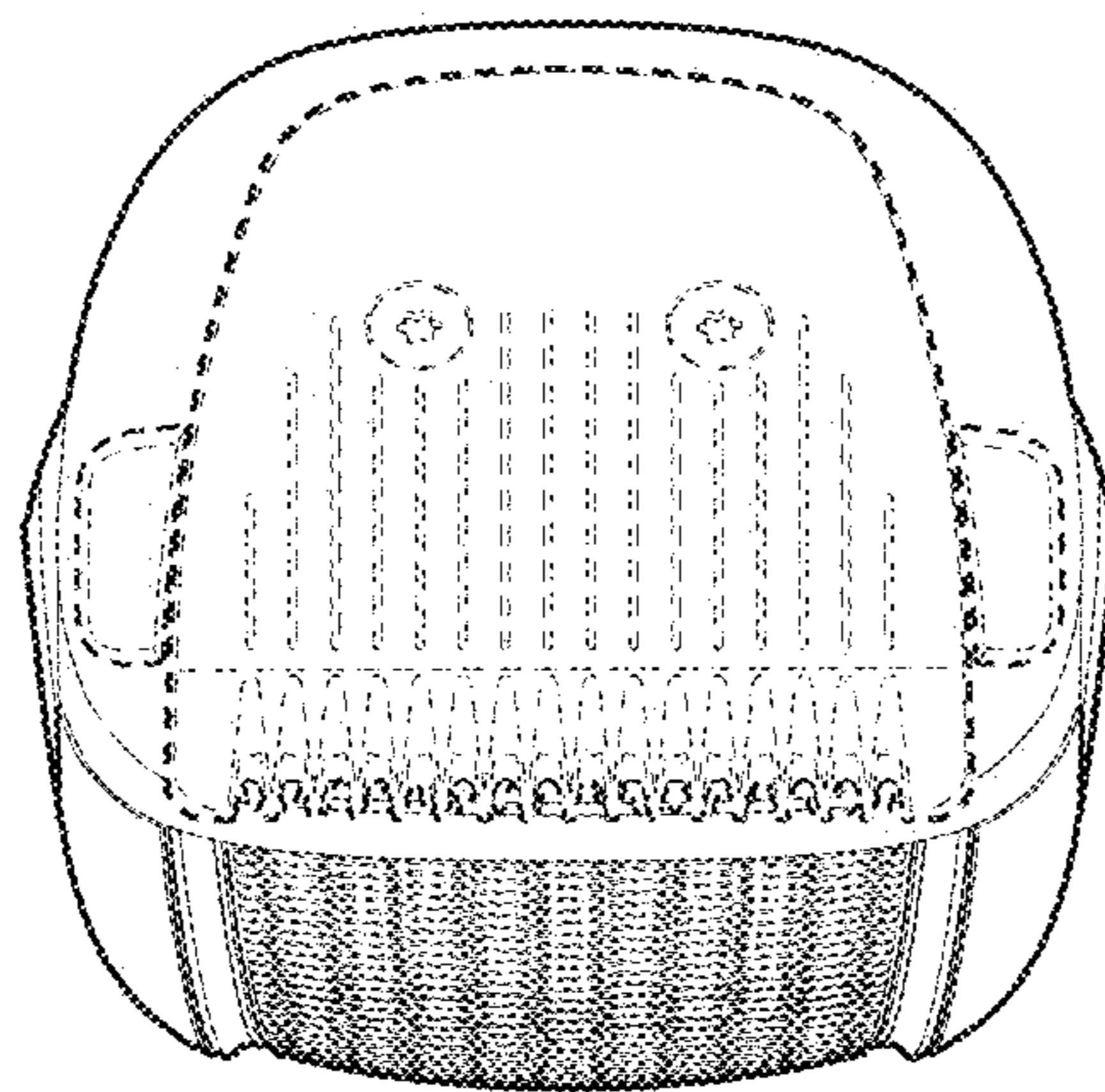

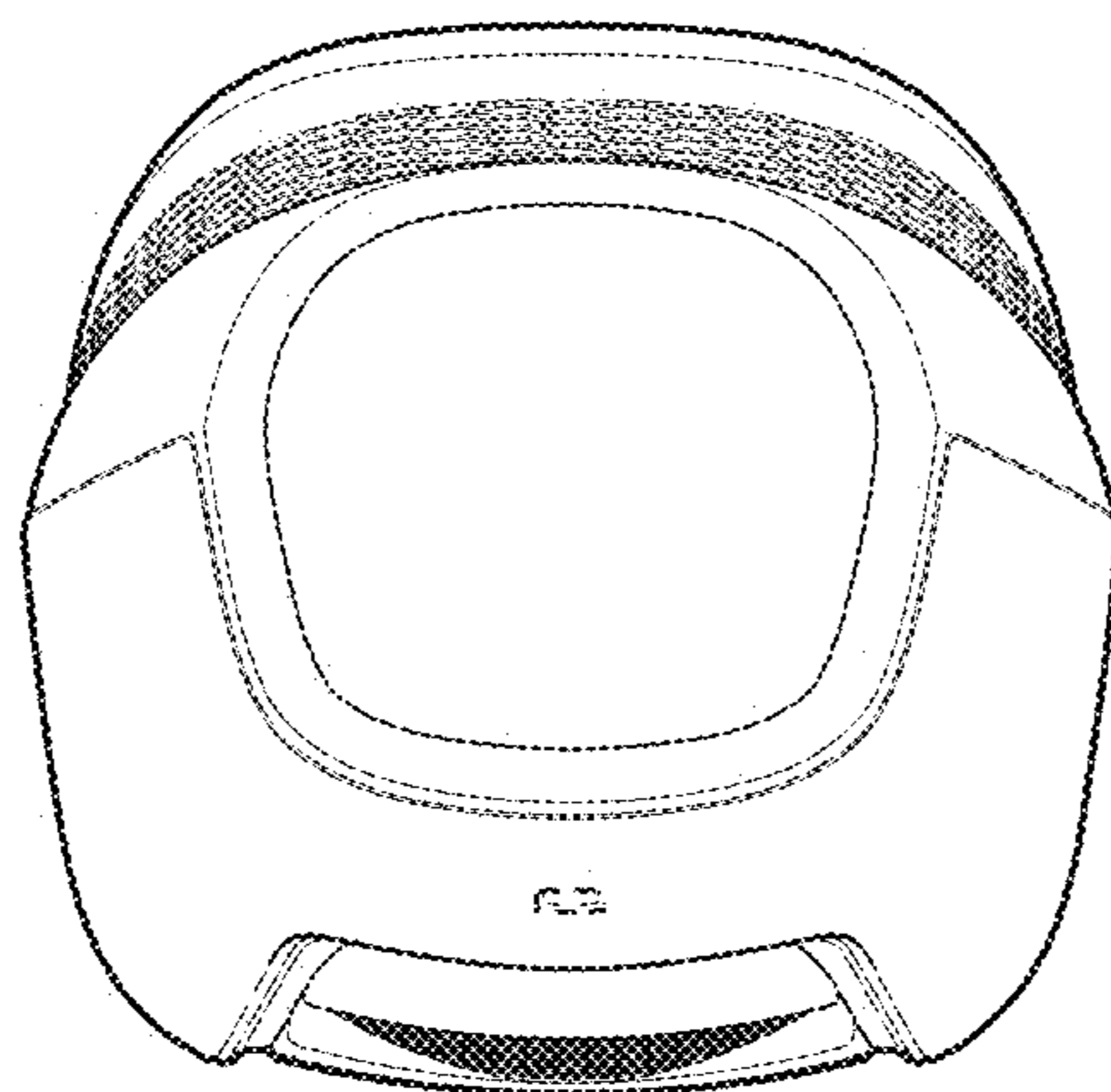
