(57) **CLAIM**

The ornamental design for a face gaiter with pocket for foldable storage, as shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view of the face gaiter with pocket for foldable storage design as it may be worn by a person;

FIG. 2 is a front right perspective view of the face gaiter with pocket for foldable storage design as it may be worn by a person;

FIG. 3 is a back perspective view of the face gaiter with pocket for foldable storage design as it may be worn by a person;

FIG. 4 is a flattened back side view of the design corresponding to FIG. 1;

FIG. 5 is a flattened front side view of the design corresponding to FIG. 1 showing the pocket;

FIG. 6 is a top perspective view of the design corresponding to FIG. 1;

FIG. 7 is a bottom perspective view of the design corresponding to FIG. 1;

FIG. 8 is a front view of the design corresponding to FIG. 1;

FIG. 9 is a right-side view of the design corresponding to FIG. 1;

FIG. 10 is a top view of the design corresponding to FIG. 1;

FIG. 11 is a bottom view of the design corresponding to FIG. 1;

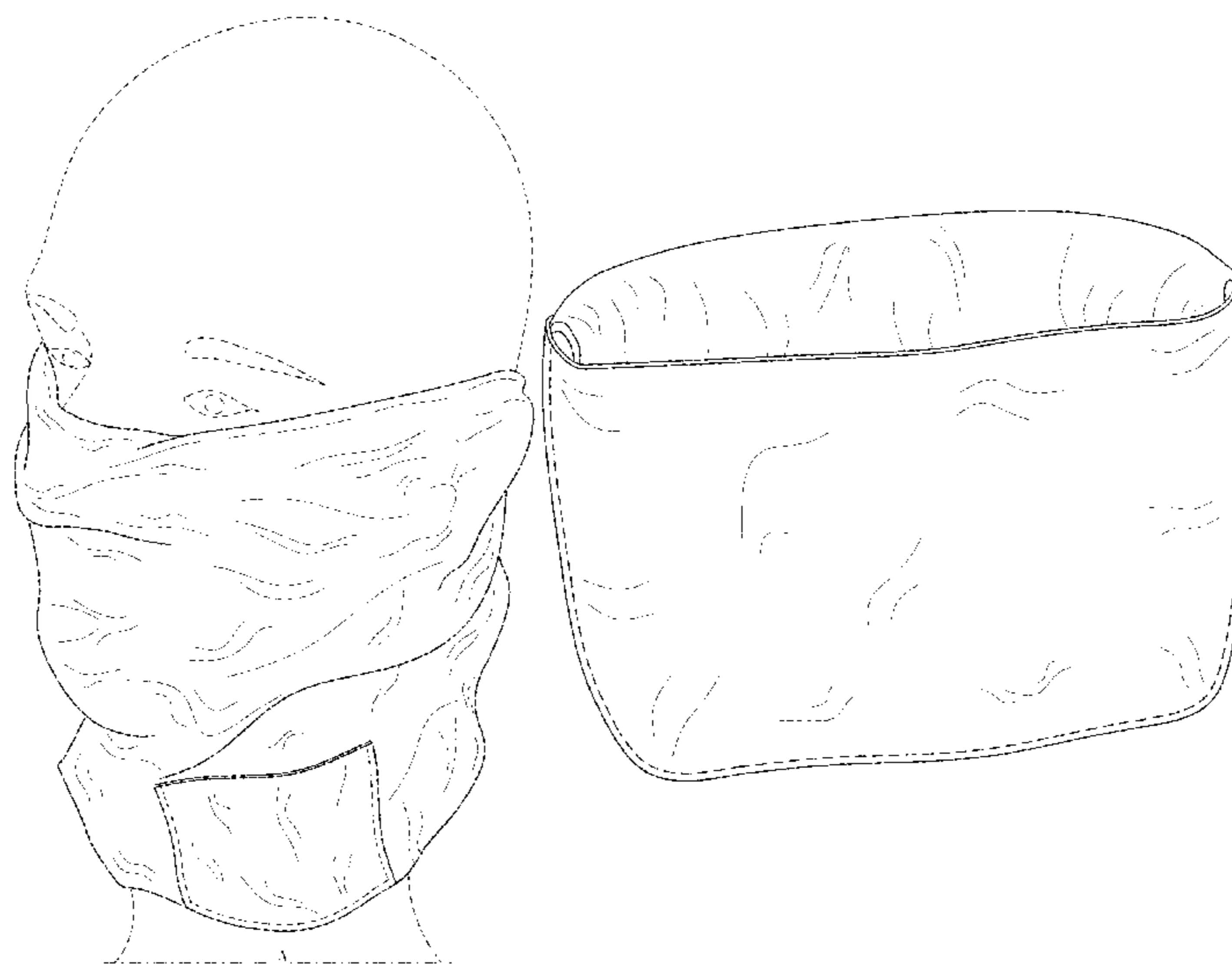
FIG. 12 is a front perspective view showing the face mask of FIG. 1 as it may be folded into the pocket;

FIG. 13 is a back perspective view showing the face mask of FIG. 1 as it may be folded into the pocket; and,

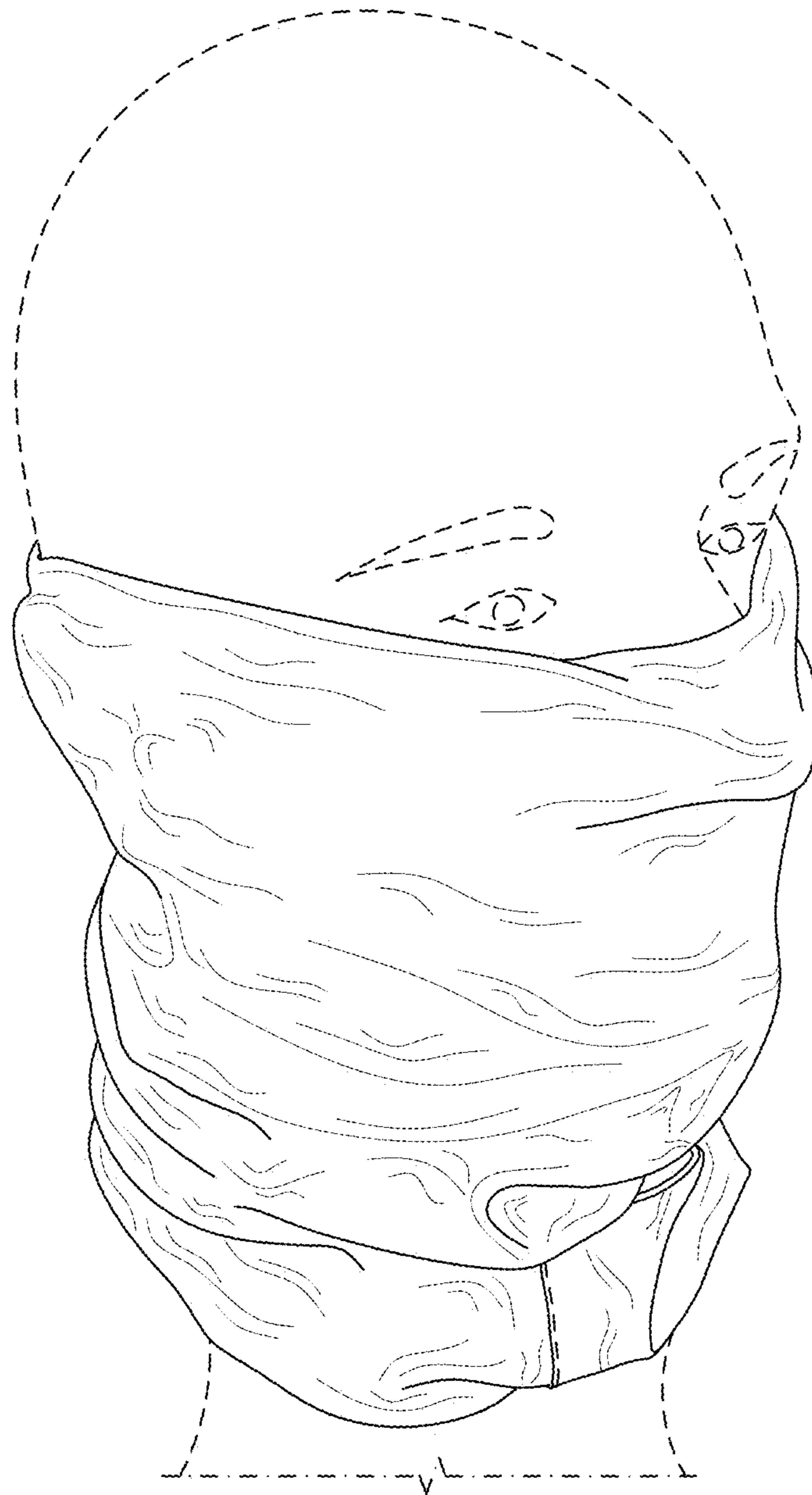

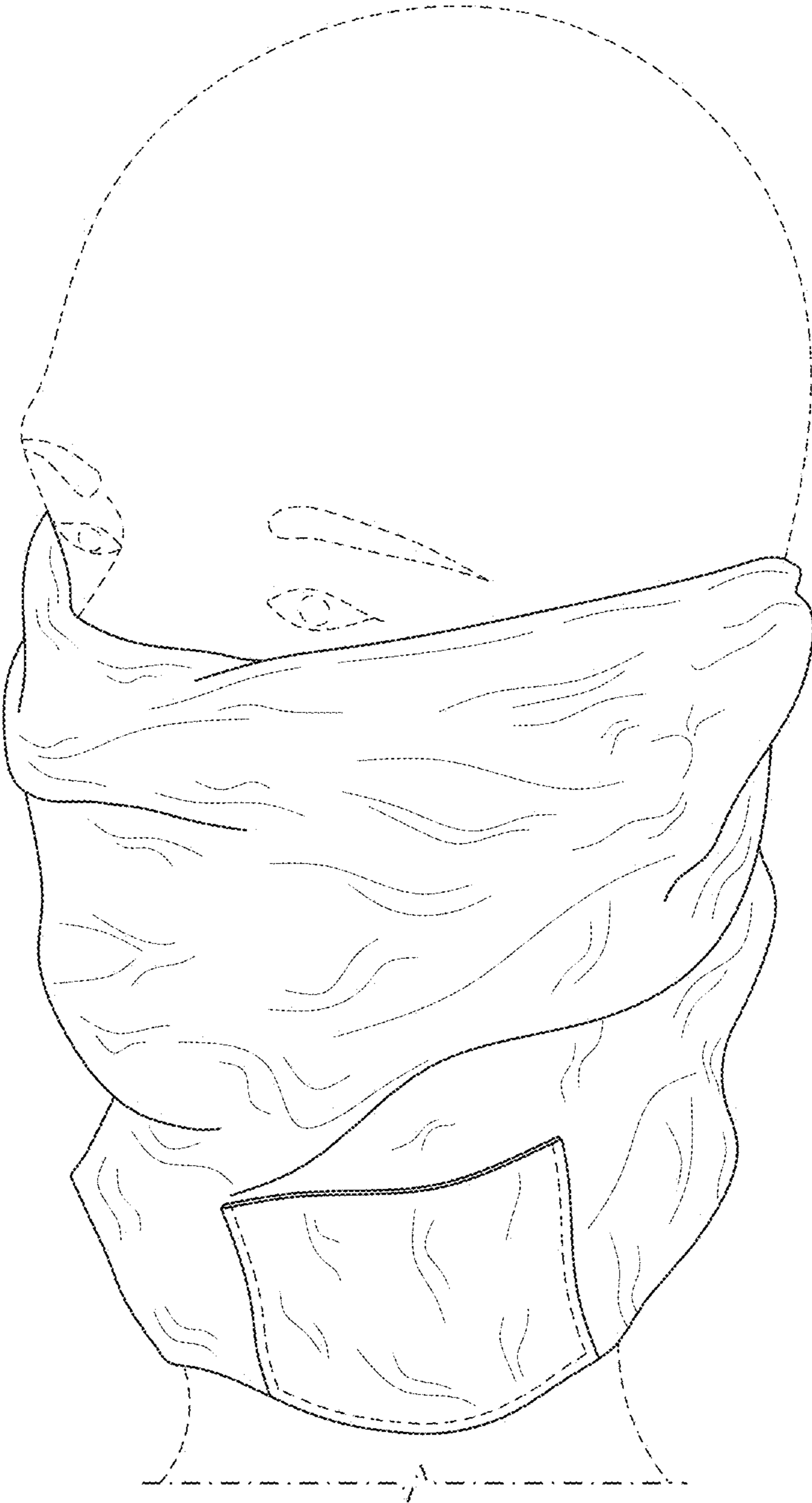

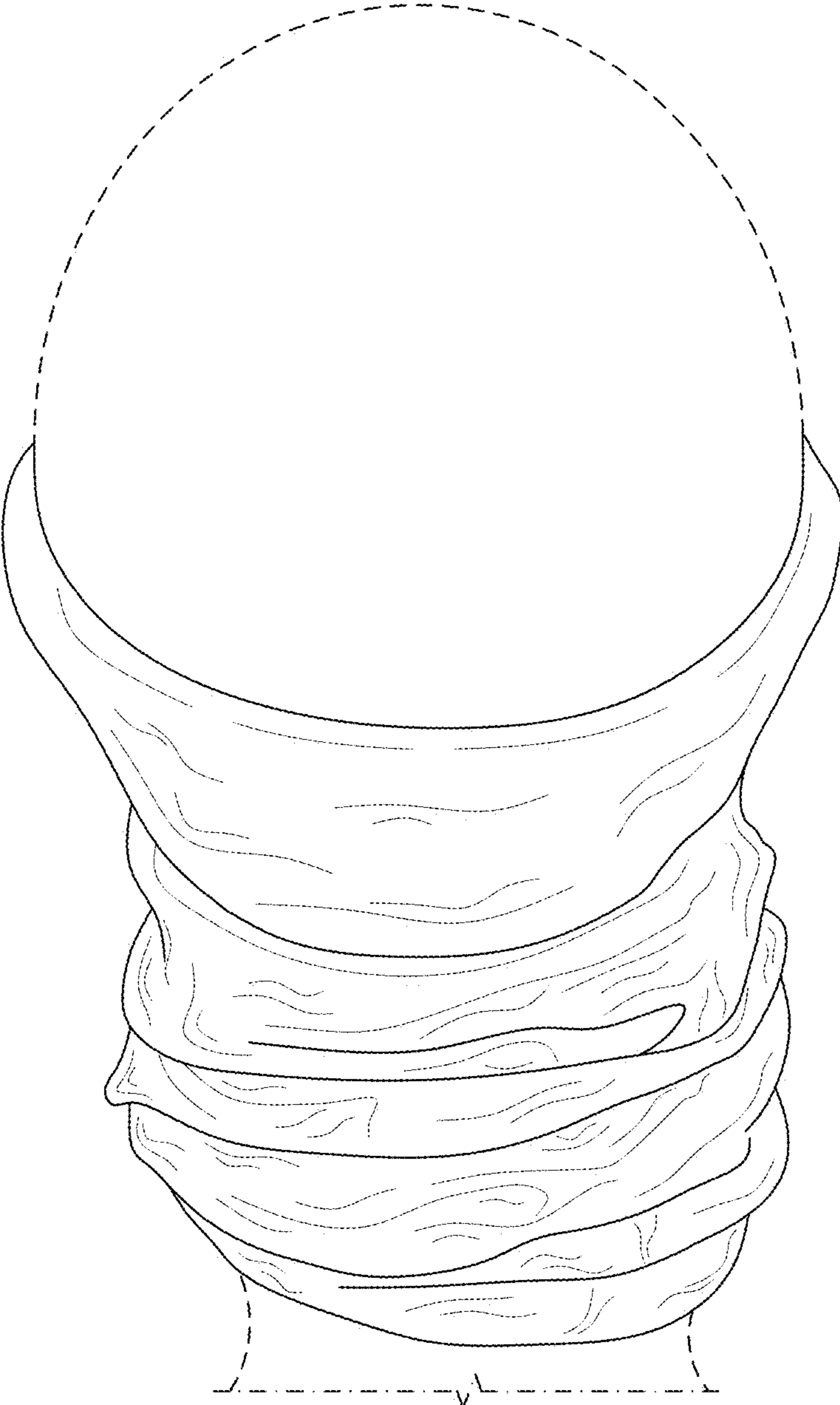

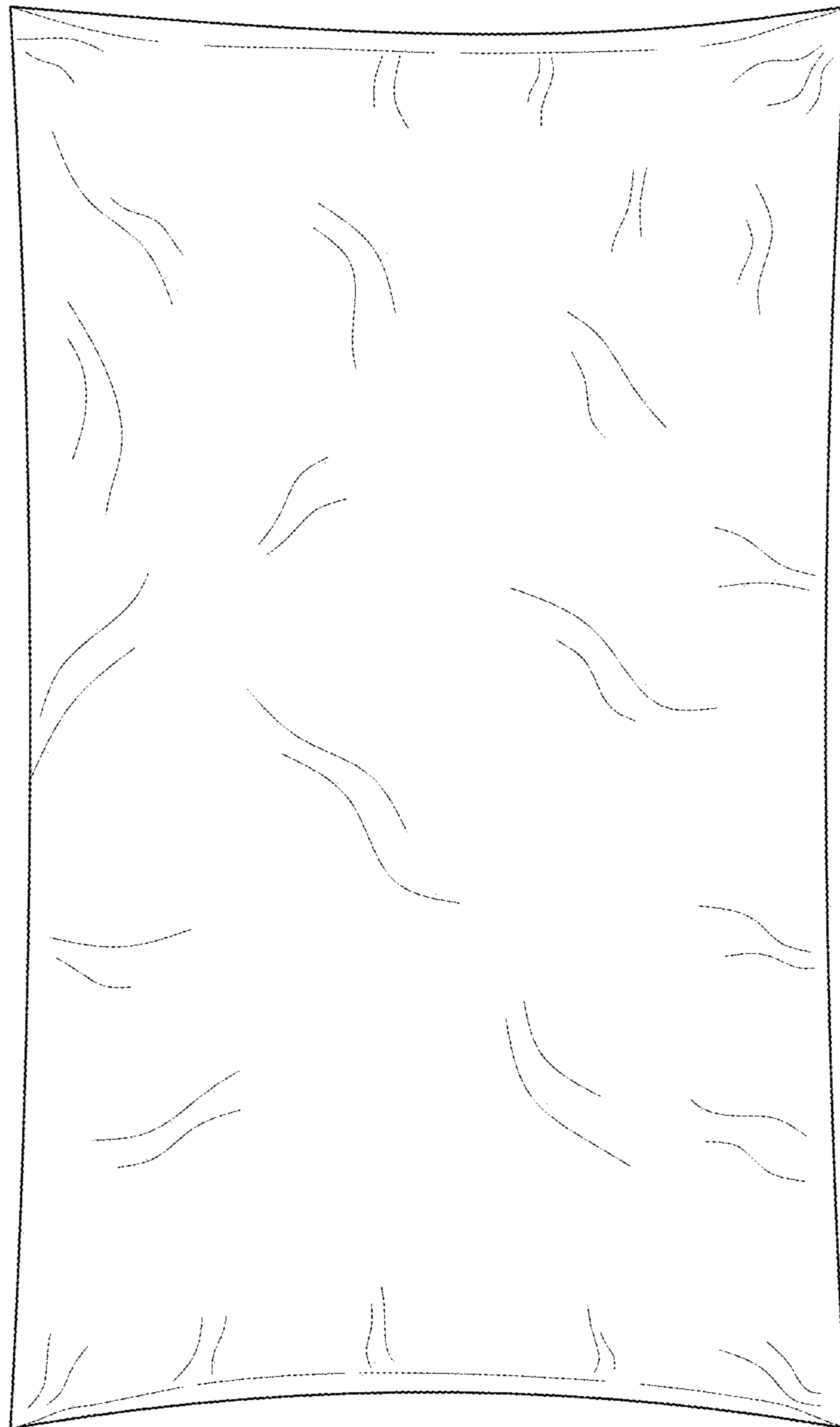

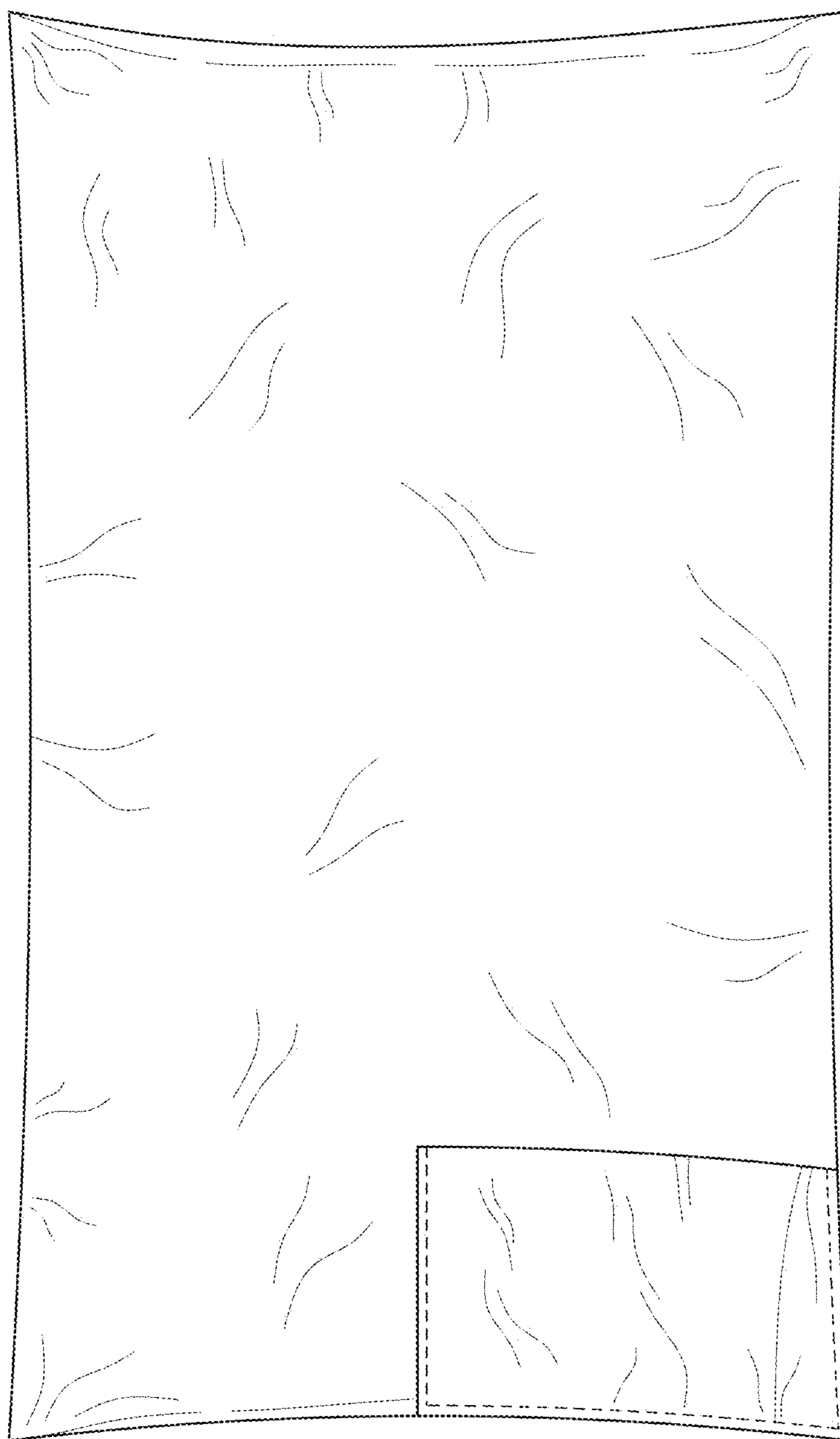

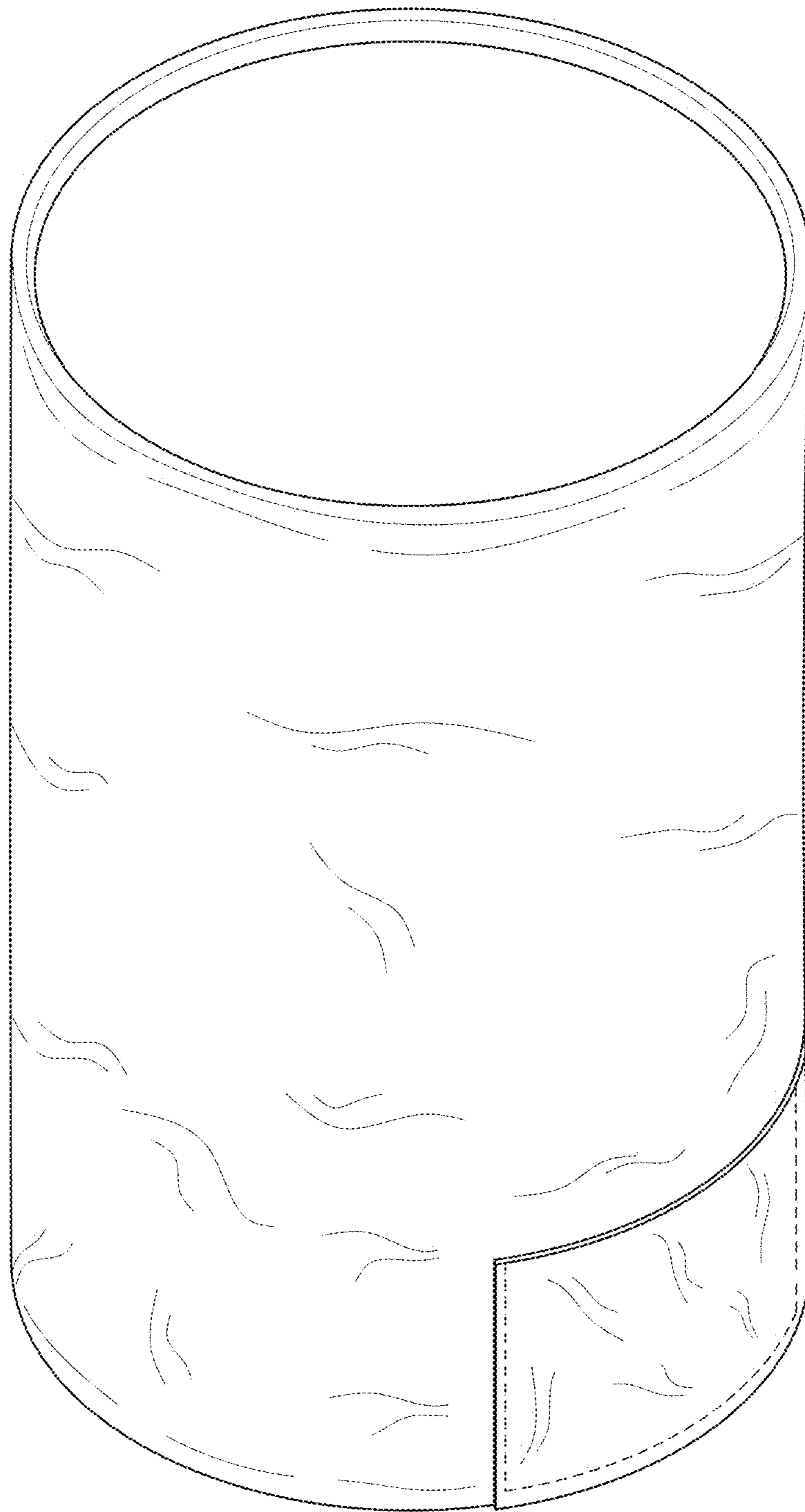

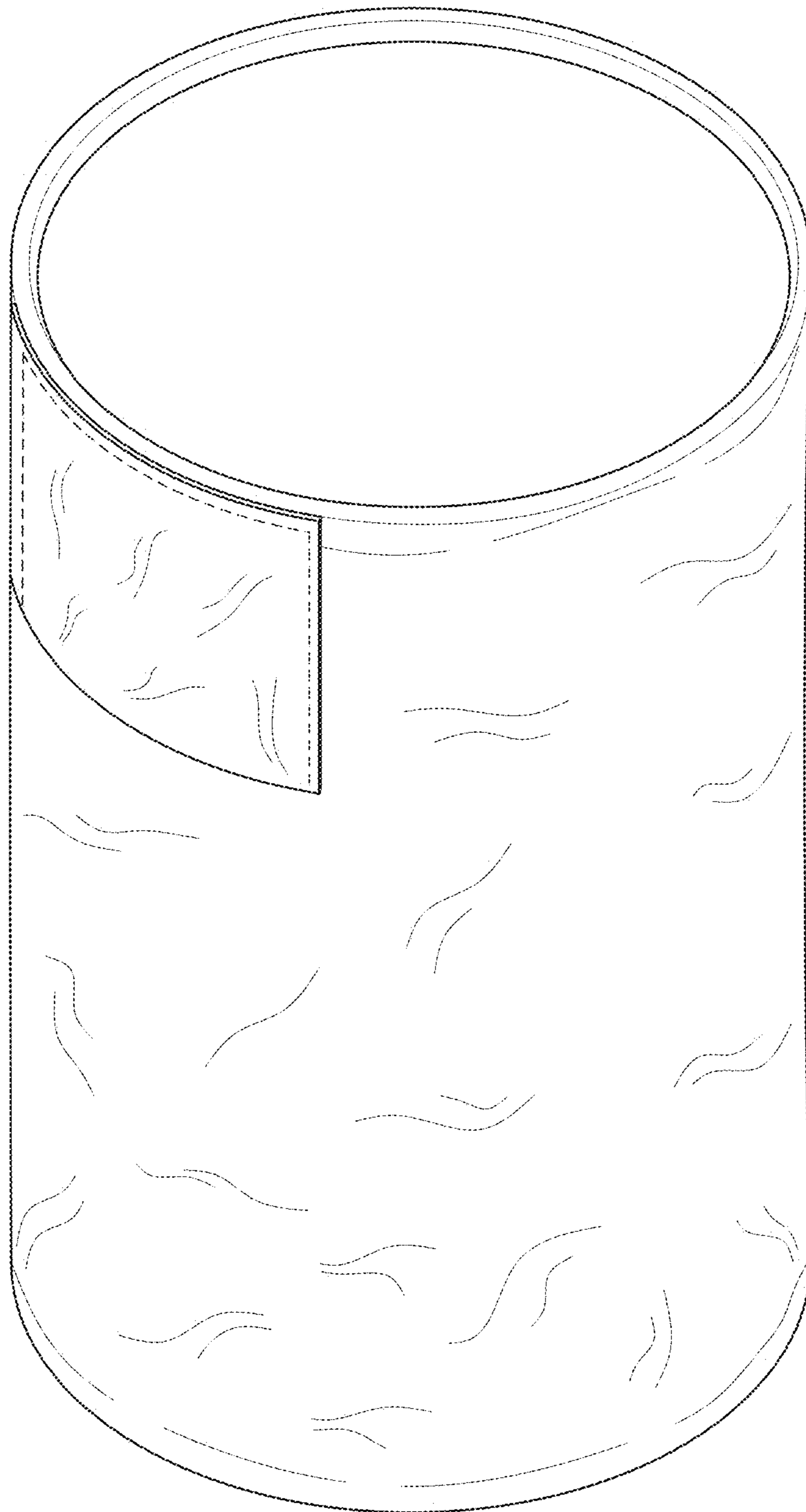

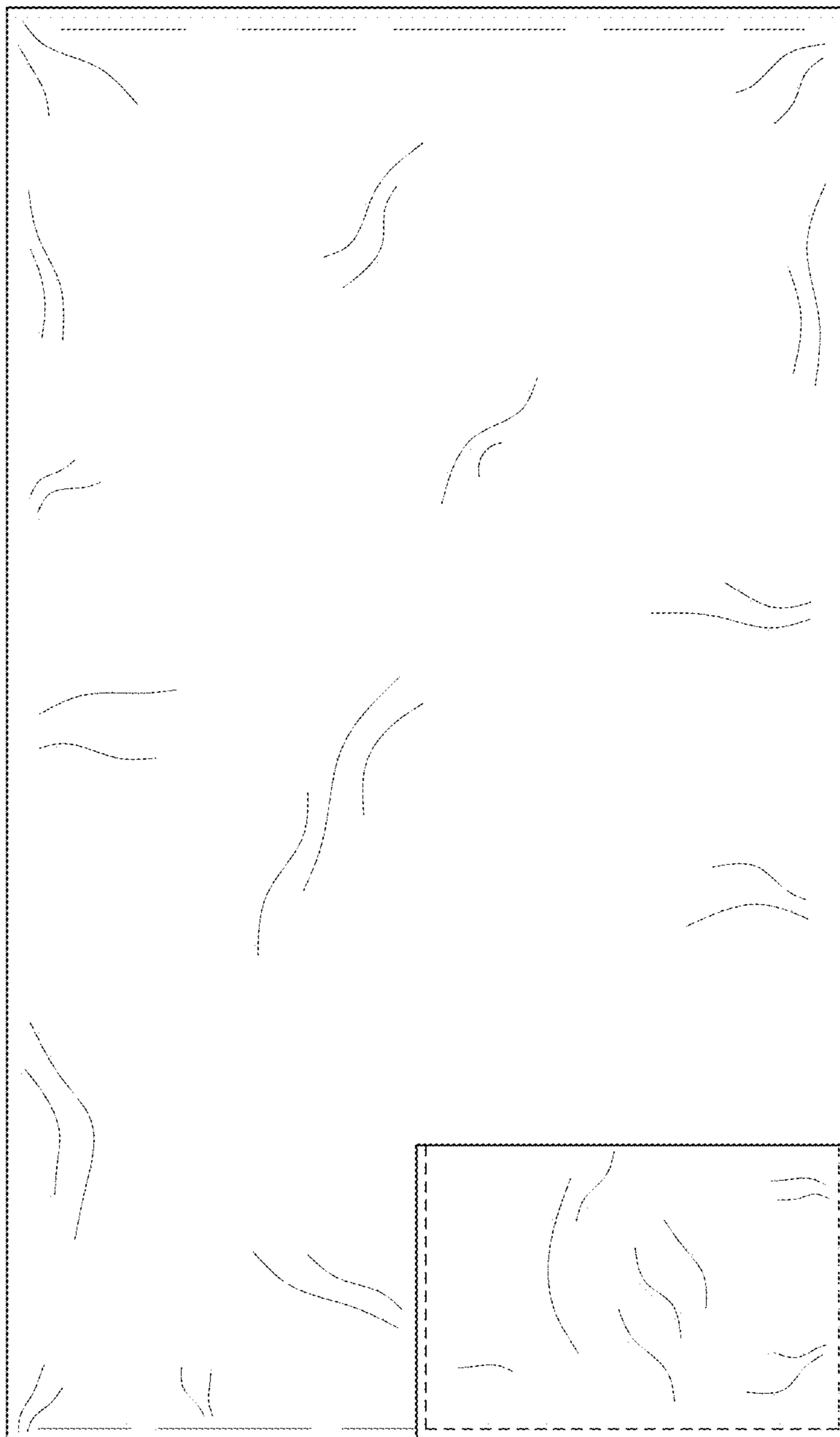

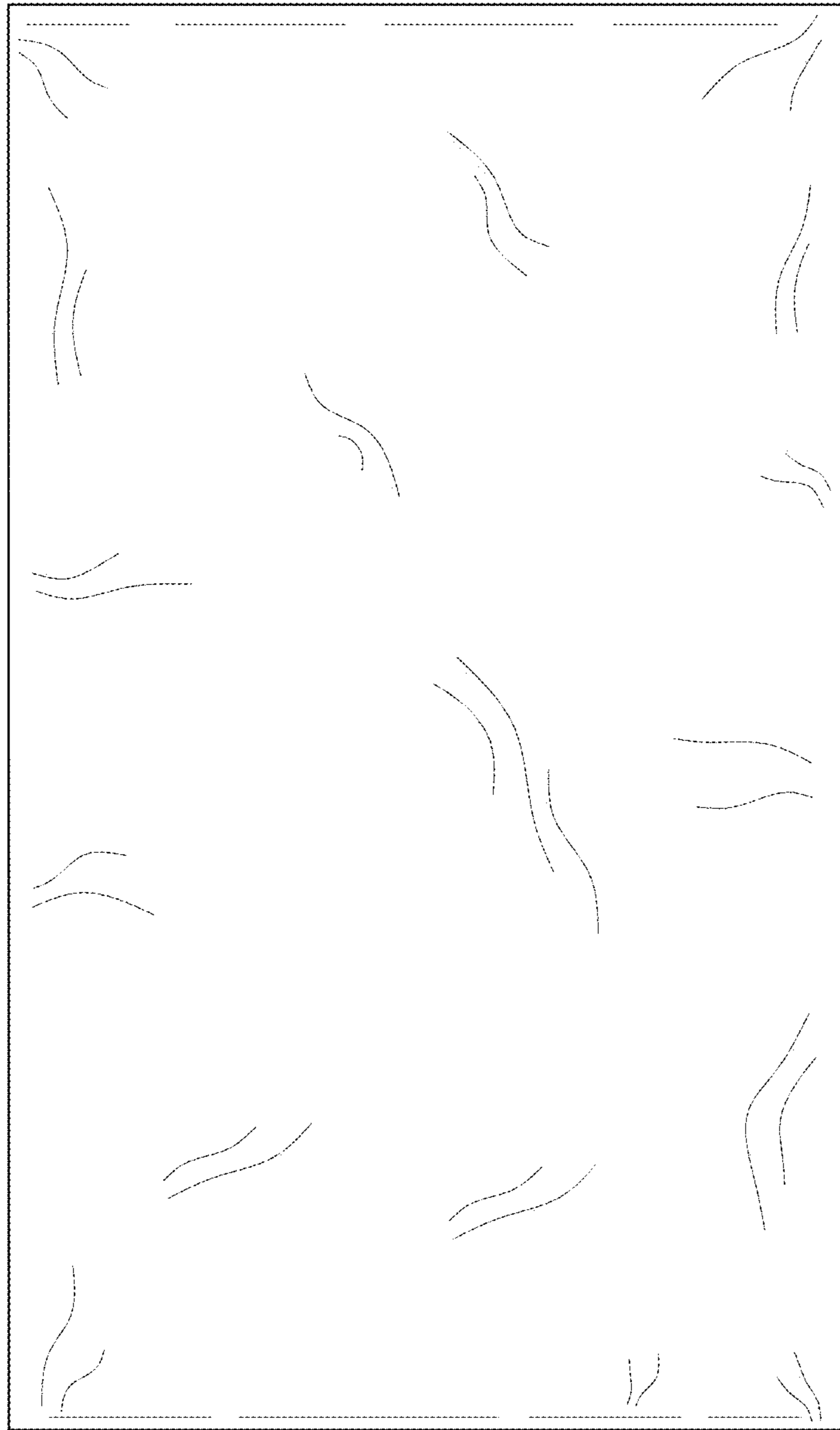

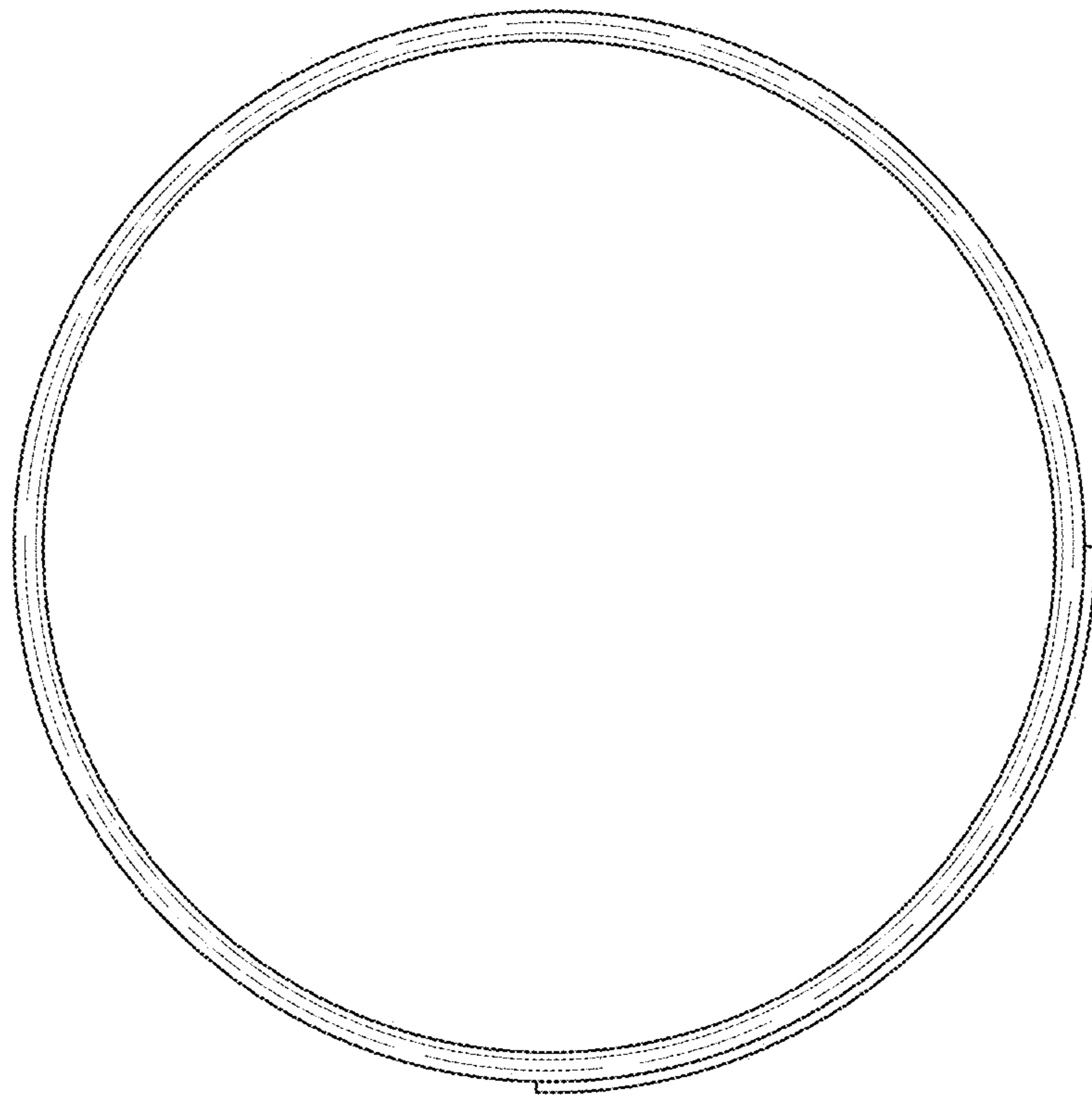

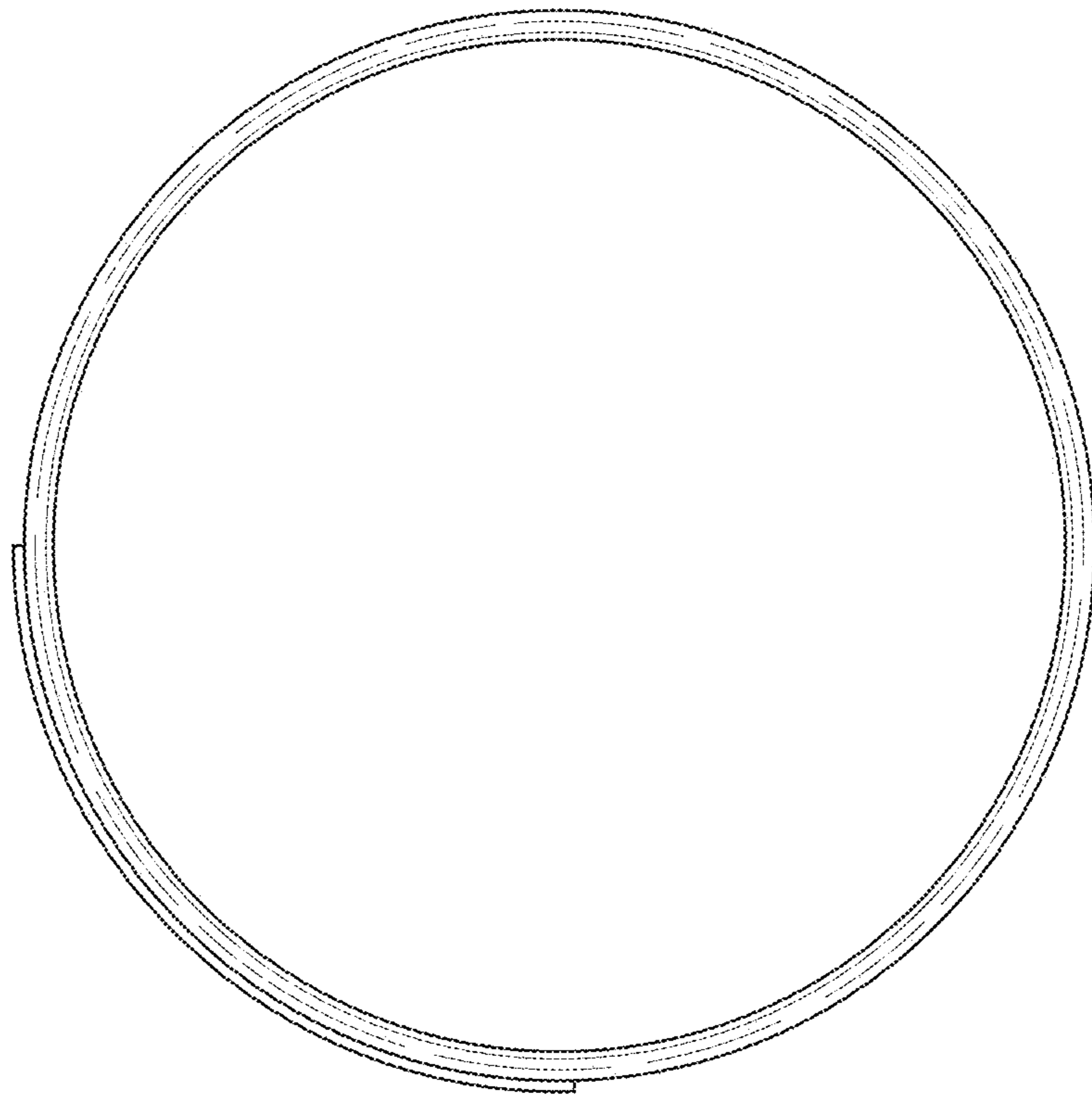

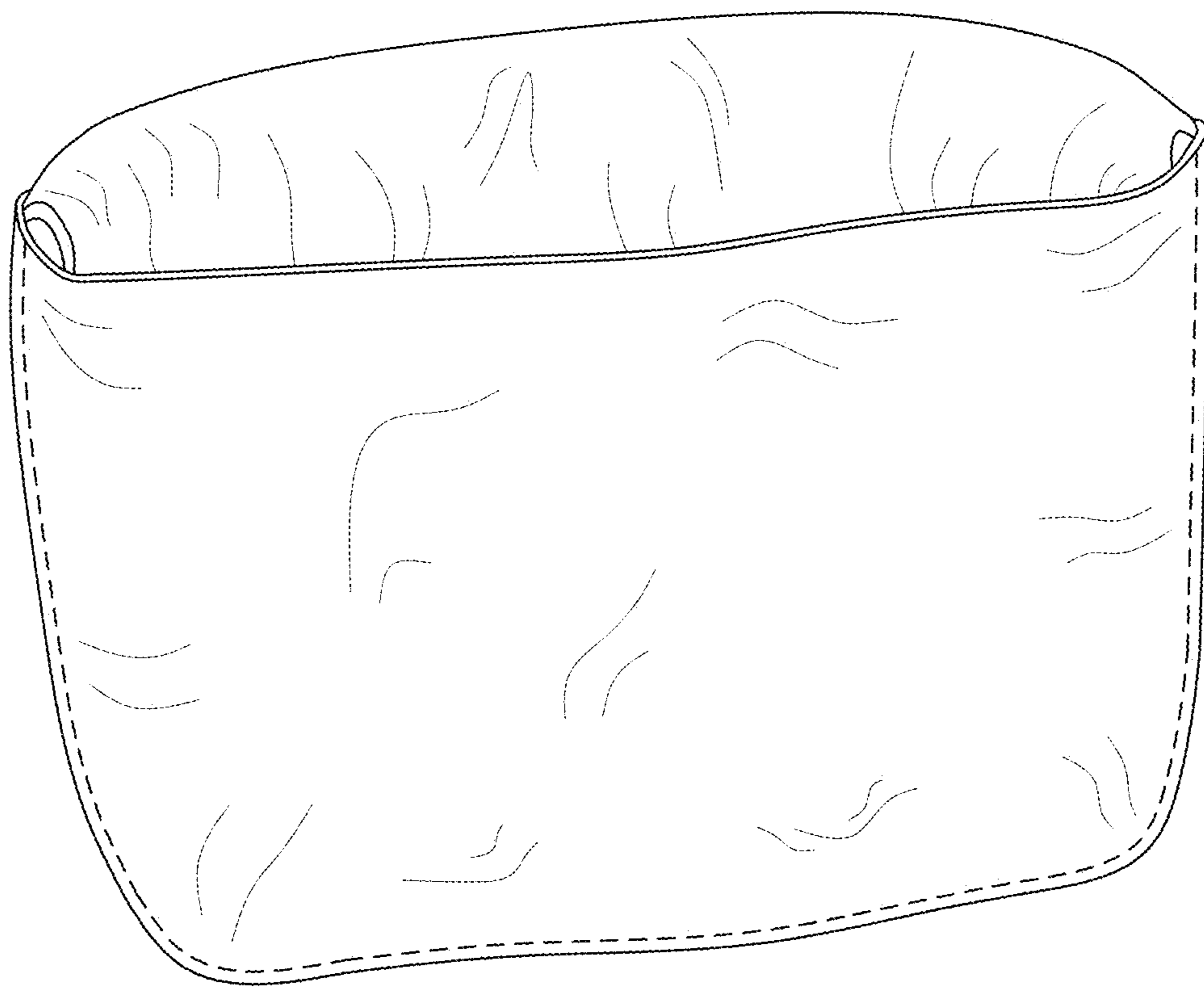

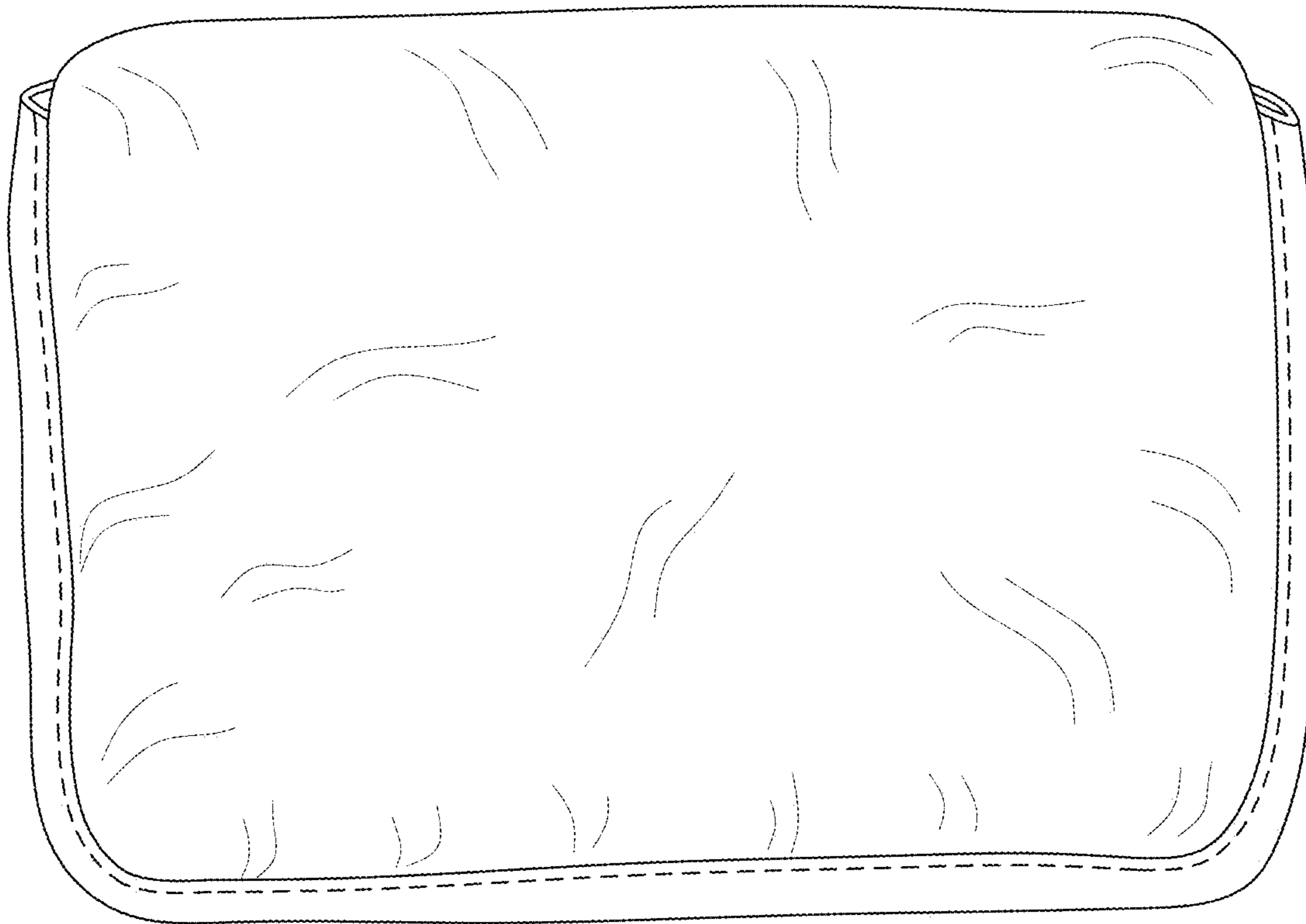

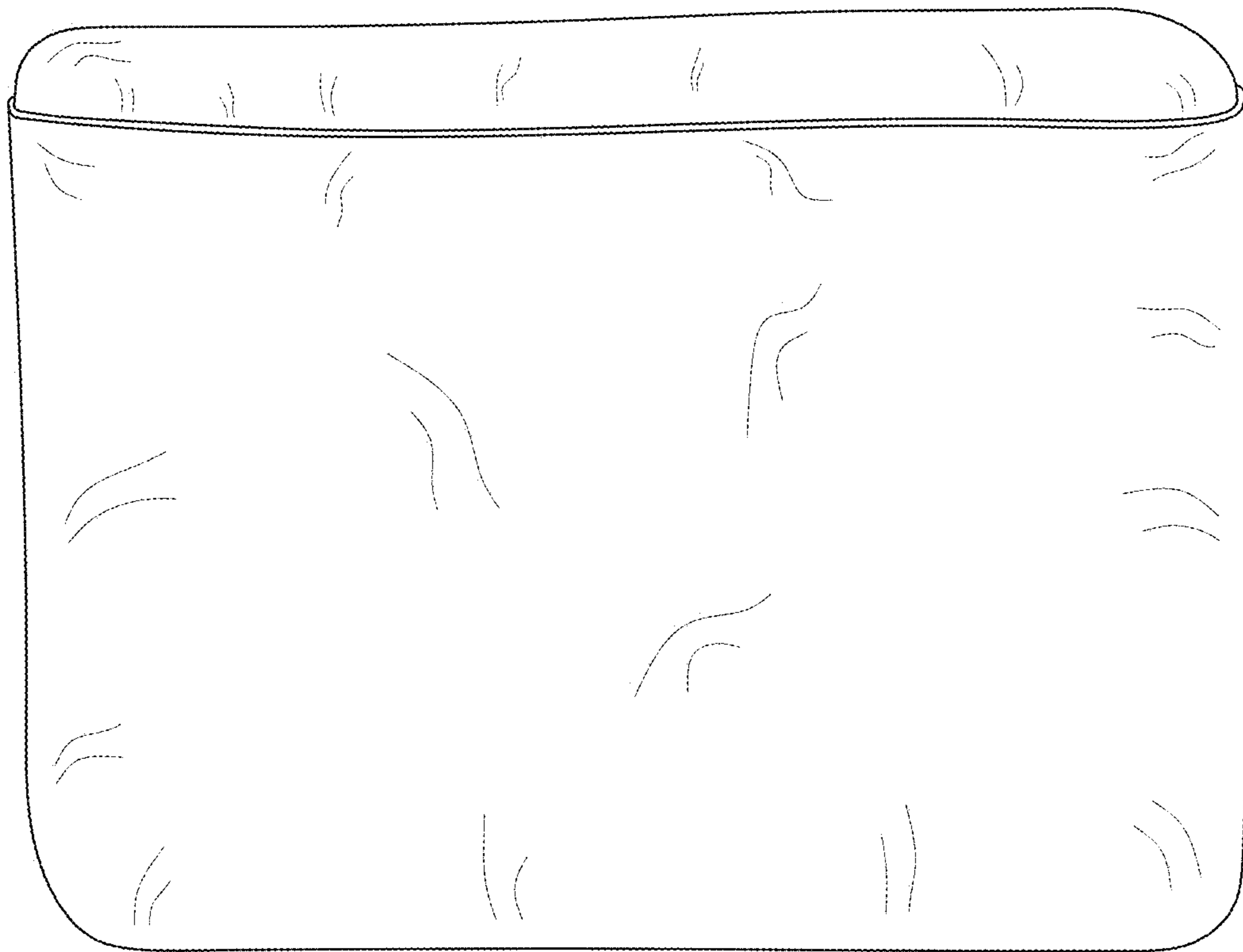
