DESCRIPTION

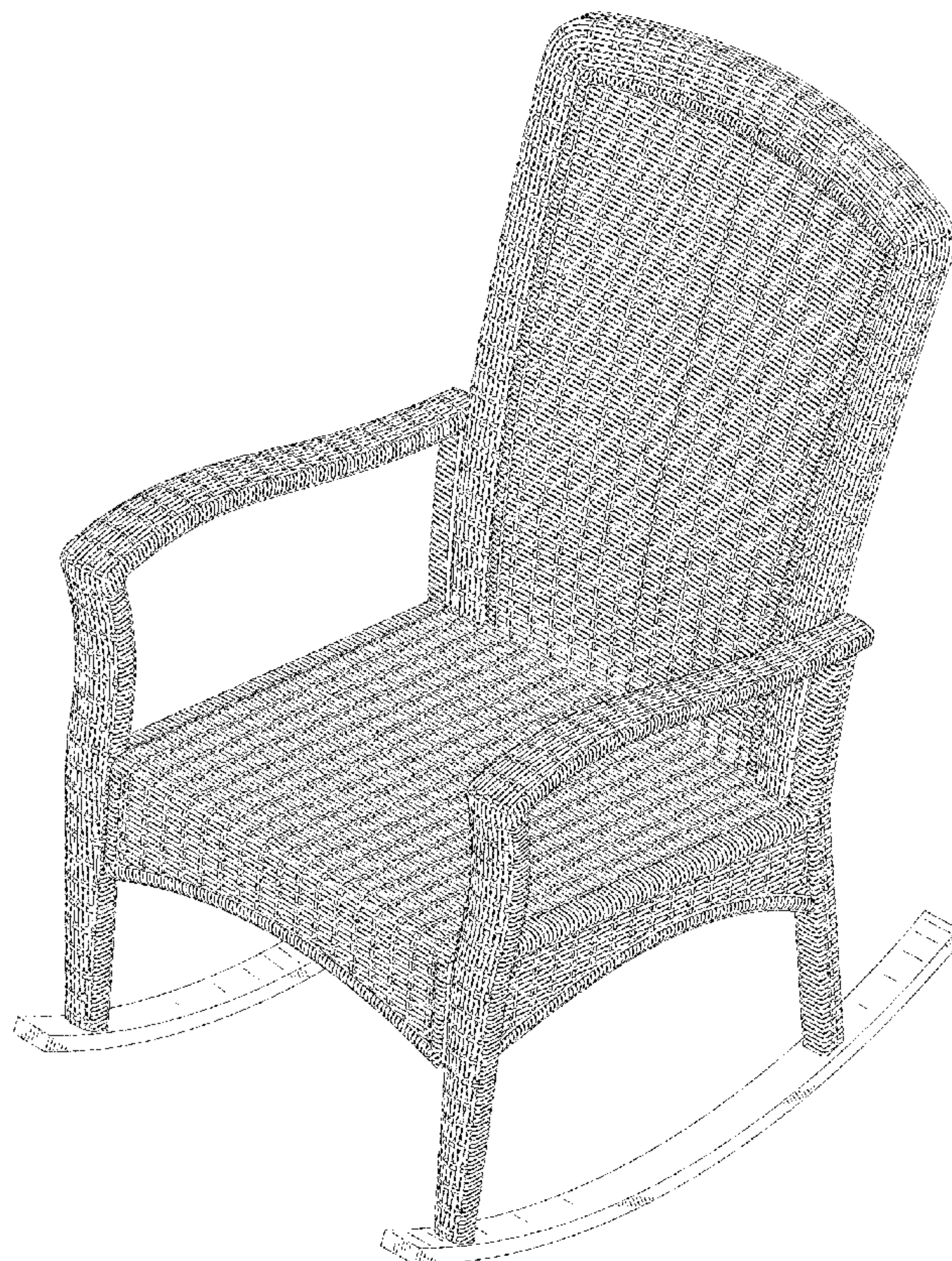
FIG. 1 is a front and top perspective view of a rocking chair, showing my new design;

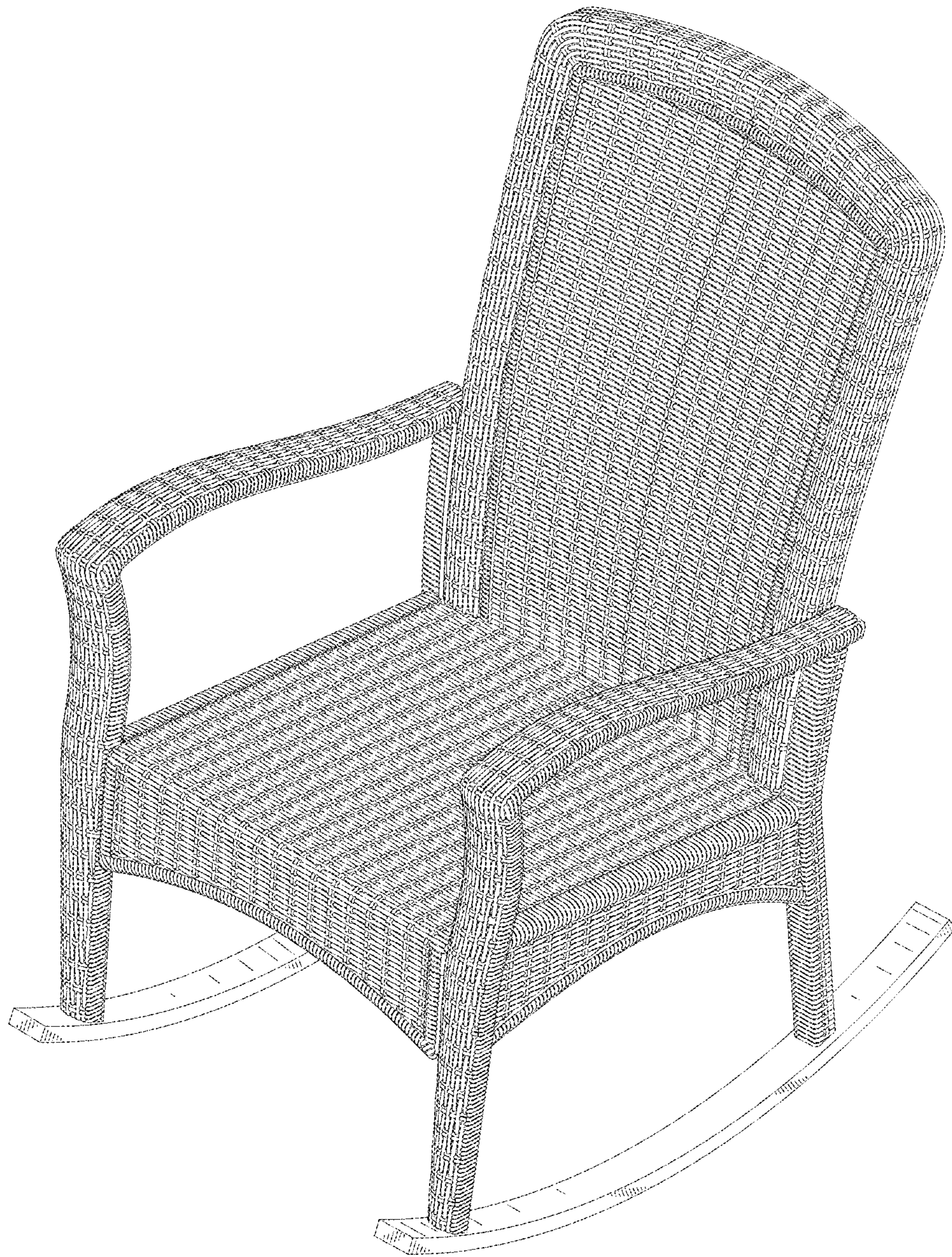

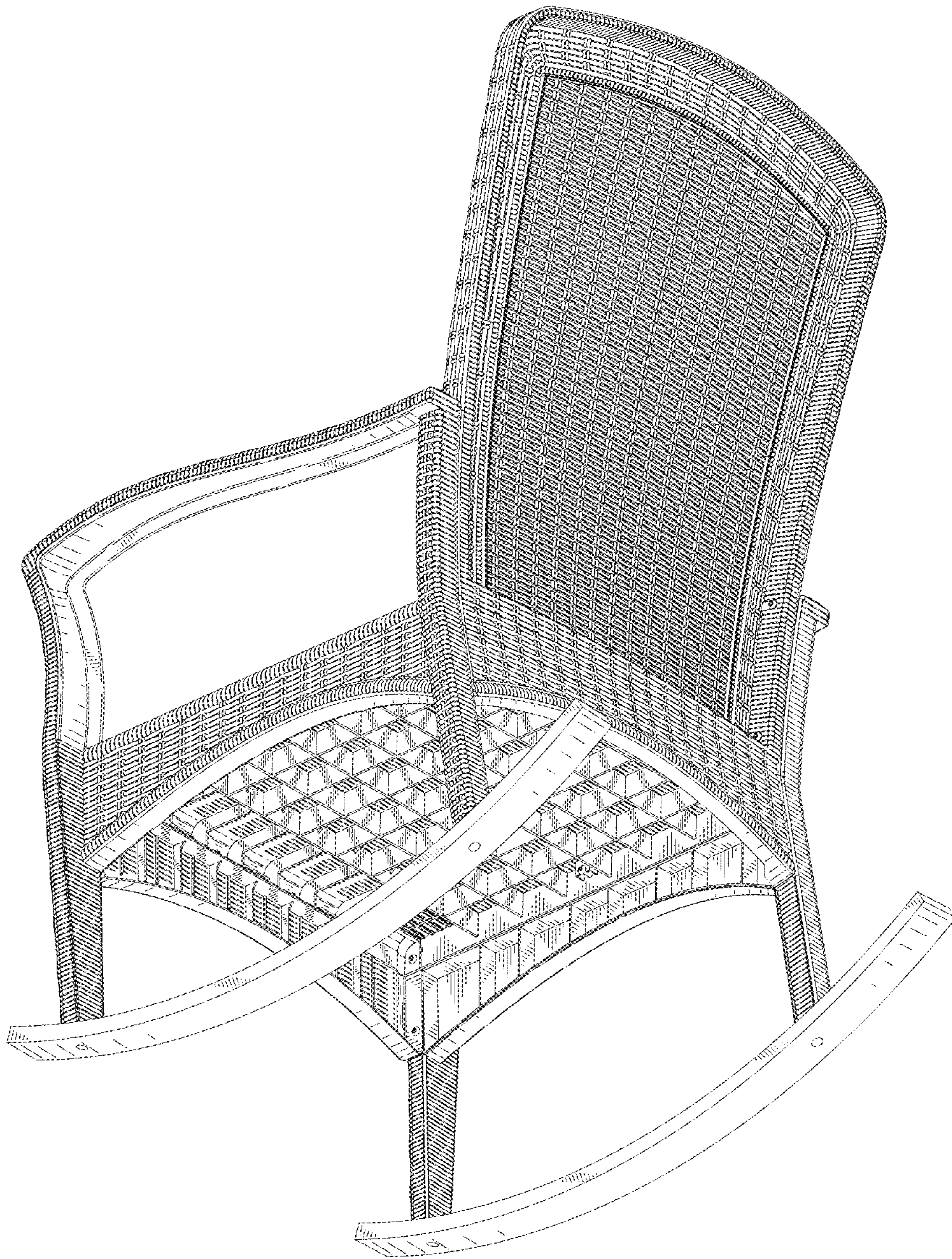

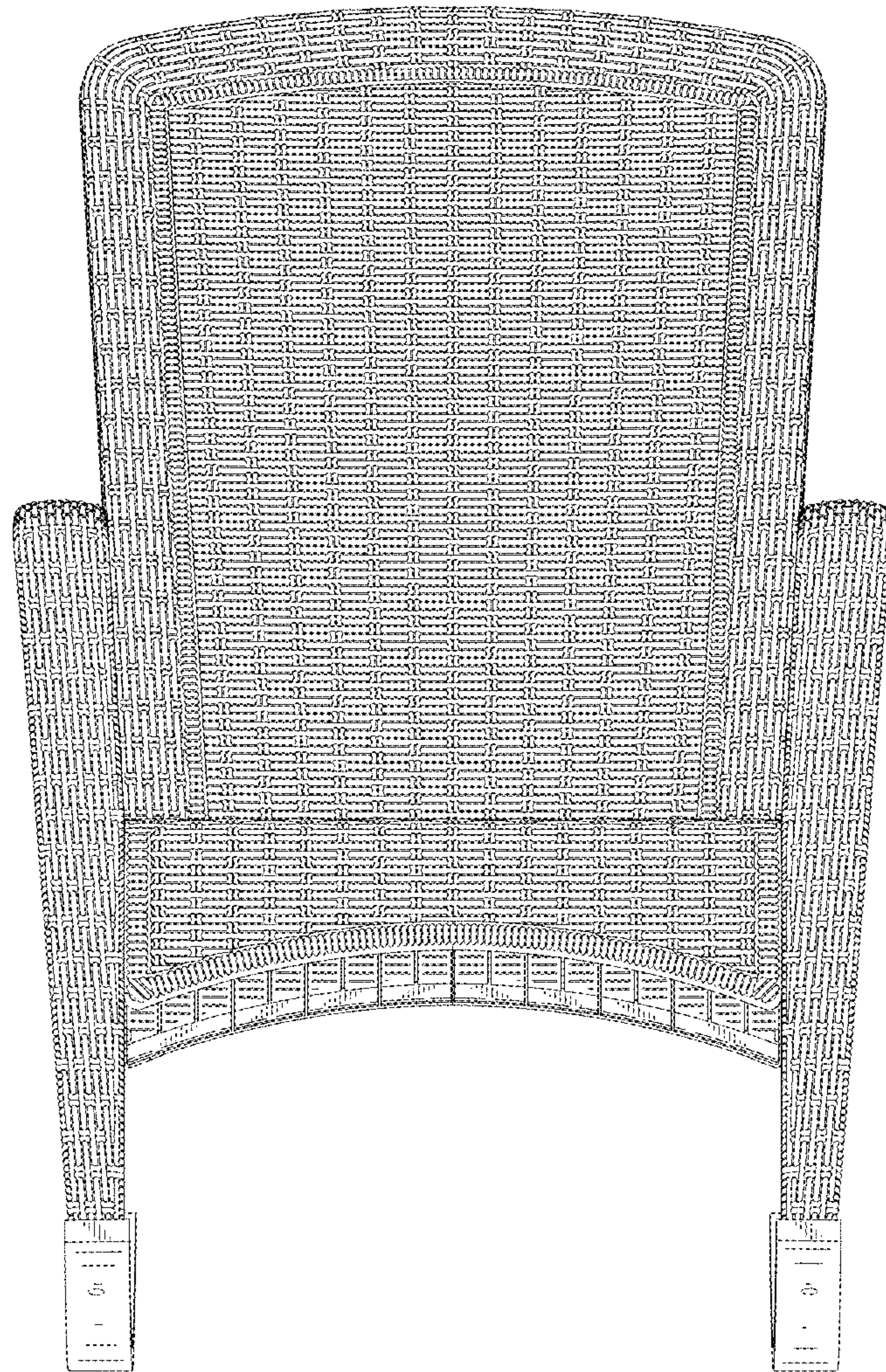

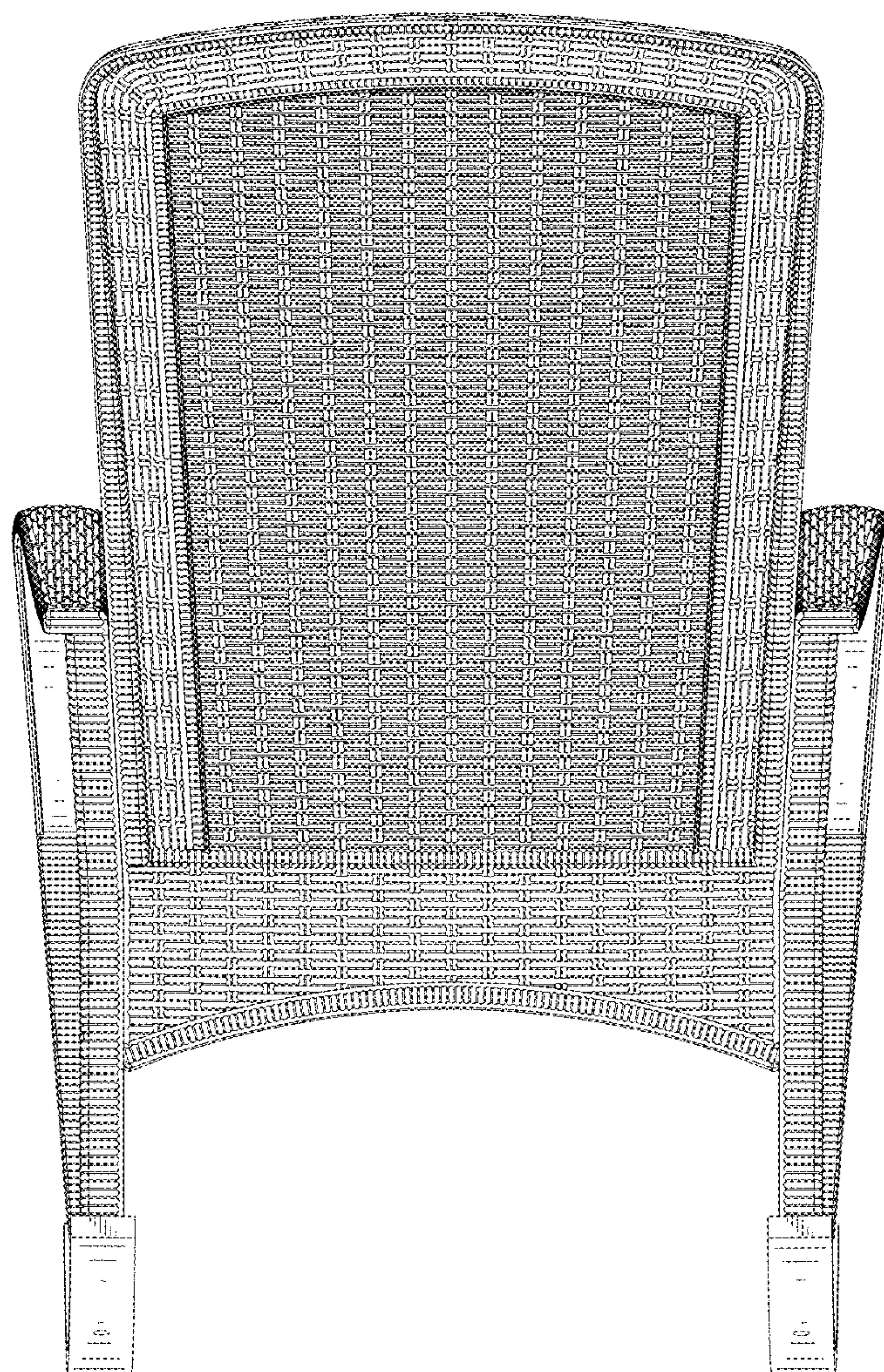

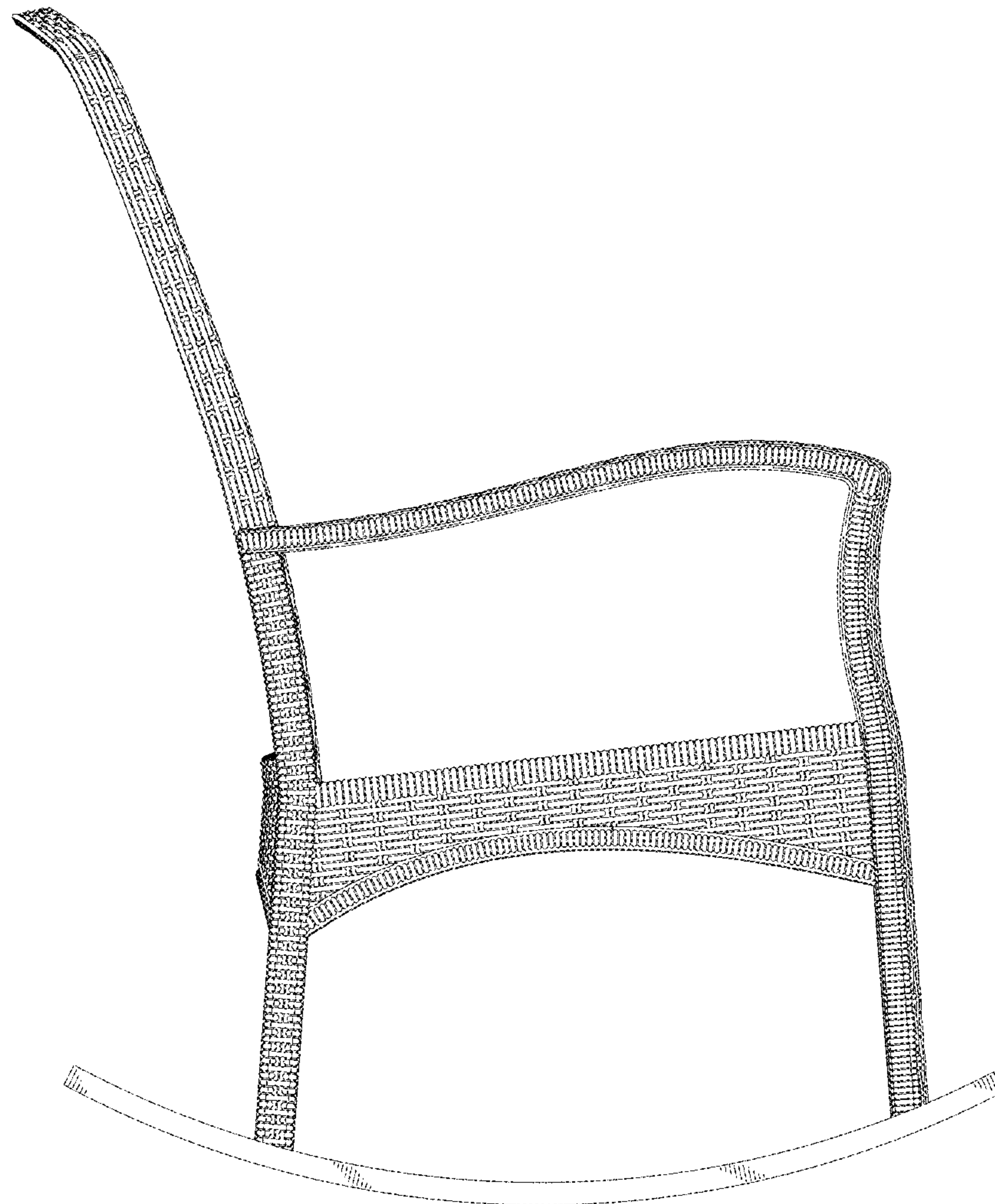

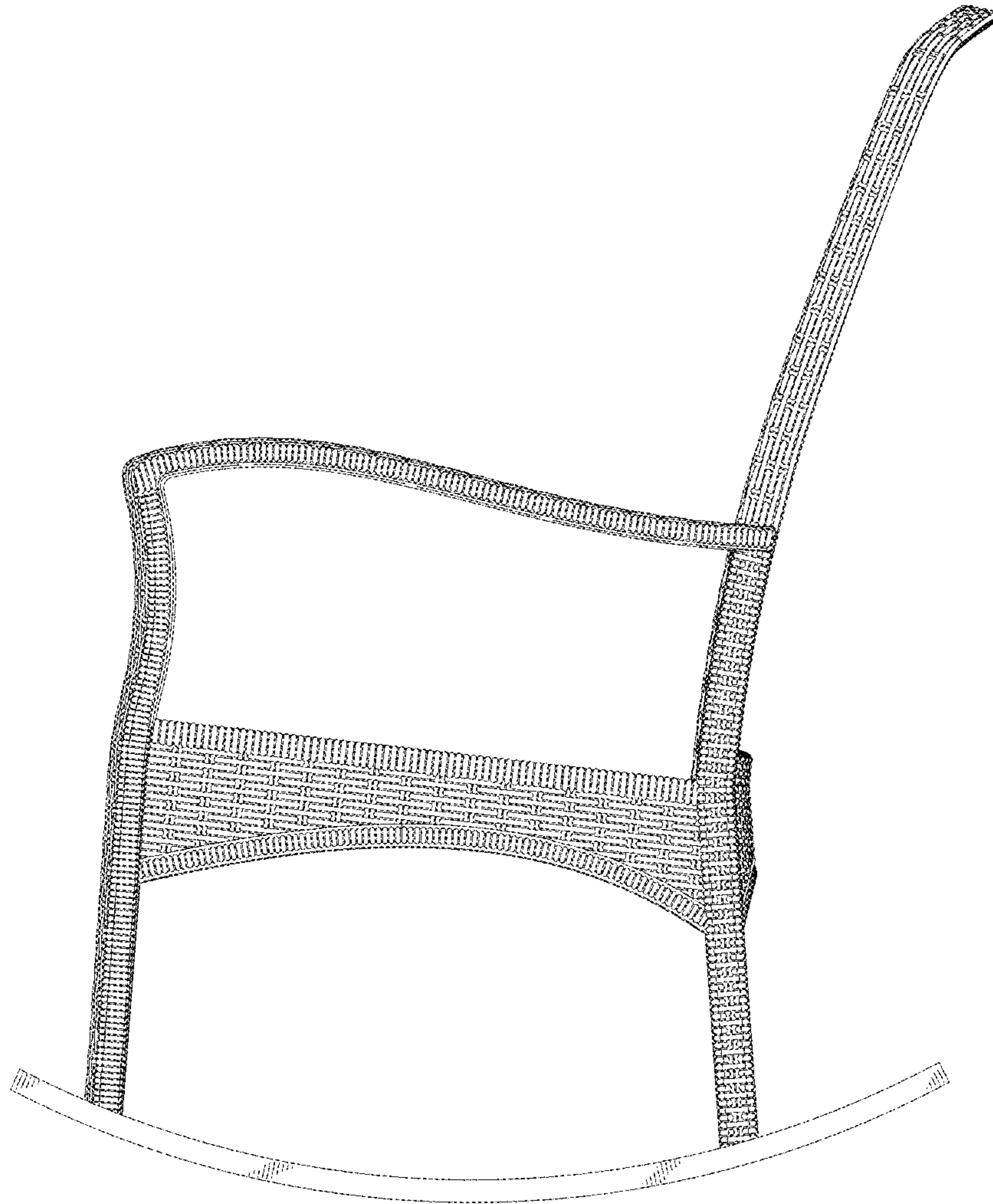

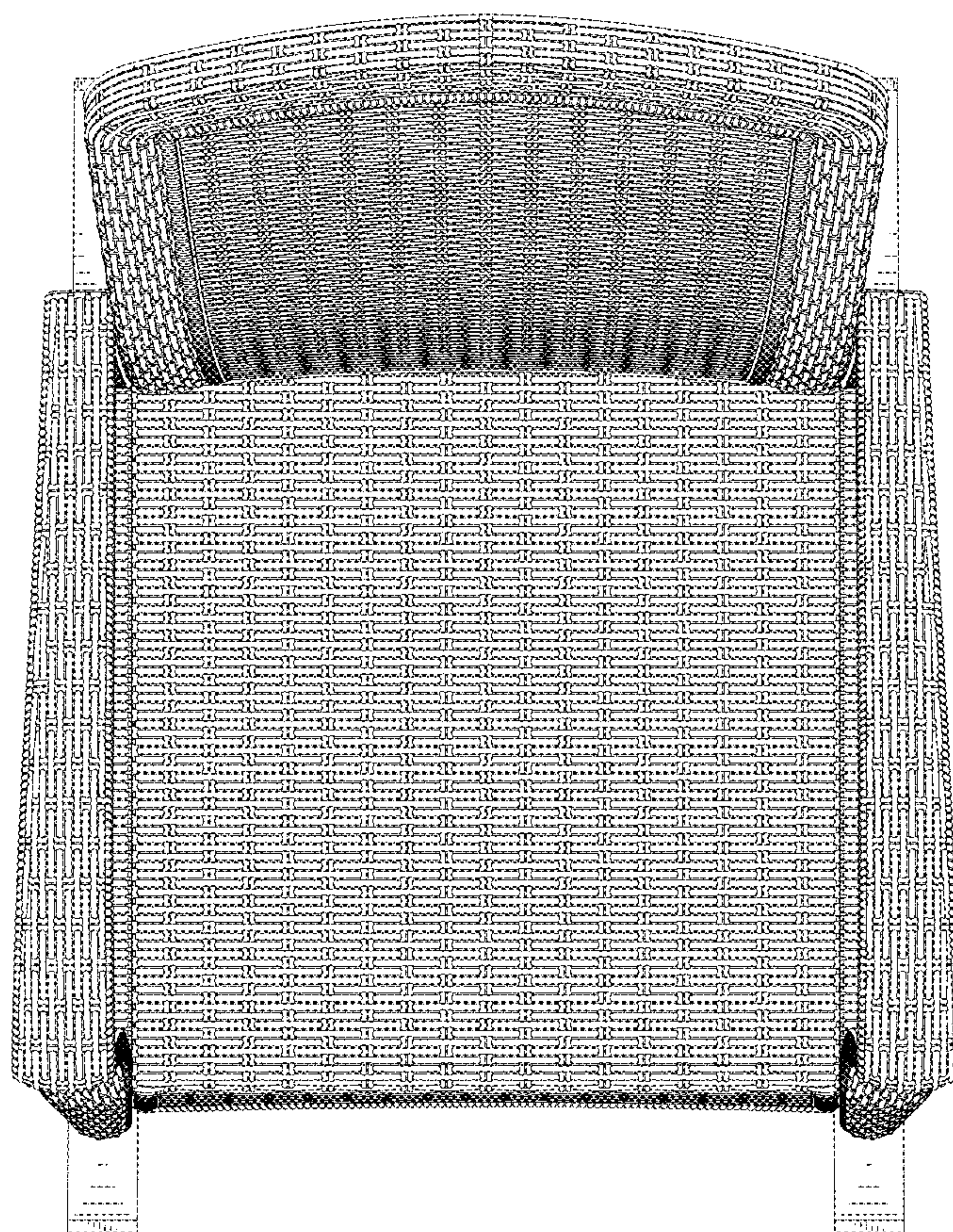

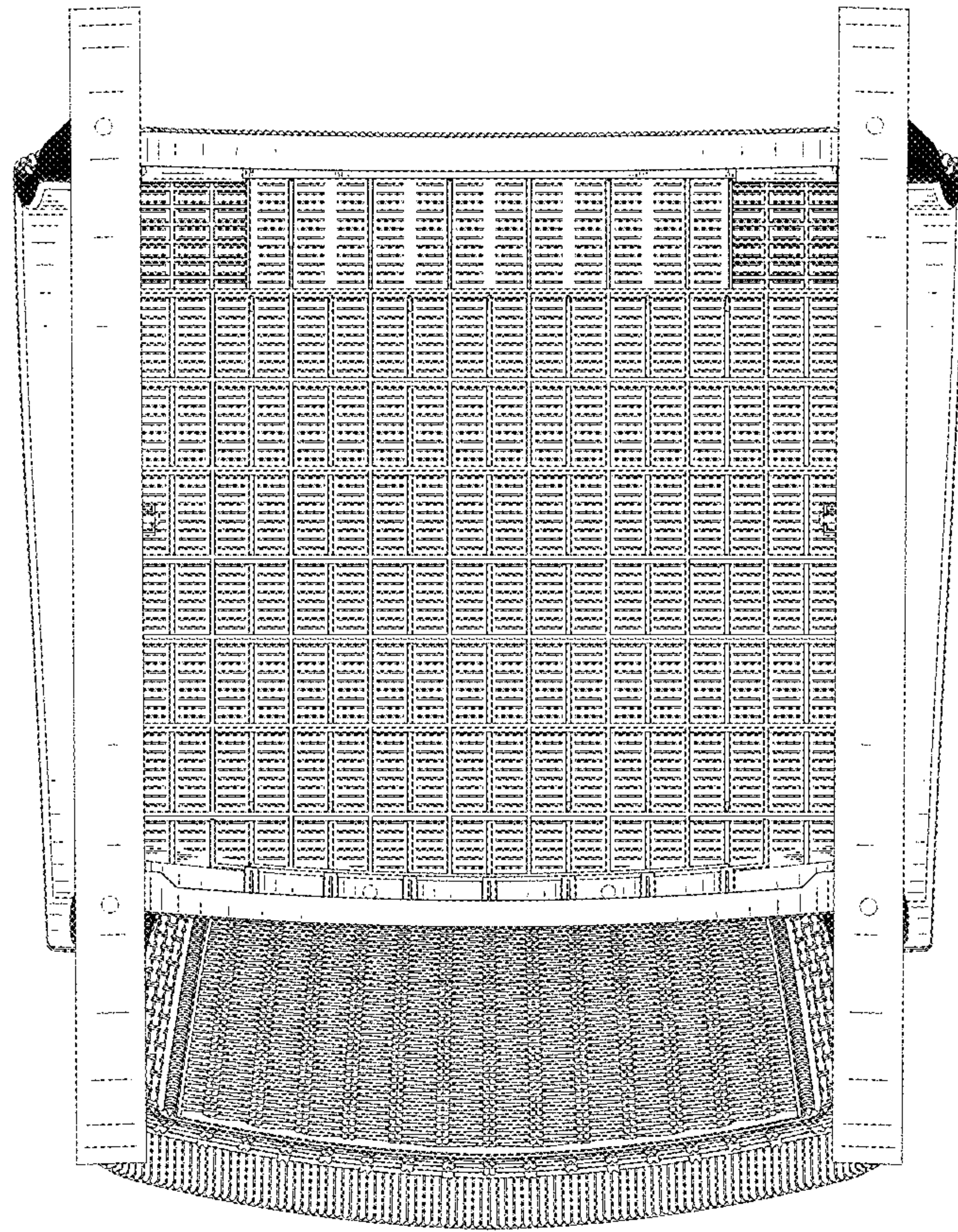
