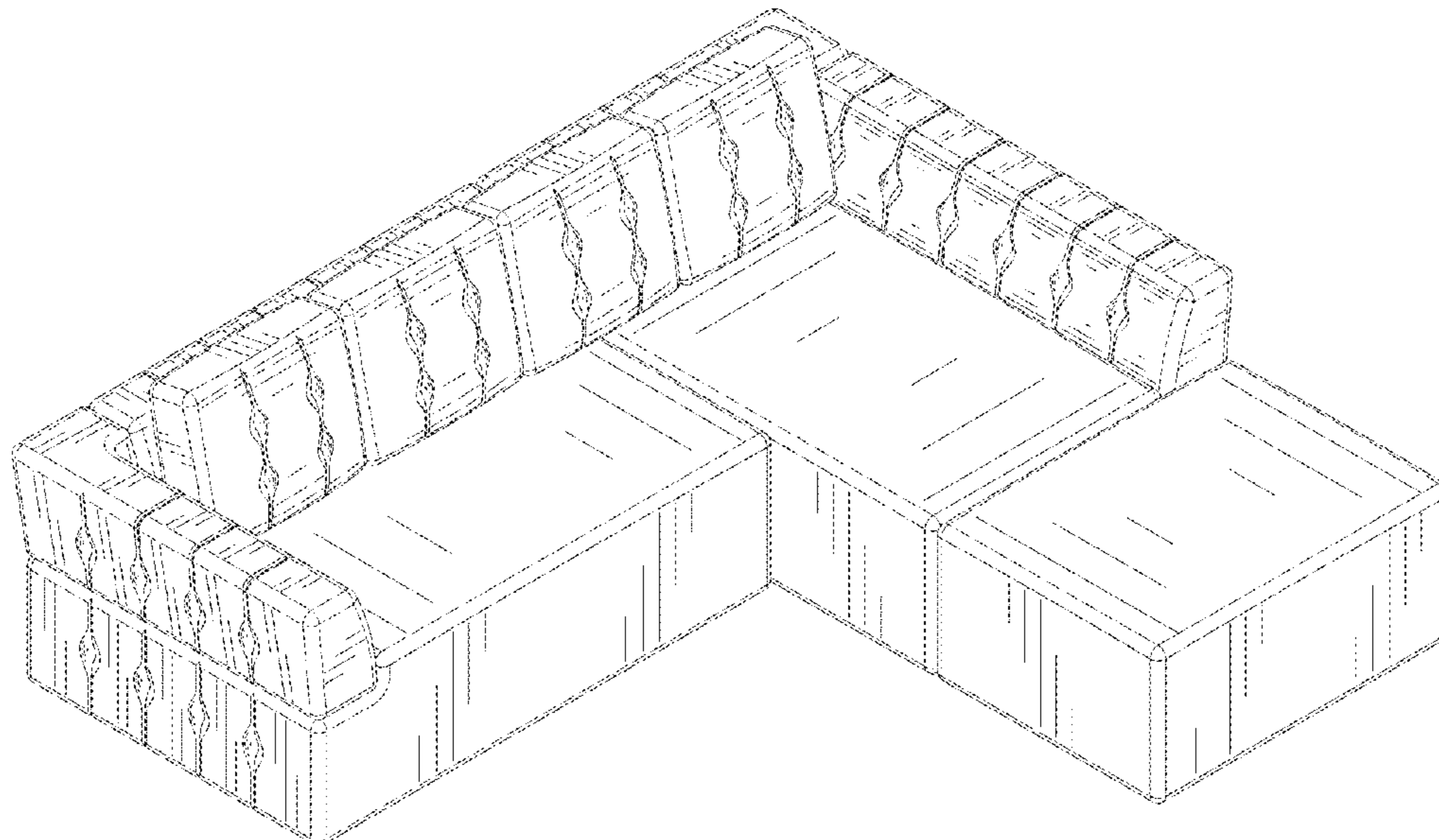
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, left and top perspective view of a sectional sofa, showing my design.
FIG. 2 is a front elevation view thereof.
FIG. 3 is a rear elevation view thereof.
FIG. 4 is a left side elevation view thereof.
FIG. 5 is a right side elevation view thereof.
FIG. 6 is a top plan view thereof; and,

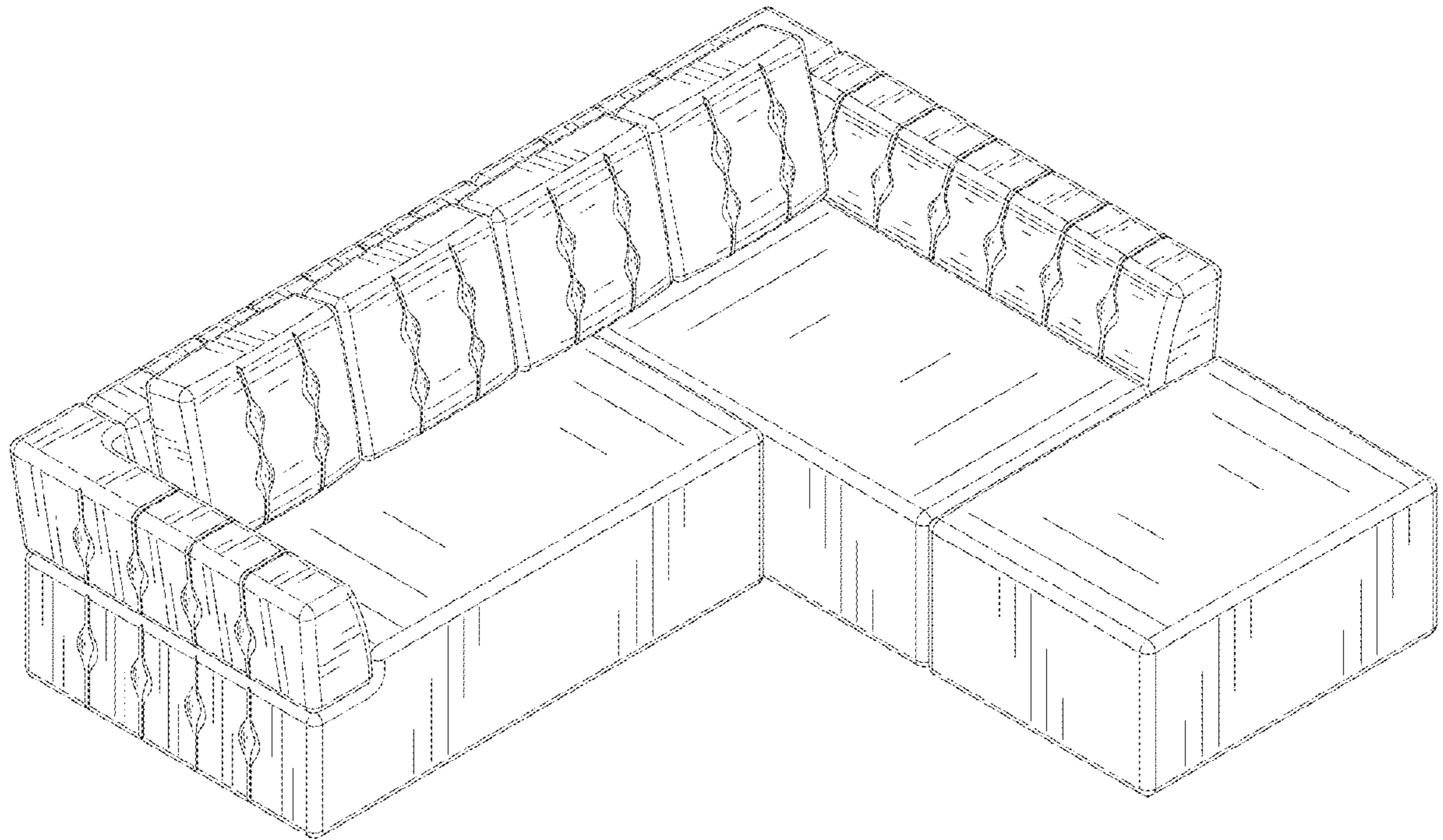

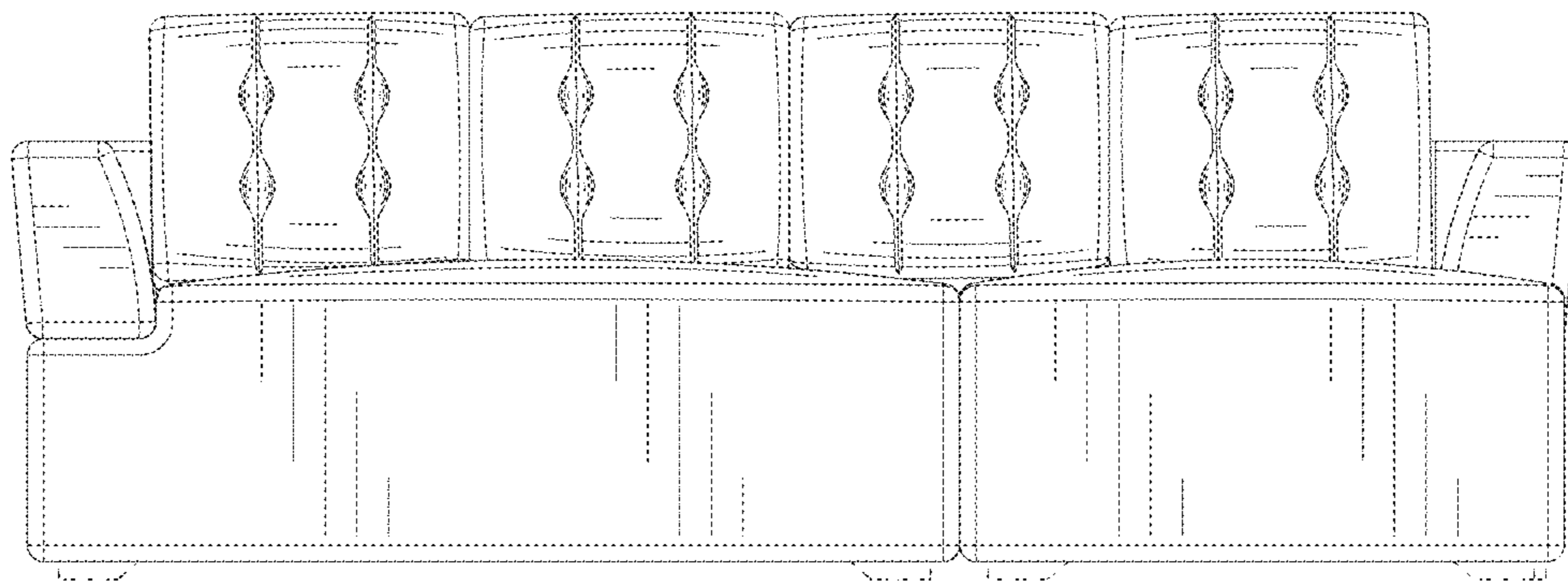

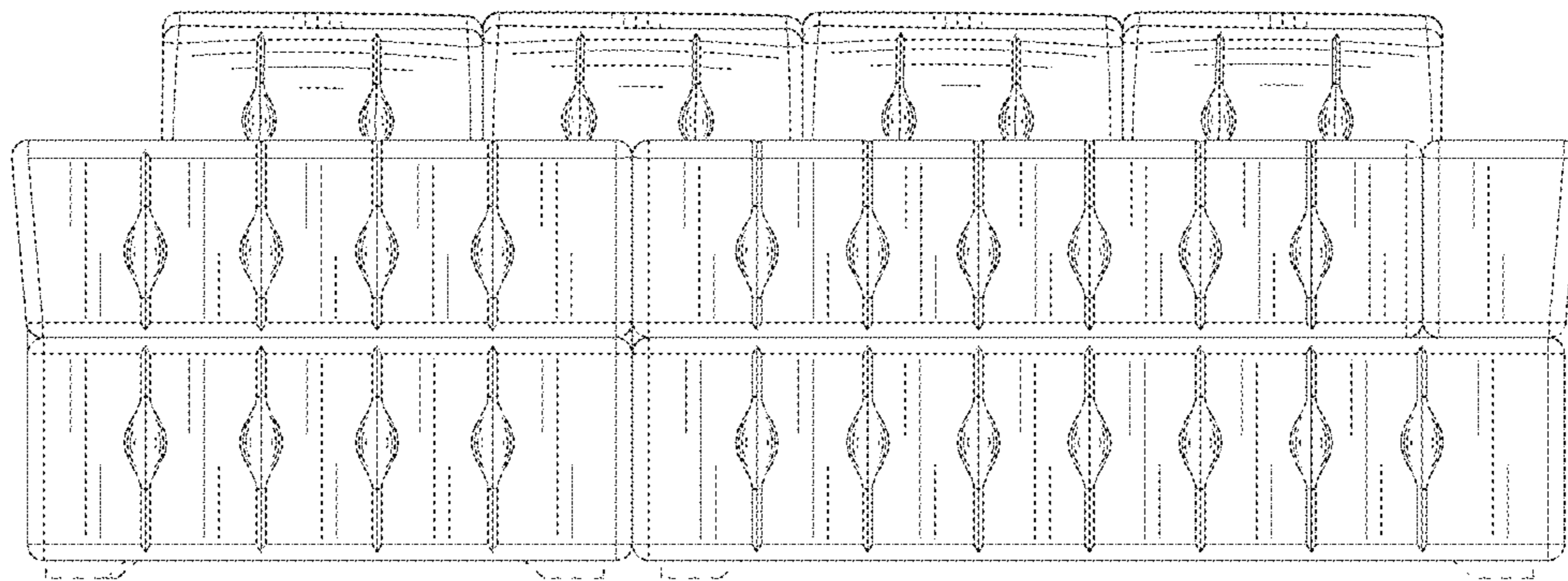

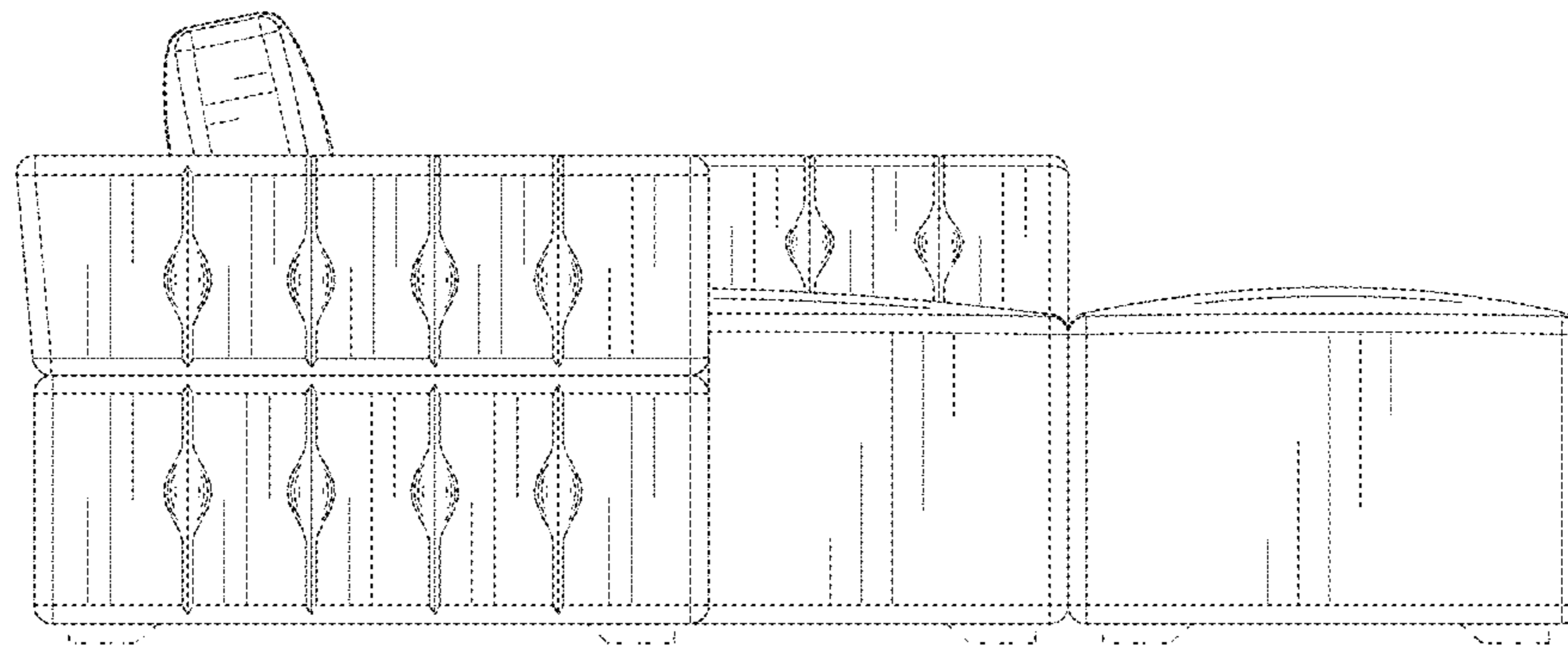

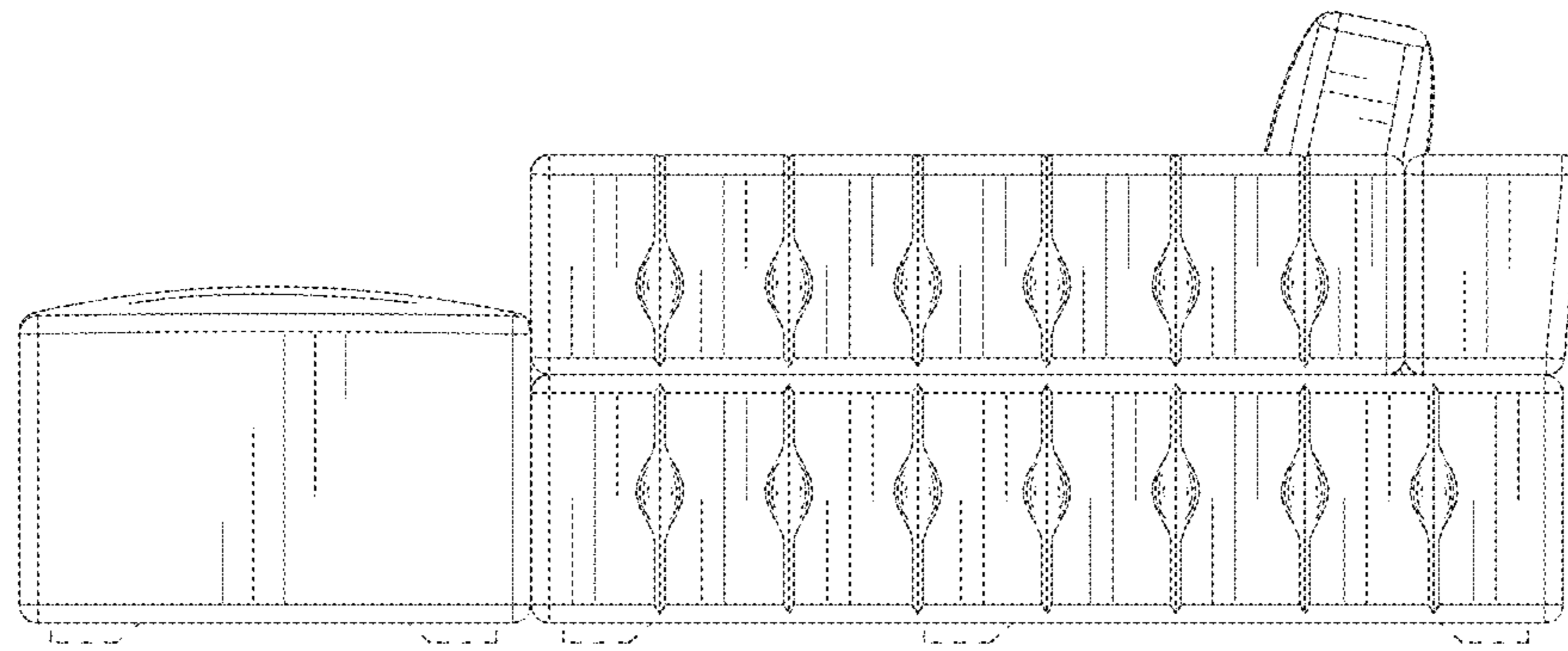

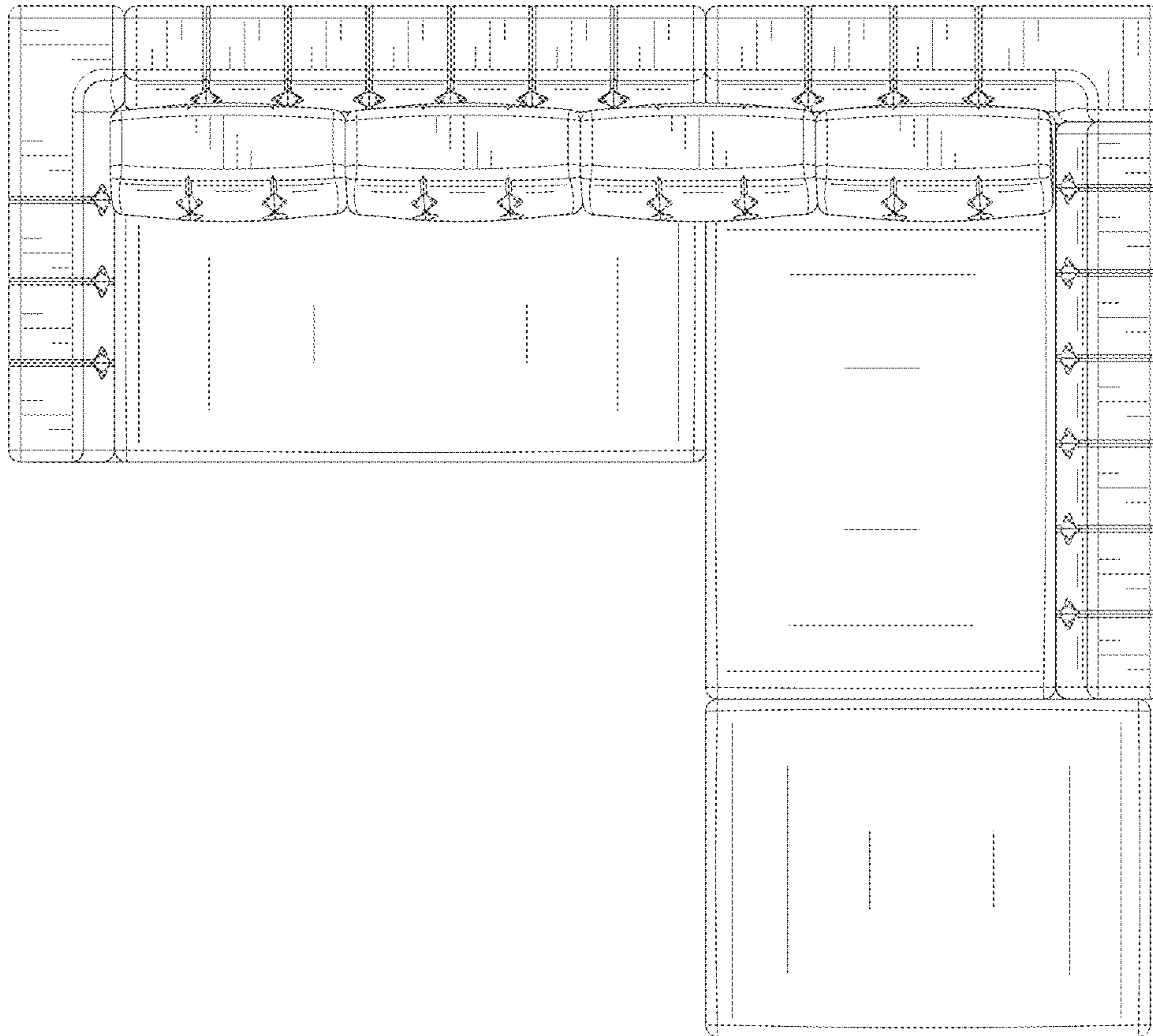

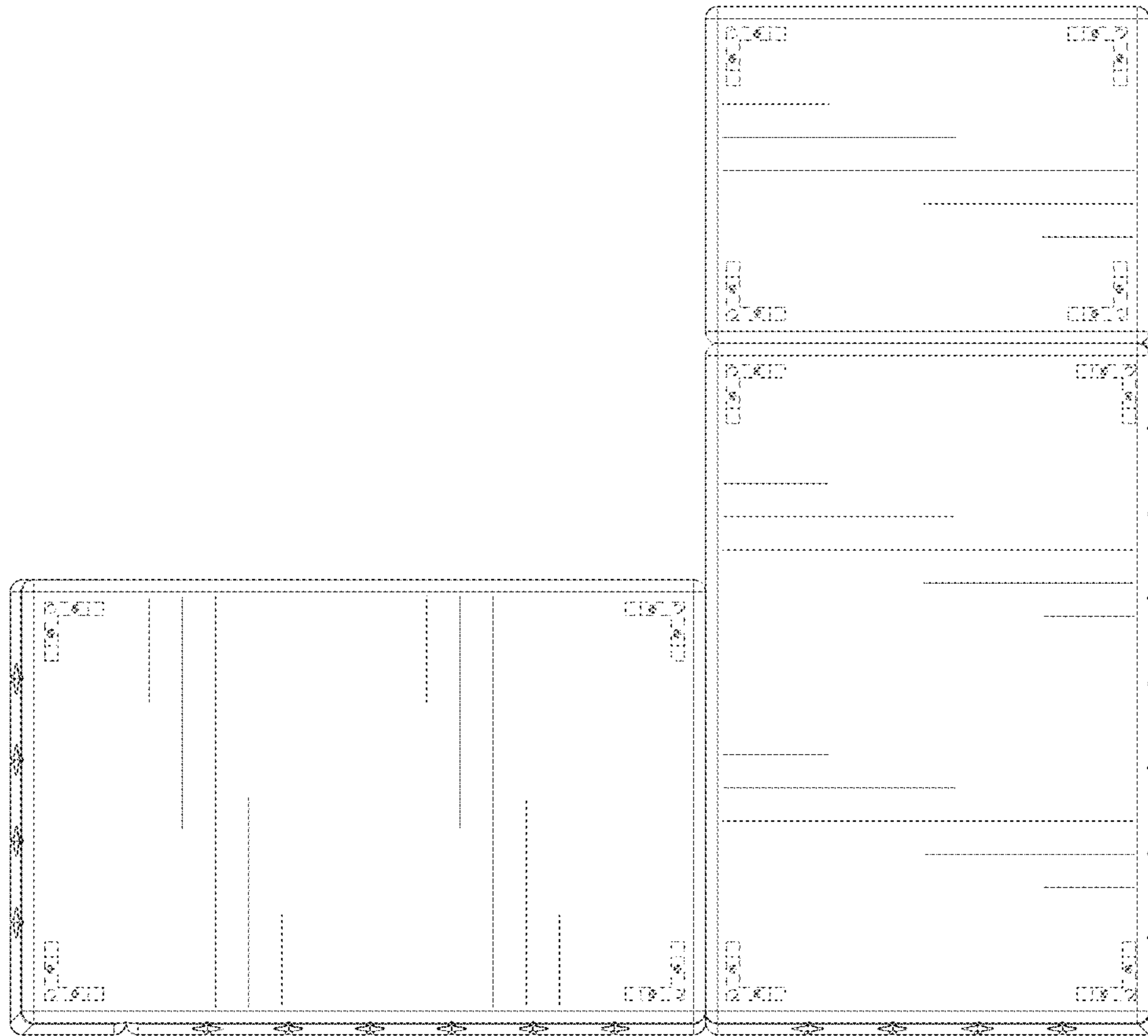
