(57) **CLAIM**

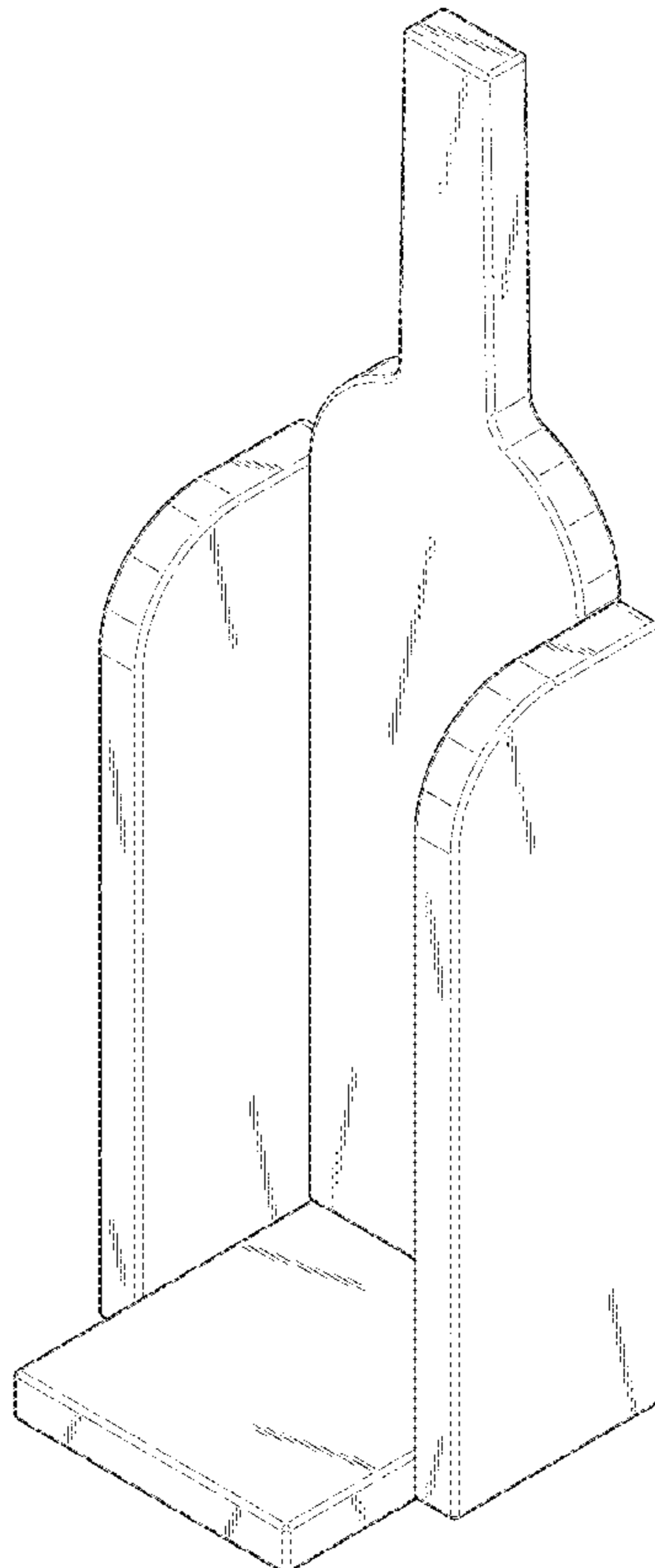
The ornamental design for a bottle holder, as shown and described.

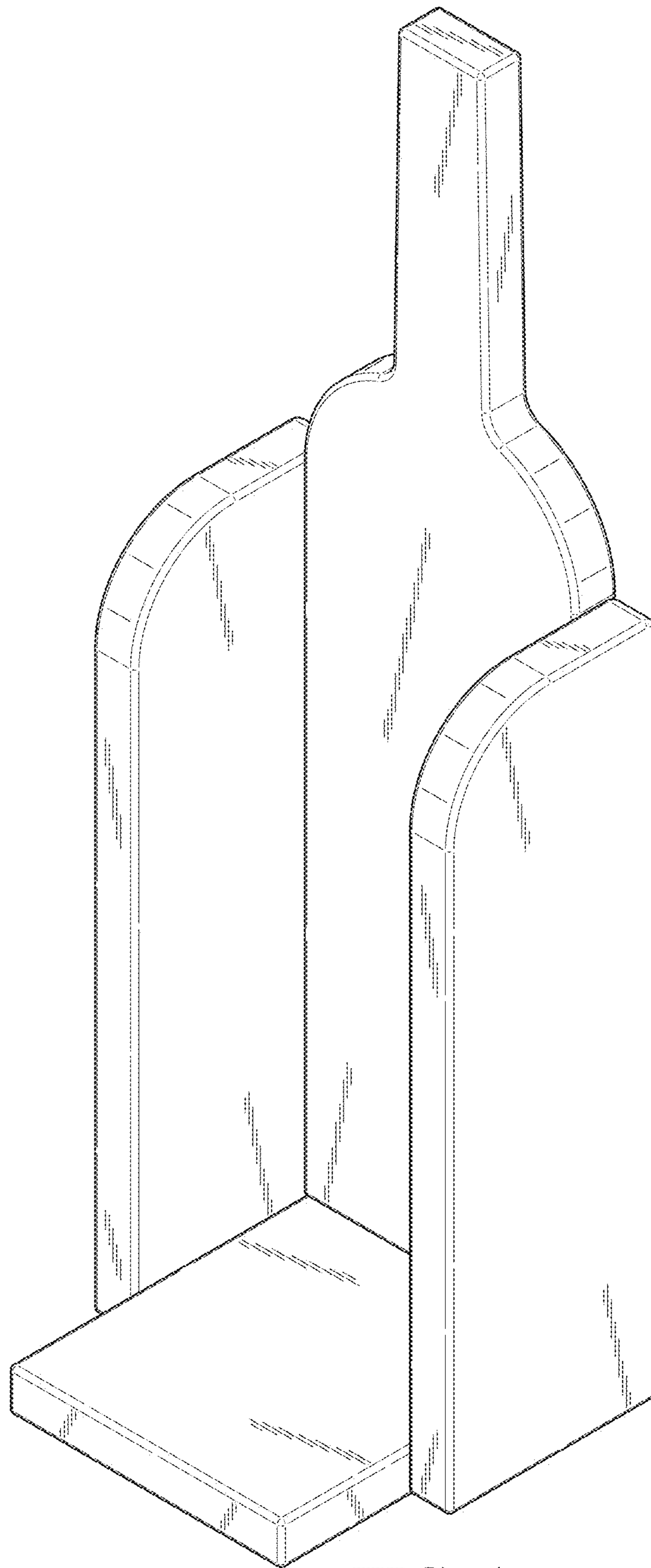
**DESCRIPTION**

FIG. 1 is a front perspective view of a bottle holder in accordance with the present invention.

FIG. 7 is a front perspective view of the bottle holder of FIG. 1.

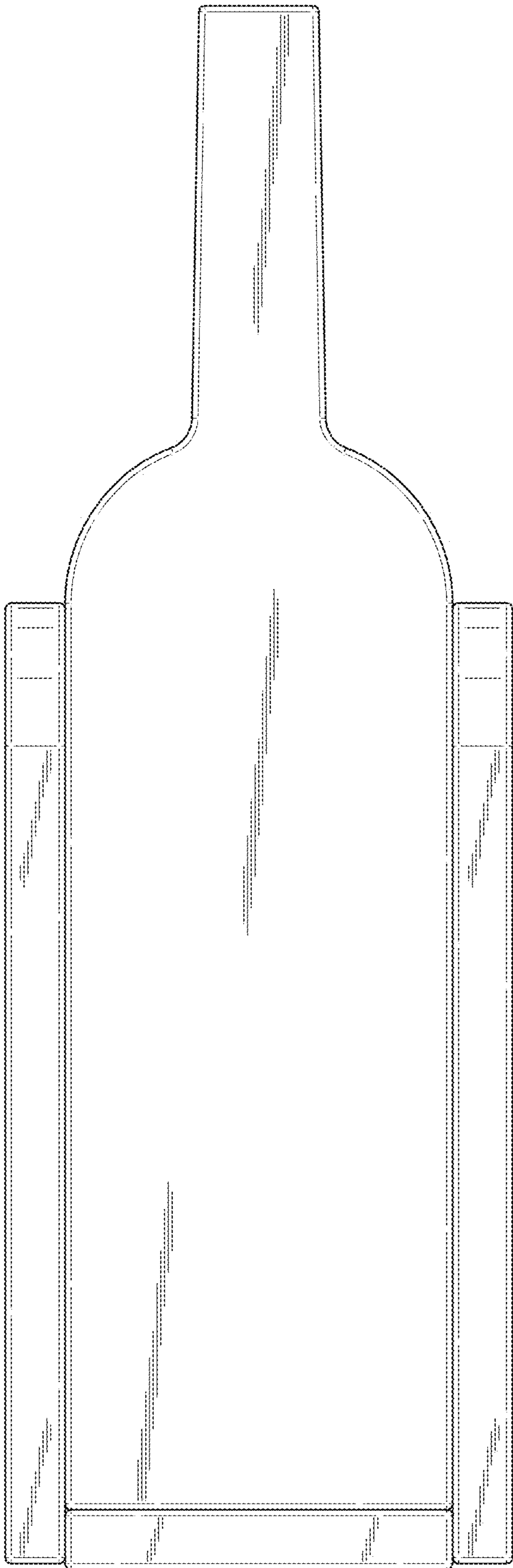

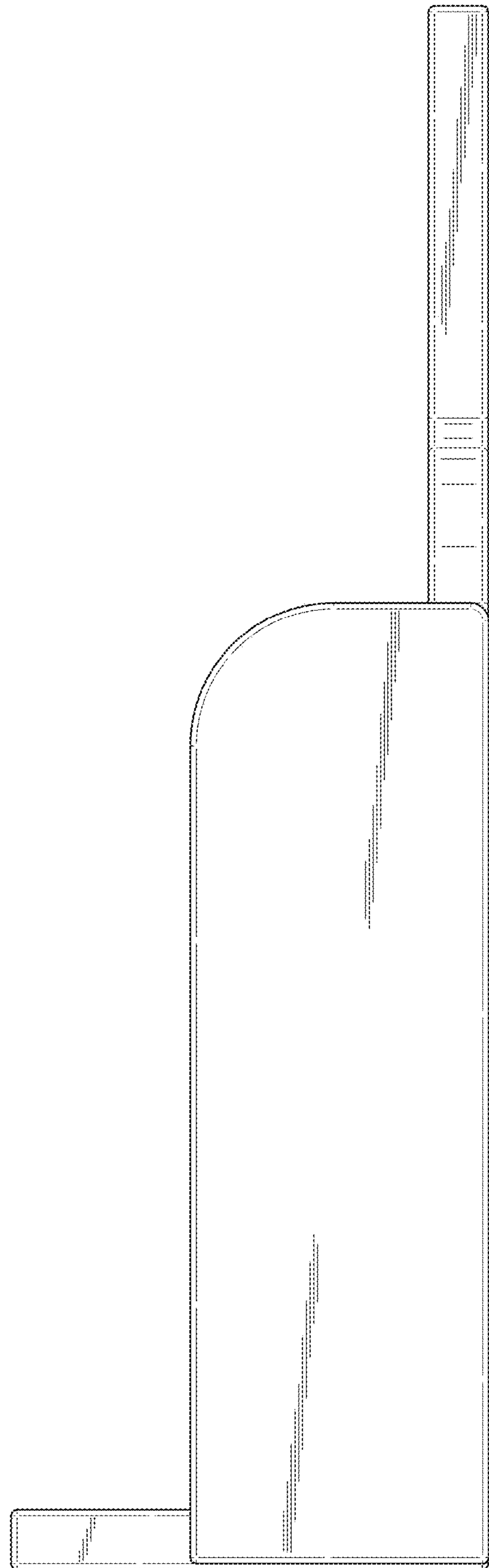




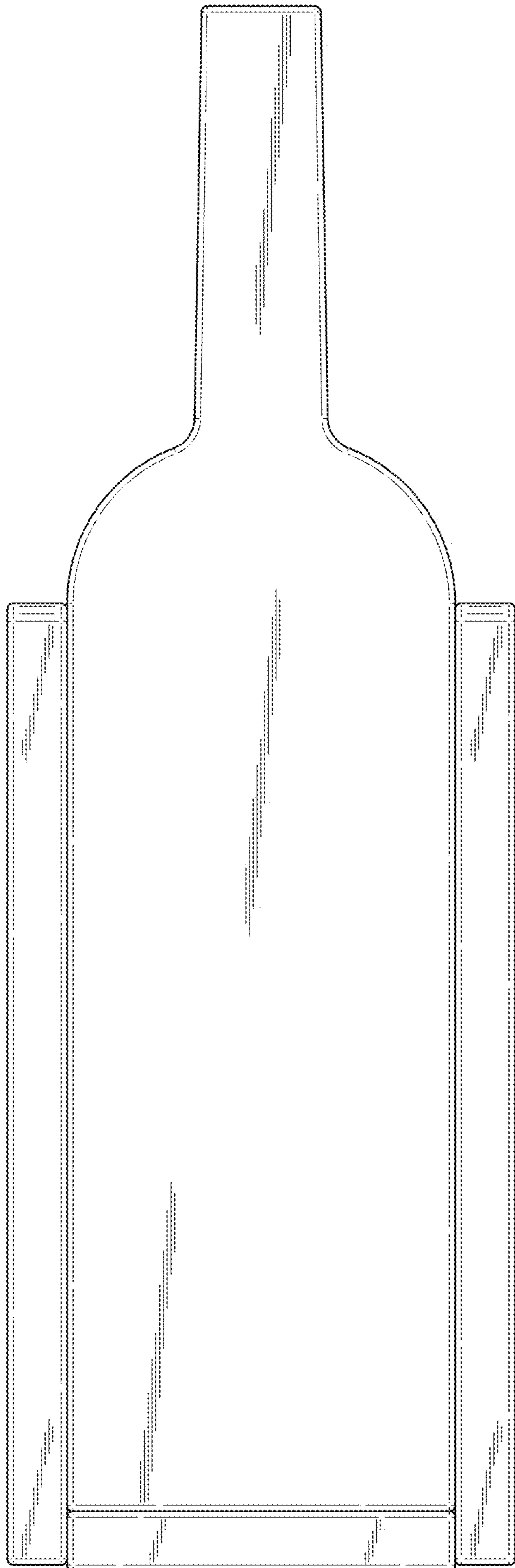

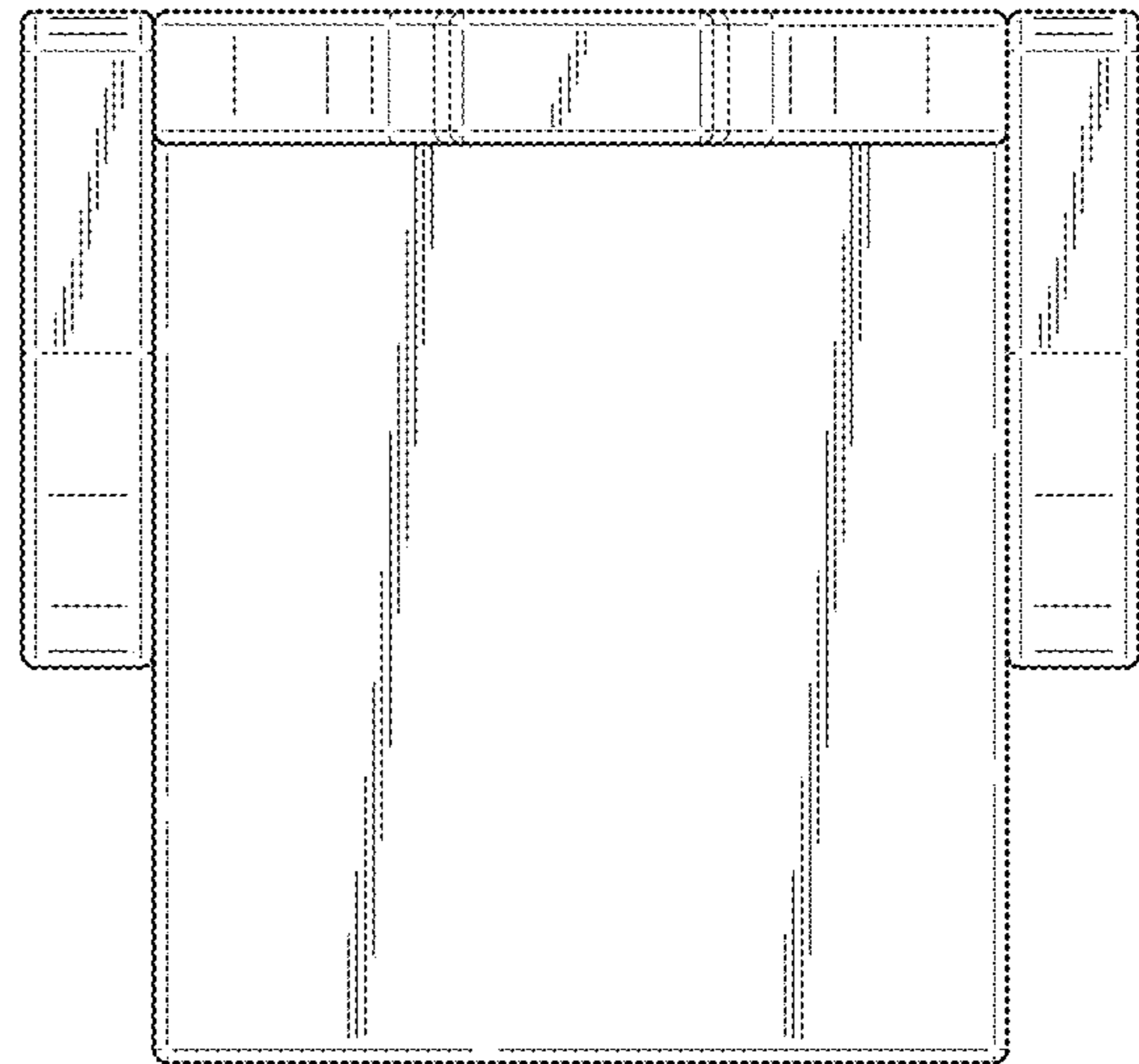

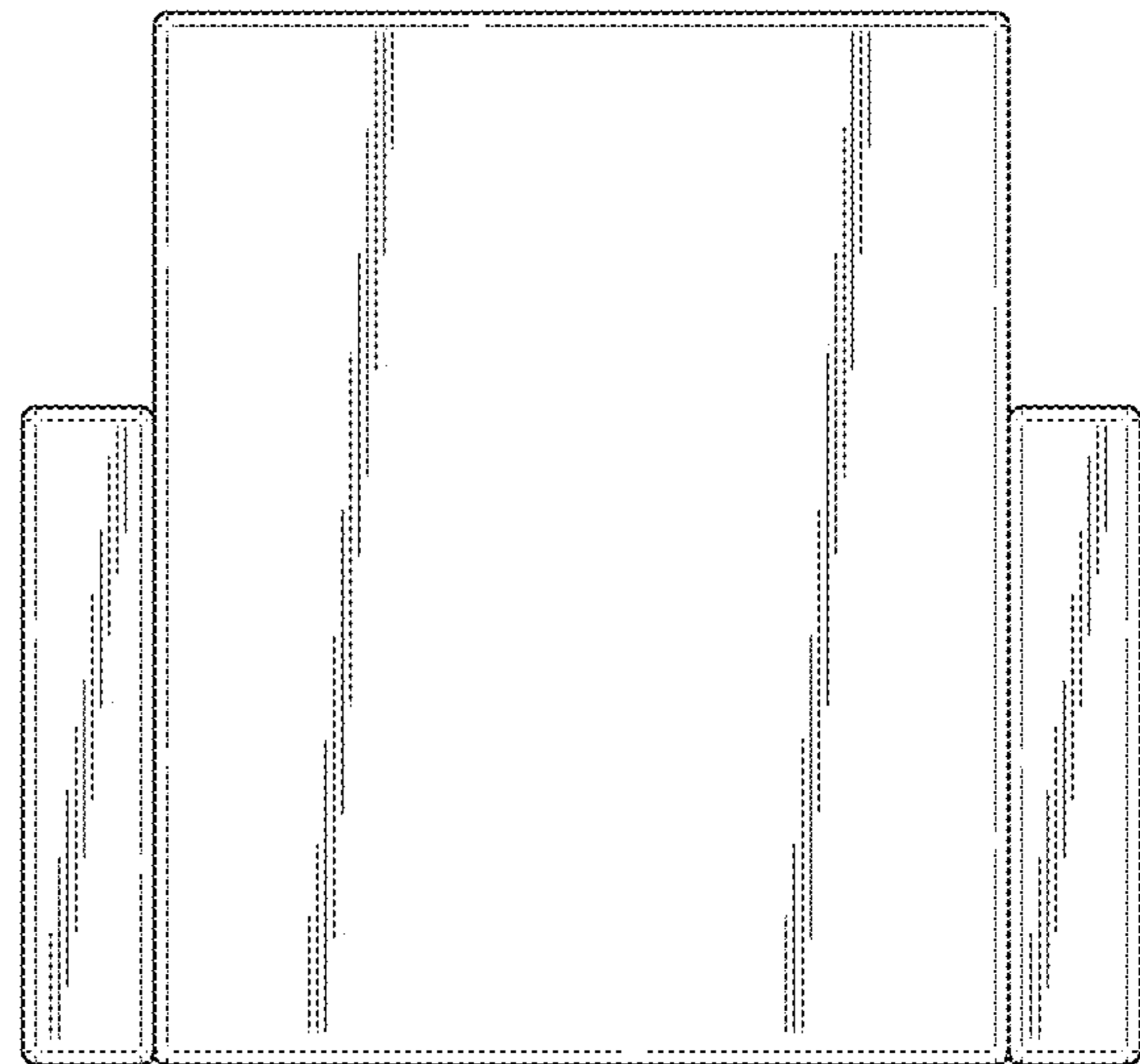

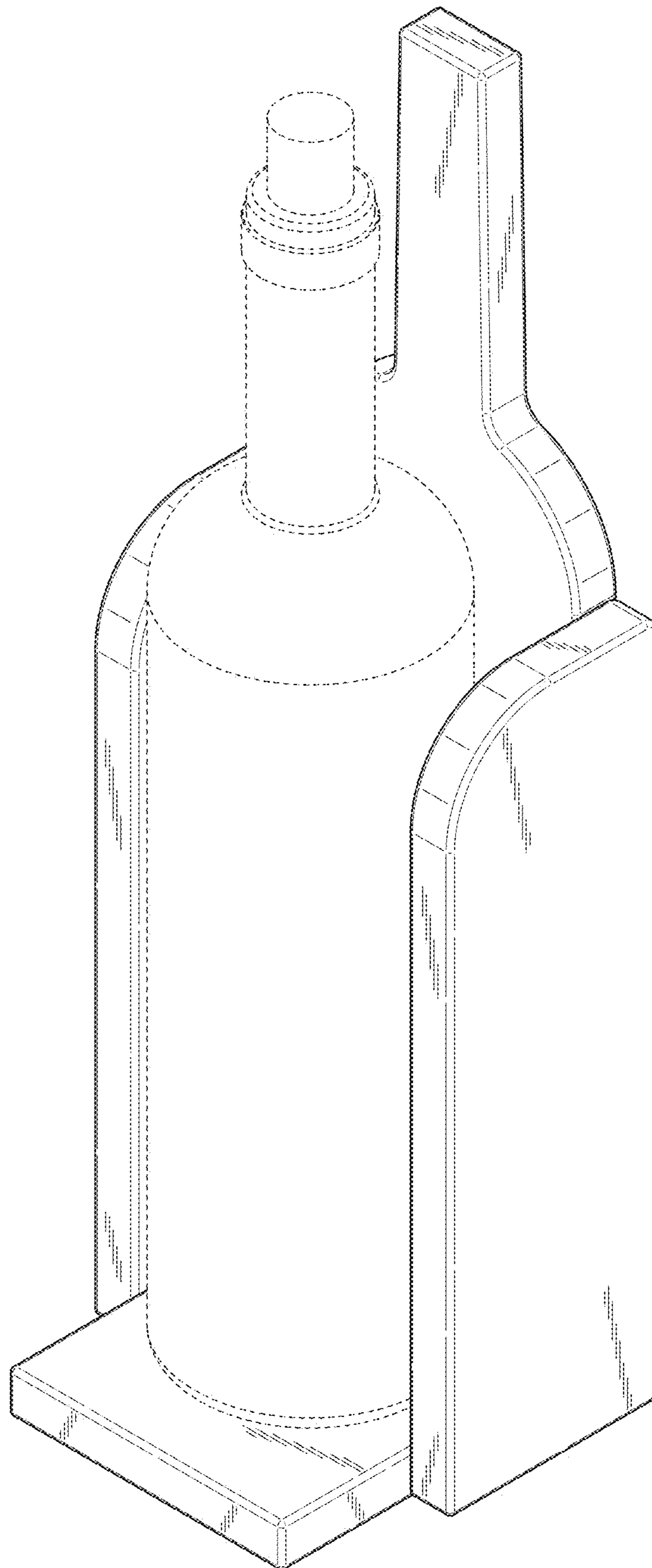
