DESCRIPTION

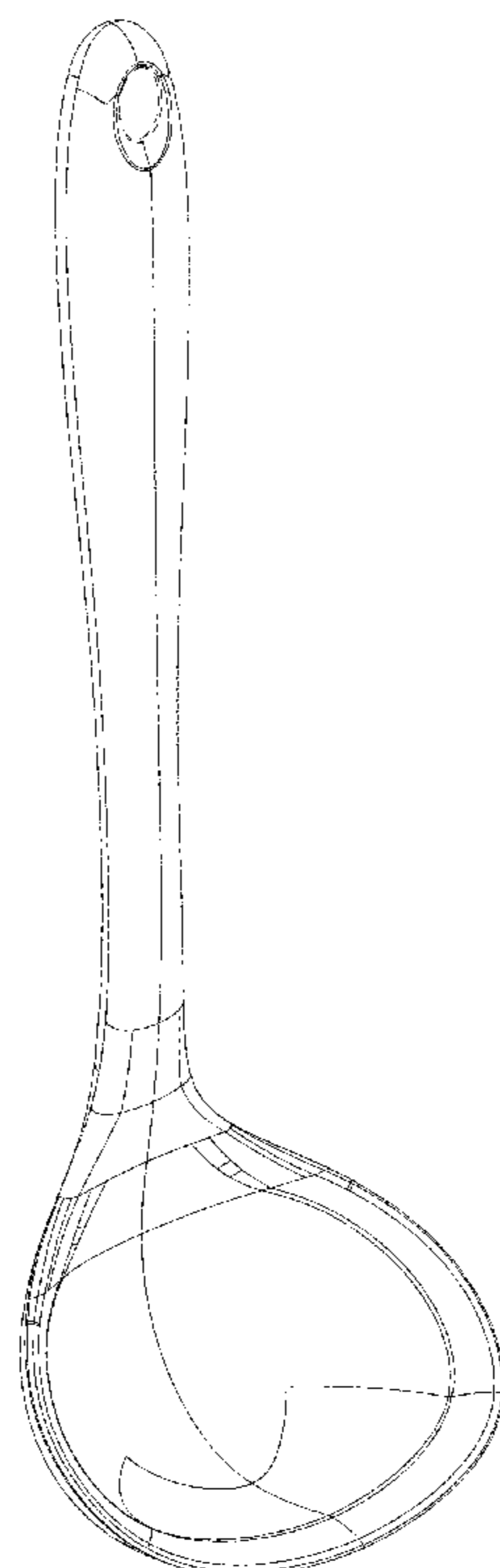
FIG. 1 is a front, left side perspective view of a ladle showing my new design;
FIG. 2 is a rear, right side perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a left side elevation view thereof, the right side elevation view being a mirror image of the left side elevation view;
FIG. 6 is an enlarged top plan view thereof; and,
FIG. 7 is an enlarged bottom plan view thereof.
The broken lines in the drawings illustrate portions of the ladle that form no part of the claimed design.

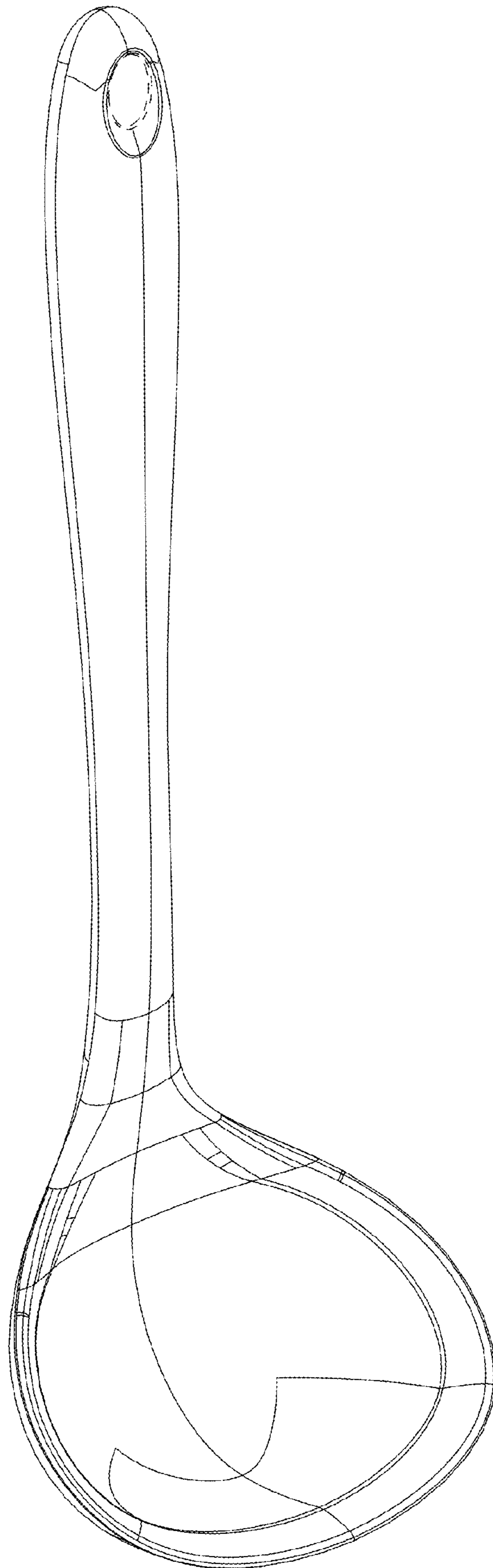

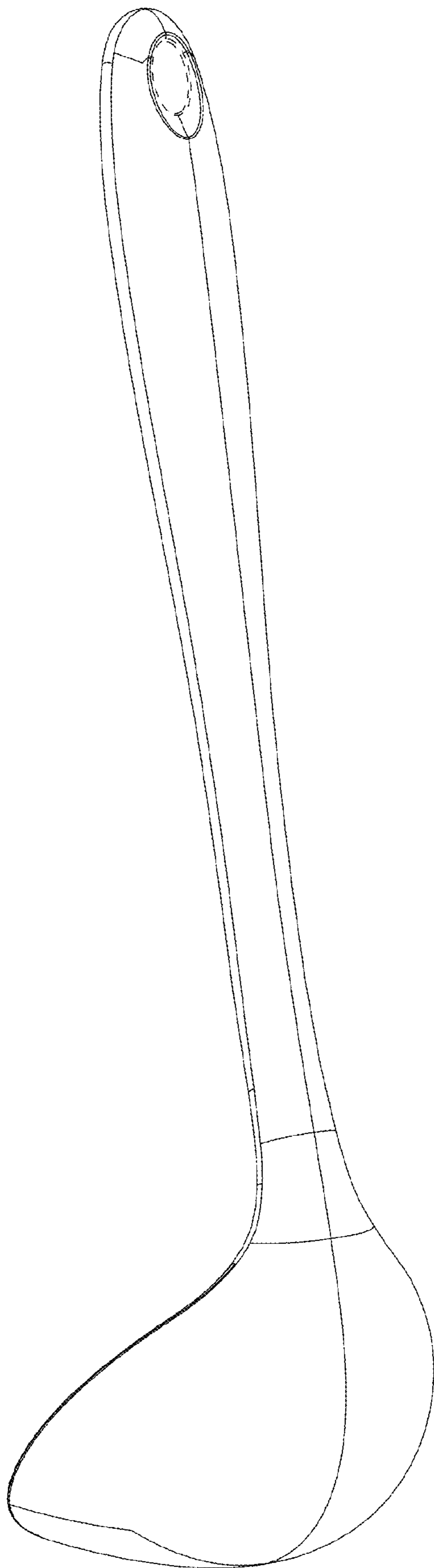

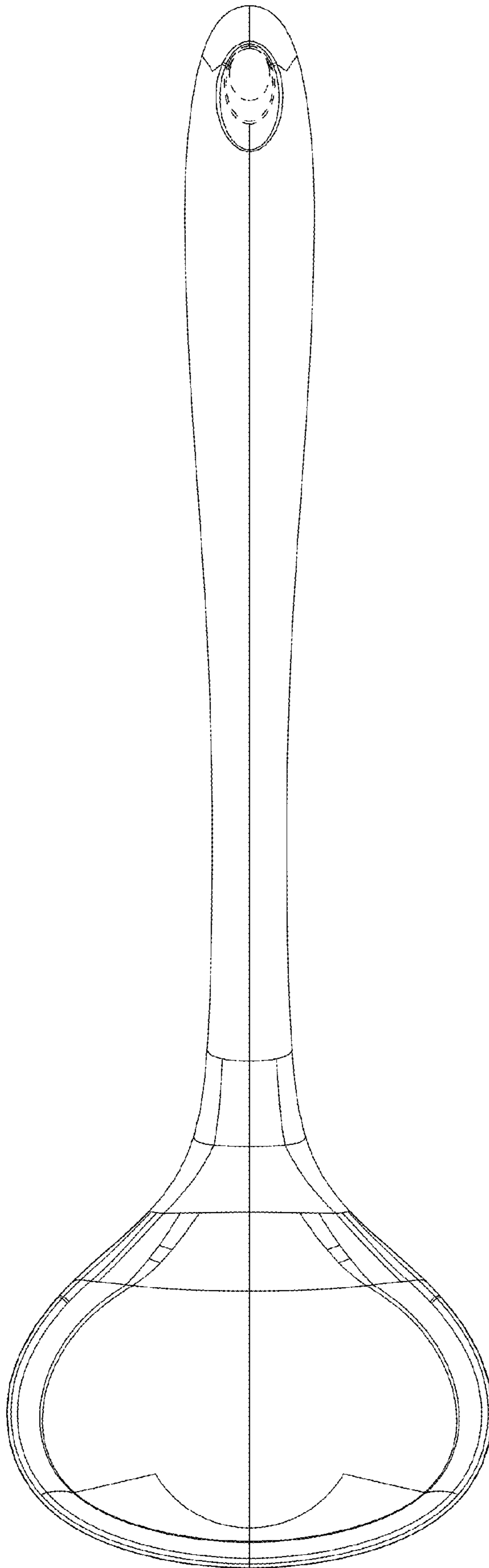

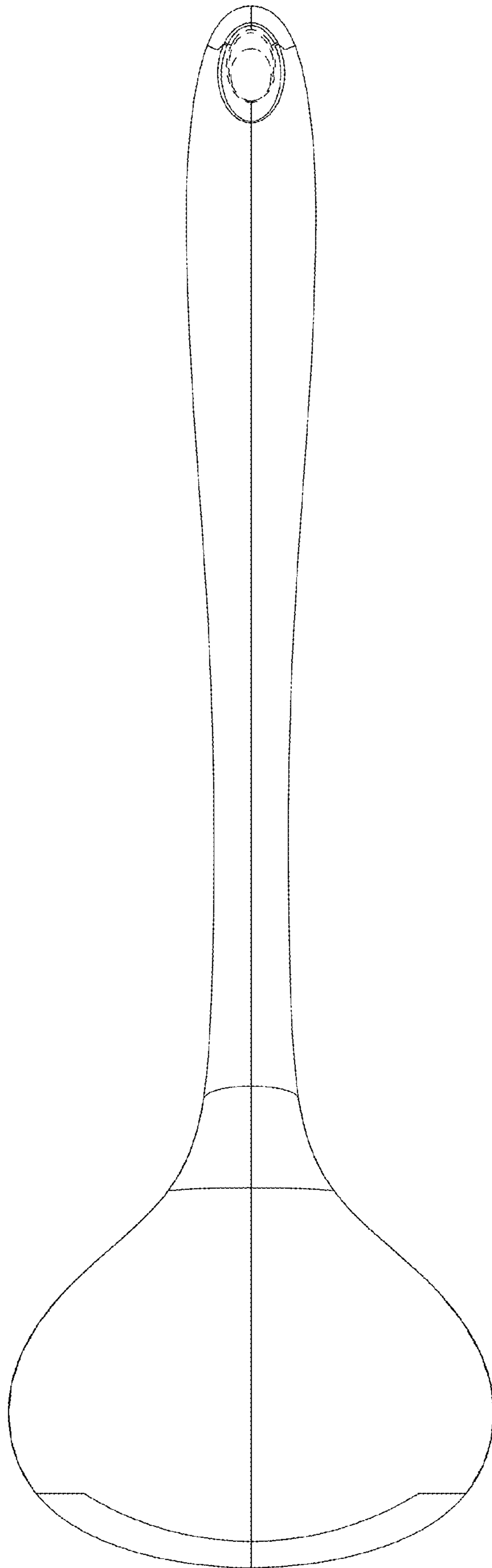

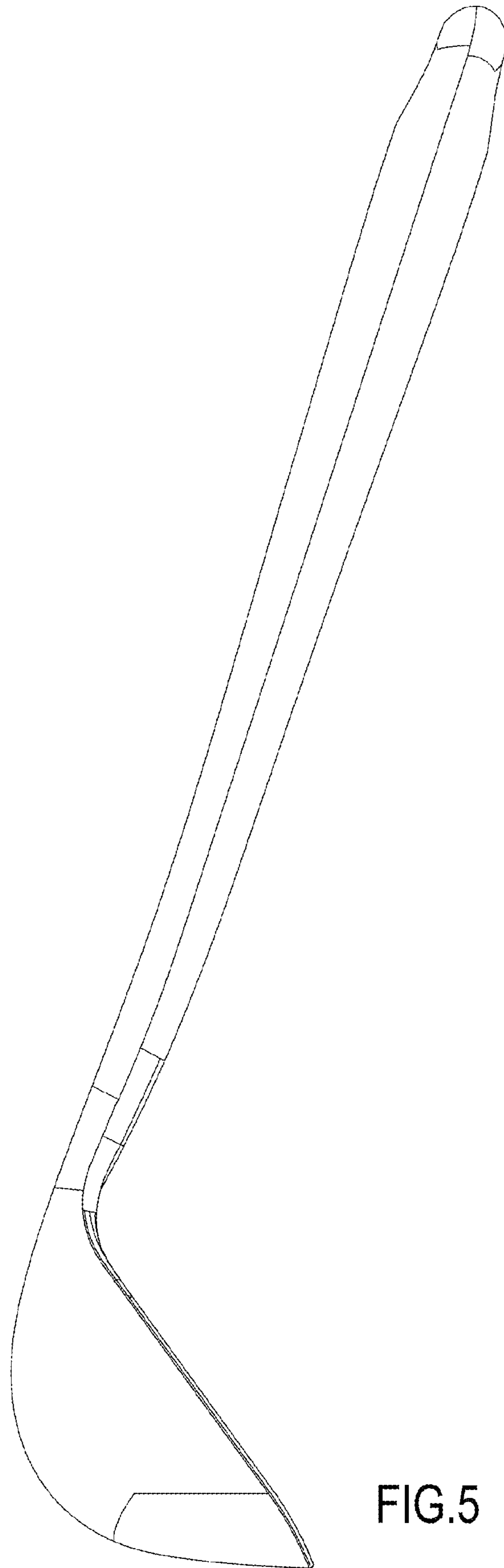

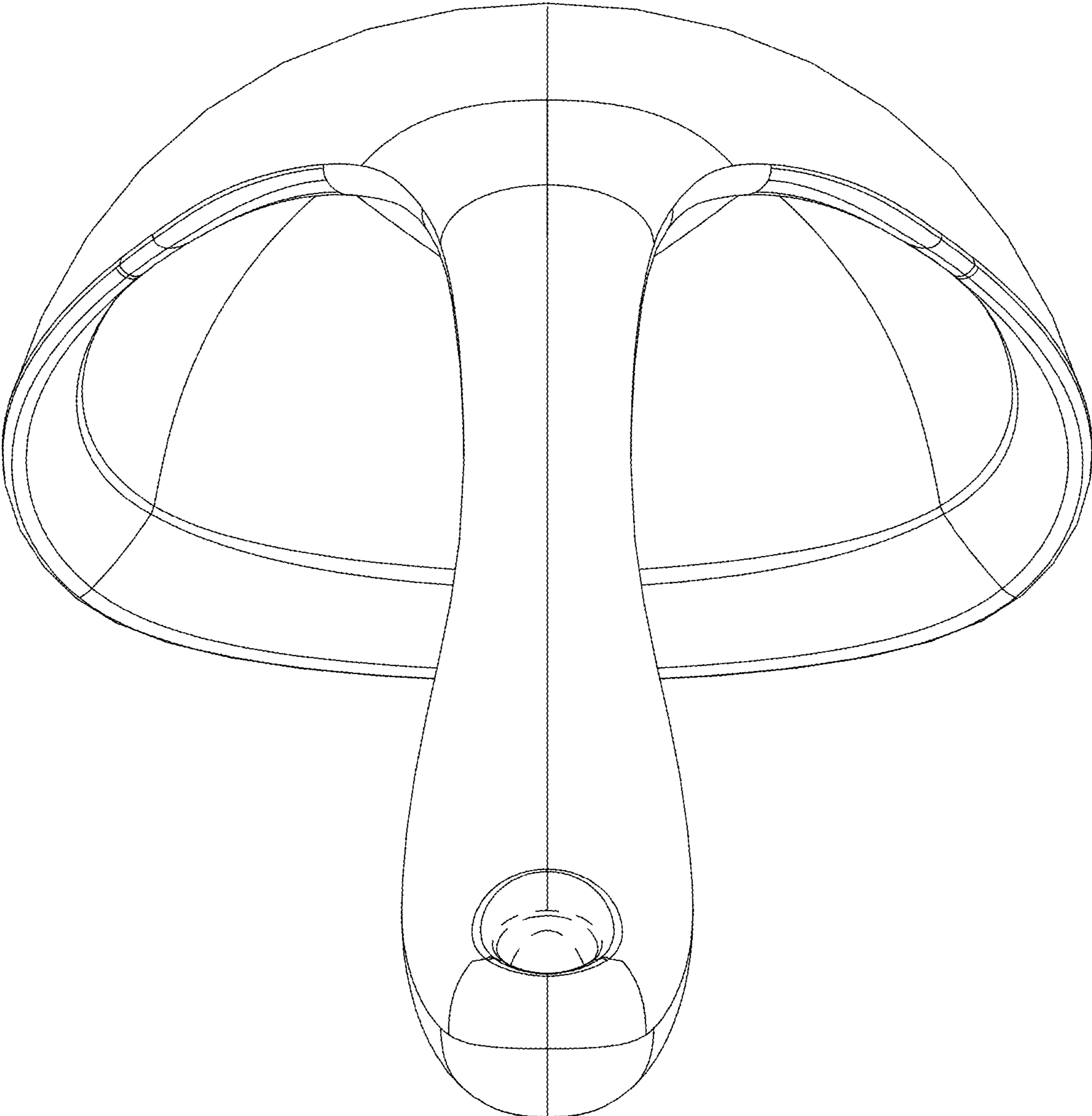

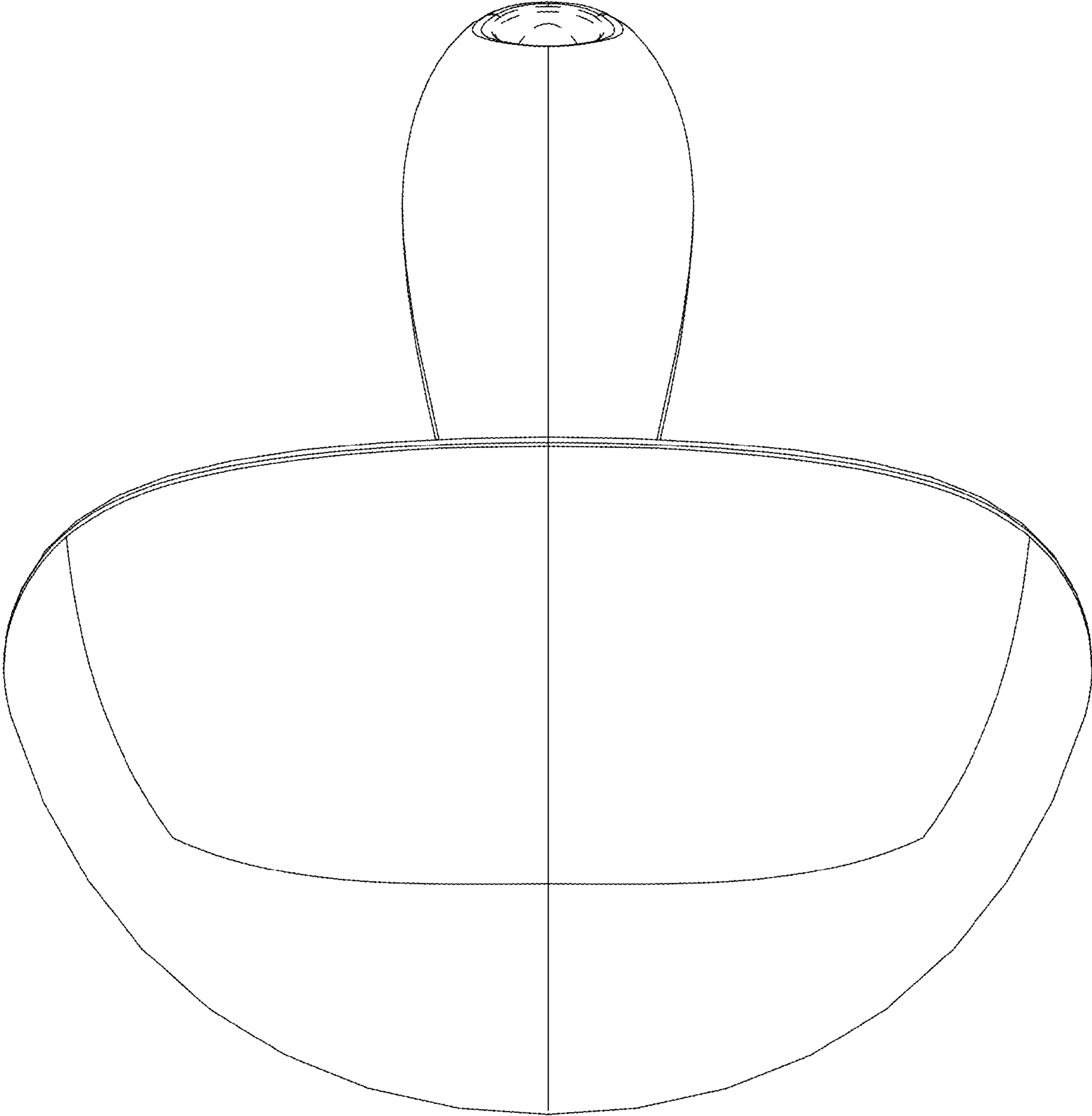
