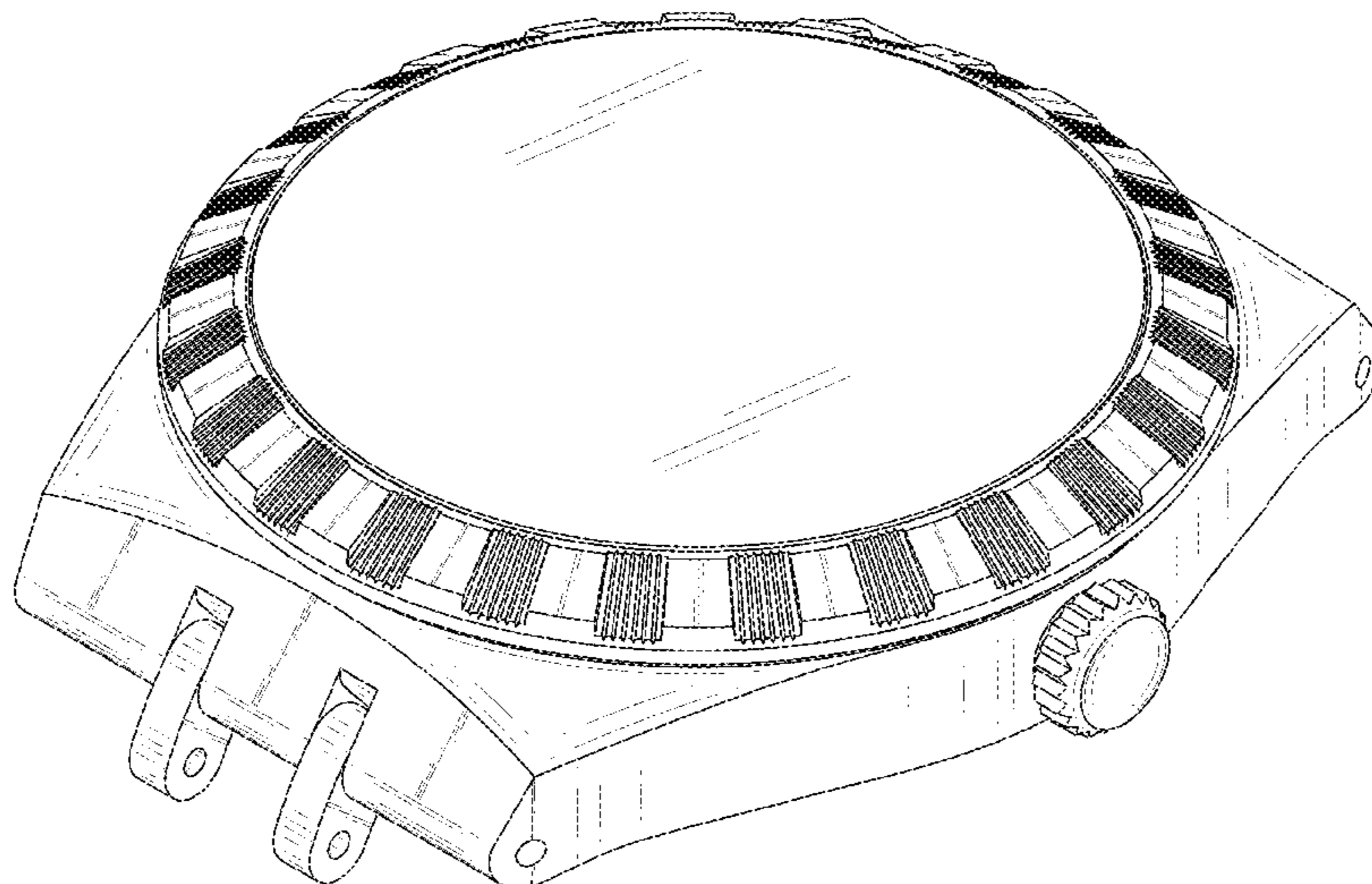
FIG. 1 is a top-front-right perspective view of the watch case;

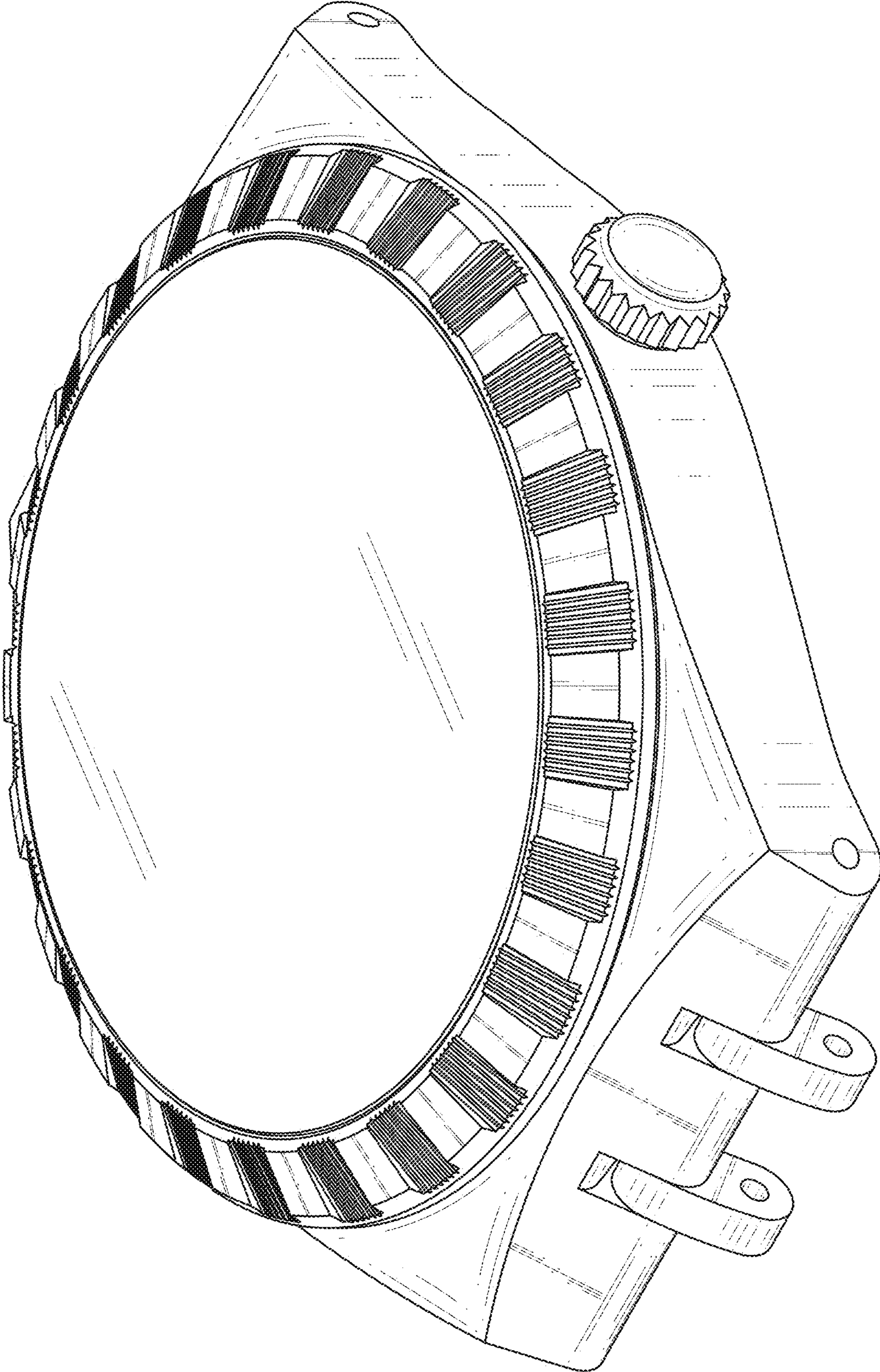

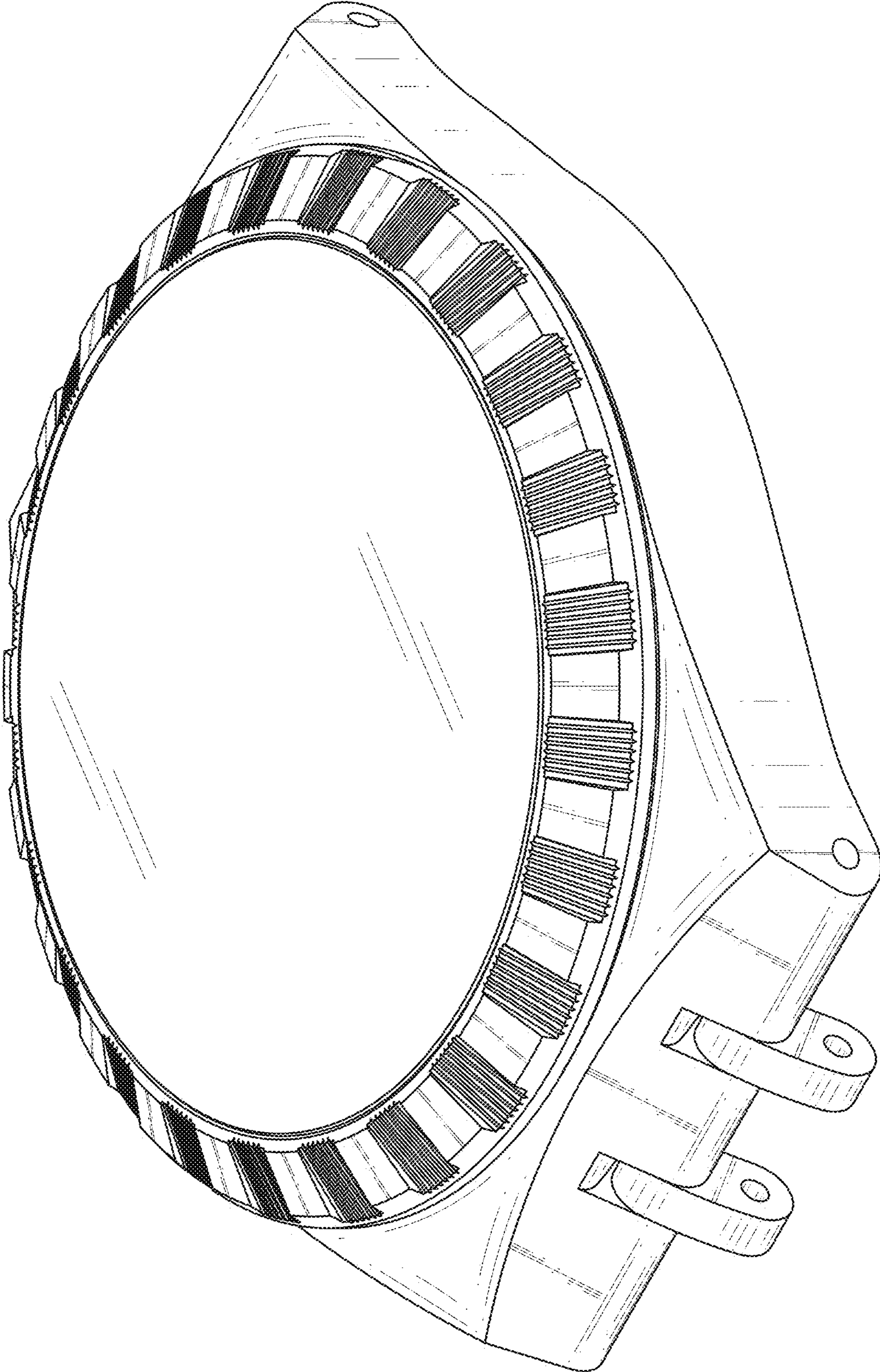

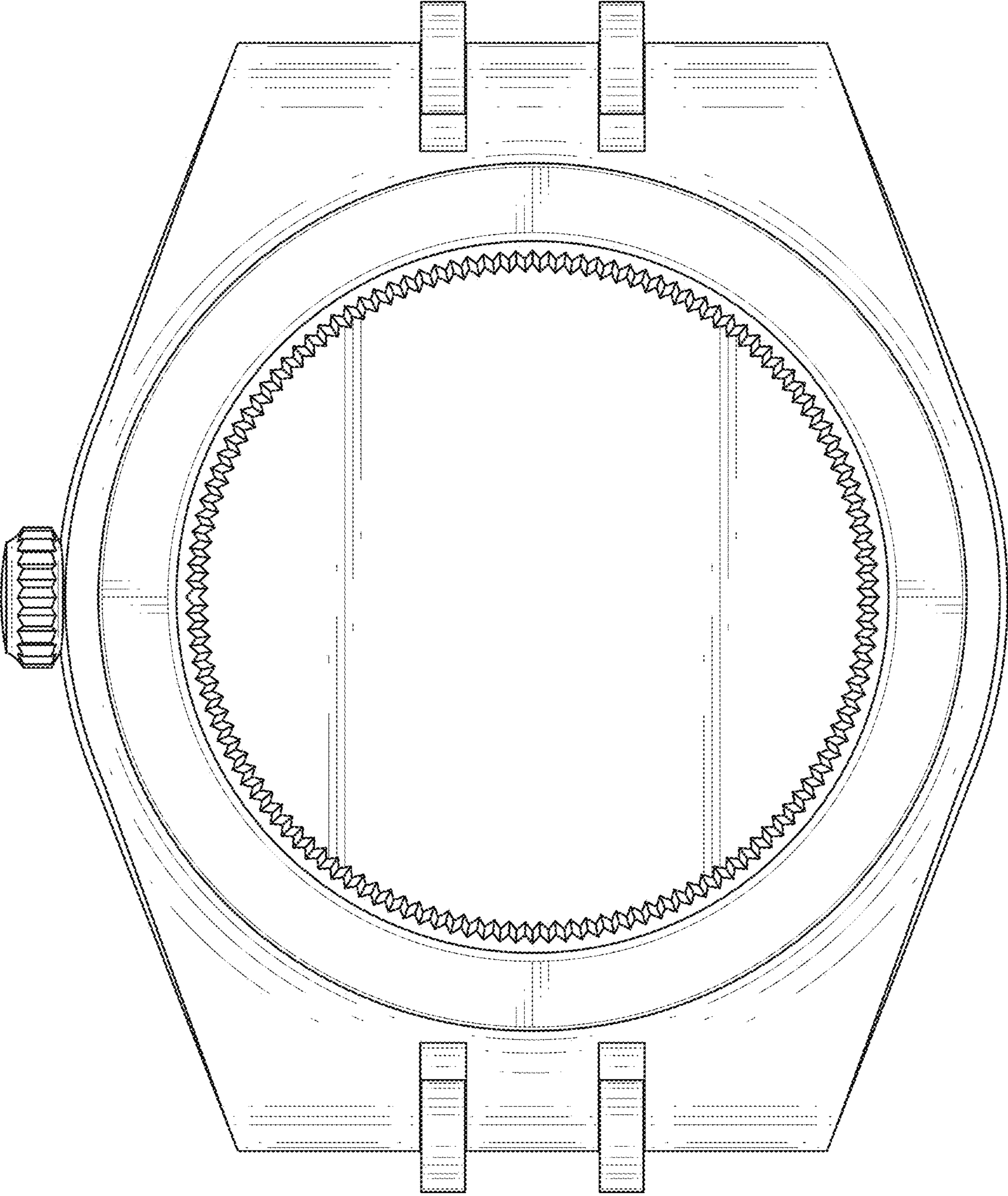

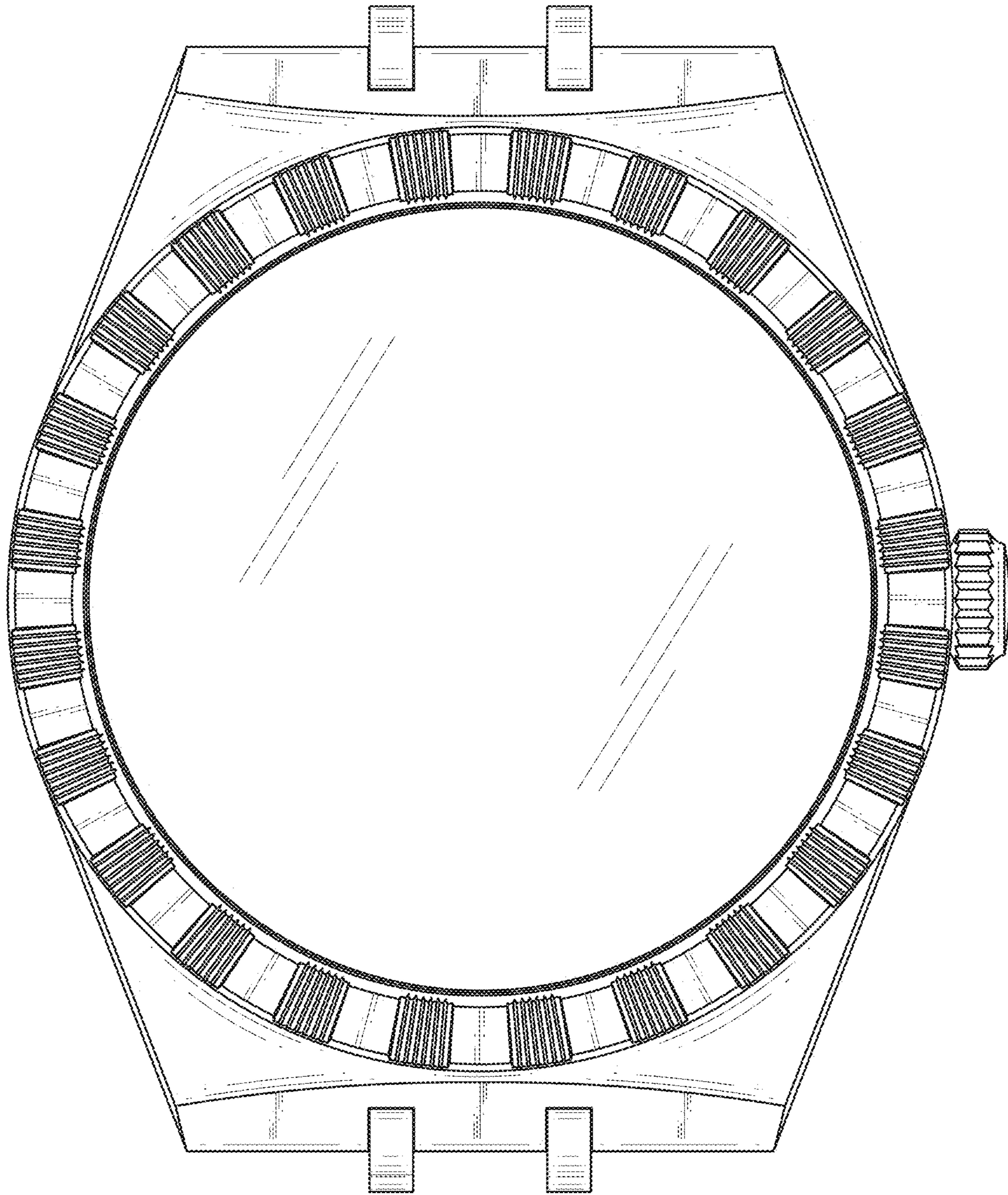

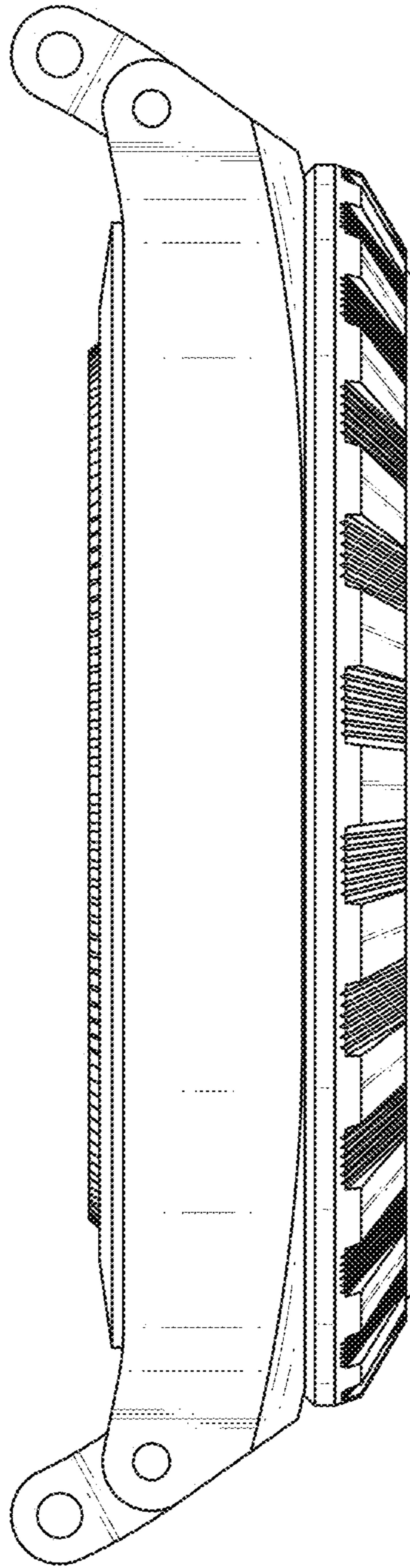

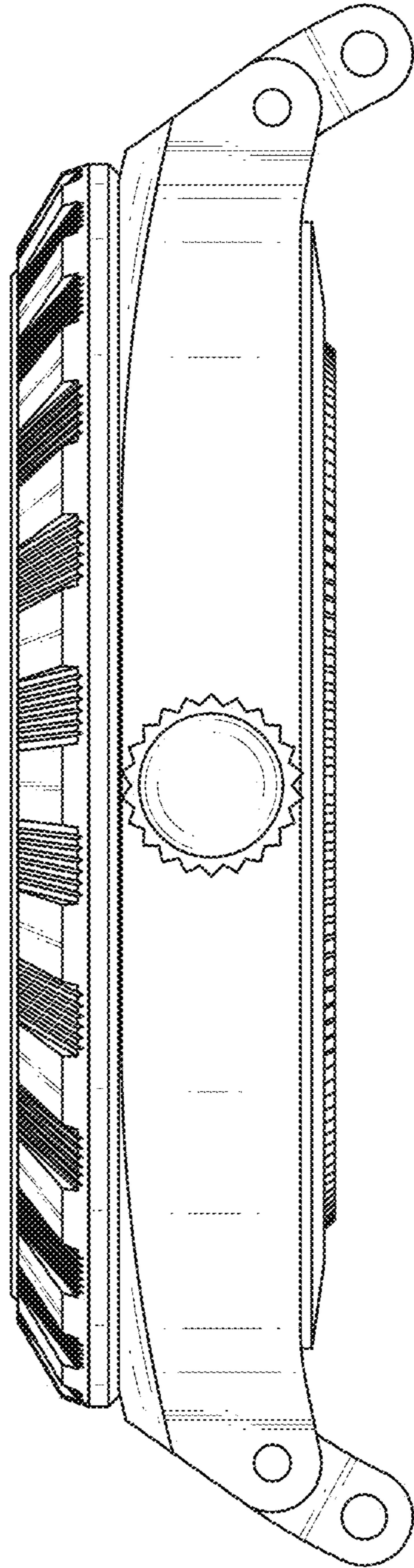

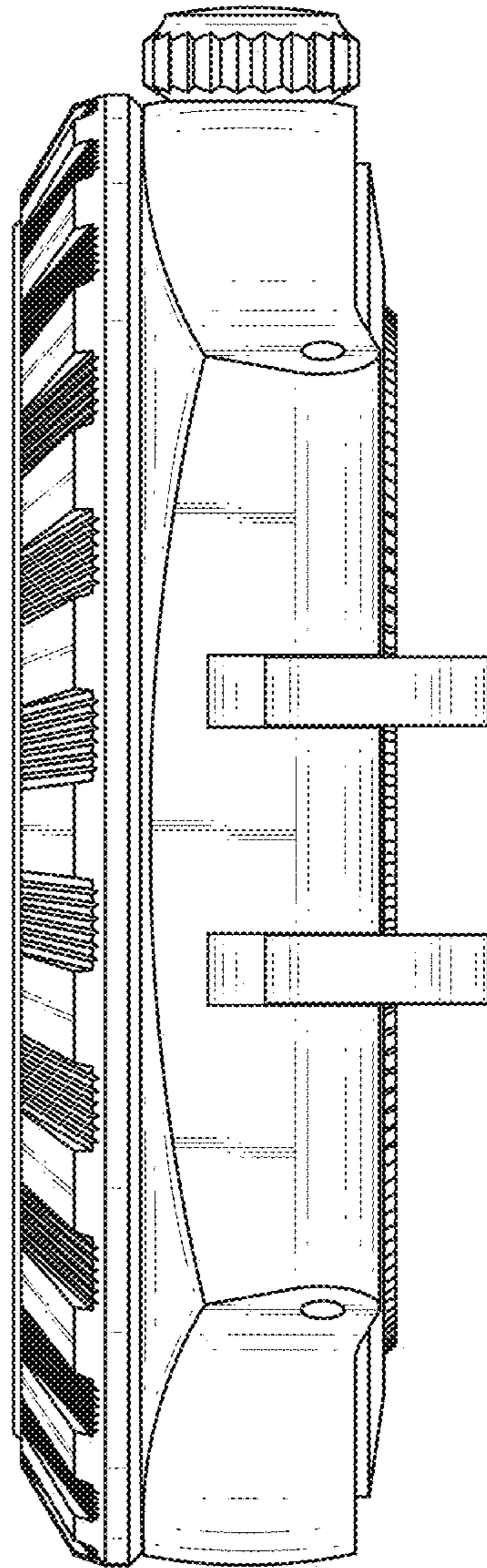

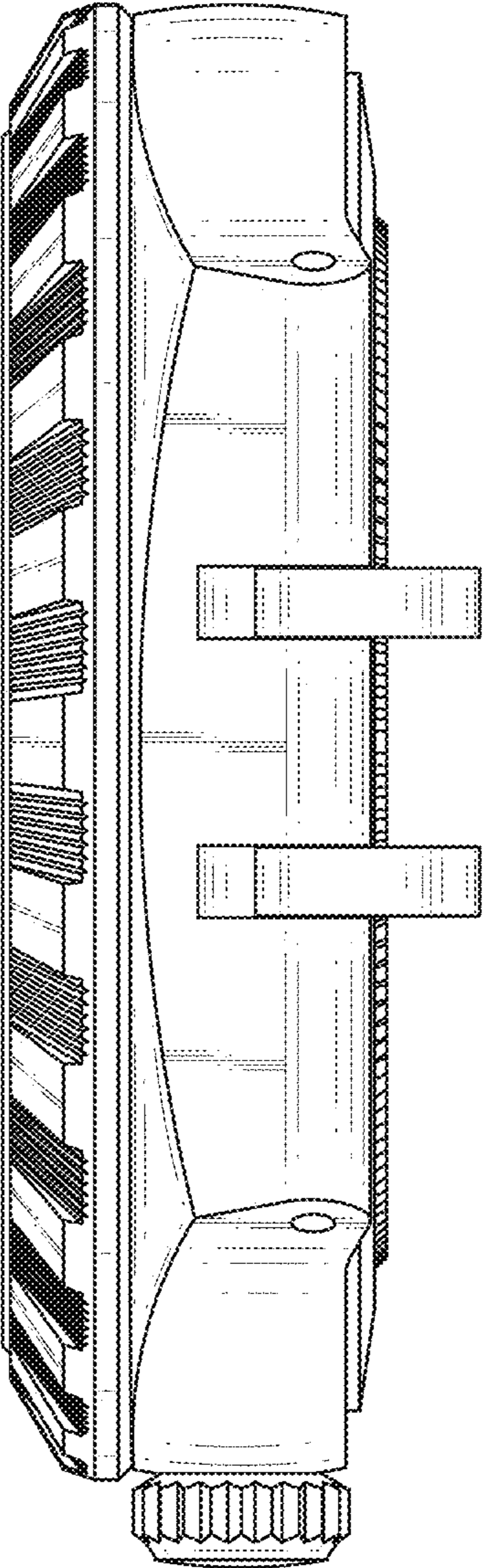

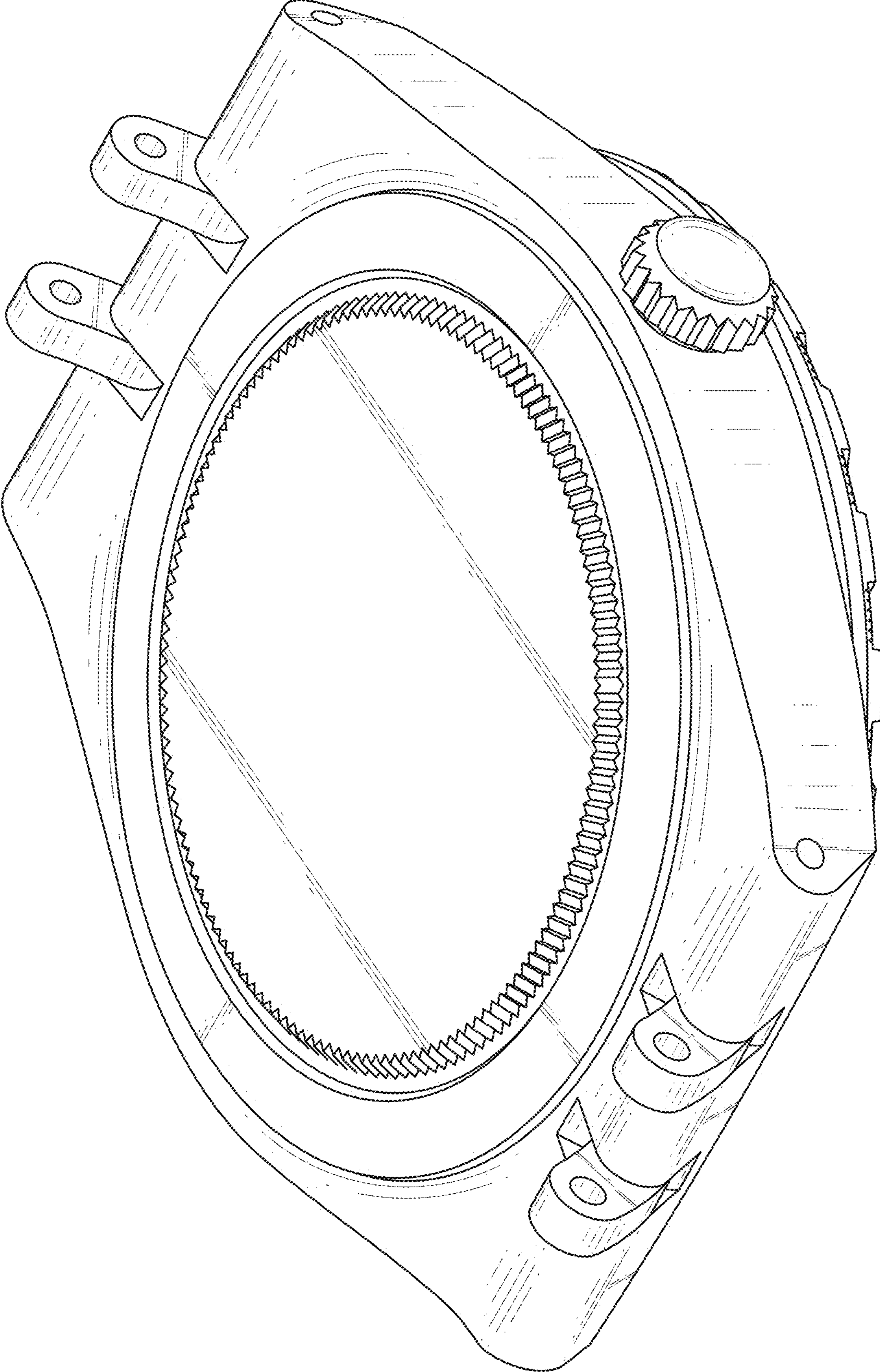

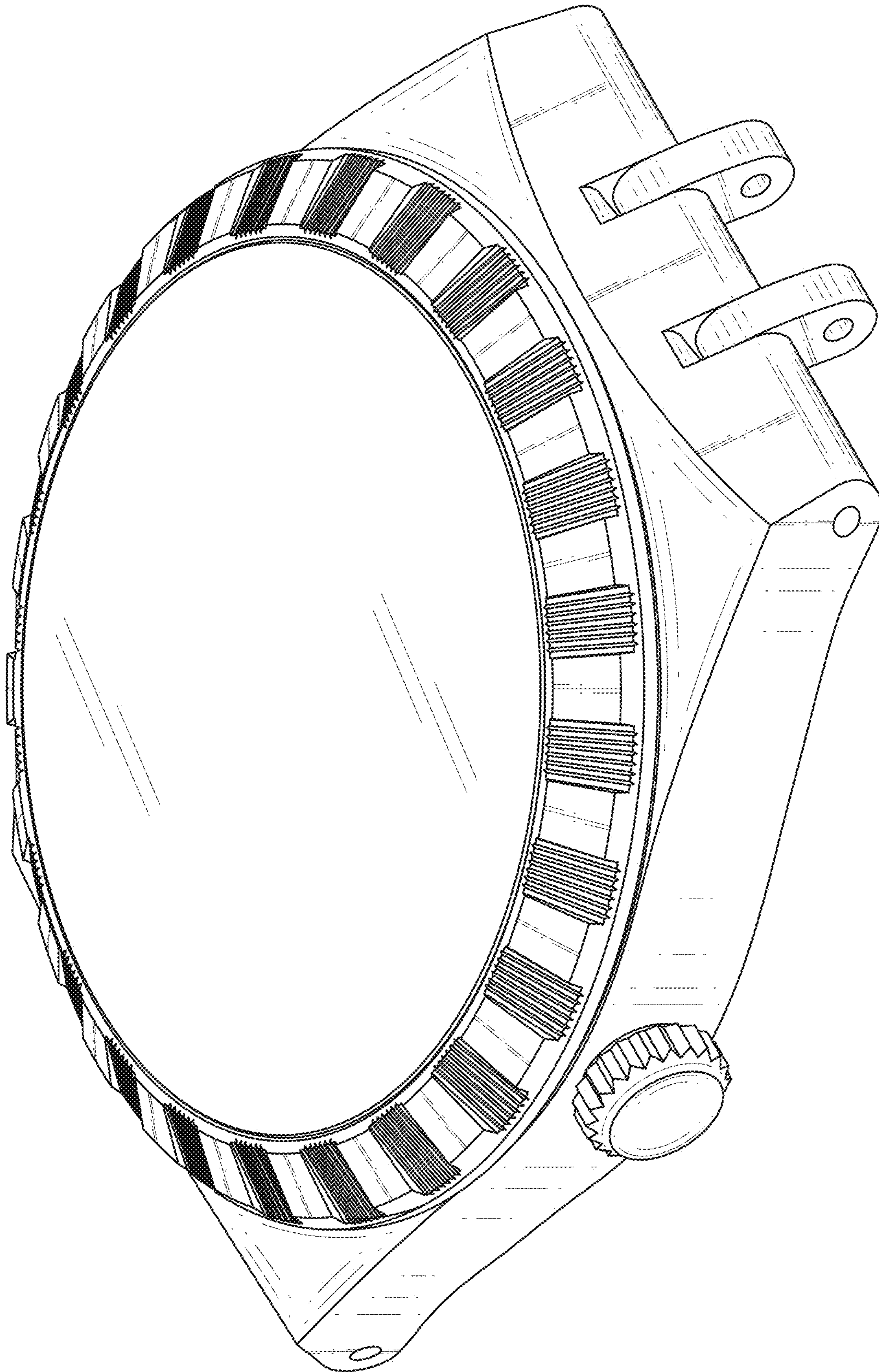

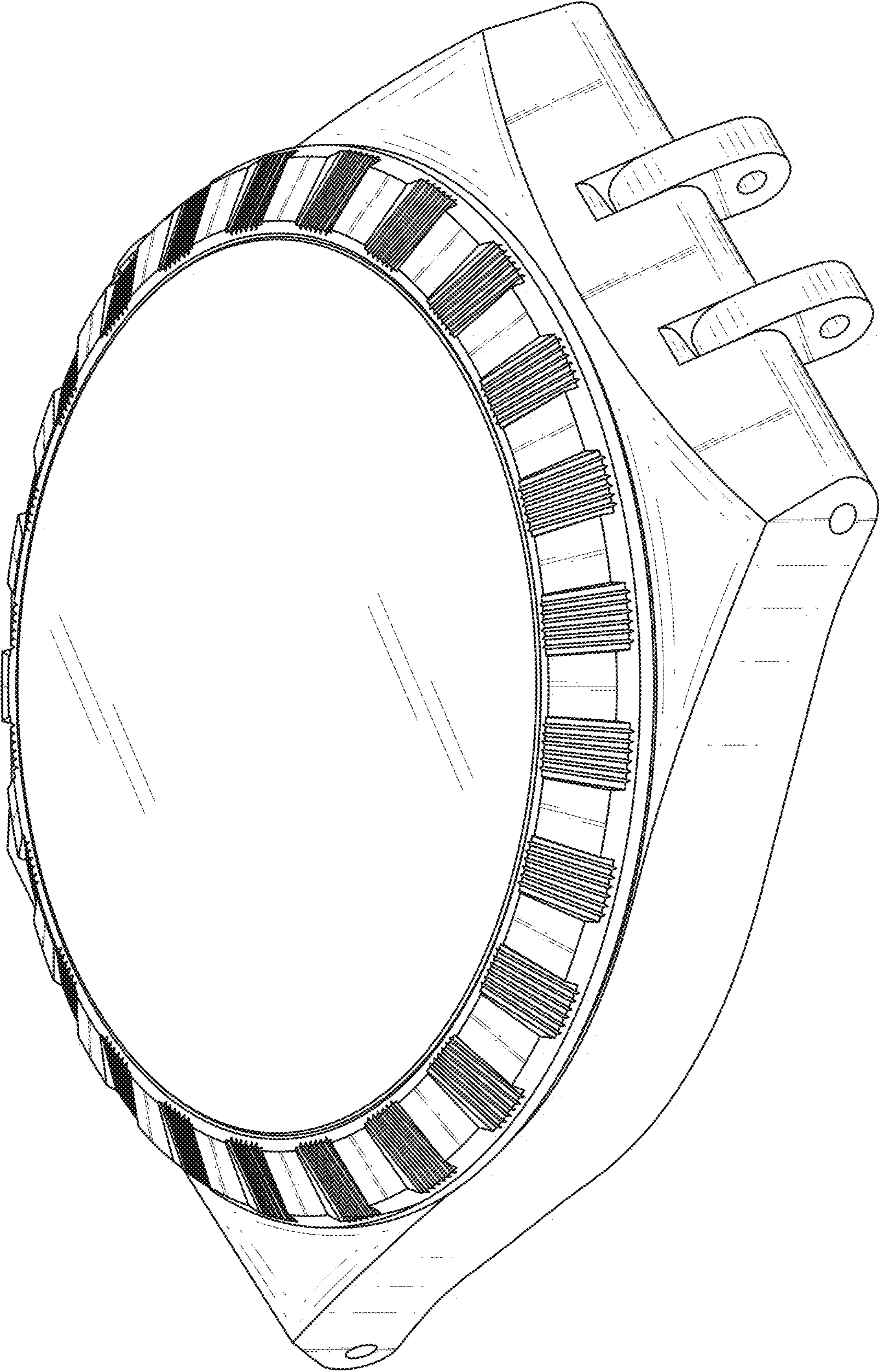
