(57) **CLAIM**

The ornamental design for a flamingo lawn ornament, as shown and described.

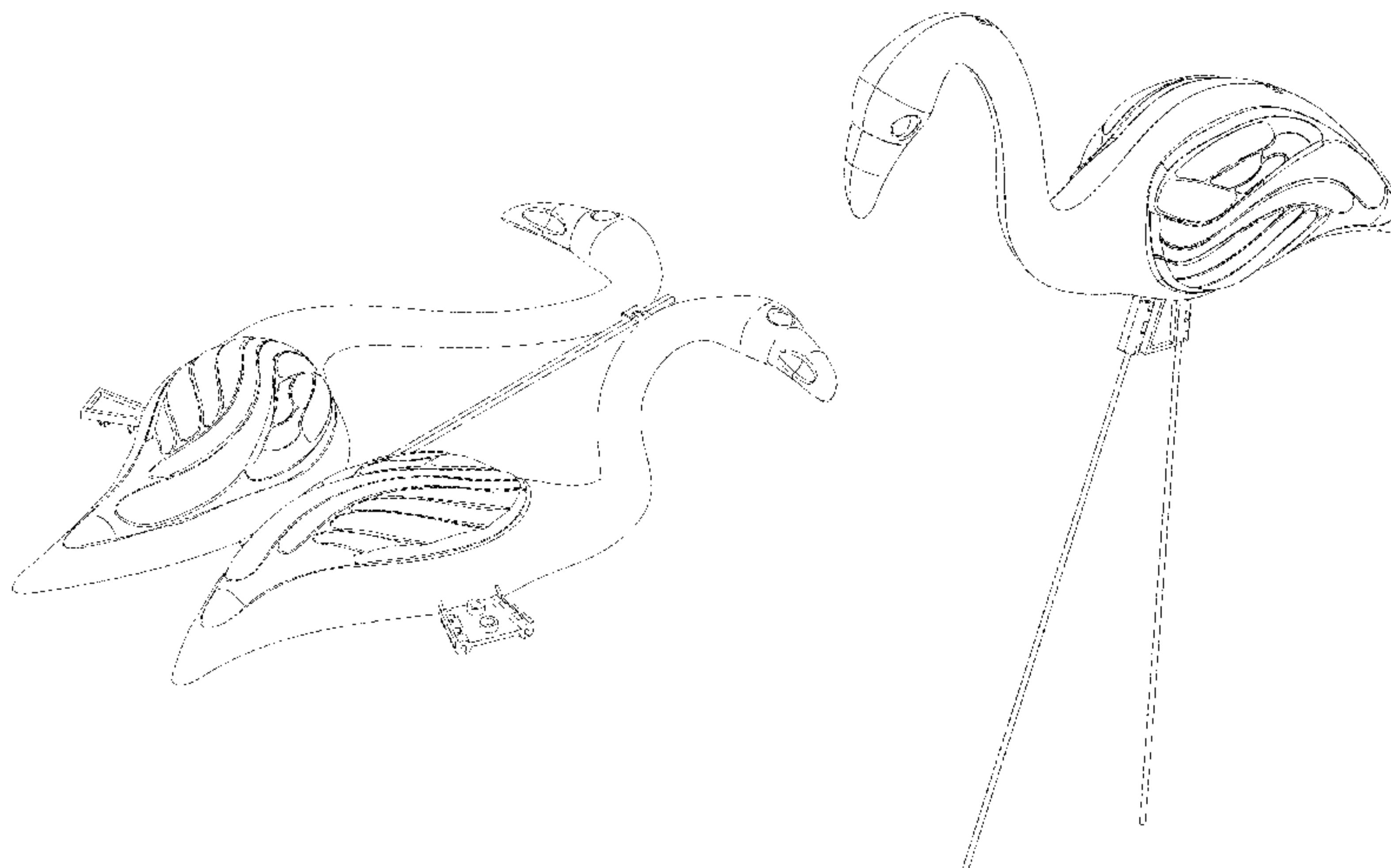


FIG. 21 is a rear side elevation view of the flamingo lawn ornament of FIG. 17;

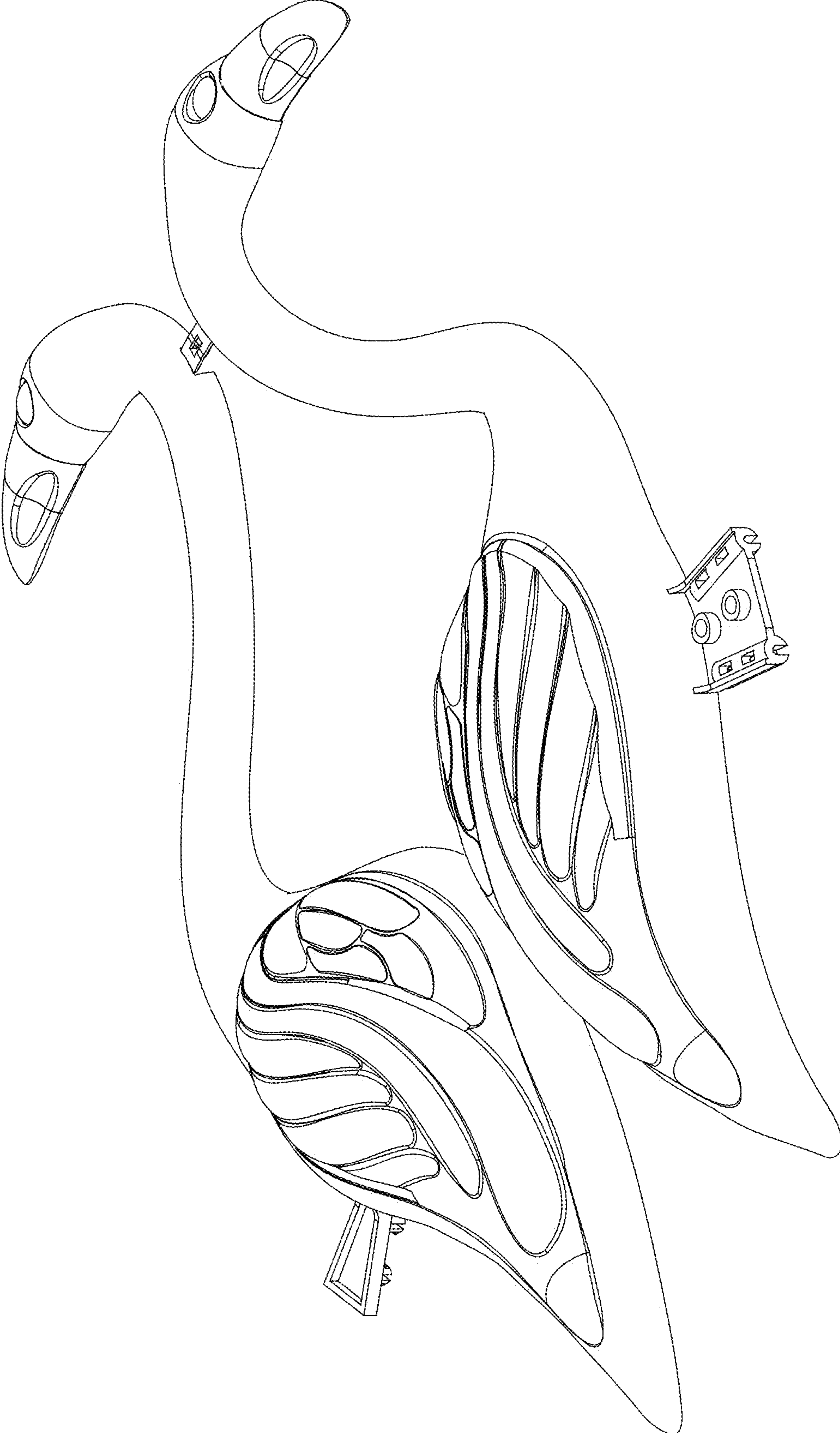

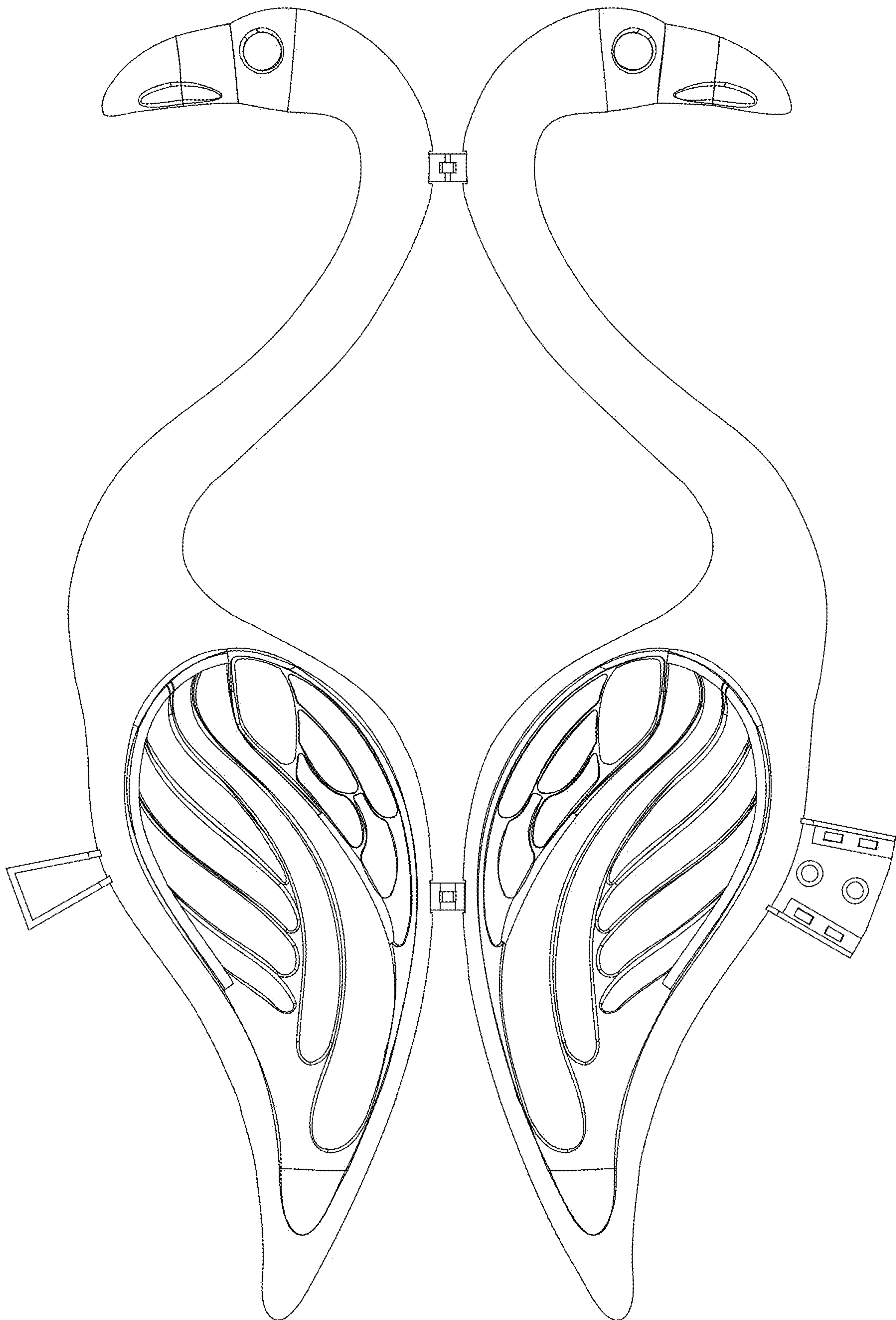

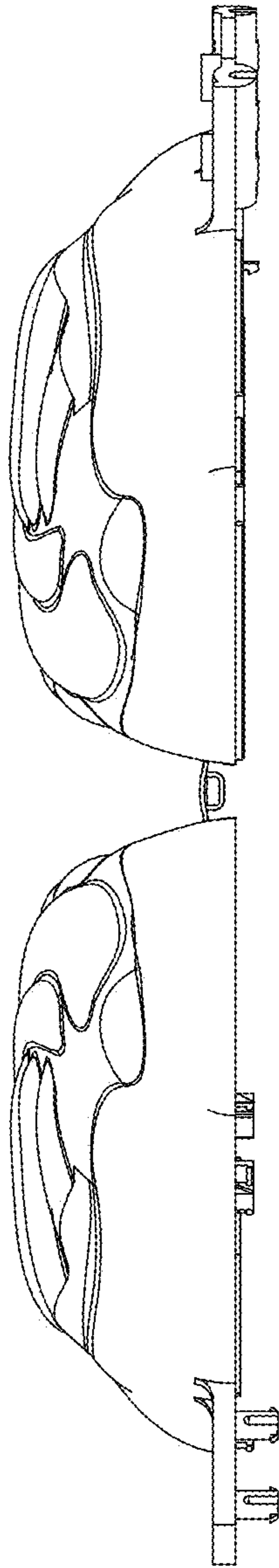

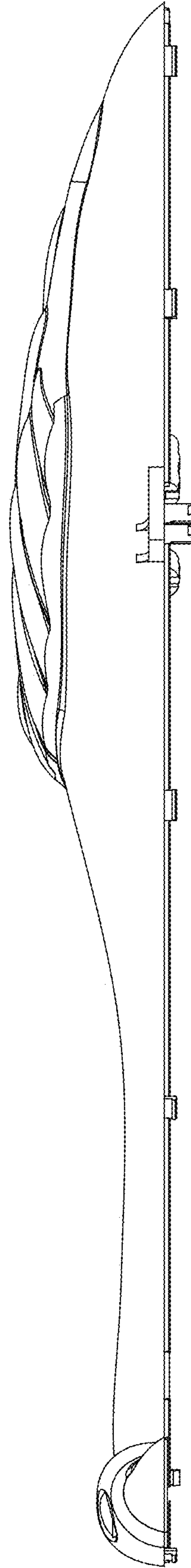

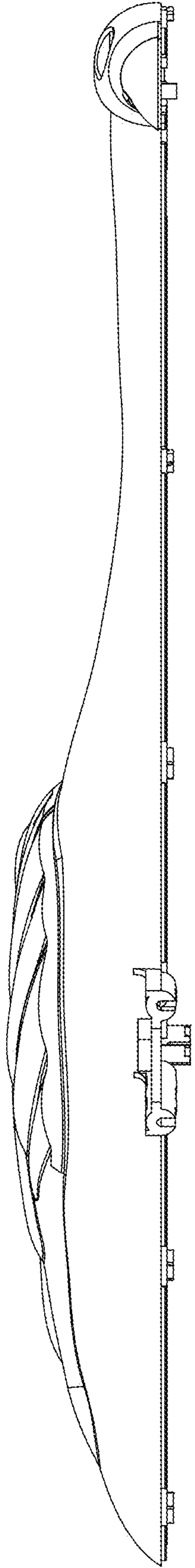

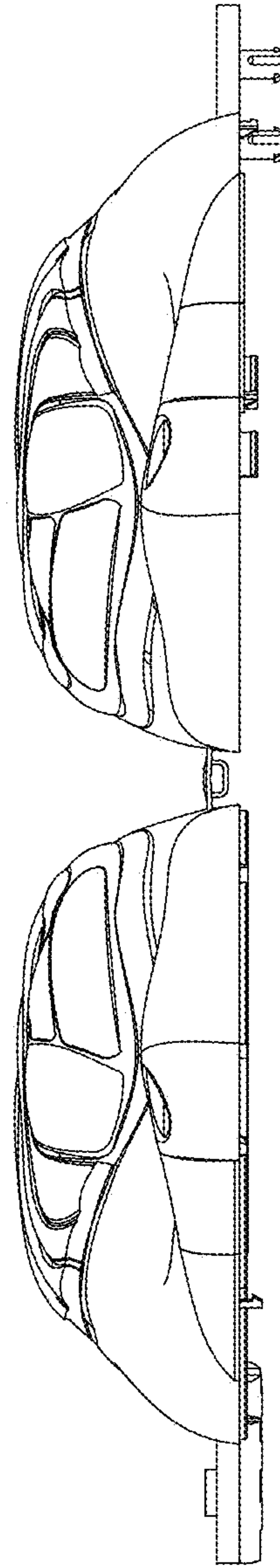

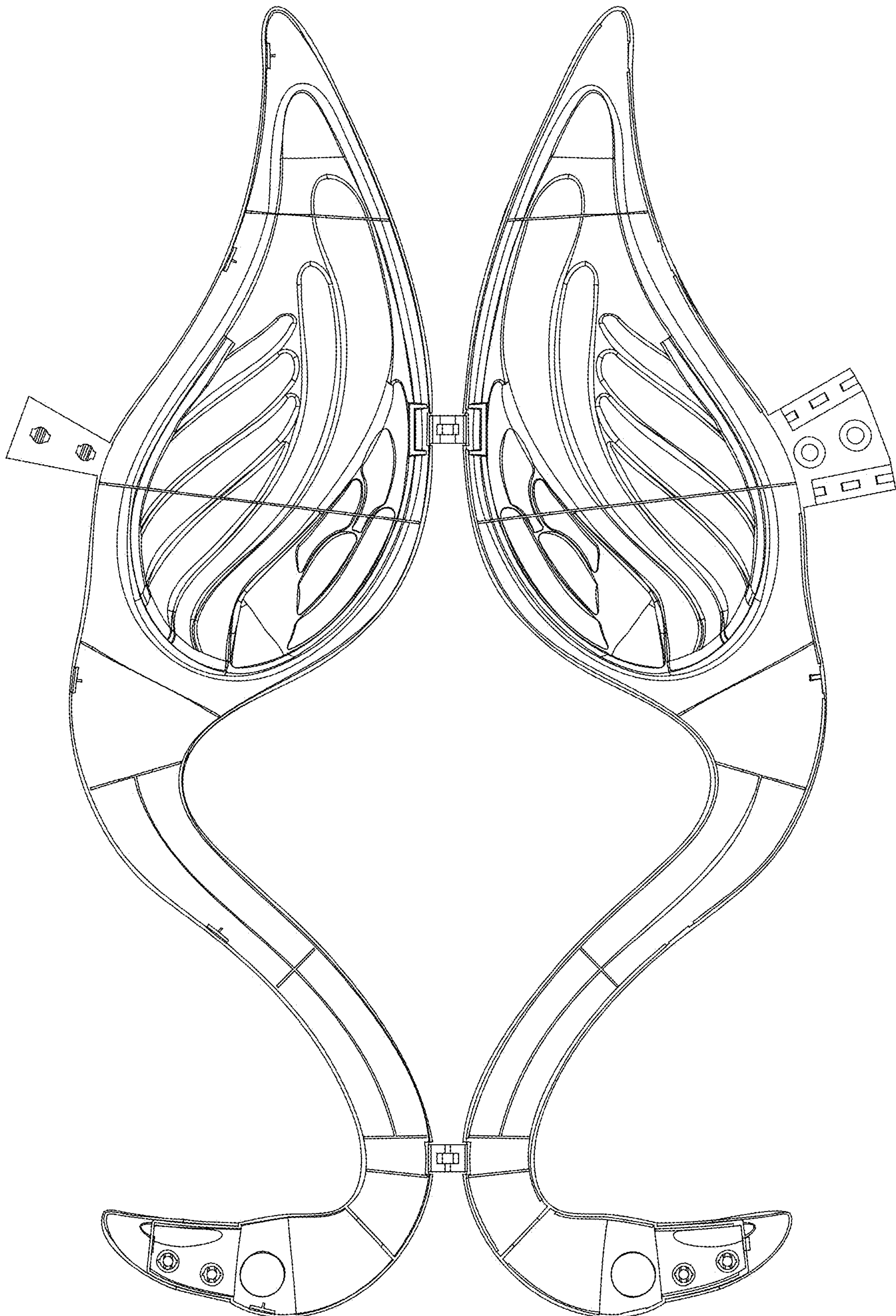

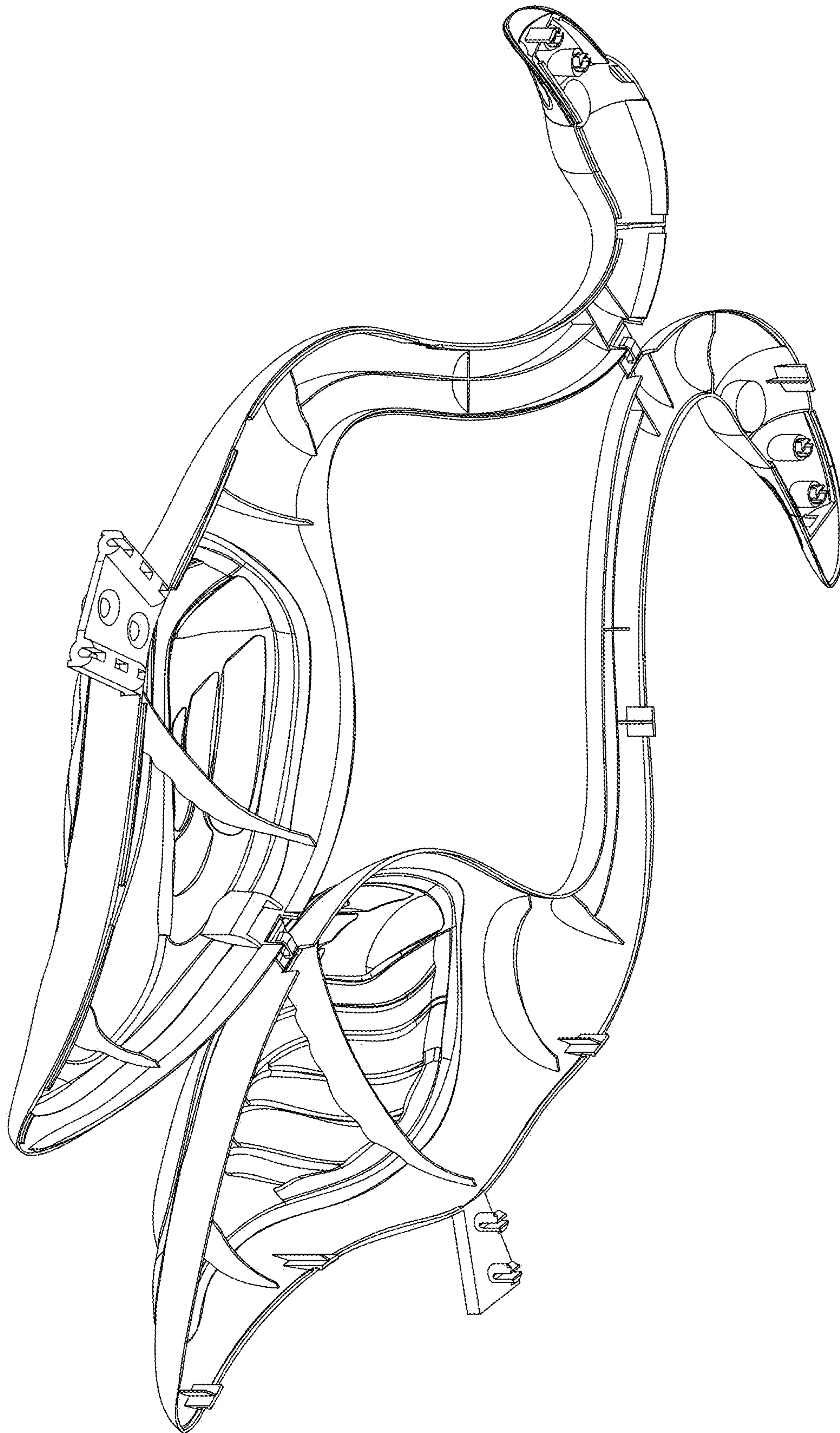

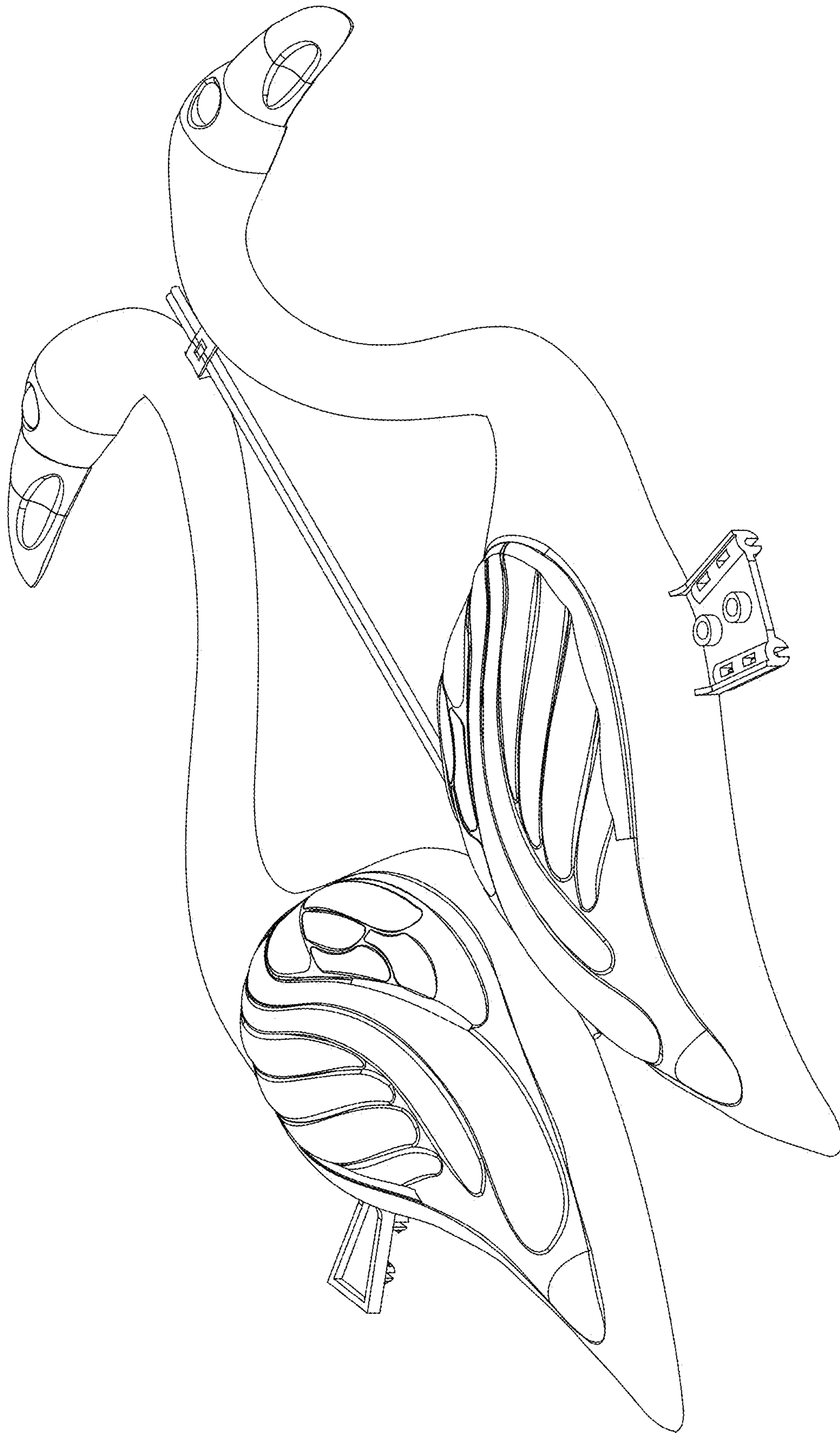

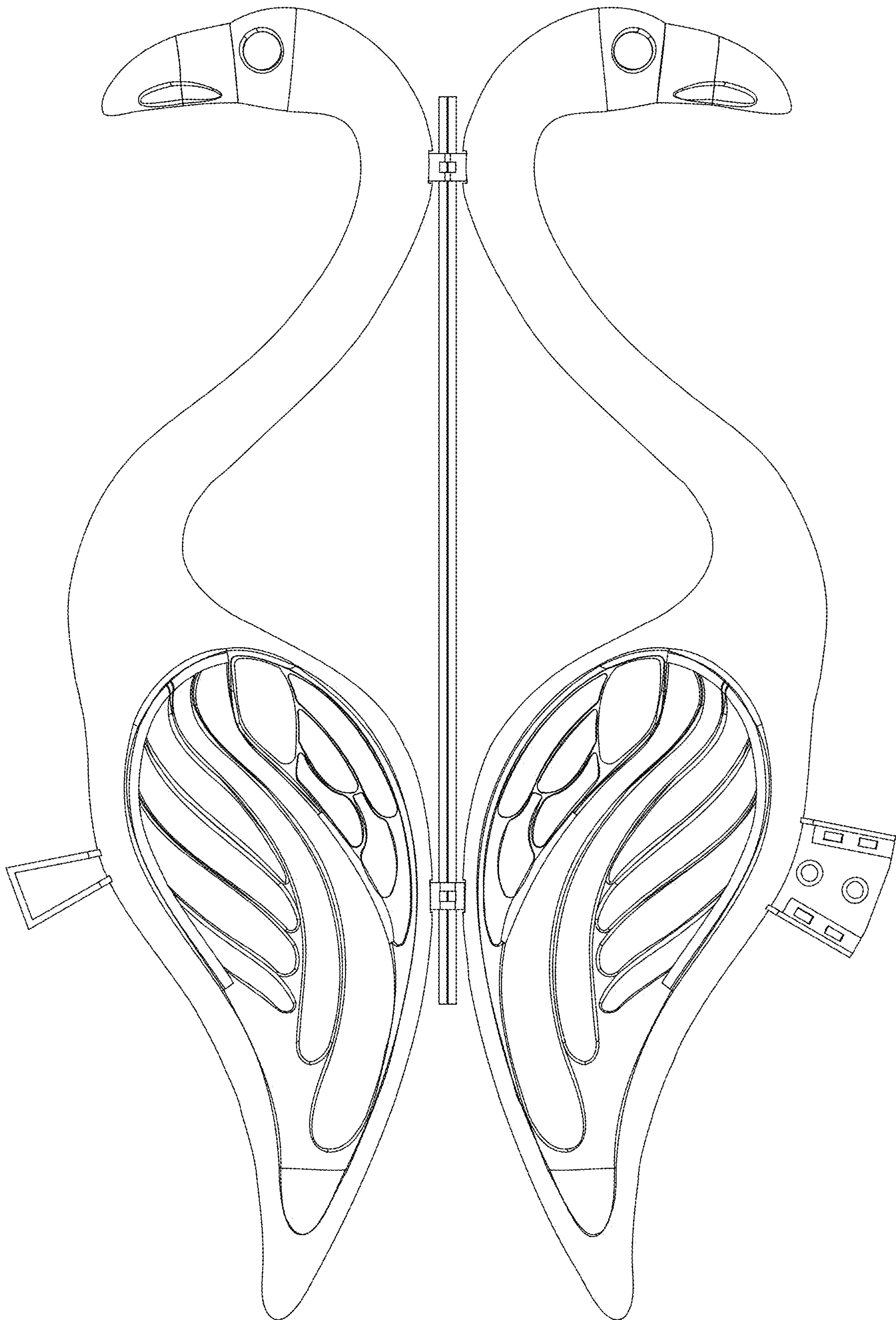

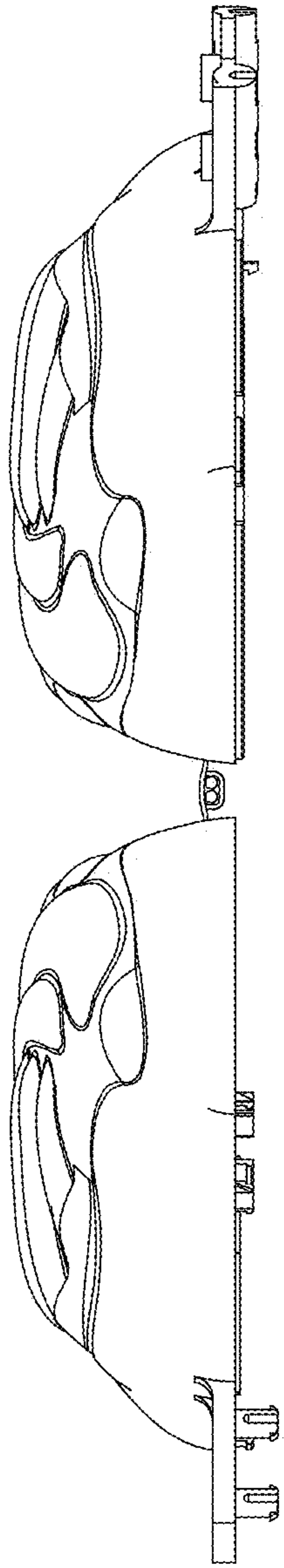

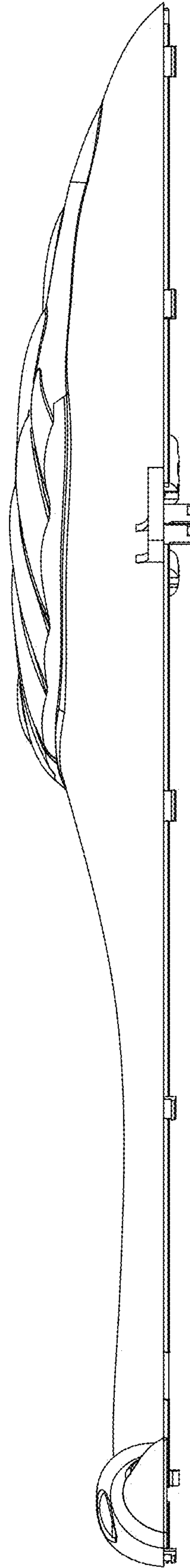

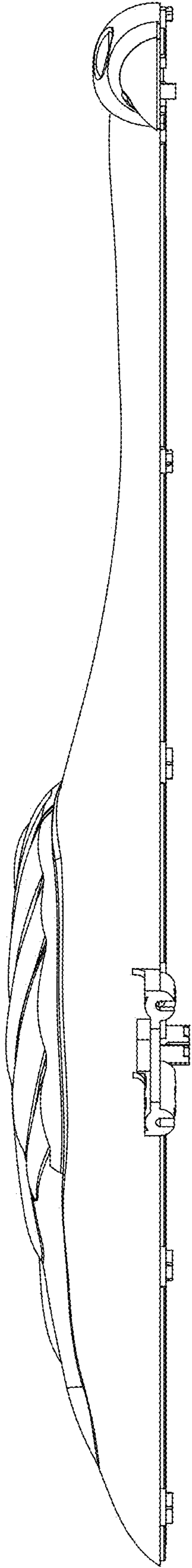

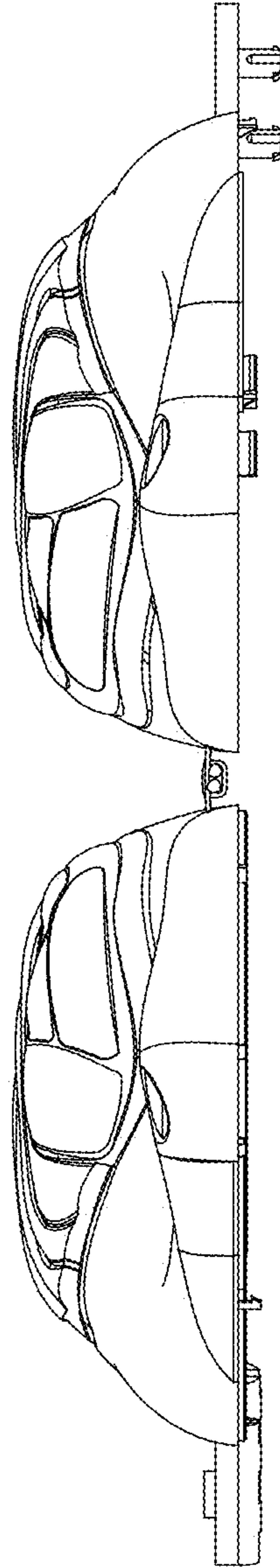

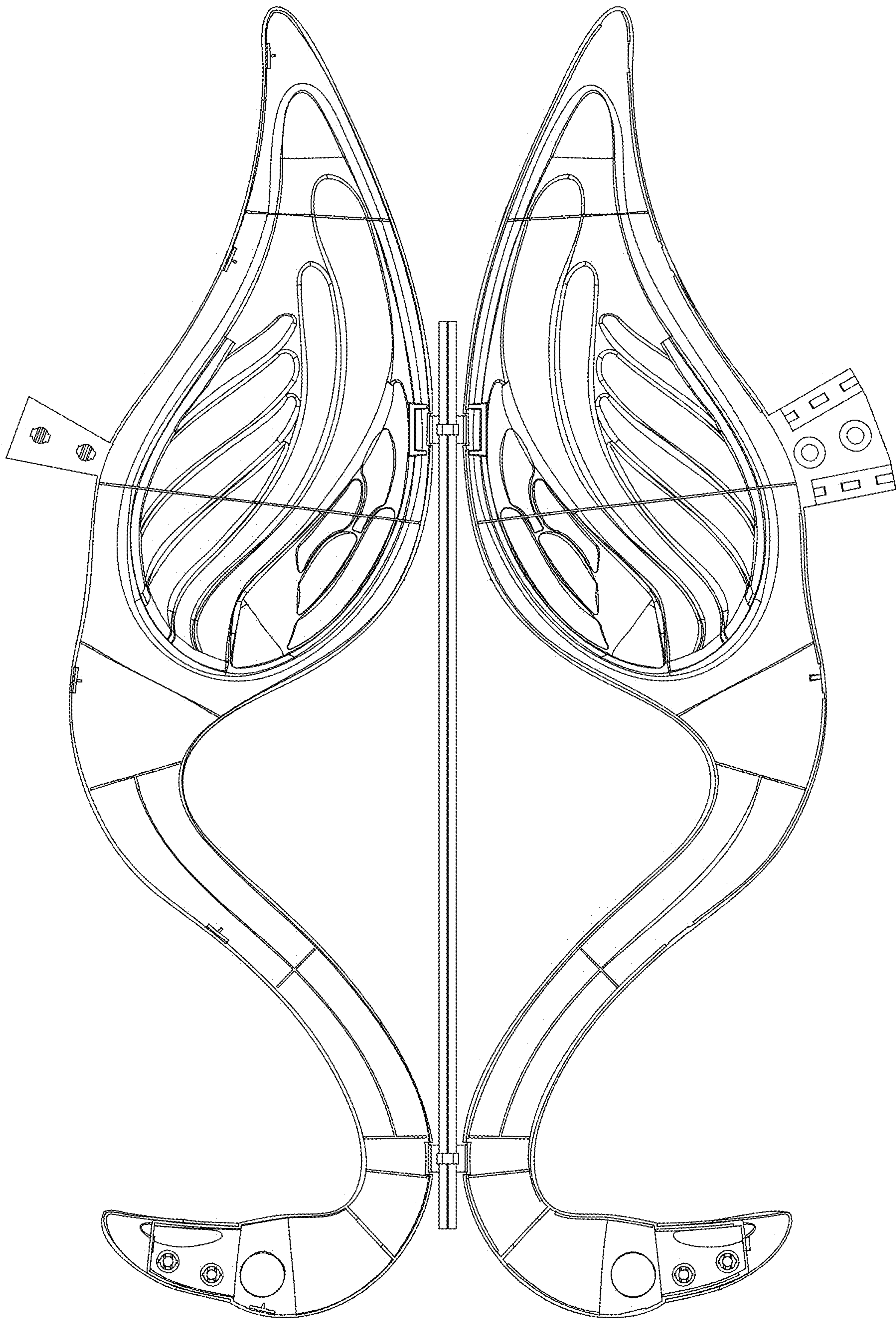

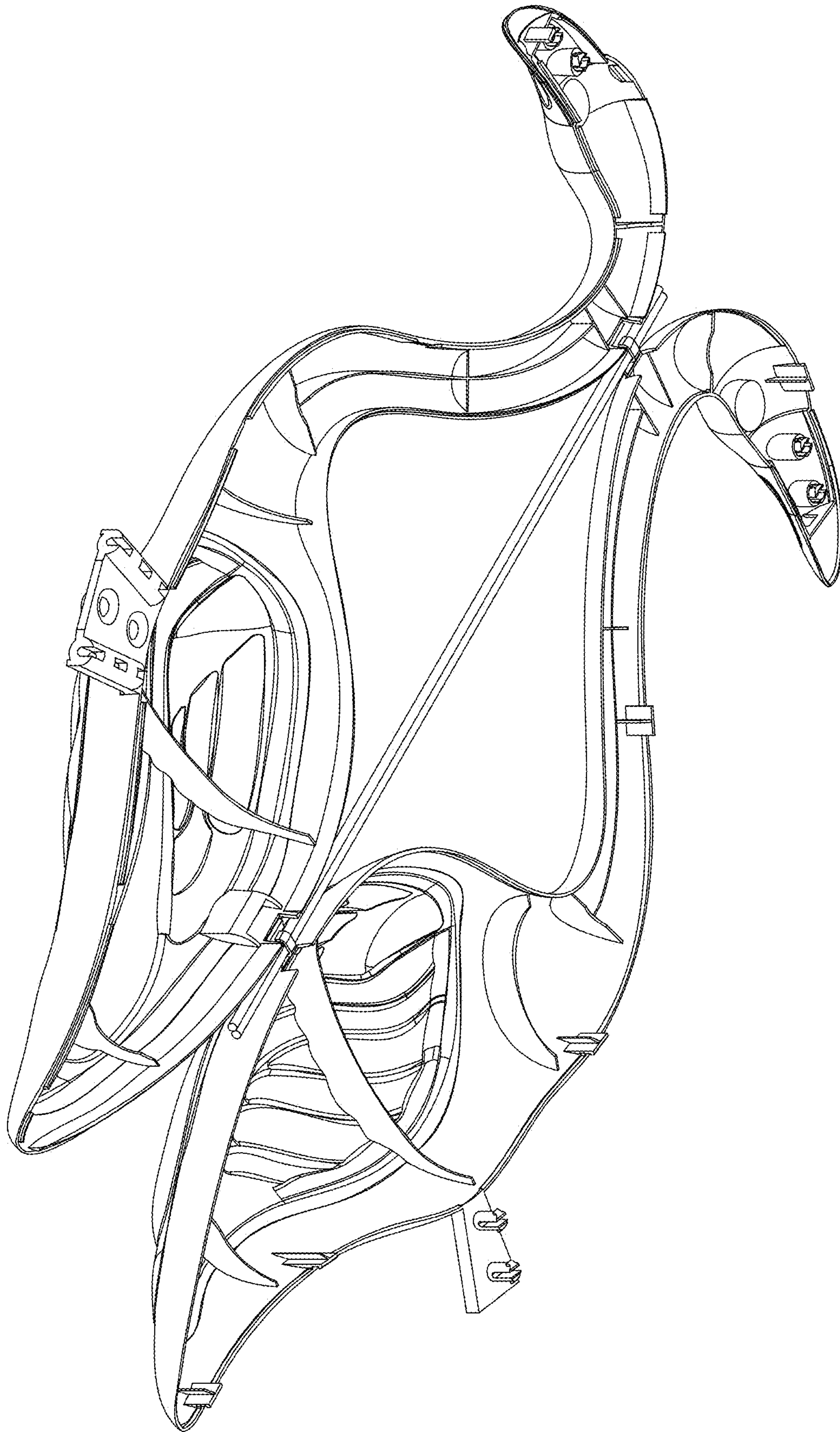

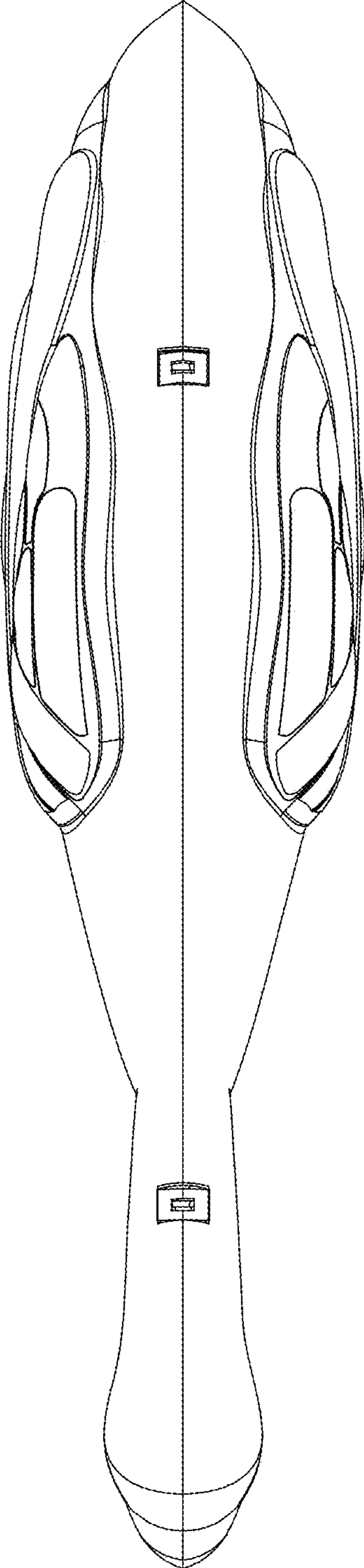

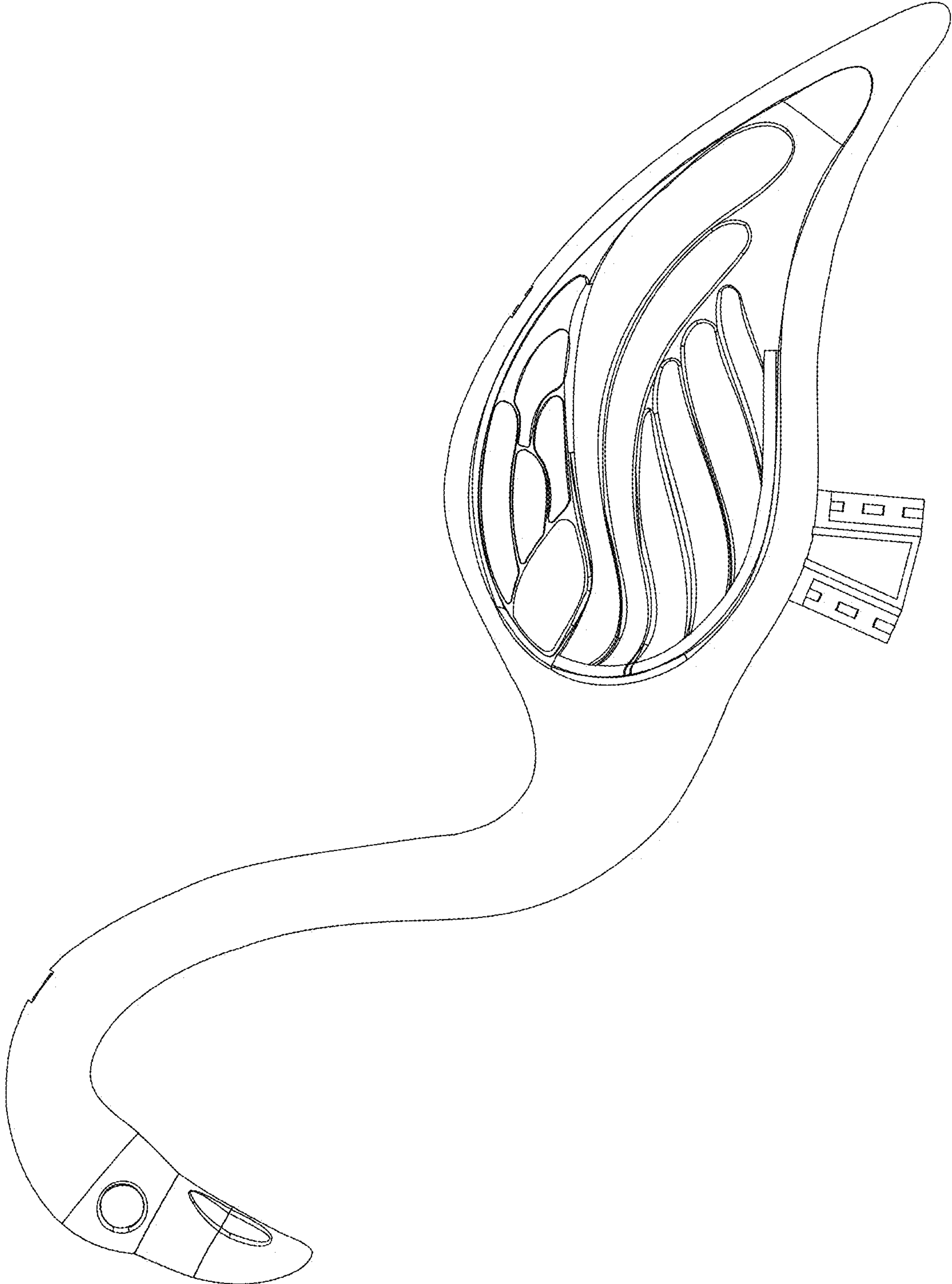

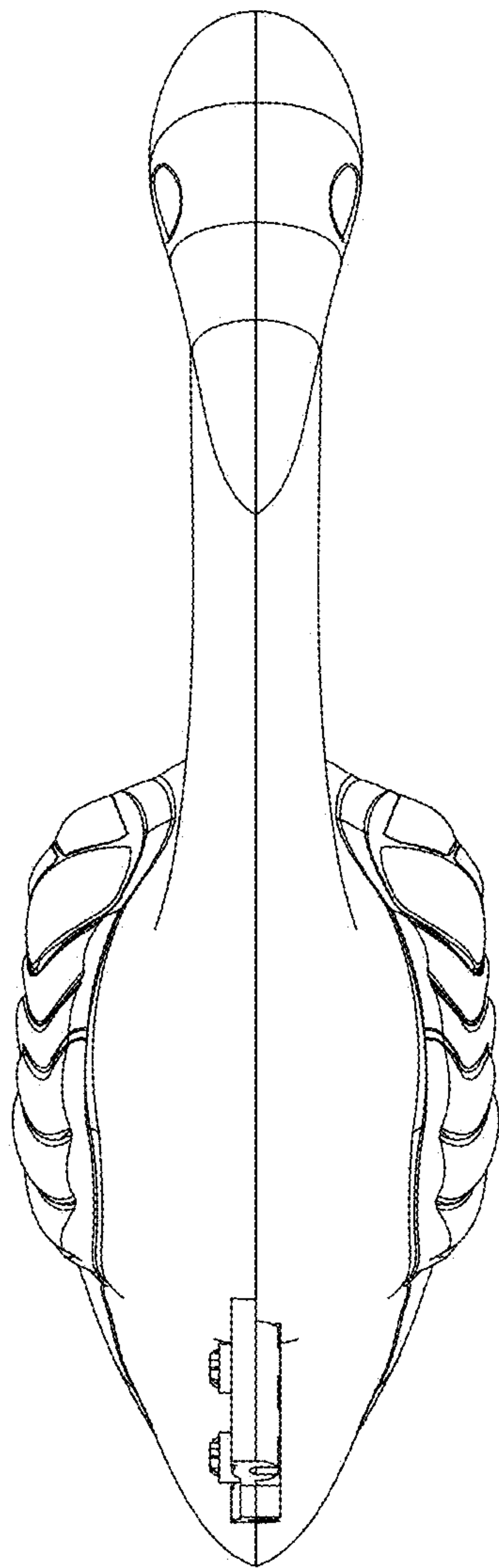

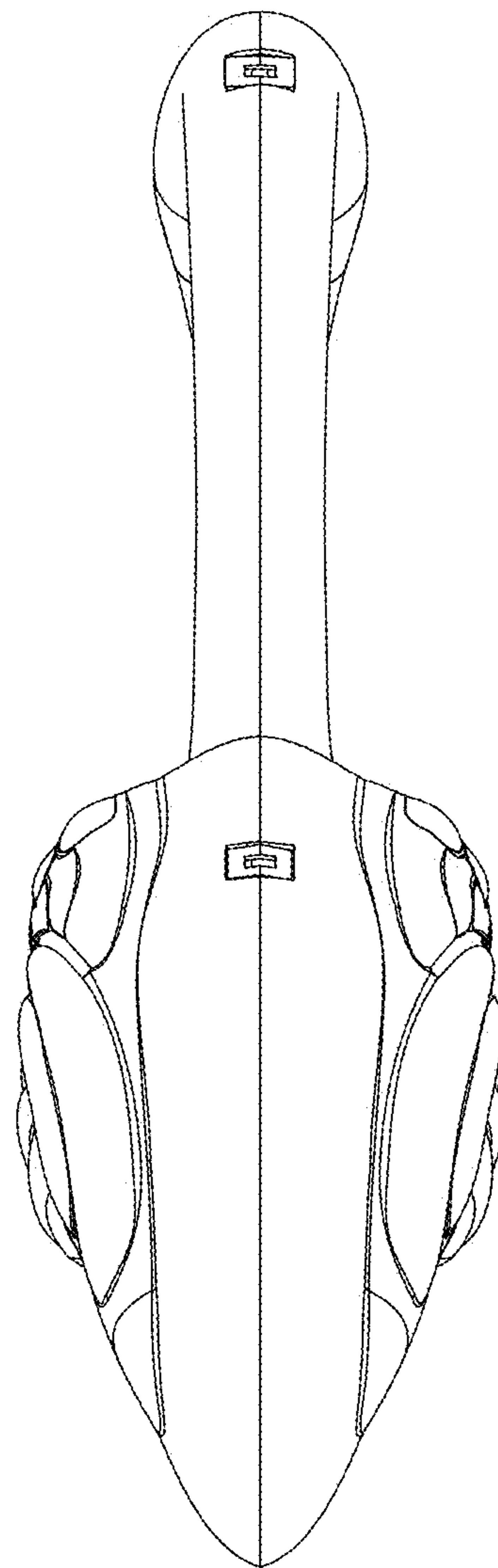

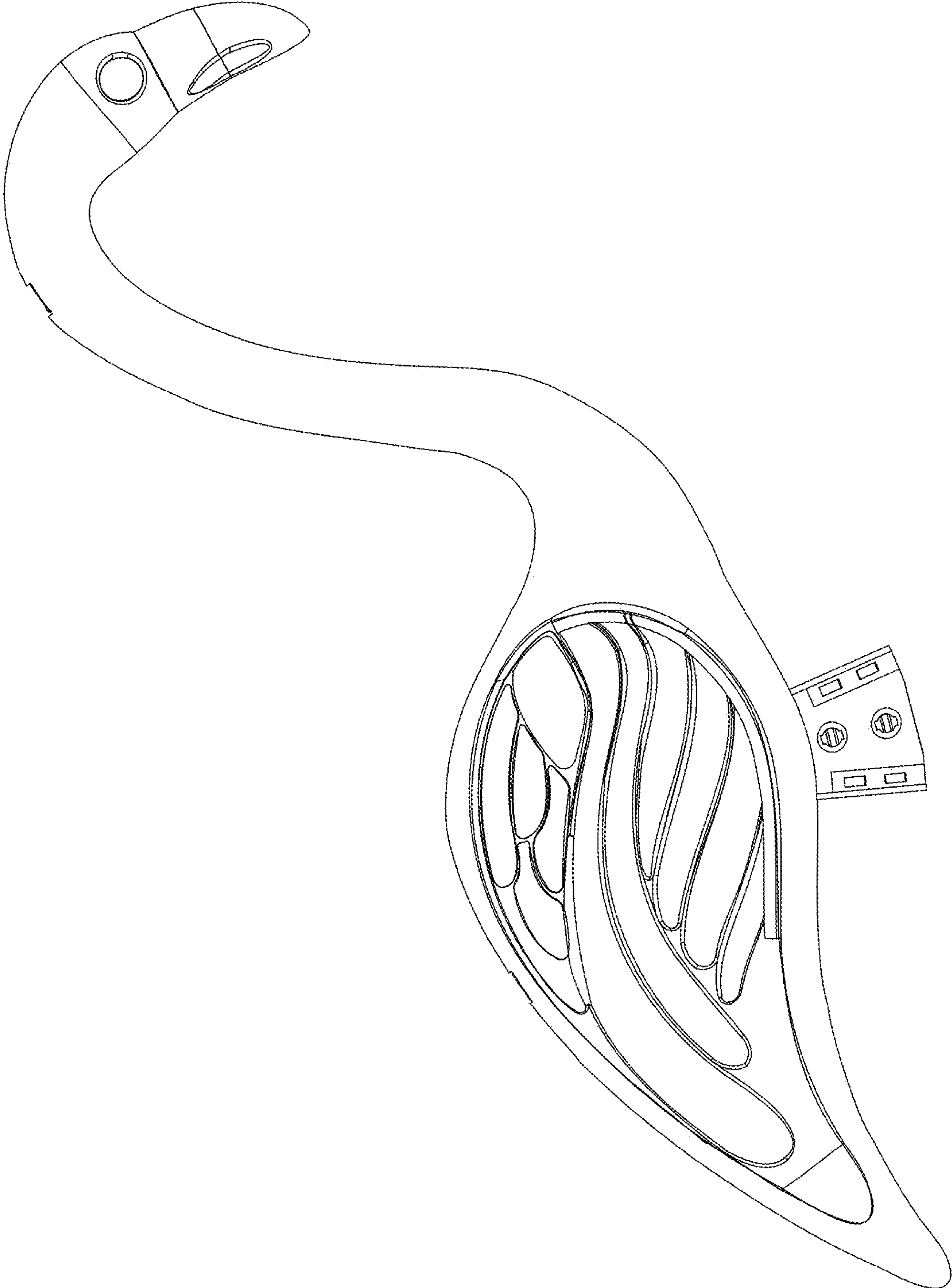

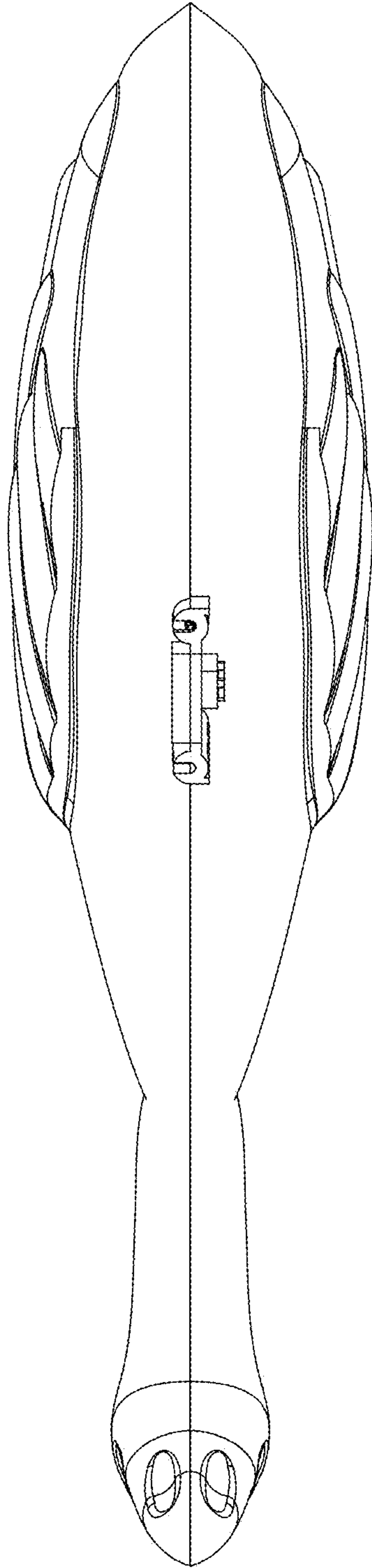

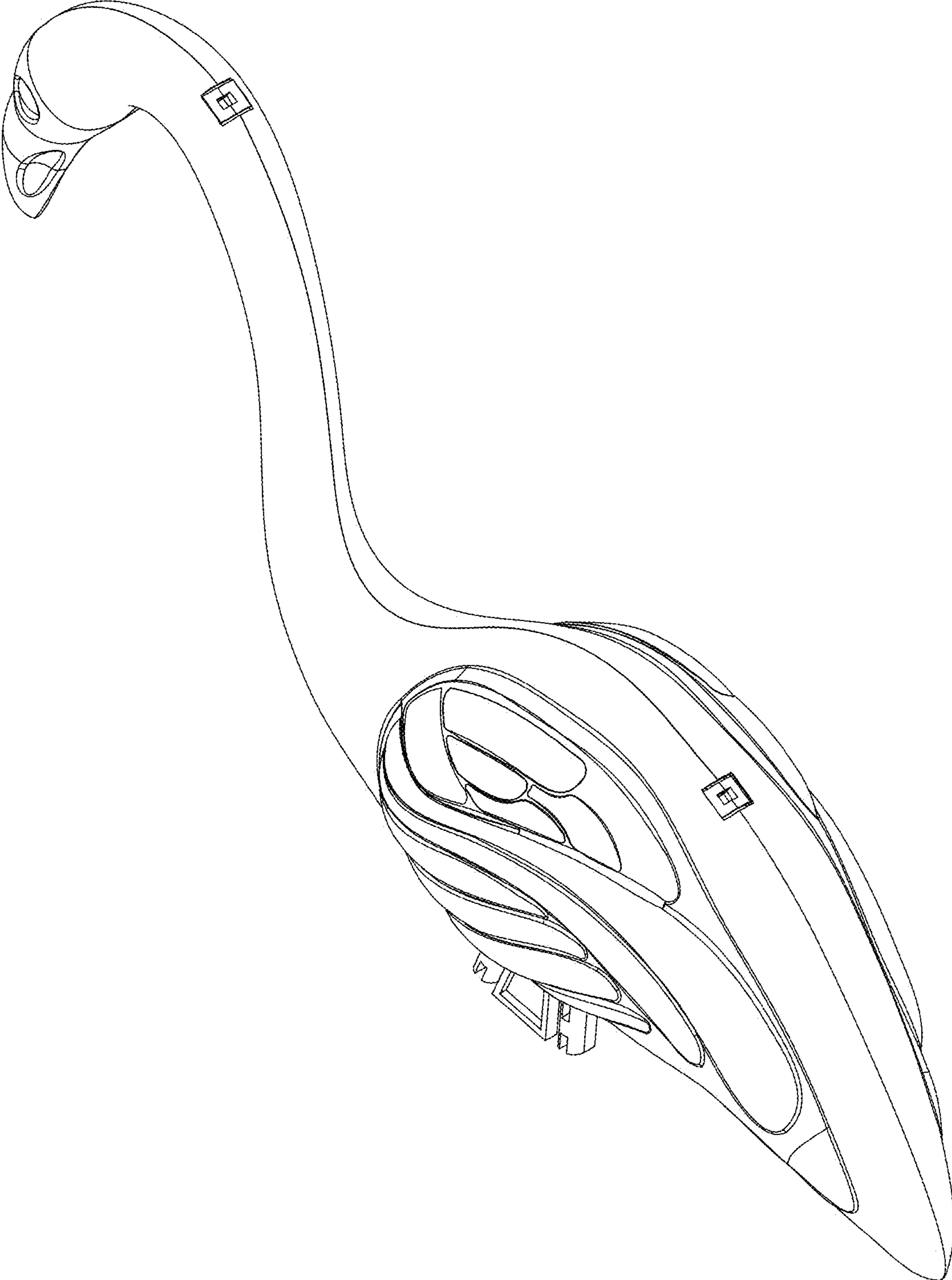

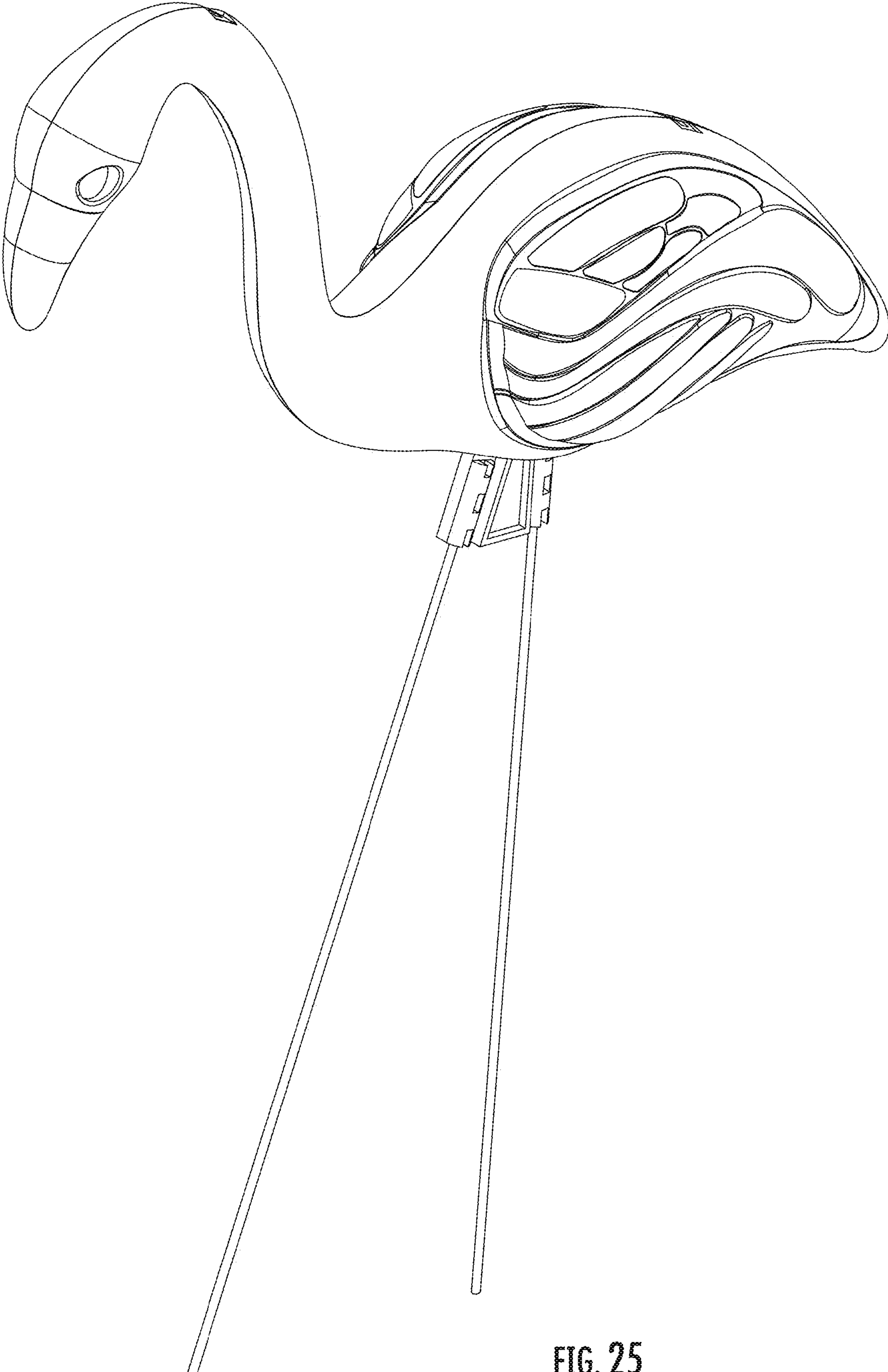

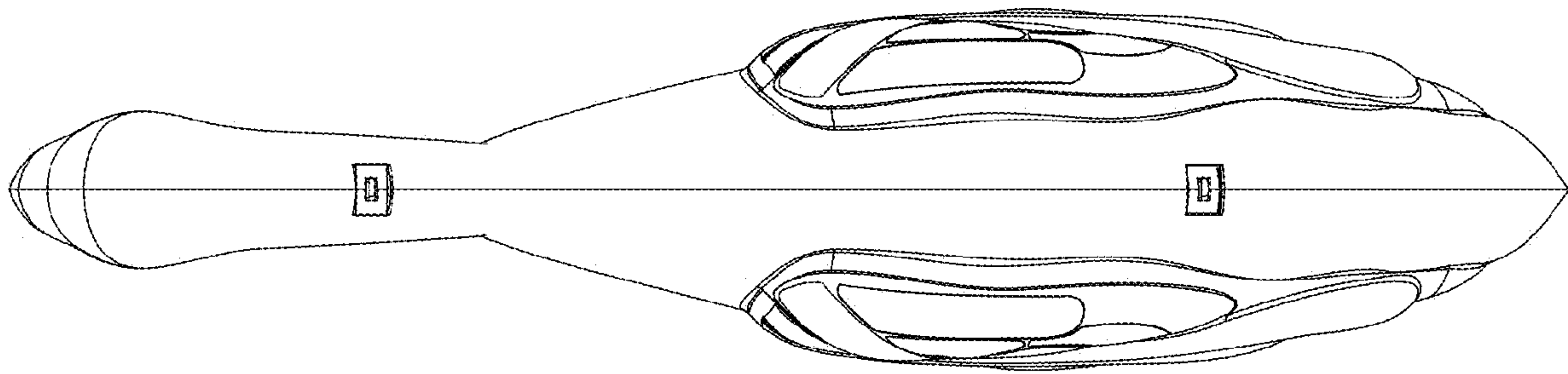

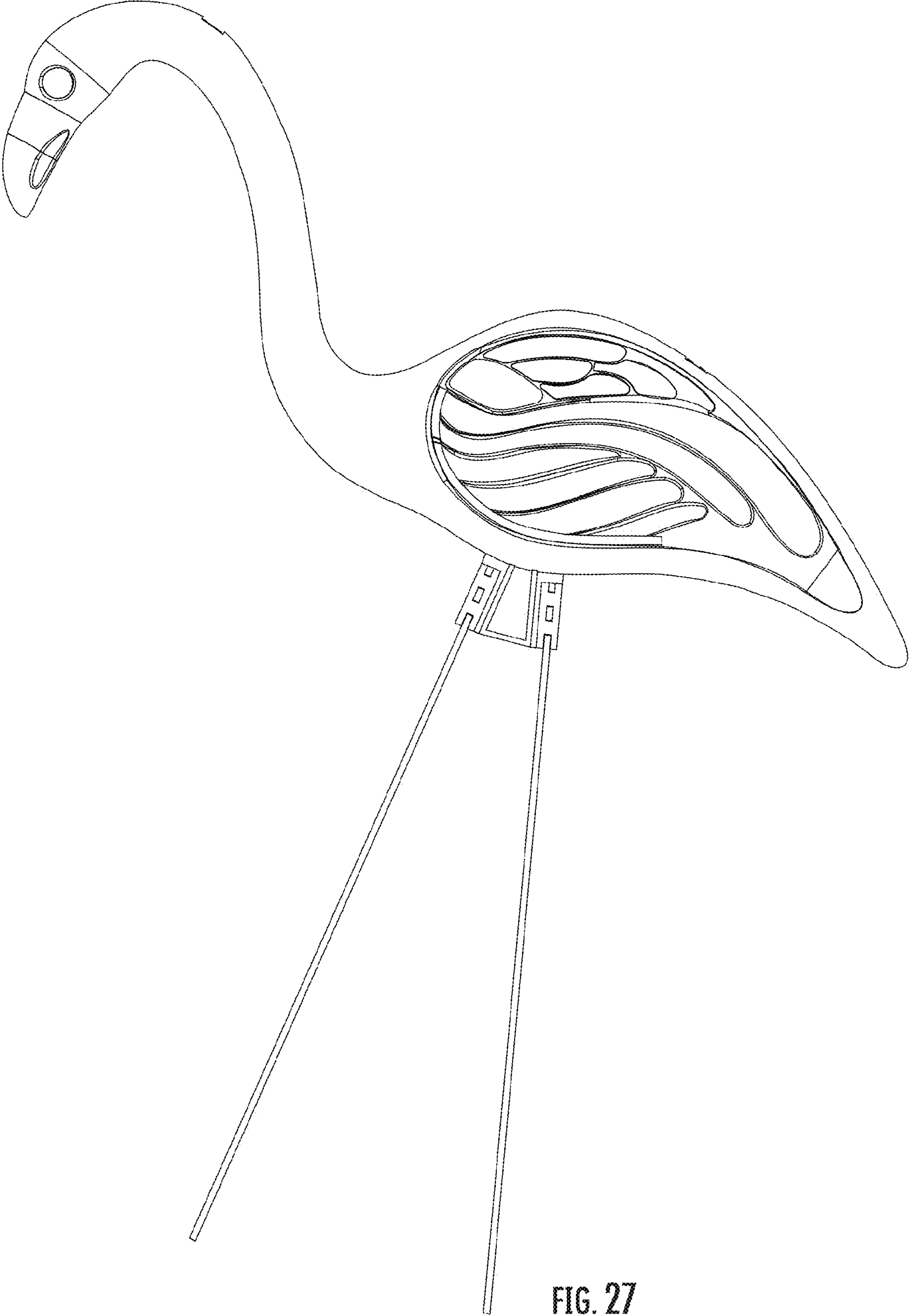

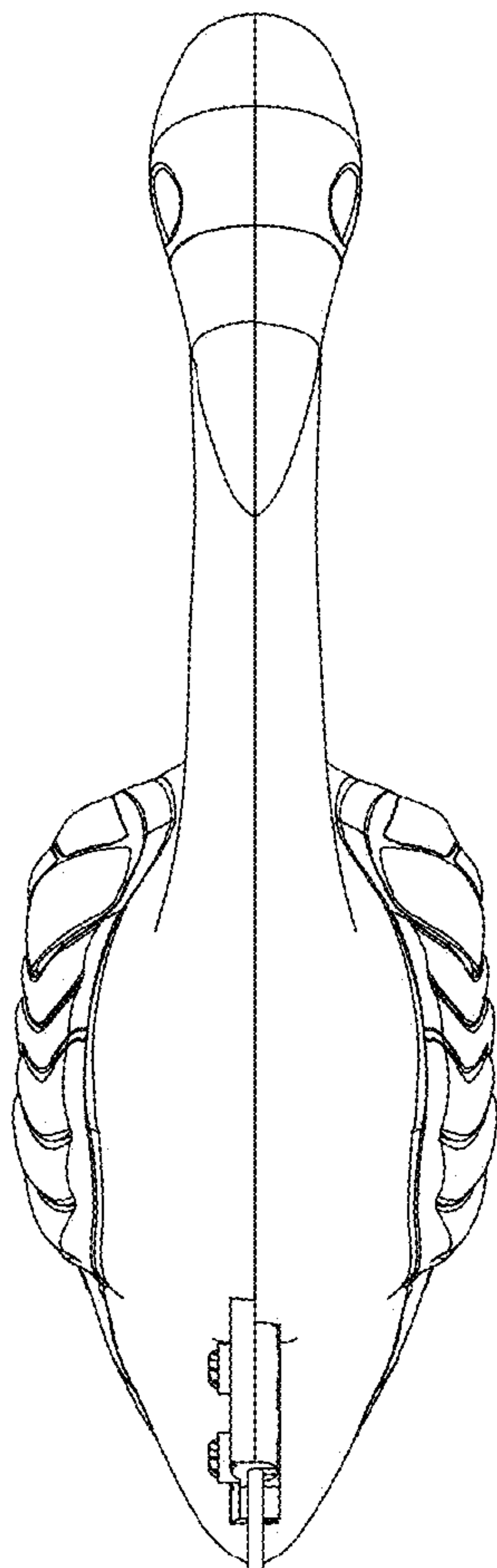

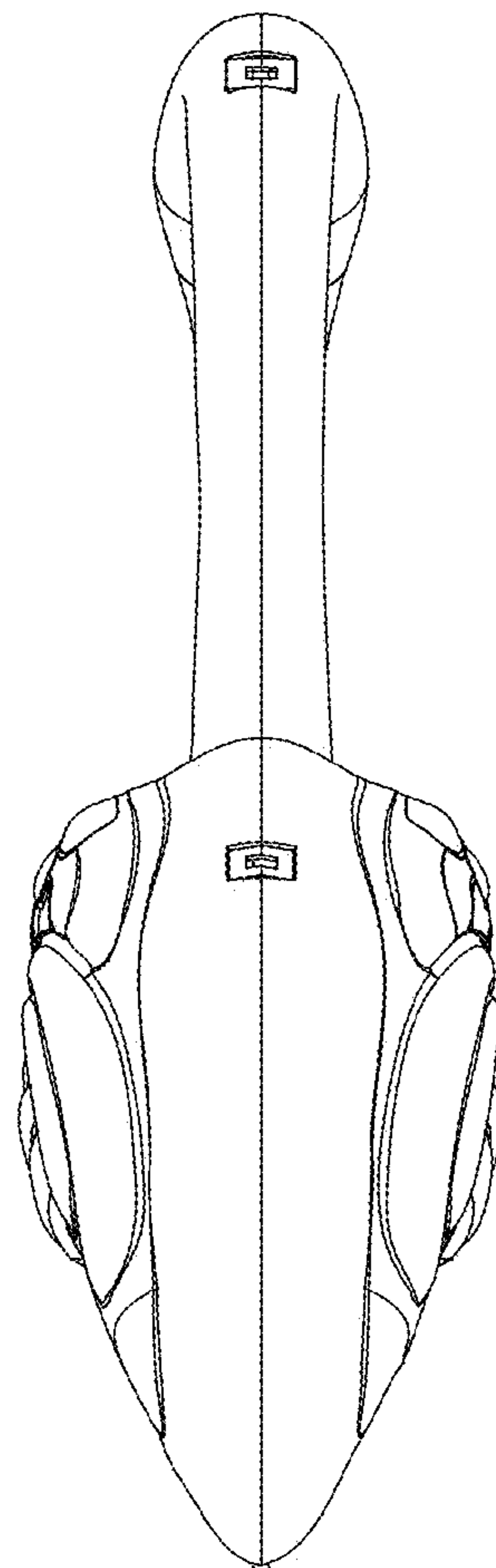

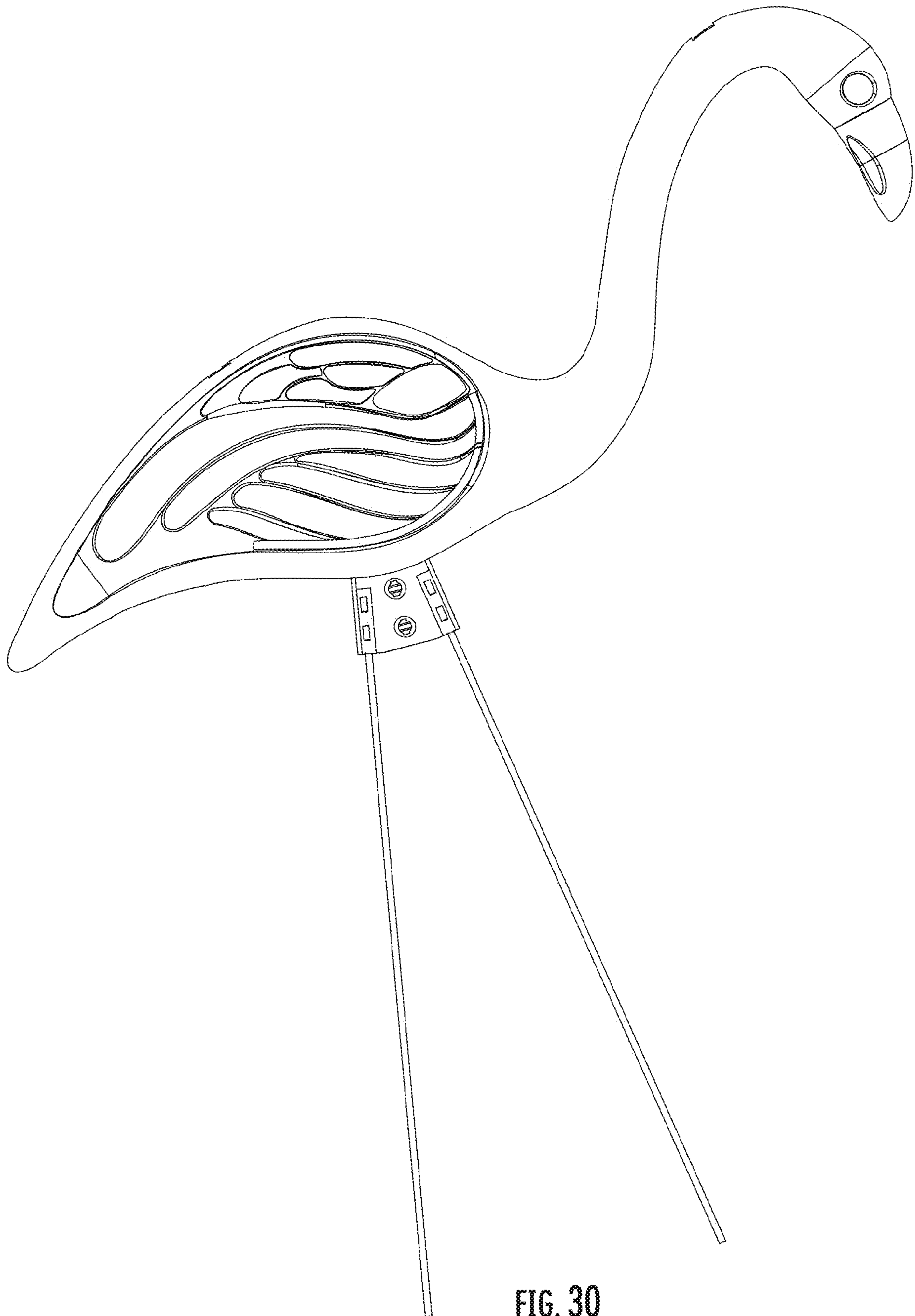

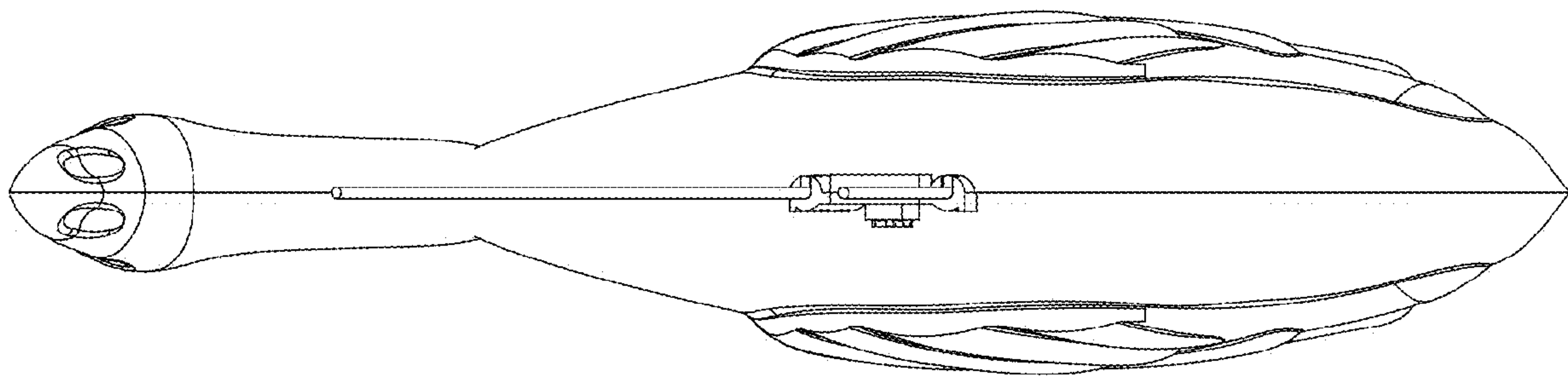

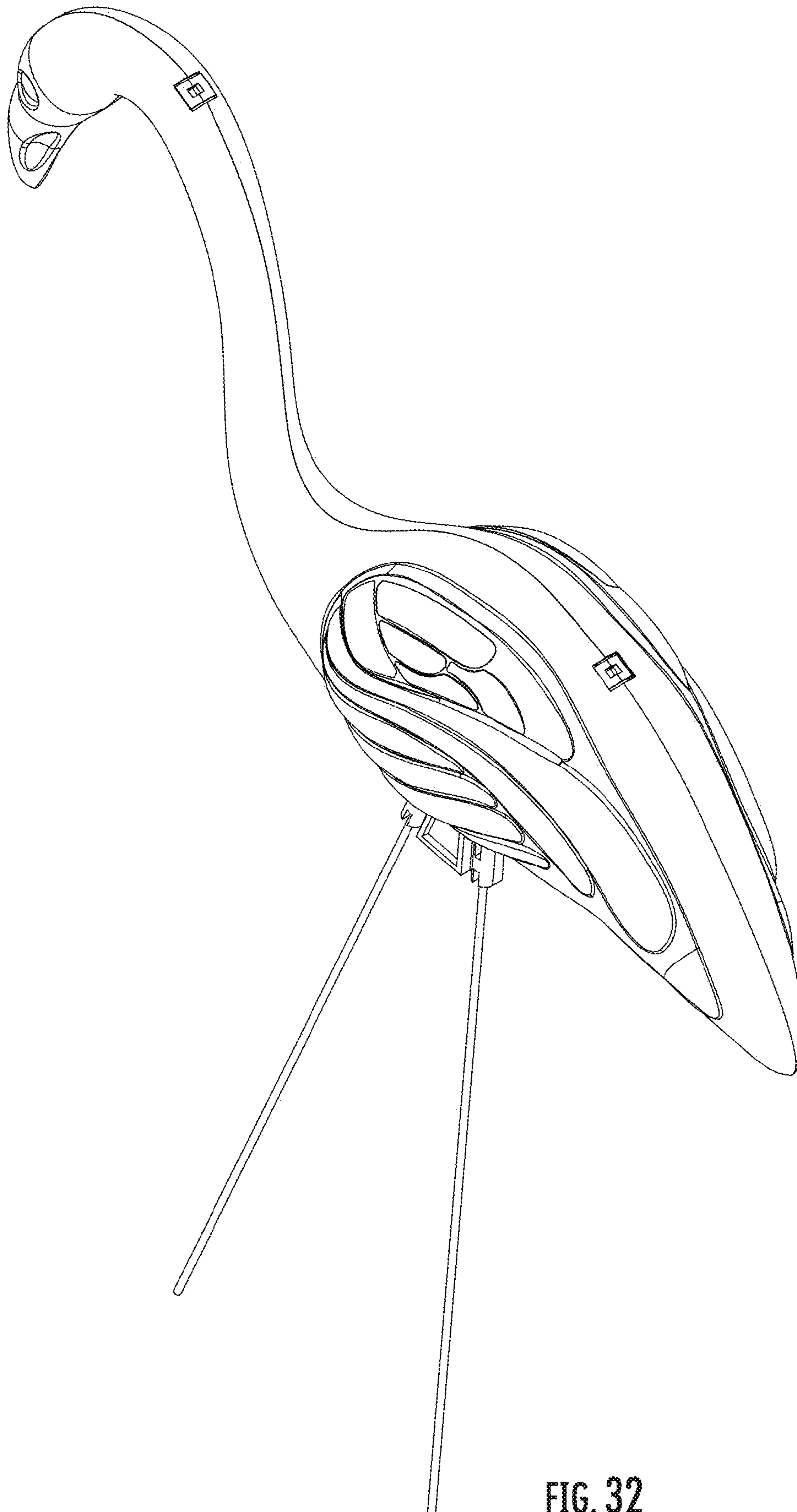
