FIG. 1 is a front view of a display screen with icon according to our new design.

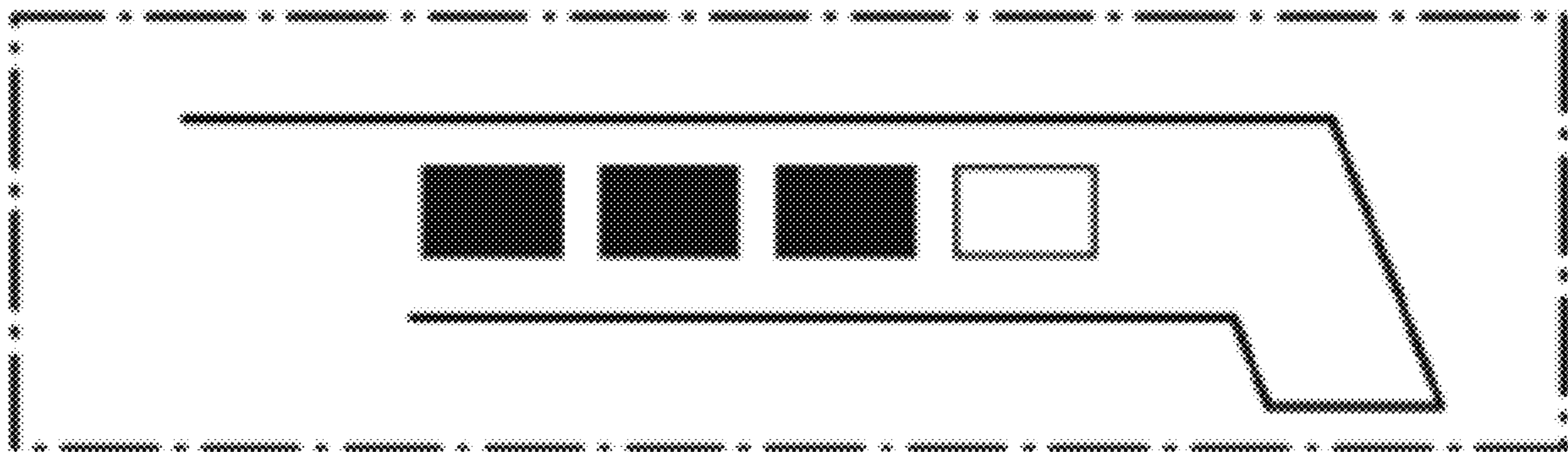
FIG. 2 is a front view of another embodiment of our new design.
