(57) **CLAIM**

The ornamental design for a display screen with animated icon, as shown and described.

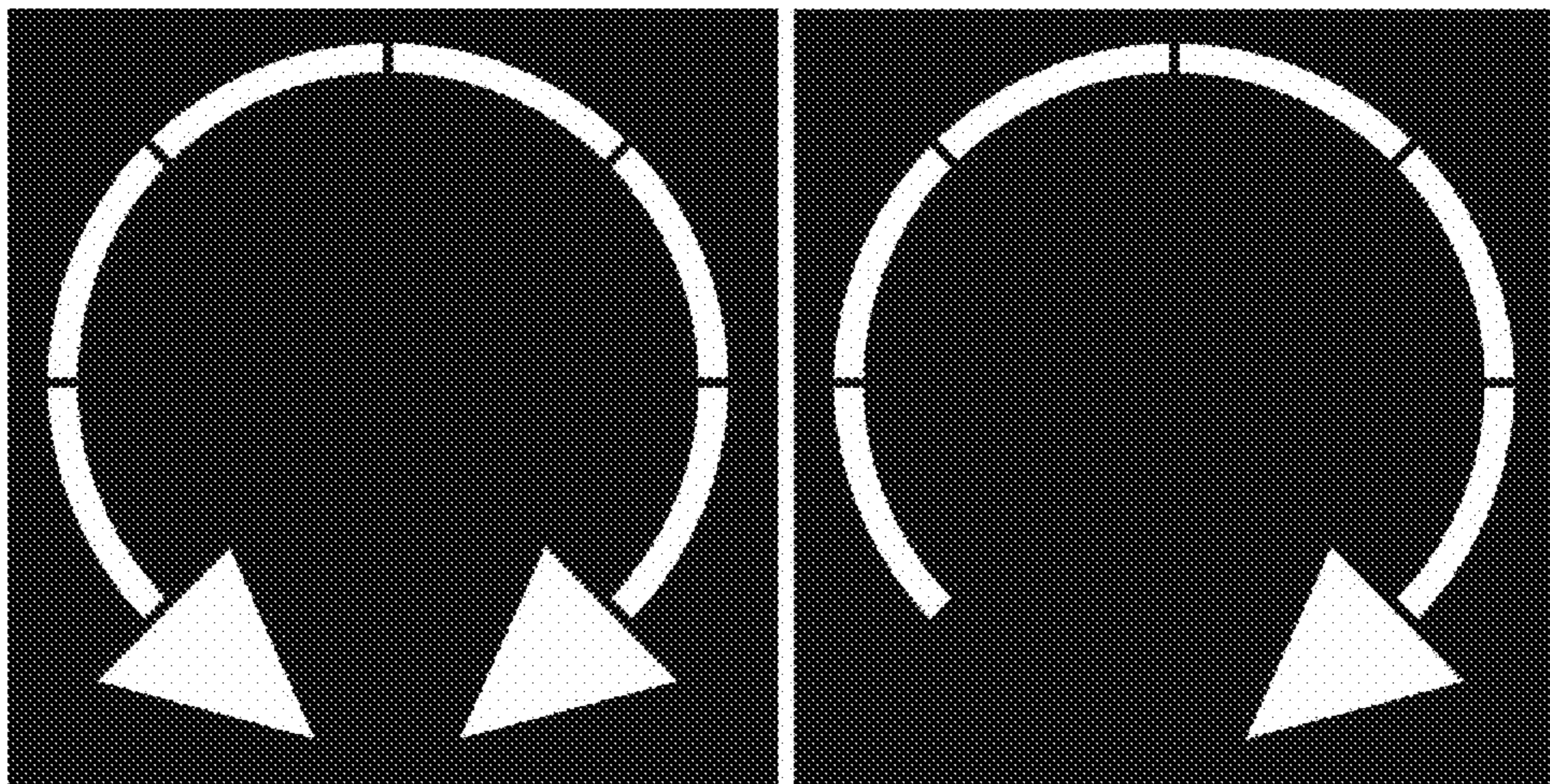
DESCRIPTION

- 1. Display screen with animated icon
- 1.1 : Partial enlarged view of figure 1.7, provided for clarity of illustration
- 1.2 : Partial enlarged view of a second image in a sequence of a display screen with animated icon, shown separate from the remainder of the display screen with graphical user interface of figure 1.7 and enlarged for clarity of illustration
- 1.3 : Partial enlarged view of a third image thereof
- 1.4 : Partial enlarged view of a fourth image thereof
- 1.5 : Partial enlarged view of a fifth image thereof
- 1.6 : Partial enlarged view of a sixth image thereof
- 1.7 : Front view of a first image in a sequence of a display screen with animated icon

All remaining features of the display screen with graphical user interface, which are not shown in the 1.1-1.6 partial enlarged views are understood to remain static as depicted in figure 1.7. The appearance of the transitional image sequentially transitions between the images shown in Figs. 1.1-1.6. The process or period in which one image transitions to another image forms no part of the claimed design. The outer edge of the underlying display screen is understood to be congruent with the rectangular border of the graphical user interface in figure 1.7. All background and graphical user interface features outside the outer black square edge of the icon in figure 1.7, depicted in red, pink, purple and orange, form no part of the claimed design.

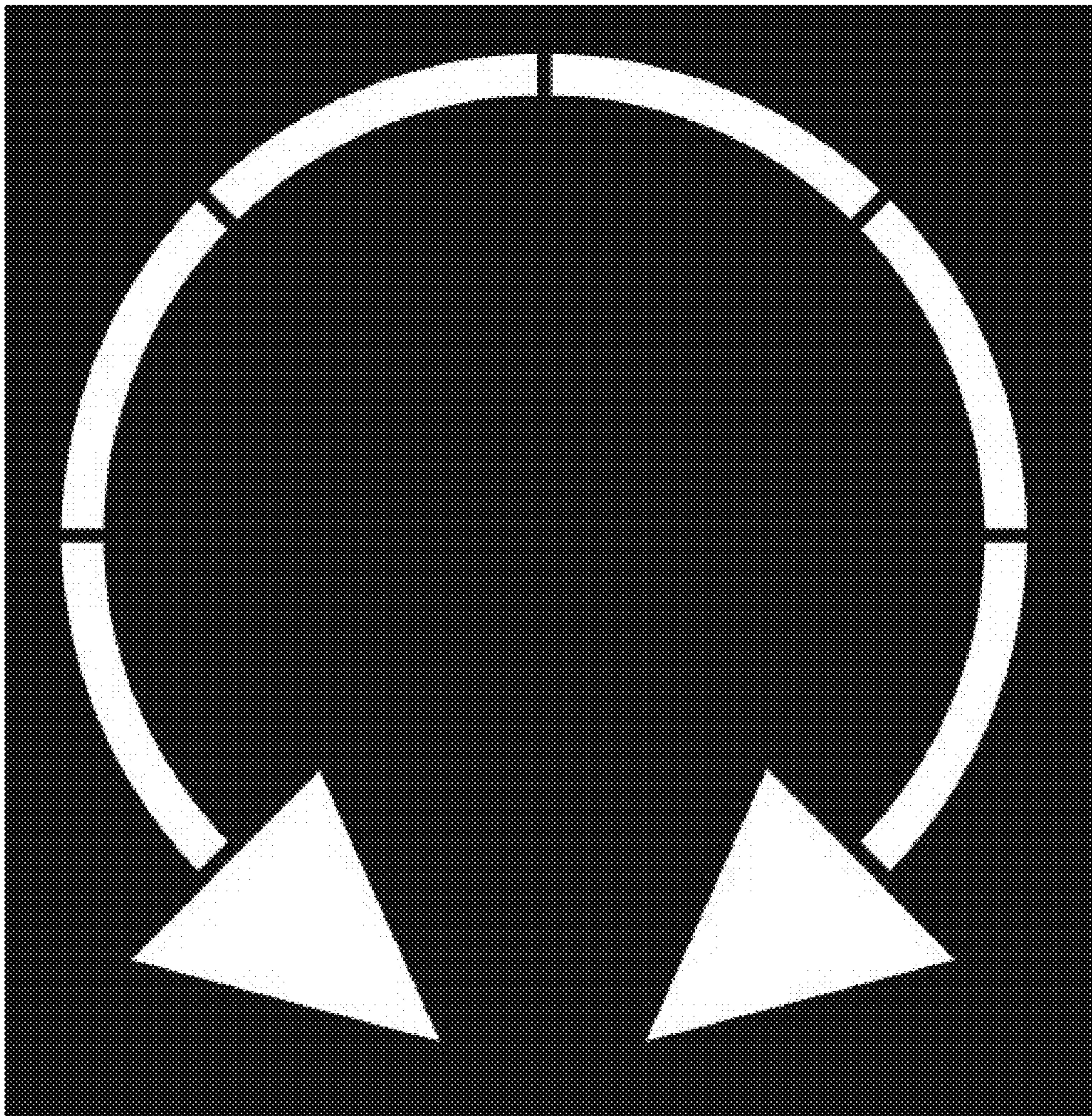

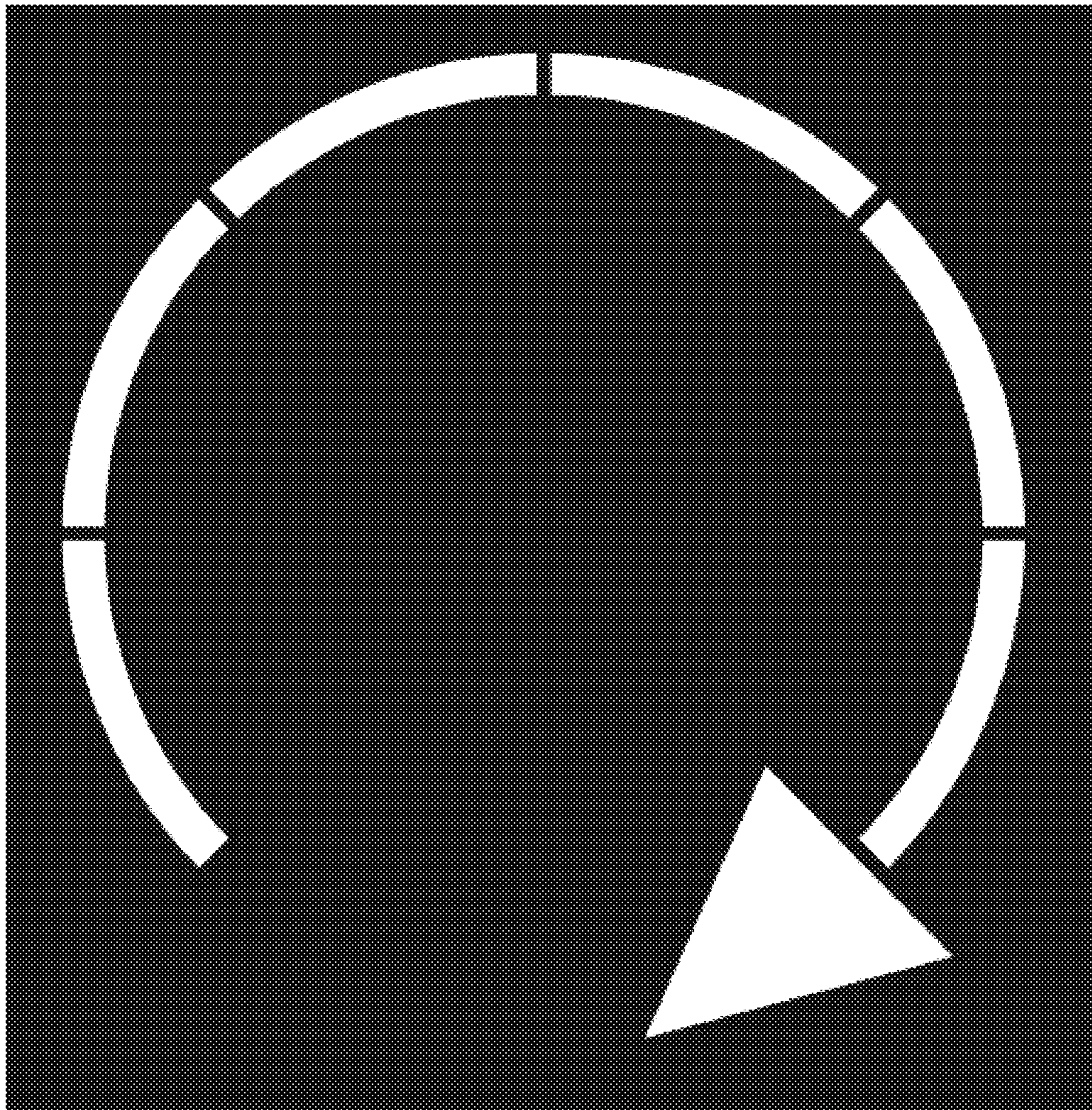

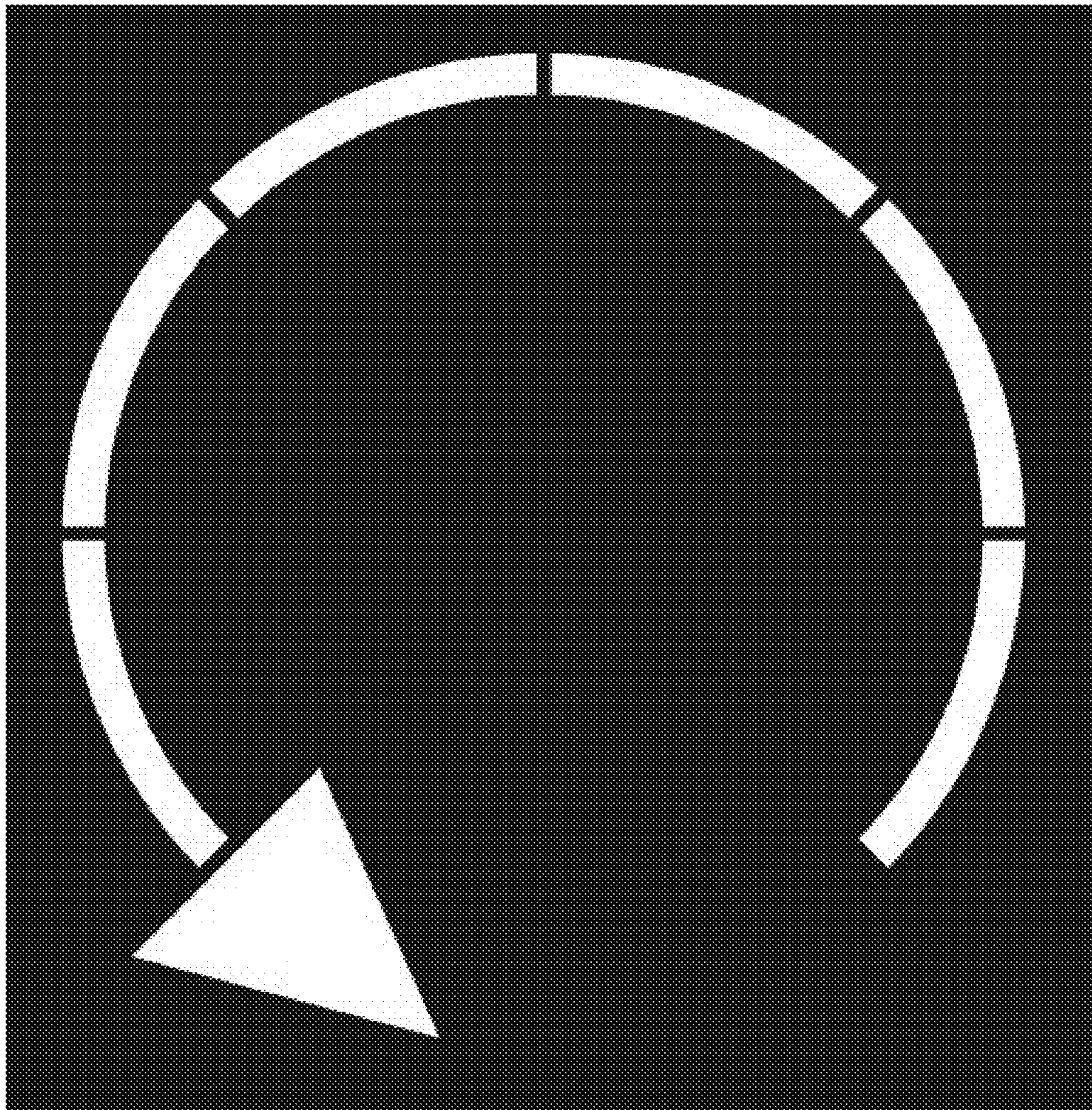

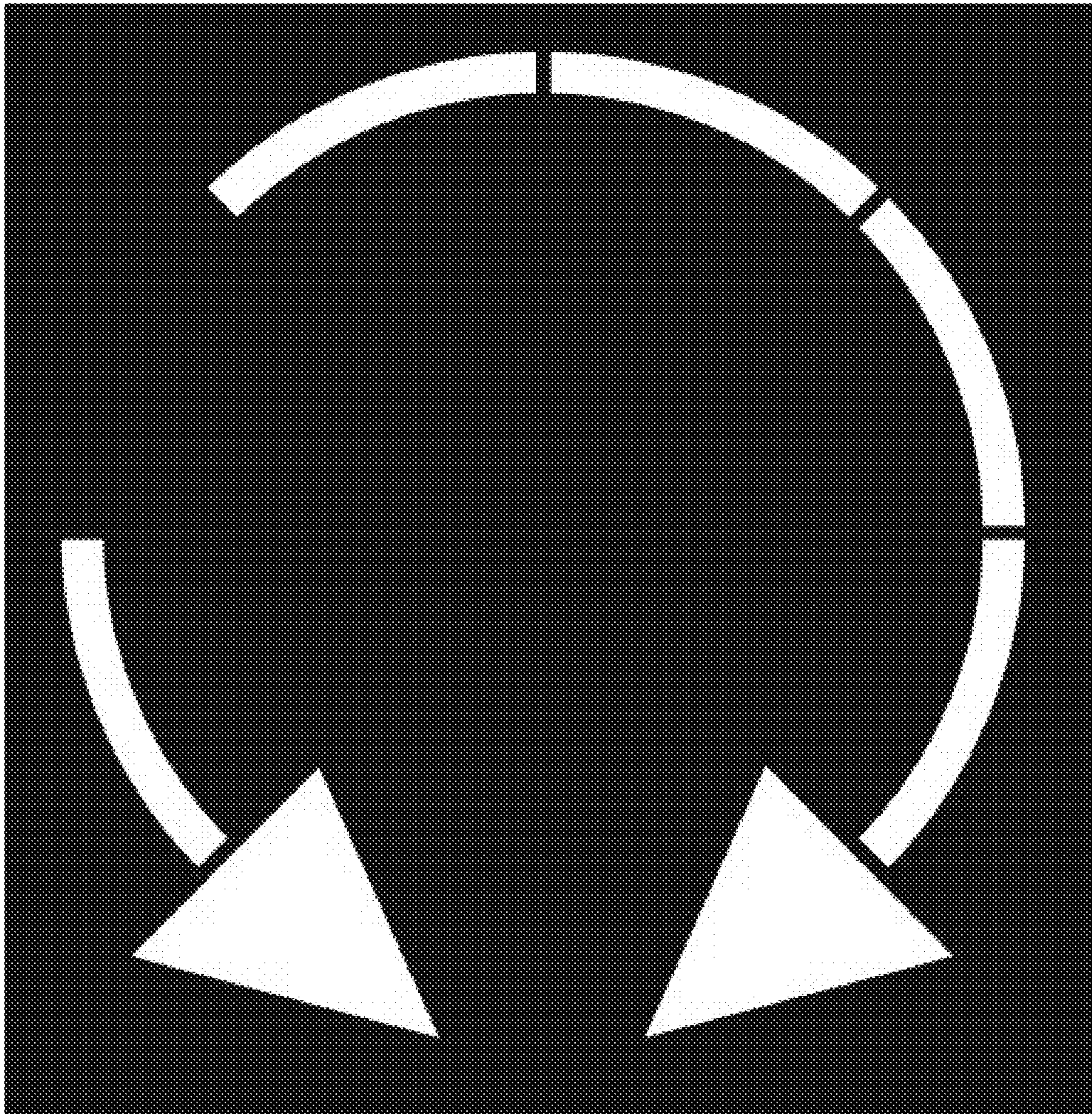

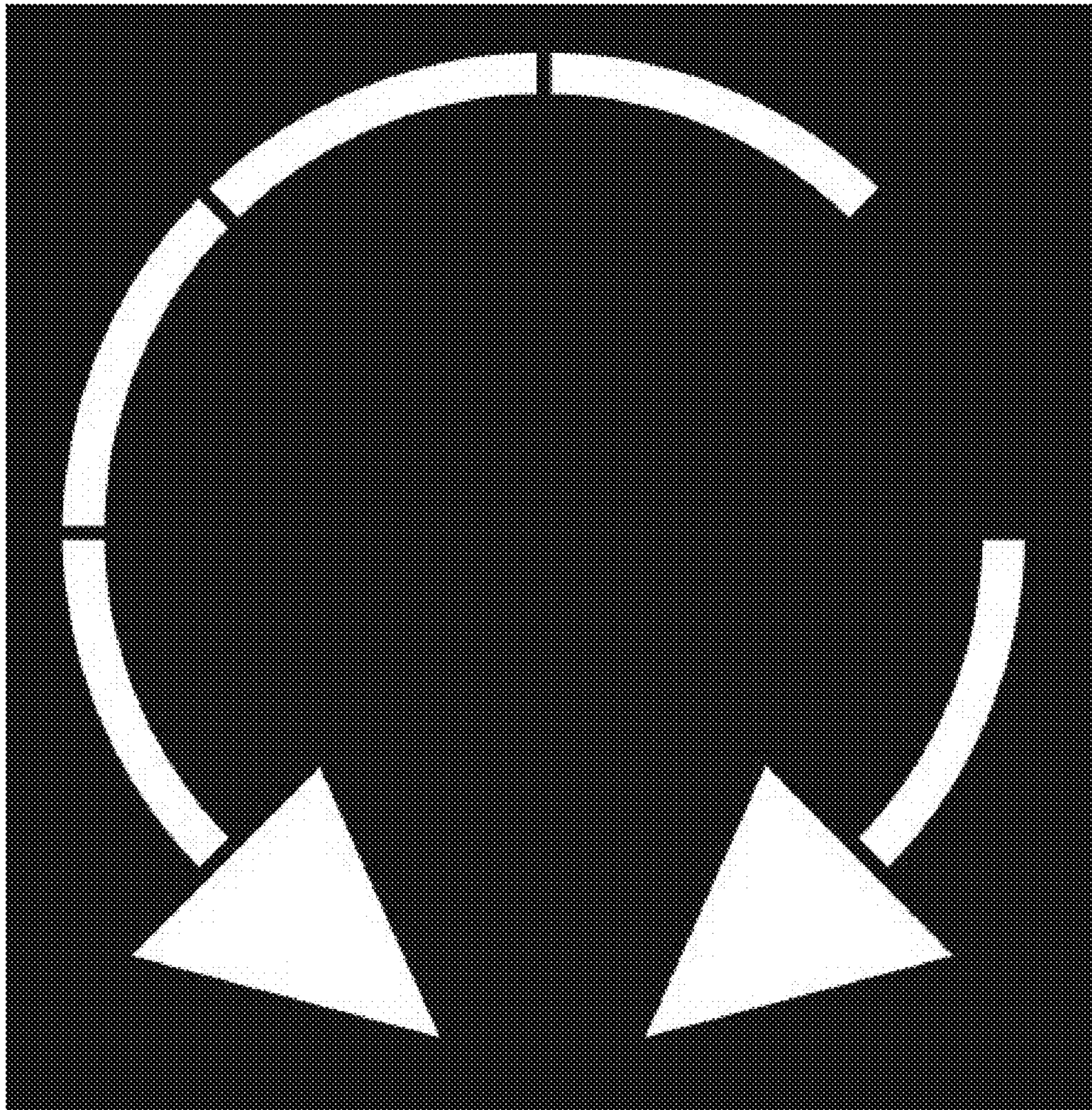

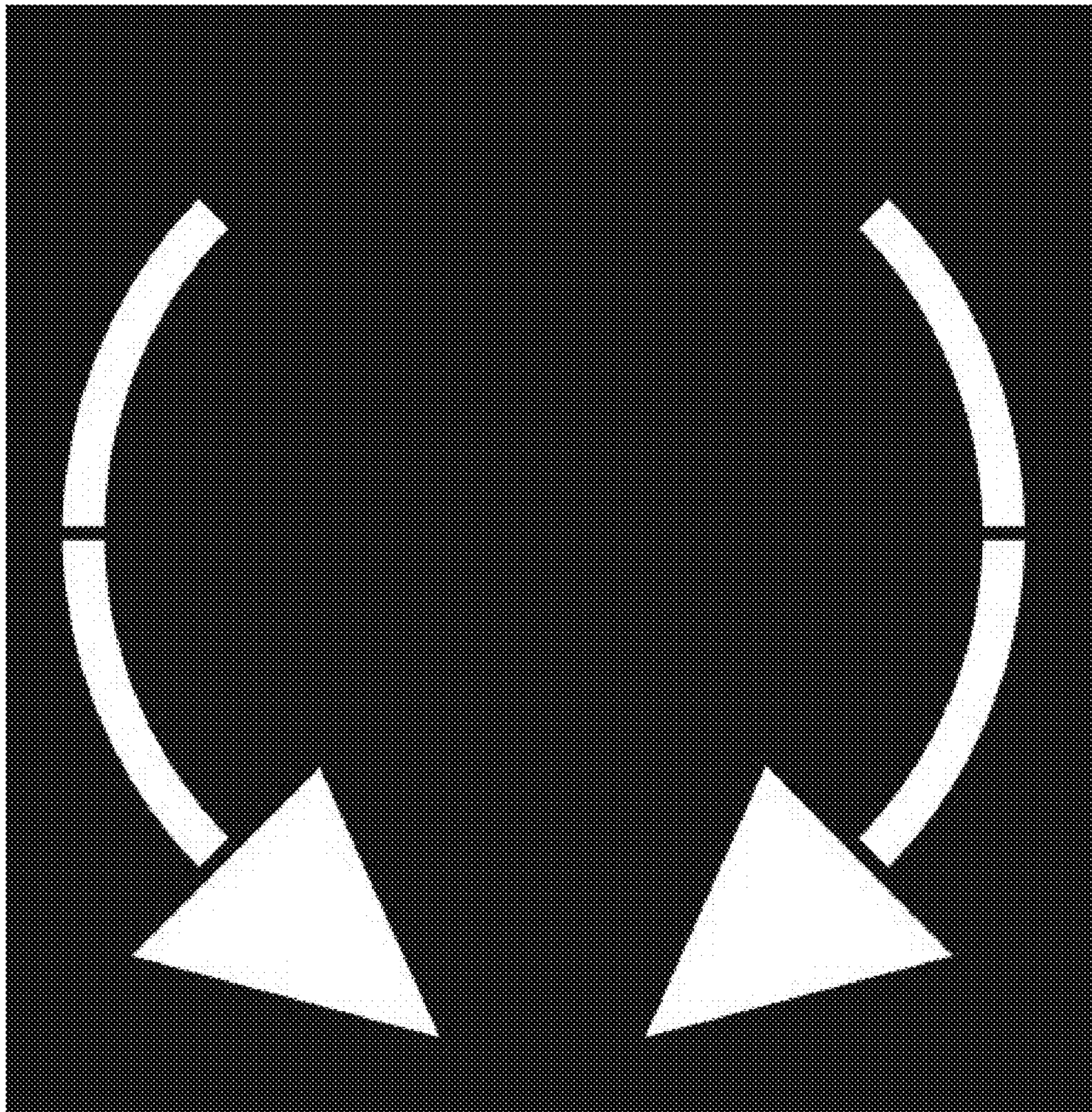
