The ornamental design for a guitar, as shown and described.

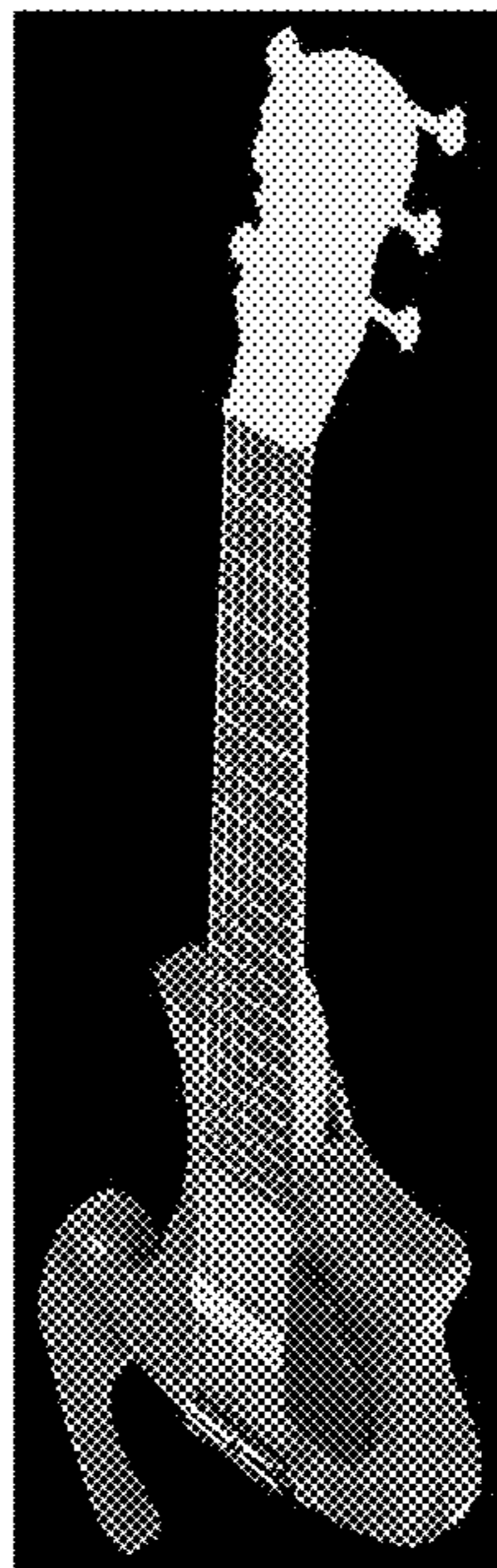

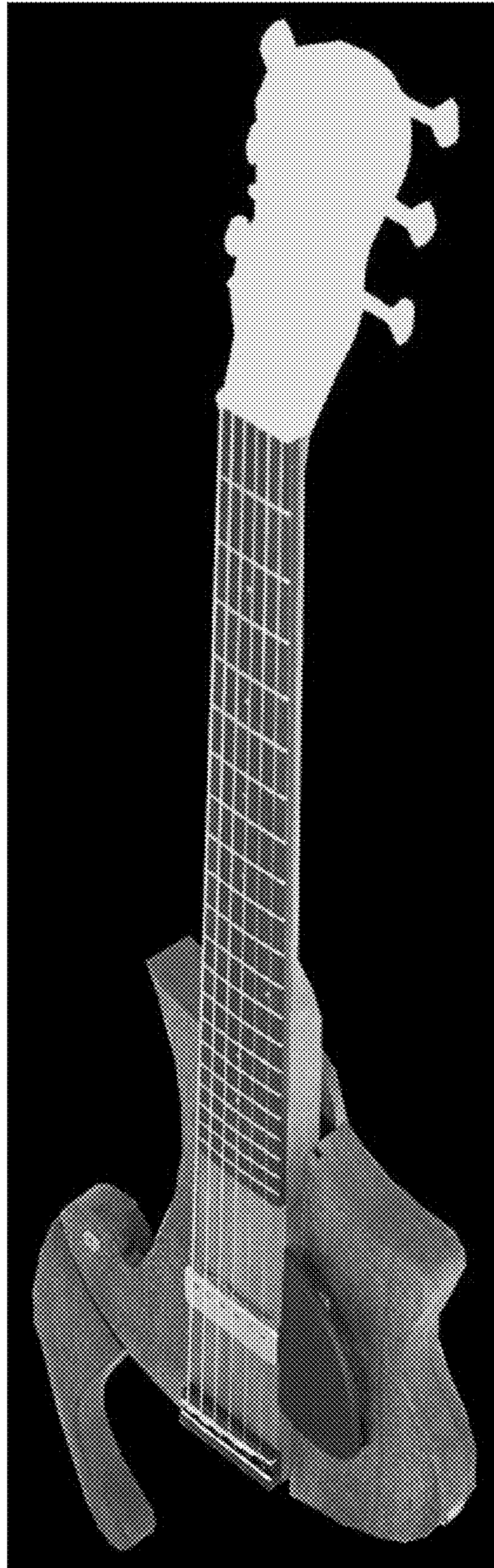

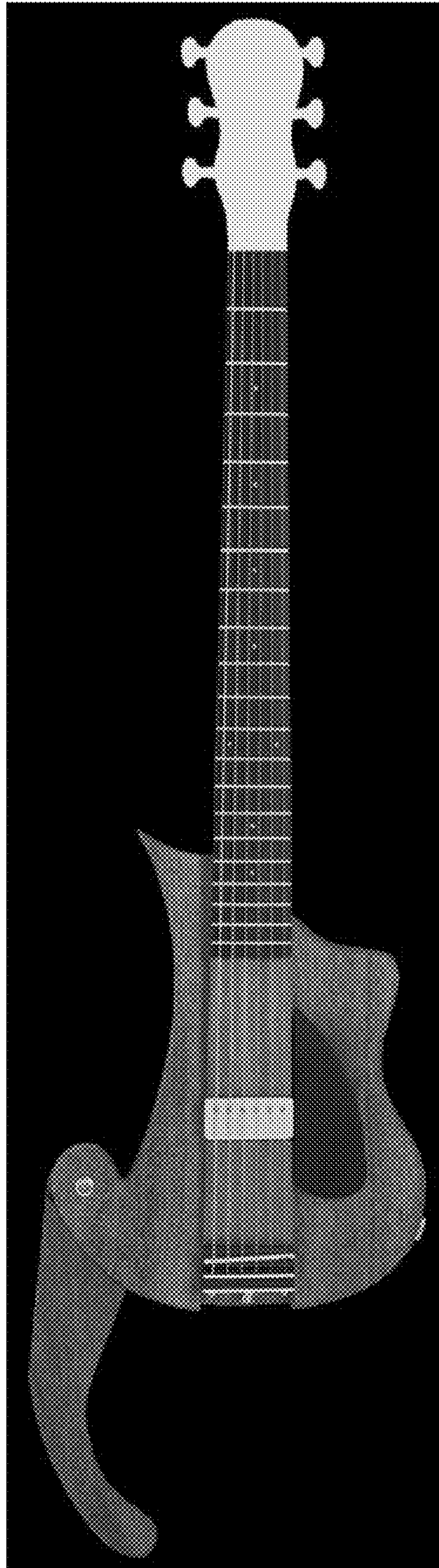

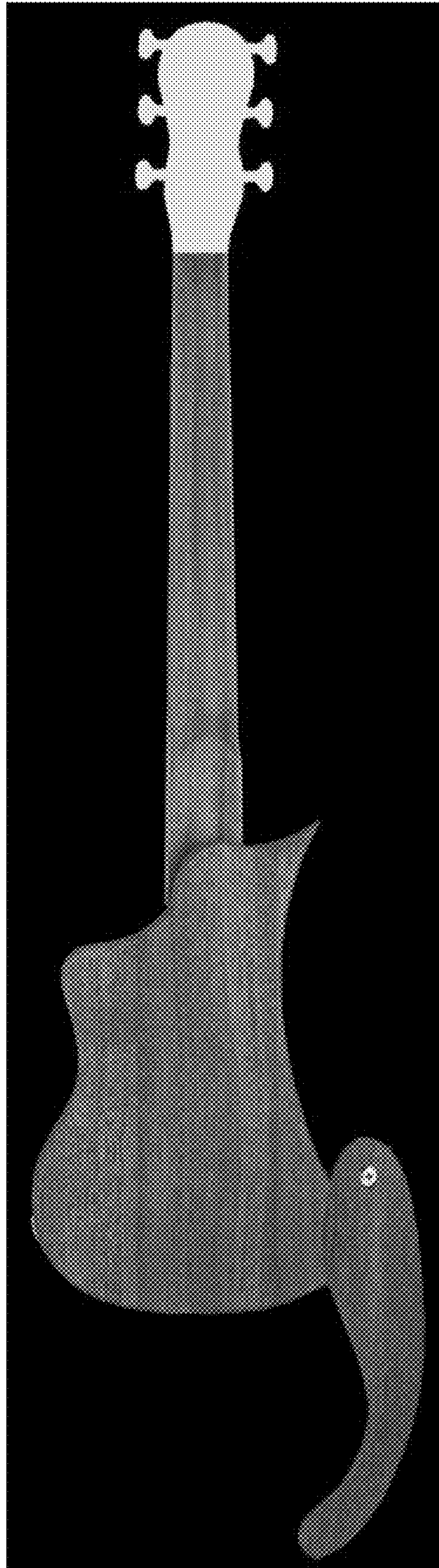

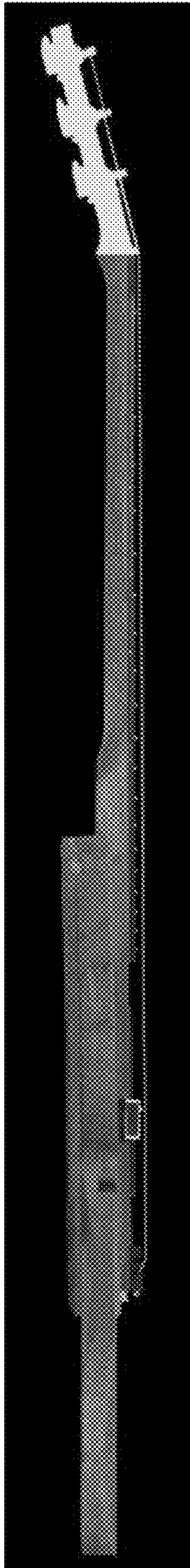

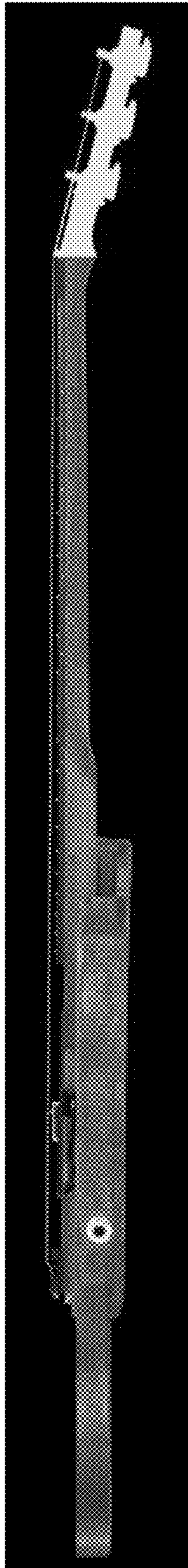

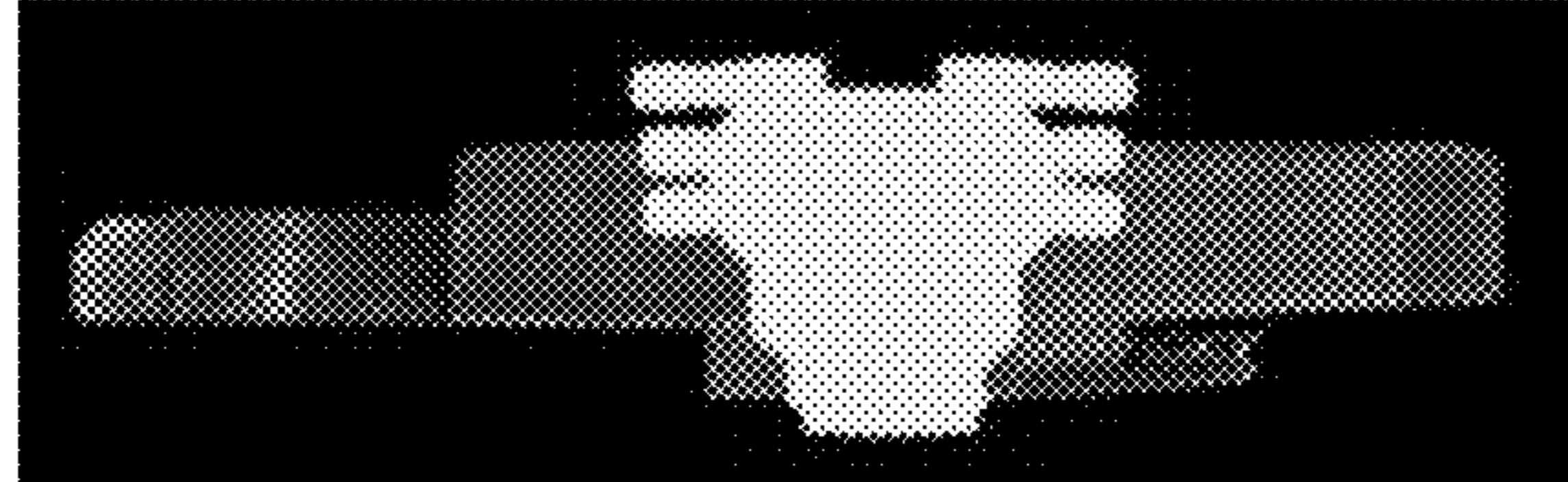

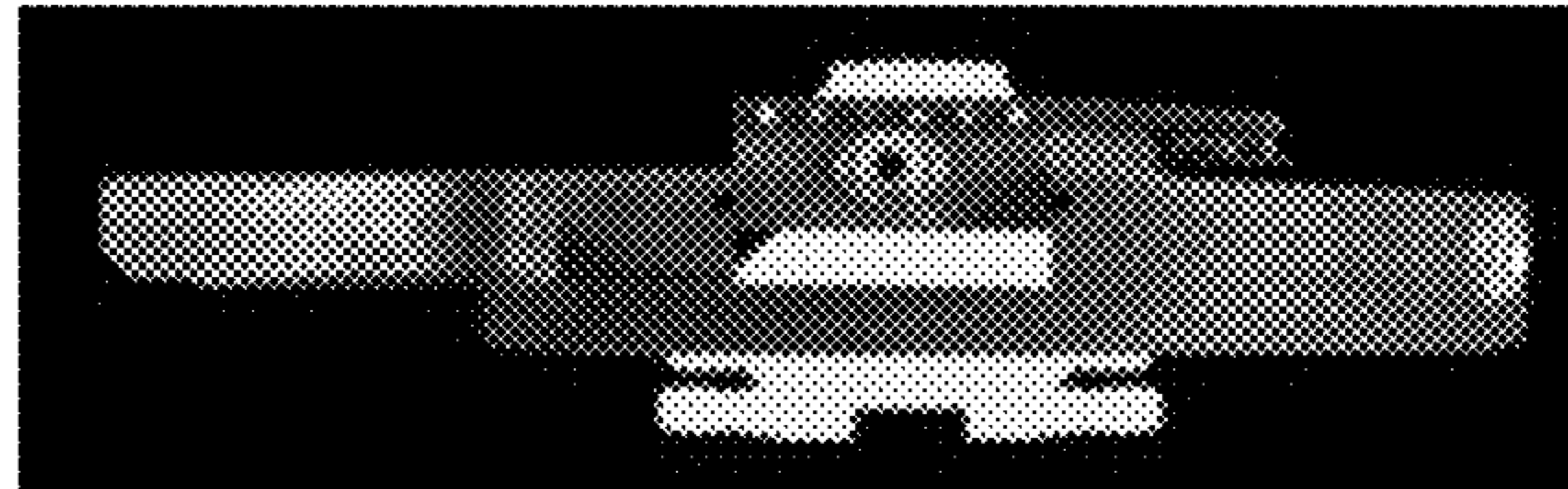
