The broken lines in the drawing depict environmental subject matter only and form no part of the claimed design.

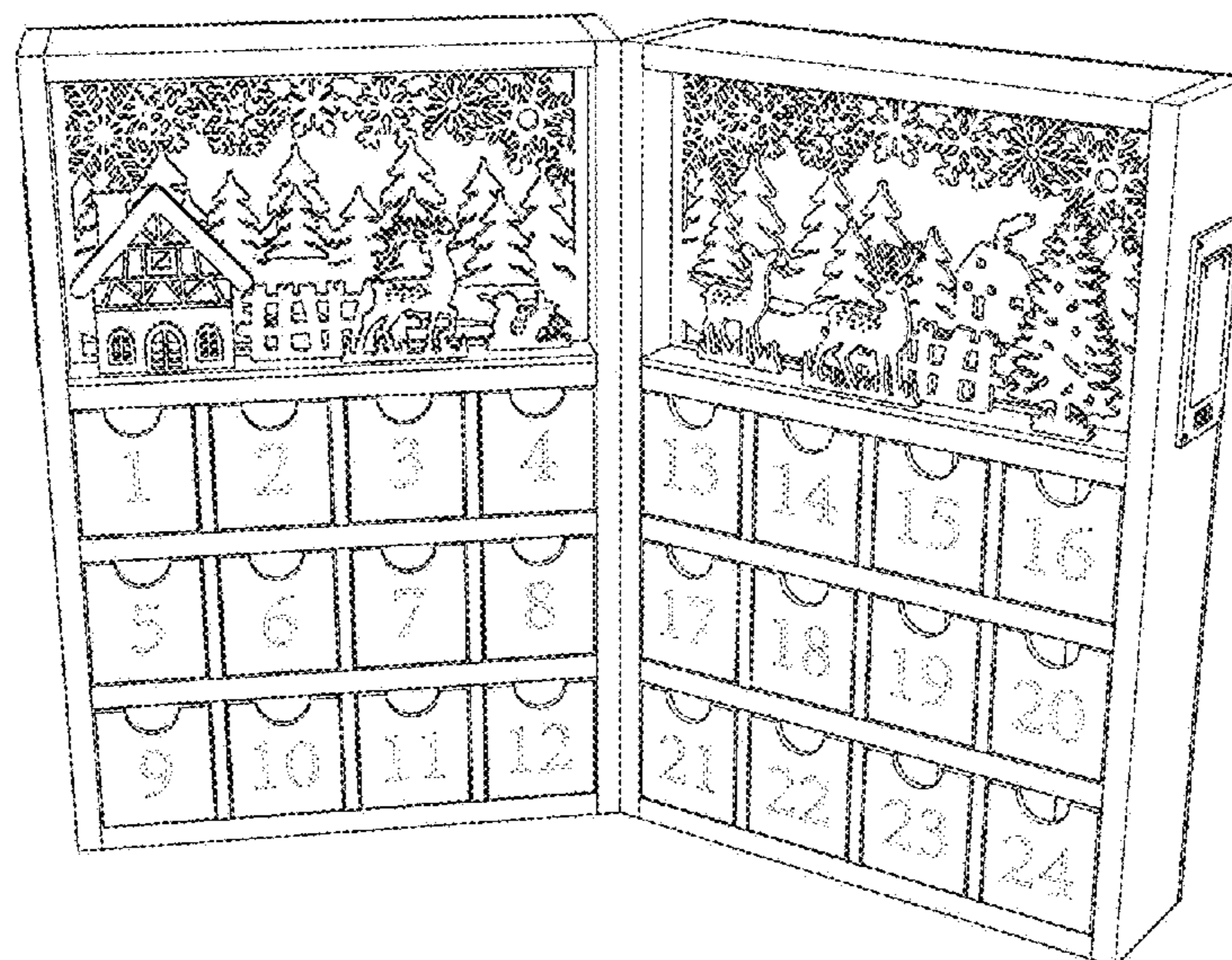

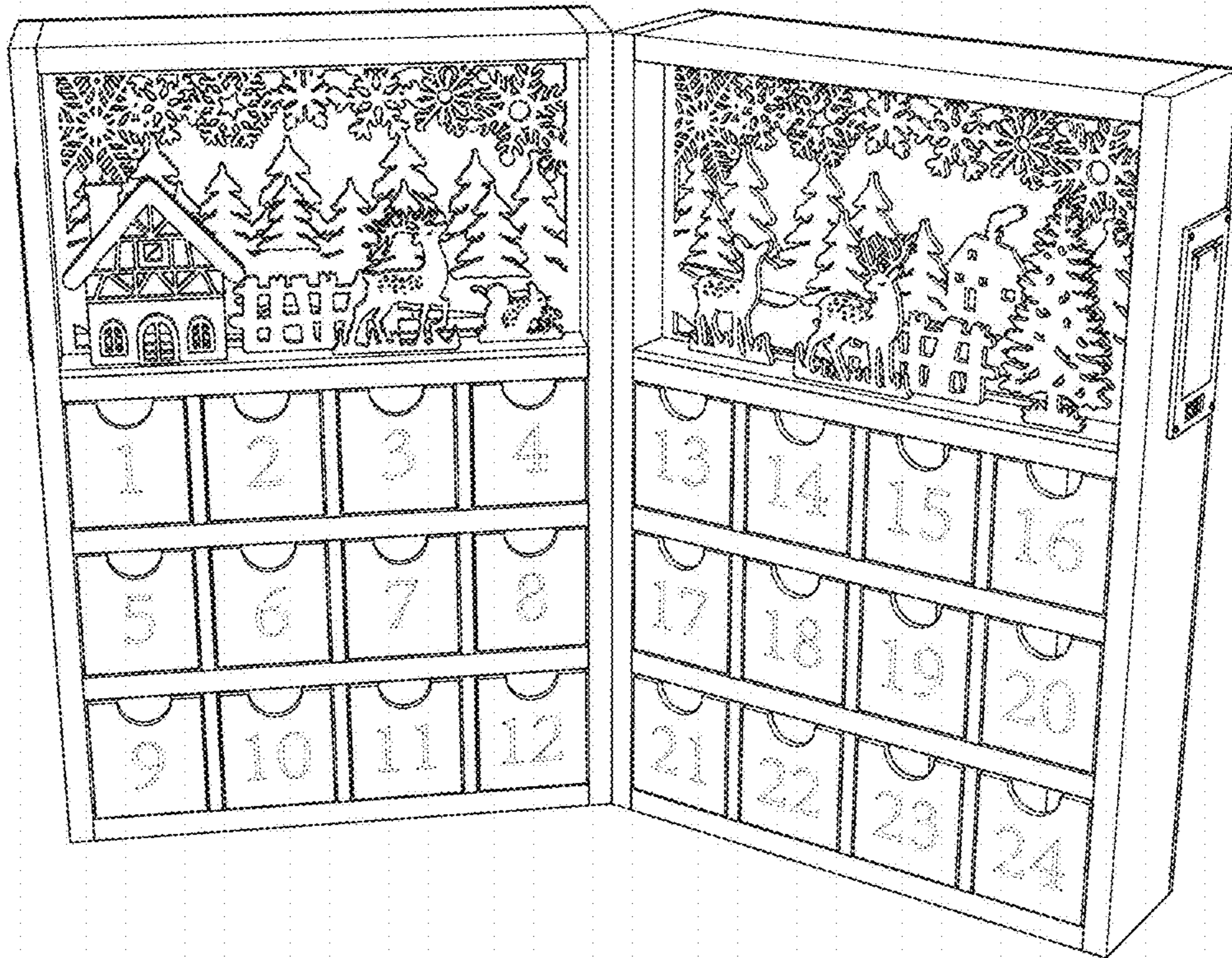

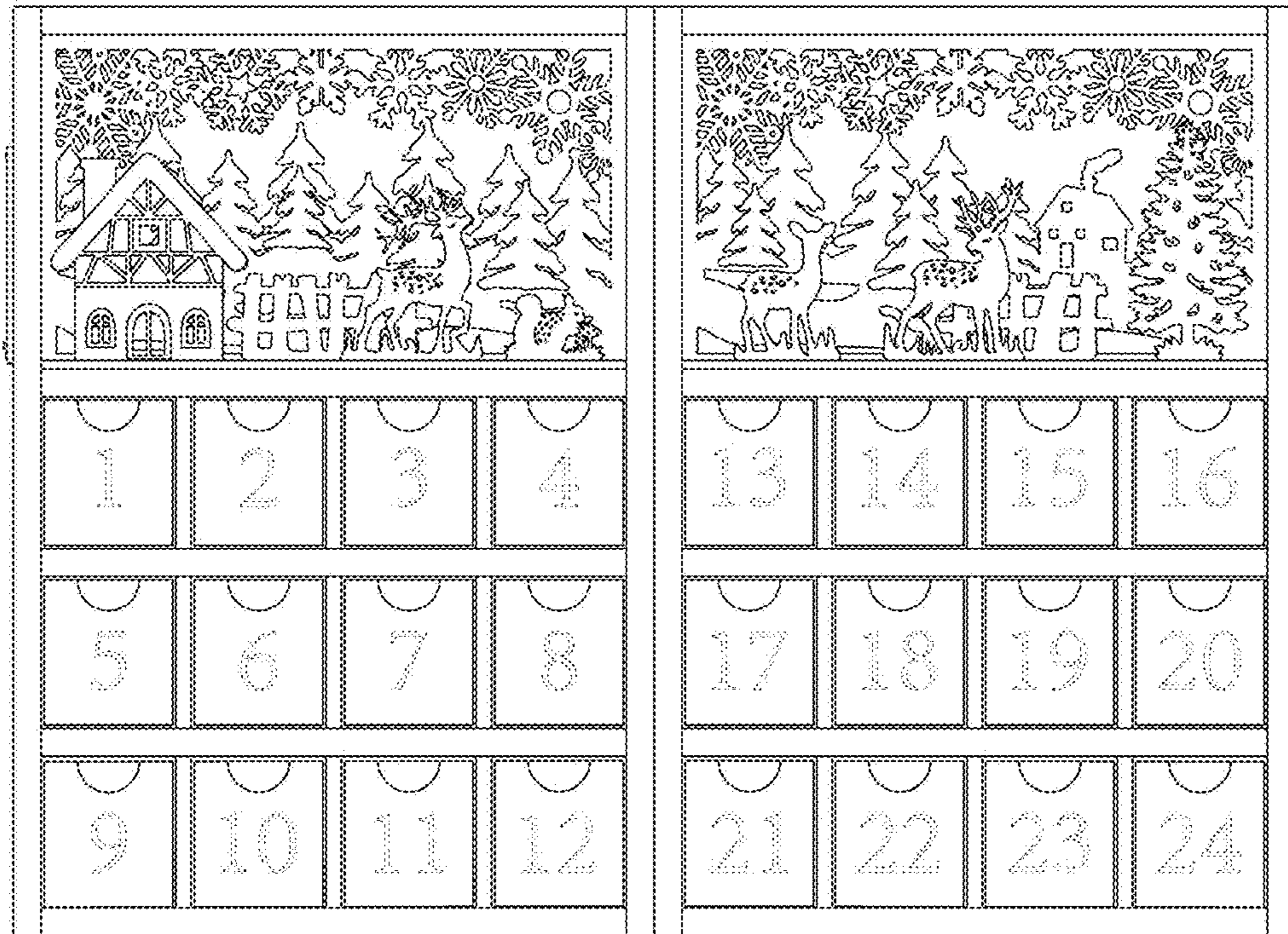

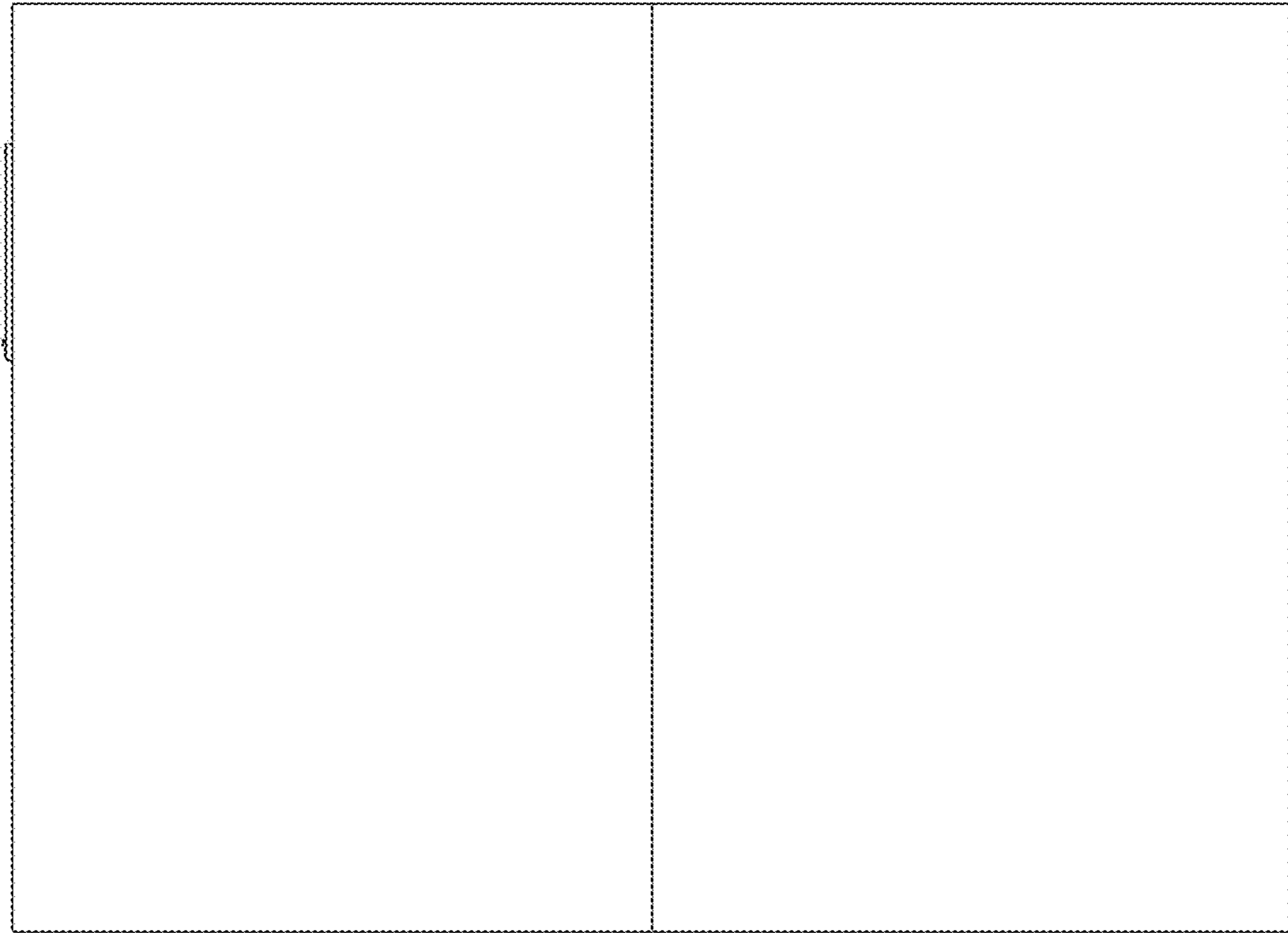

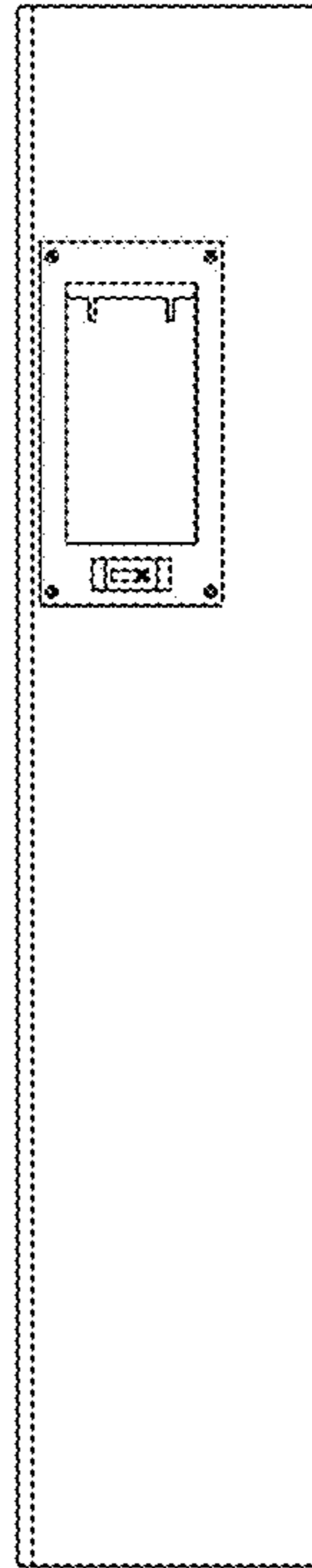

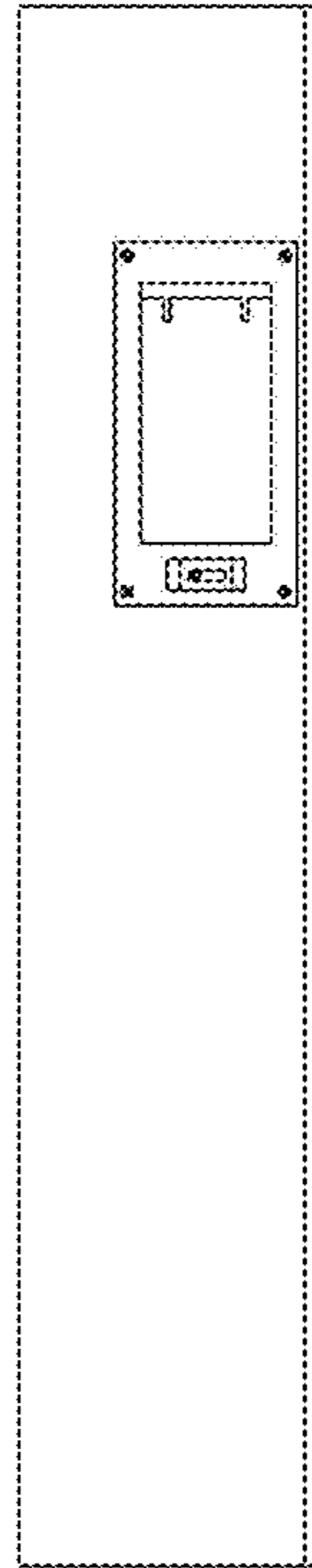

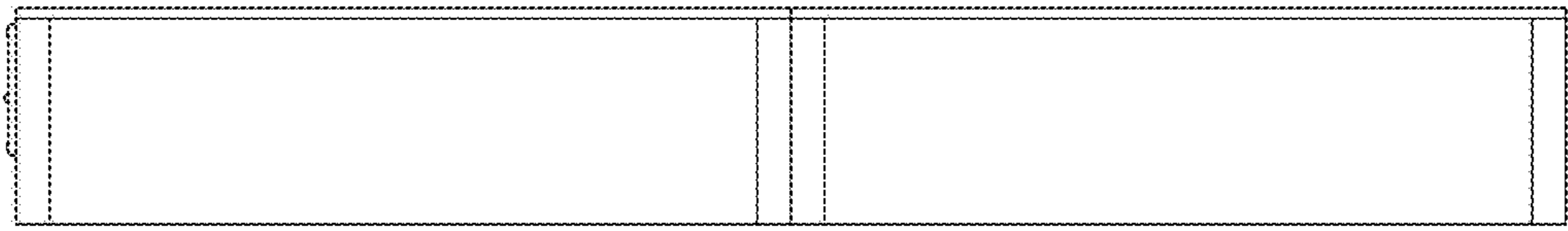

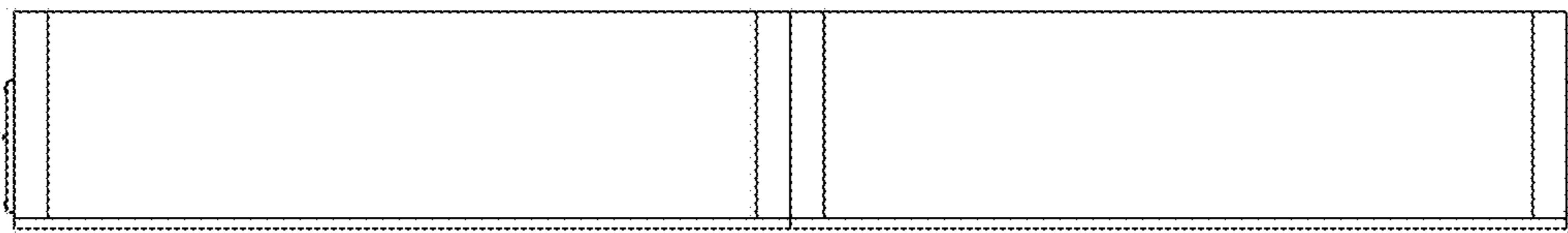

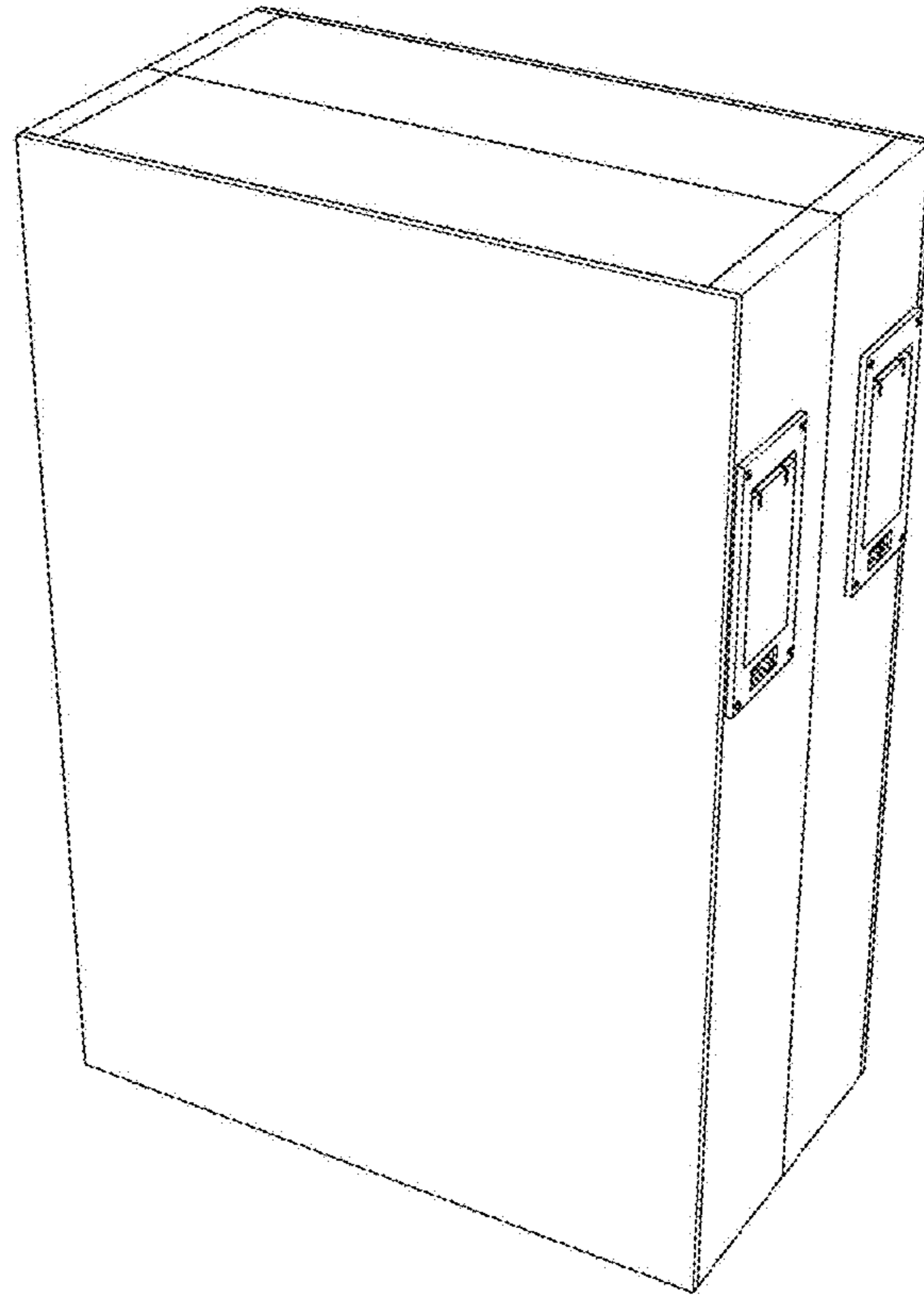

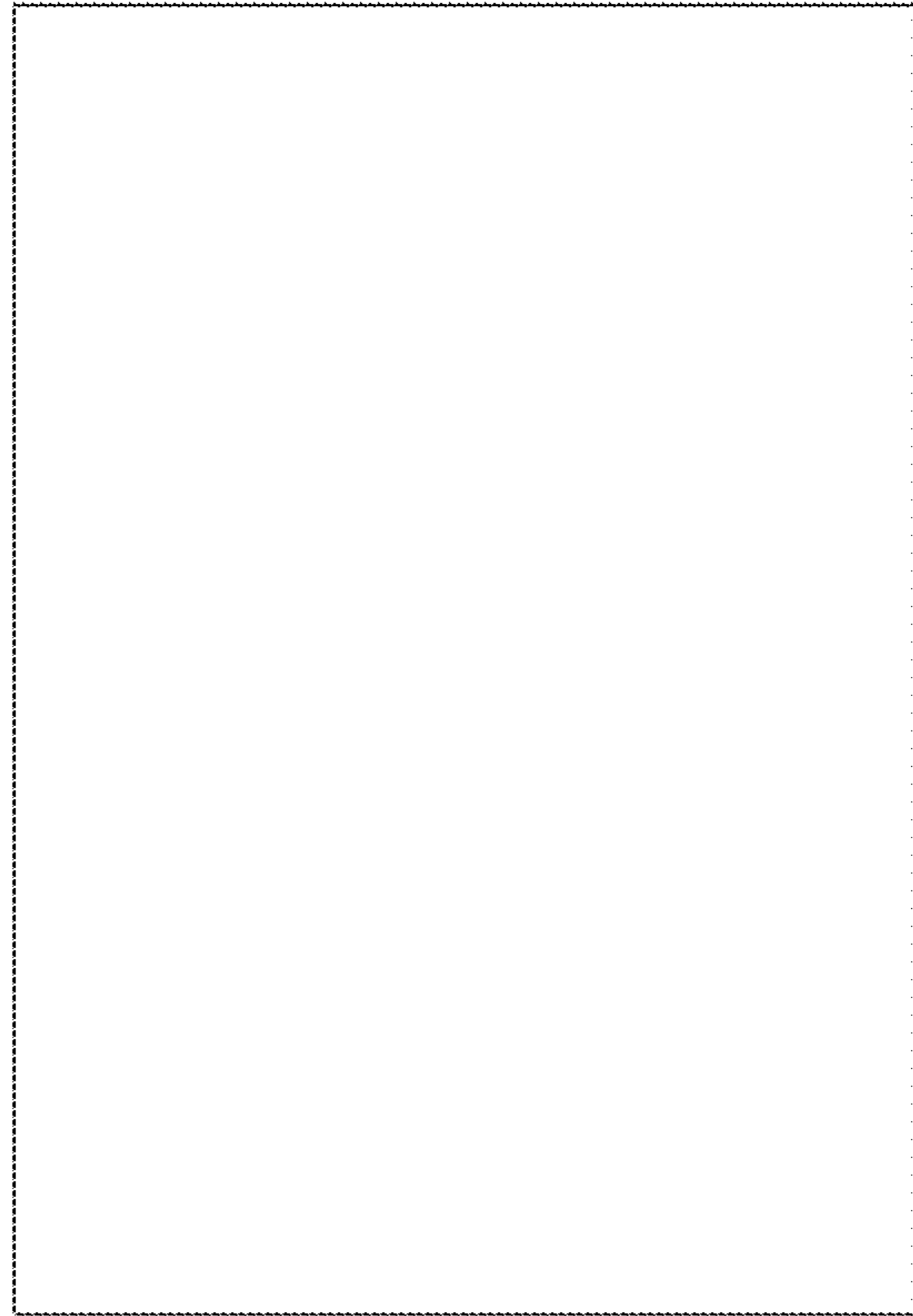

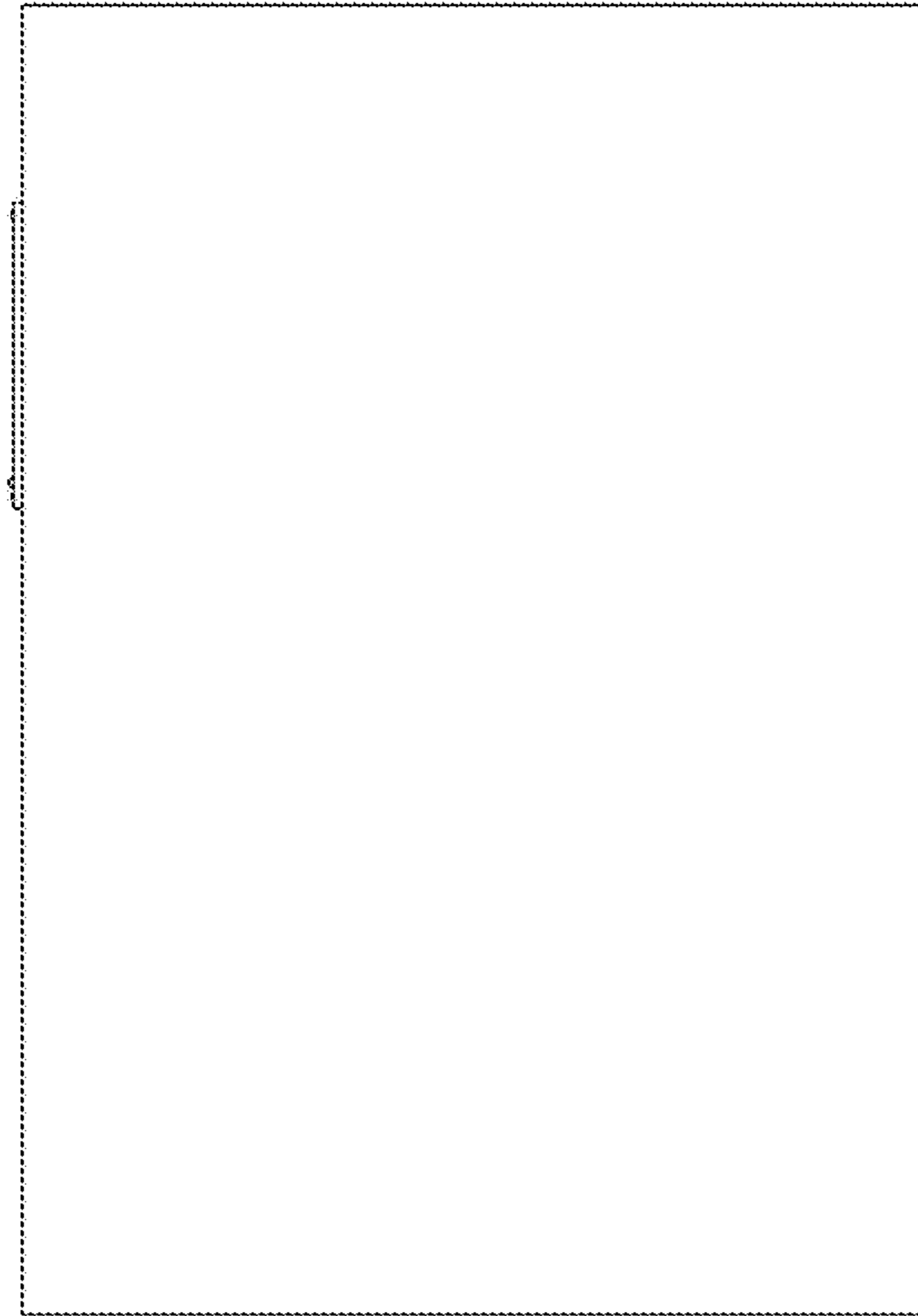

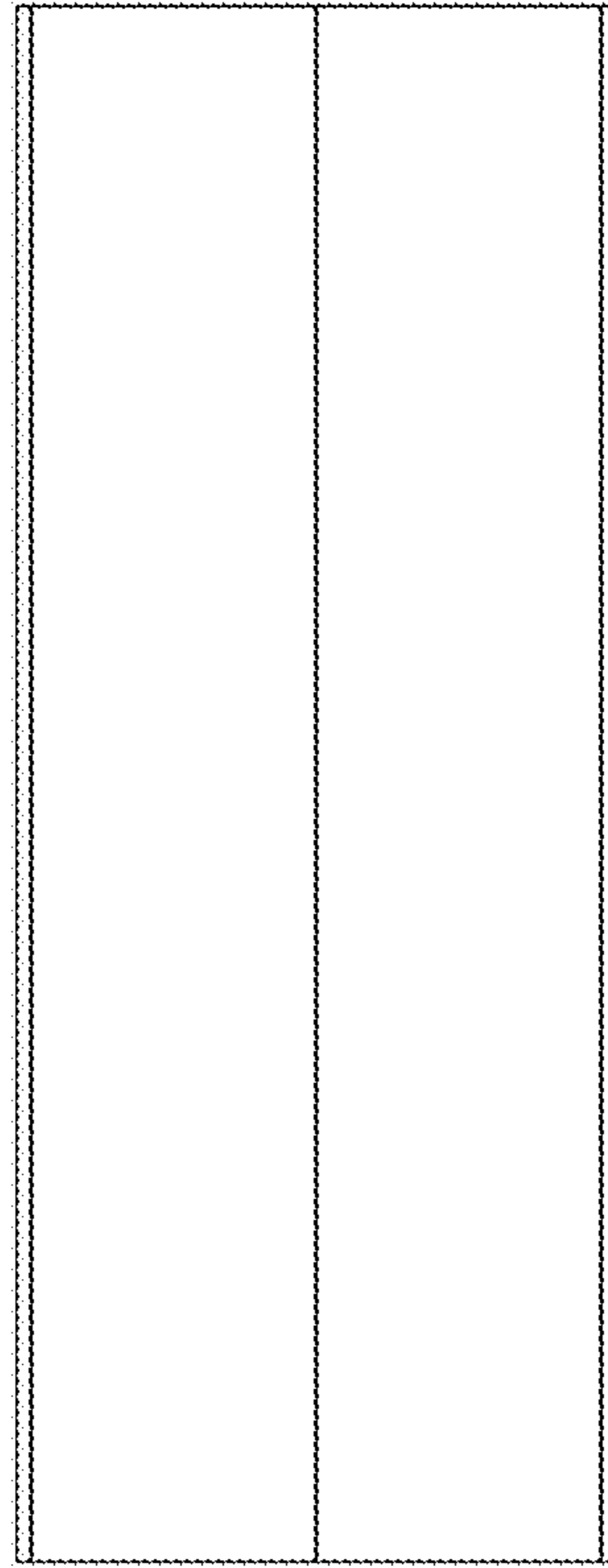

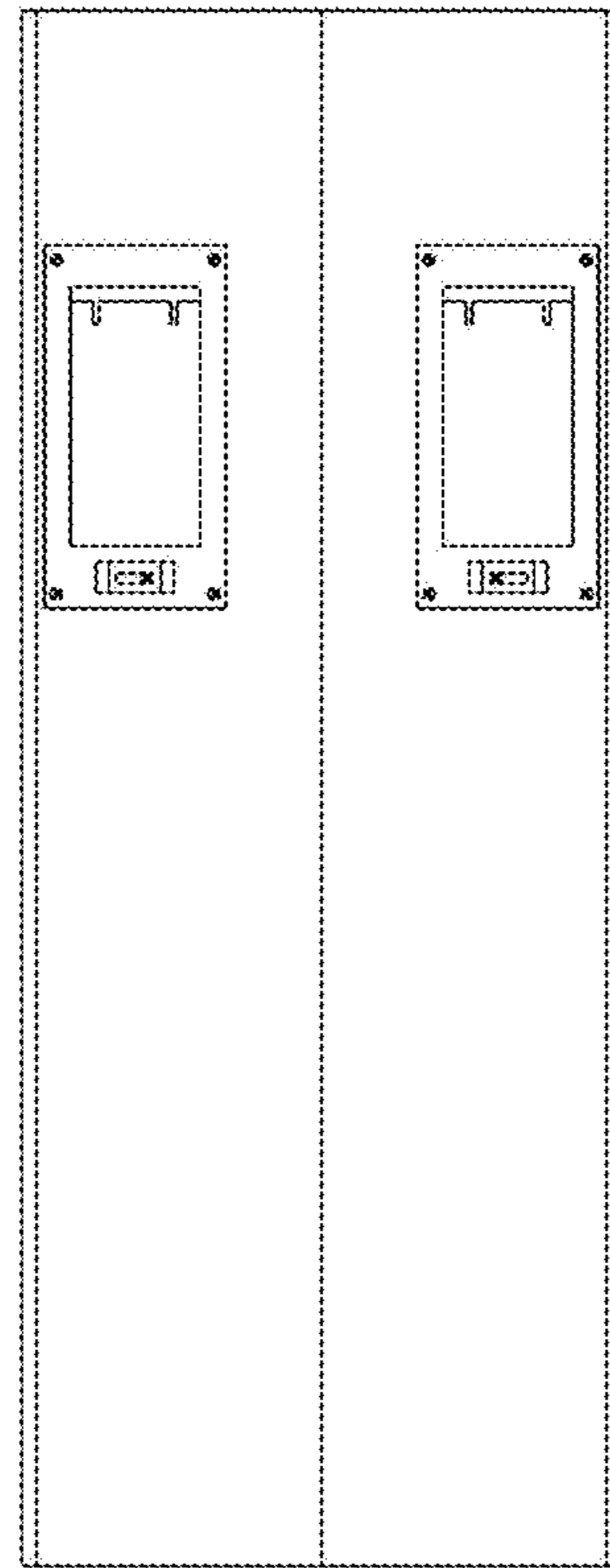

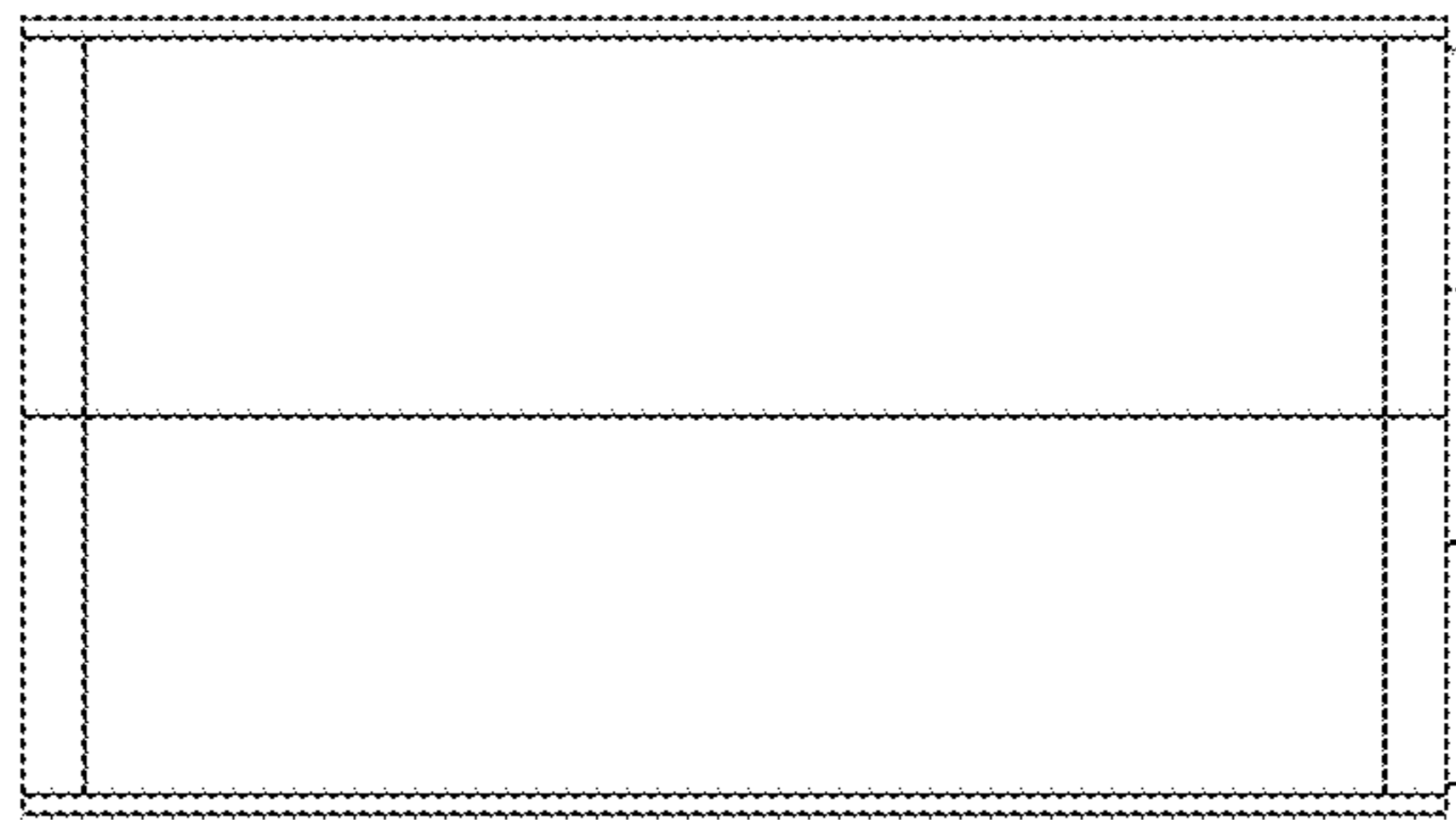
