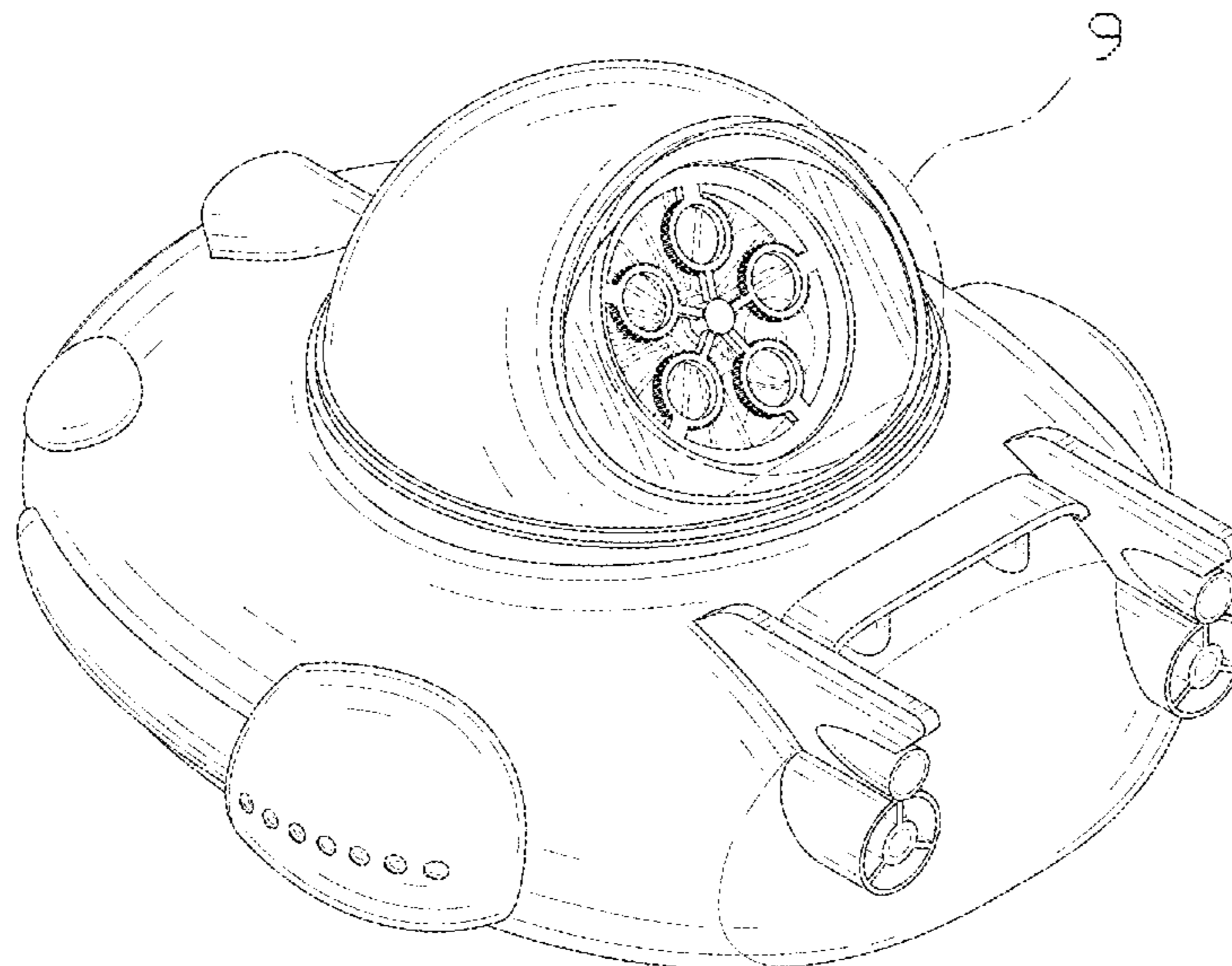

FIG. 1 is a rear and top perspective view of a bubble machine, showing my new design;
FIG. 2 is a front and bottom perspective view thereof;

FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof; and,
FIG. 9 is an enlarged view of a portion indicated “9” in FIG. 1.

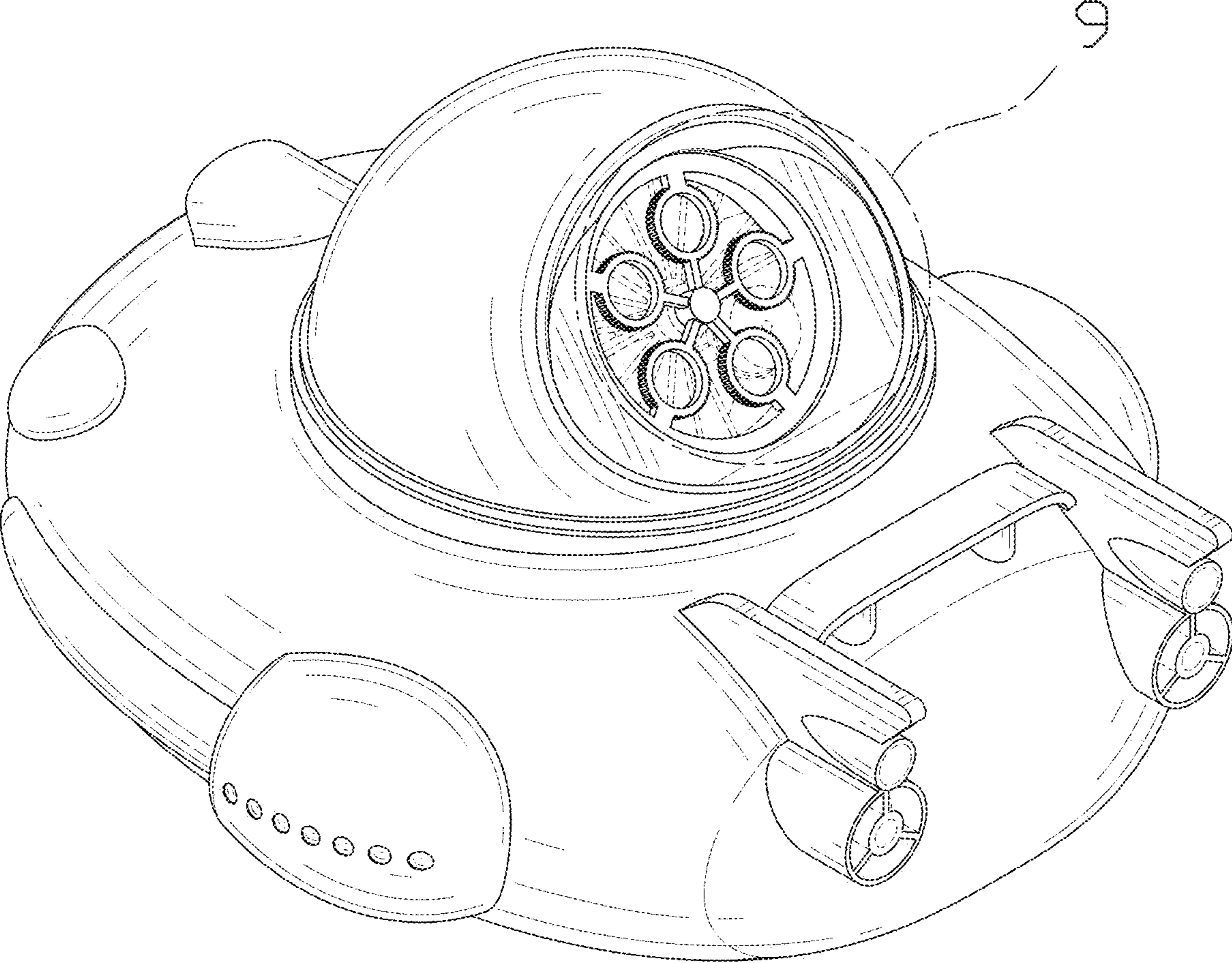

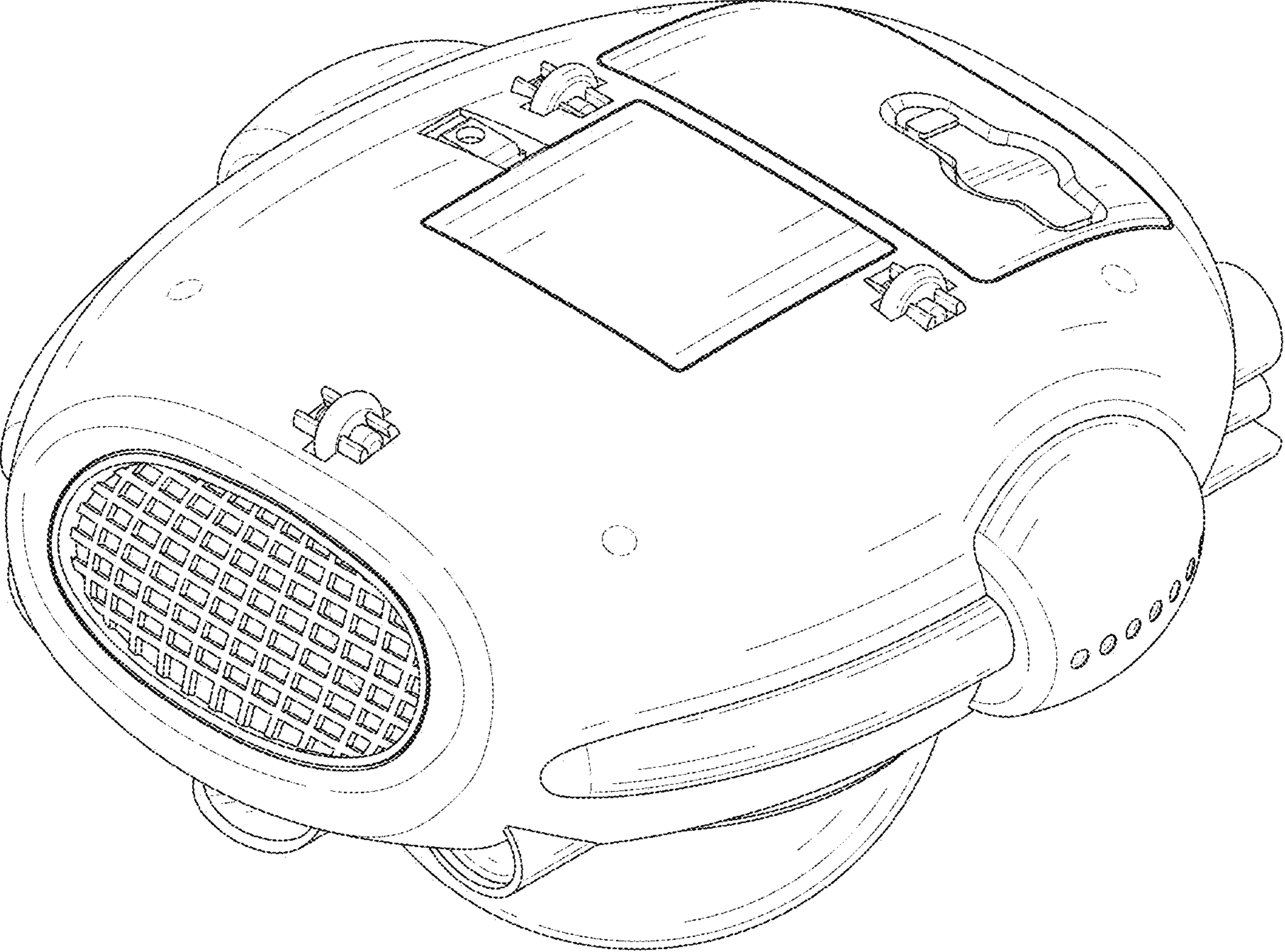

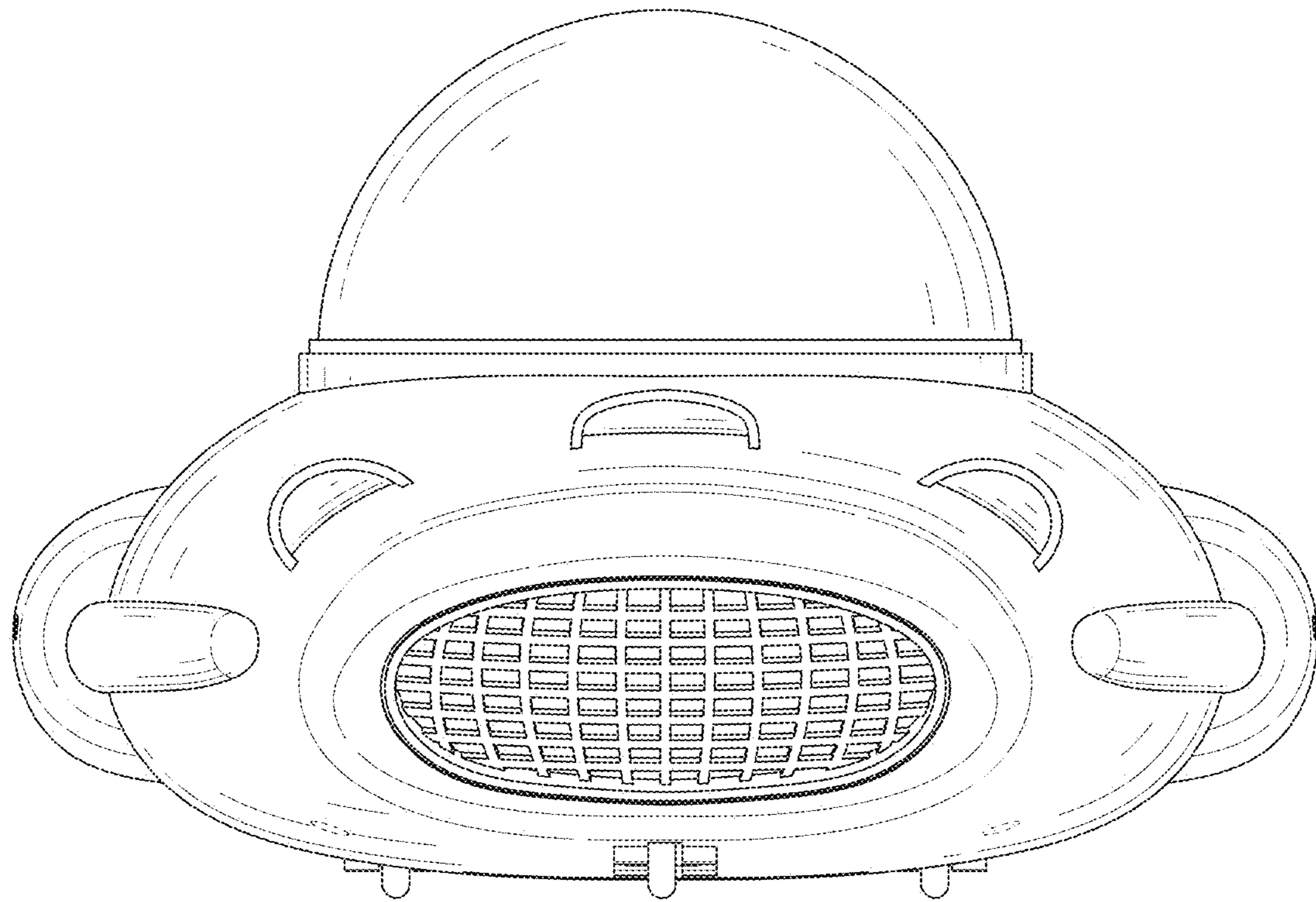

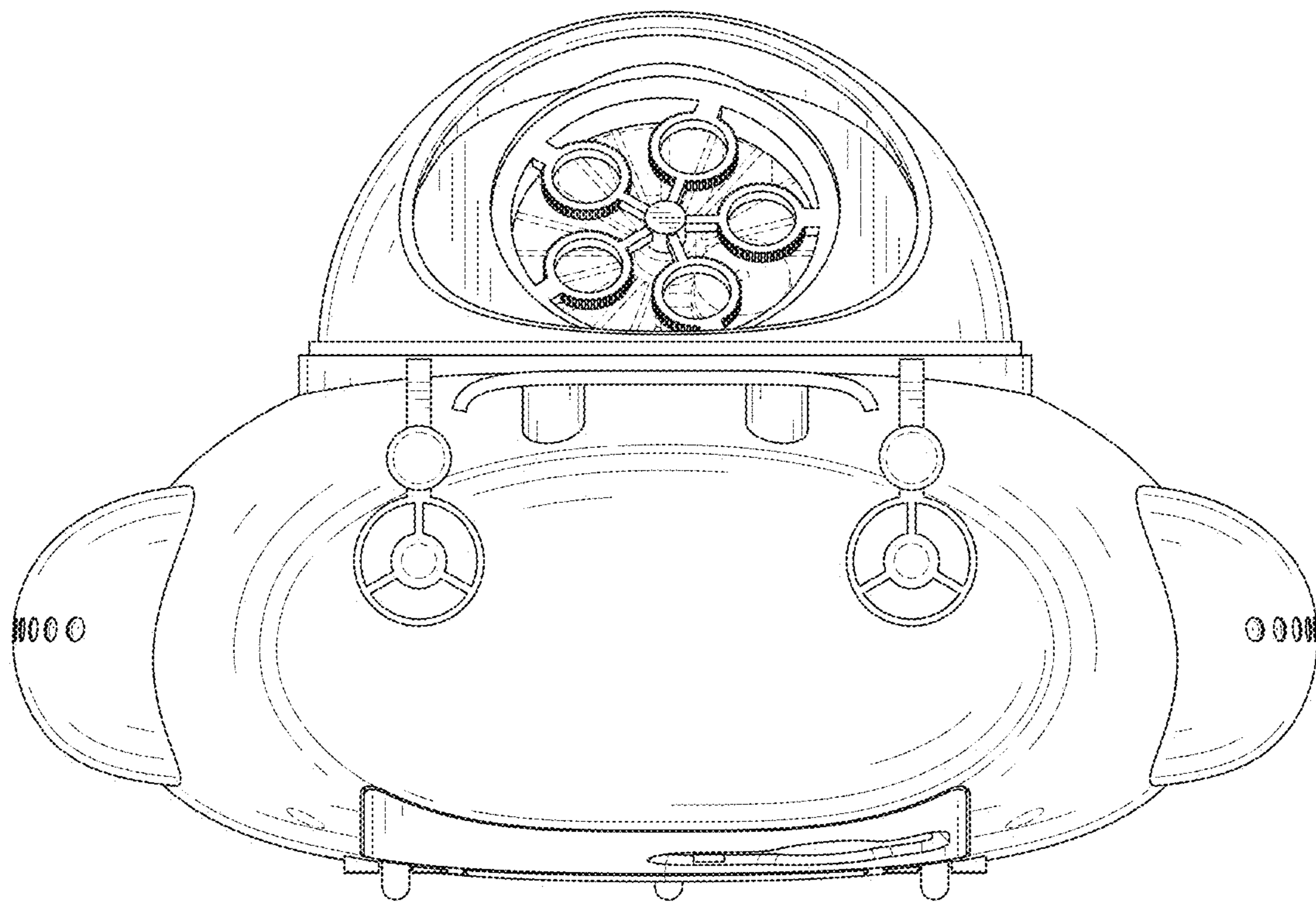

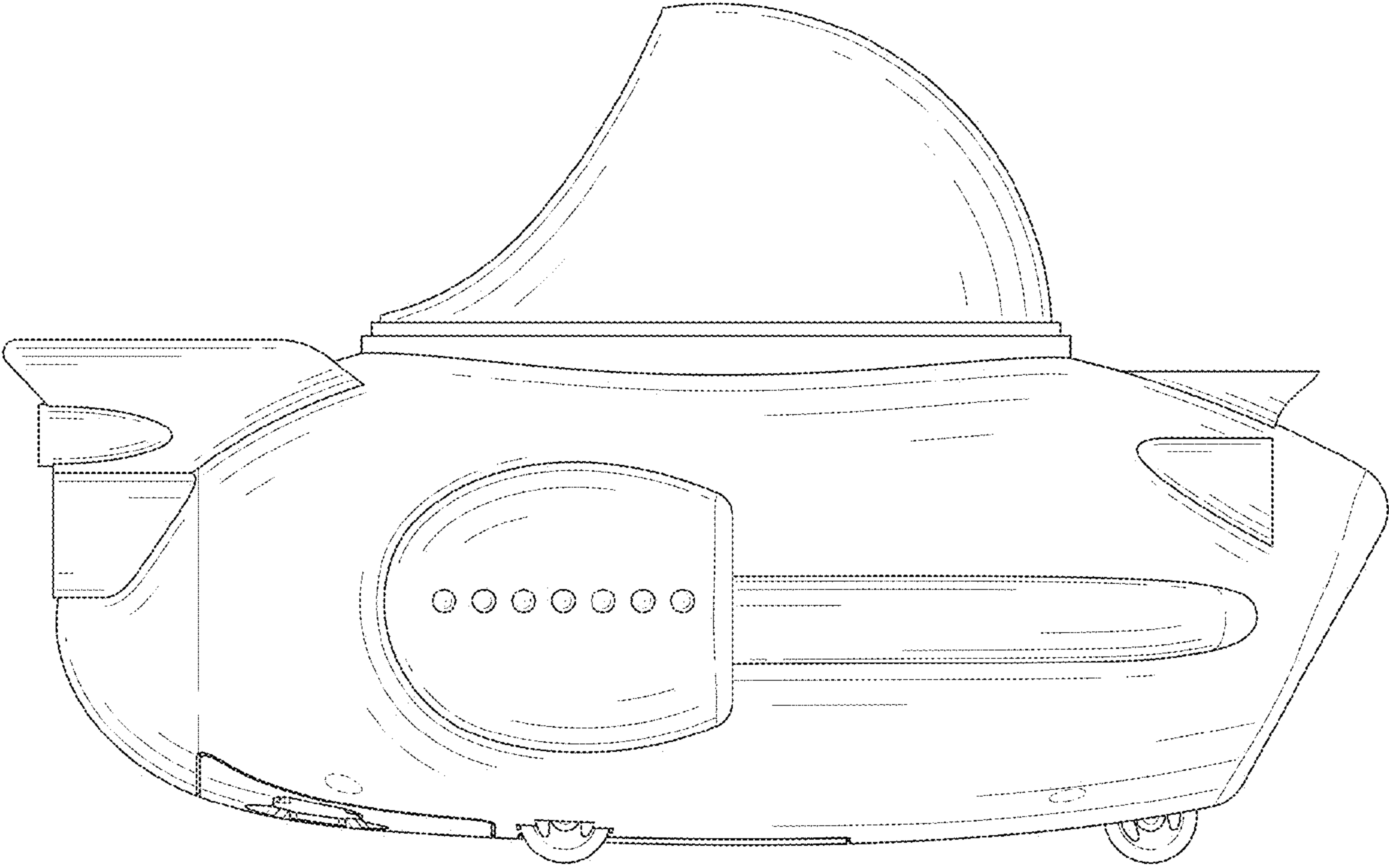

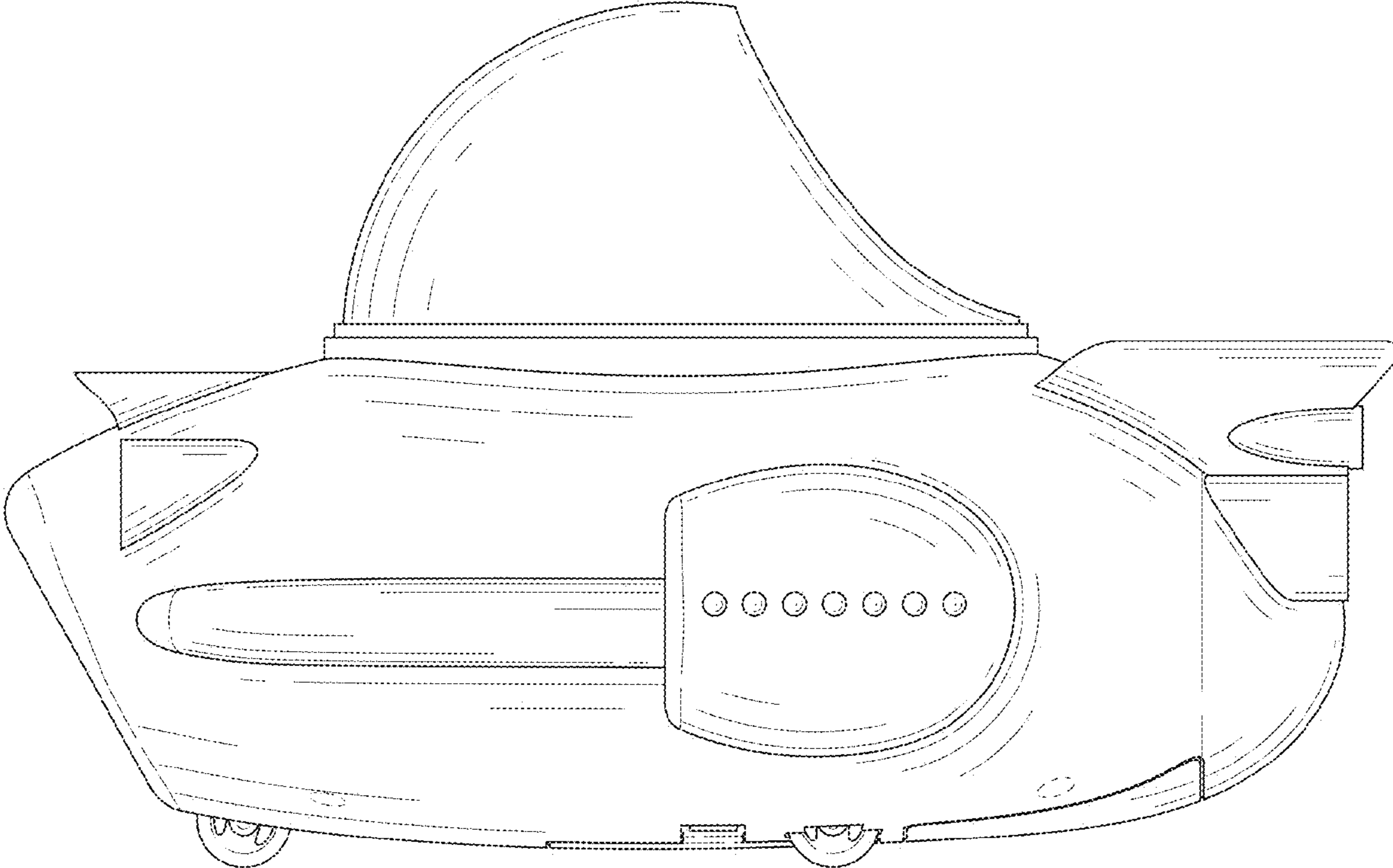

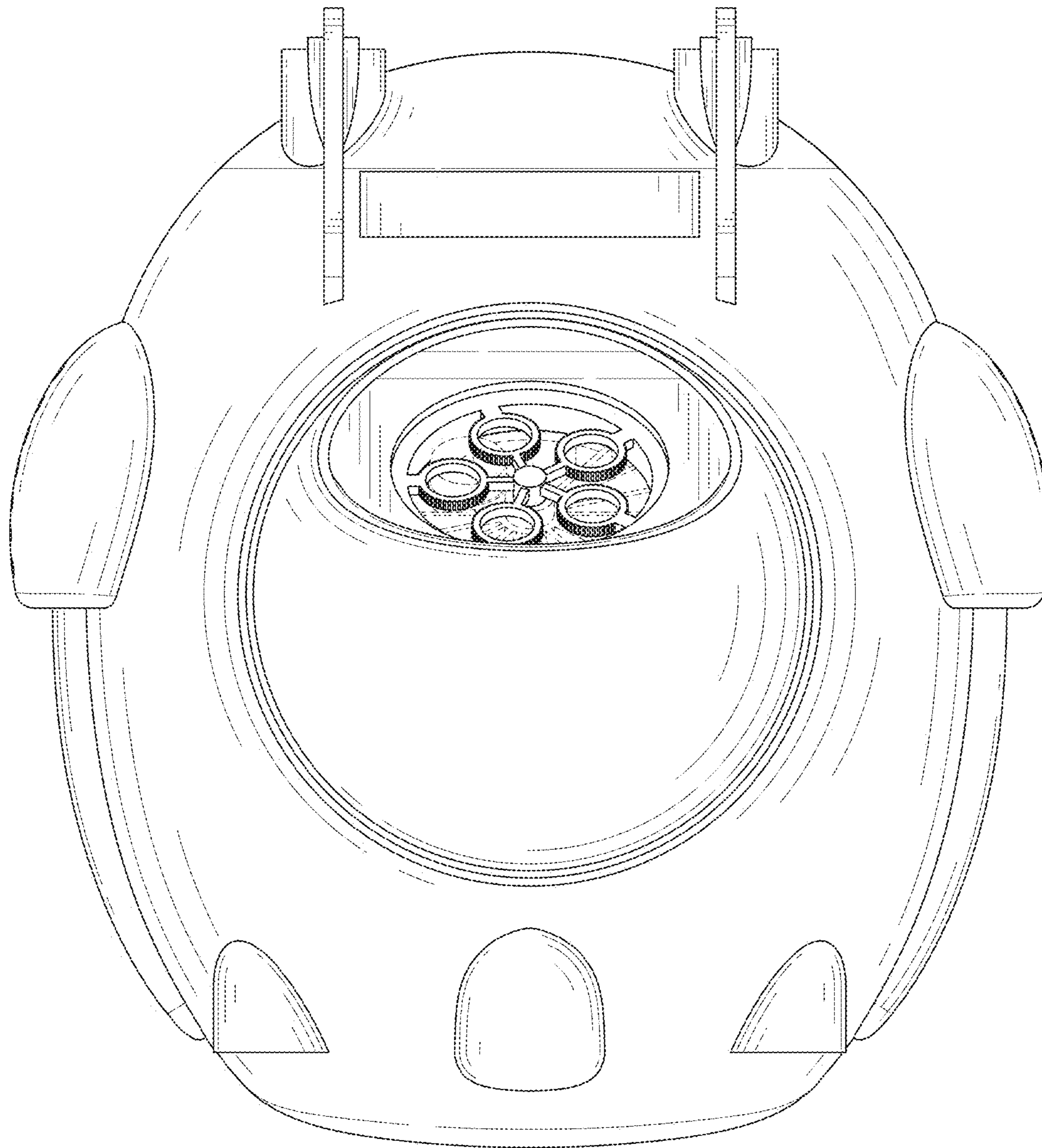

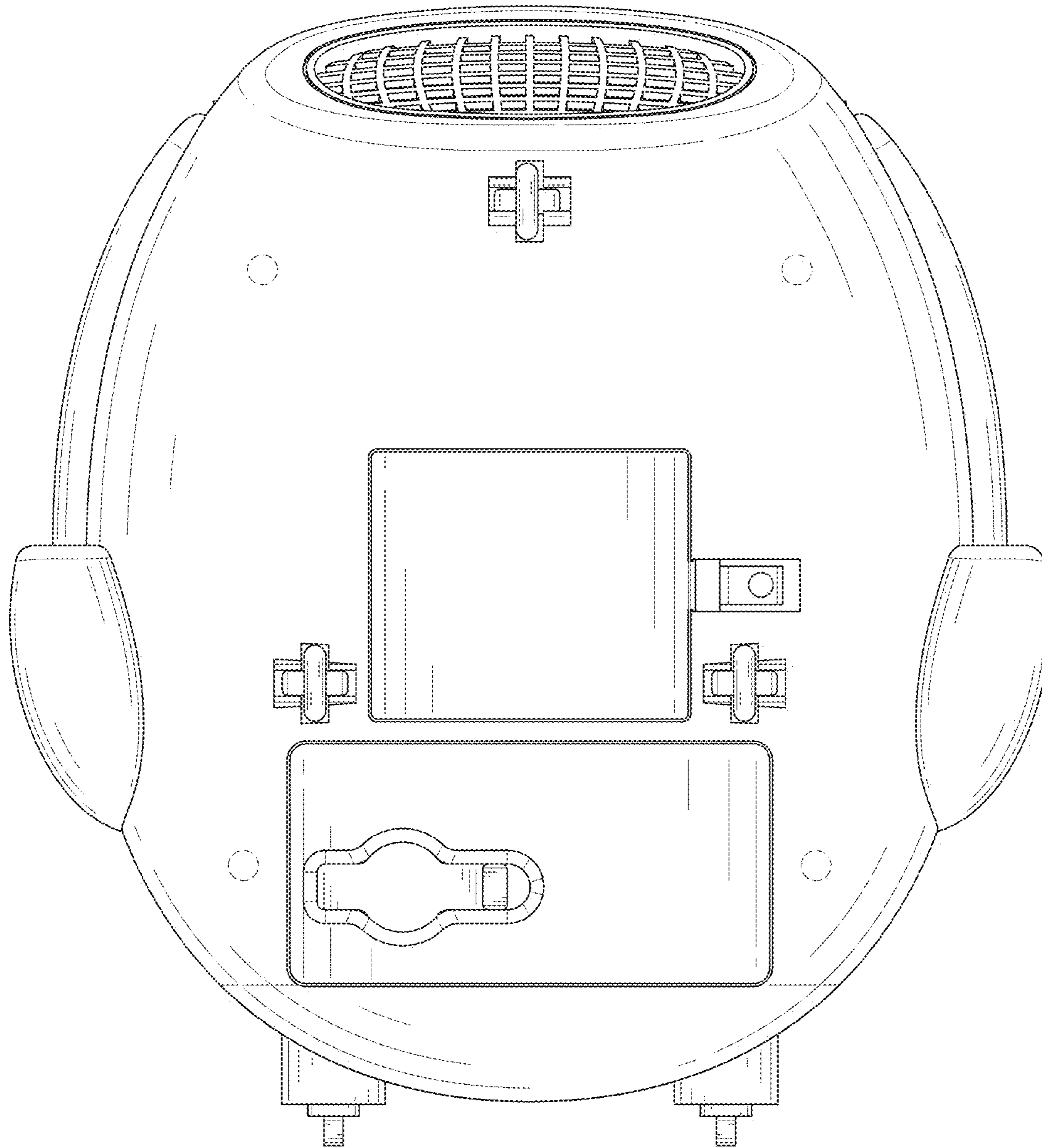

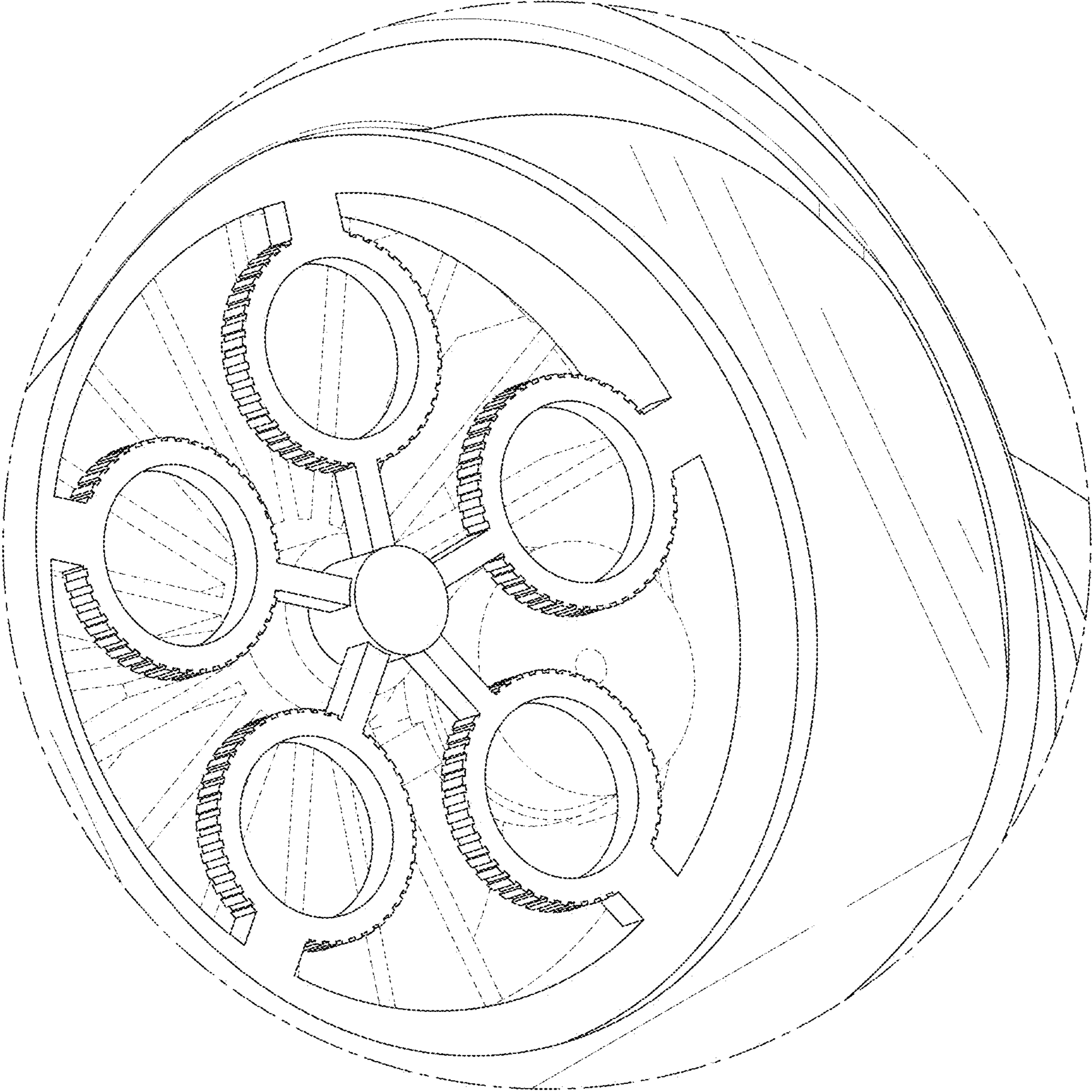
