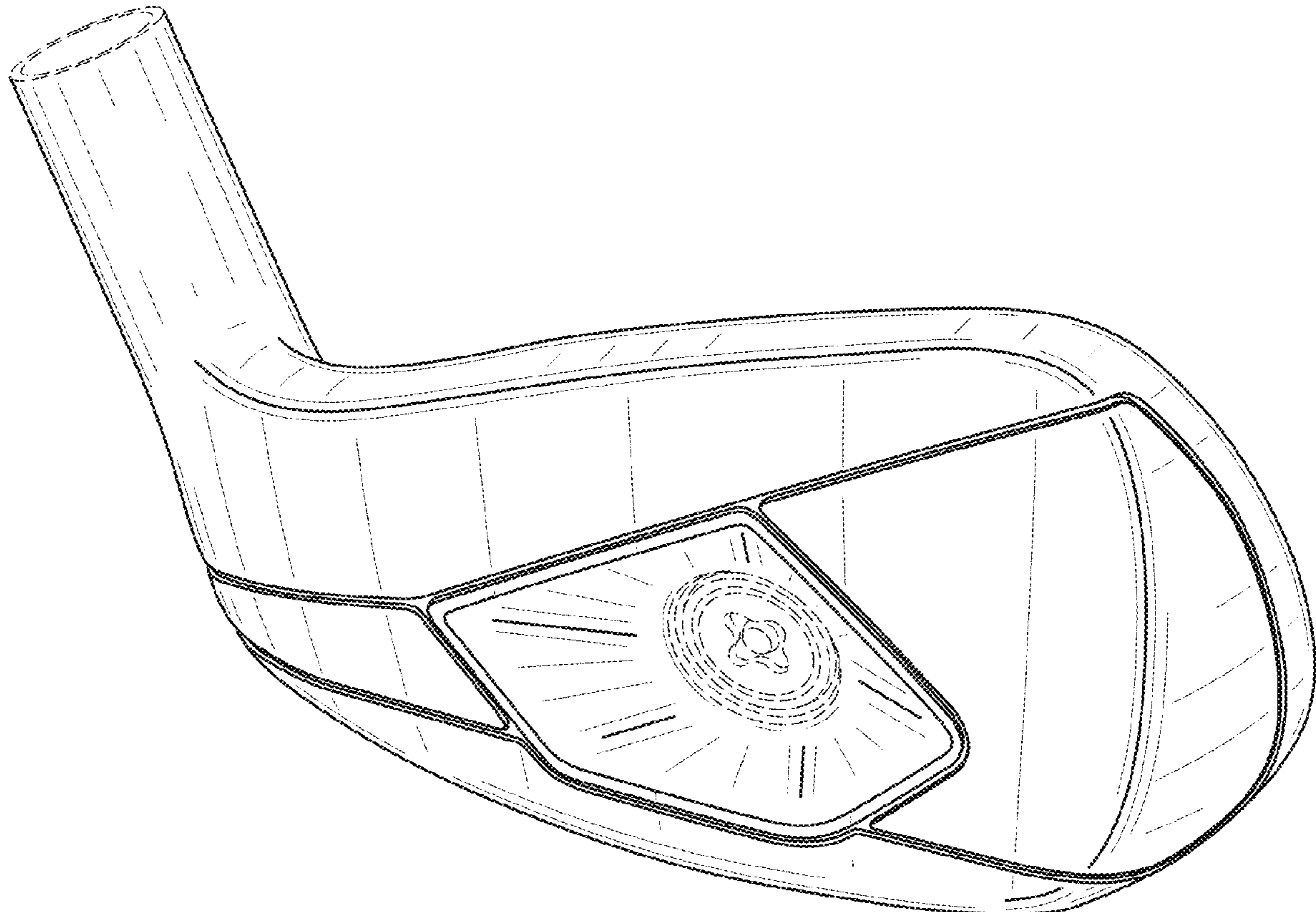
The ornamental design for iron golf club head, as shown and described.

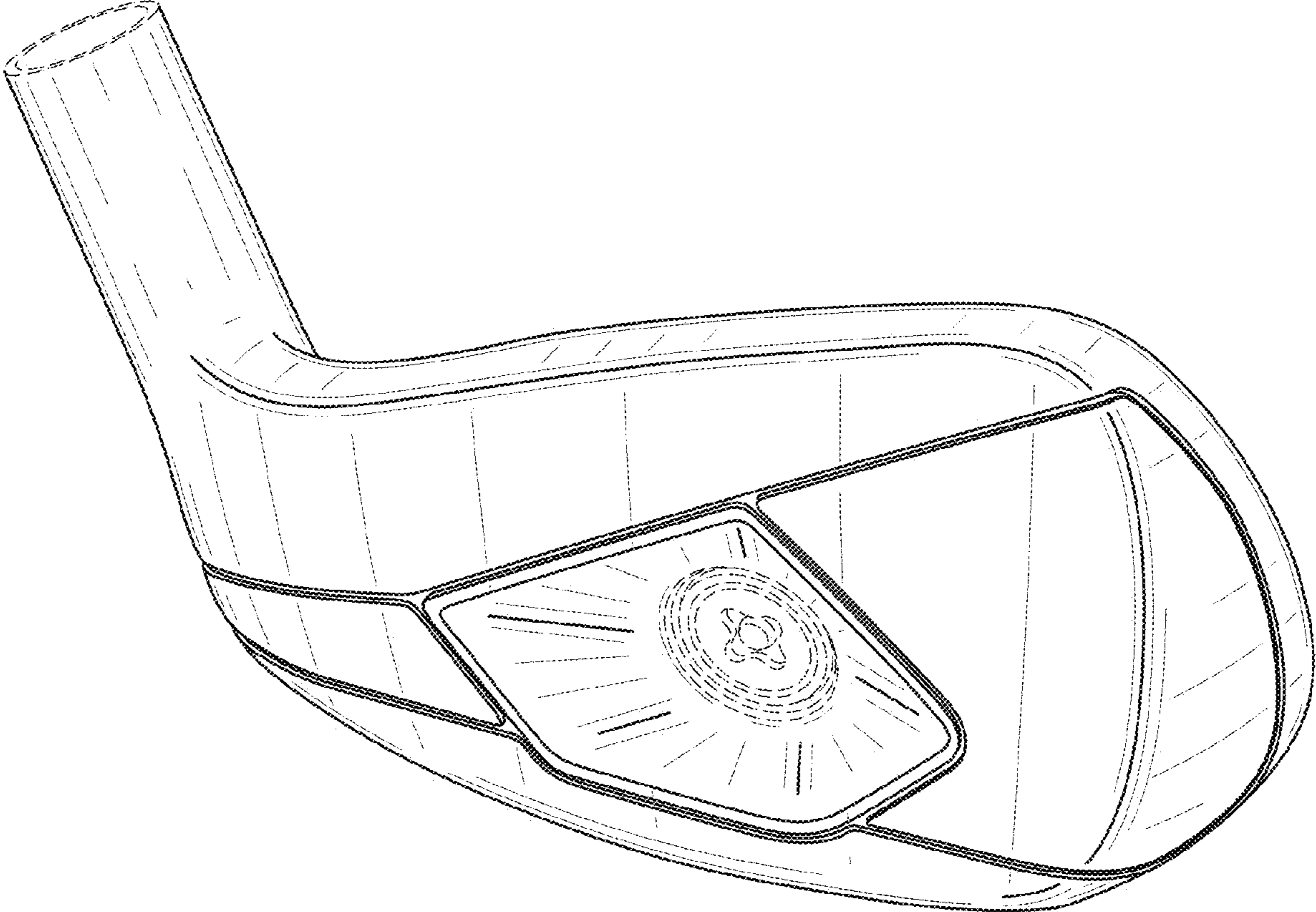

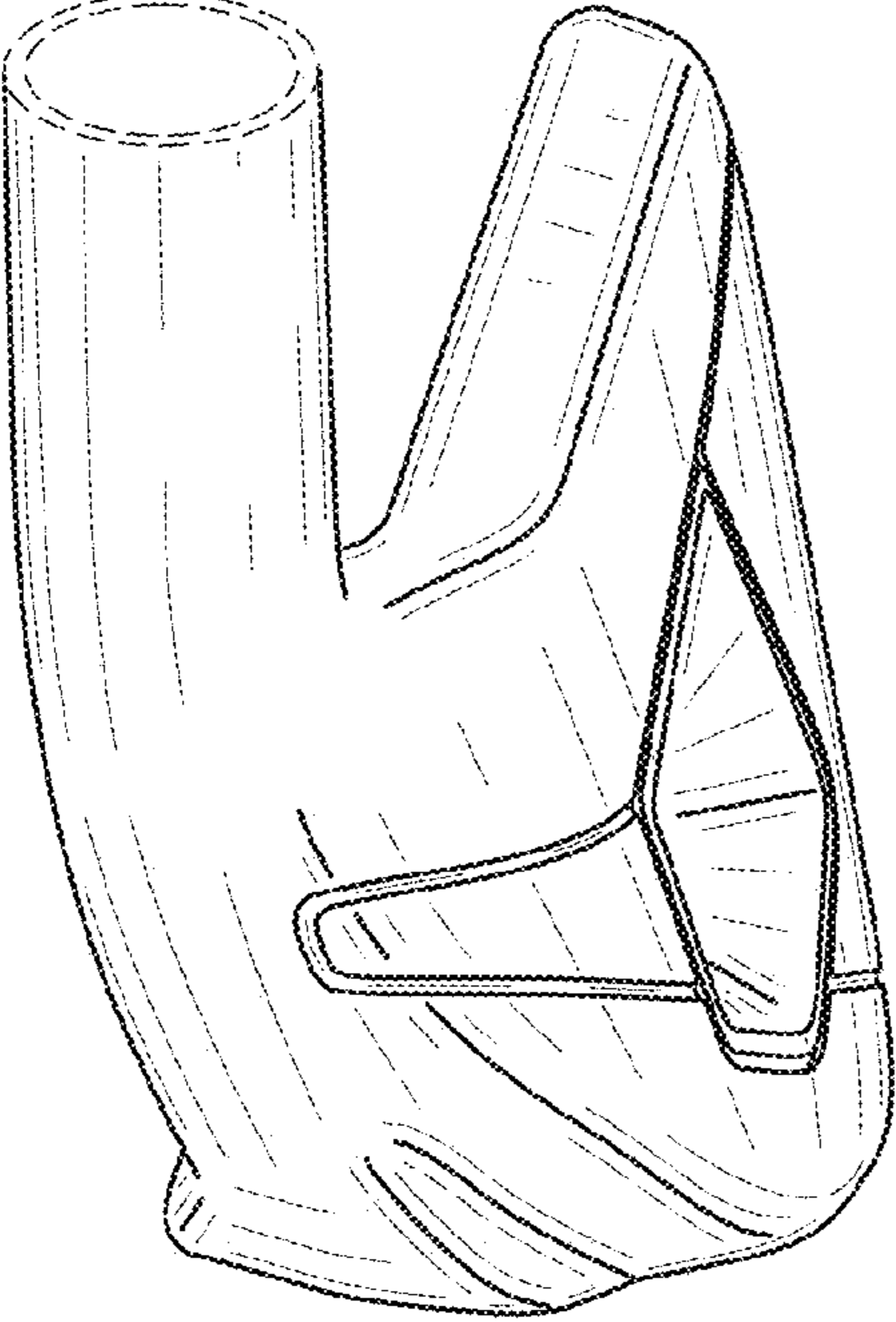

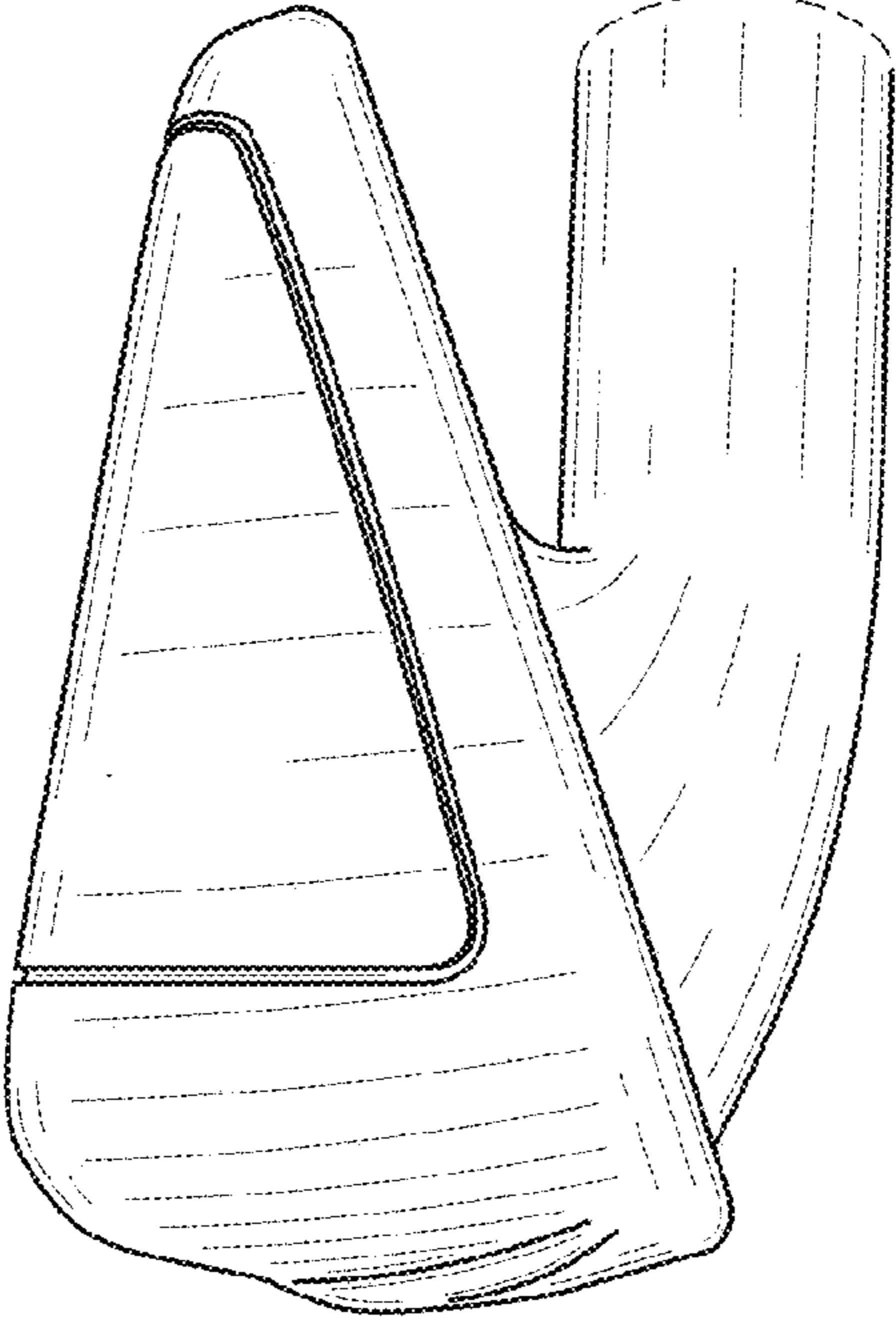

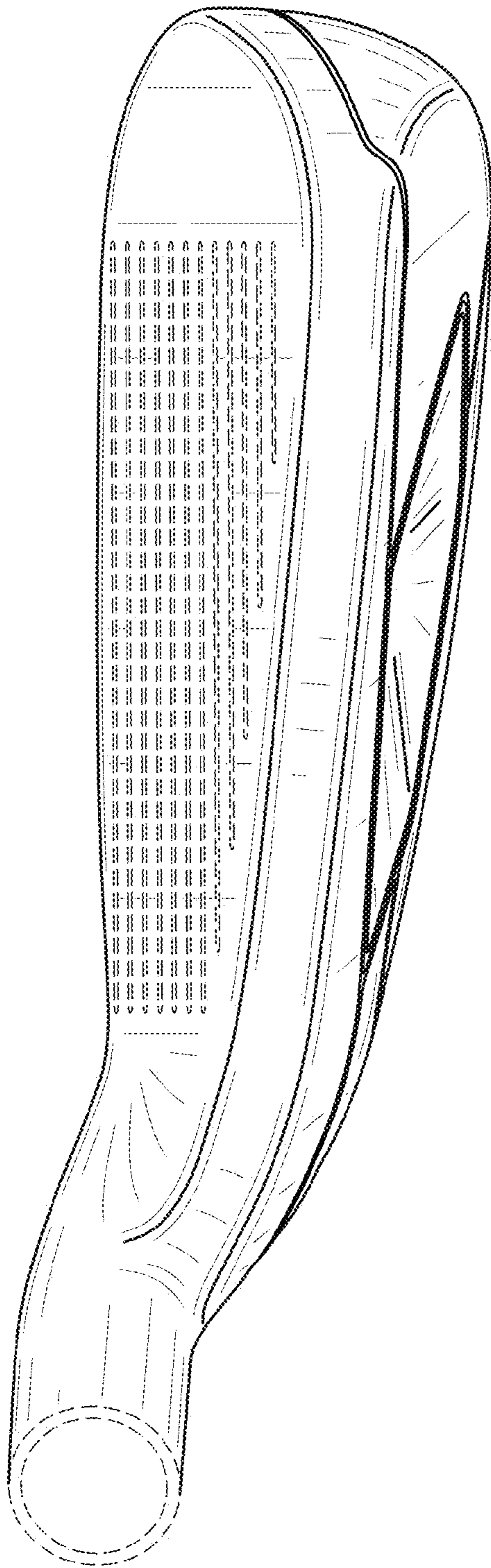
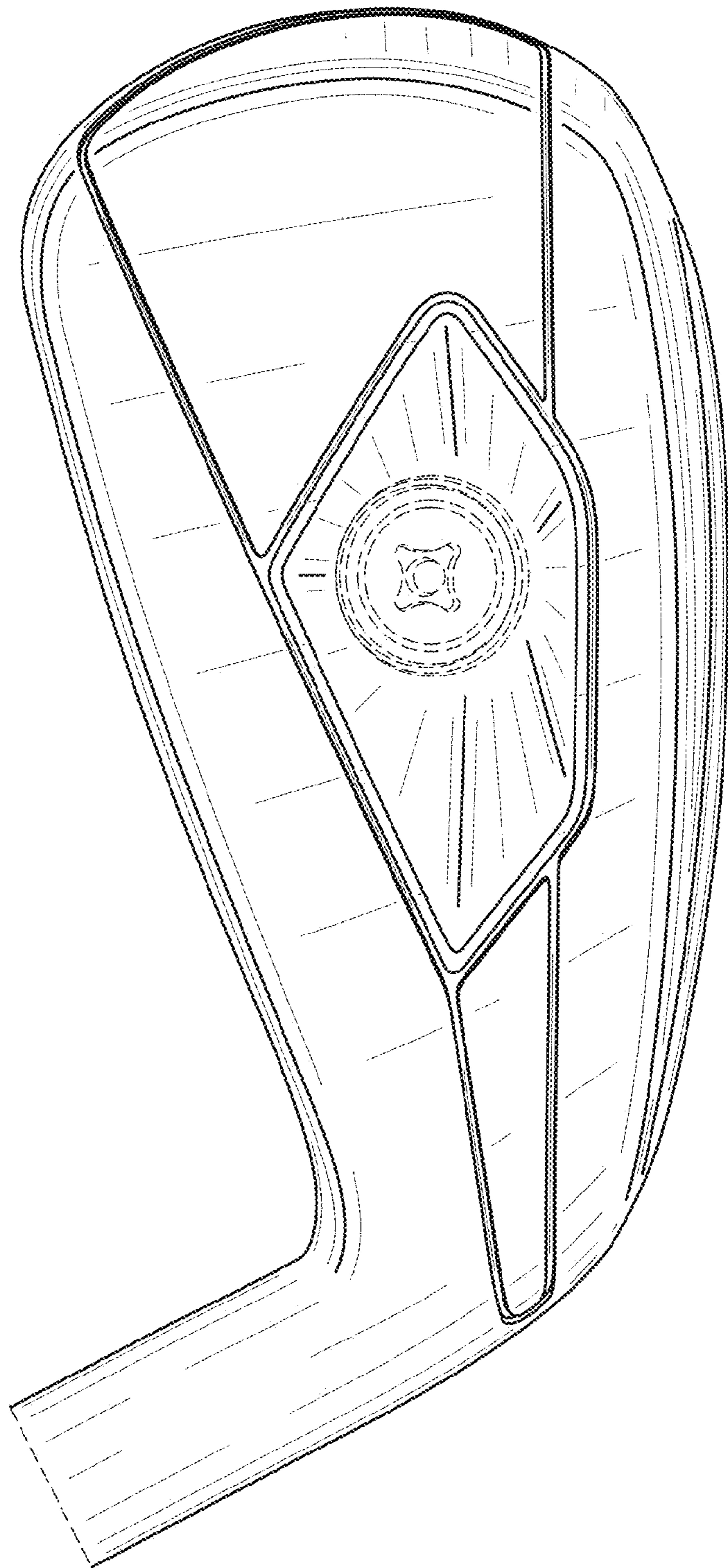

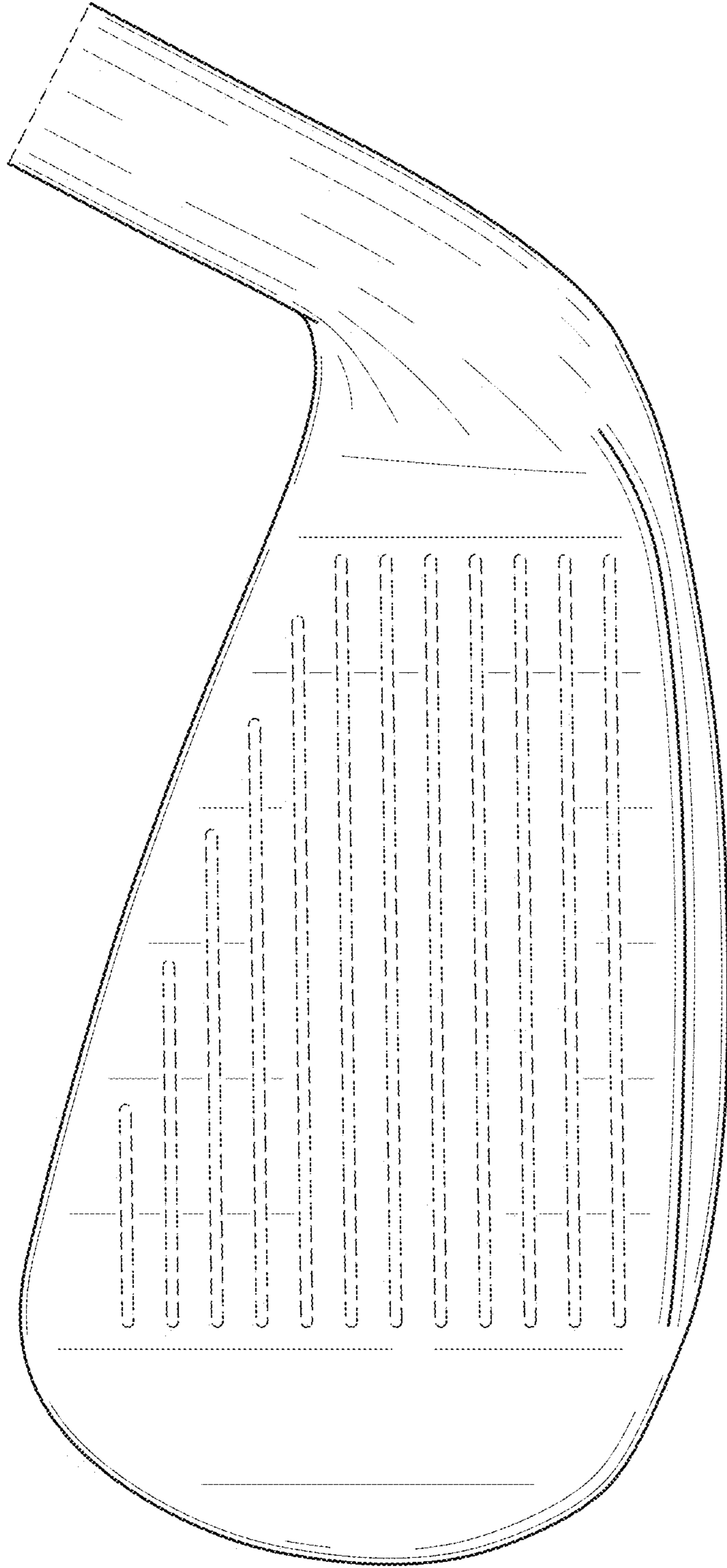

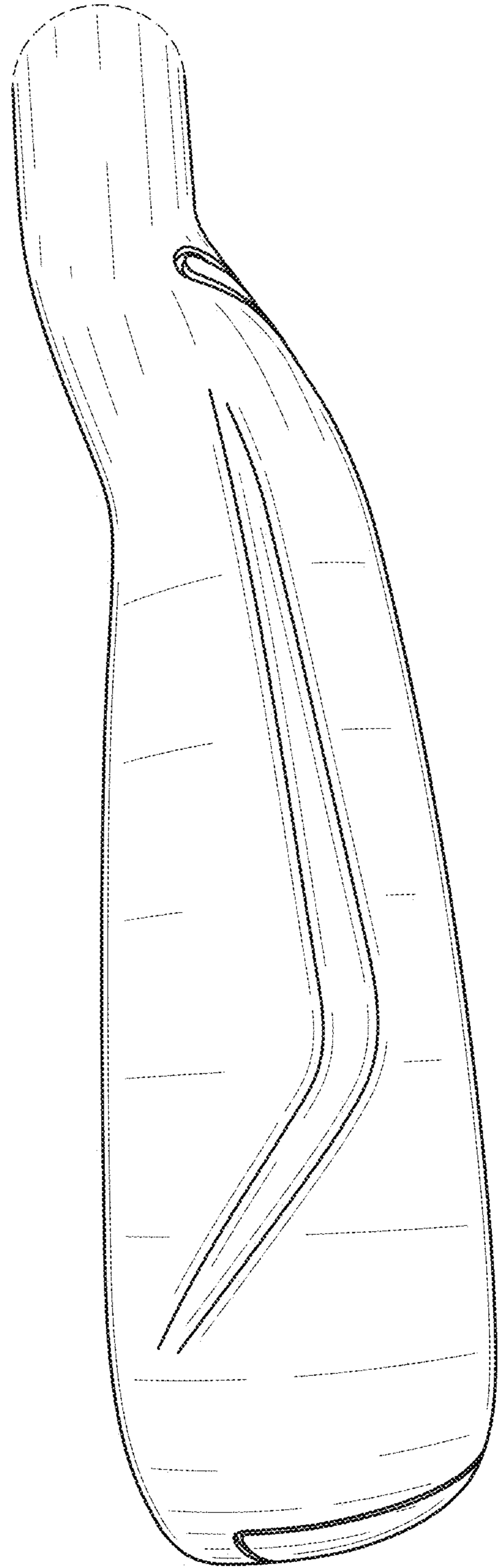
