**DESCRIPTION**

FIG. 5 is a bottom plan view of the air freshener of FIG. 1;

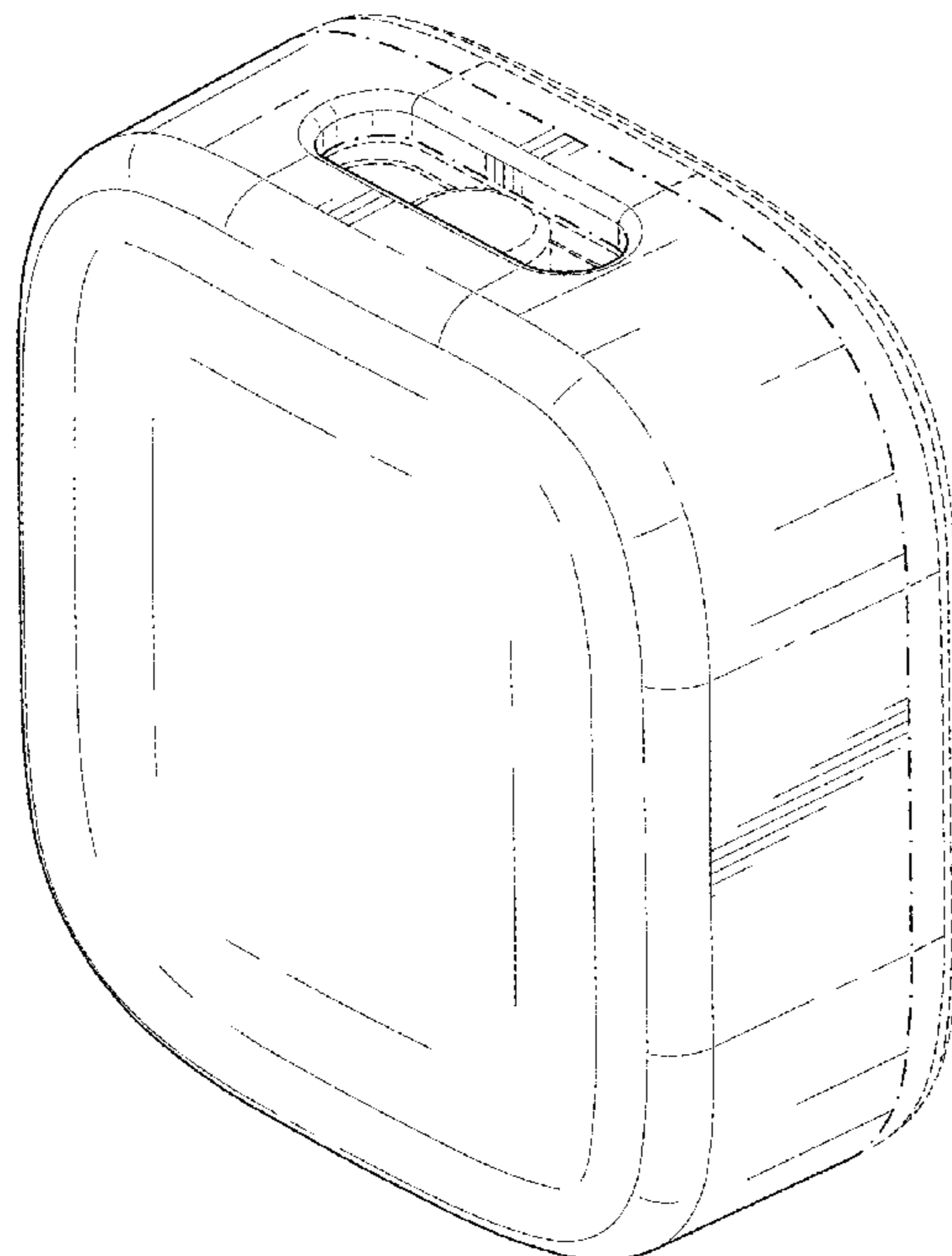
FIG. 6 is a left elevational view of the air freshener of FIG. 1; and,

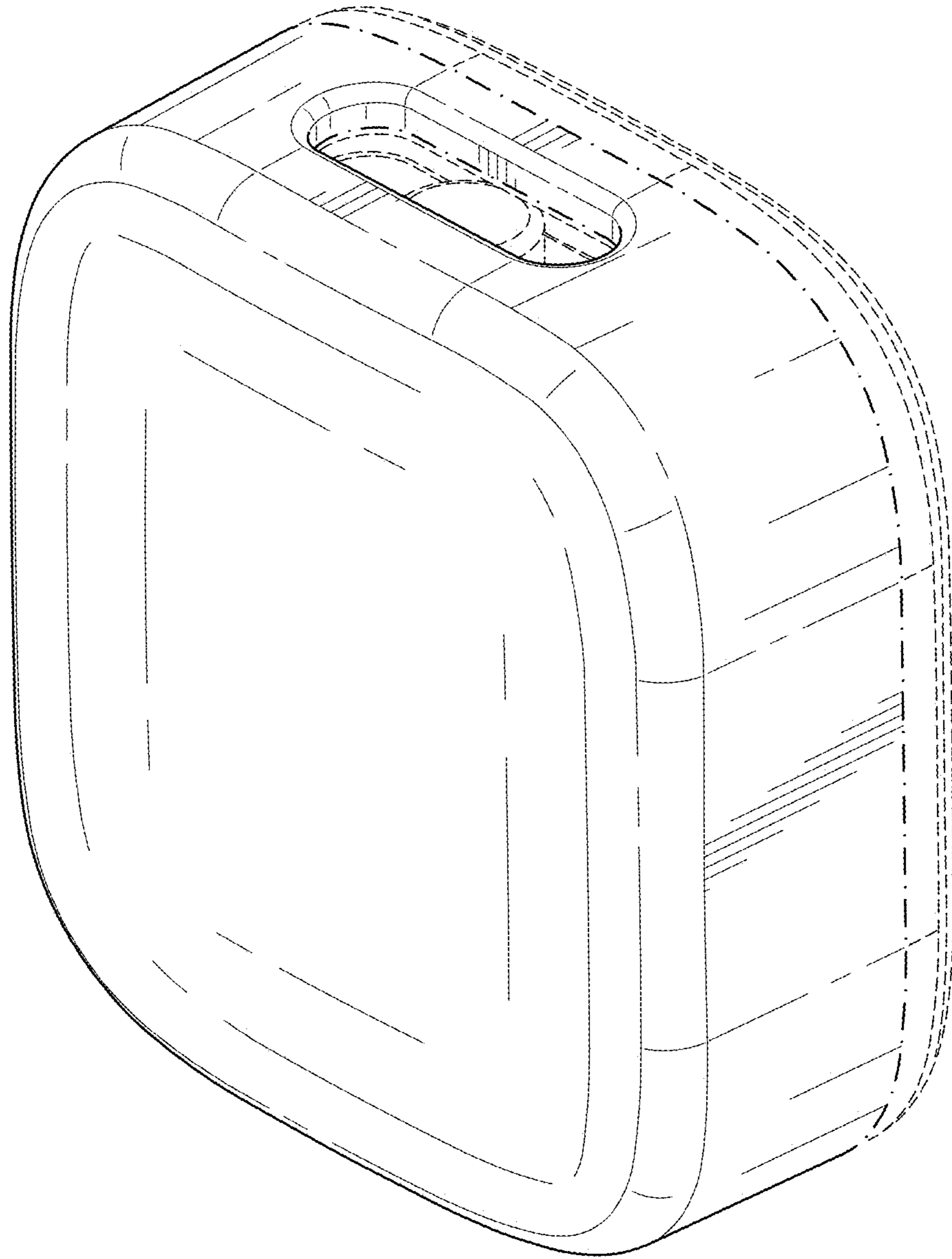

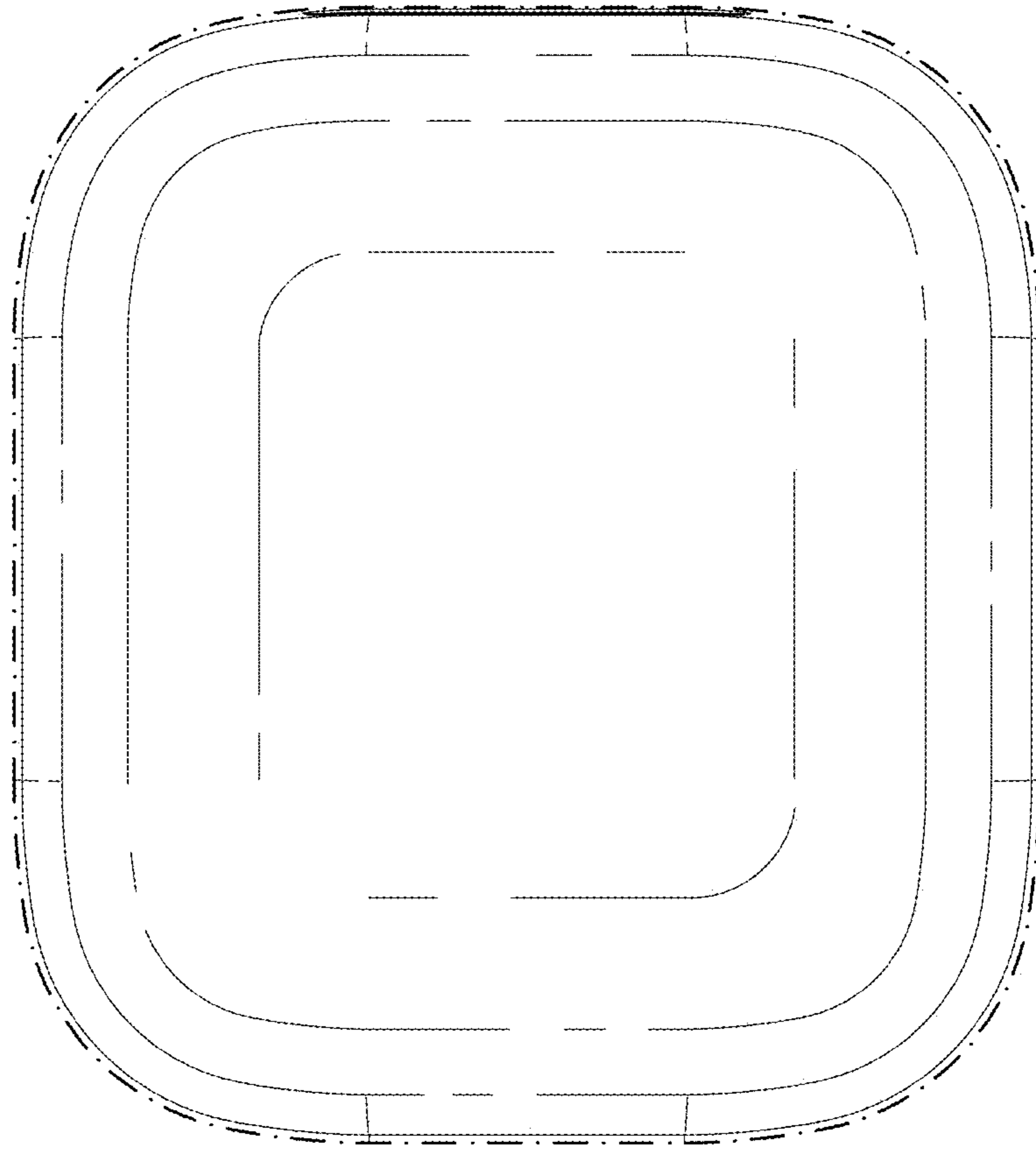
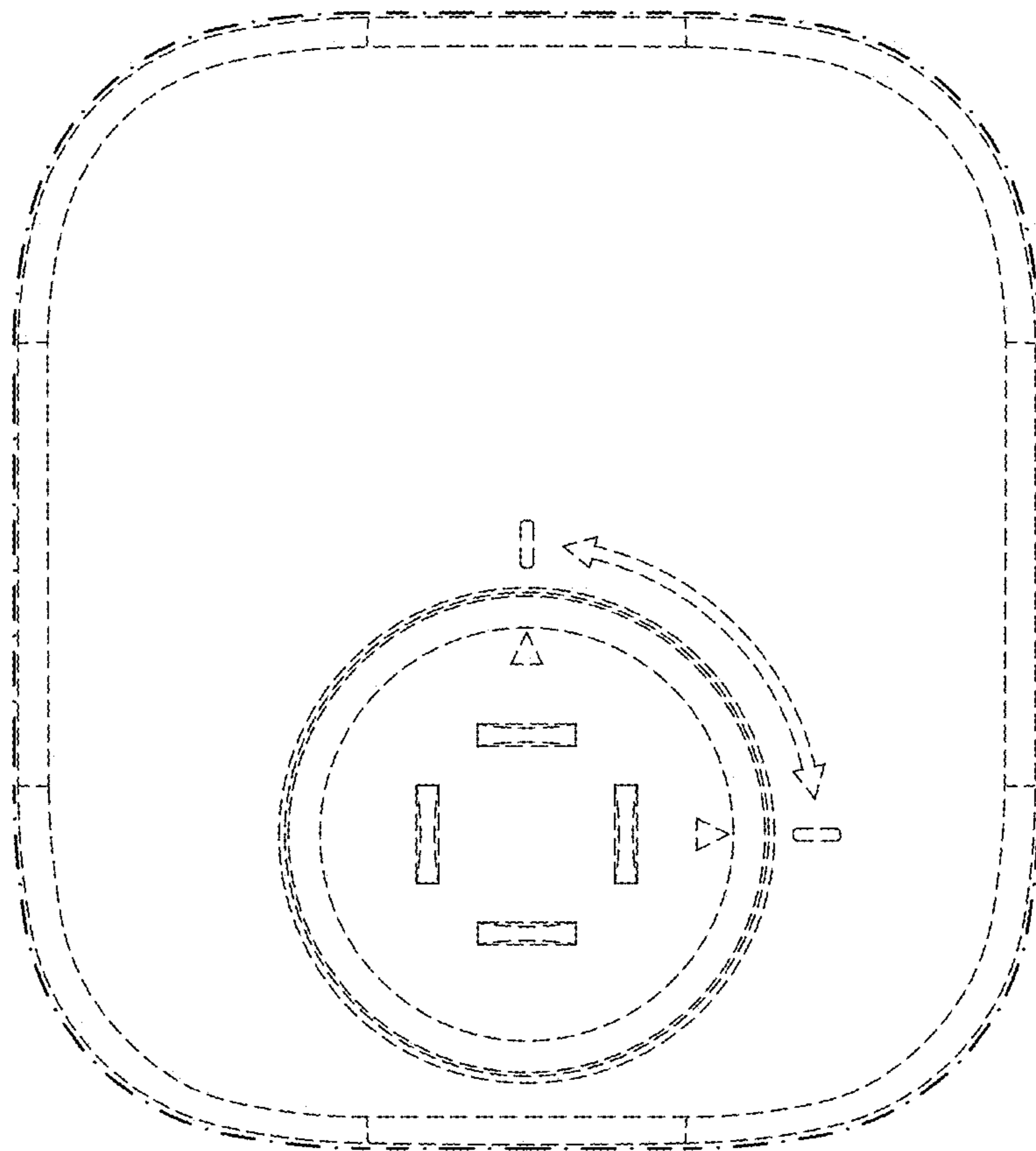

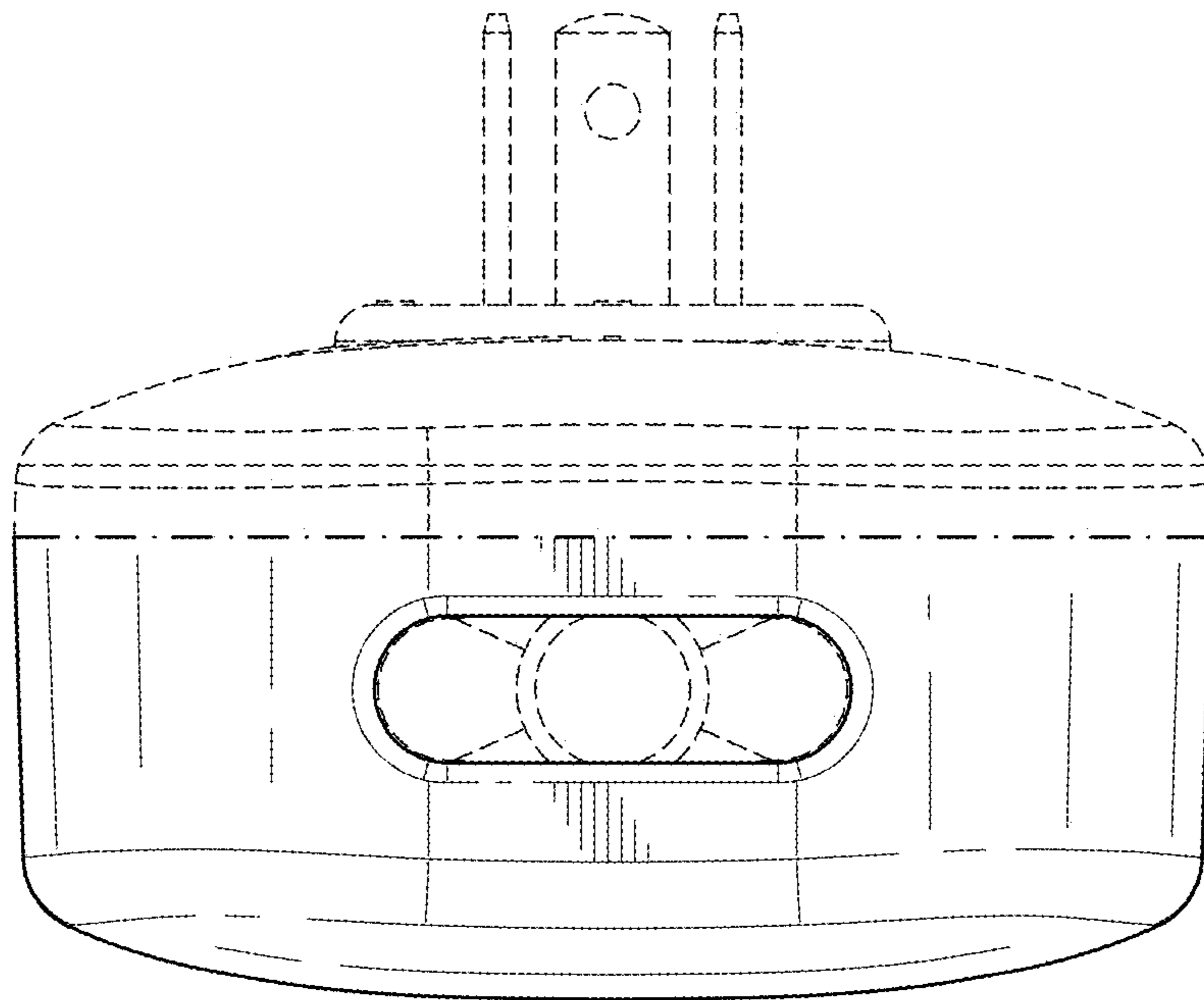

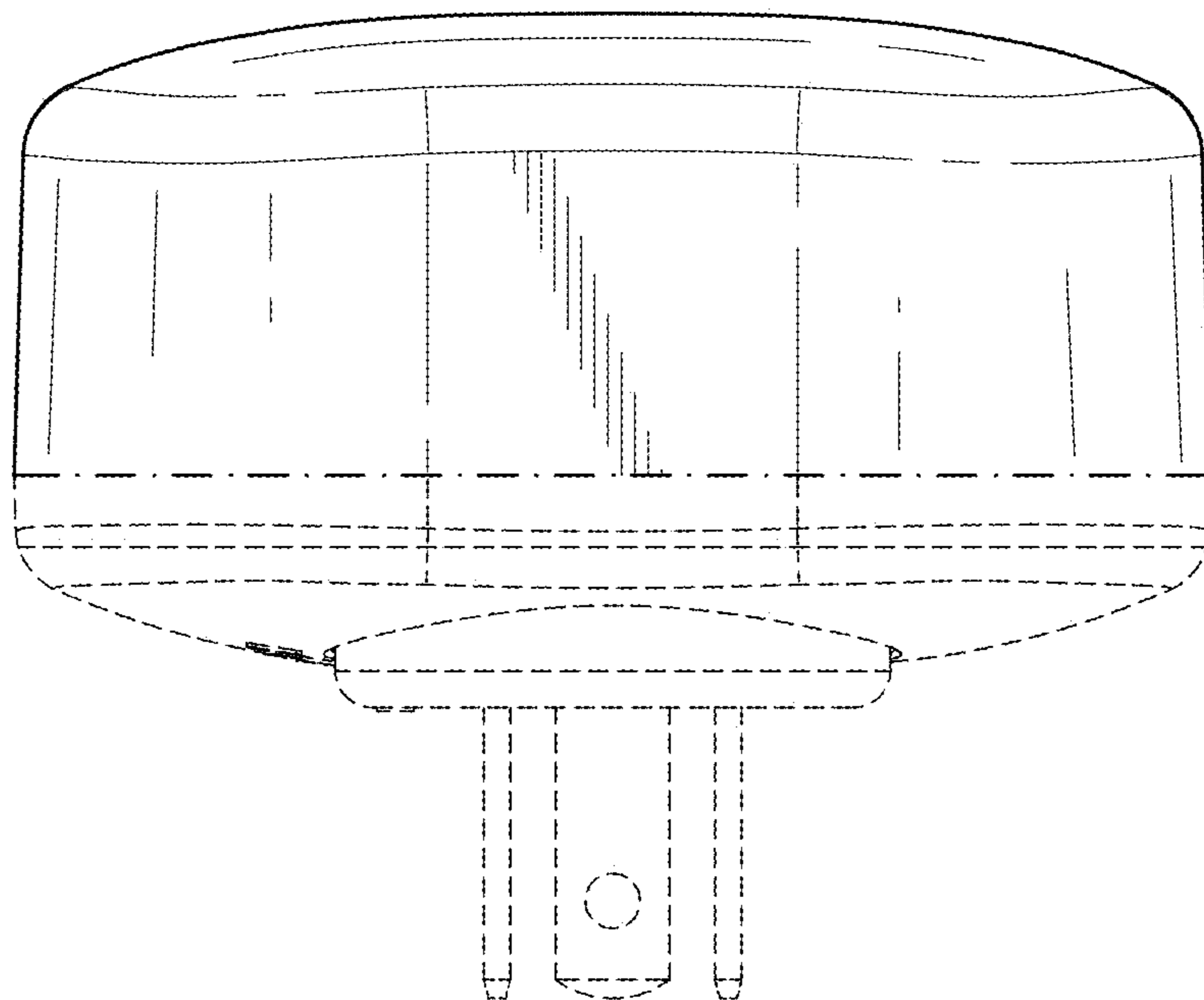

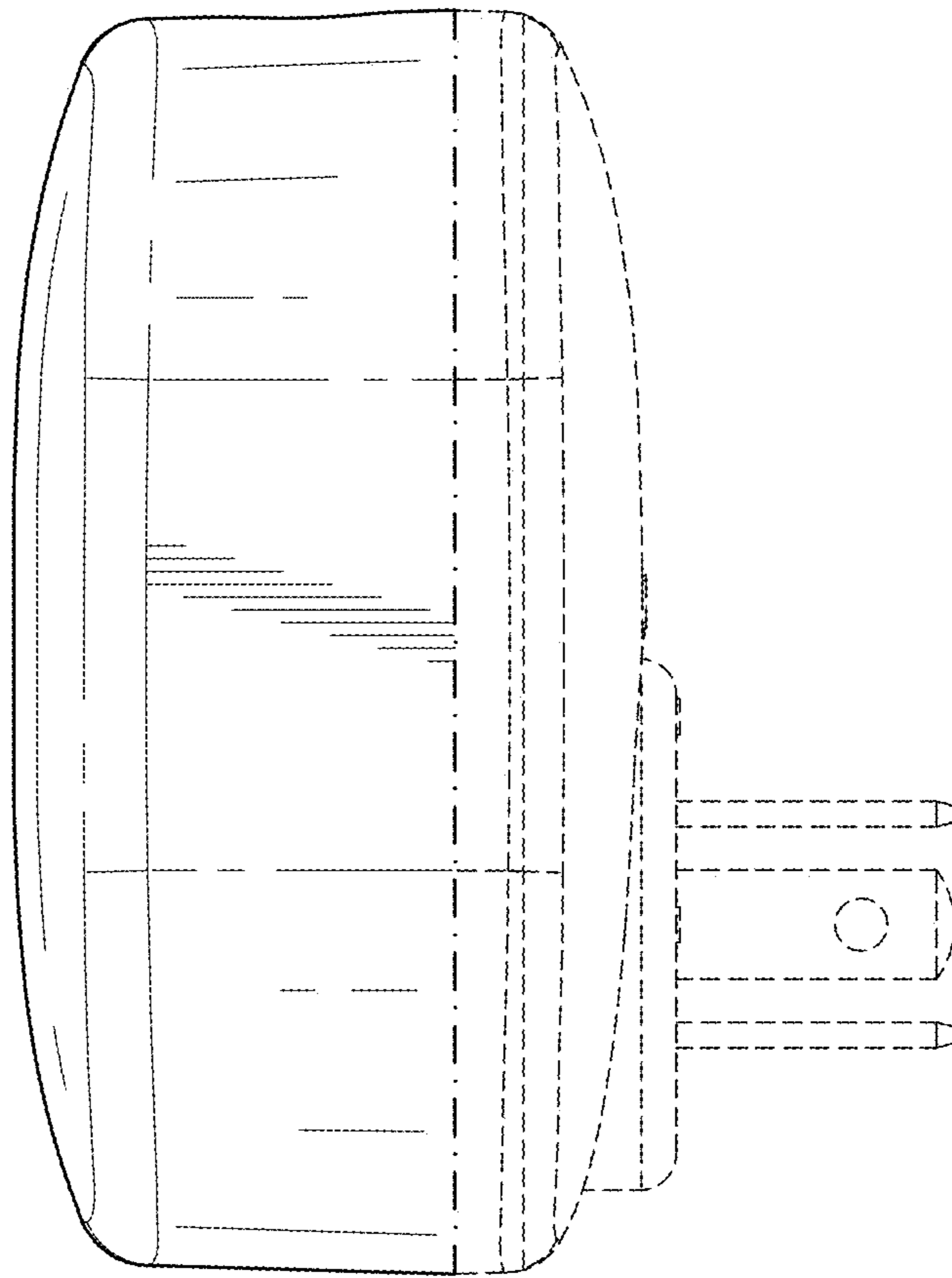
