(57) **CLAIM**

The ornamental design for a face mask, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a face mask according to the design.

FIG. 2 is a rear perspective view of the face mask of FIG. 1.

FIG. 3 is a front view of the face mask of FIG. 1.

FIG. 4 is a back view of the face mask of FIG. 1.

FIG. 5 is a side view of the face mask of FIG. 1, the opposite side view being a mirror image thereof.

FIG. 6 is a top view of the face mask of FIG. 1.

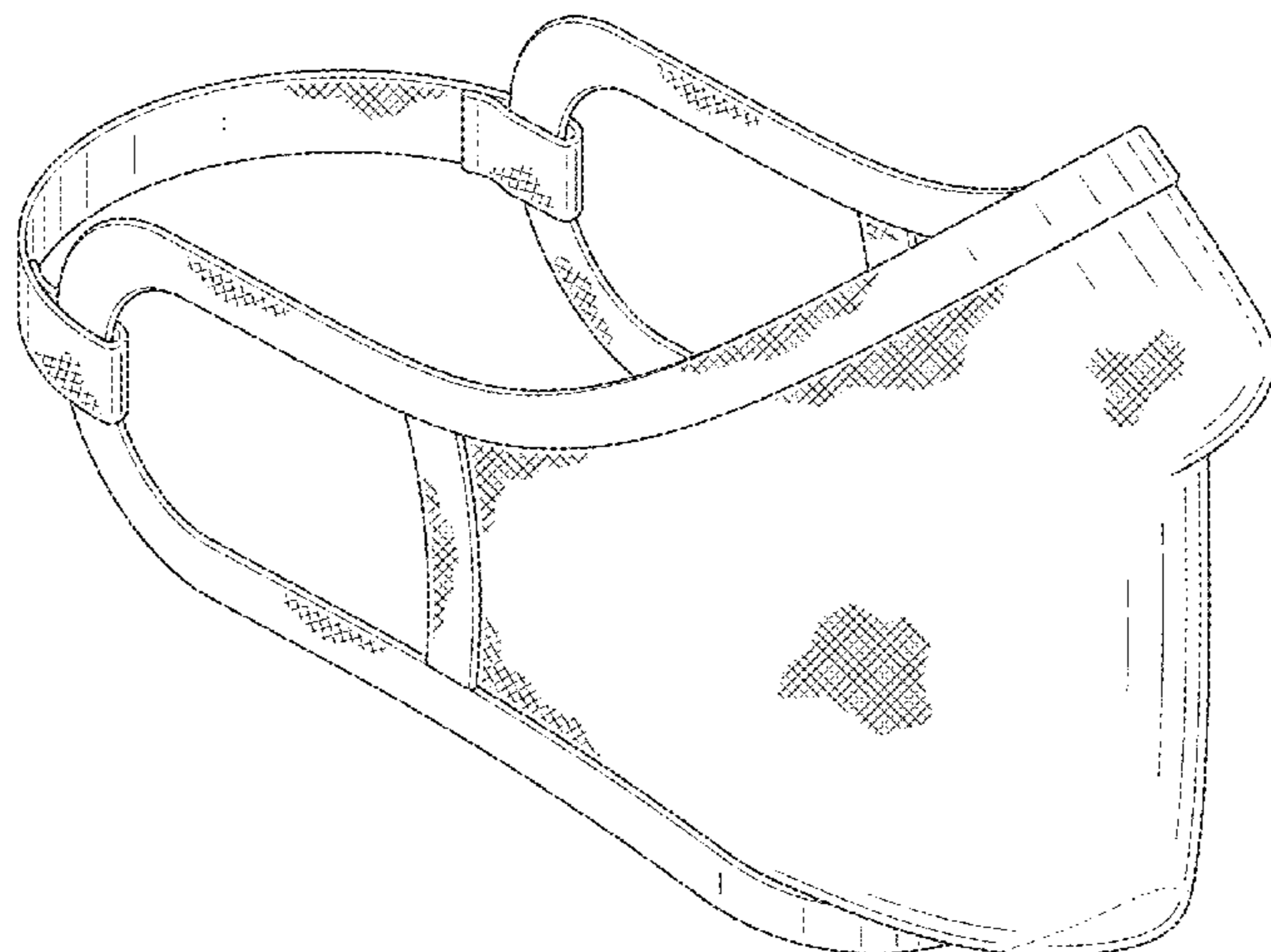
FIG. 7 is a bottom view of the face mask of FIG. 1.

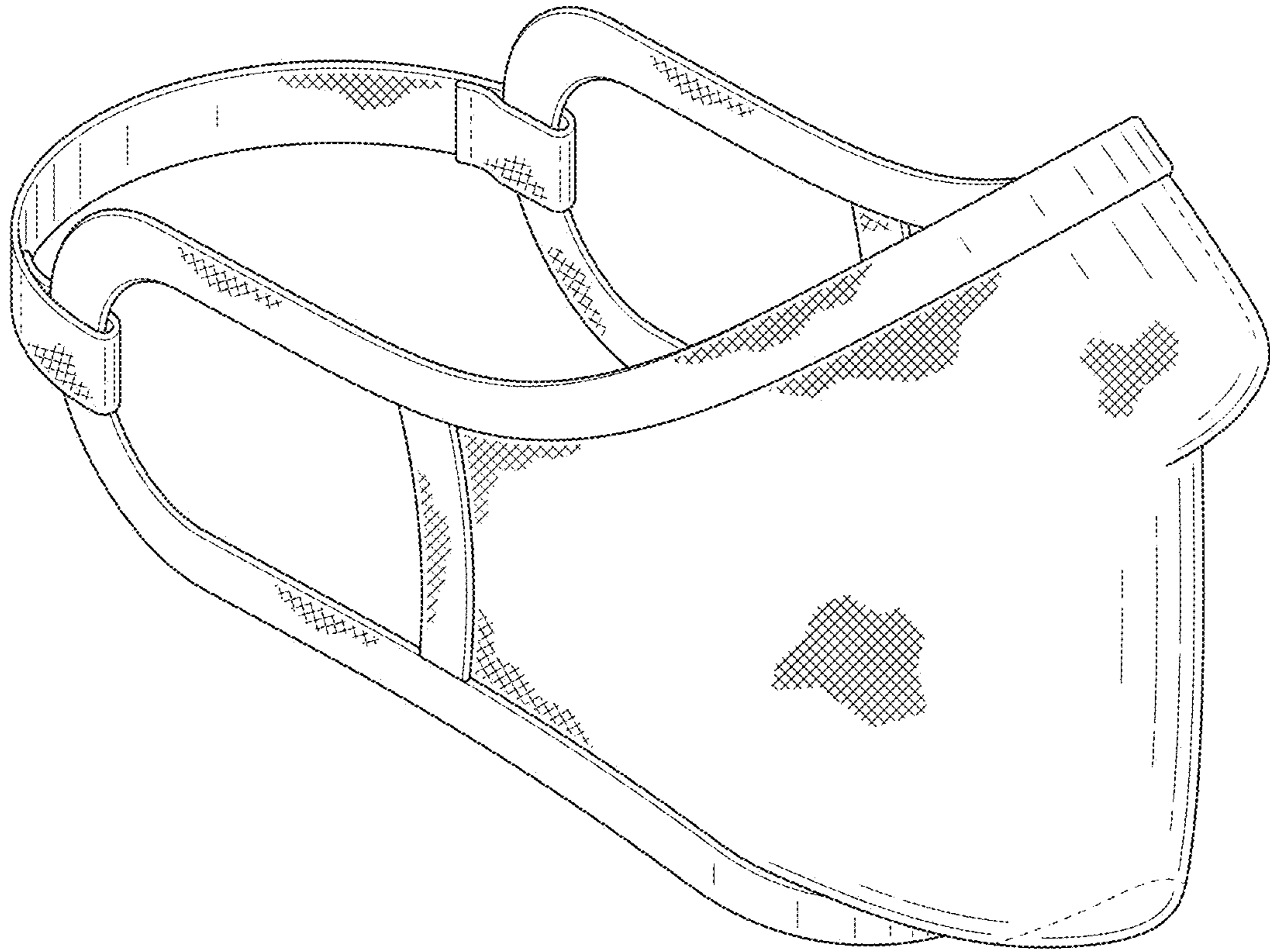

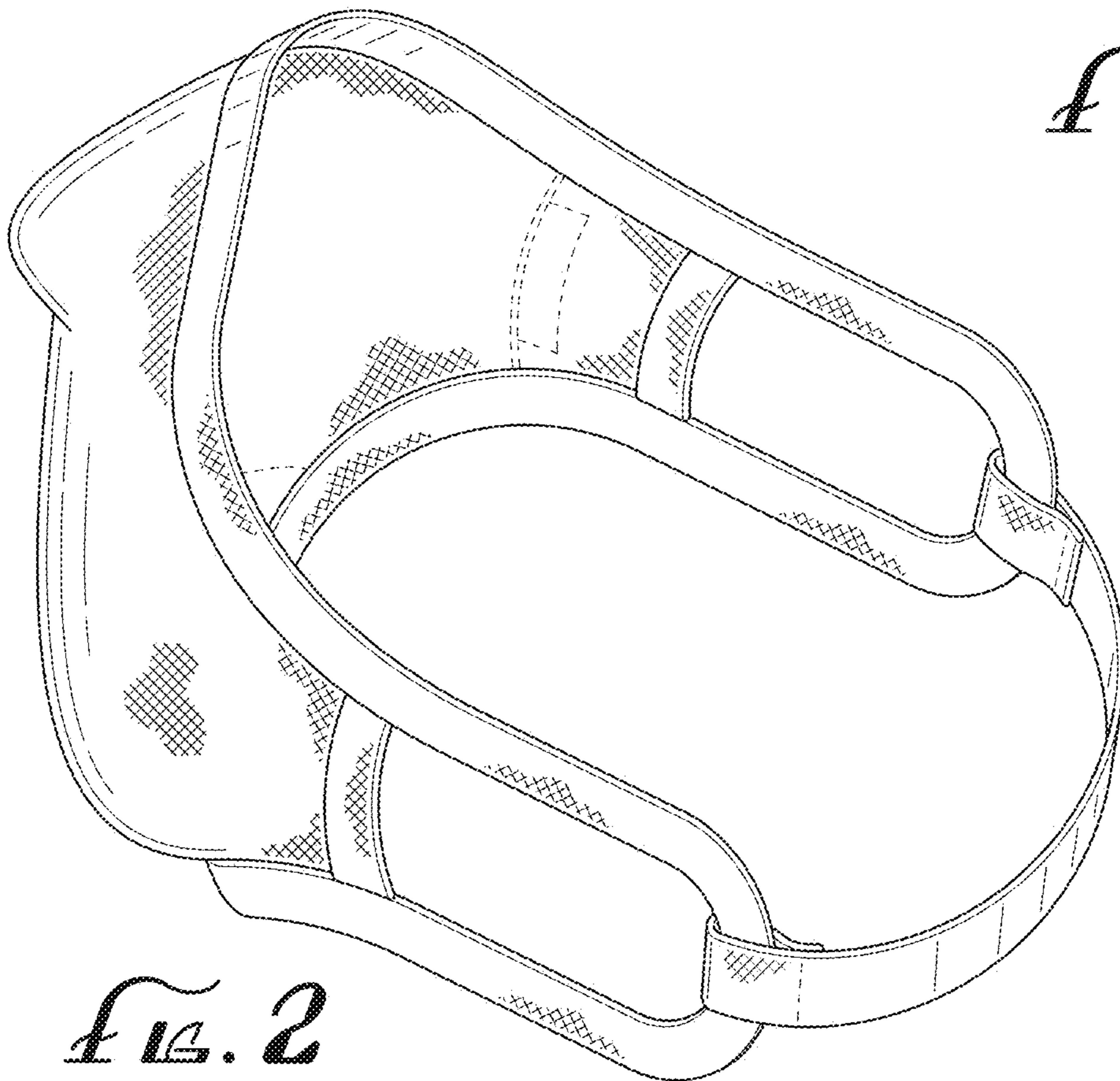

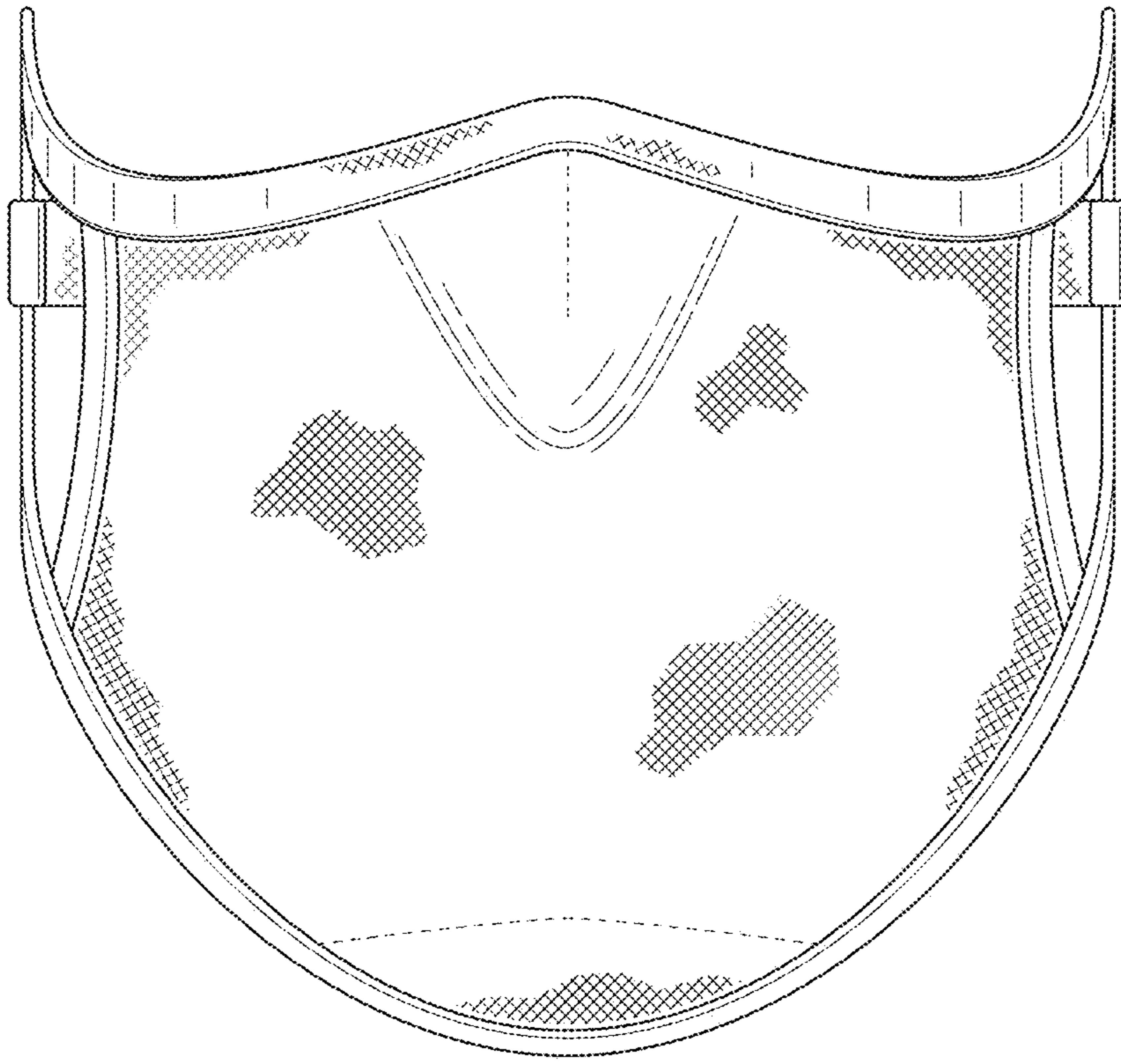

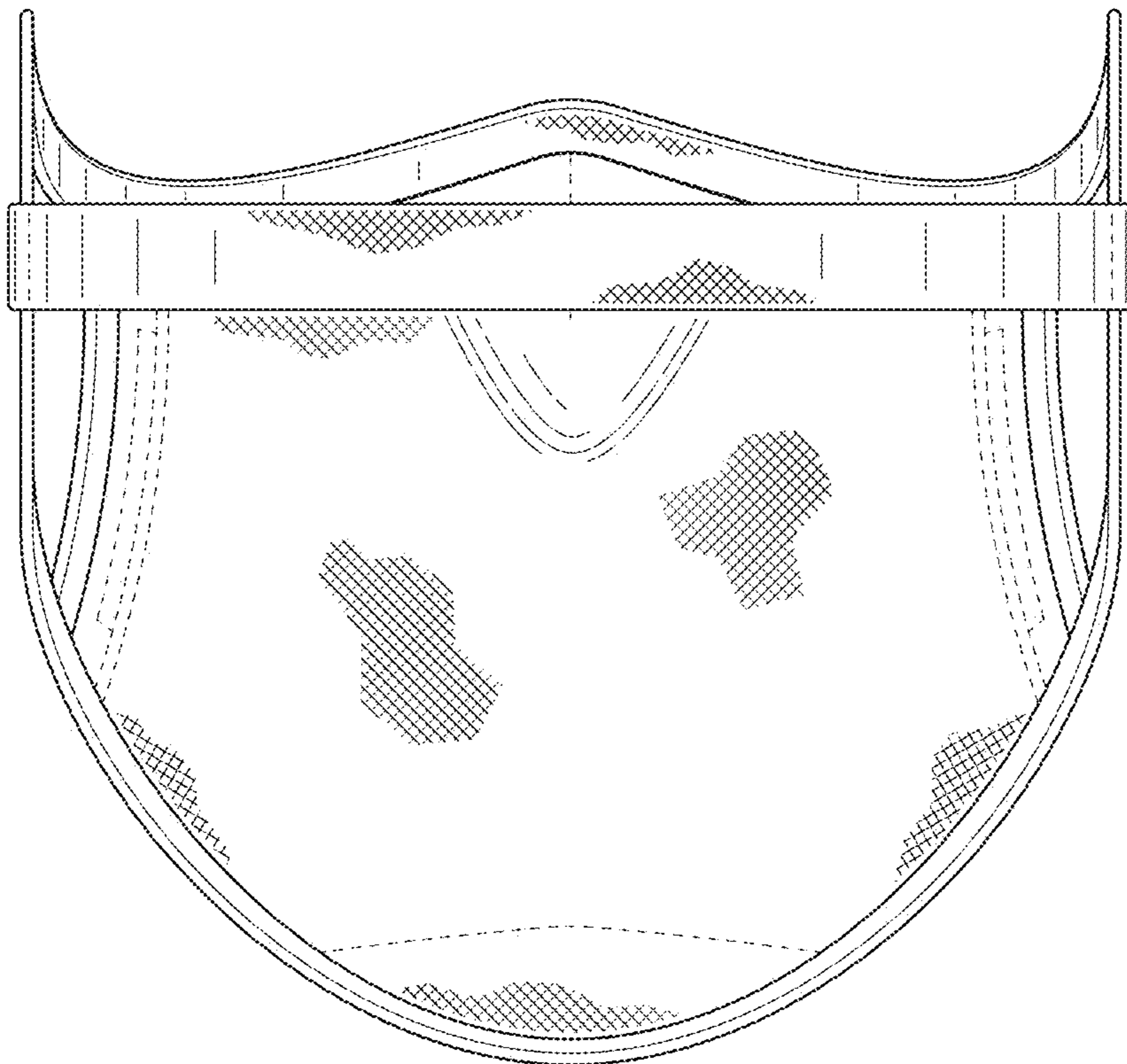

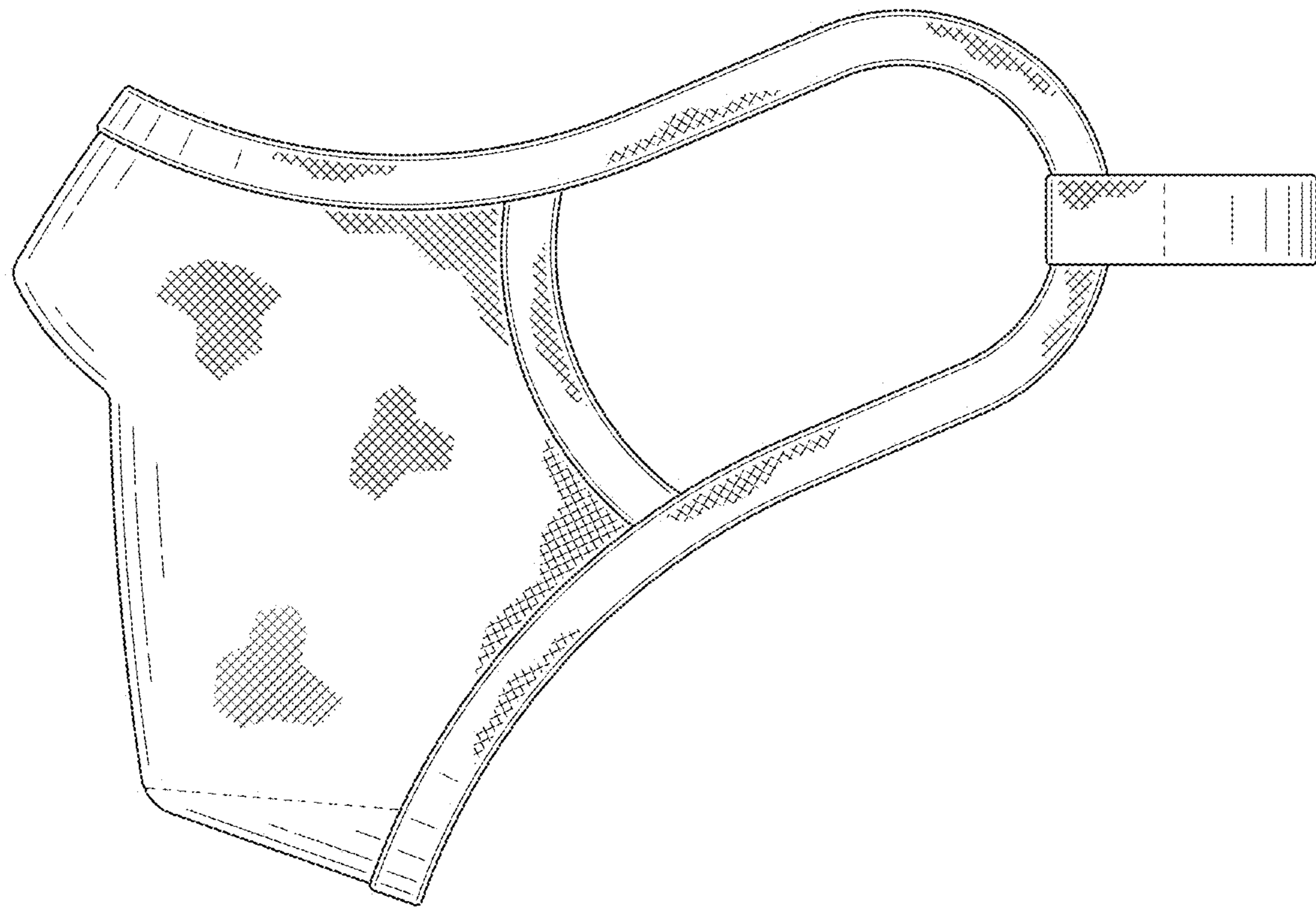

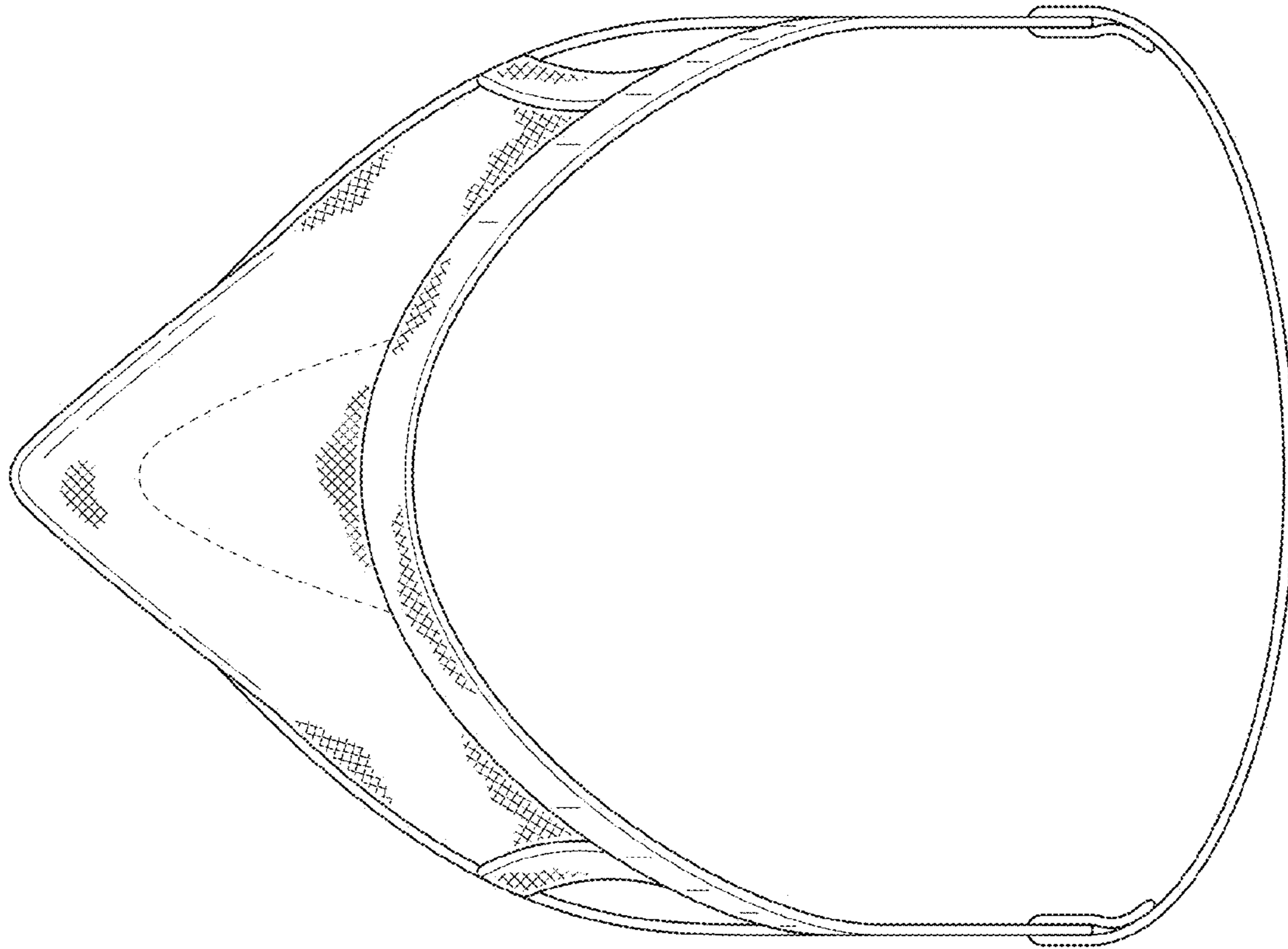

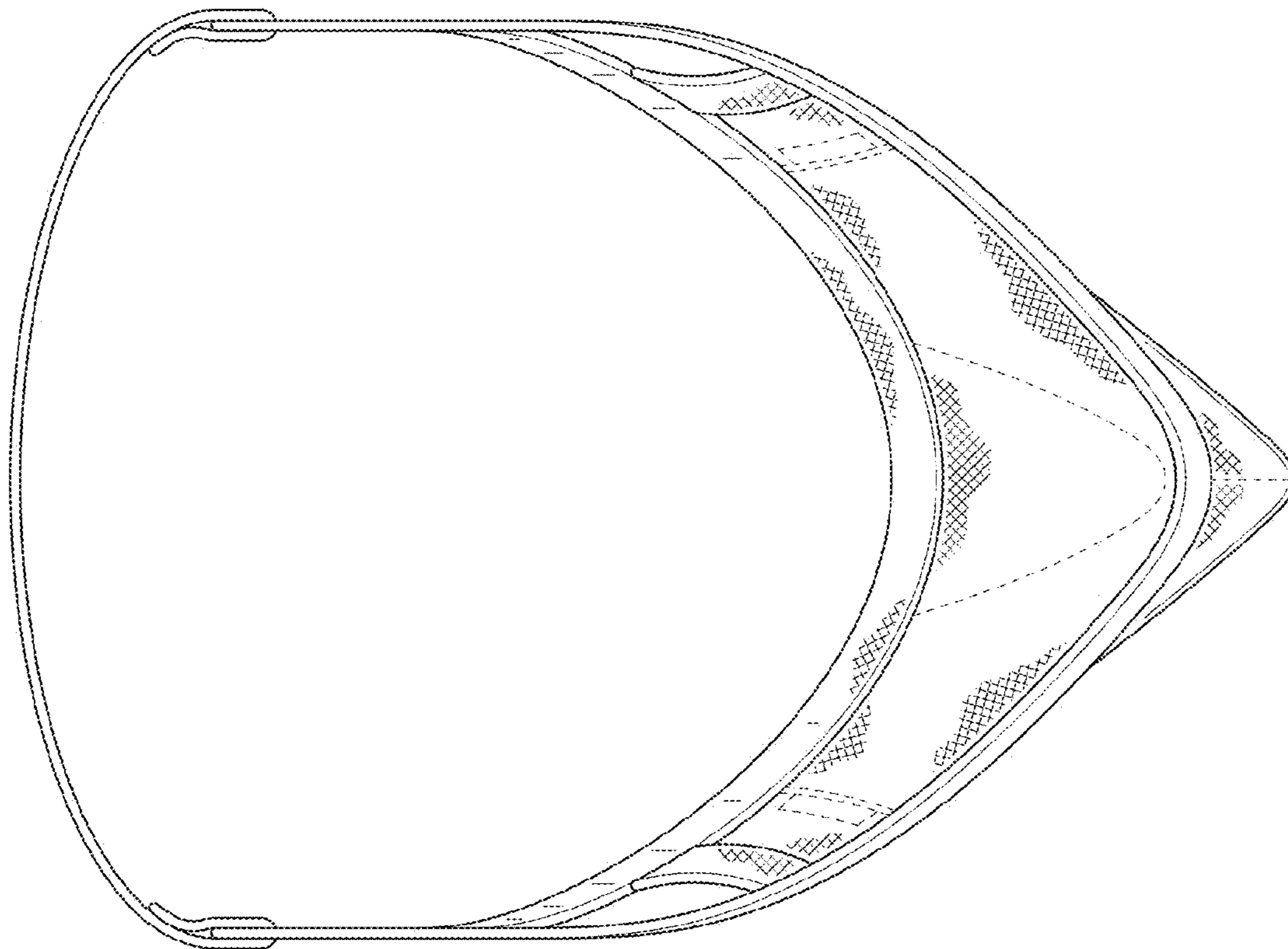

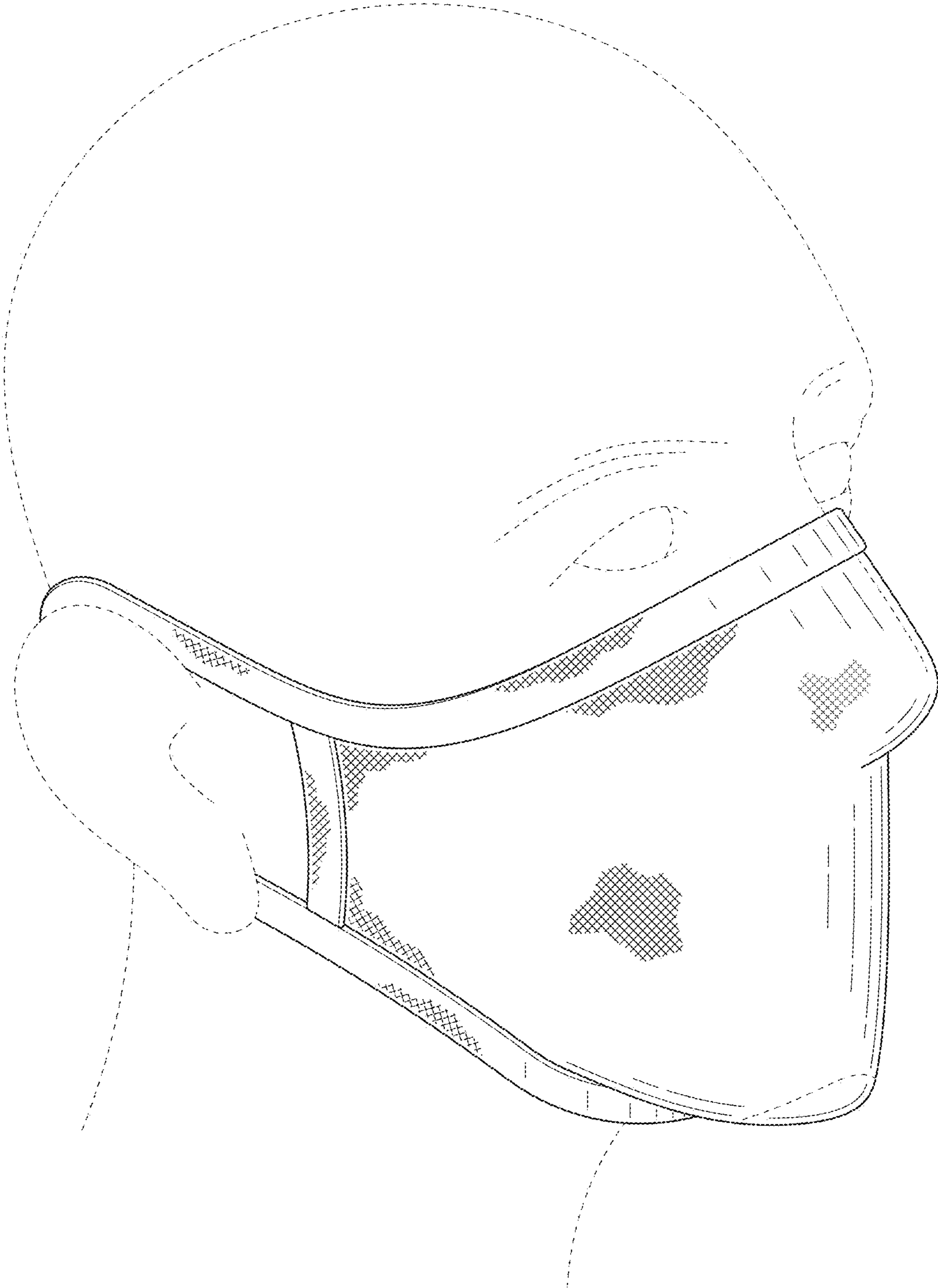

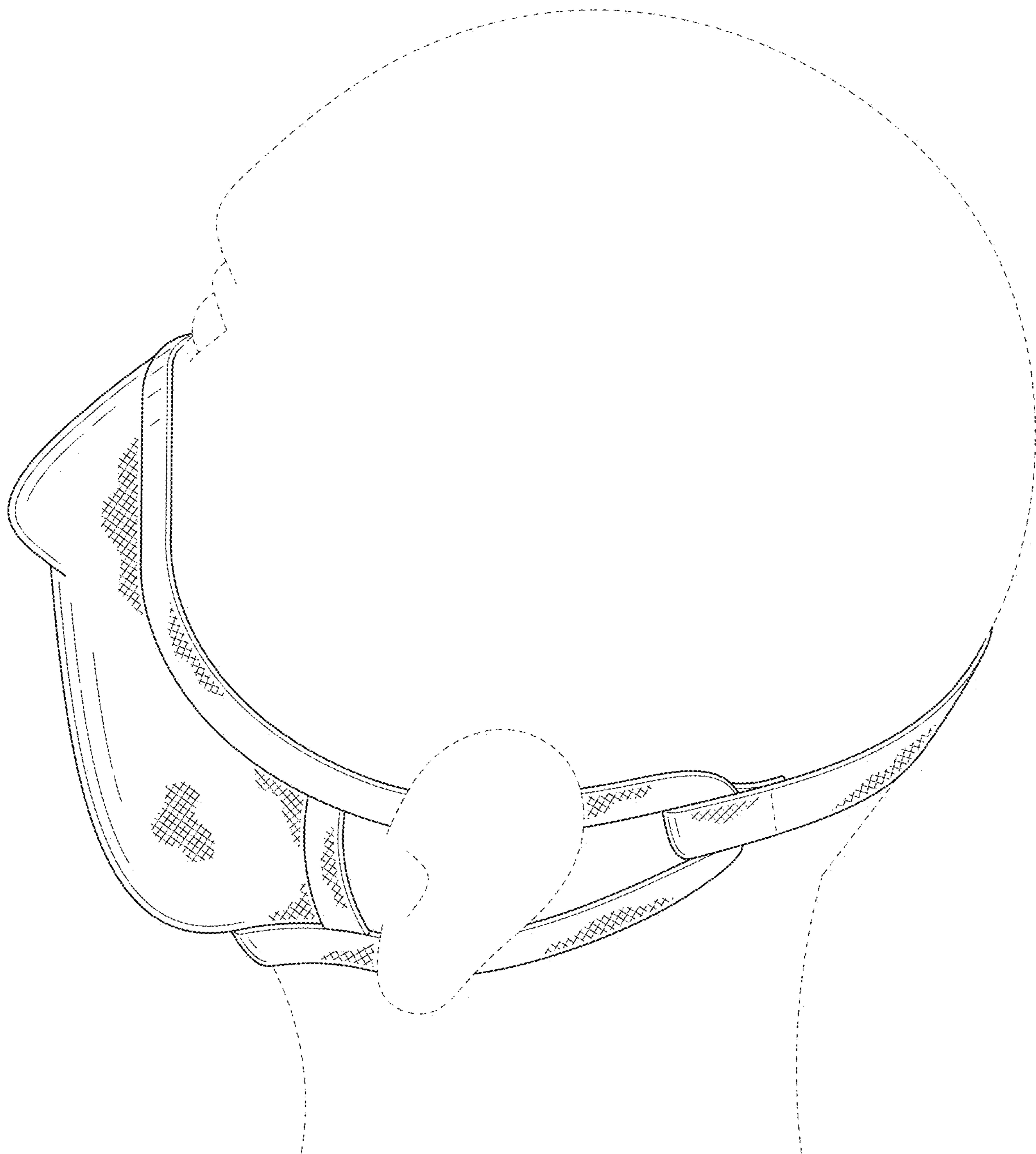
