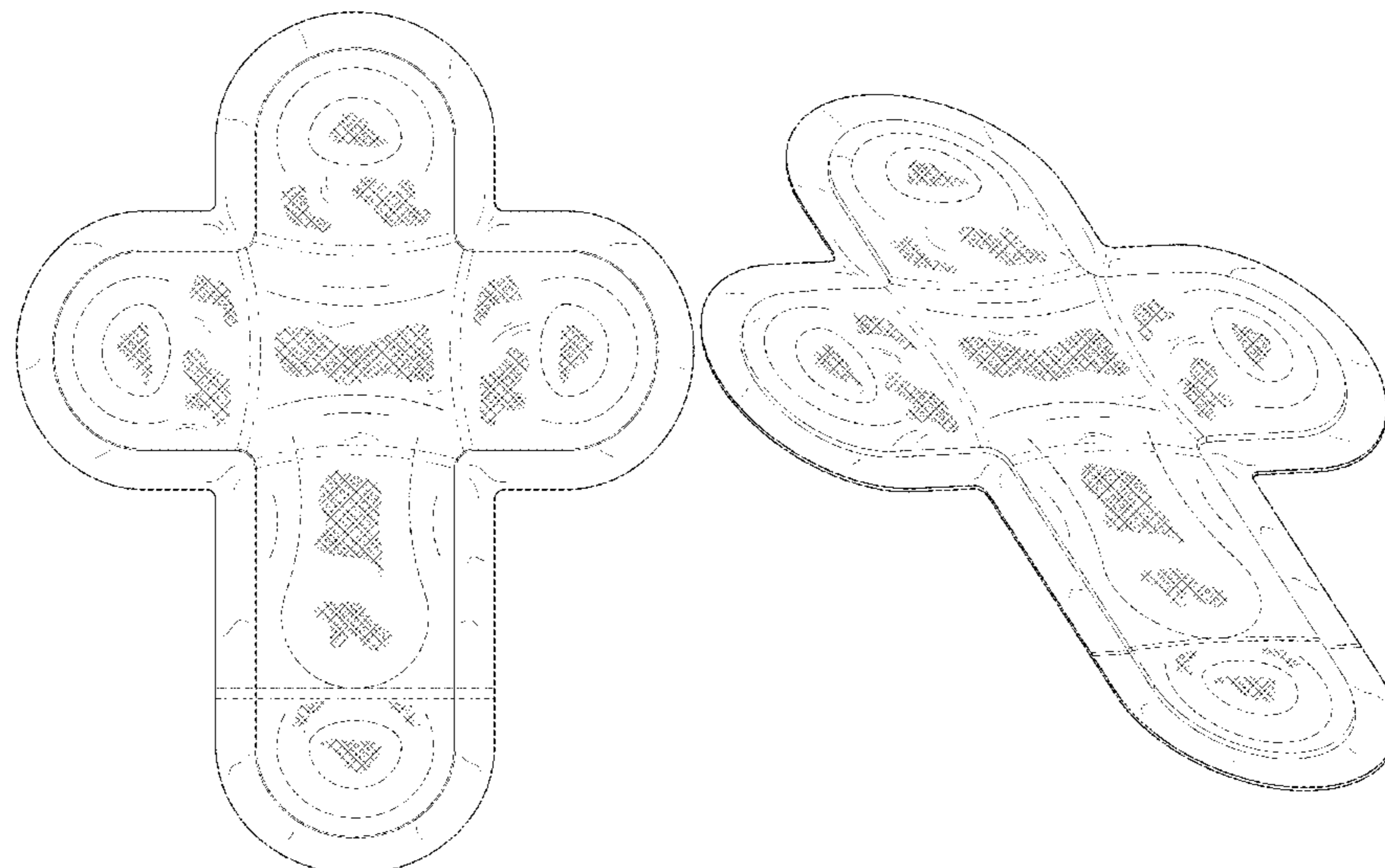
(57) **CLAIM**

I claim the ornamental design for an urine-absorbing liner for male undergarments, as shown and described.

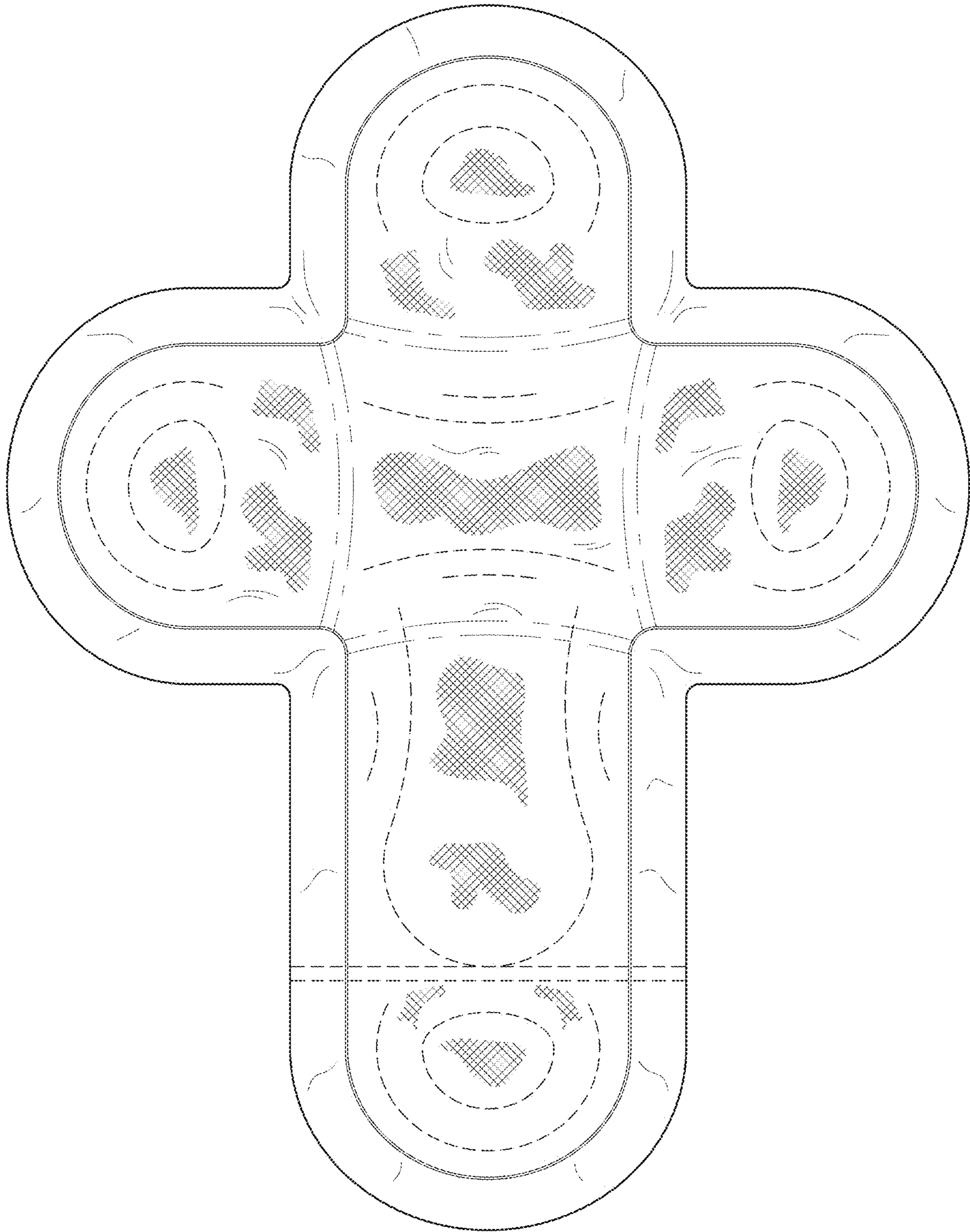

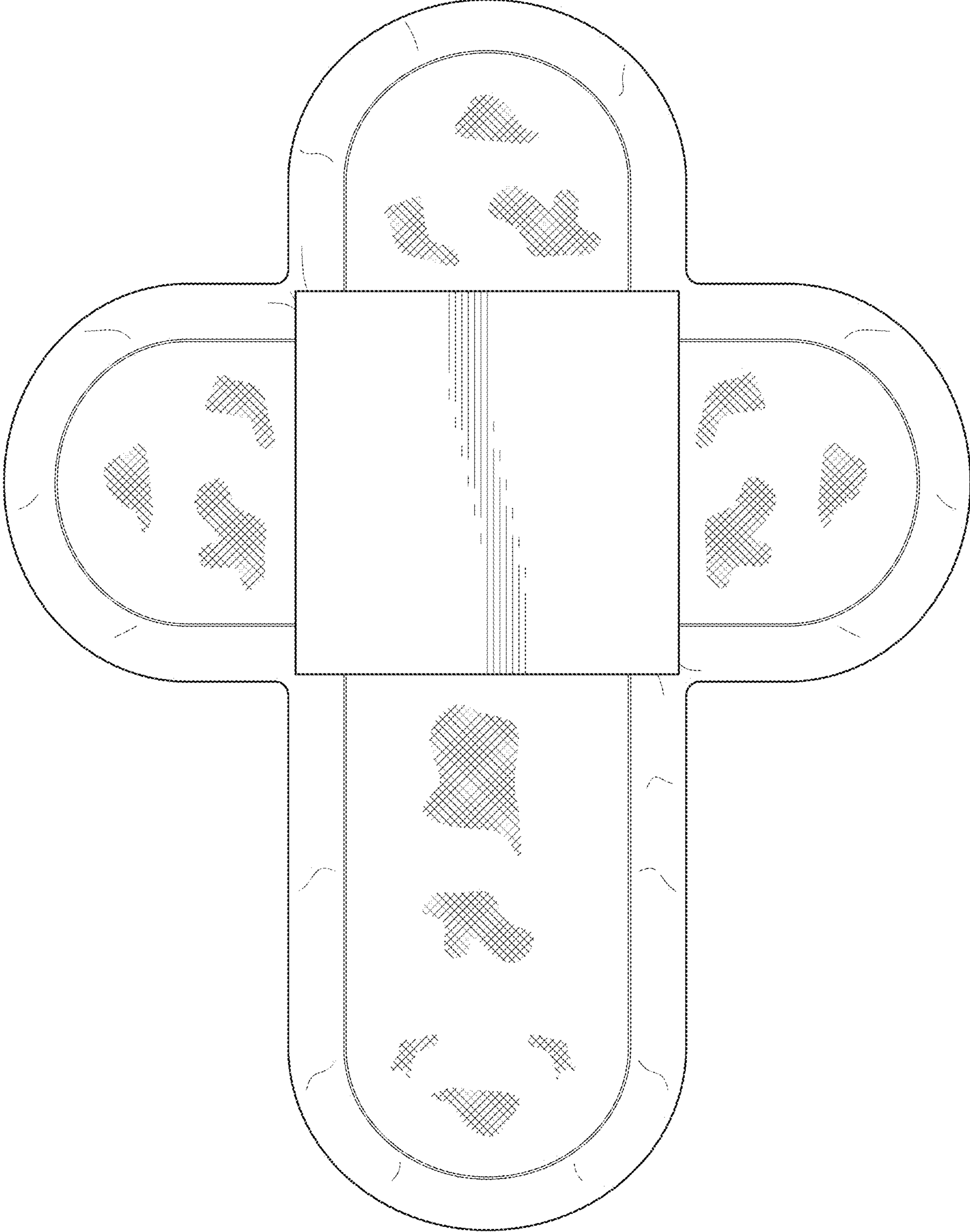

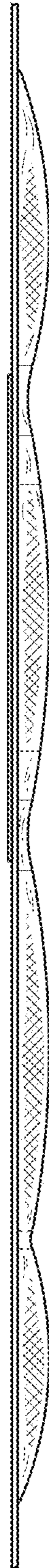

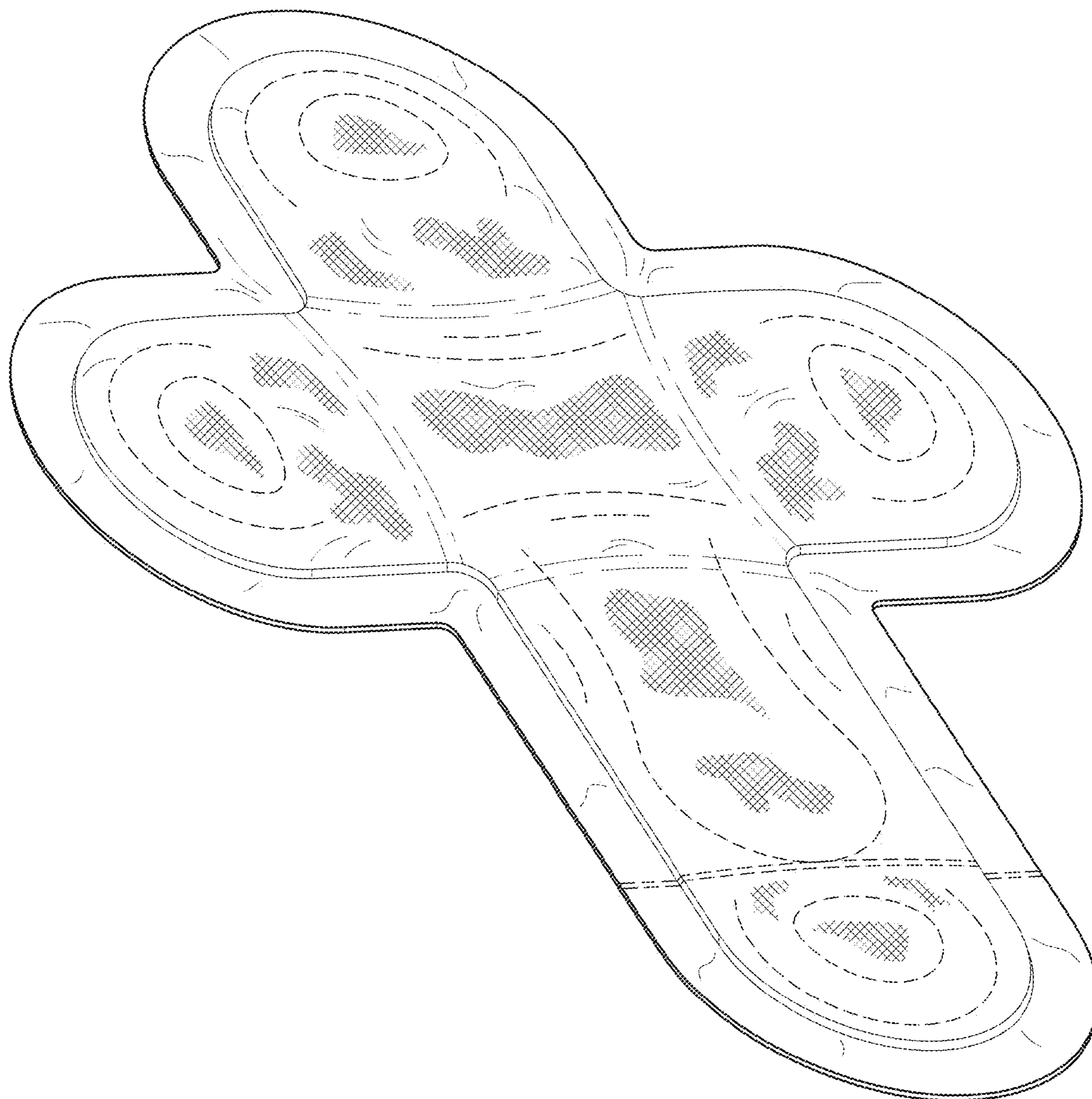
