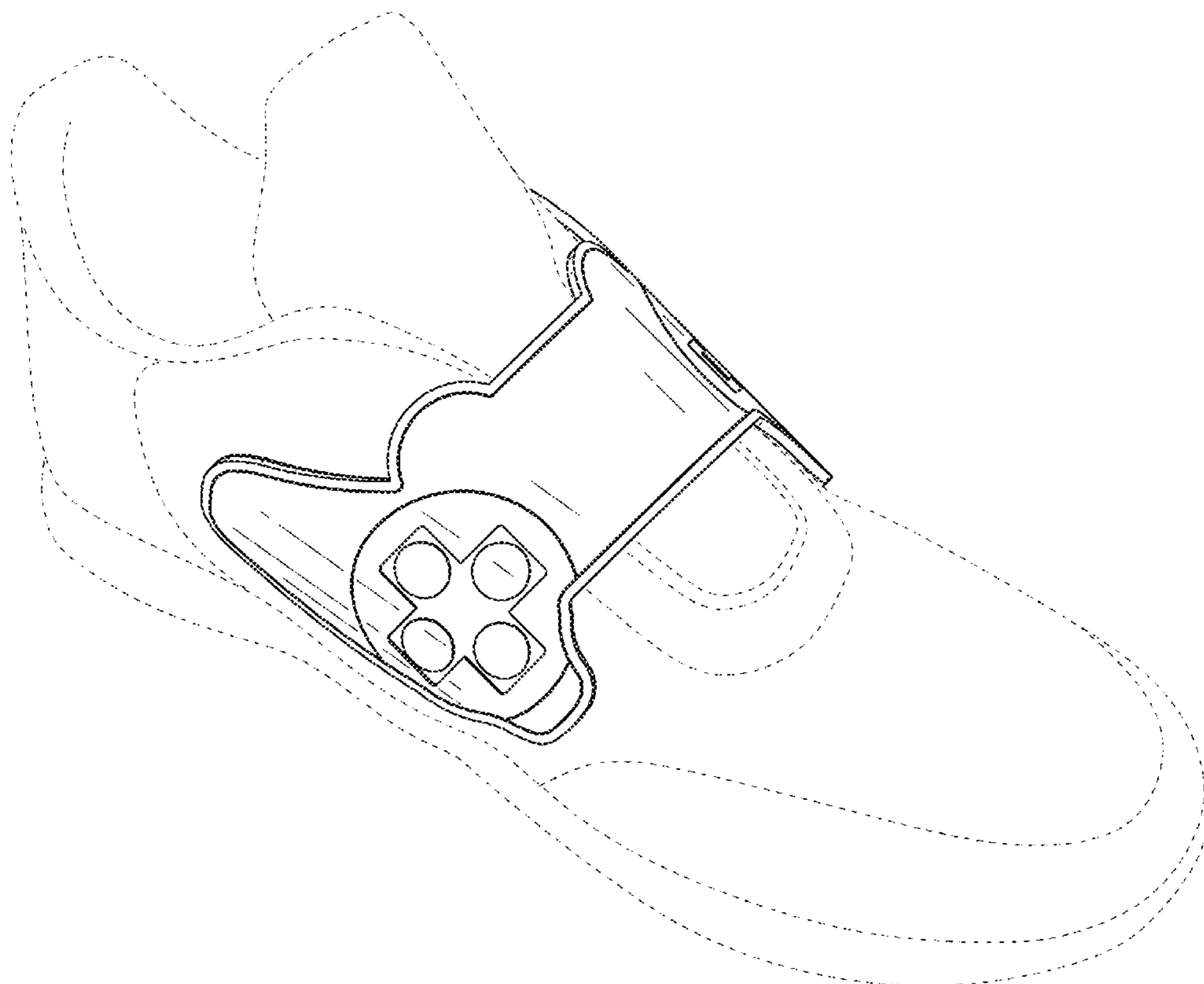
(57) **CLAIM**

The ornamental design for a shoe strap, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a shoe strap showing my new design;
FIG. 2 is a bottom perspective view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a left side elevation view thereof, the right side being a mirror image thereof;
FIG. 6 is front elevation view thereof;
FIG. 7 is rear elevation view thereof; and,
FIG. 8 is a perspective view thereof, shown in use.

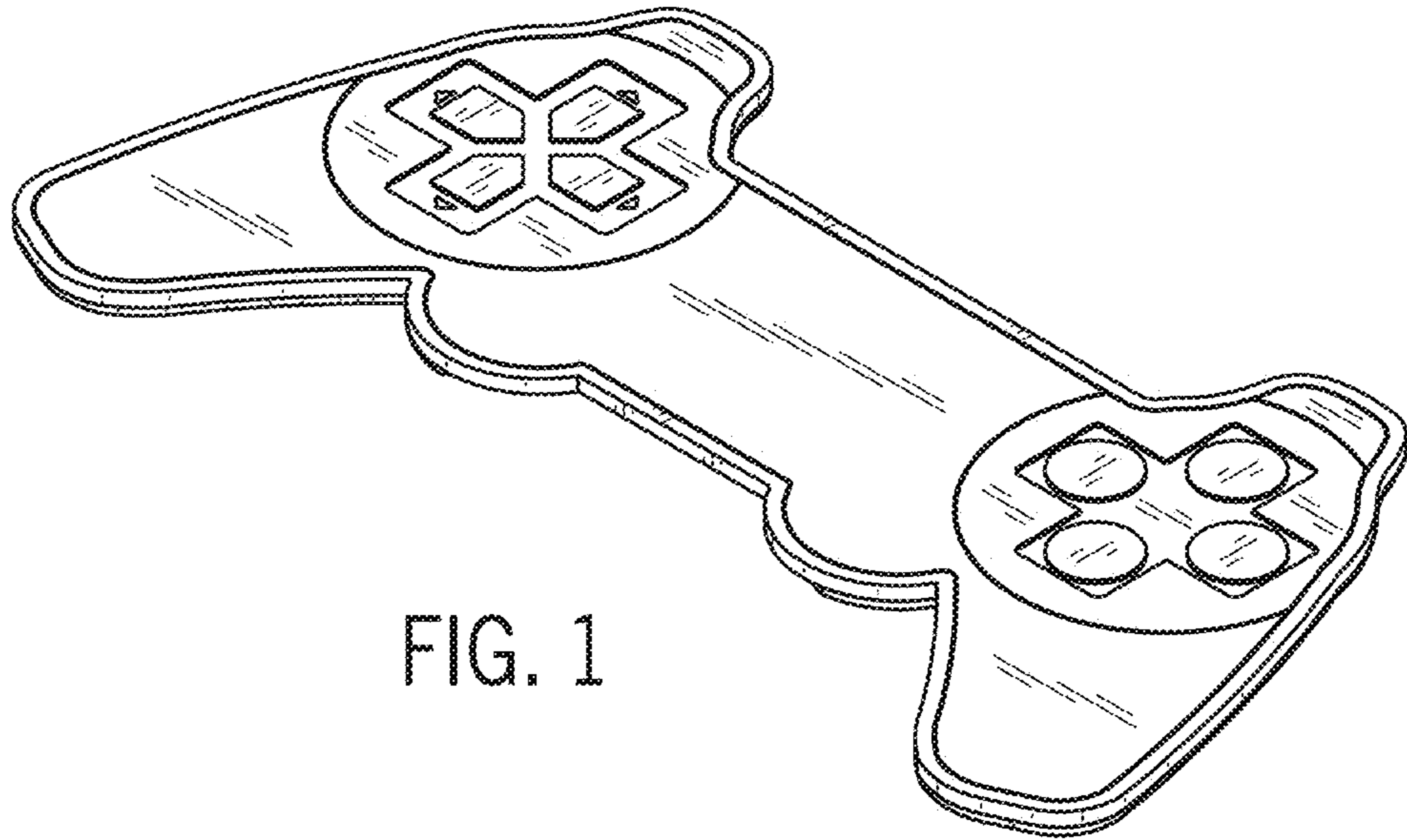

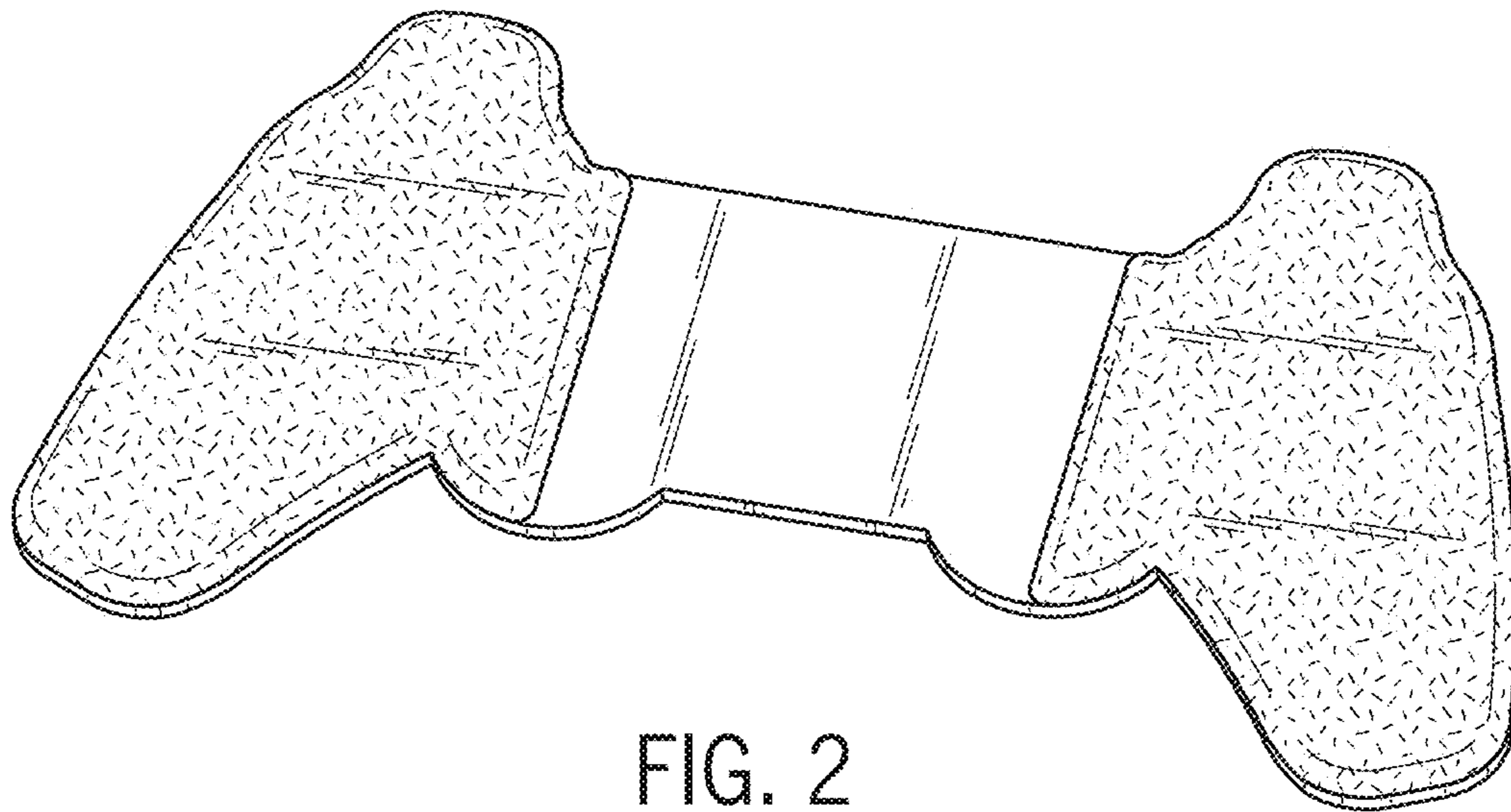

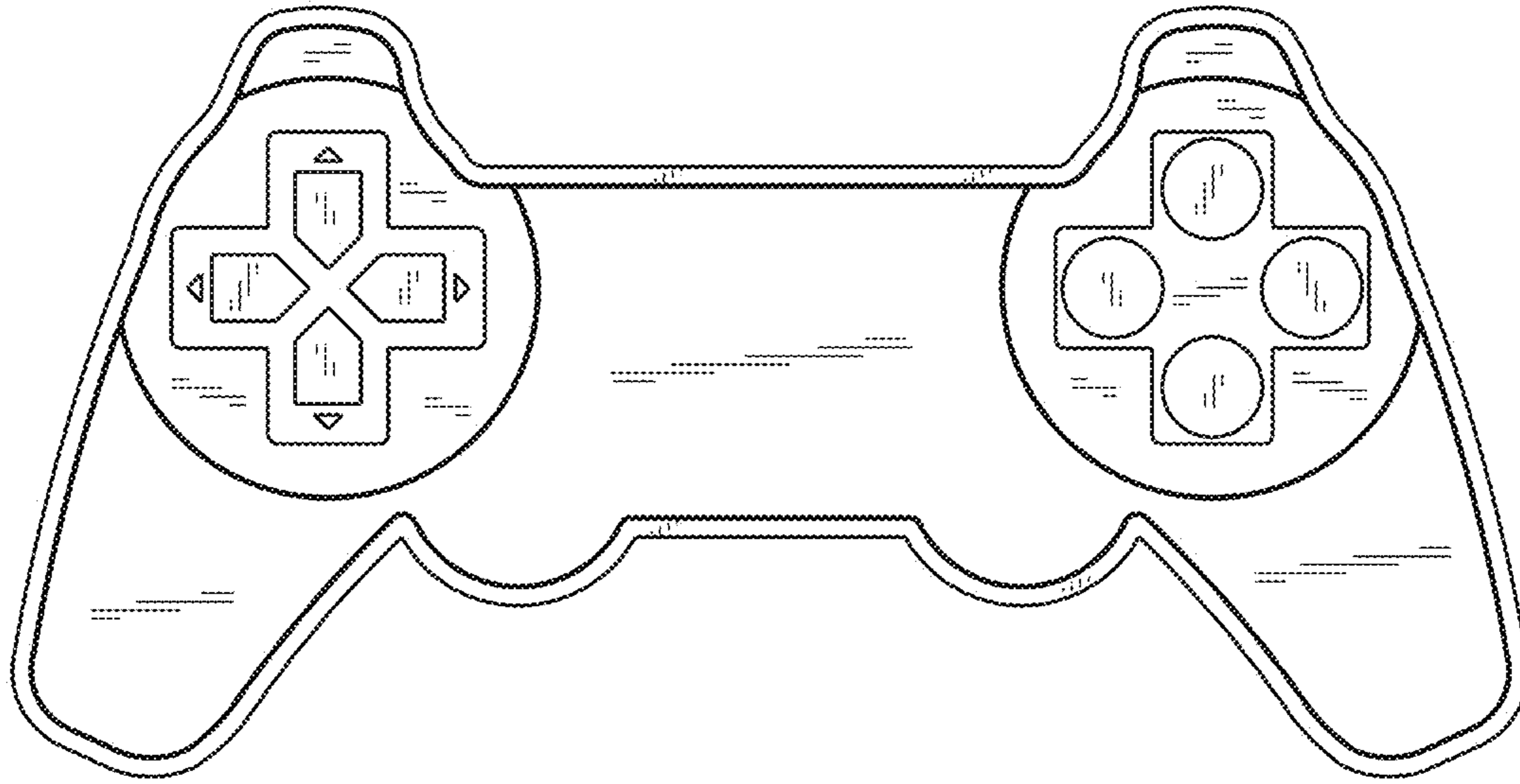

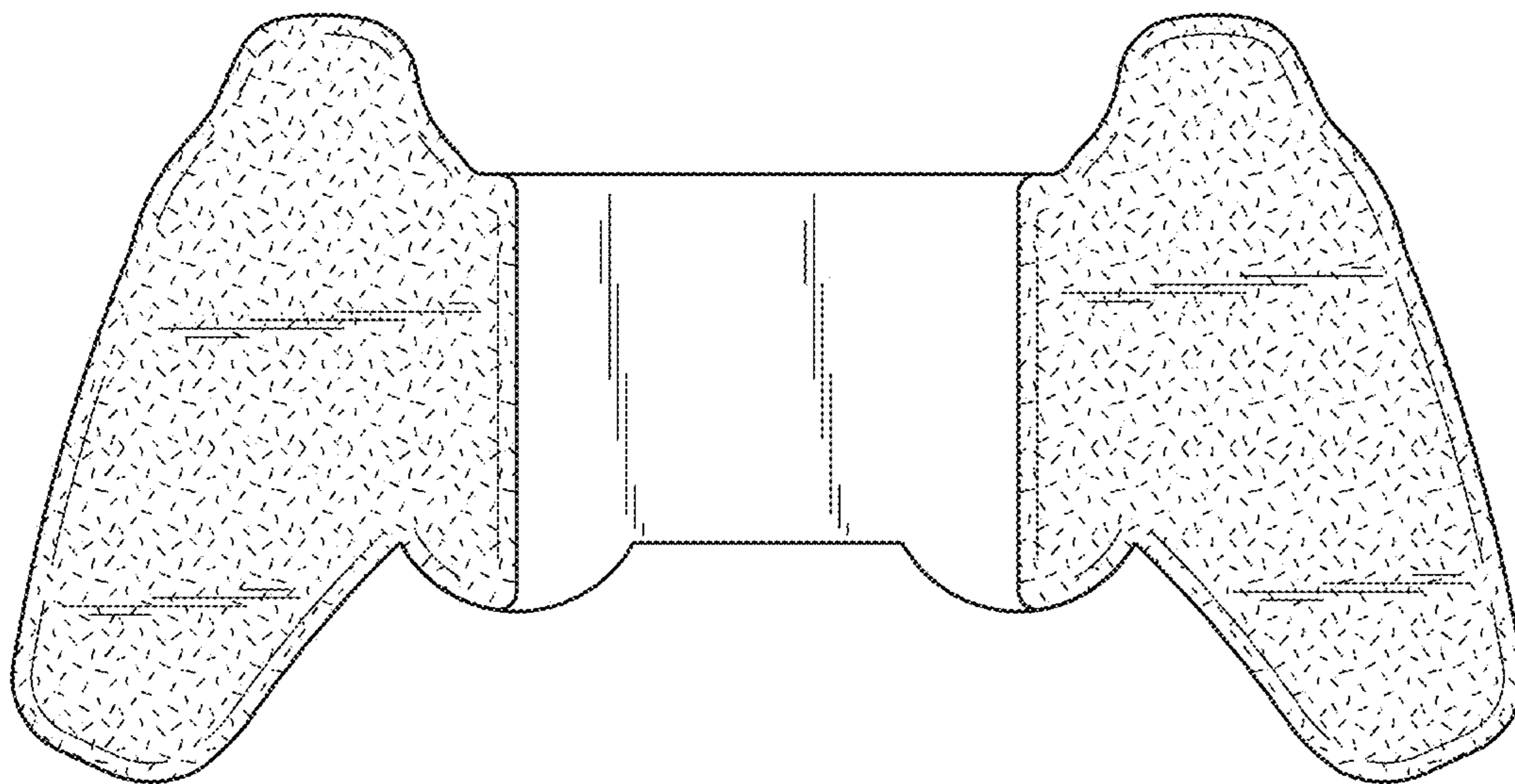

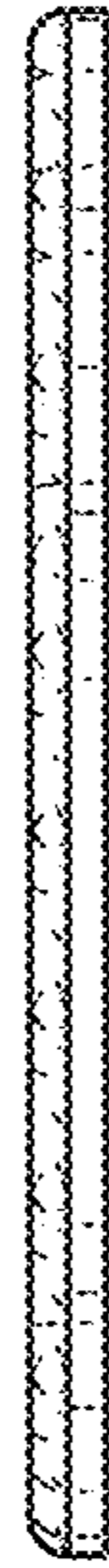

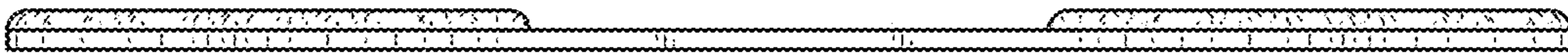
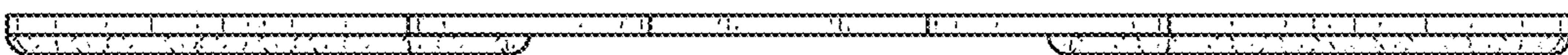

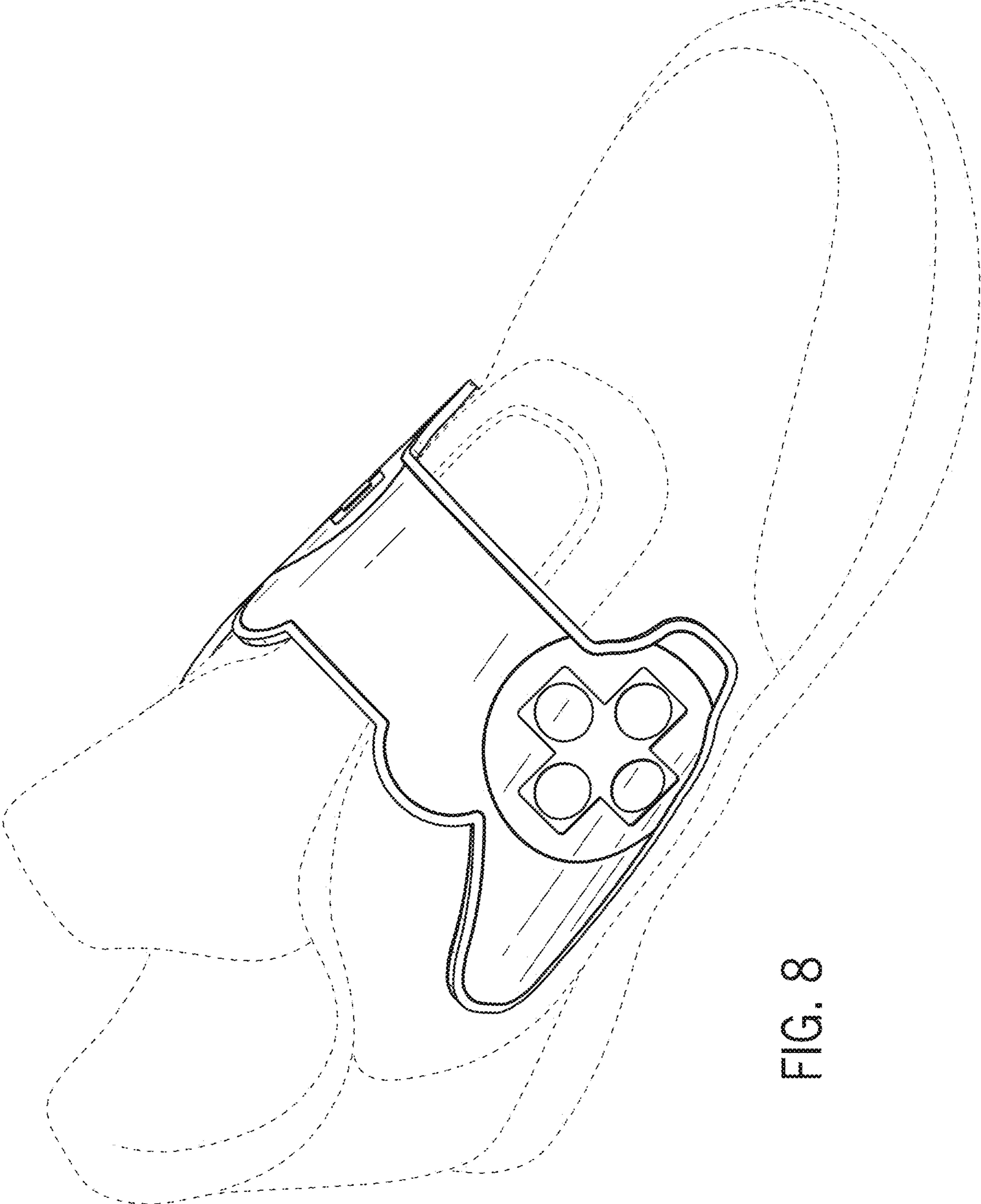
