(57) **CLAIM**

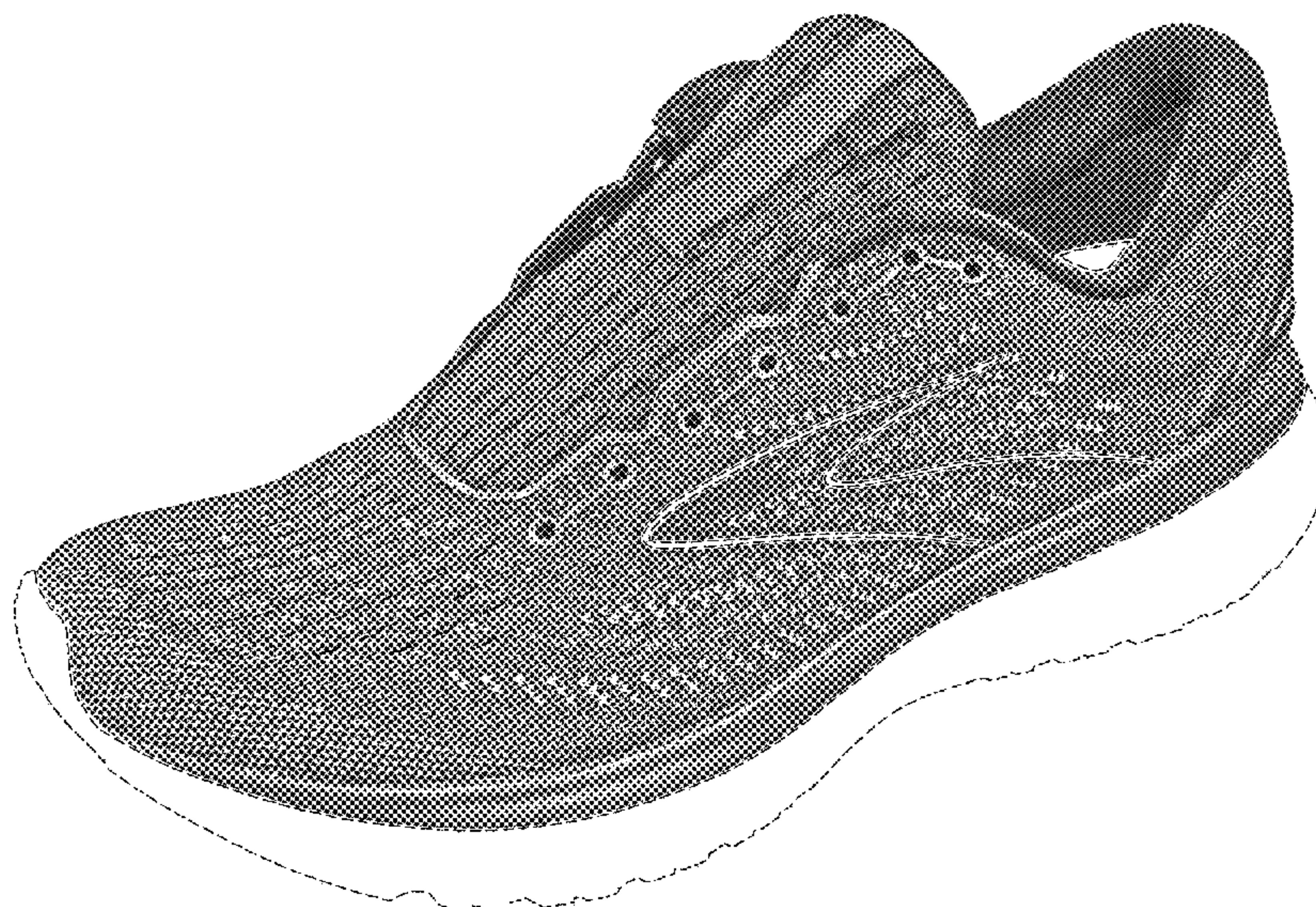
The ornamental design for a shoe upper portion and mid-portion, as shown and described.

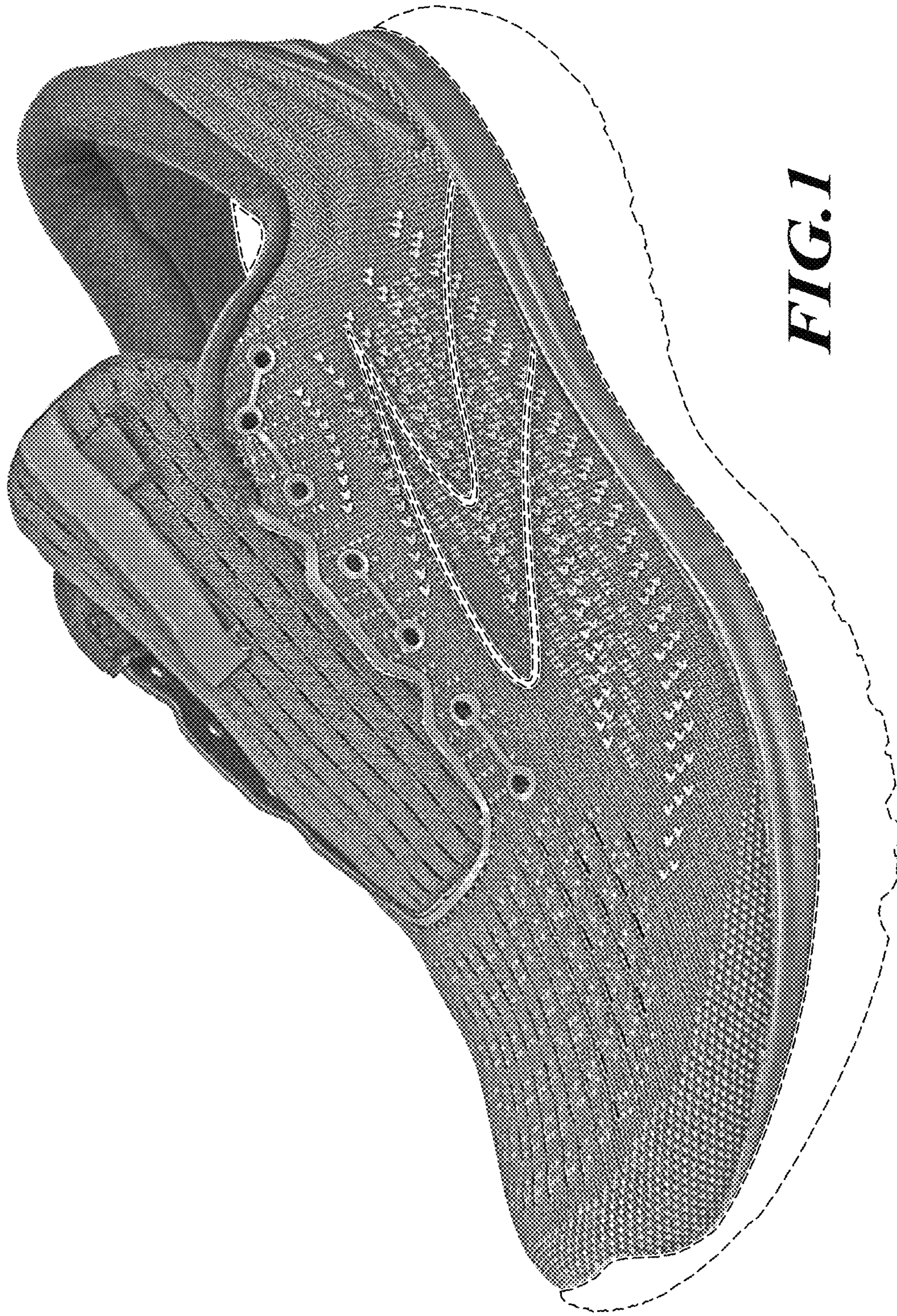

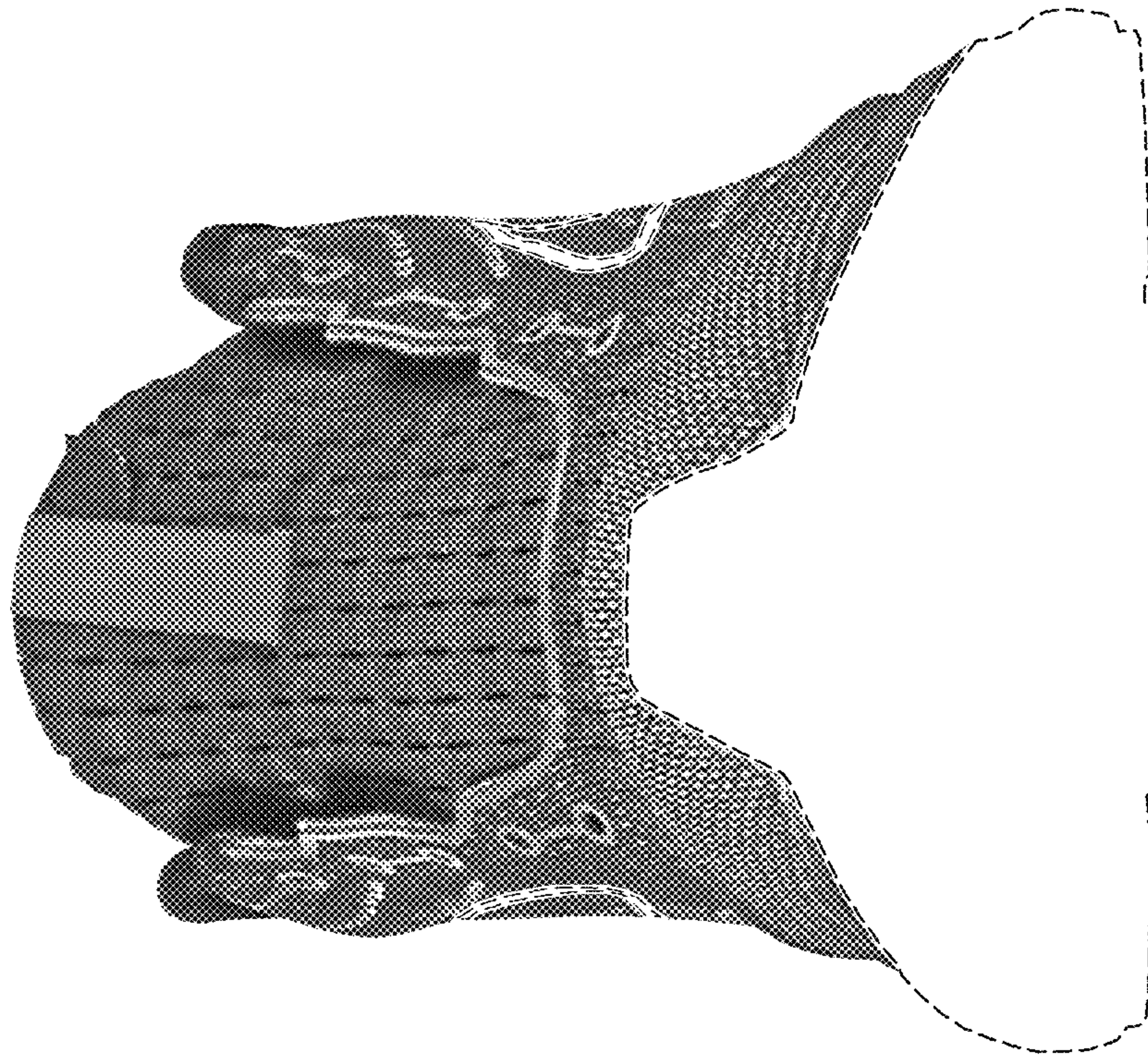

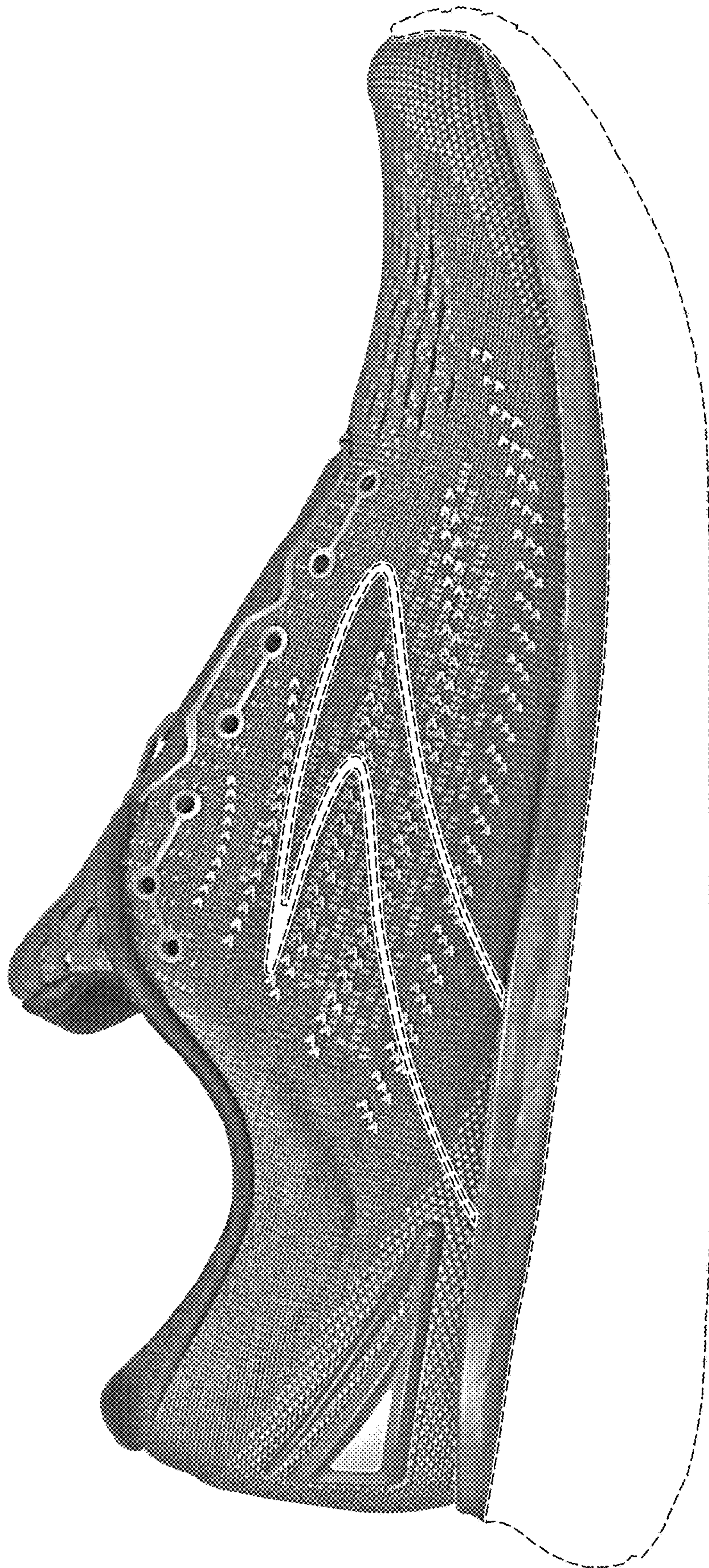

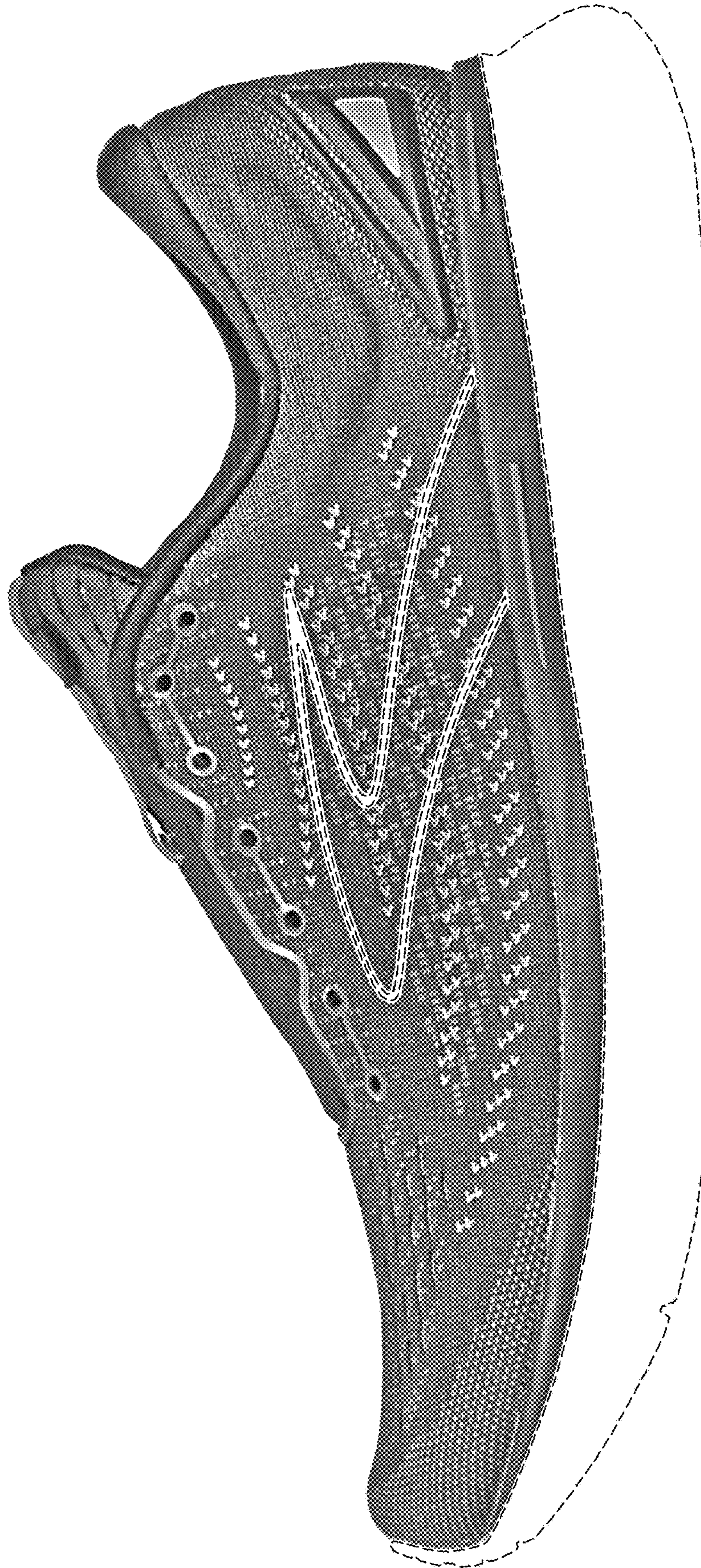

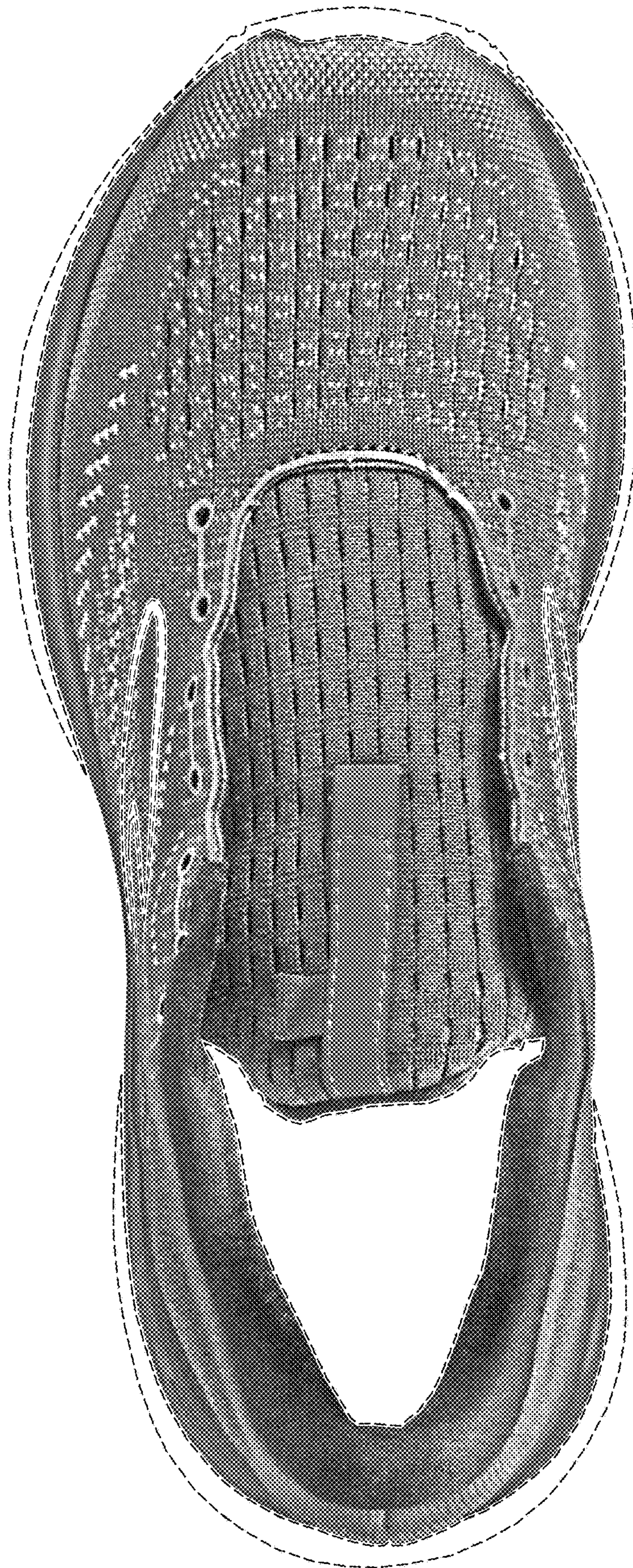
