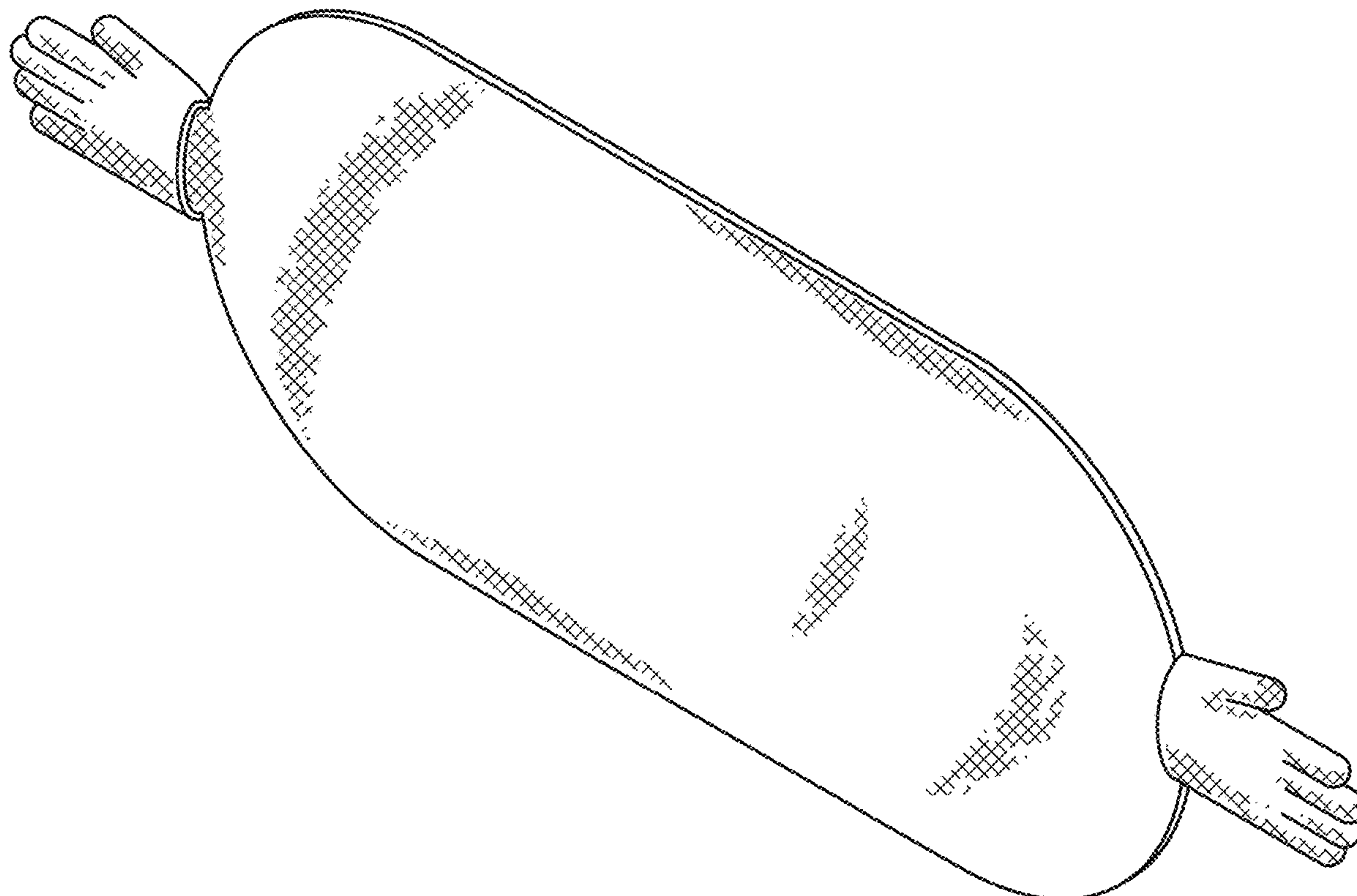
The ornamental design for a towel, as shown and described.

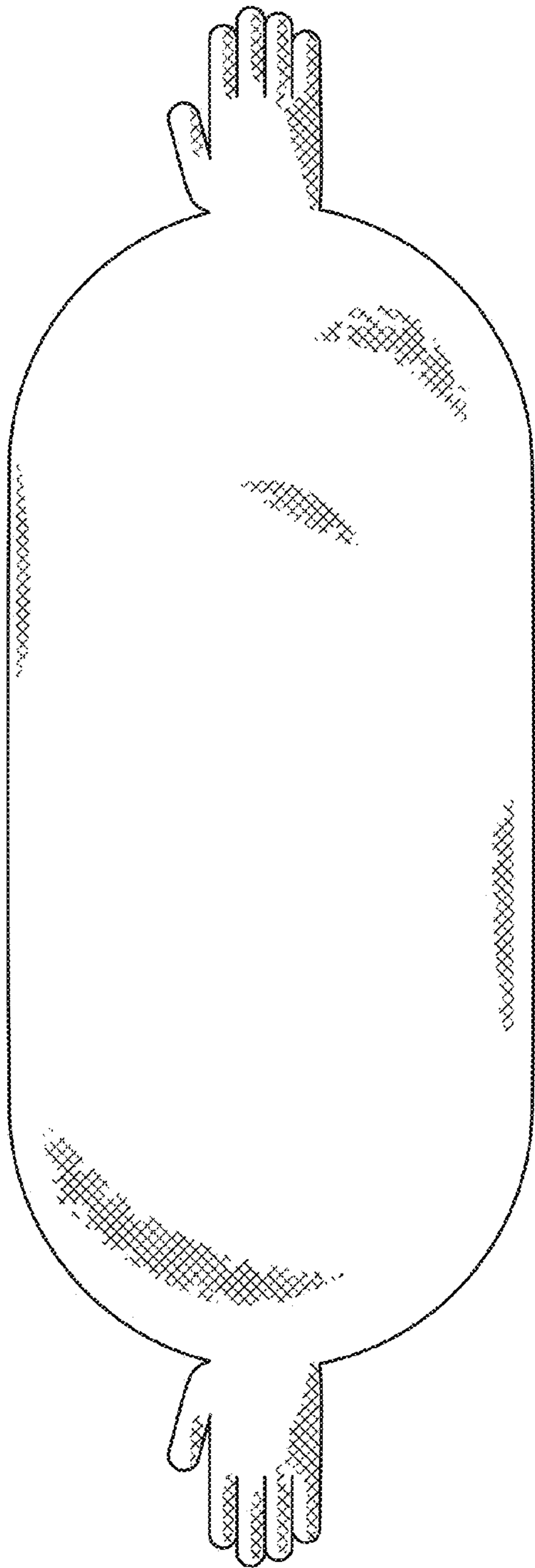

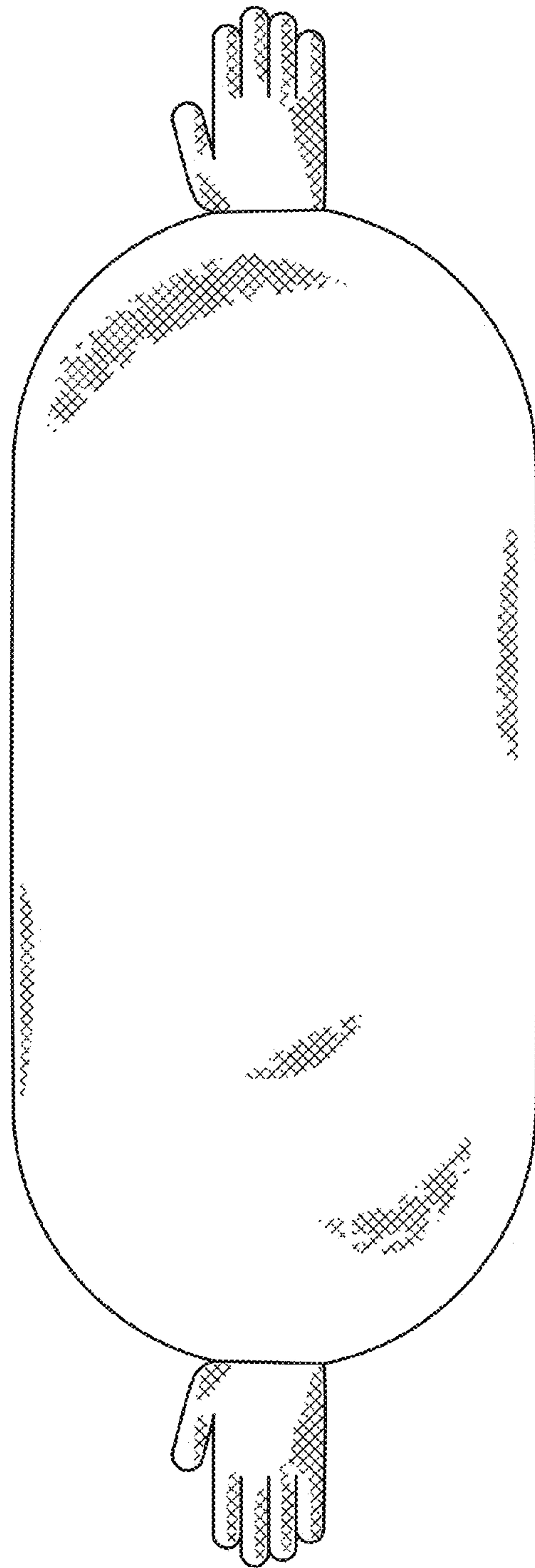

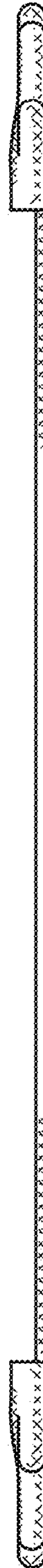

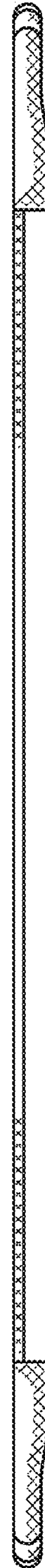

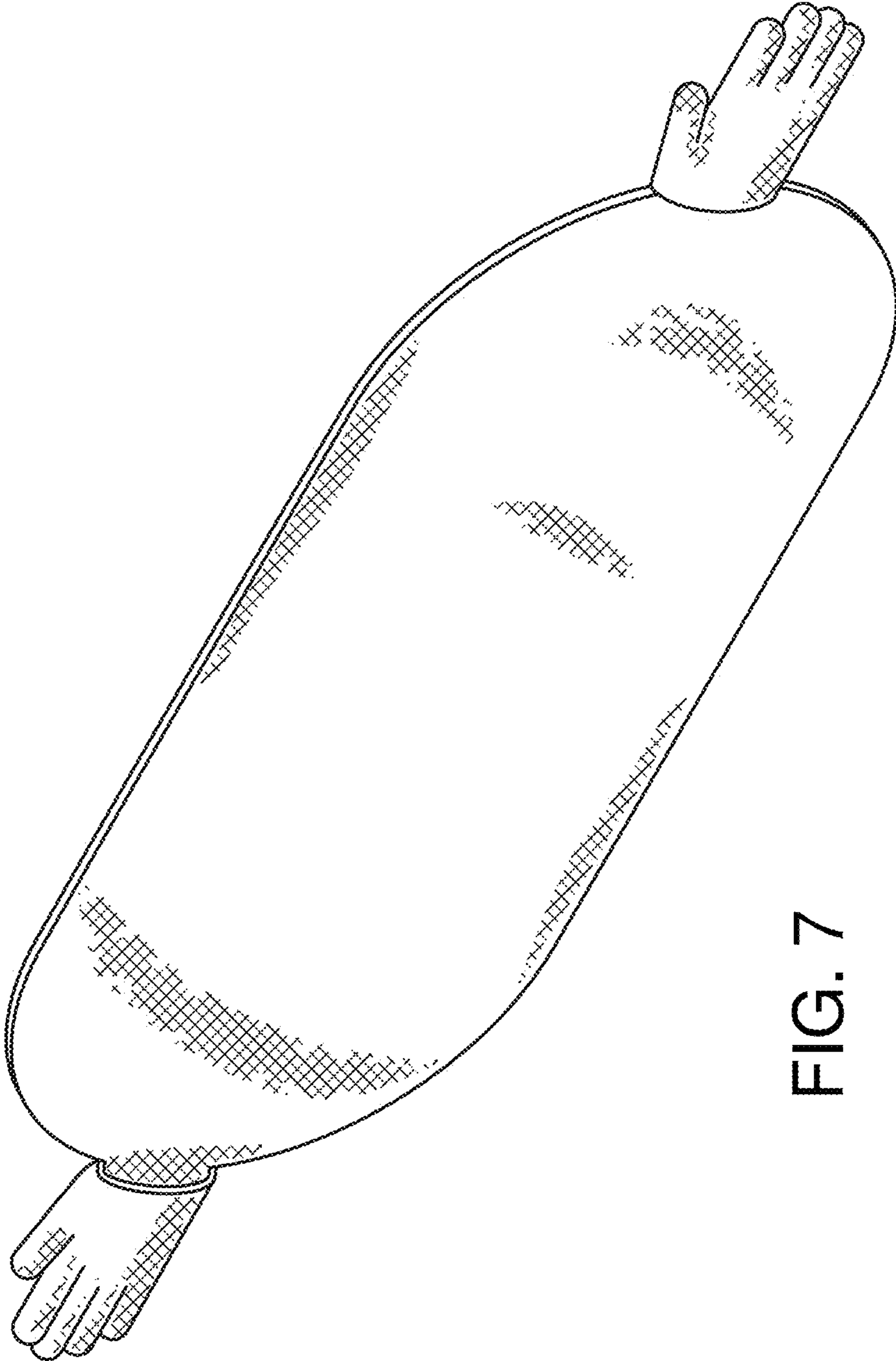
