DESCRIPTION

FIG. 1 is a perspective view of a water pitcher showing our new design.

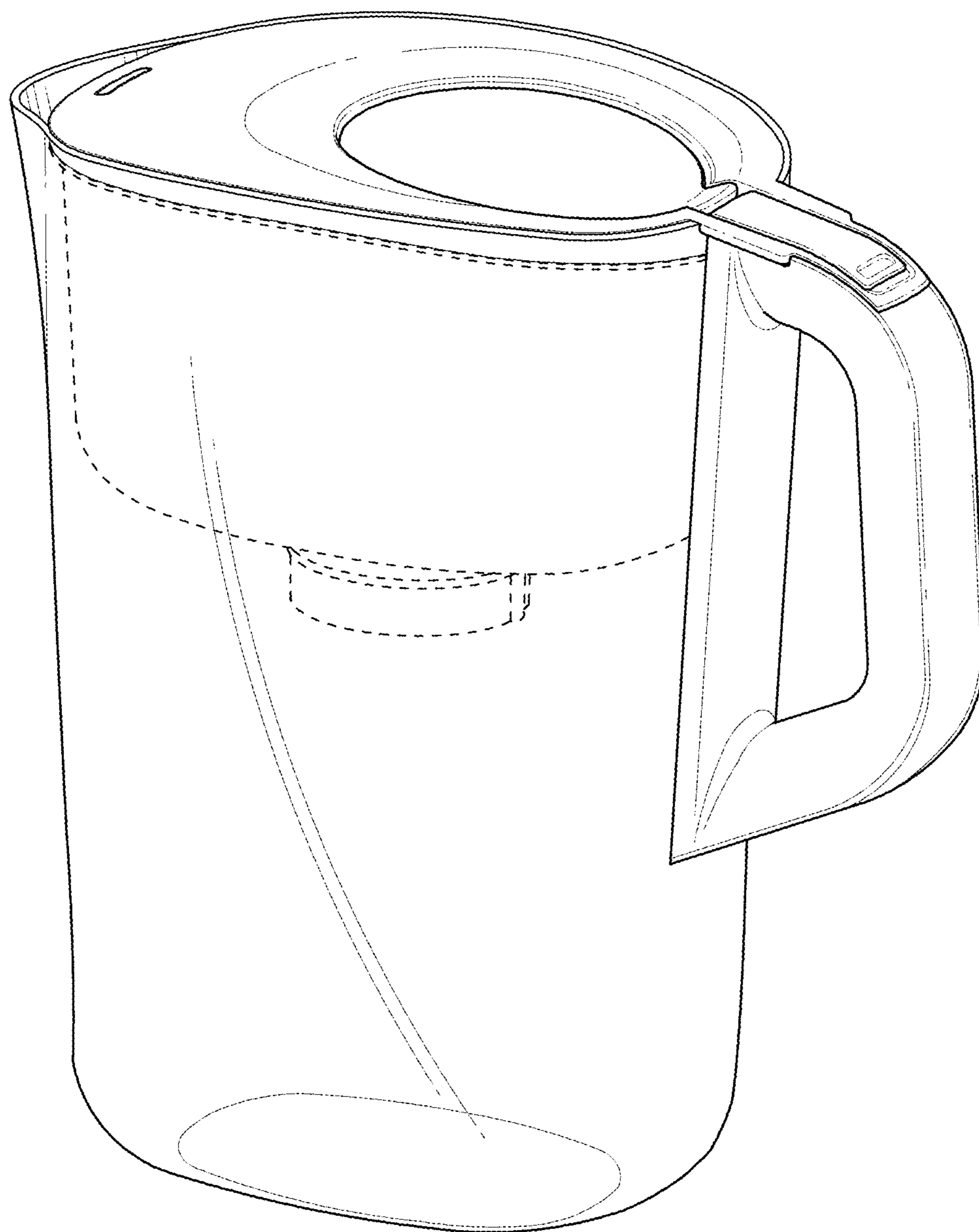

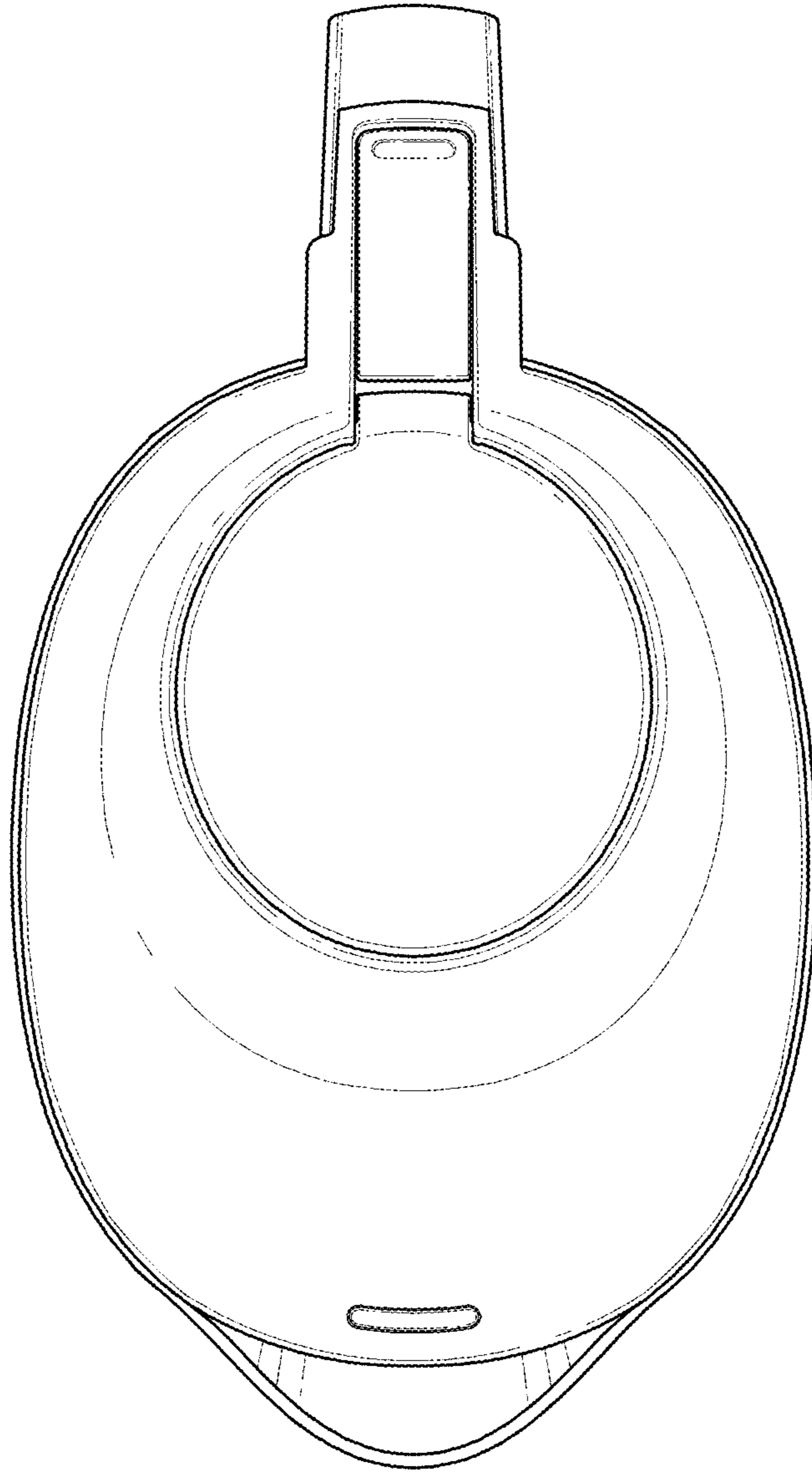

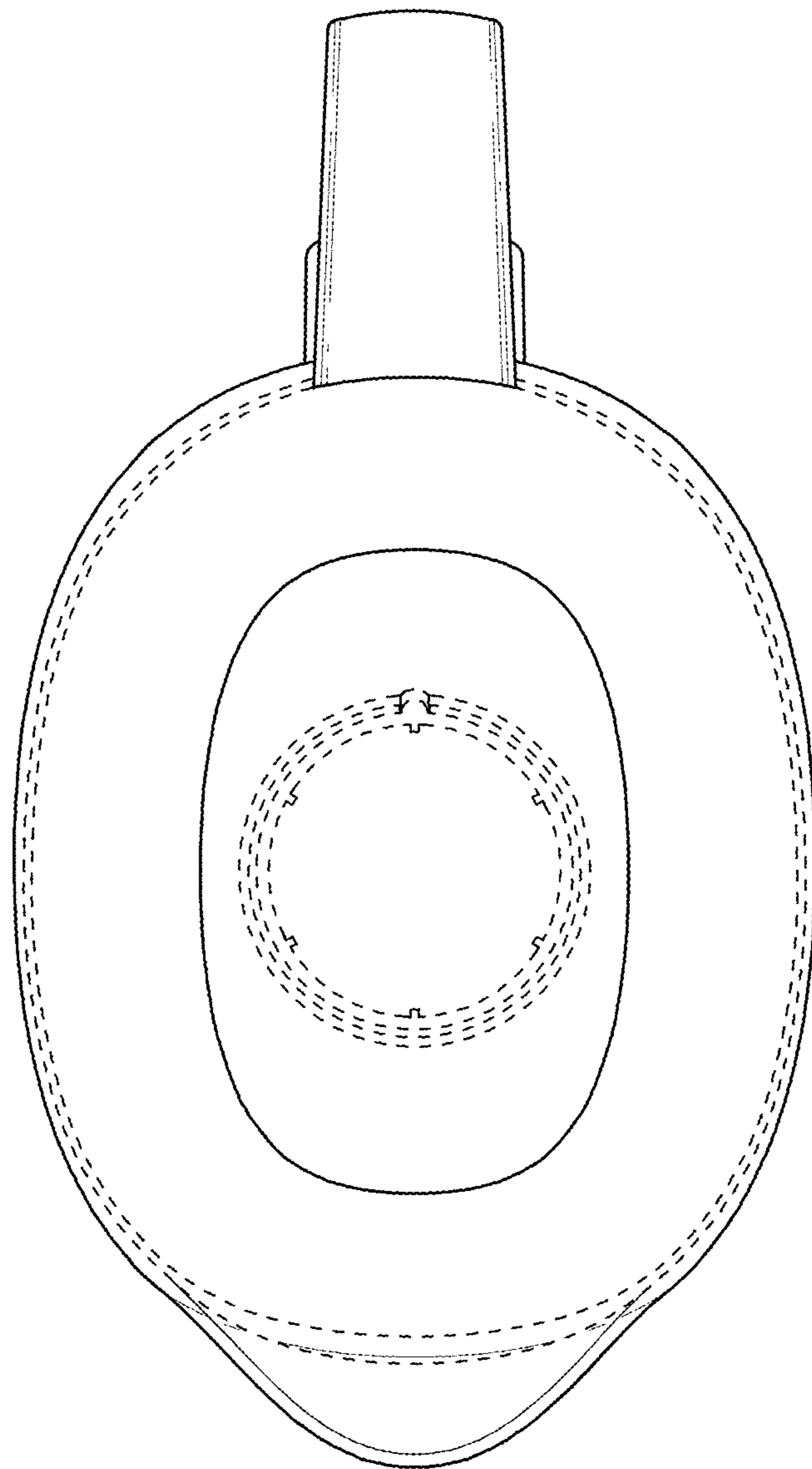

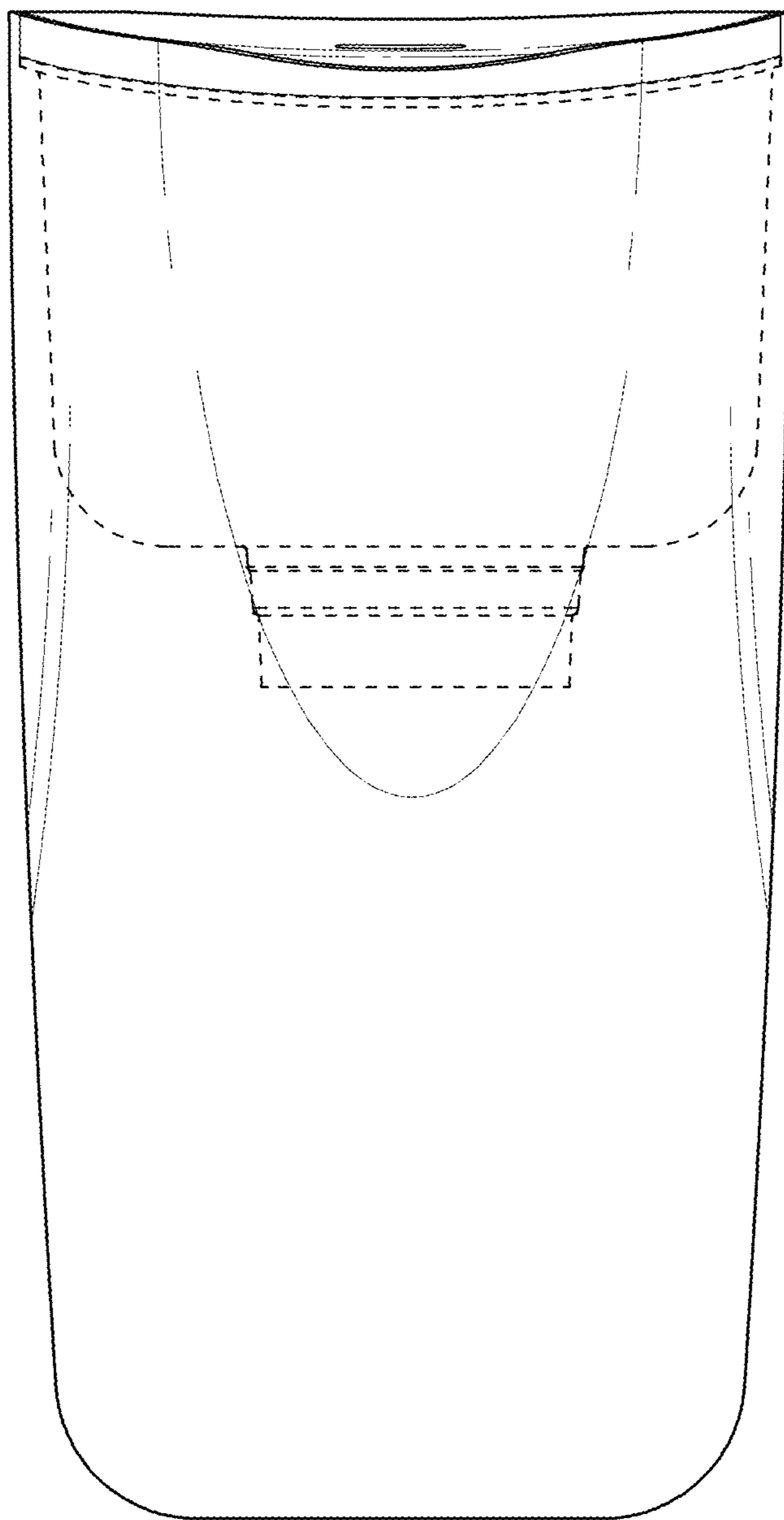

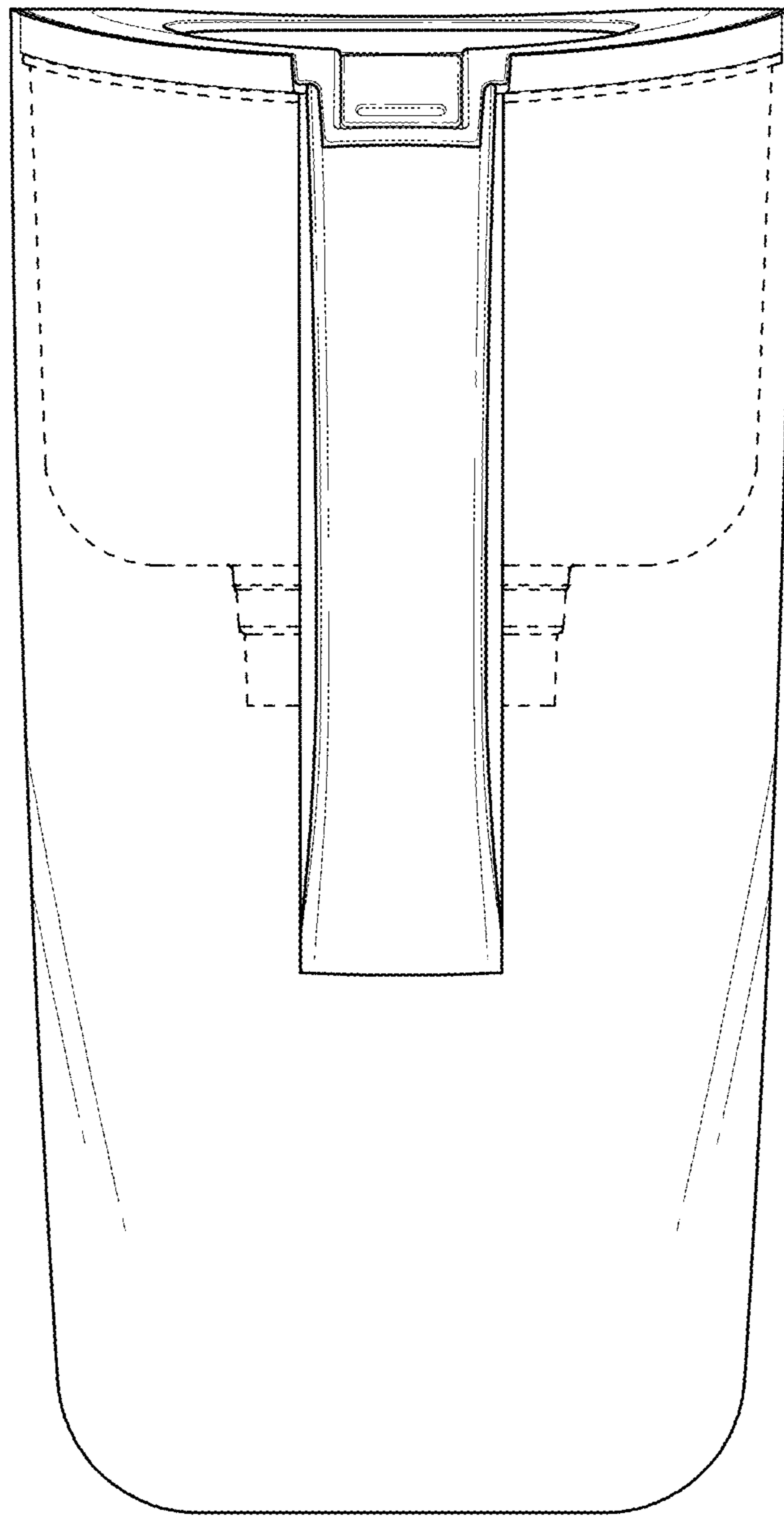
