(57) **CLAIM**

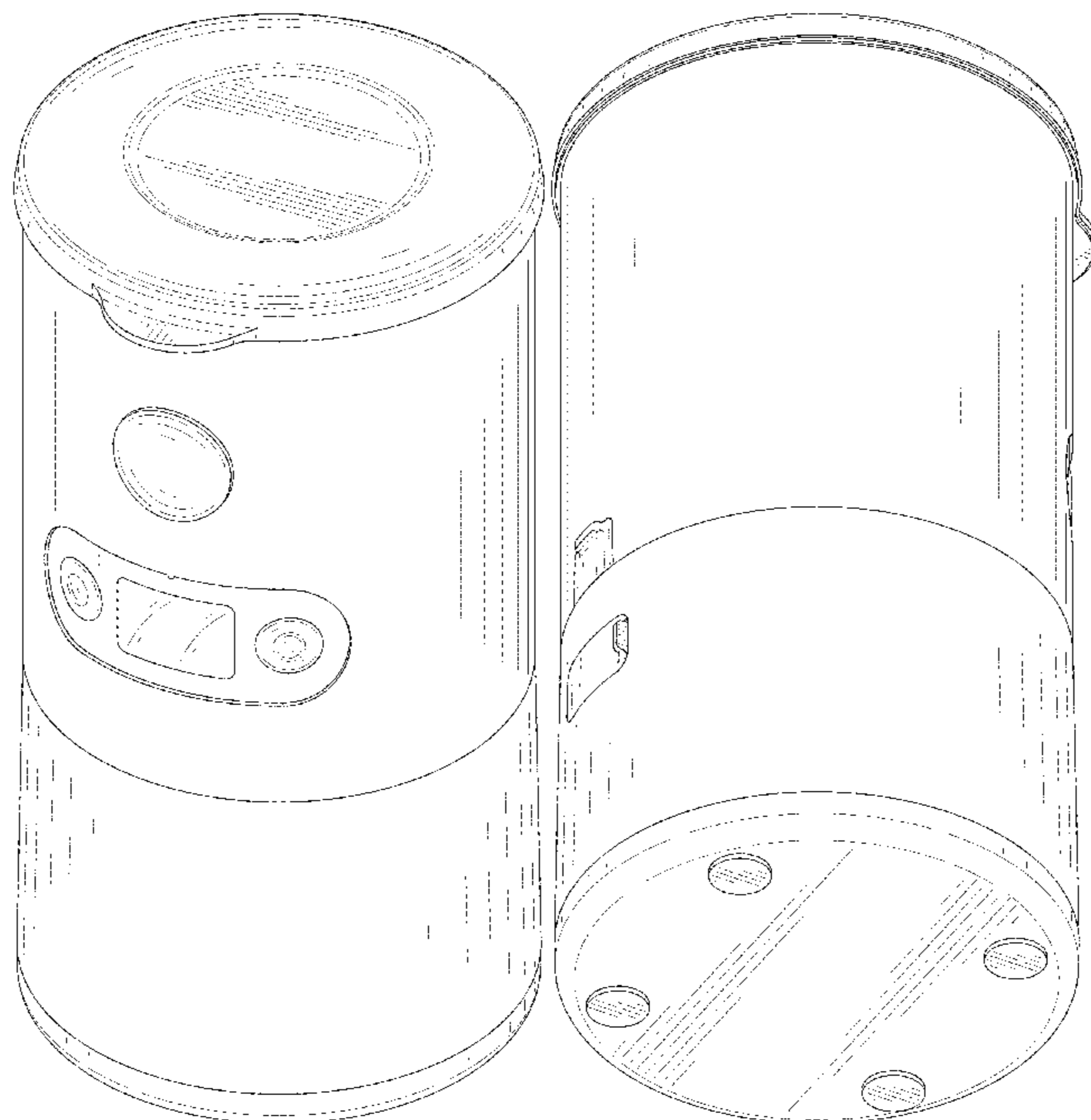
The ornamental design for a bottle warmer, as shown and described.

DESCRIPTION

FIG. 1 is a front, right, and top perspective view of a bottle warmer, showing my design.

 FIG. 5 is a left side elevation view thereof.

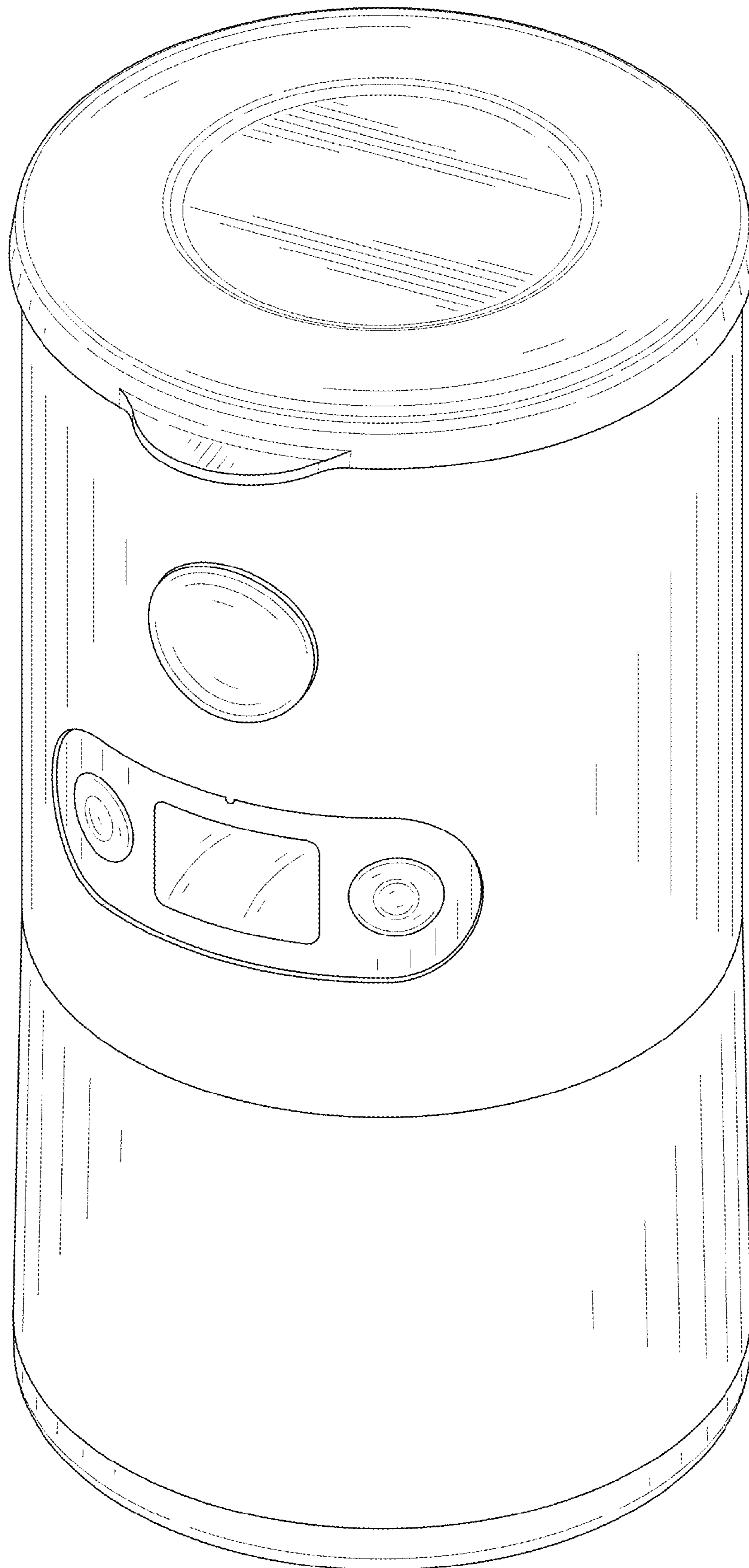

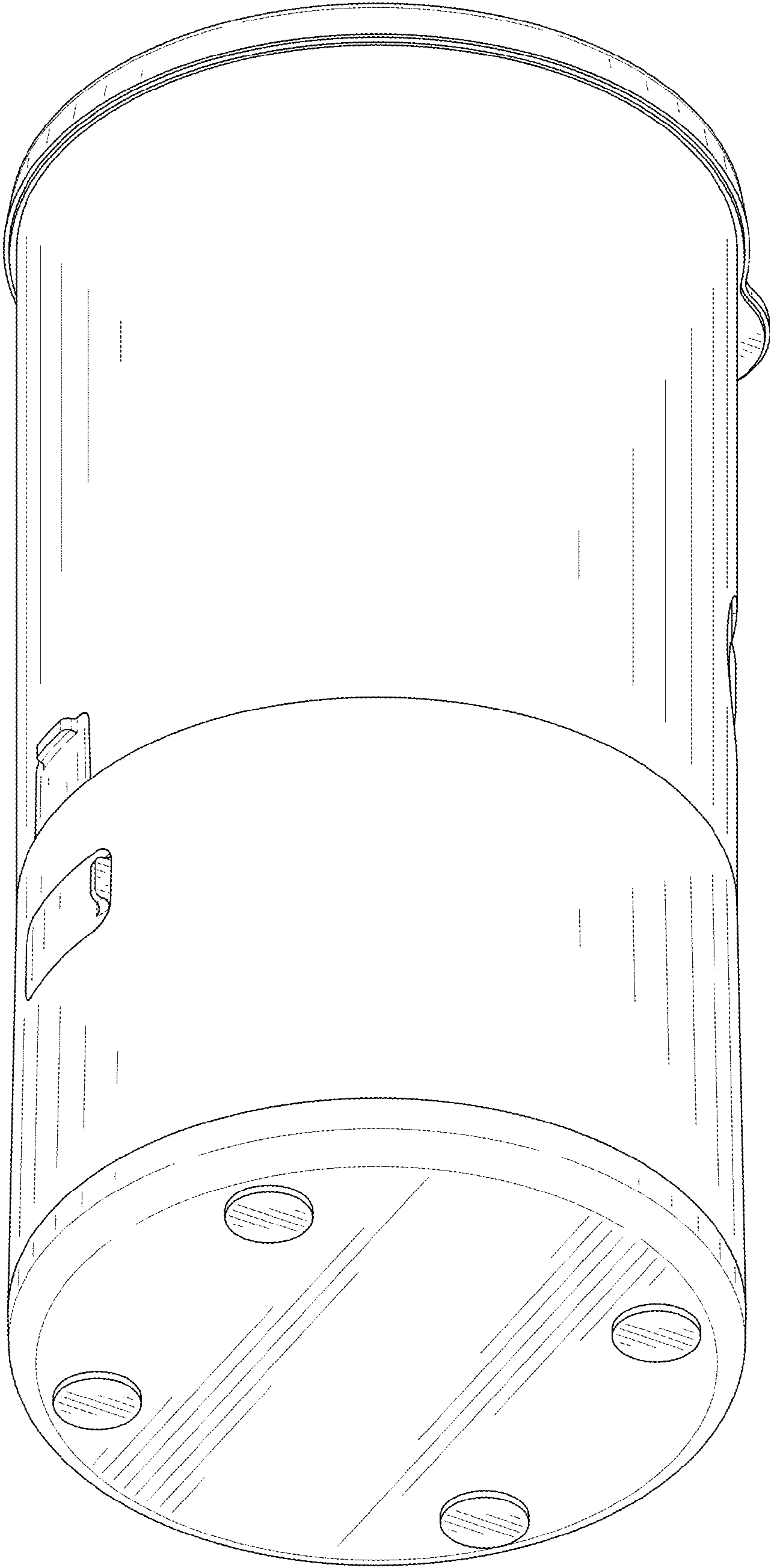

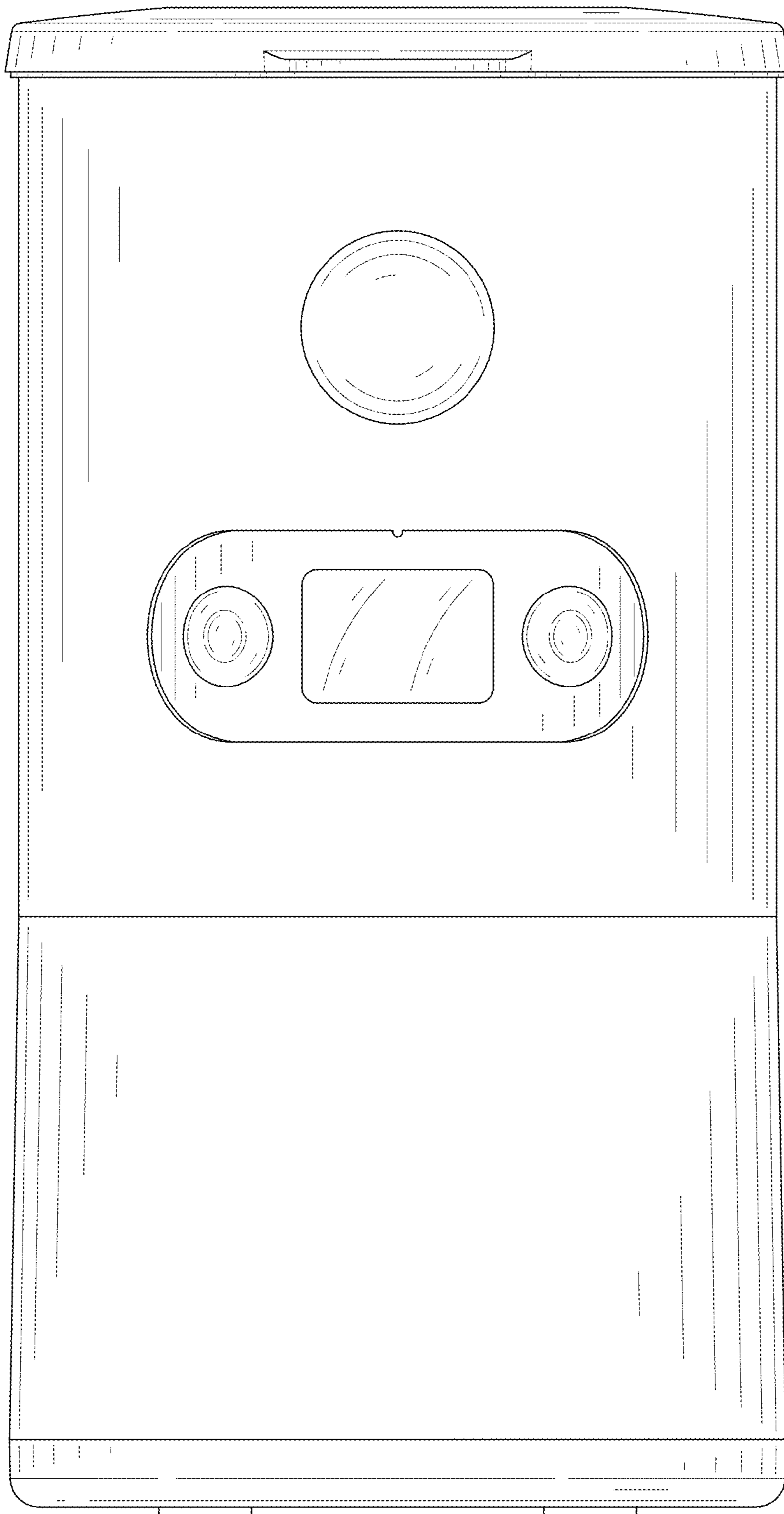

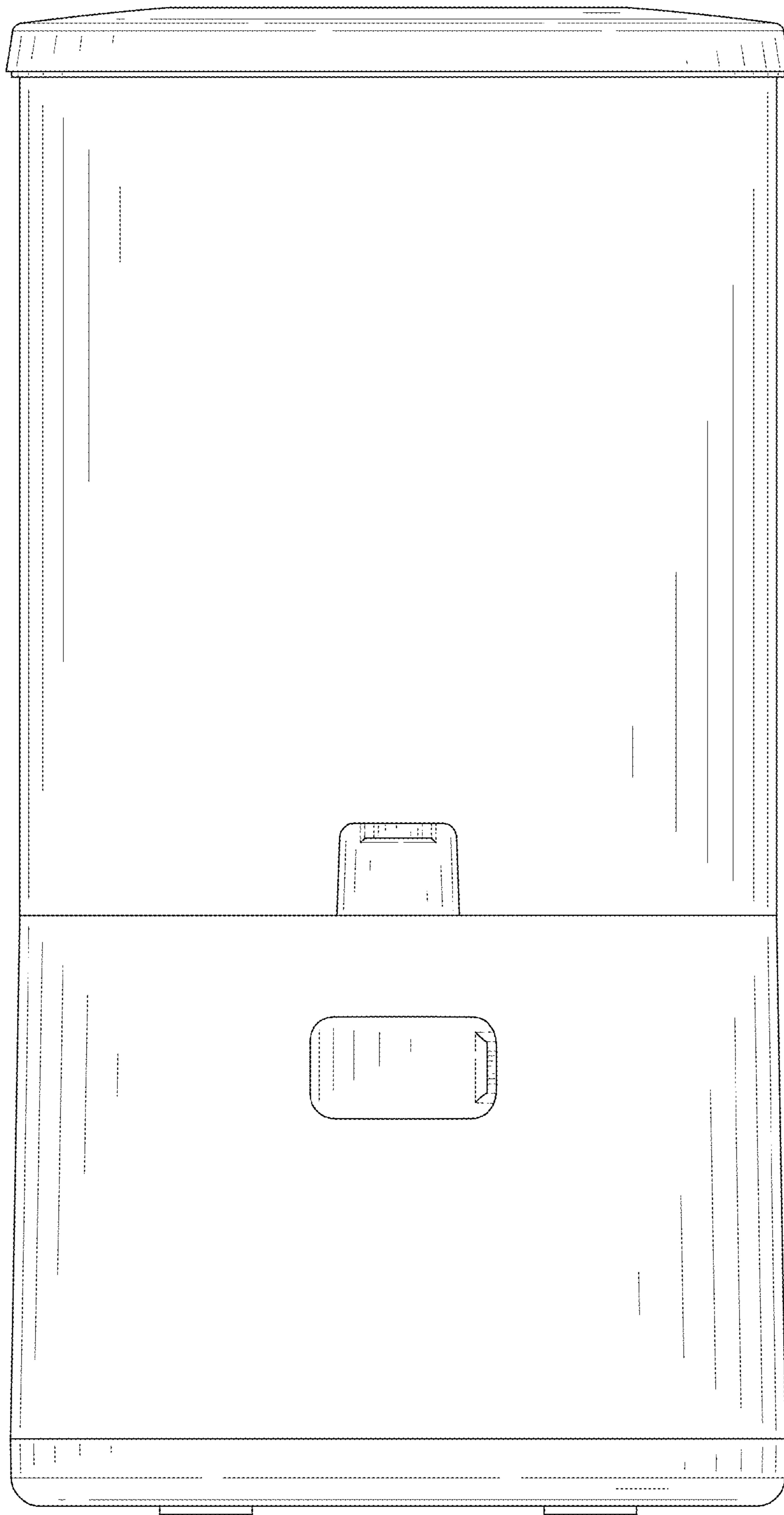

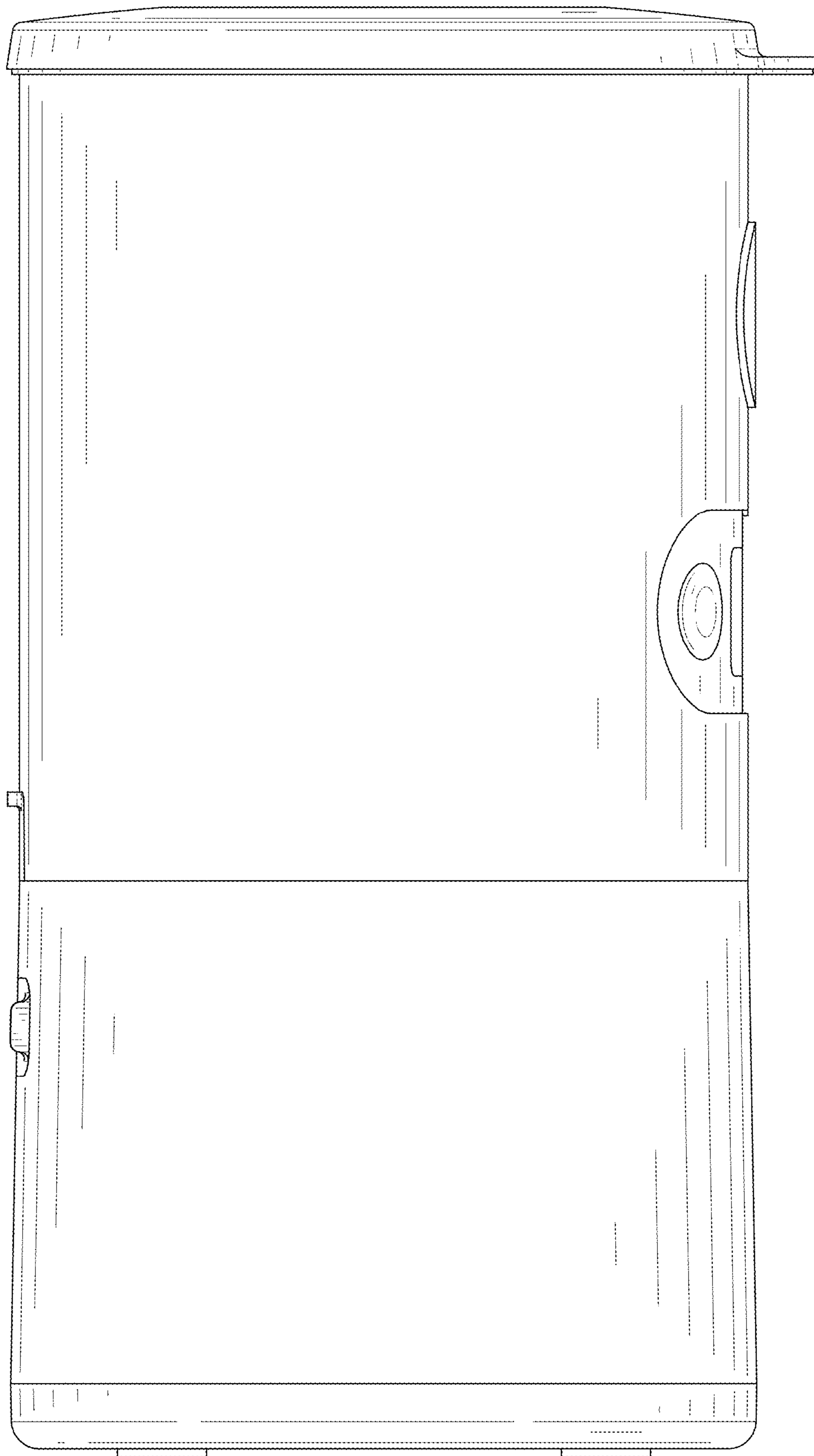

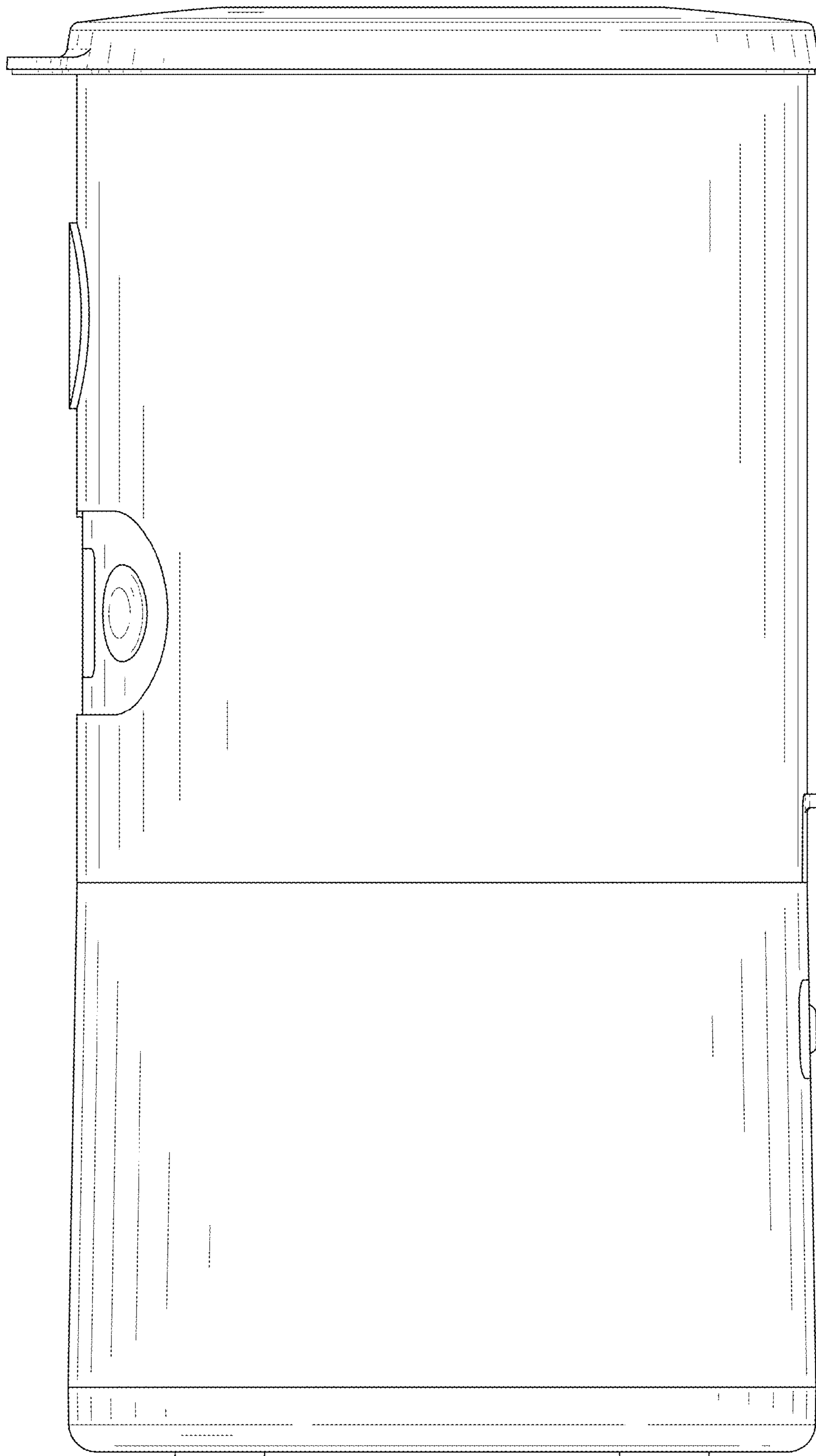

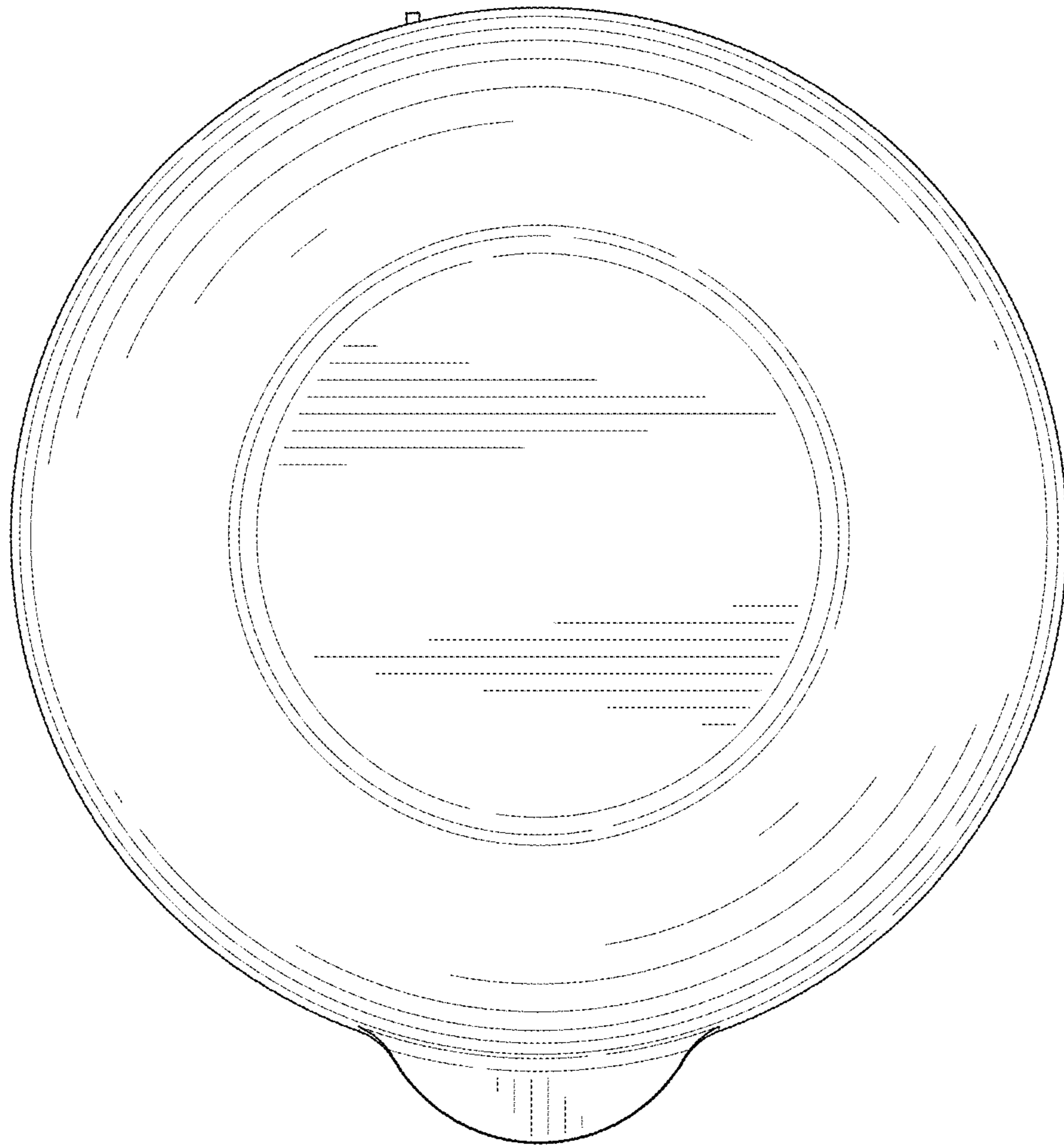

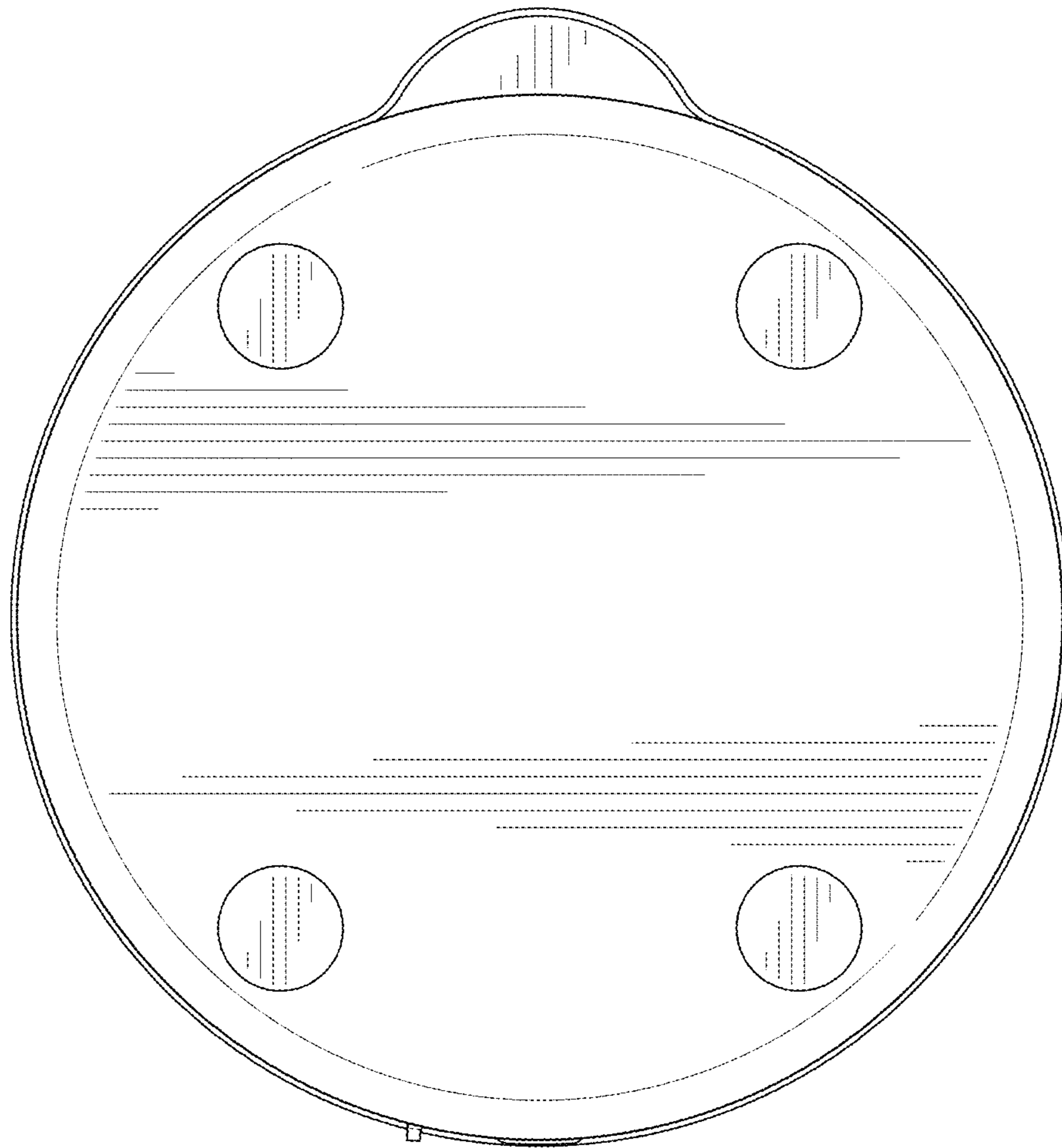

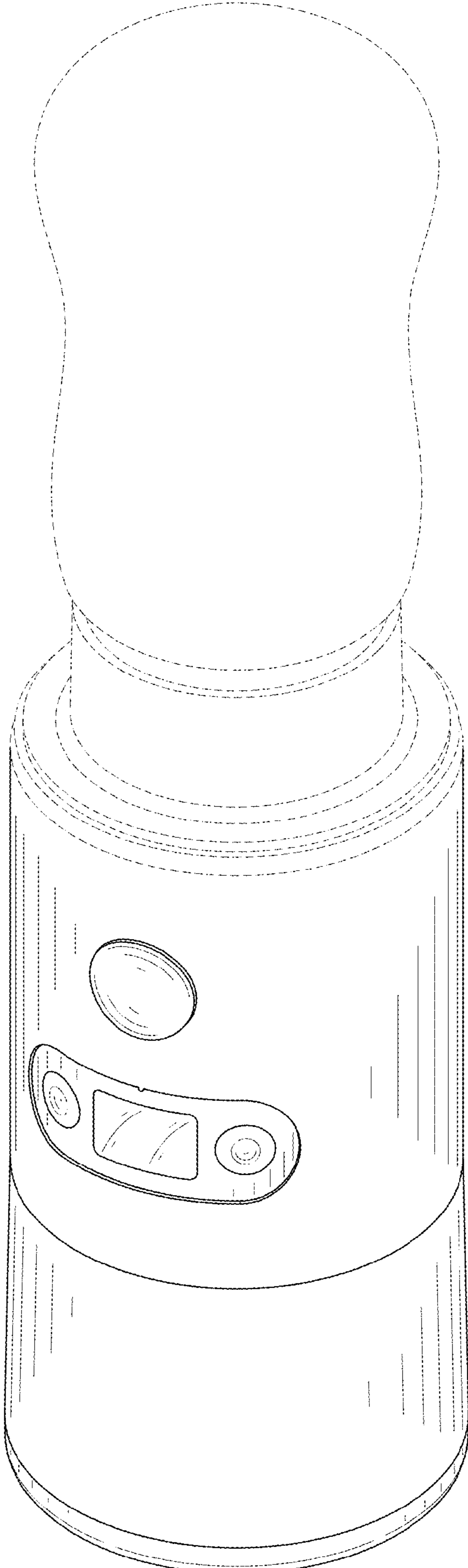
