FIG. 8 sipper is an exploded view of the cereal sipper showing the inner cup separated from the outer cup.

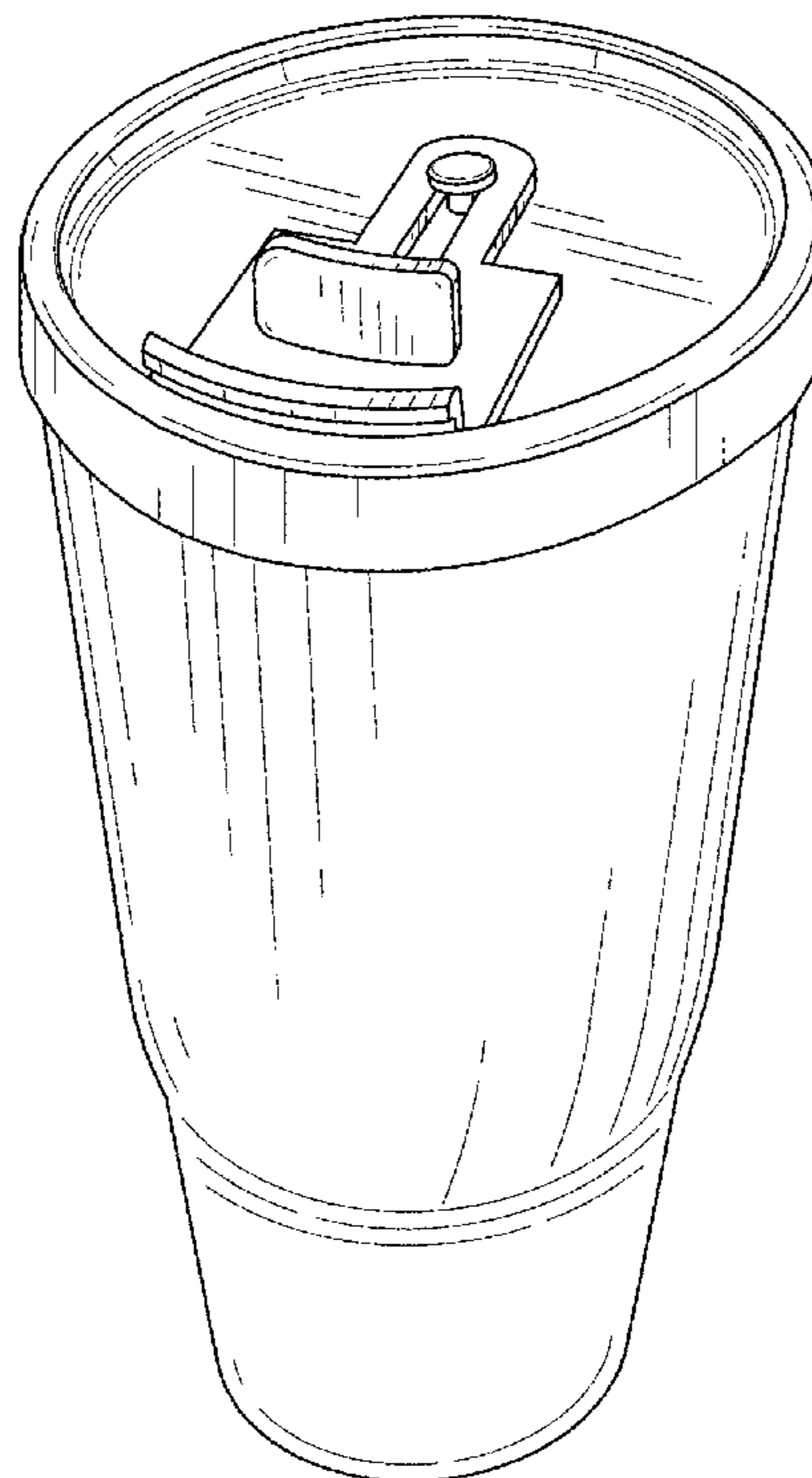

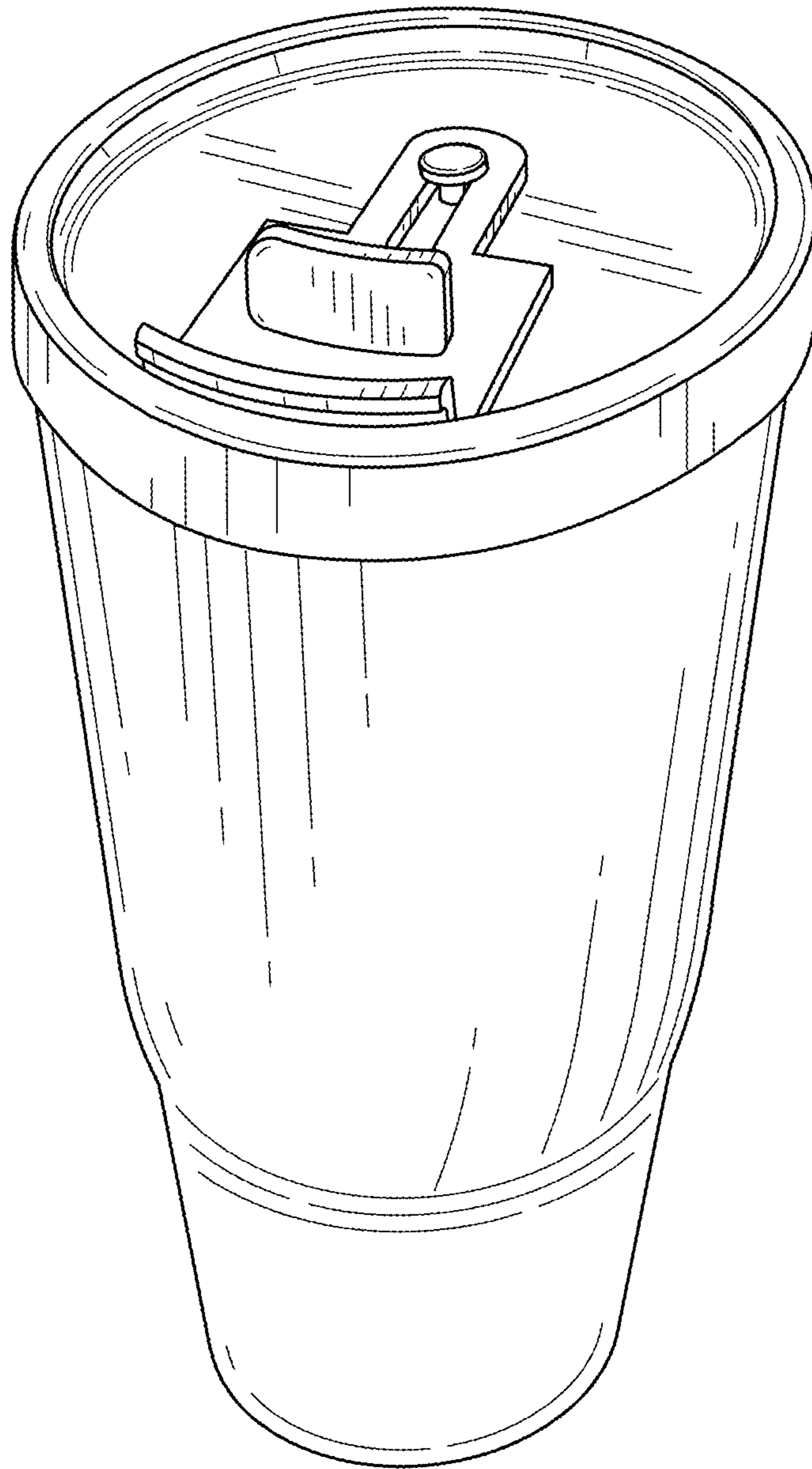

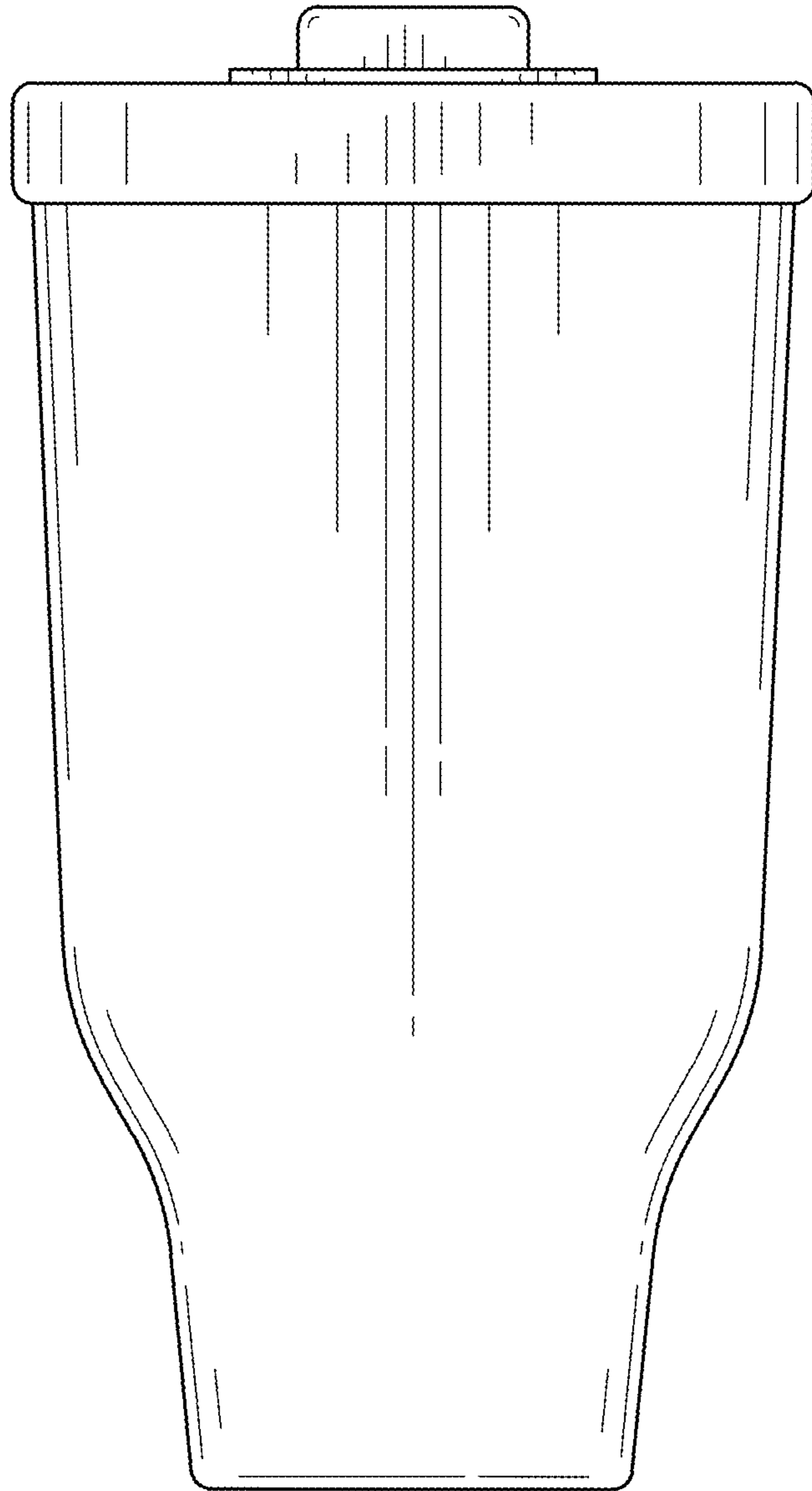

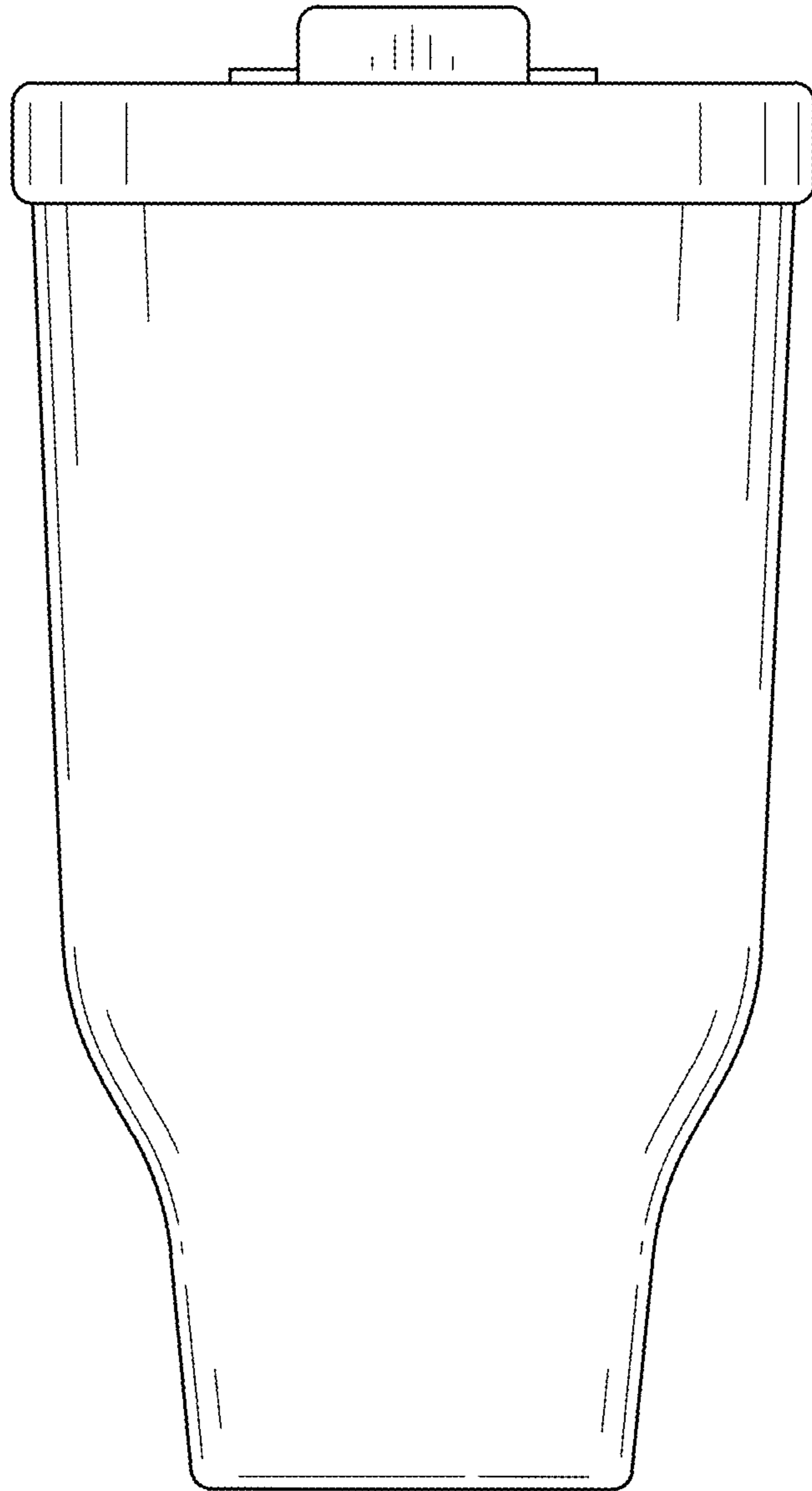

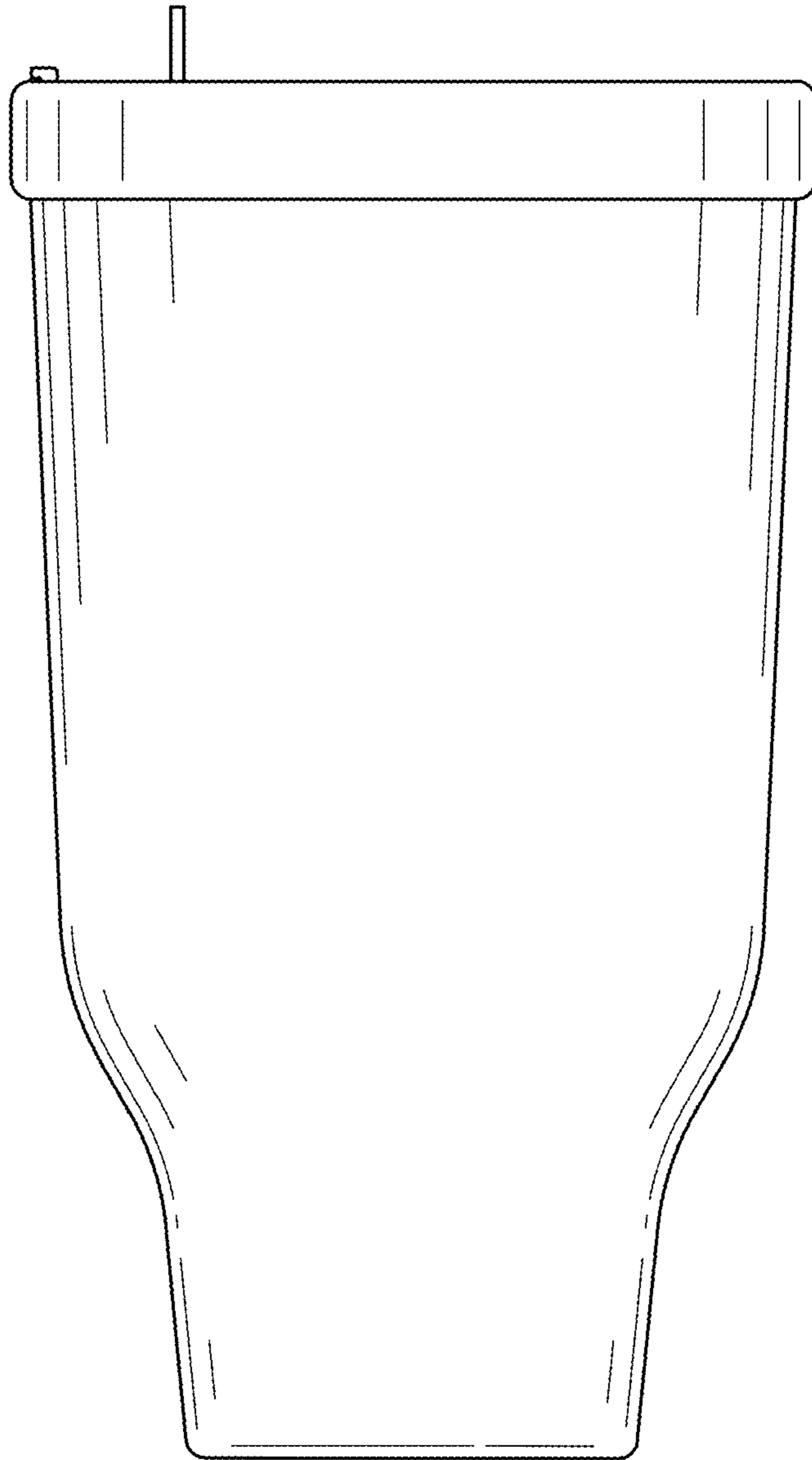

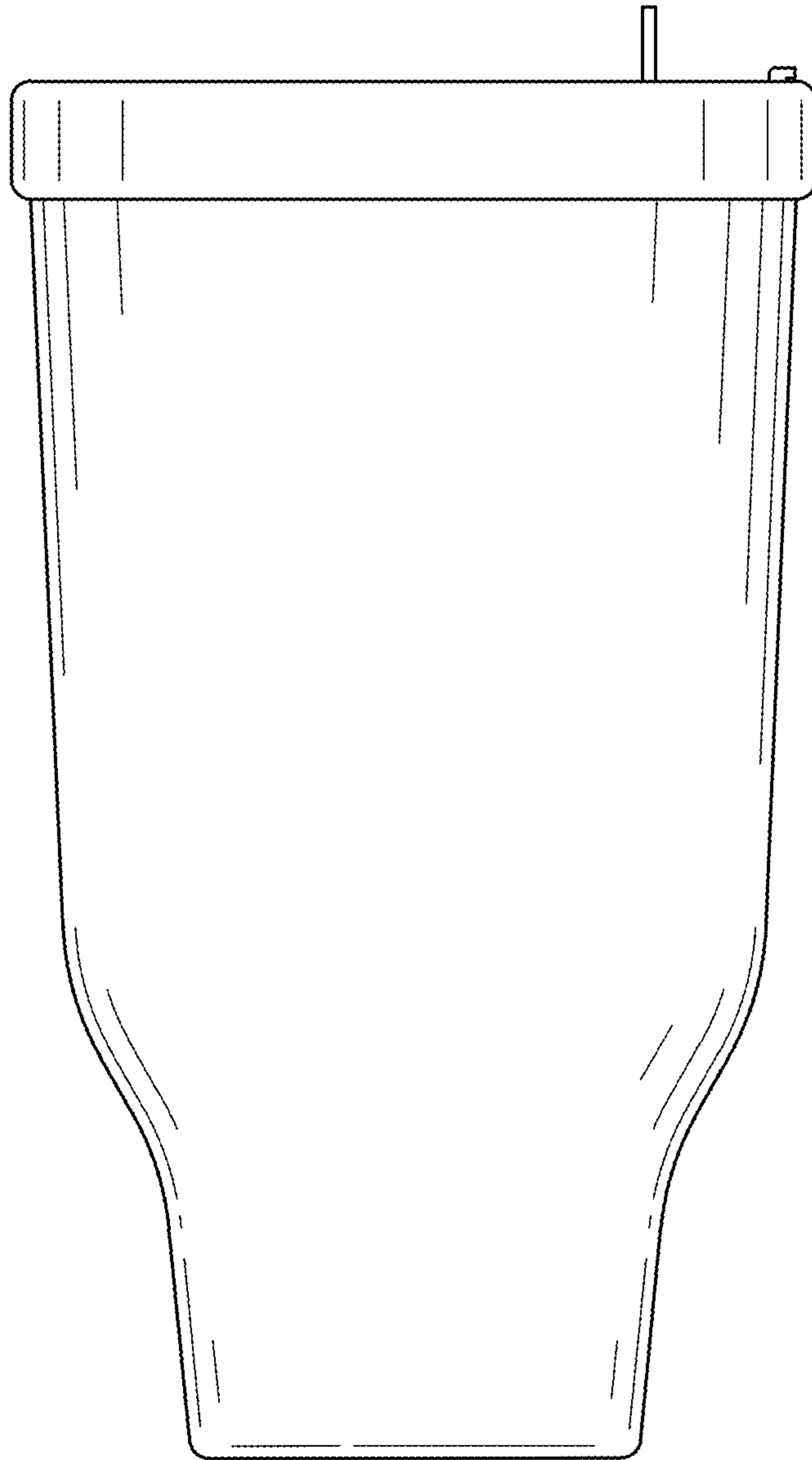

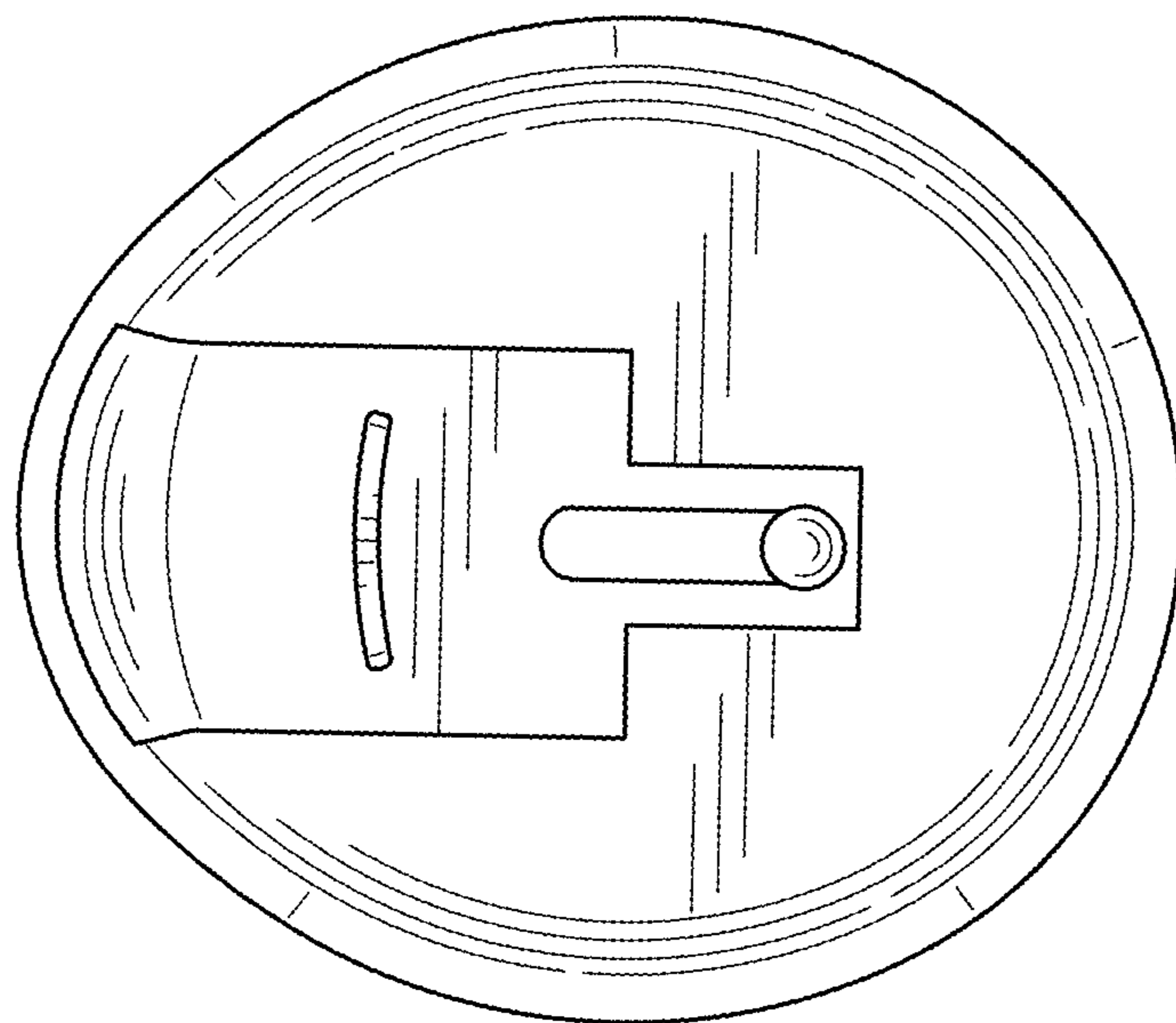

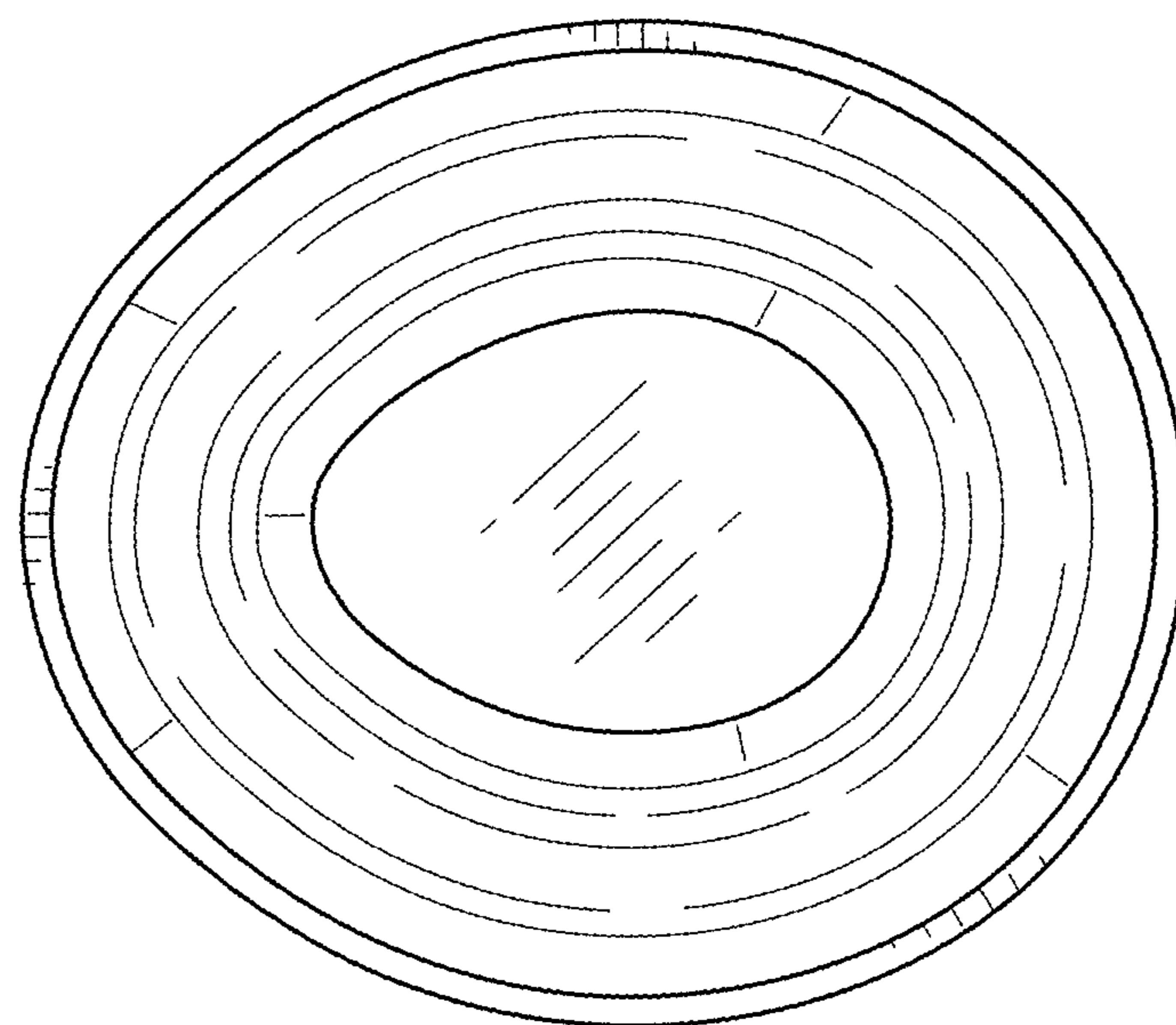

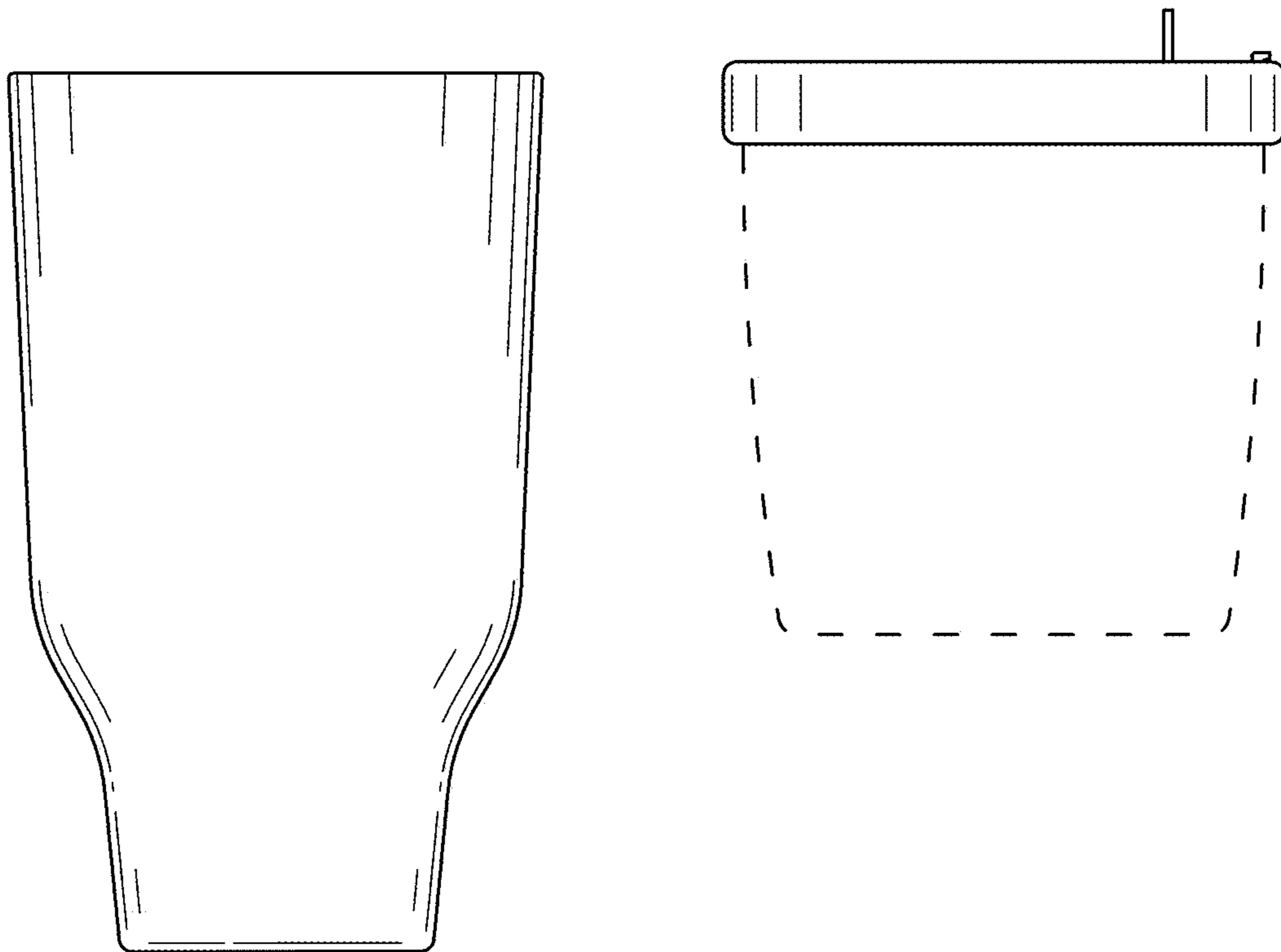
