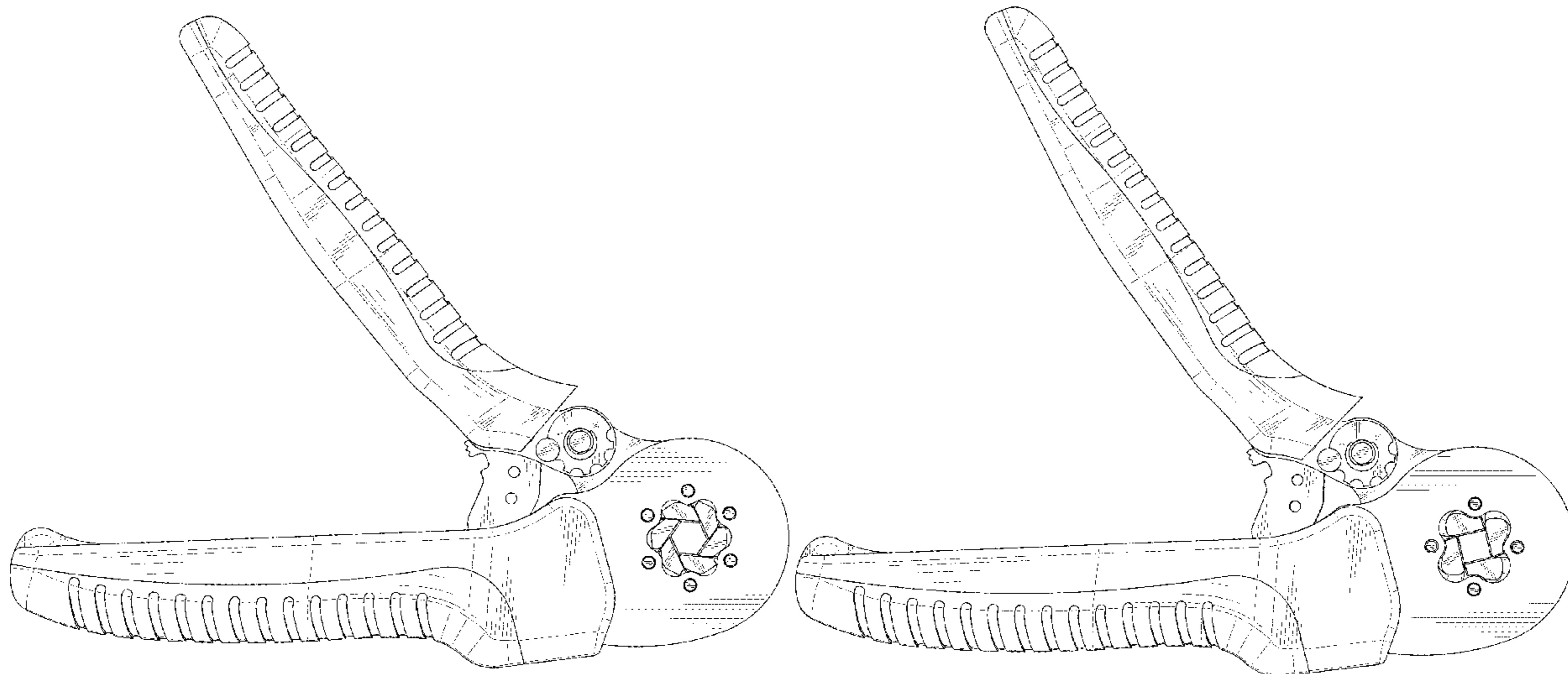
(57) **CLAIM**

The ornamental design for a crimping tool, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a crimping tool showing my new design; FIG. 2 is another perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; and FIG. 9 is an enlarged view of portion 9 shown in FIG. 1. FIG. 10 is a perspective view of a second embodiment of the crimping tool; FIG. 11 is another perspective view thereof; FIG. 12 is a front elevational view thereof; FIG. 13 is a rear elevational view thereof; FIG. 14 is a left side elevational view thereof; FIG. 15 is a right side elevational view thereof; FIG. 16 is a top plan view thereof; FIG. 17 is a bottom plan view thereof; and, FIG. 18 is an enlarged view of portion 18 shown in FIG. 10. The dash-dash broken lines in the drawings depict portions of the crimping tool that form no part of the claimed design. The dot-dash broken lines represent boundaries of the enlarged portions and form no part of the claimed design.

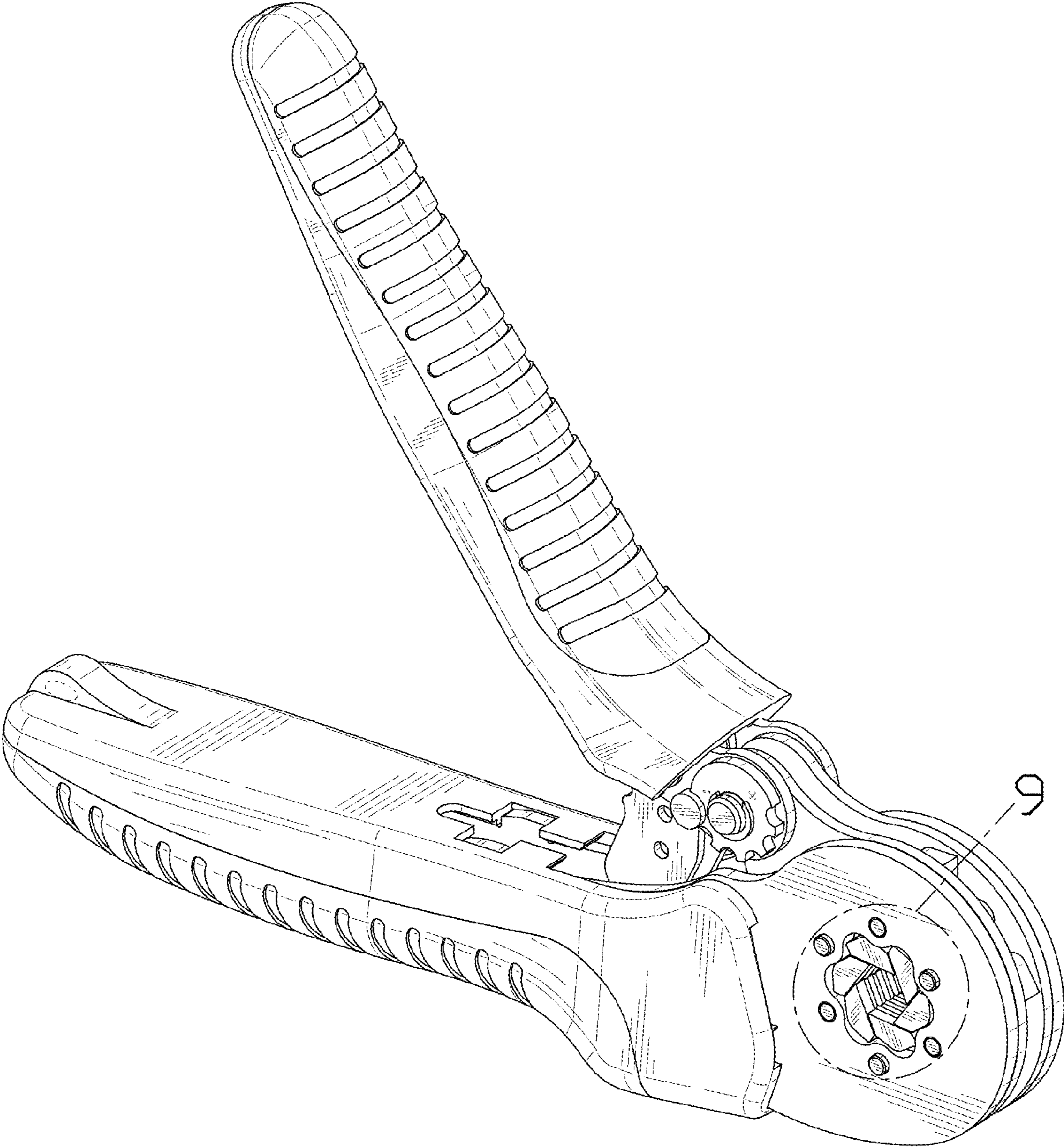

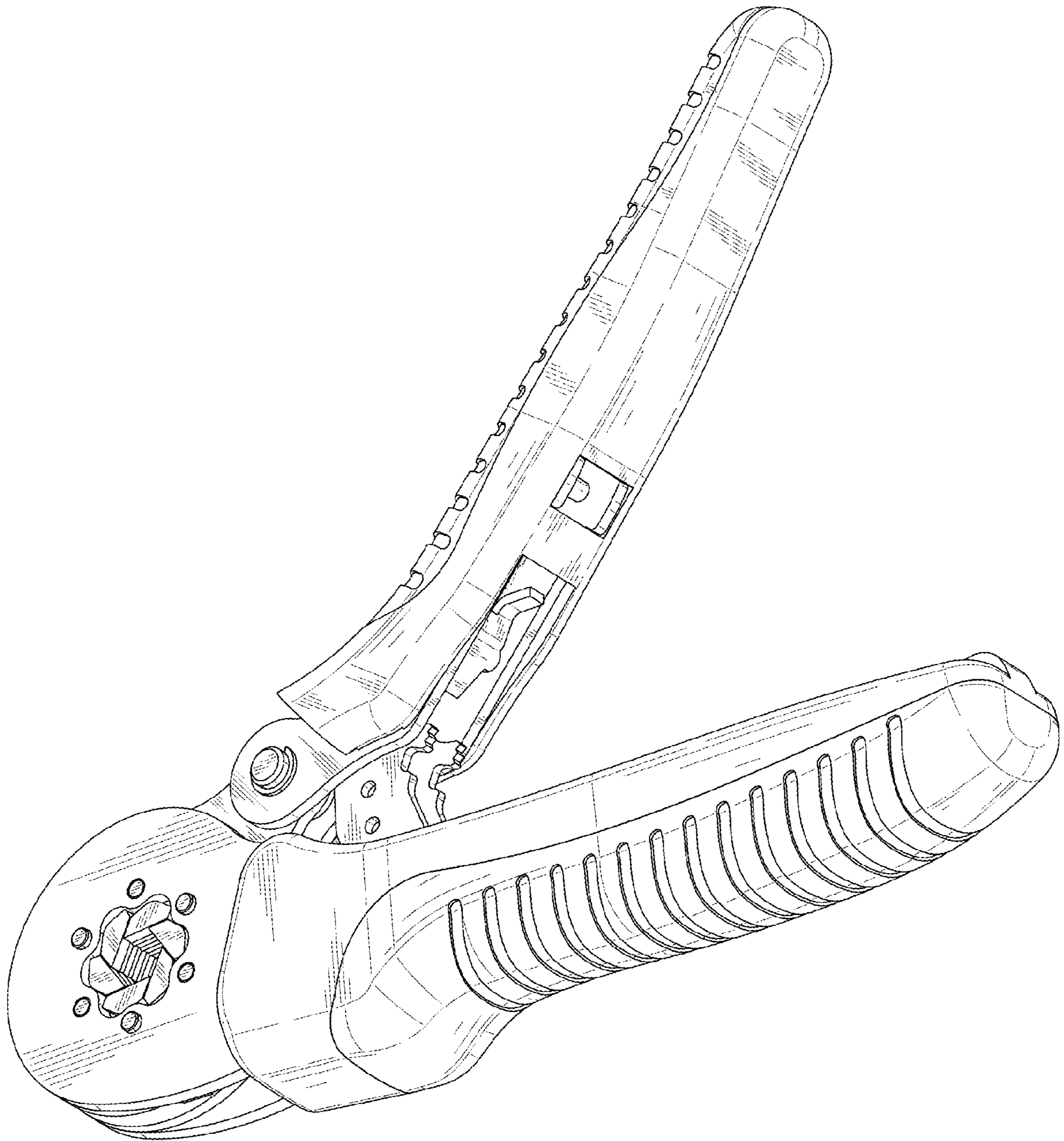

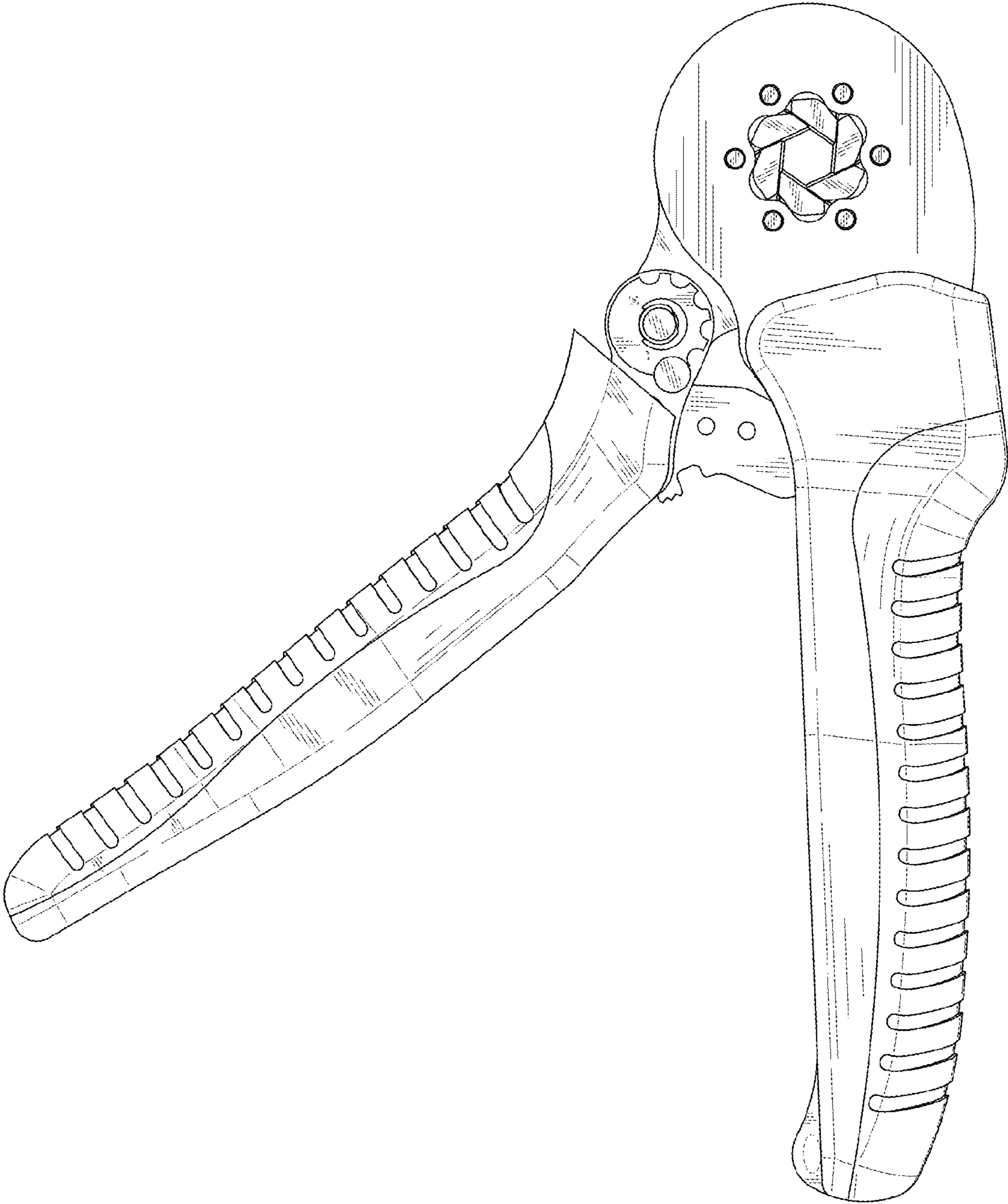

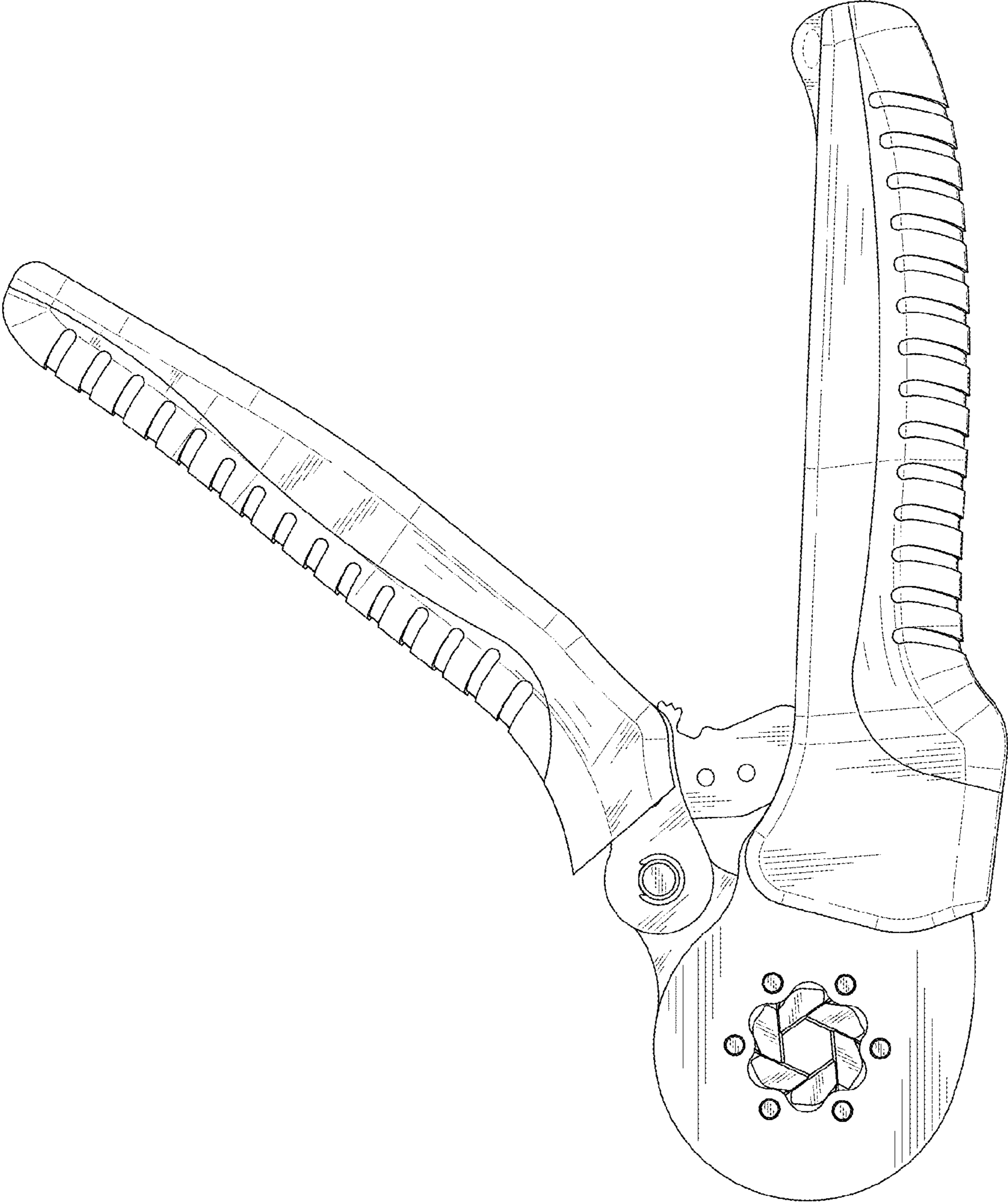

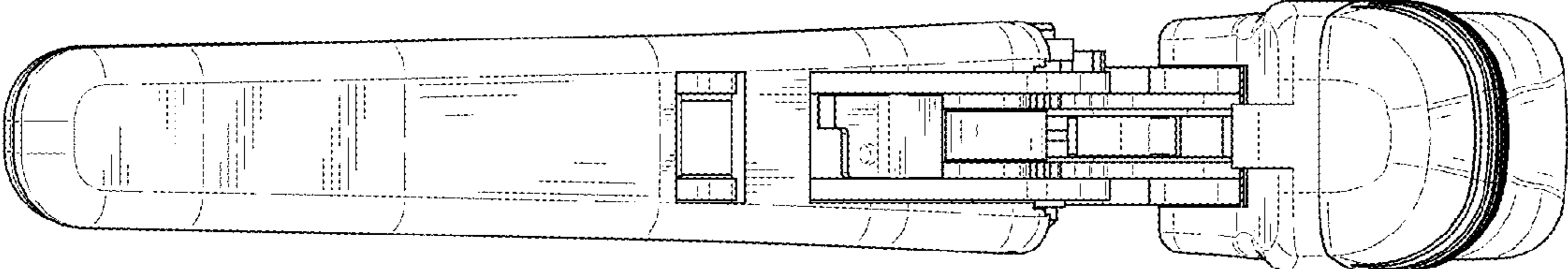

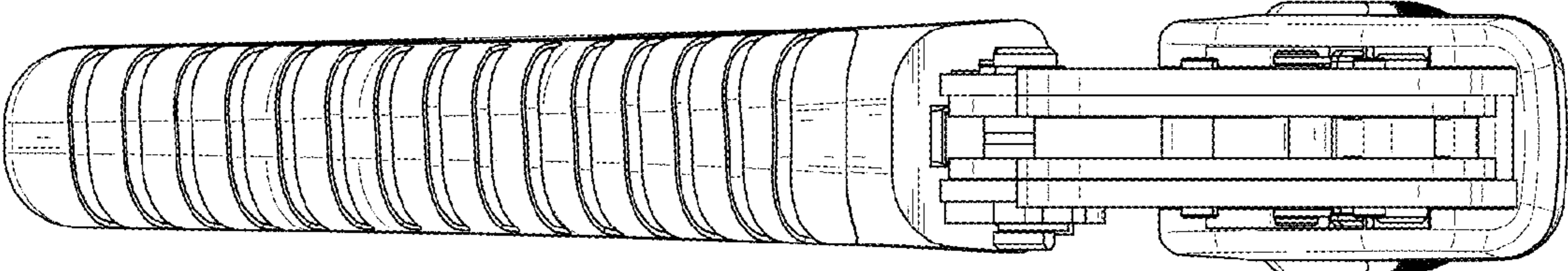

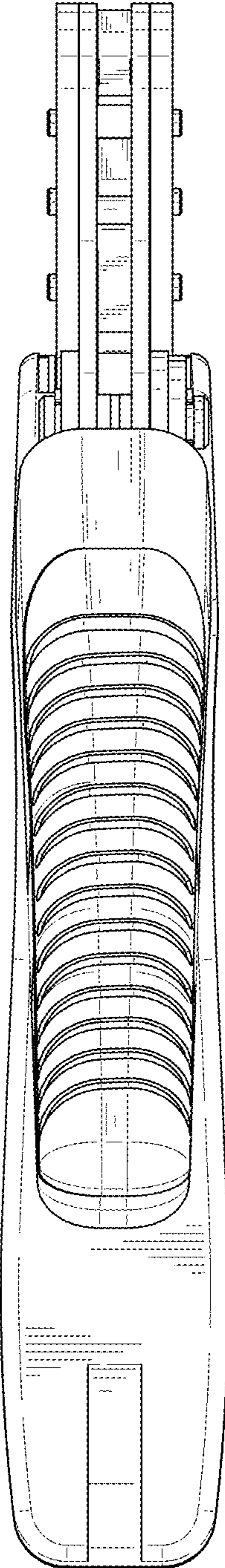

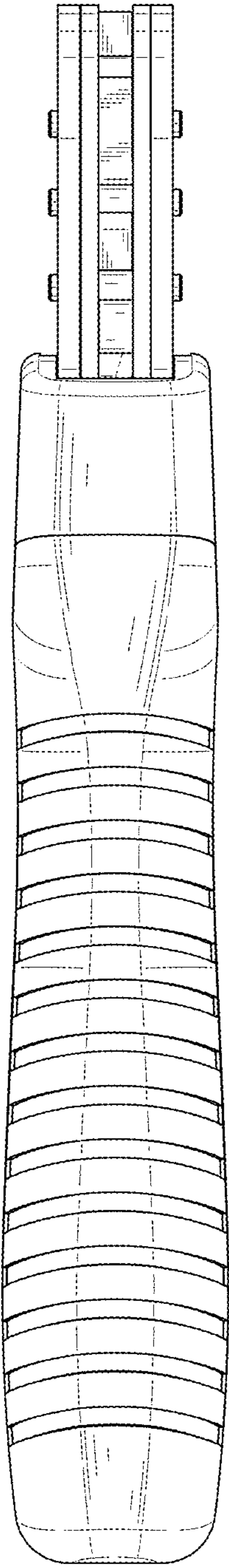

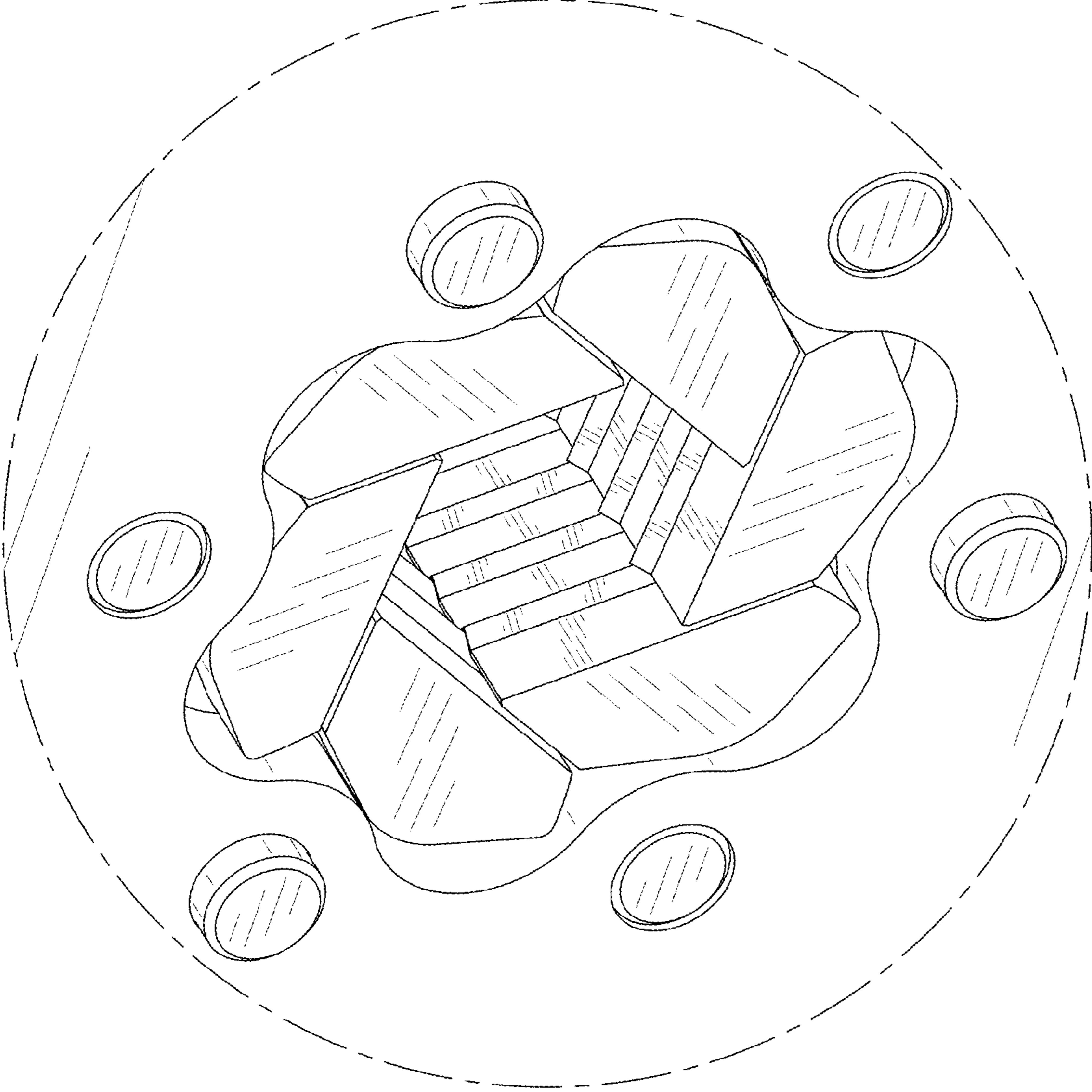

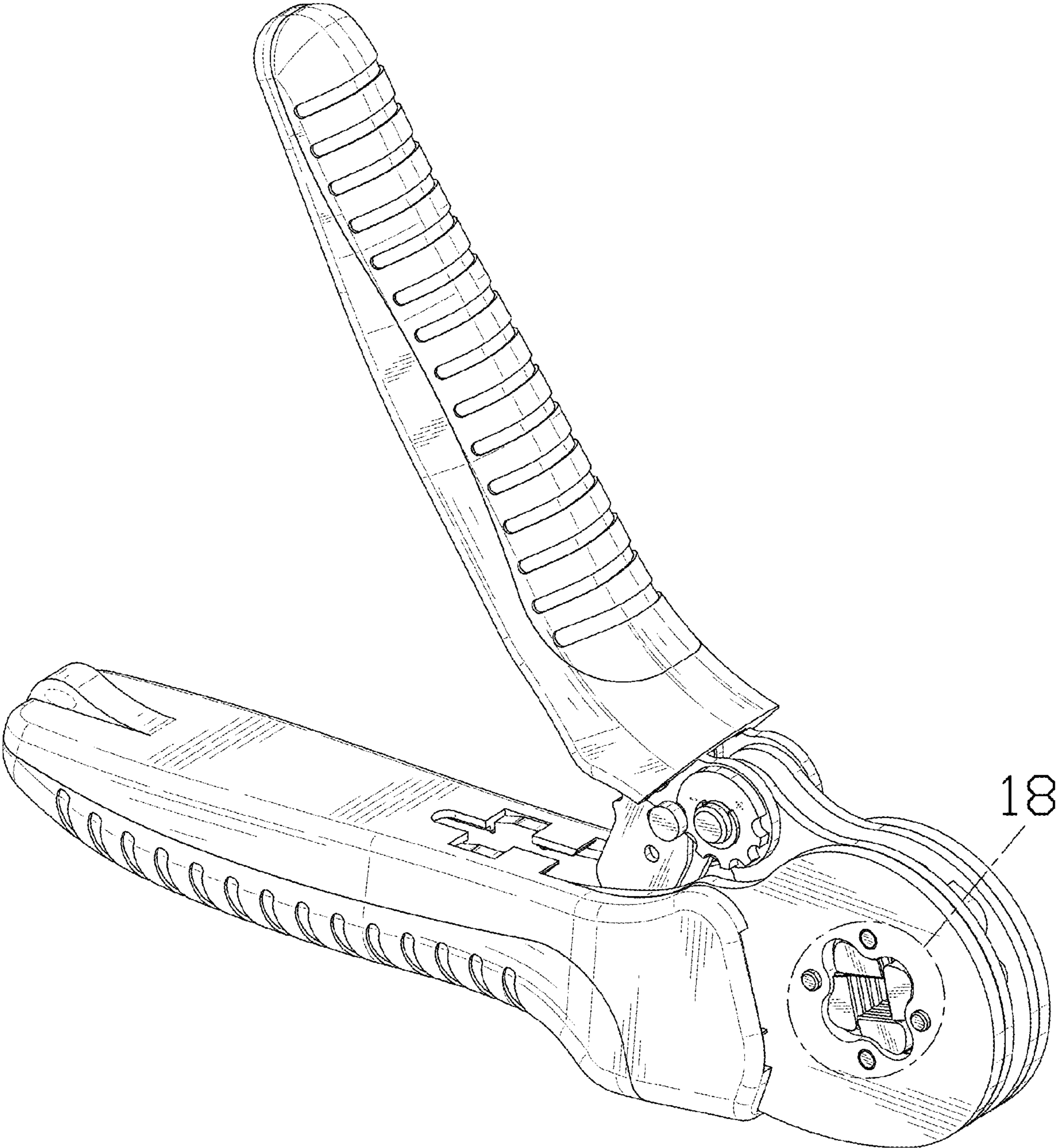

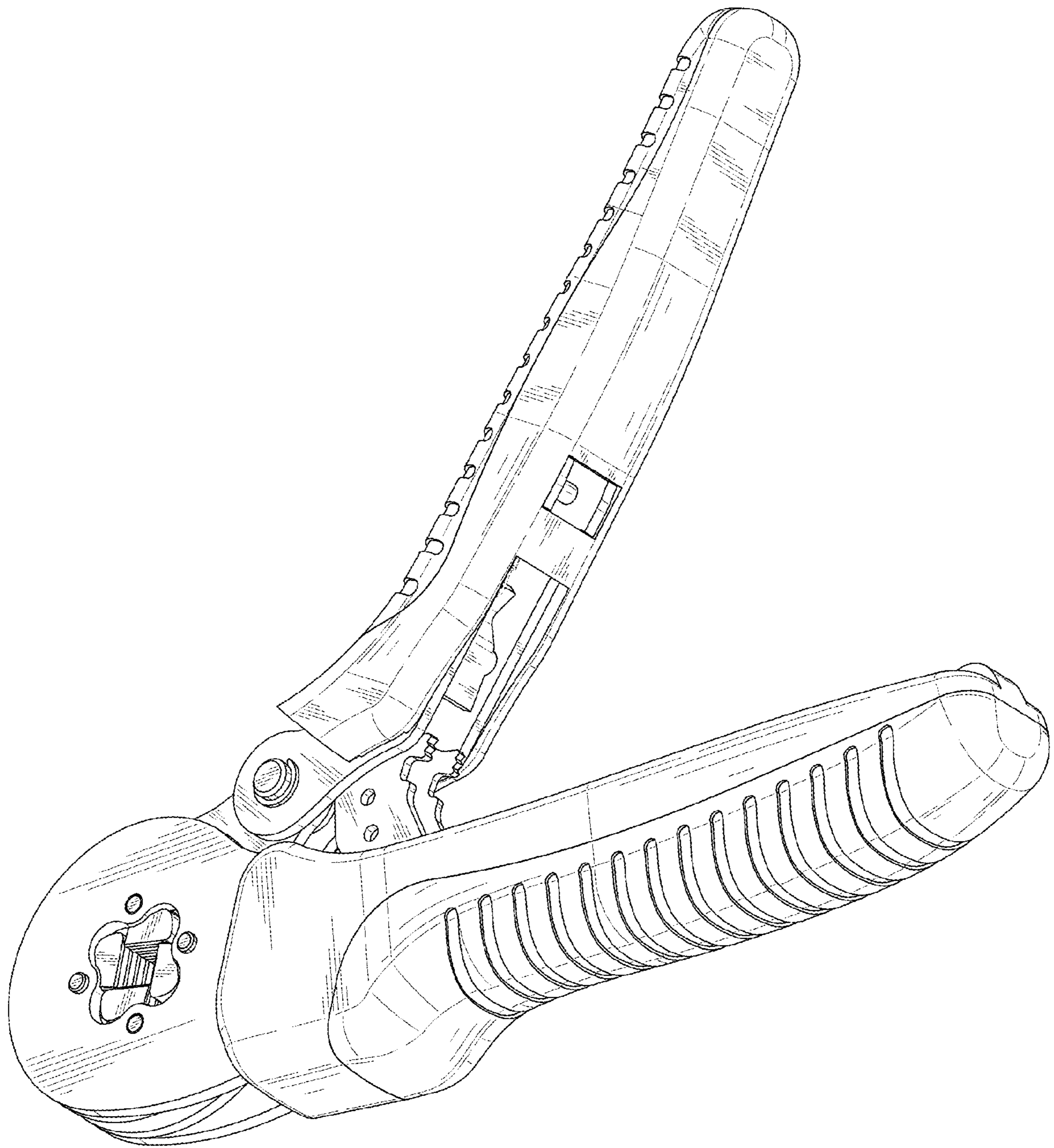

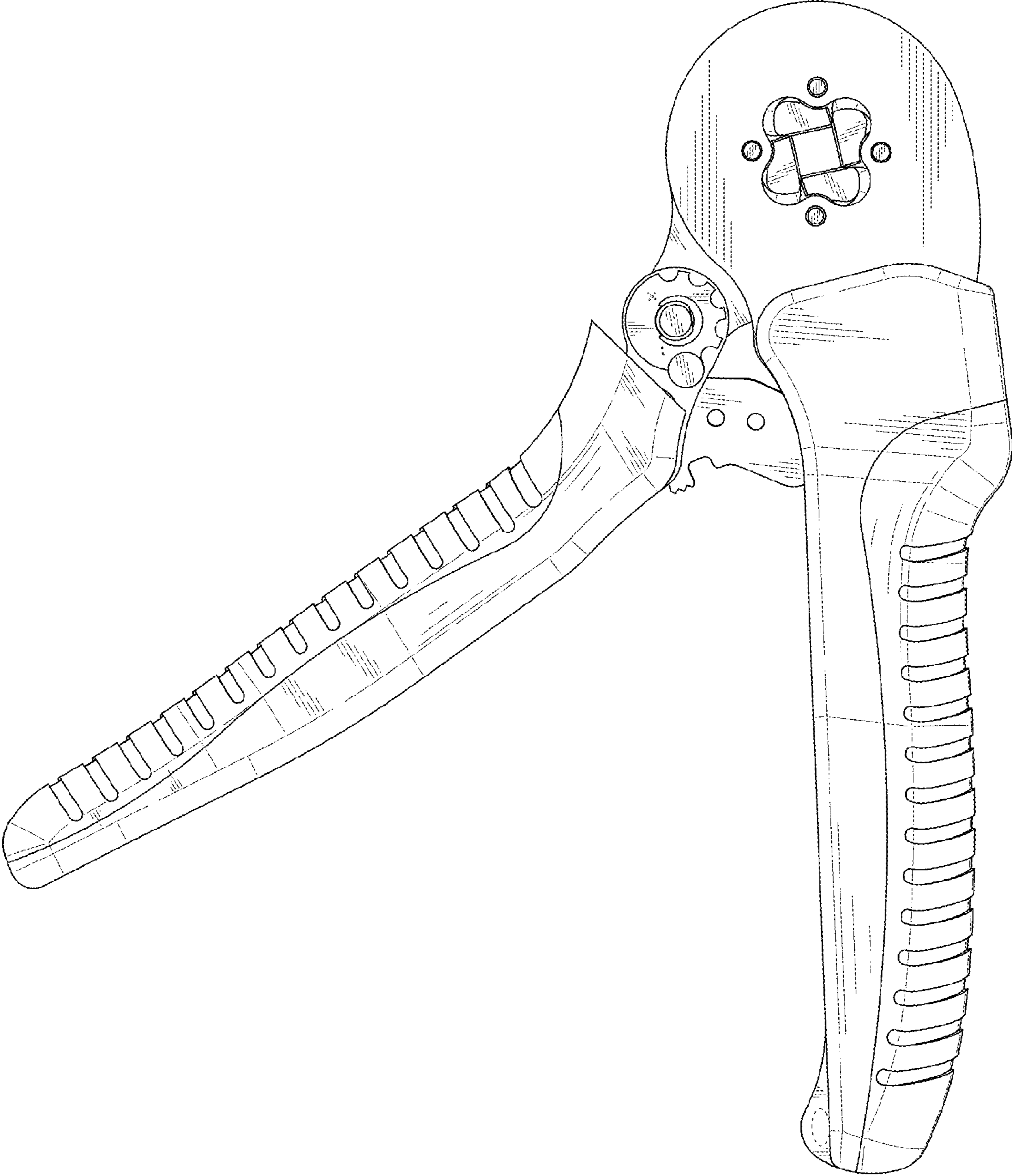

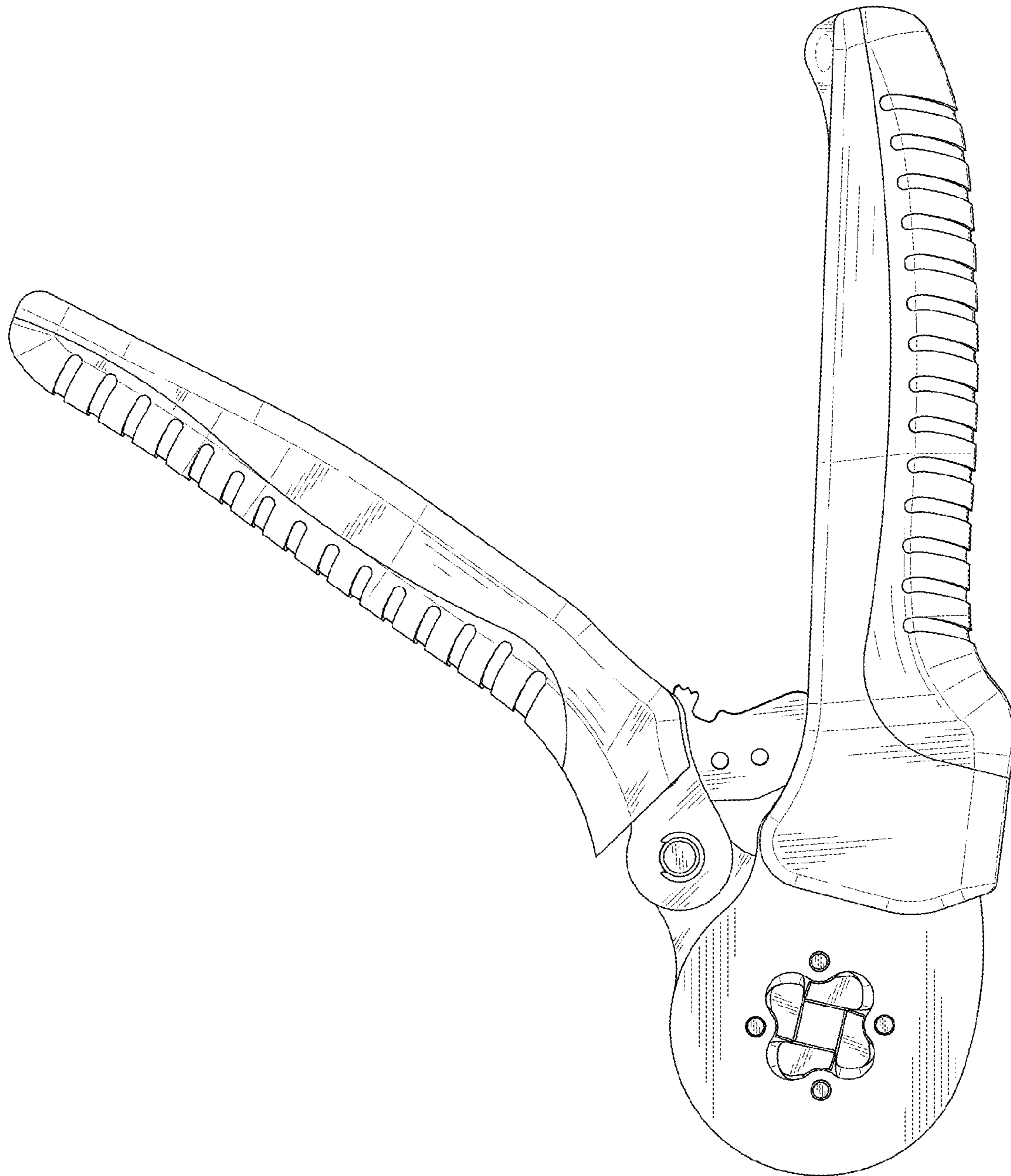

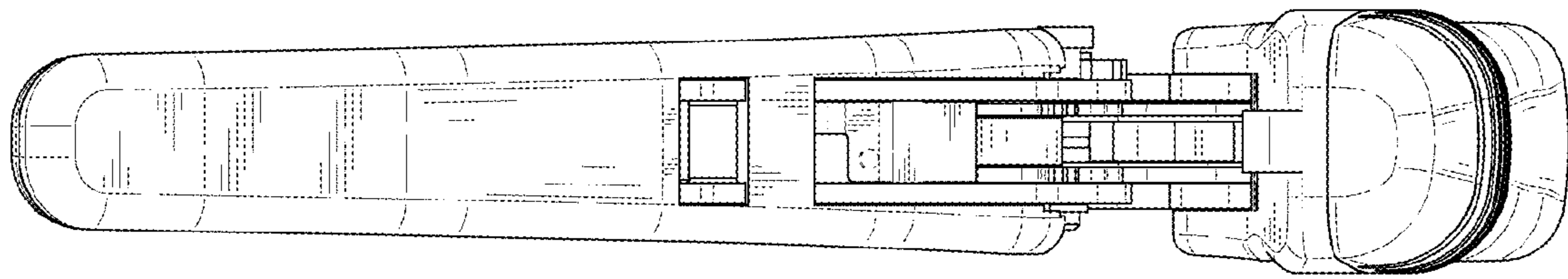

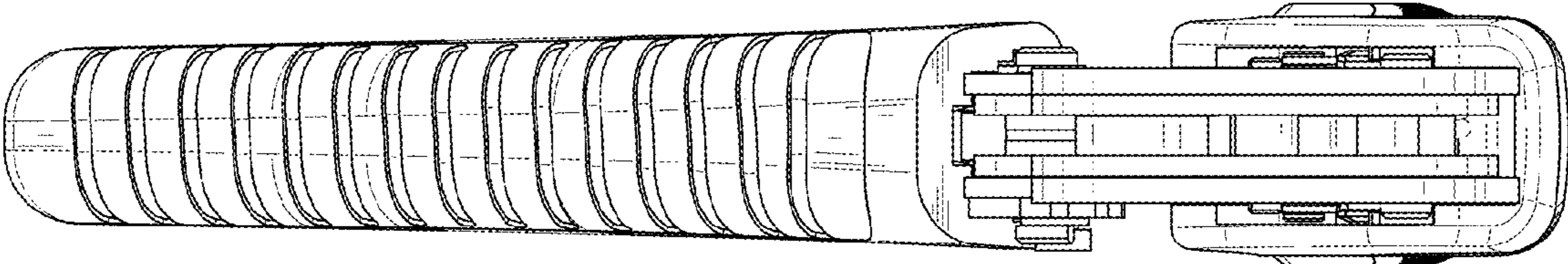

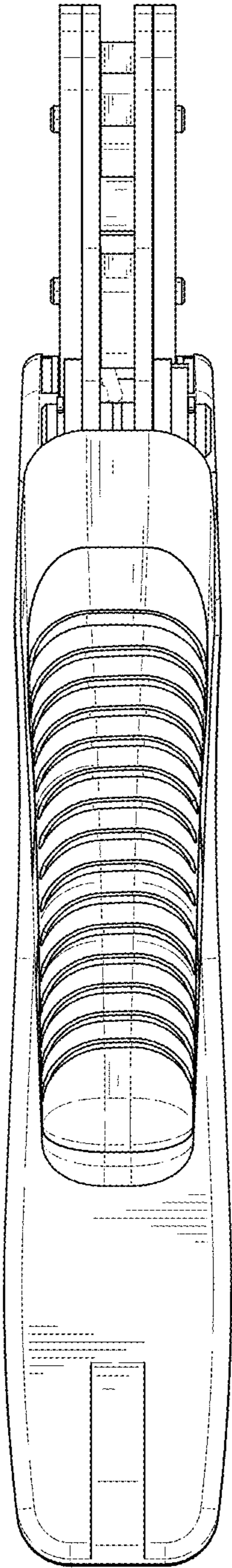

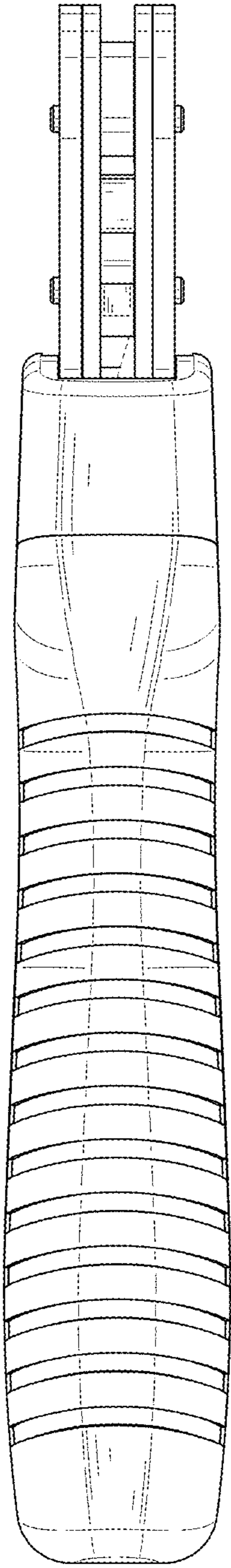

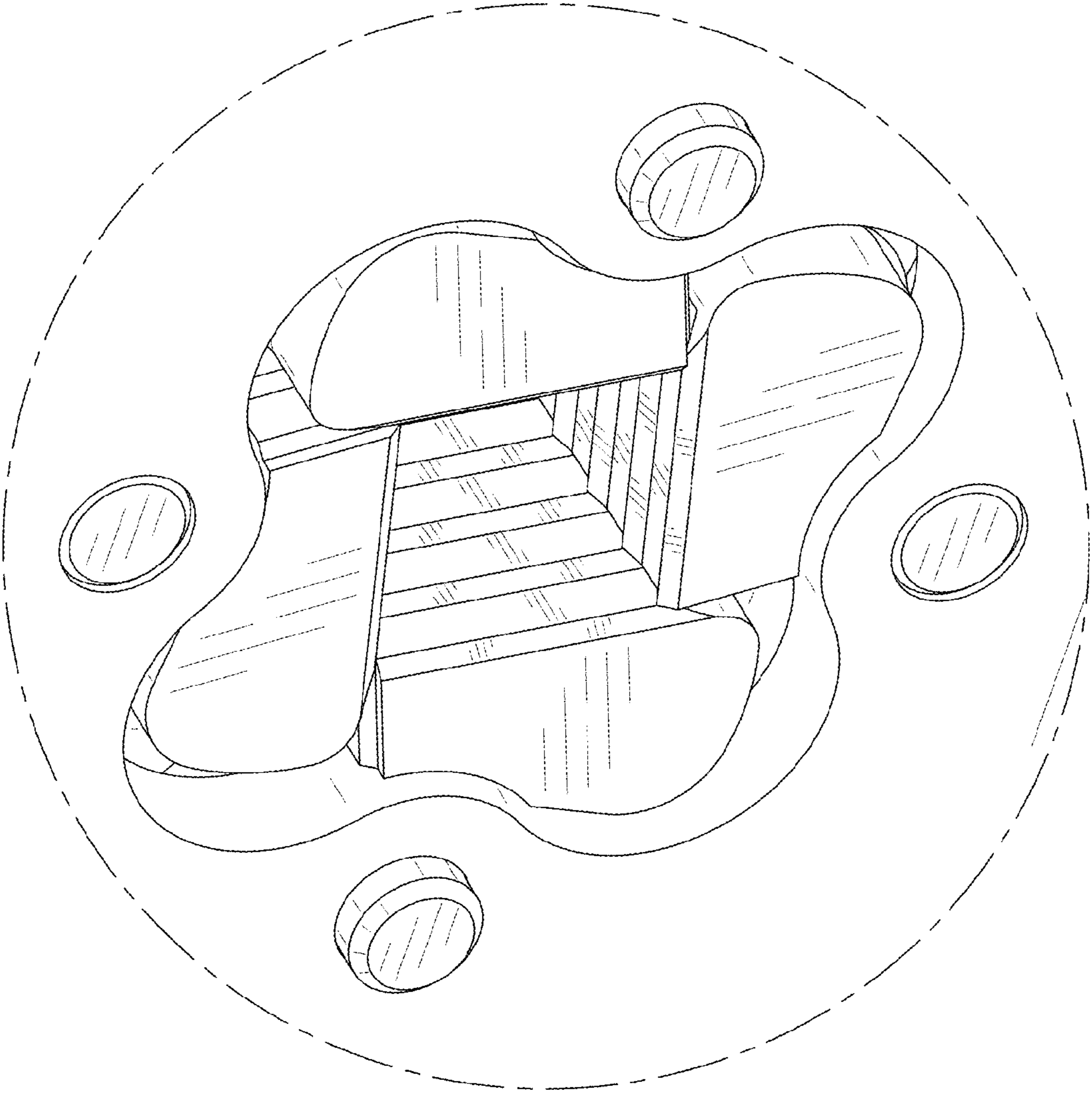
