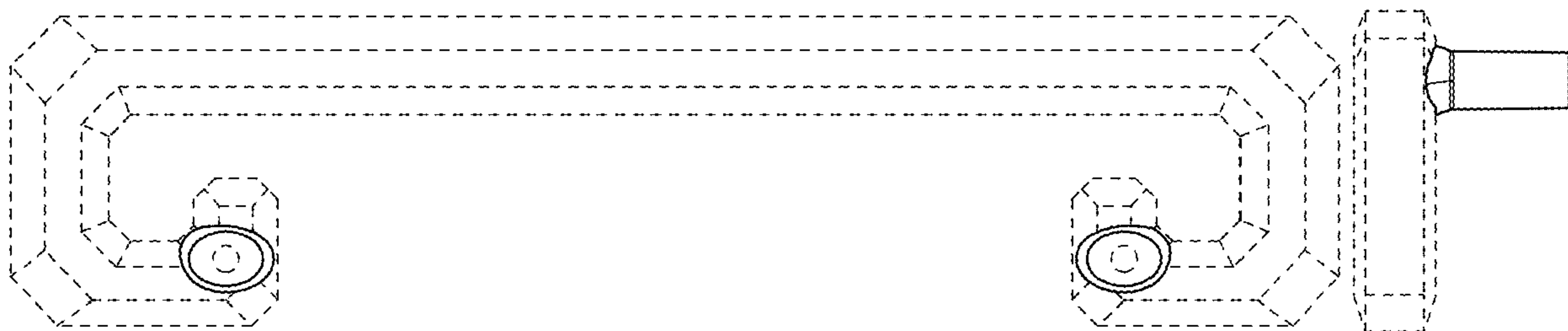
(57) **CLAIM**

I claim the ornamental design for a decorative handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a decorative handle; FIG. 2 is a front view of the decorative handle of FIG. 1; FIG. 3 is a back view of the decorative handle of FIG. 1; FIG. 4 is a left view of the decorative handle of FIG. 1; FIG. 5 is a right view of the decorative handle of FIG. 1; FIG. 6 is a top view of the decorative handle of FIG. 1; and, FIG. 7 is a bottom view of the decorative handle of FIG. 1. All broken lines shown in the Figures illustrate portions of the article that form no part of the claimed design.

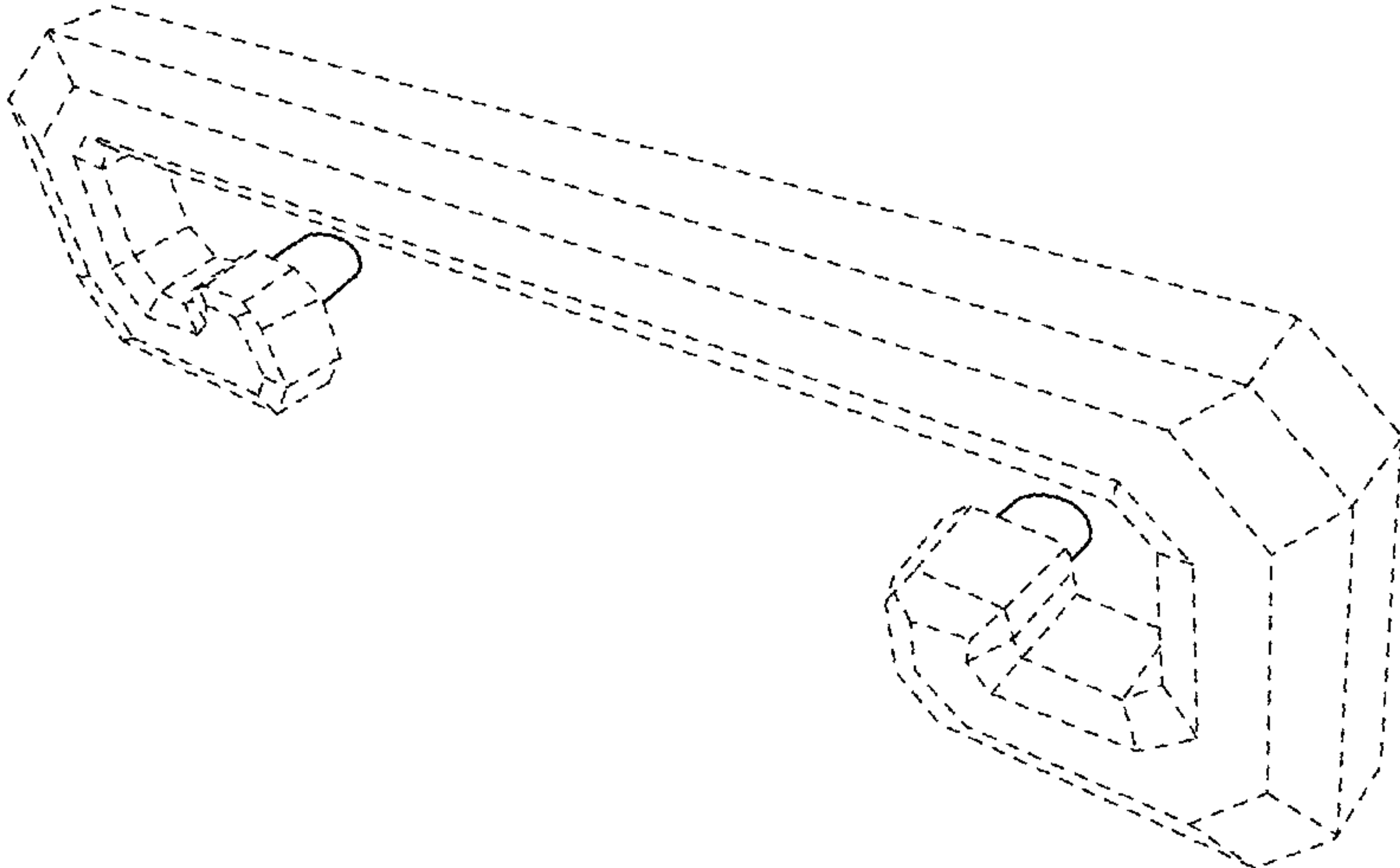

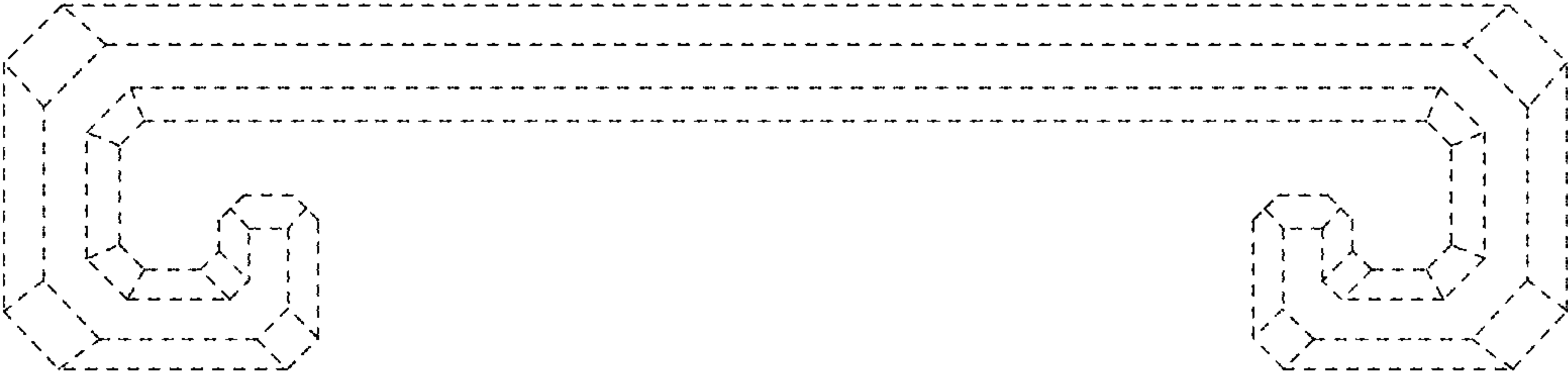

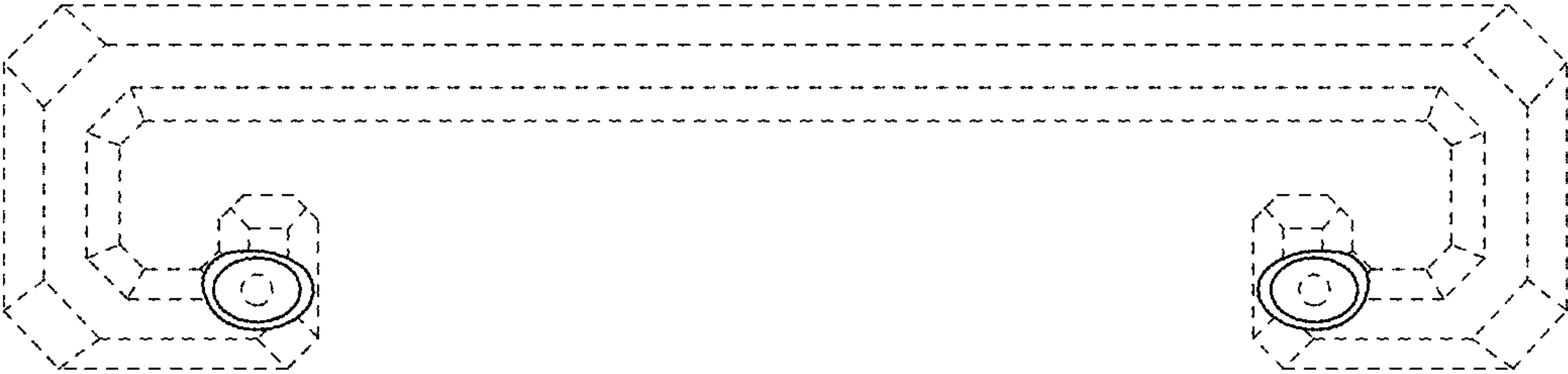

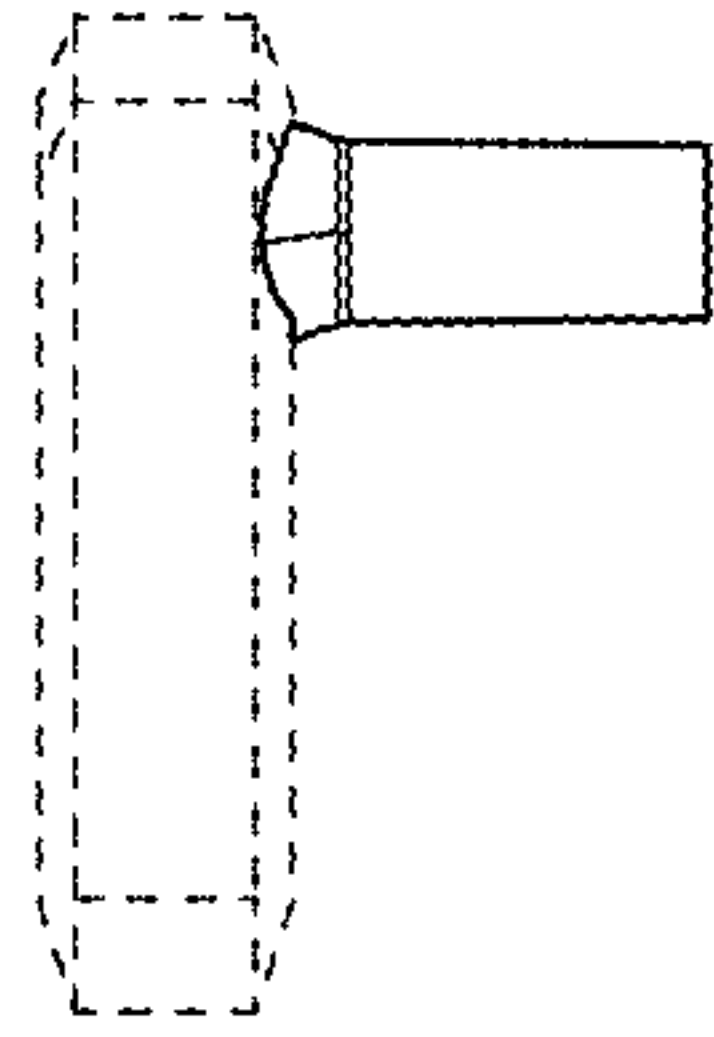

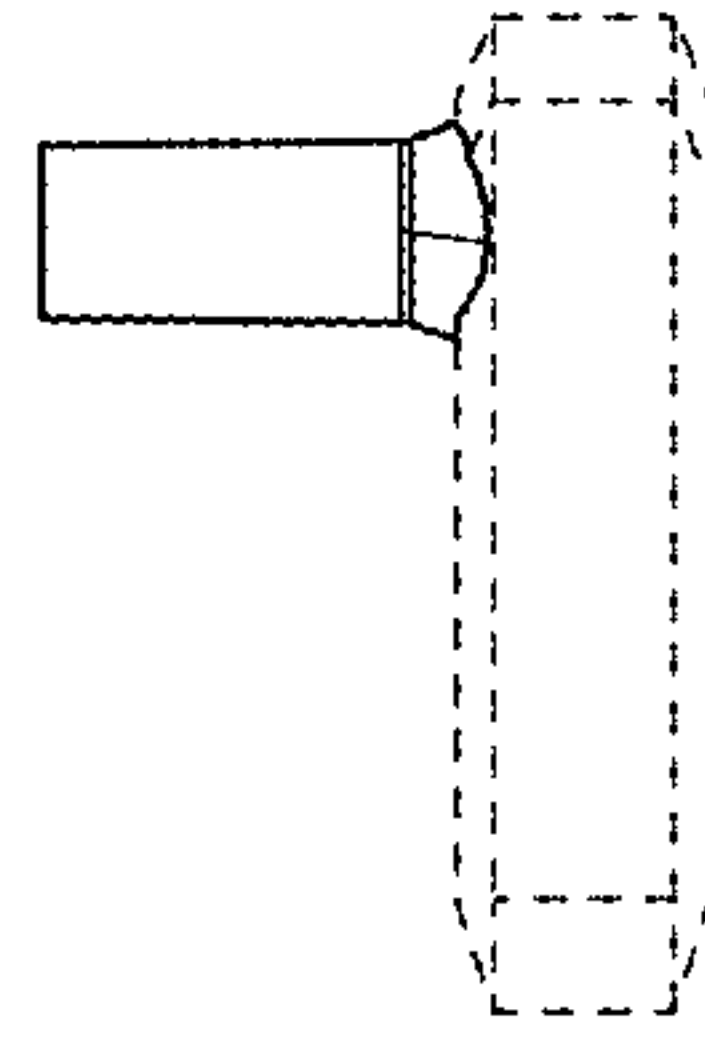

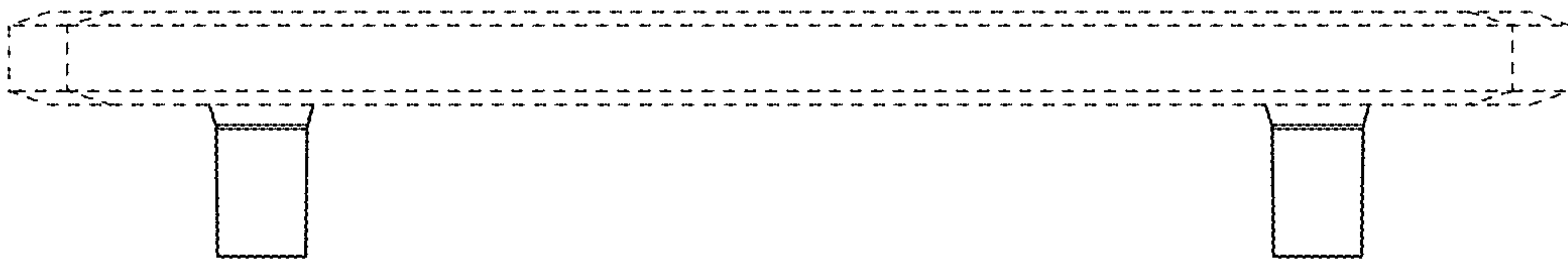

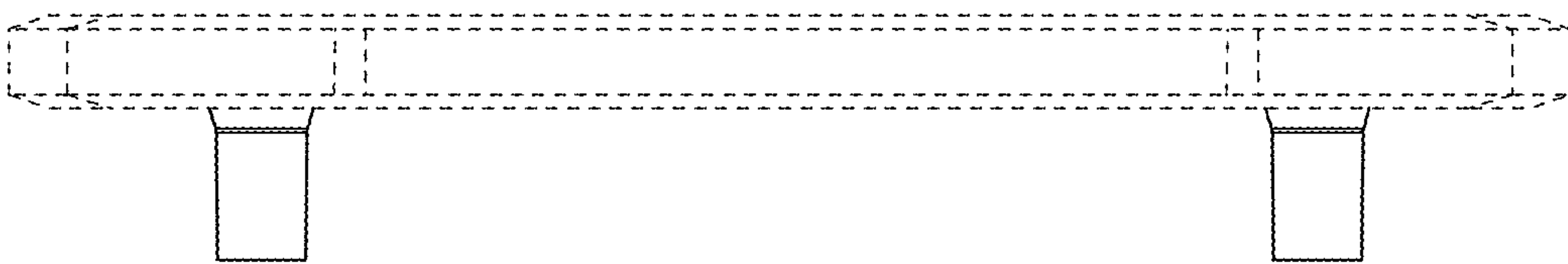
