(57) **CLAIM**

The ornamental design for a center segment of a motor vehicle, toy and/or replica, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of a center segment of a motor vehicle, toy and/or replica according to my new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

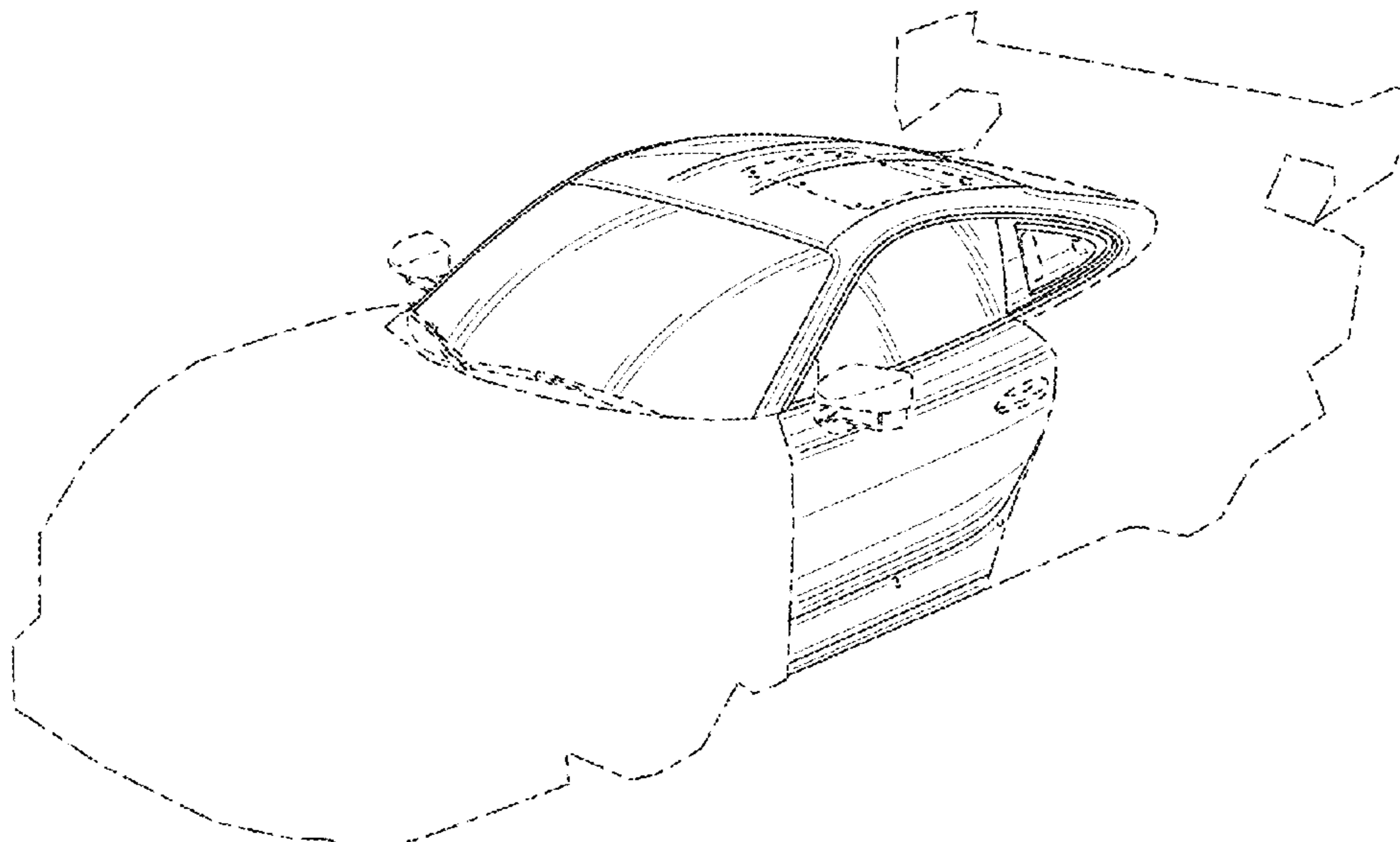
FIG. 4 is an elevation view from the right side thereof;

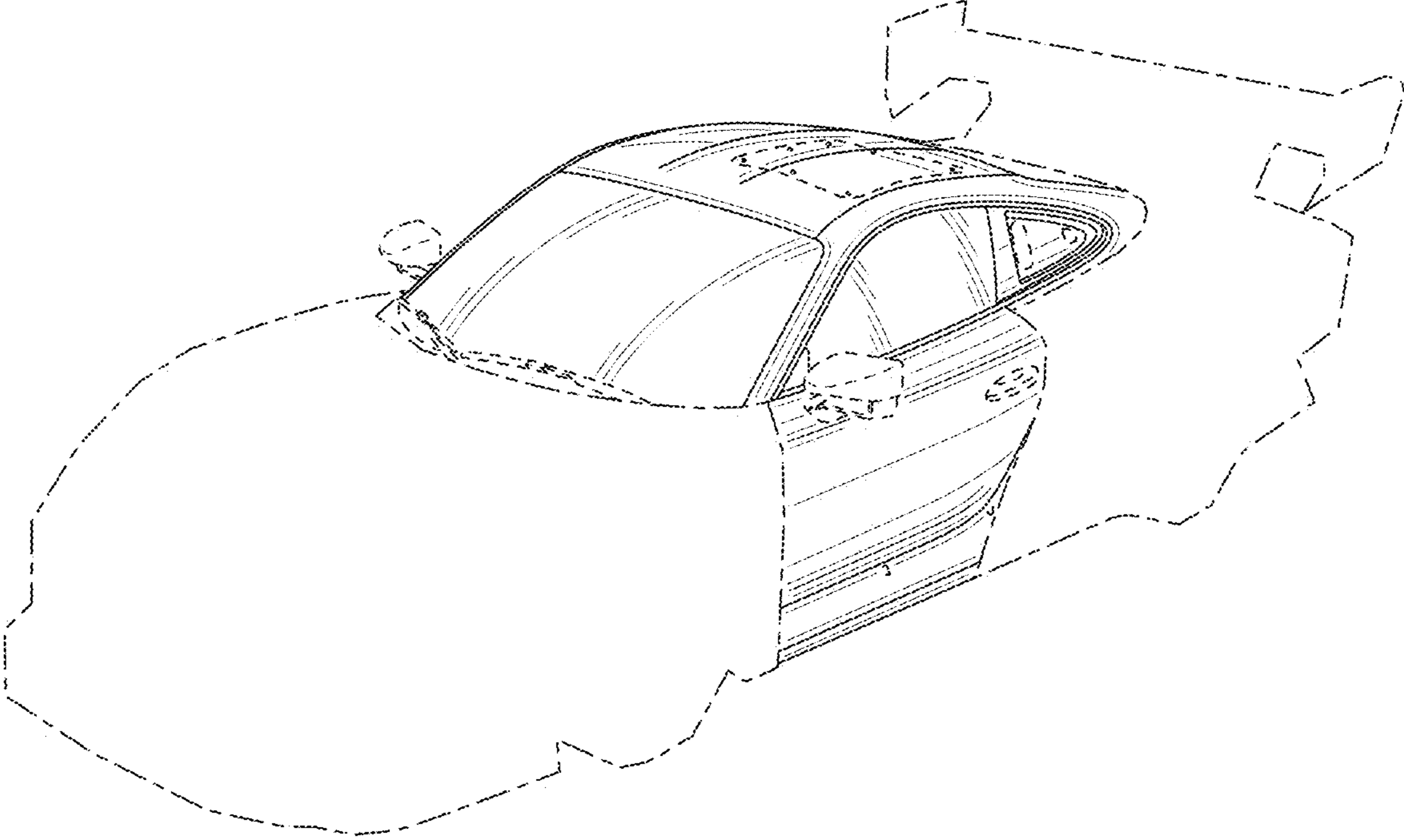

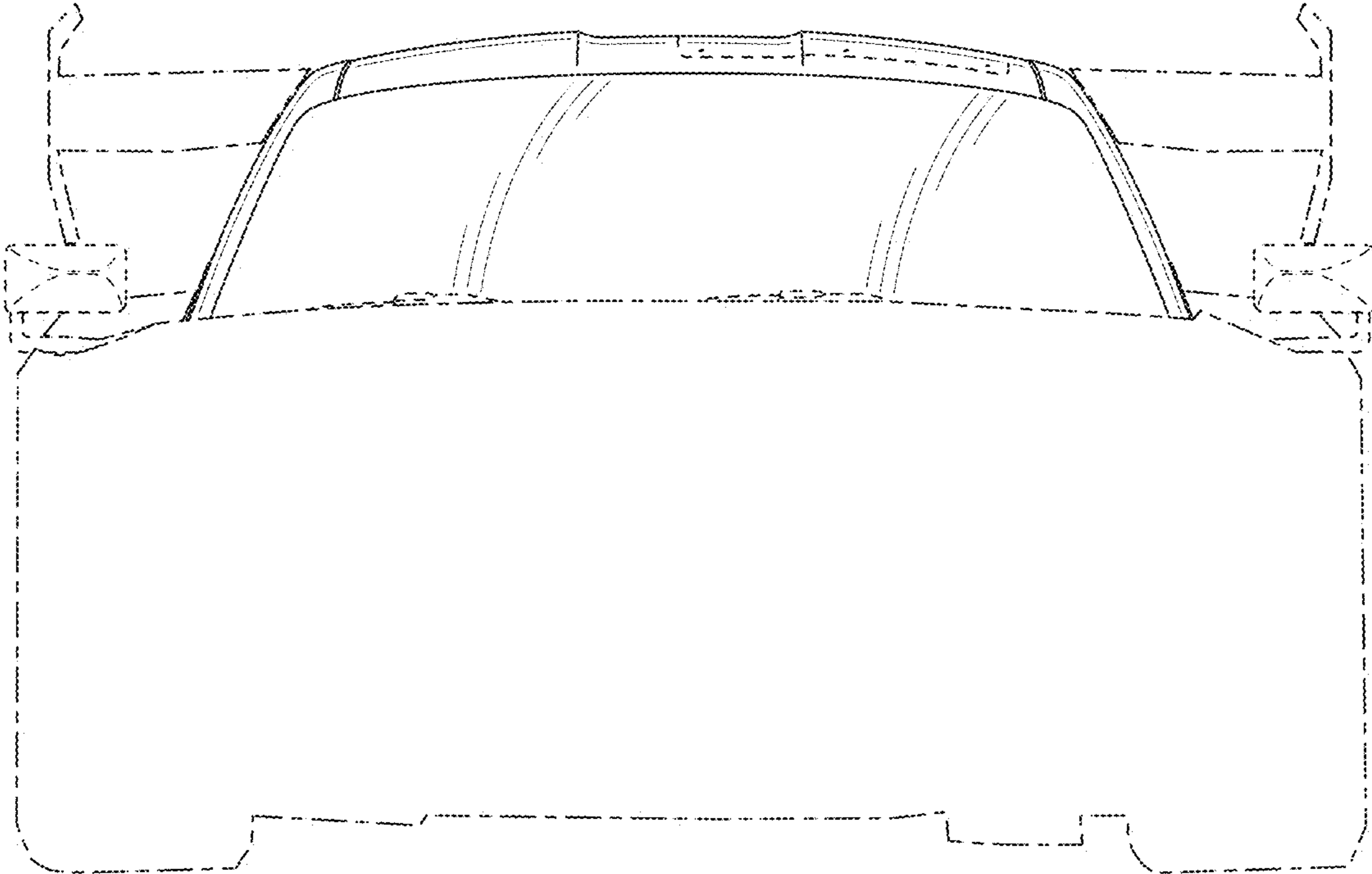

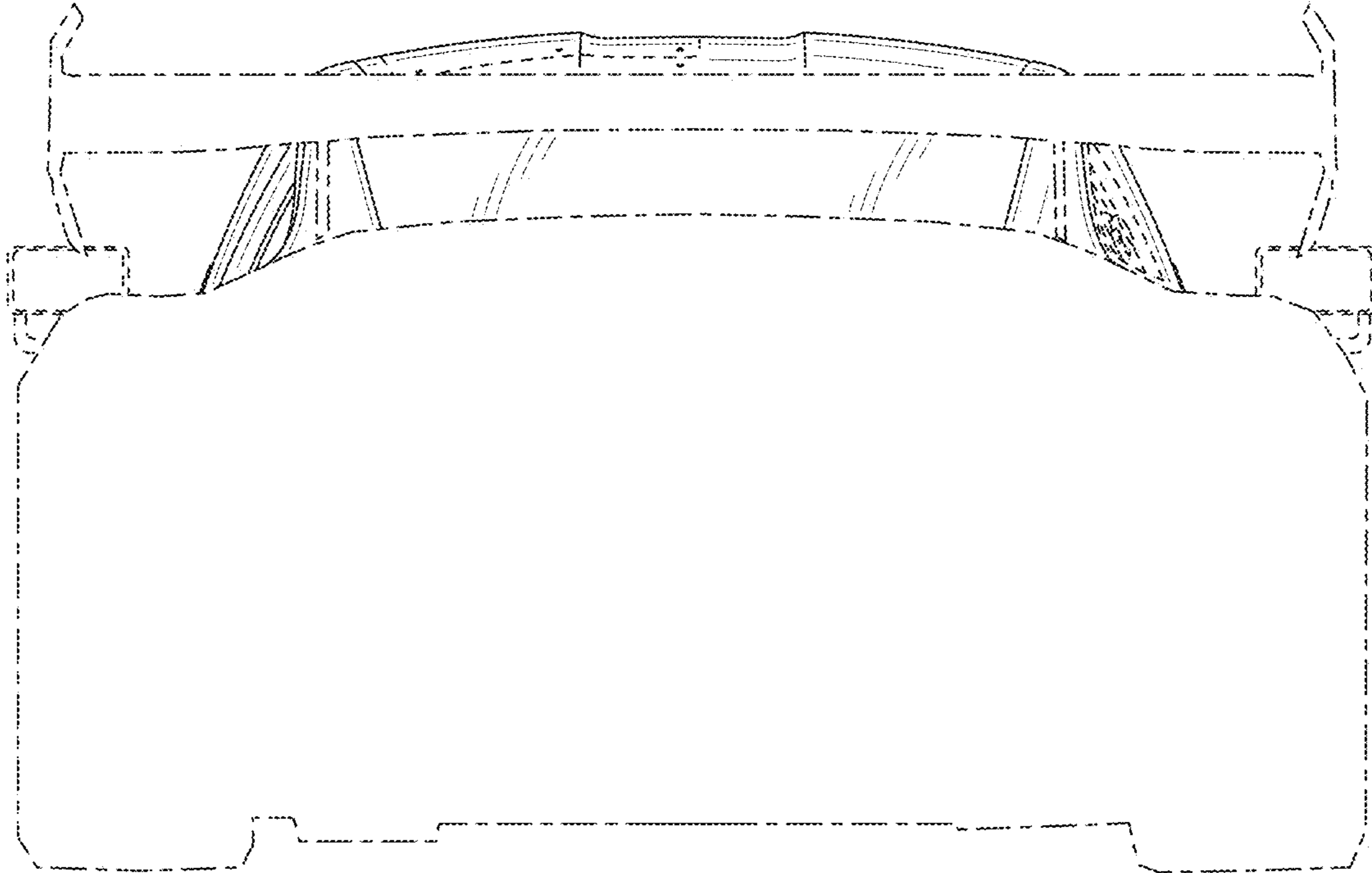

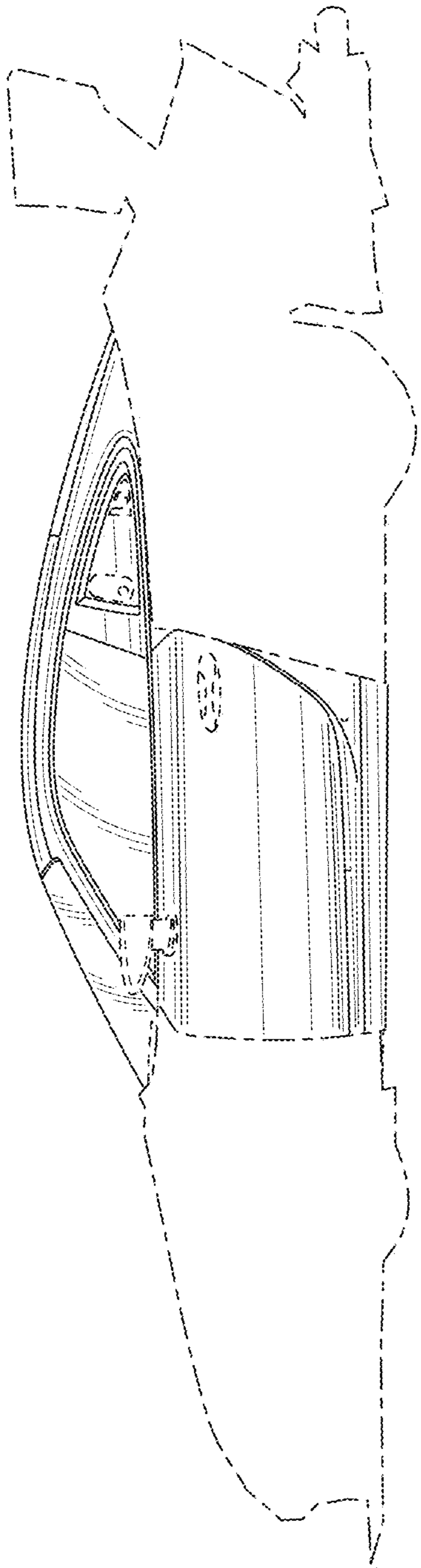

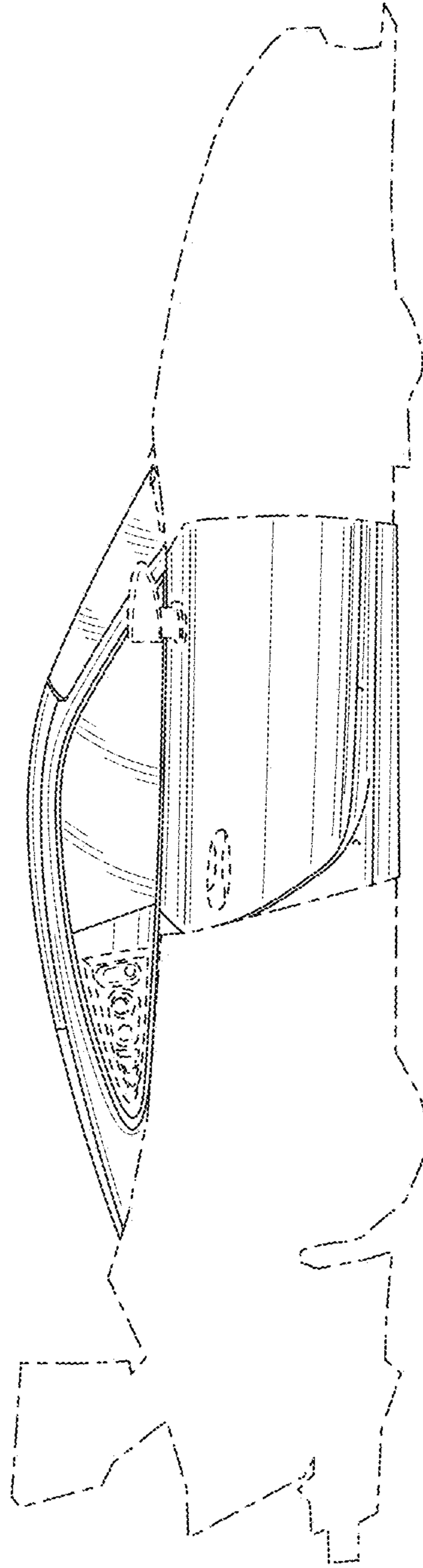

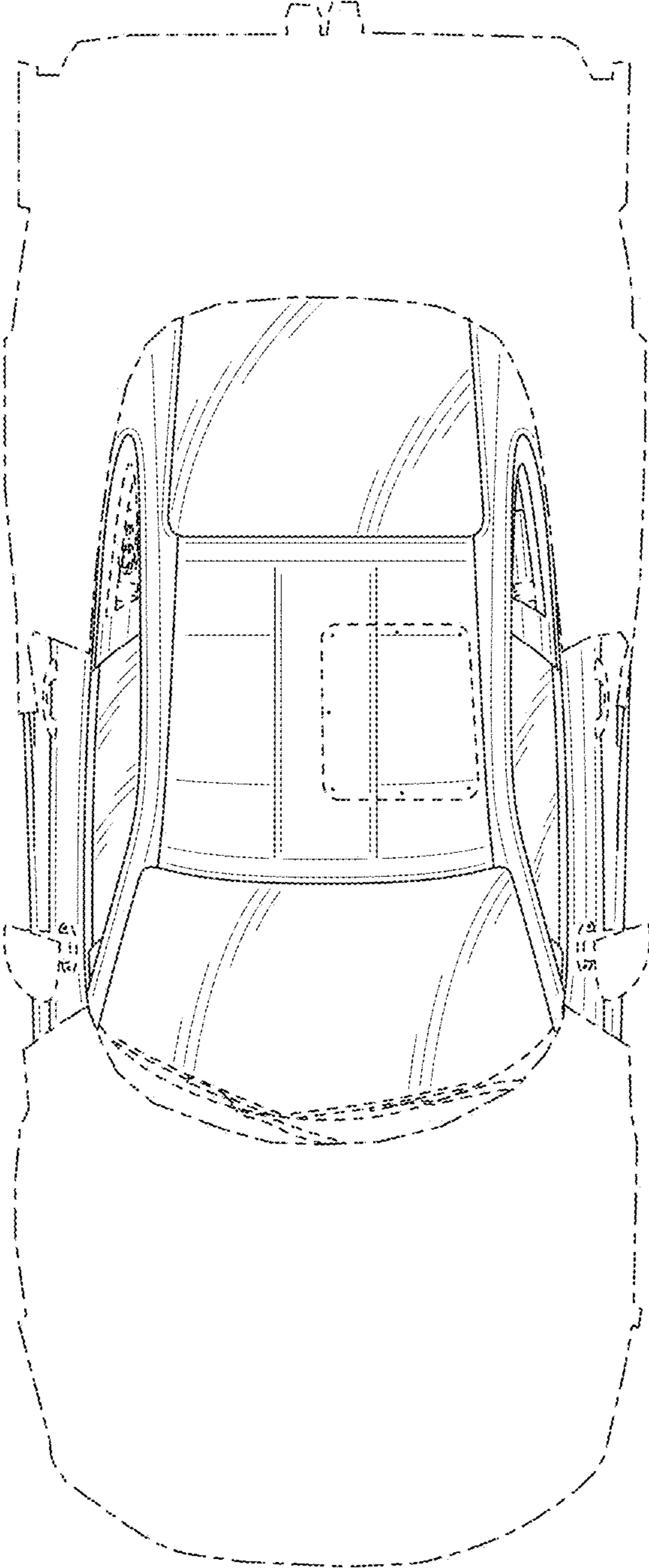
