between the break lines forms no part of the claimed design.

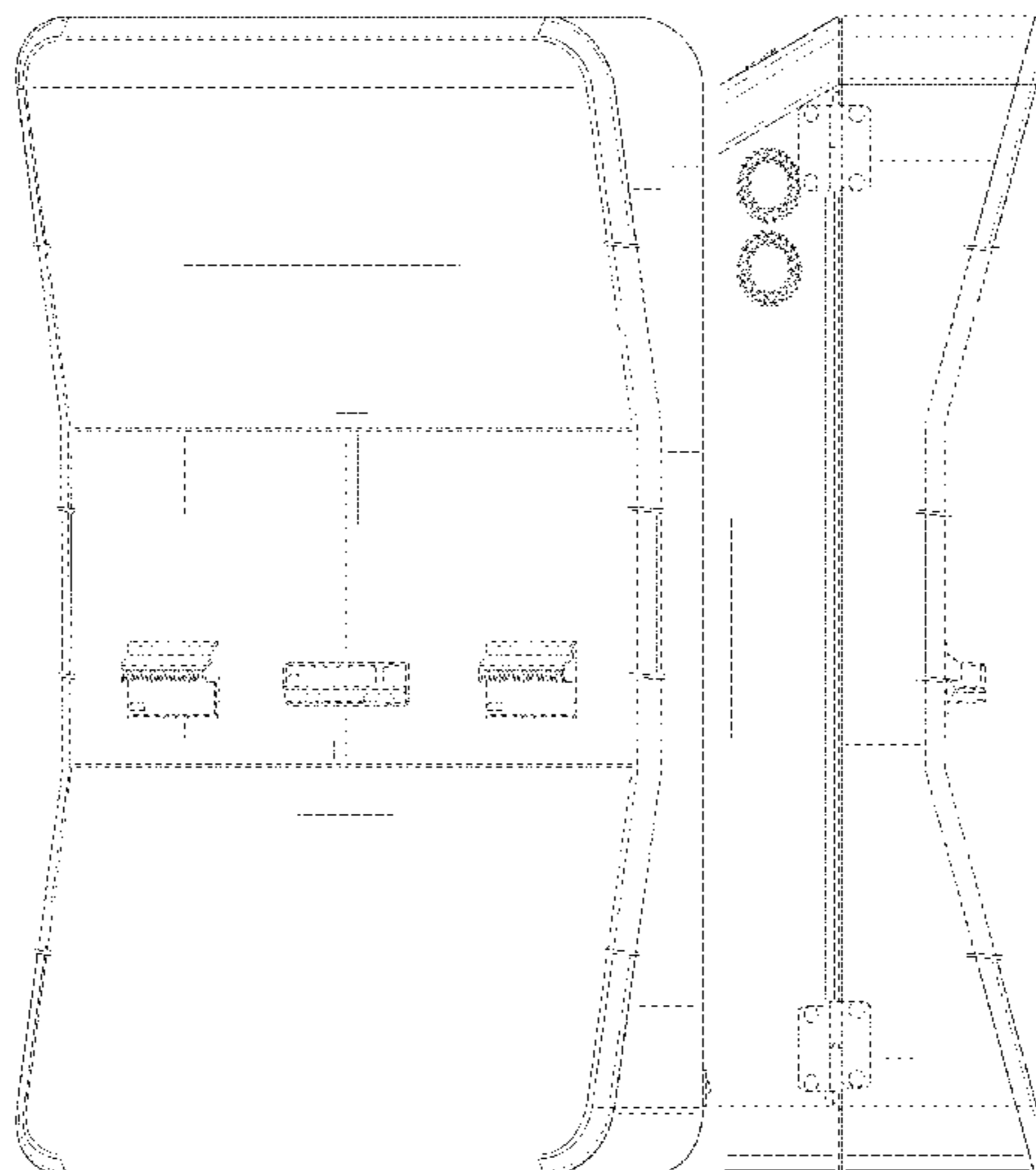

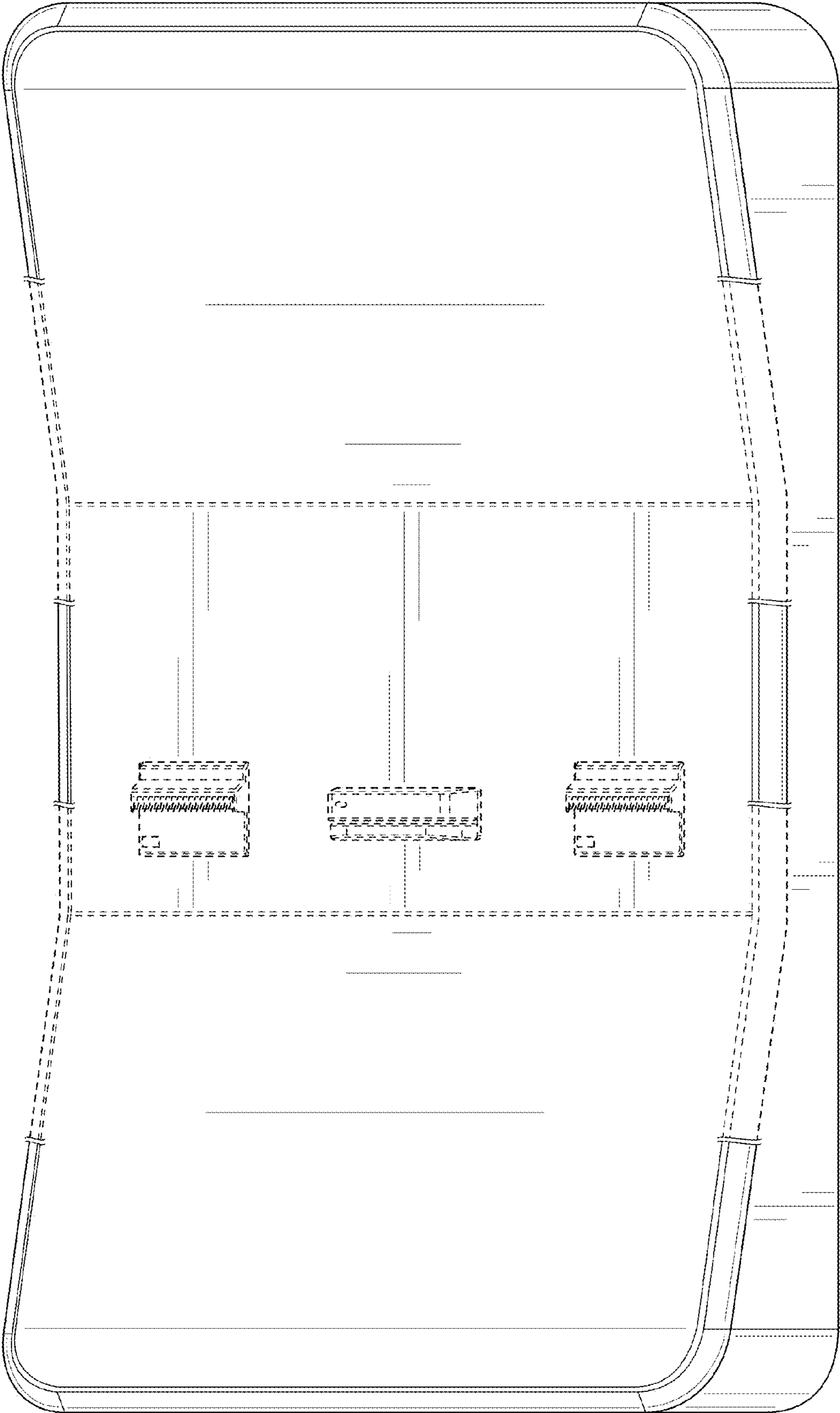

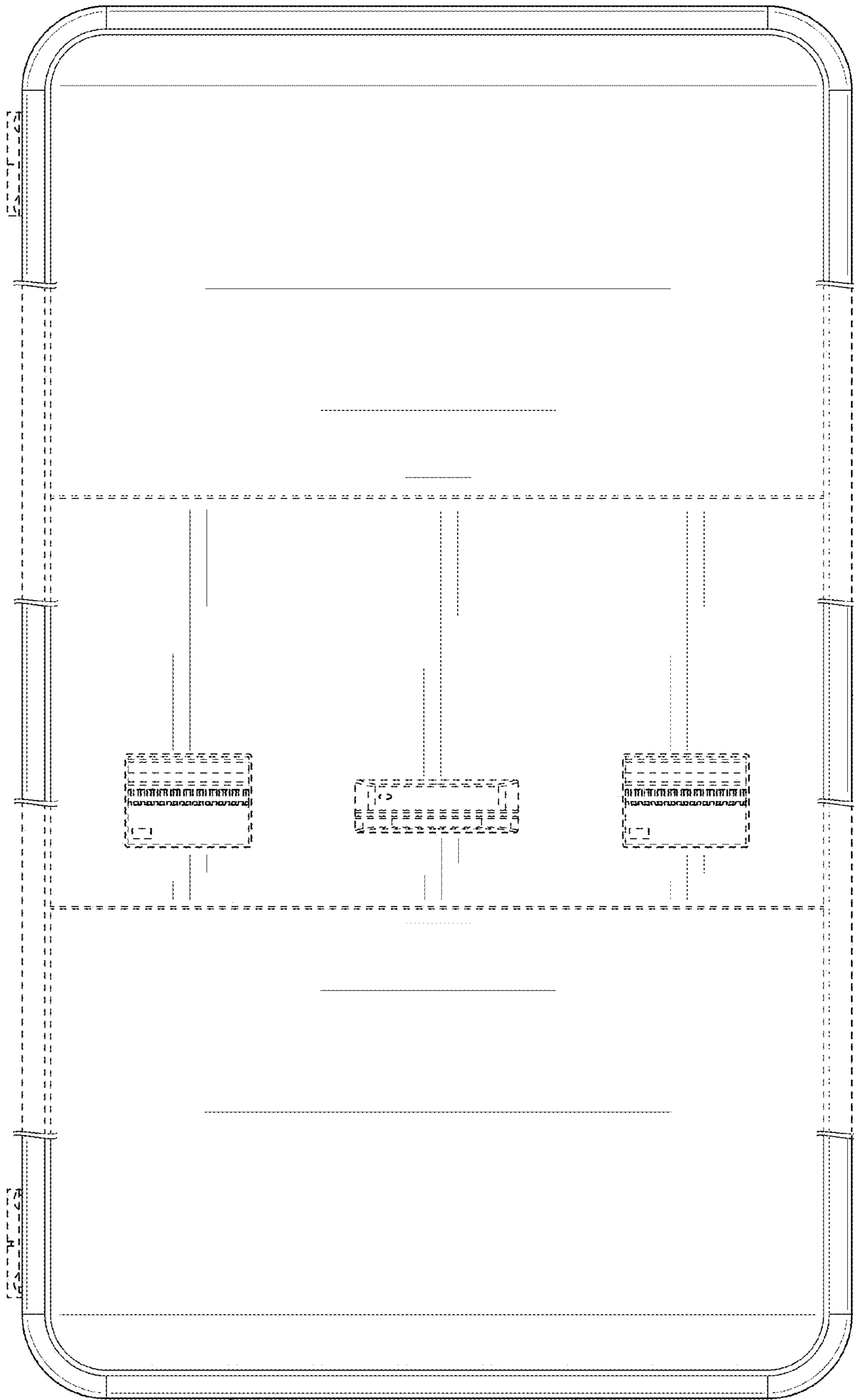

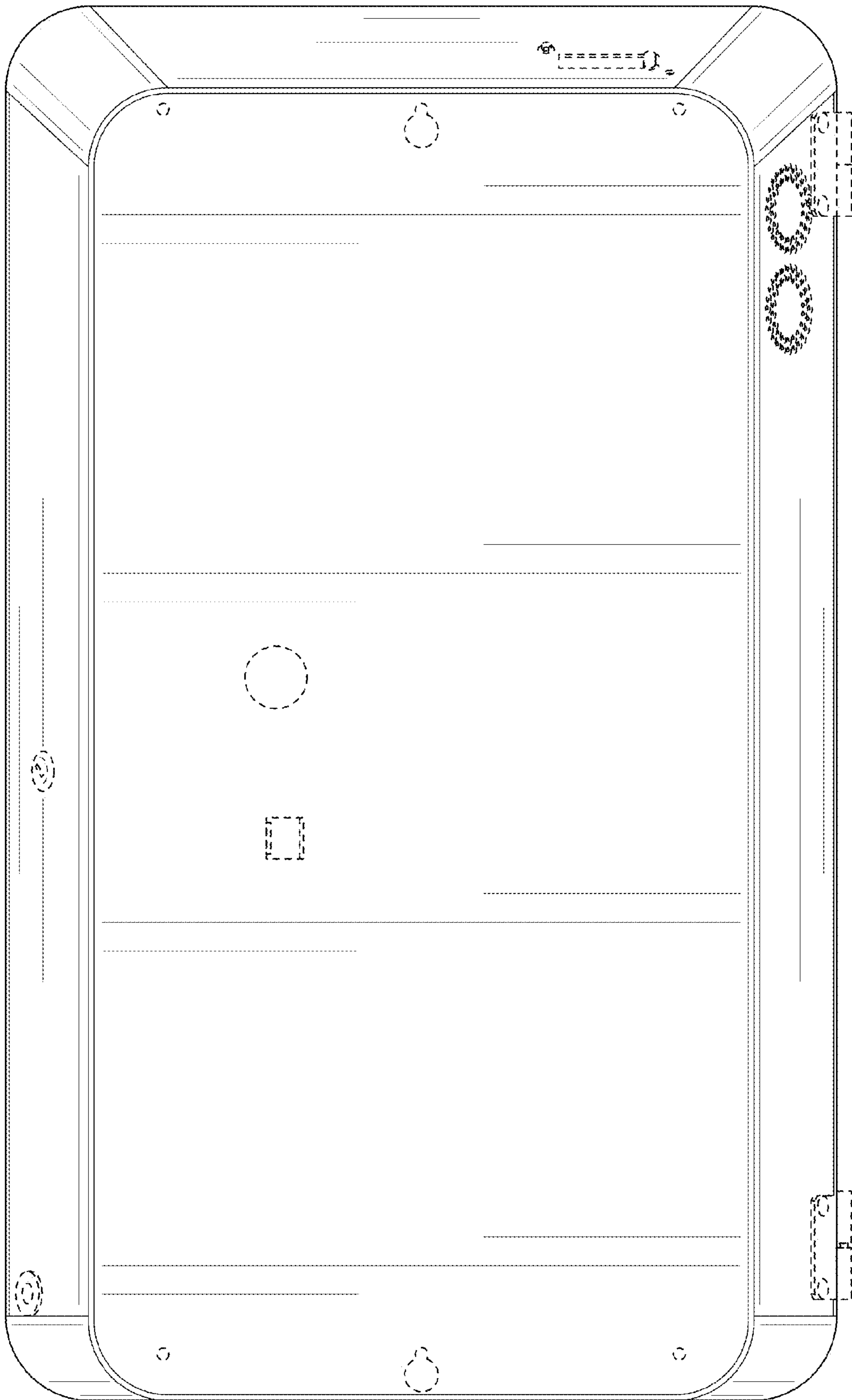

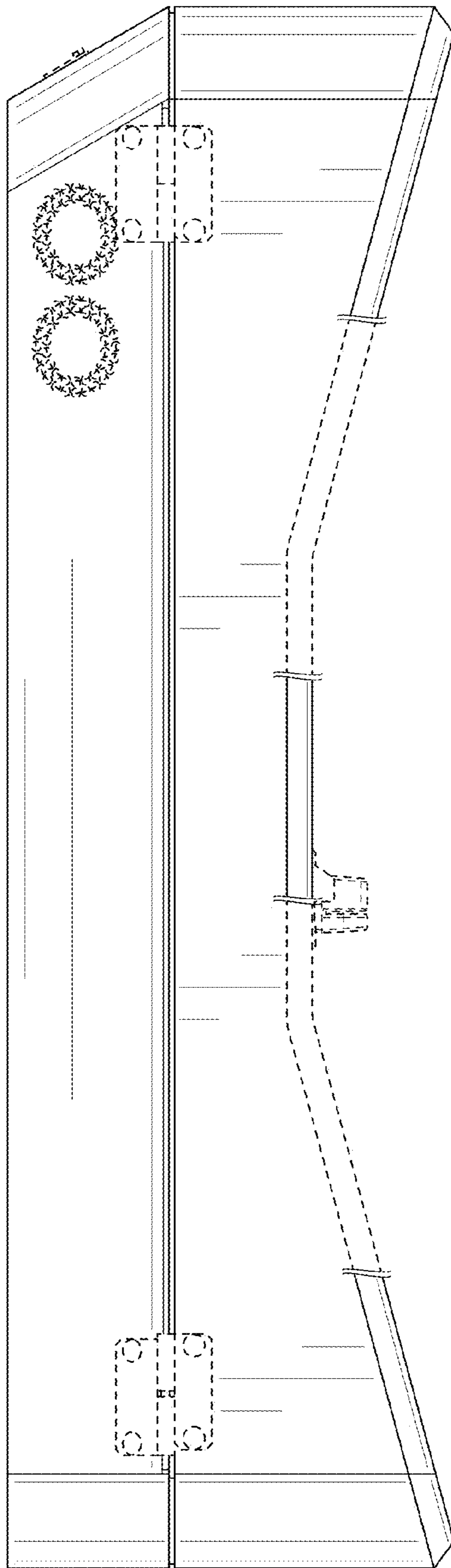

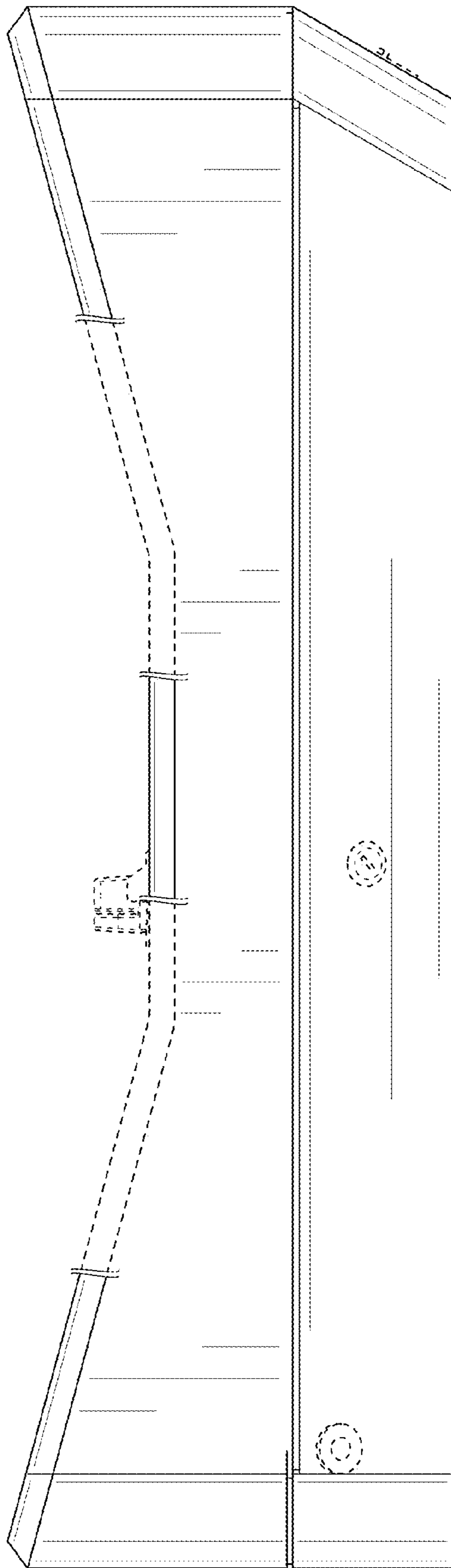

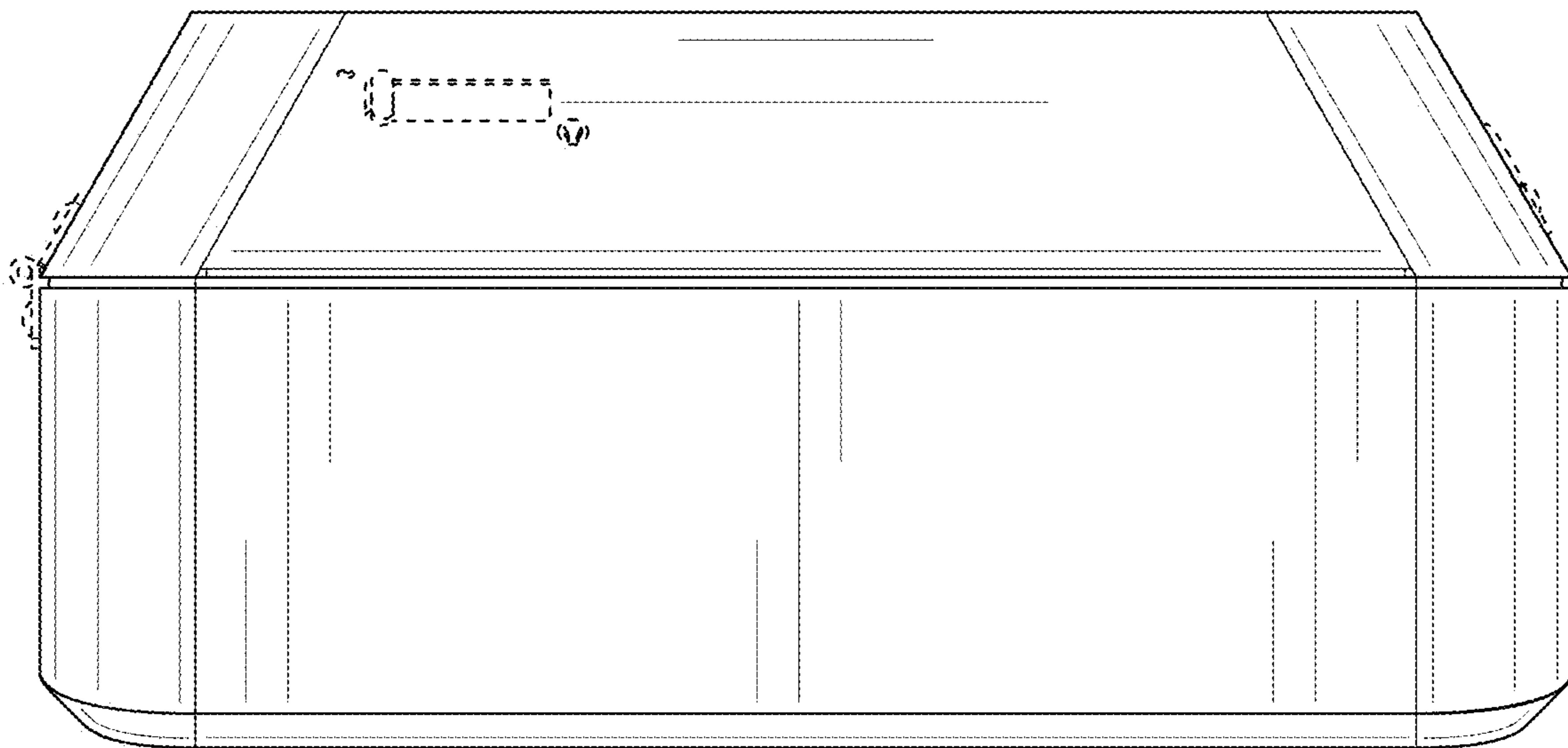

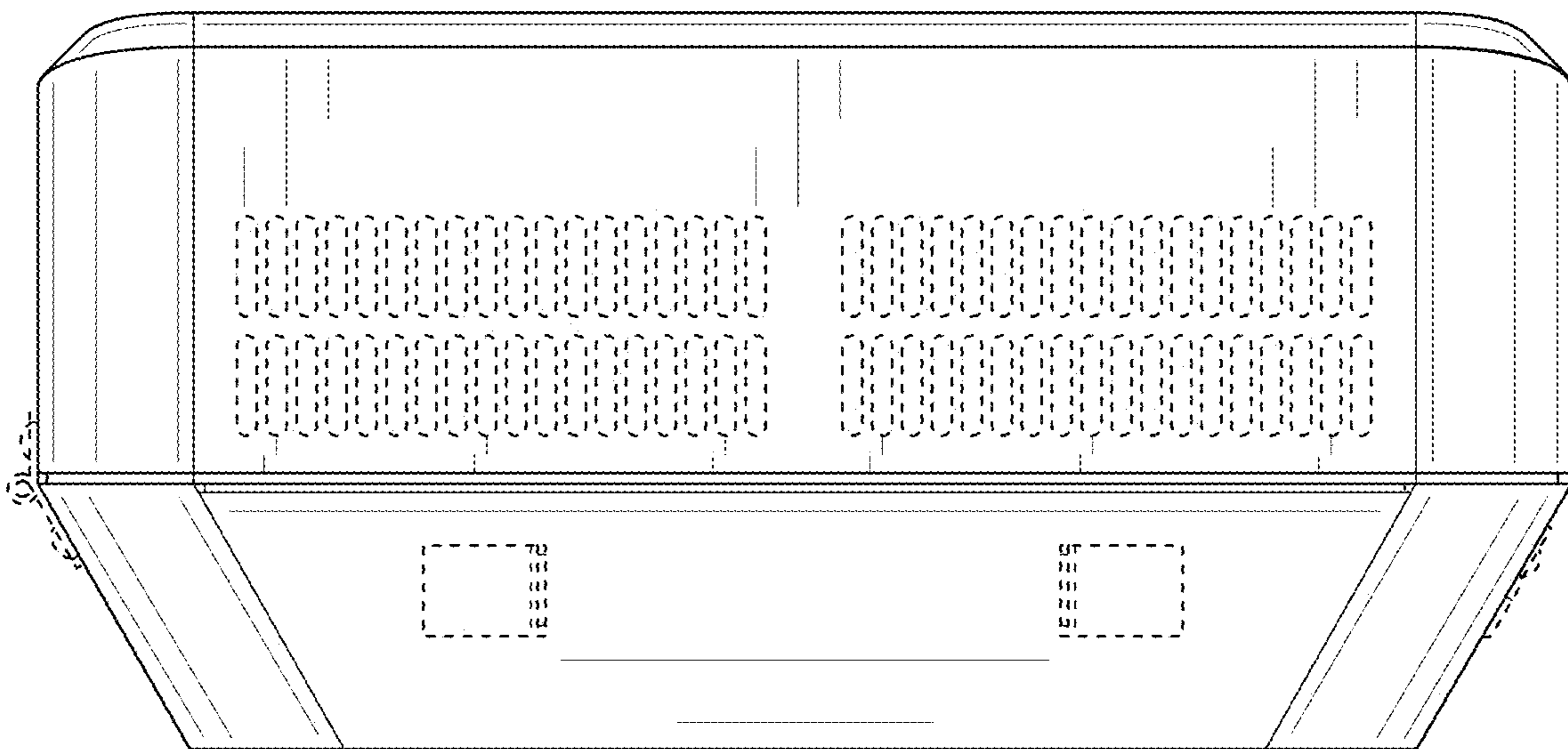
