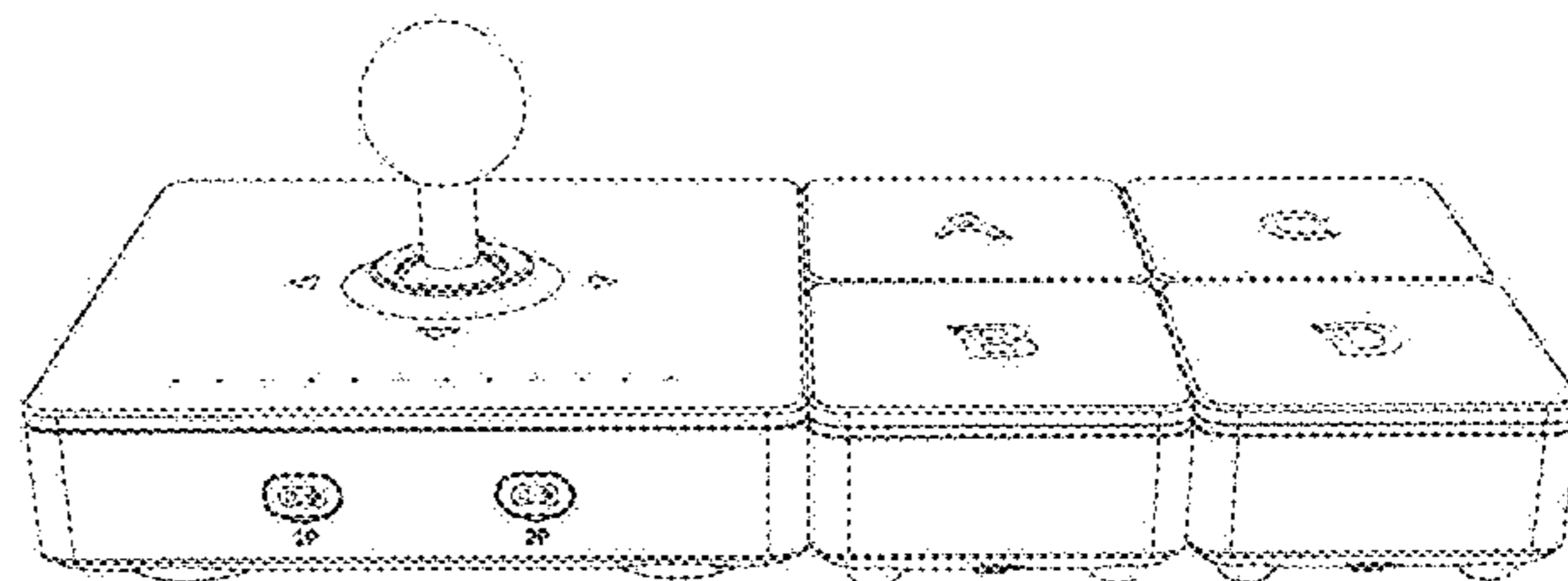
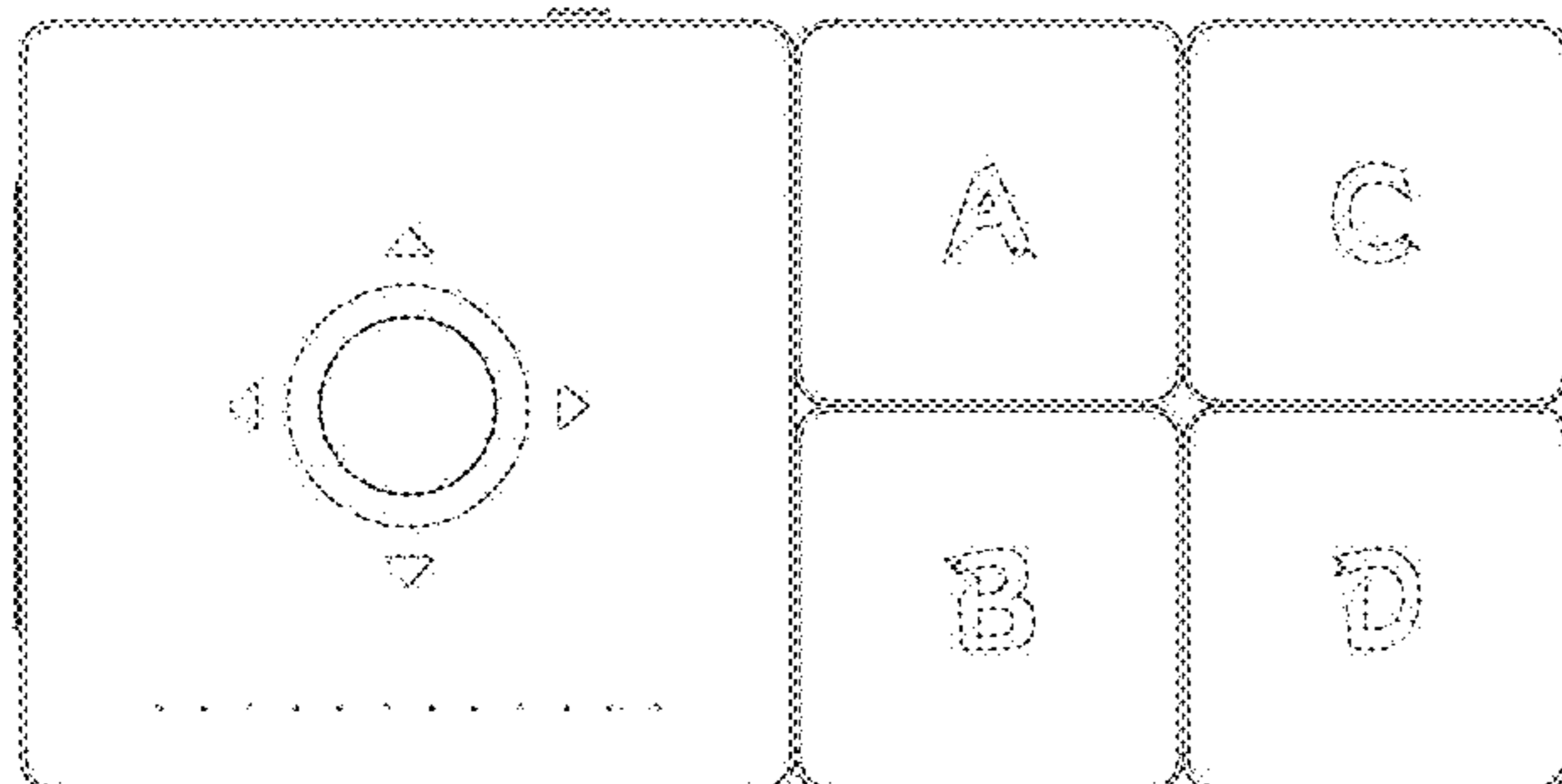


FIG. 20 is a front view of the second assembly of the video game controller;

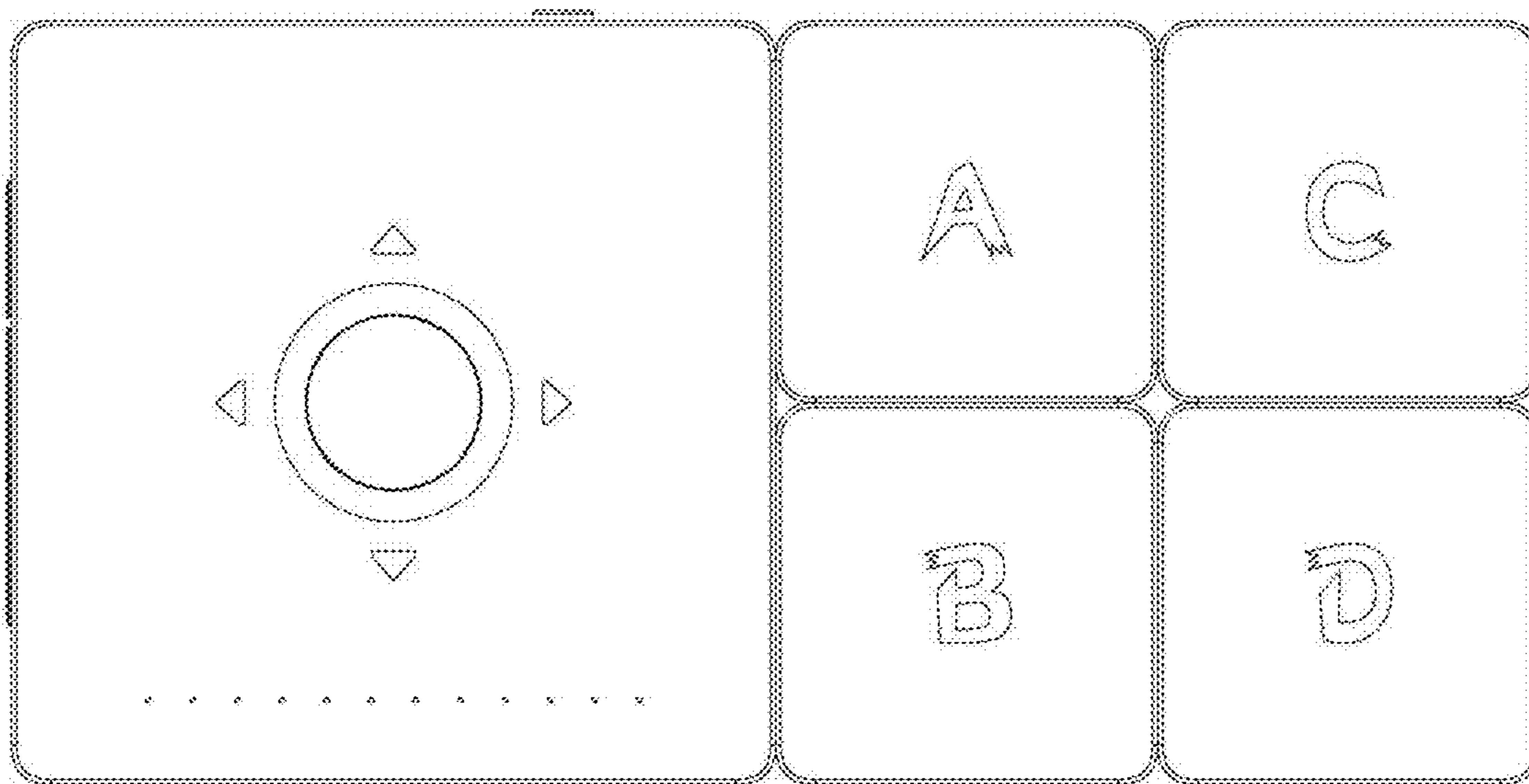

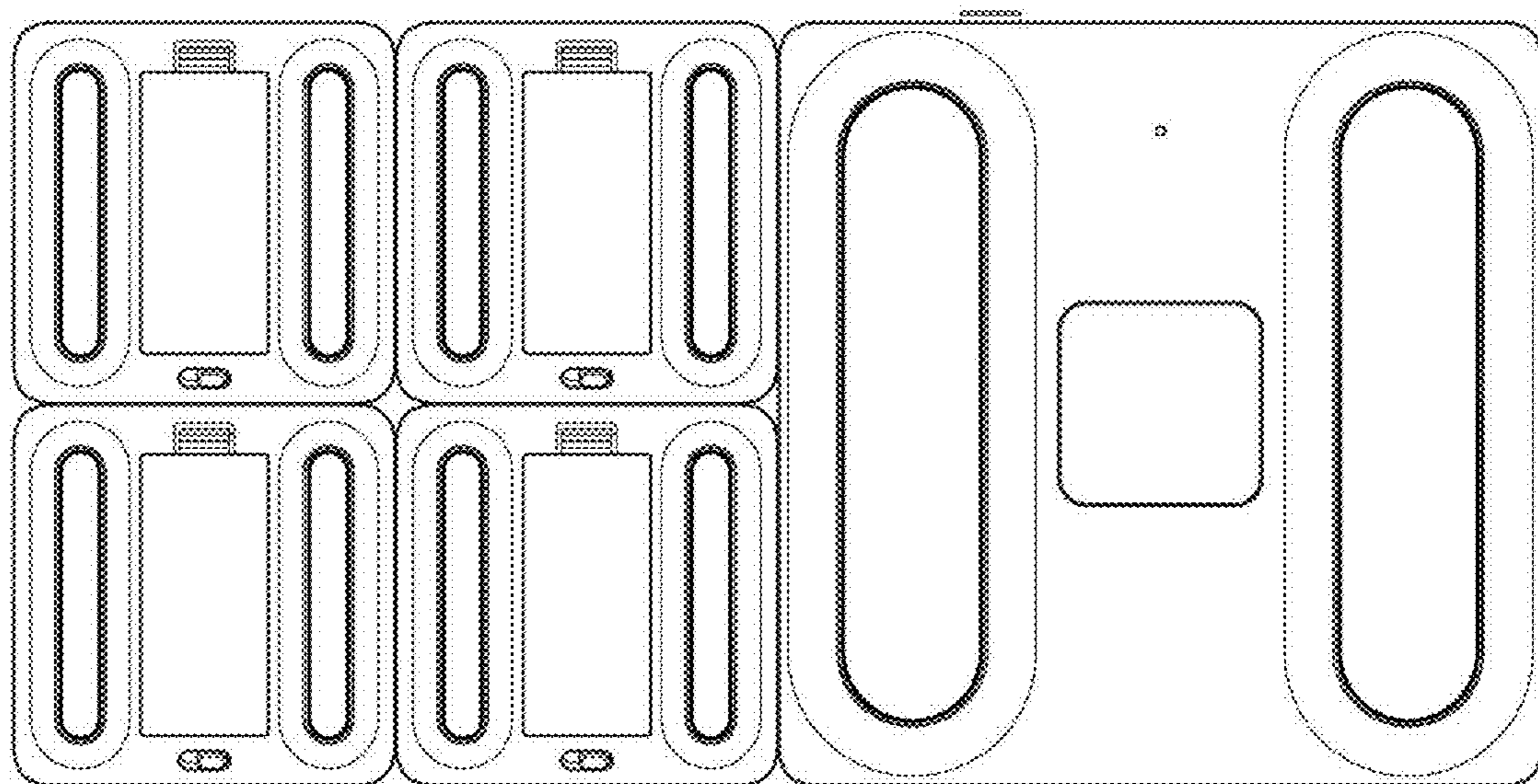

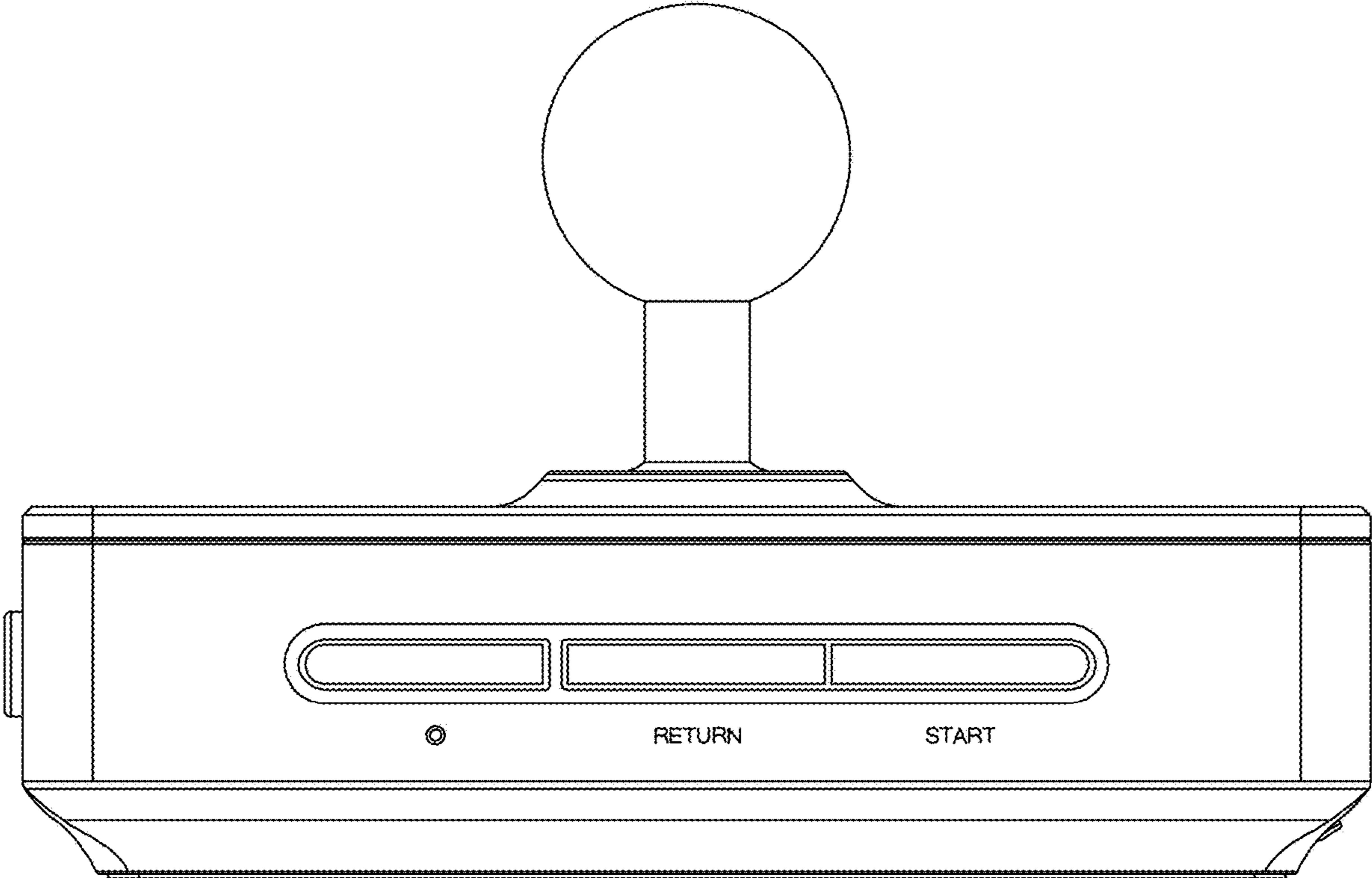

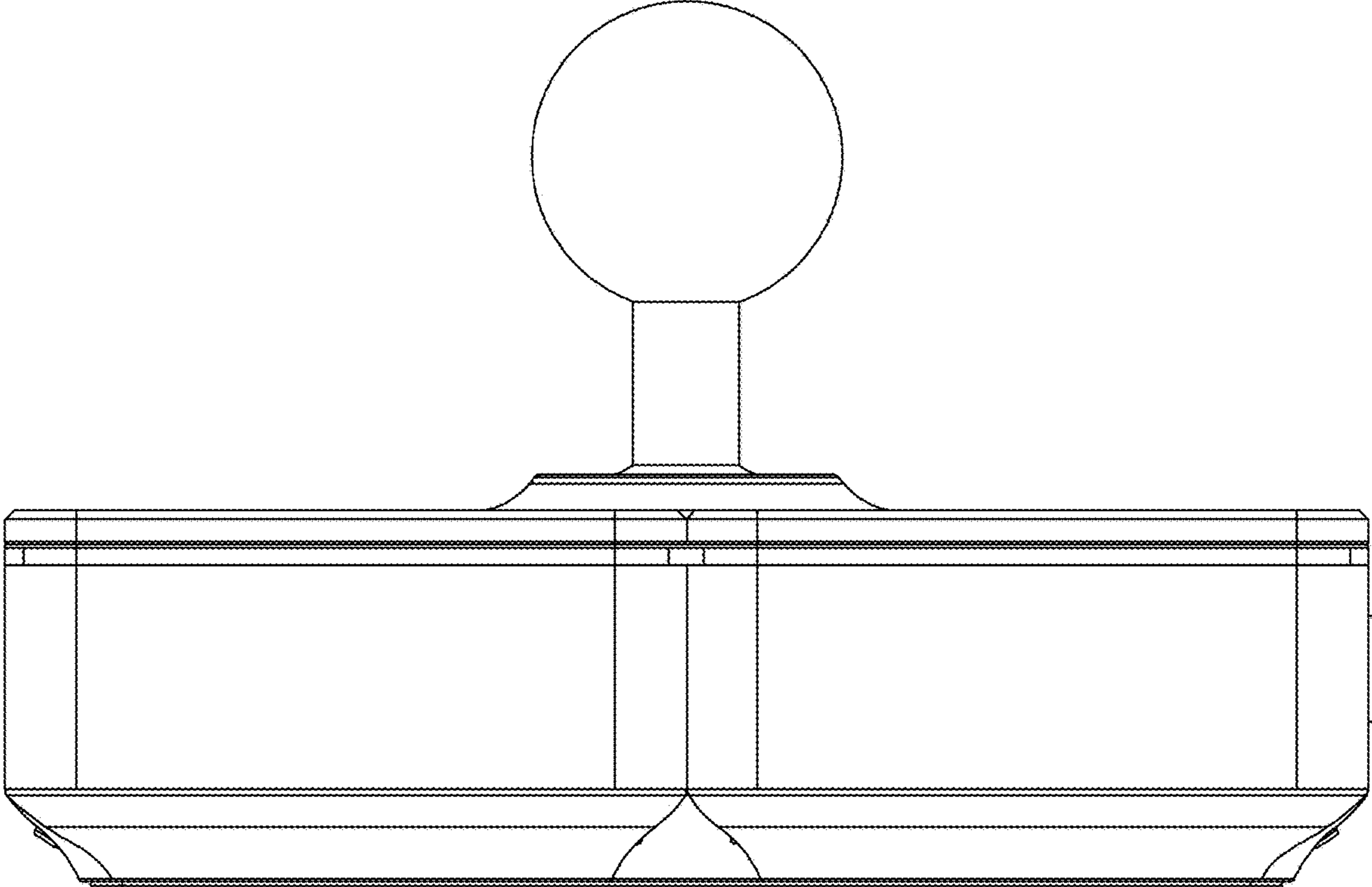

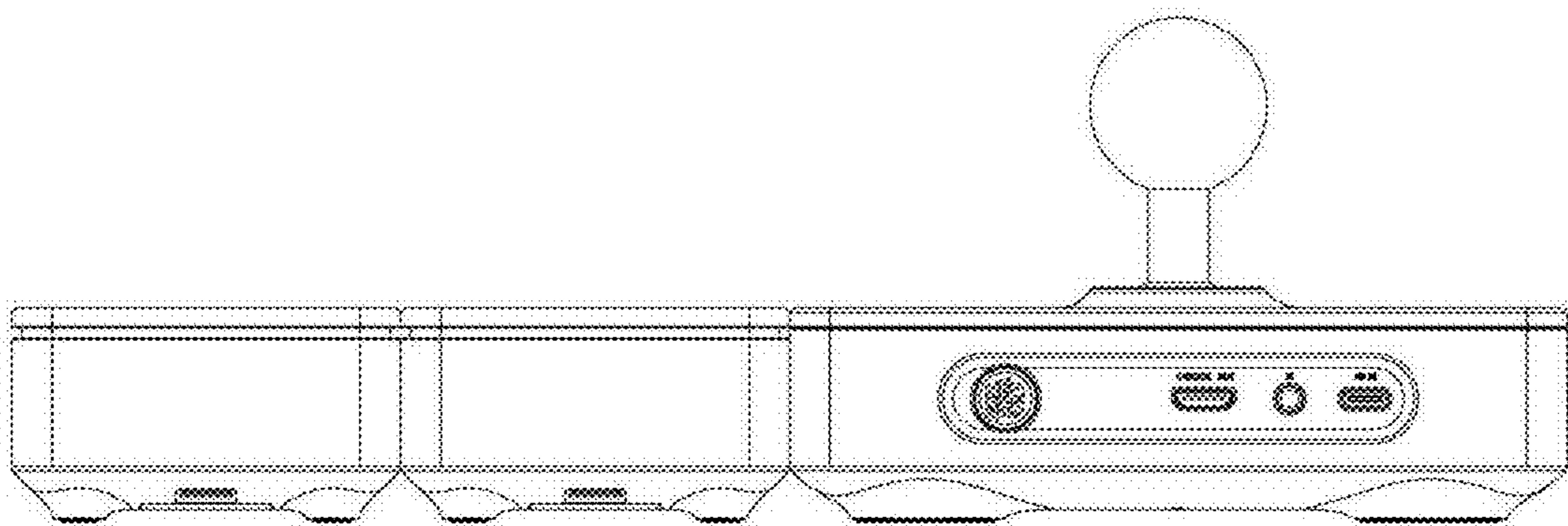

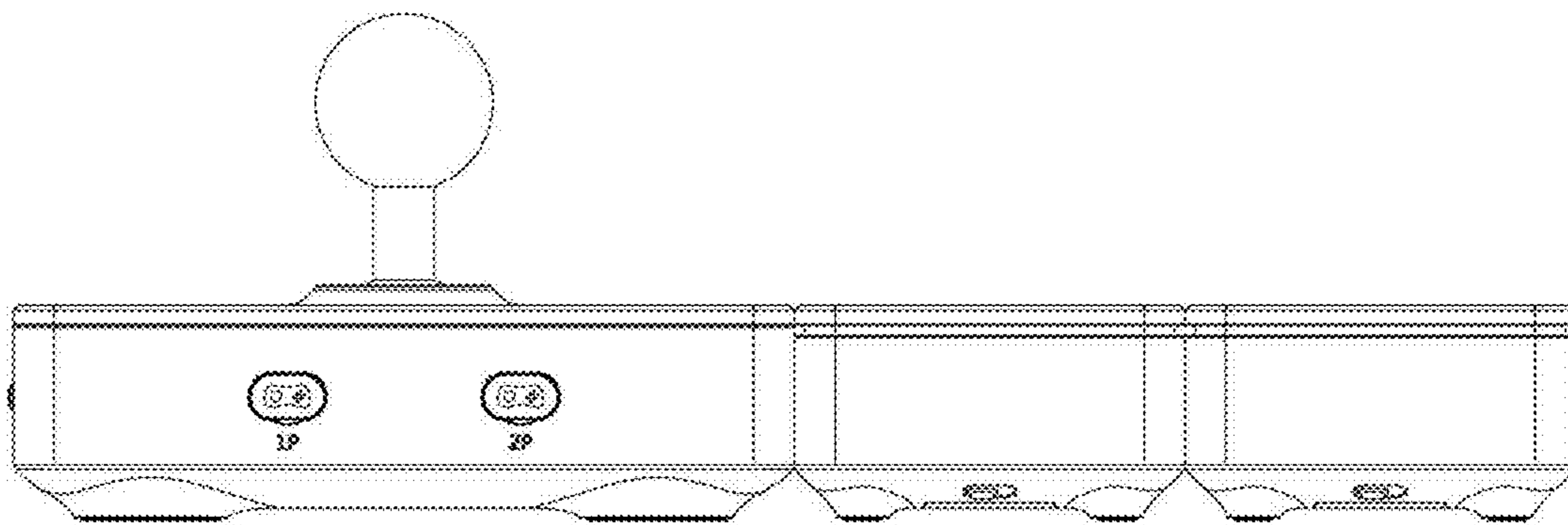

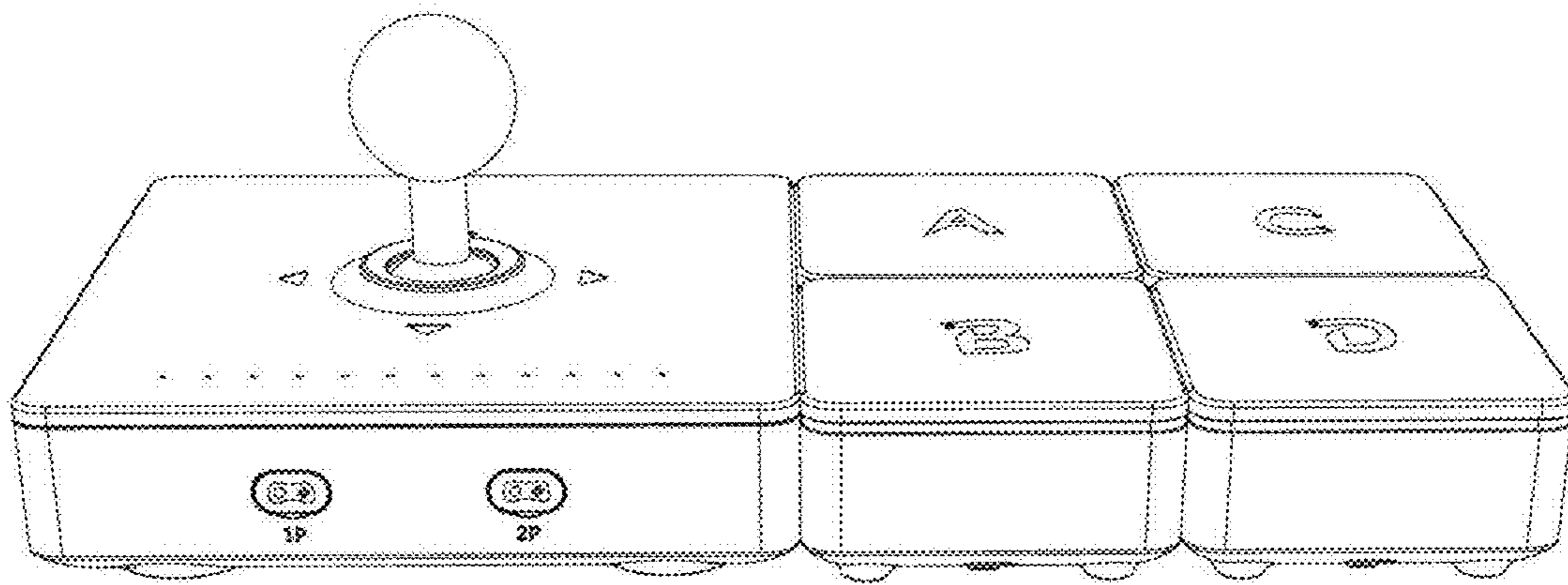

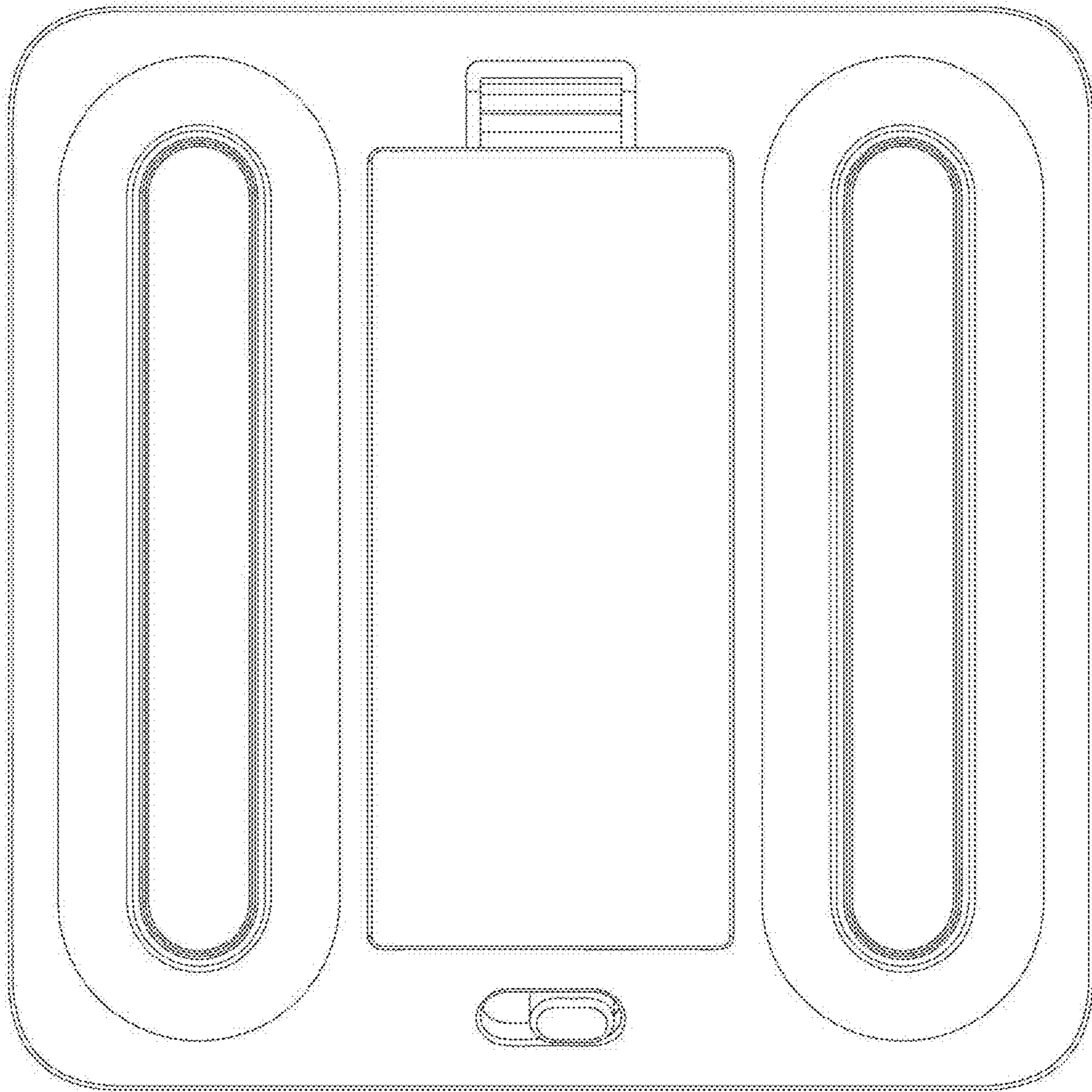

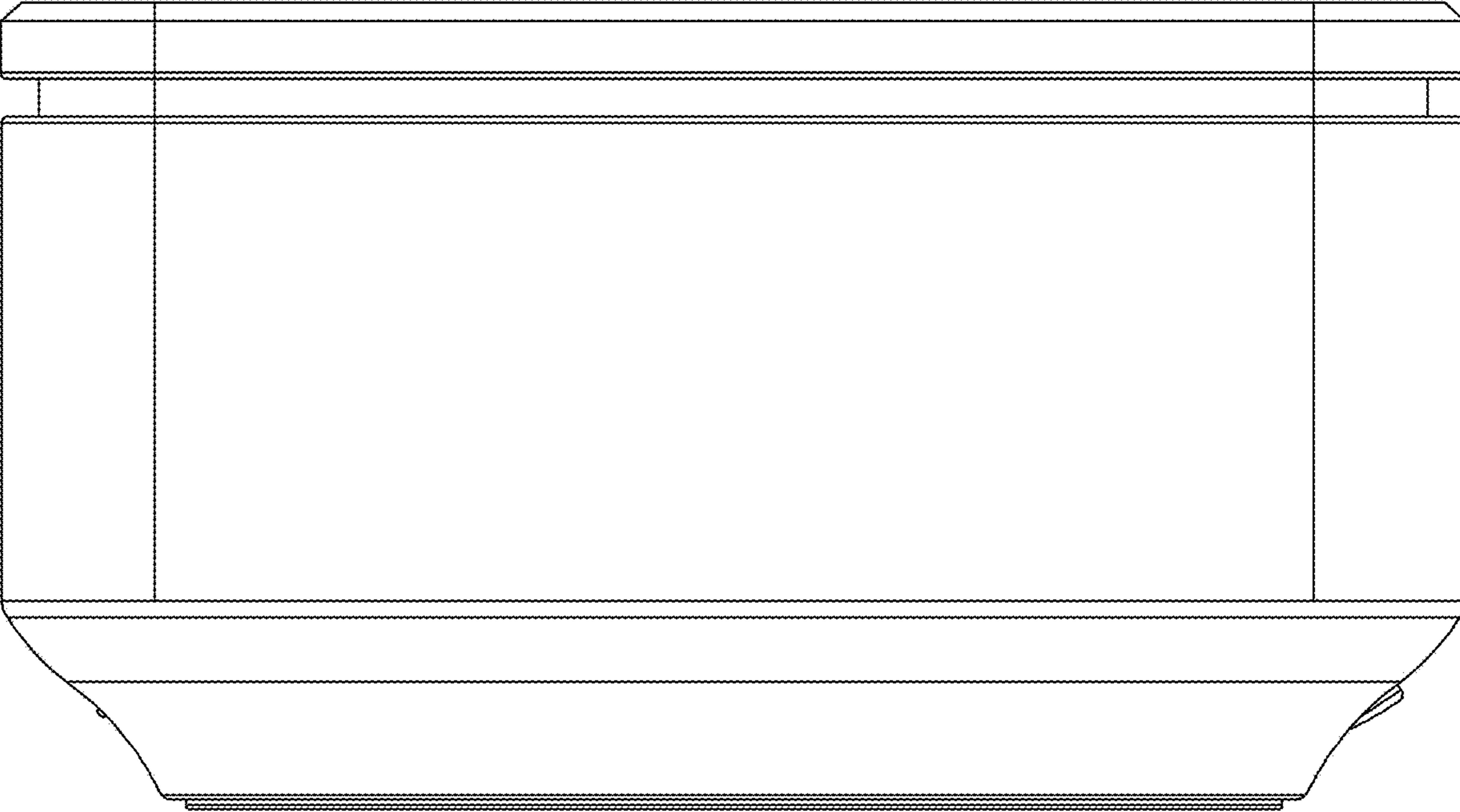

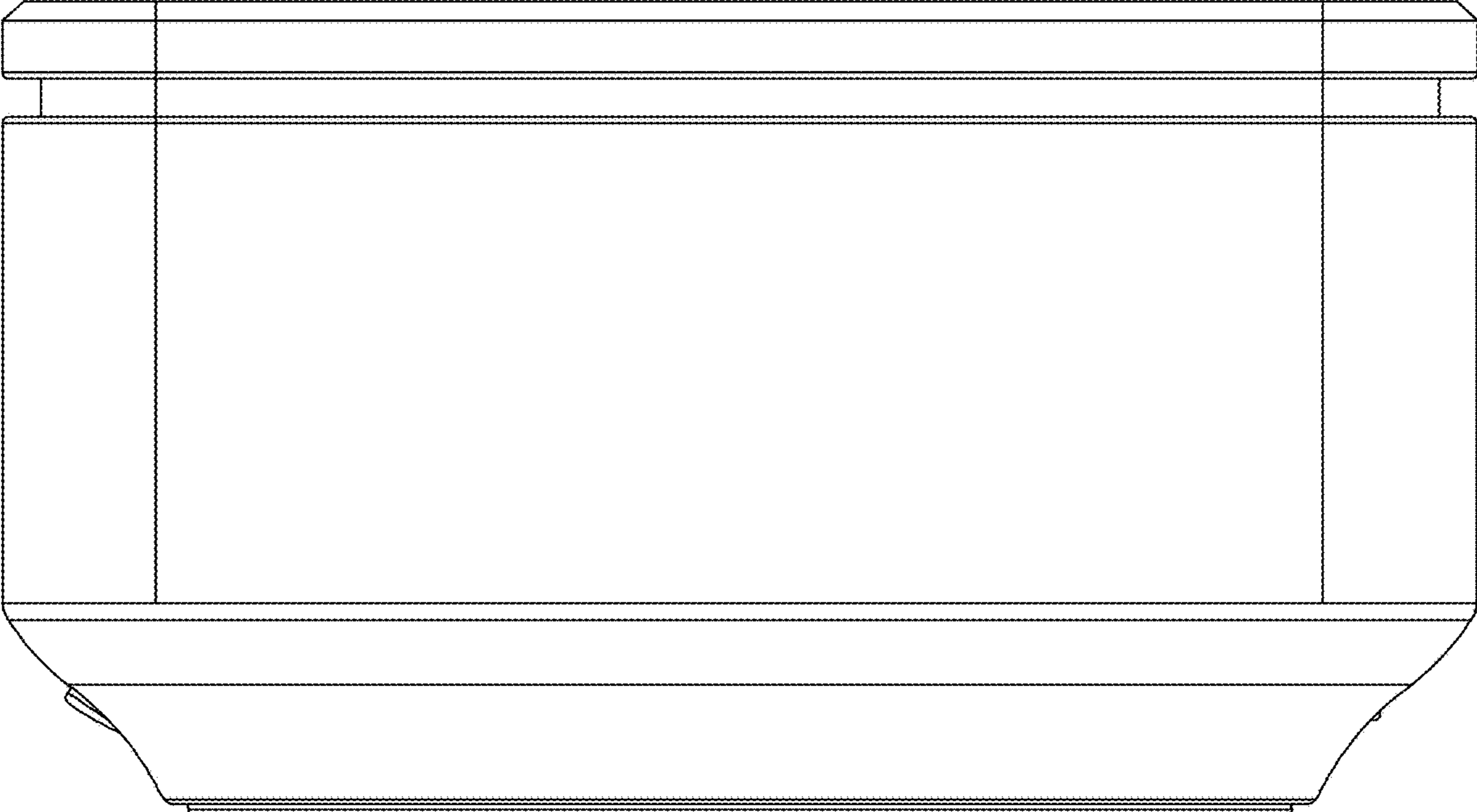

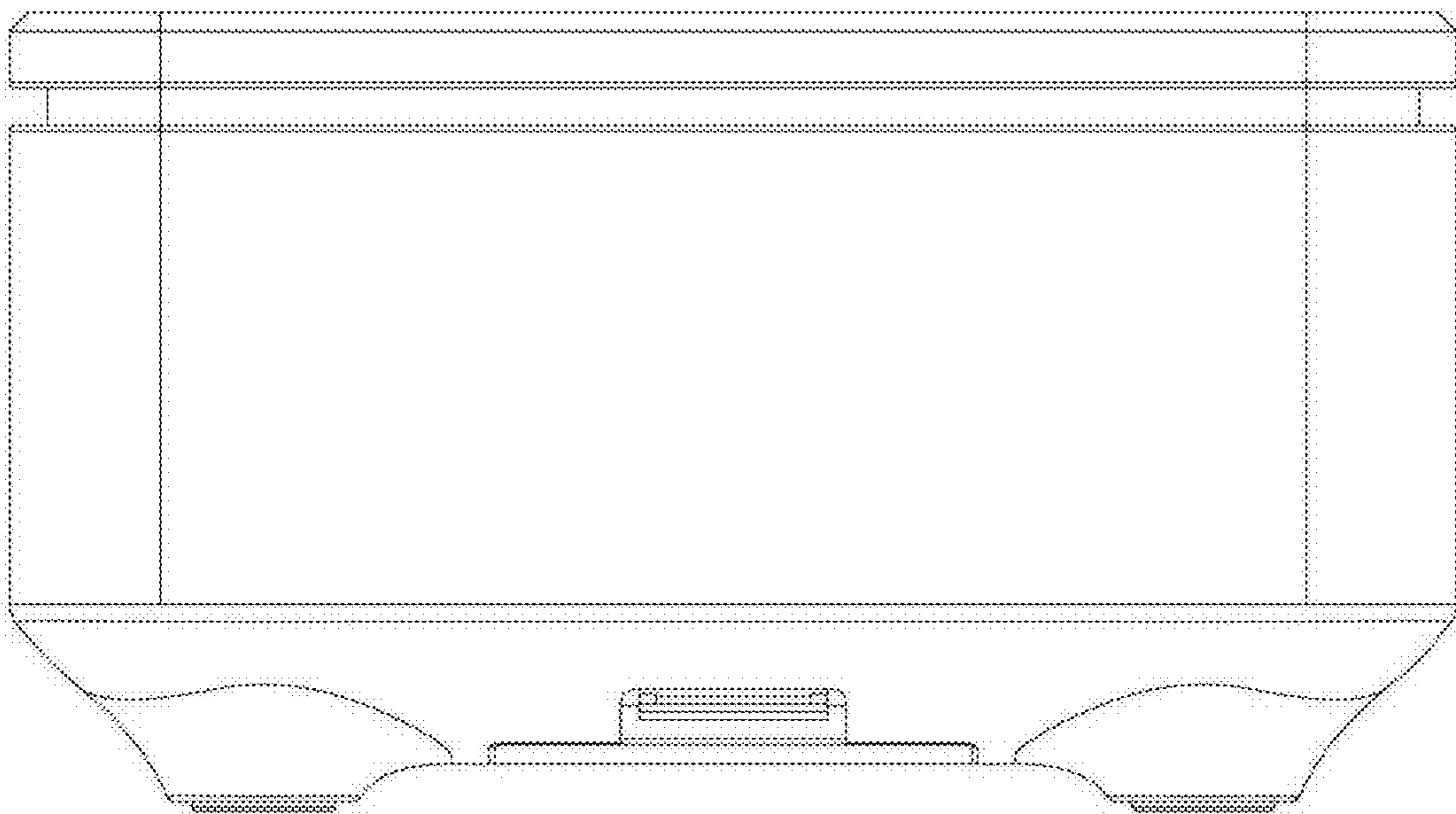

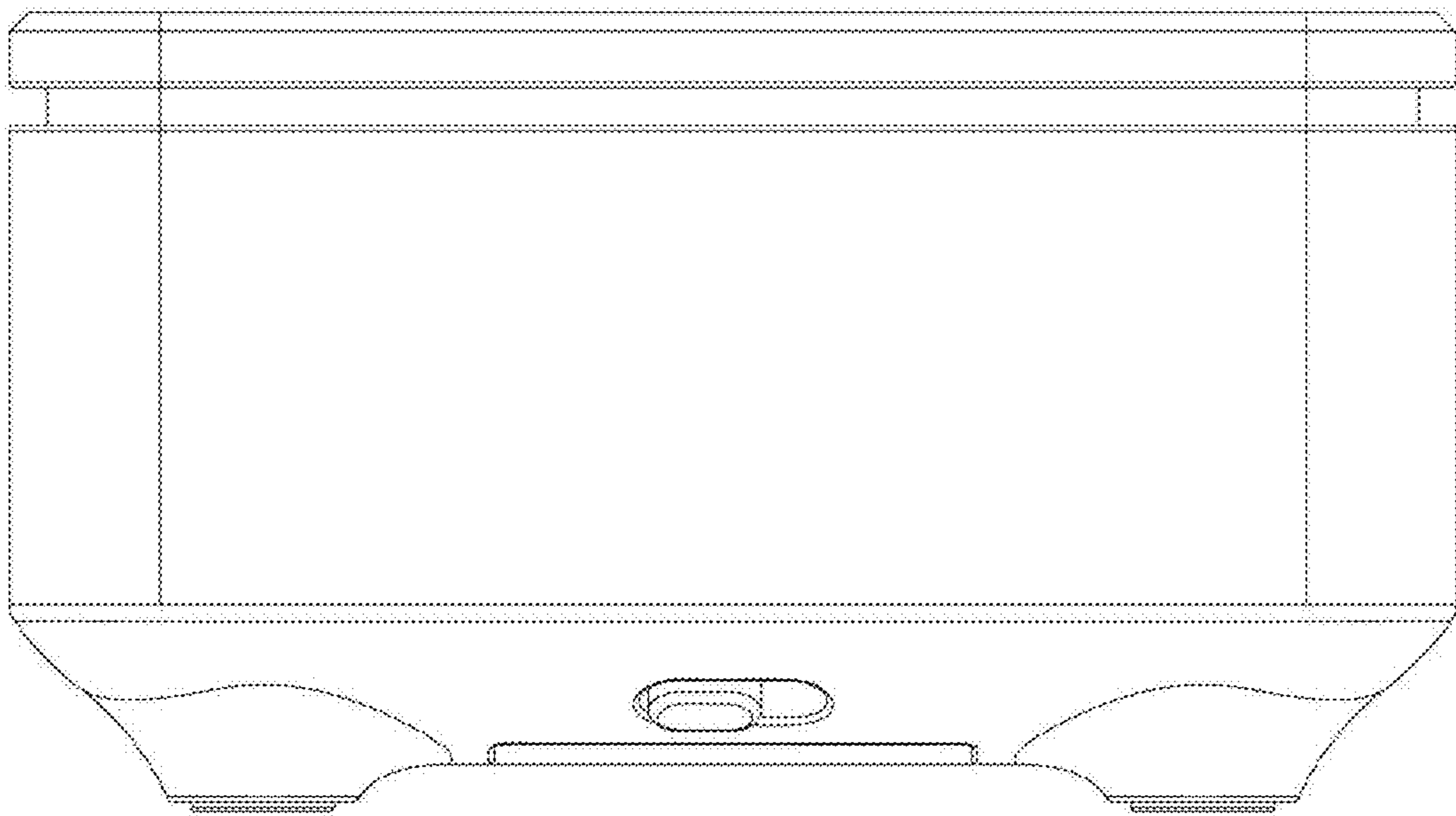

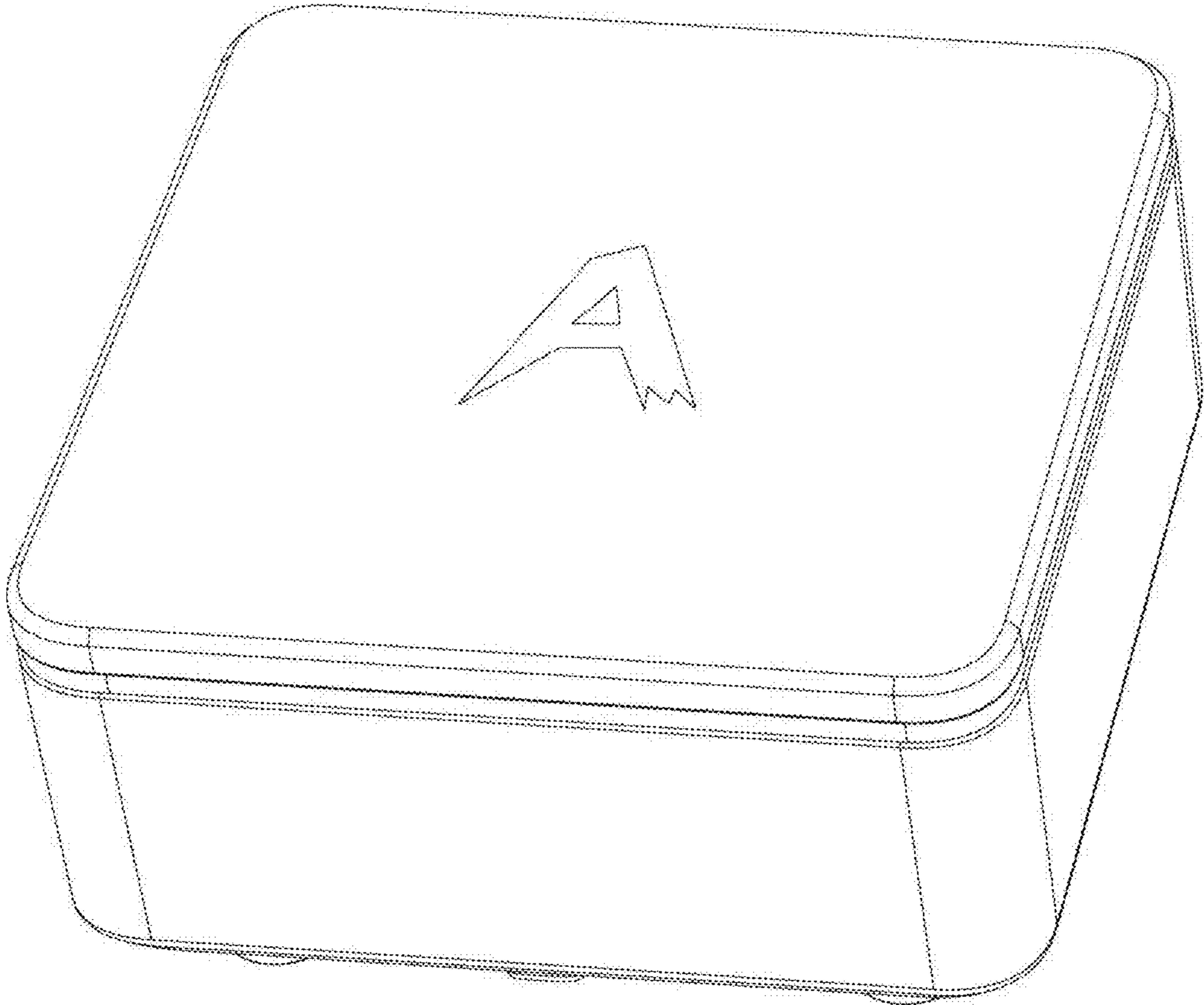
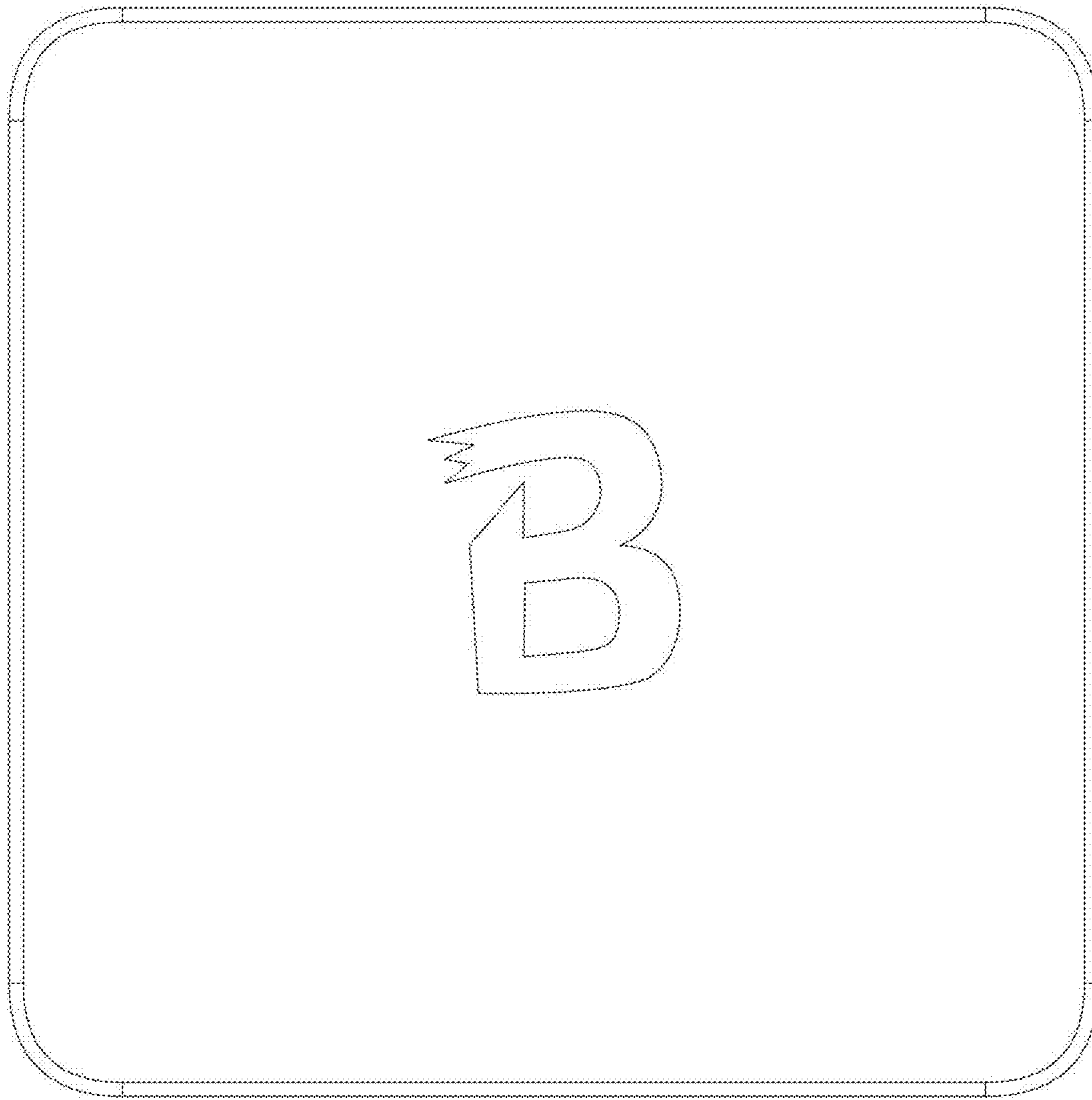

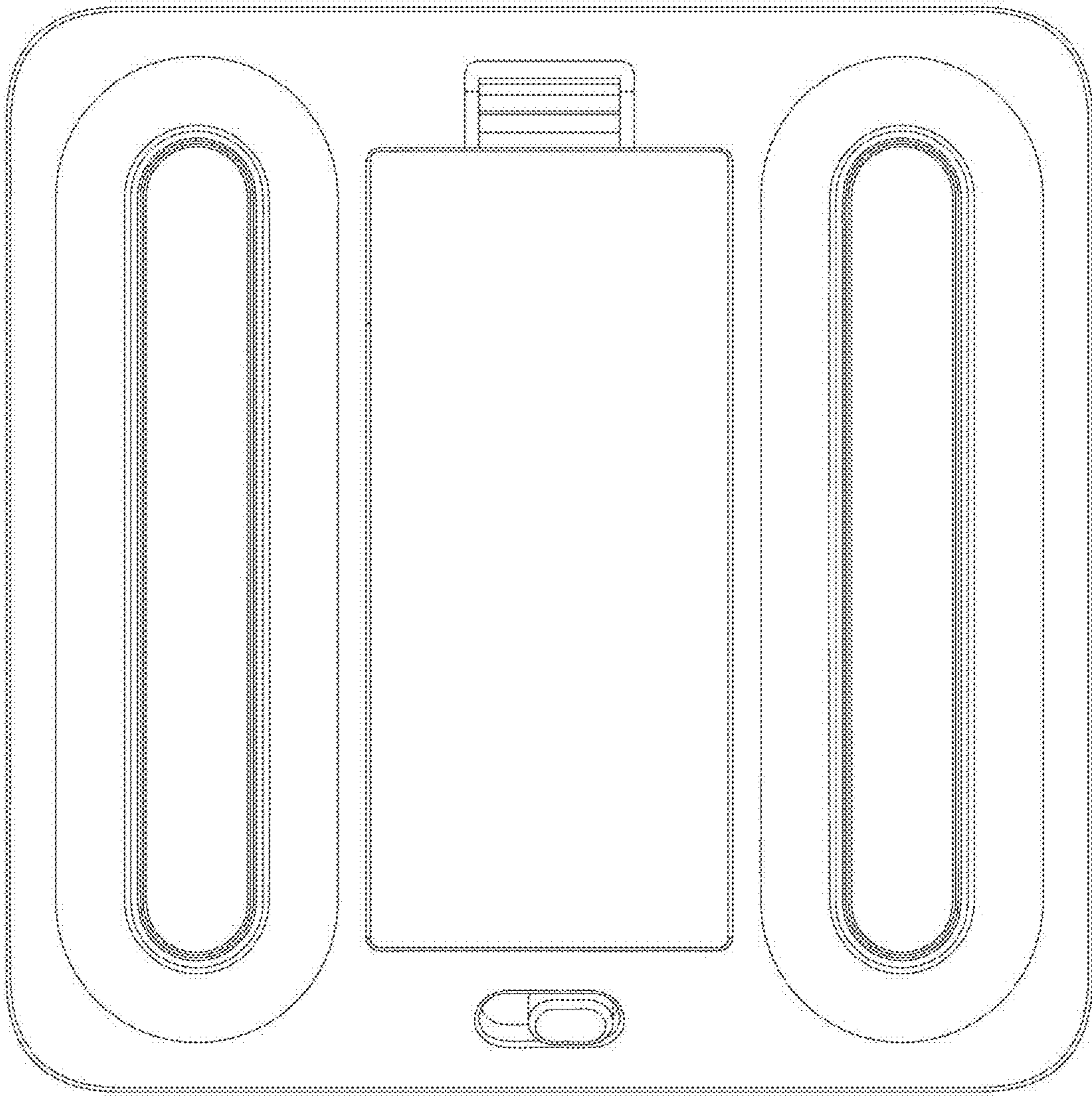

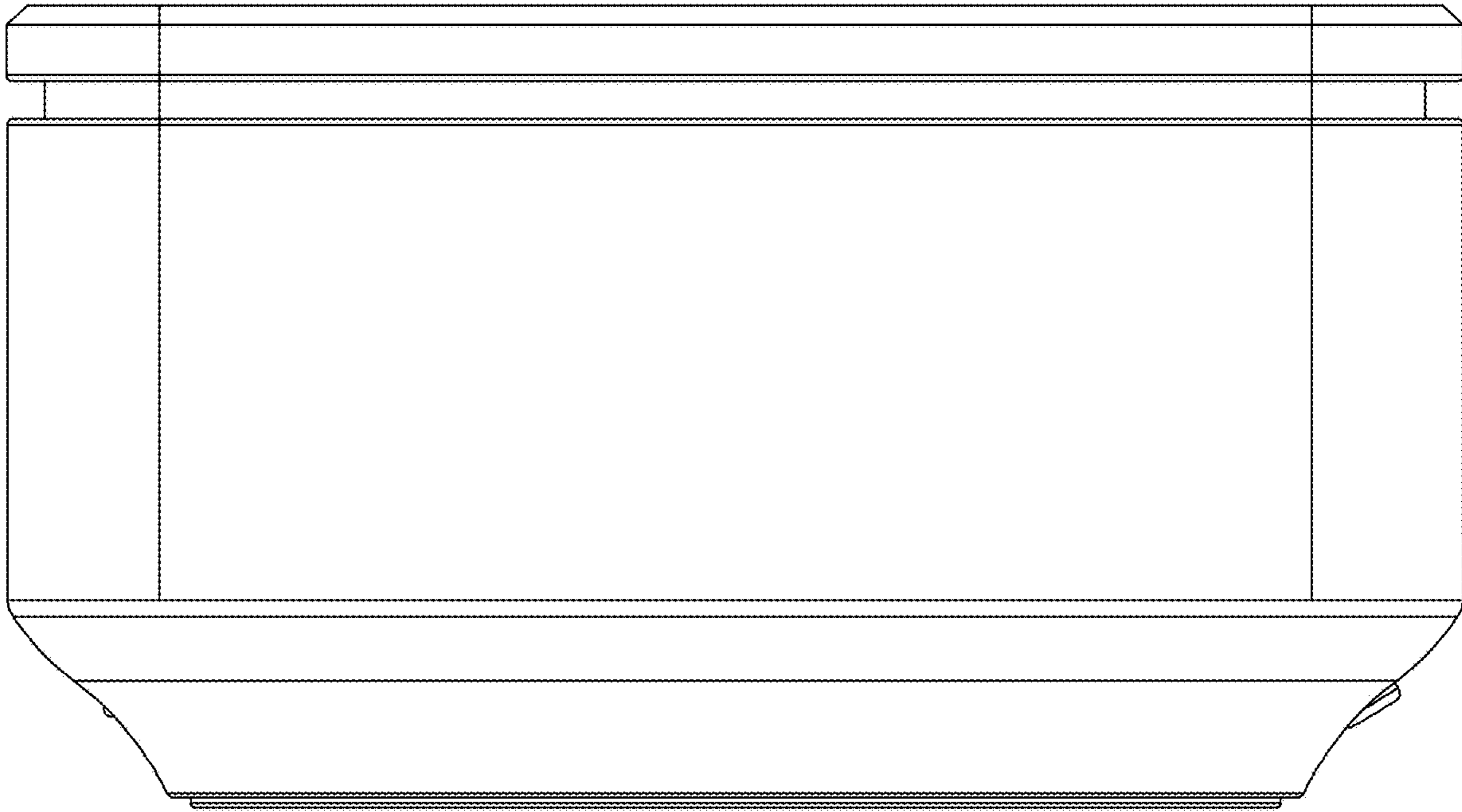

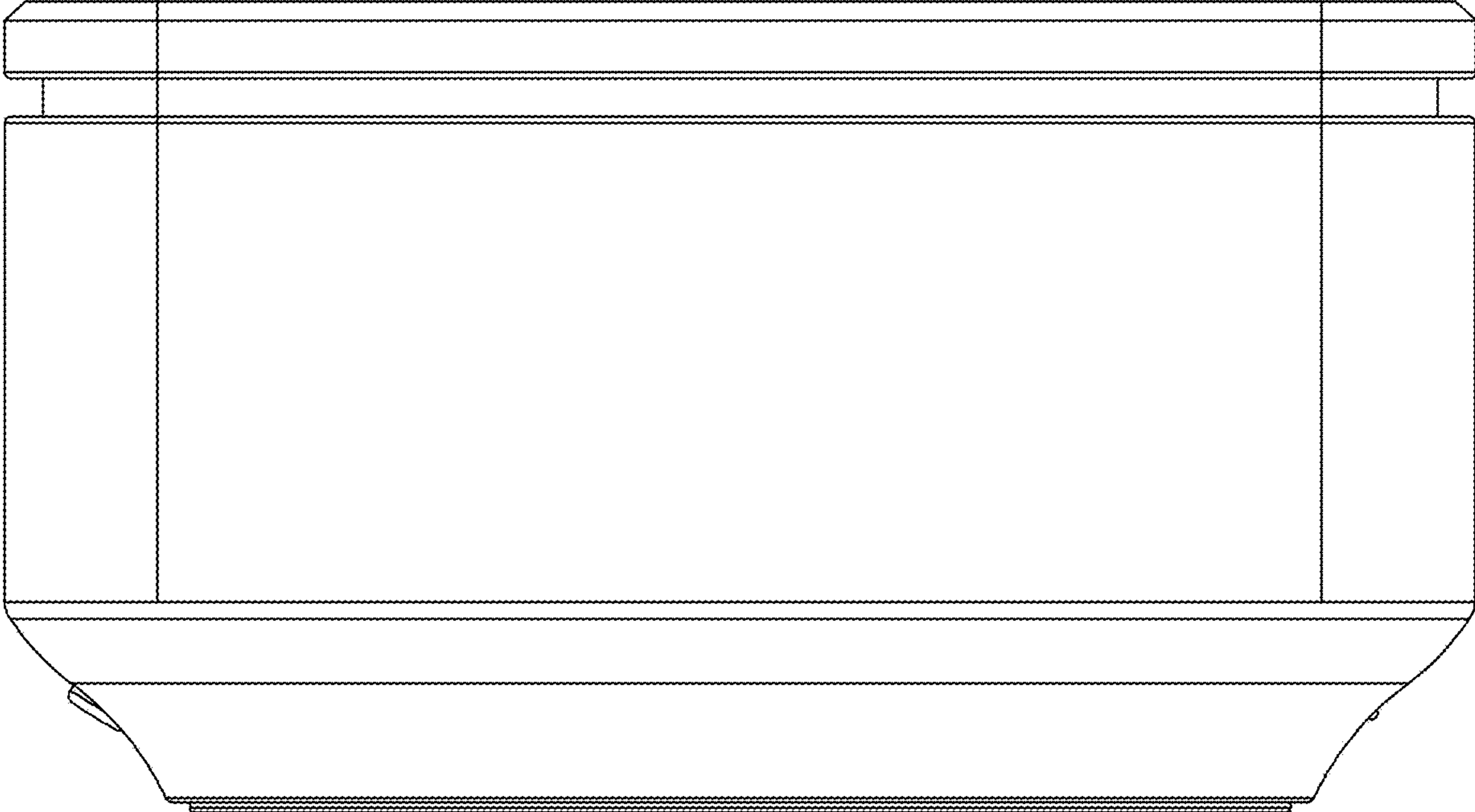

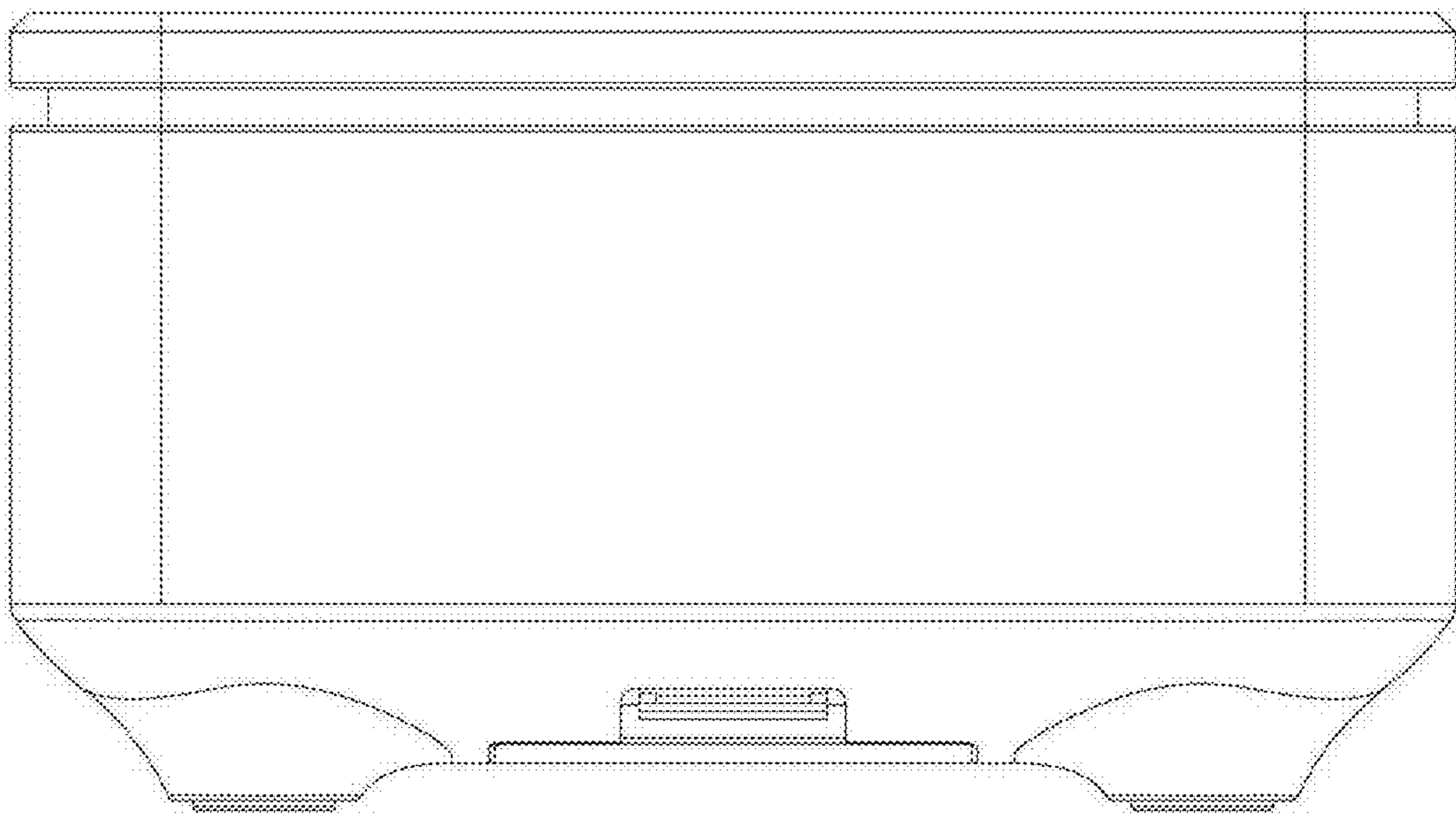
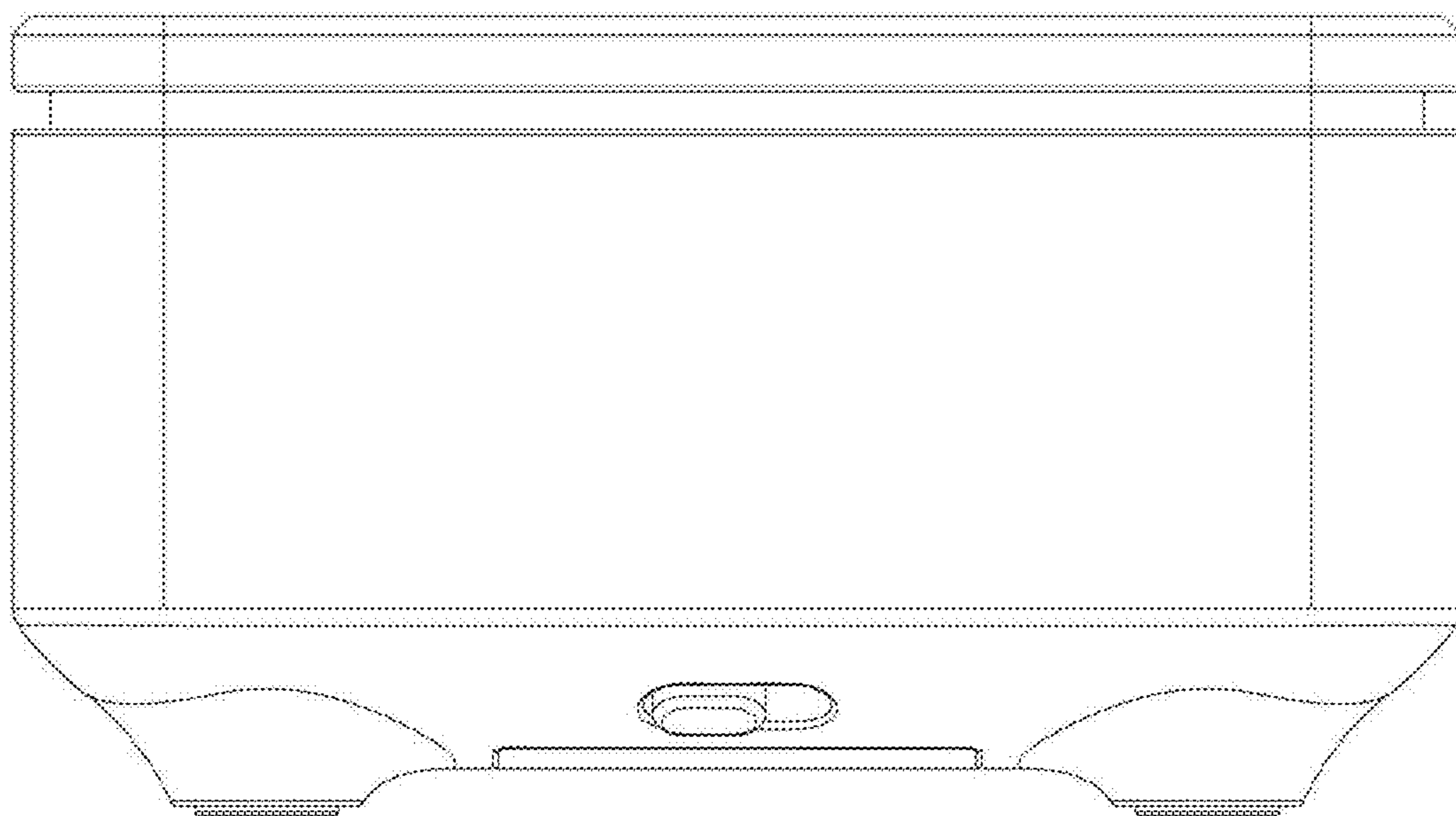

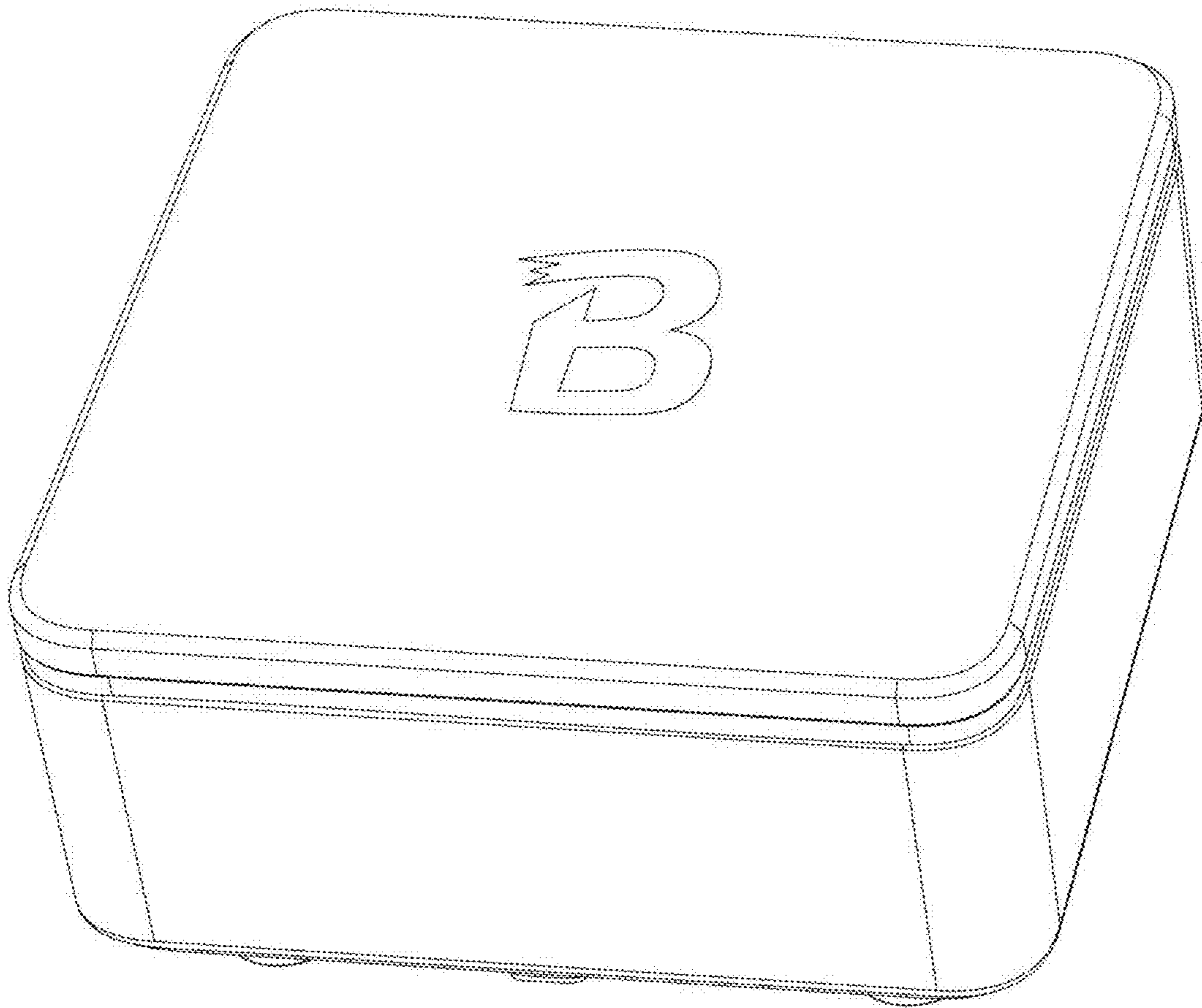
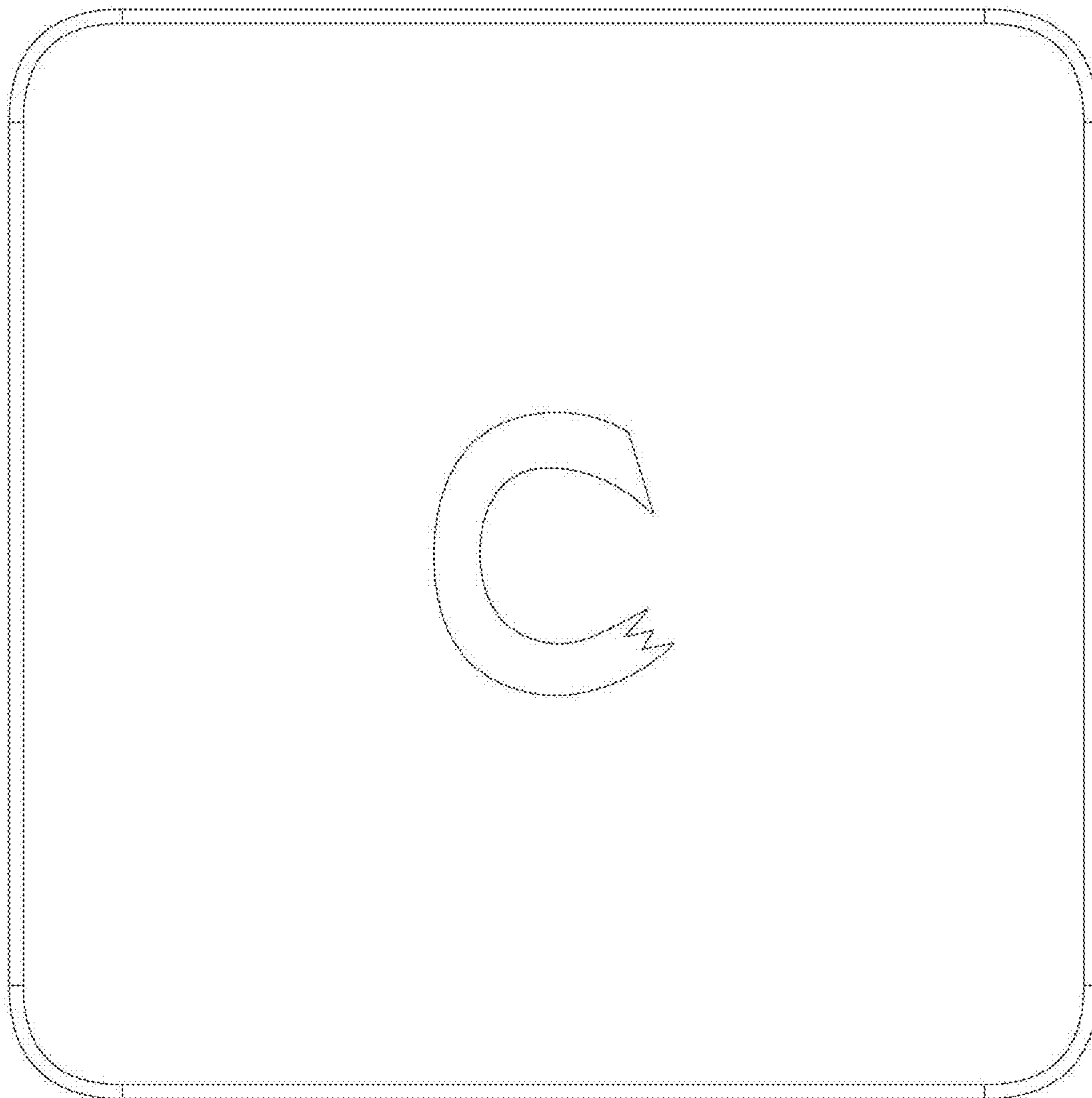

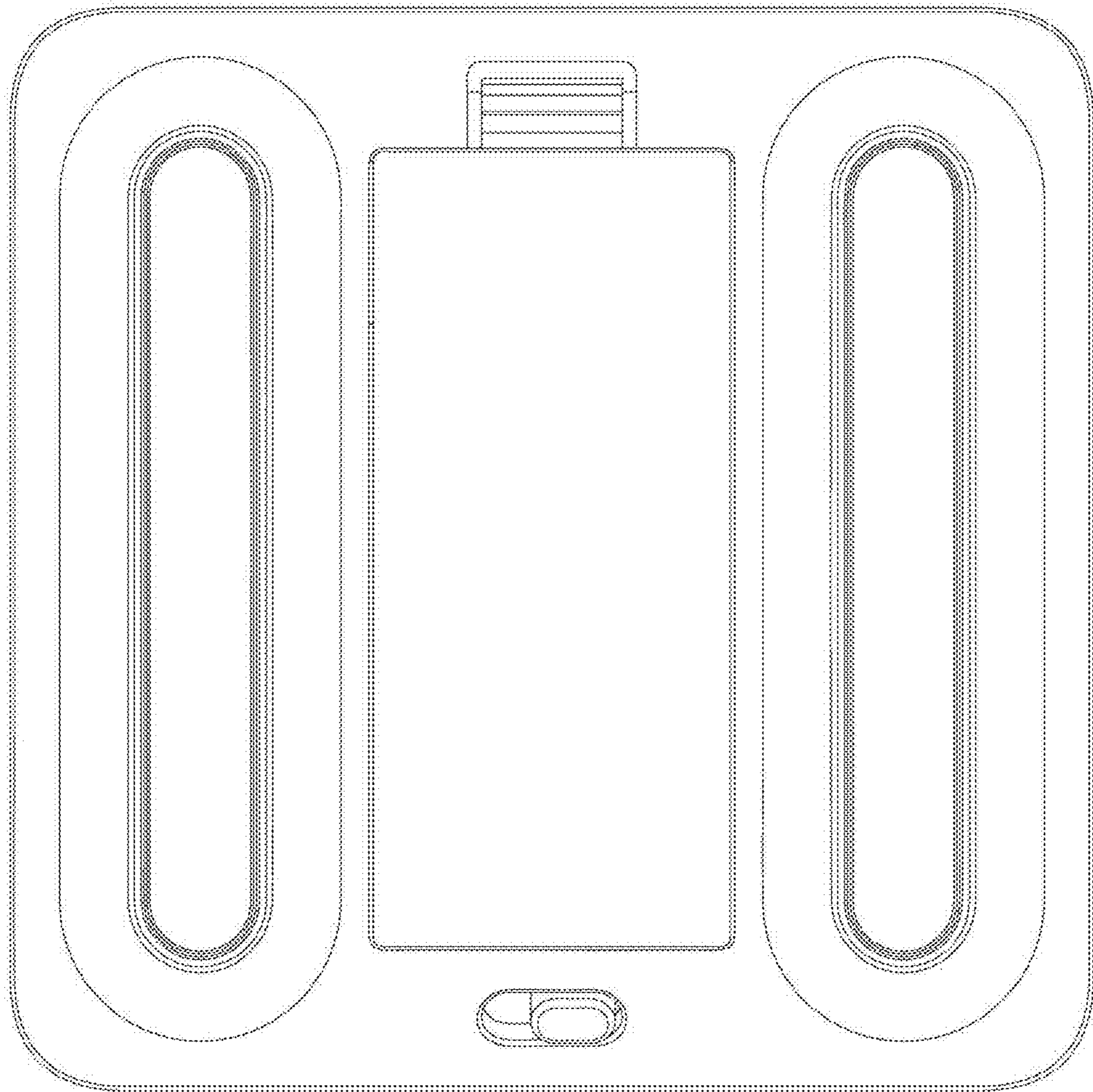

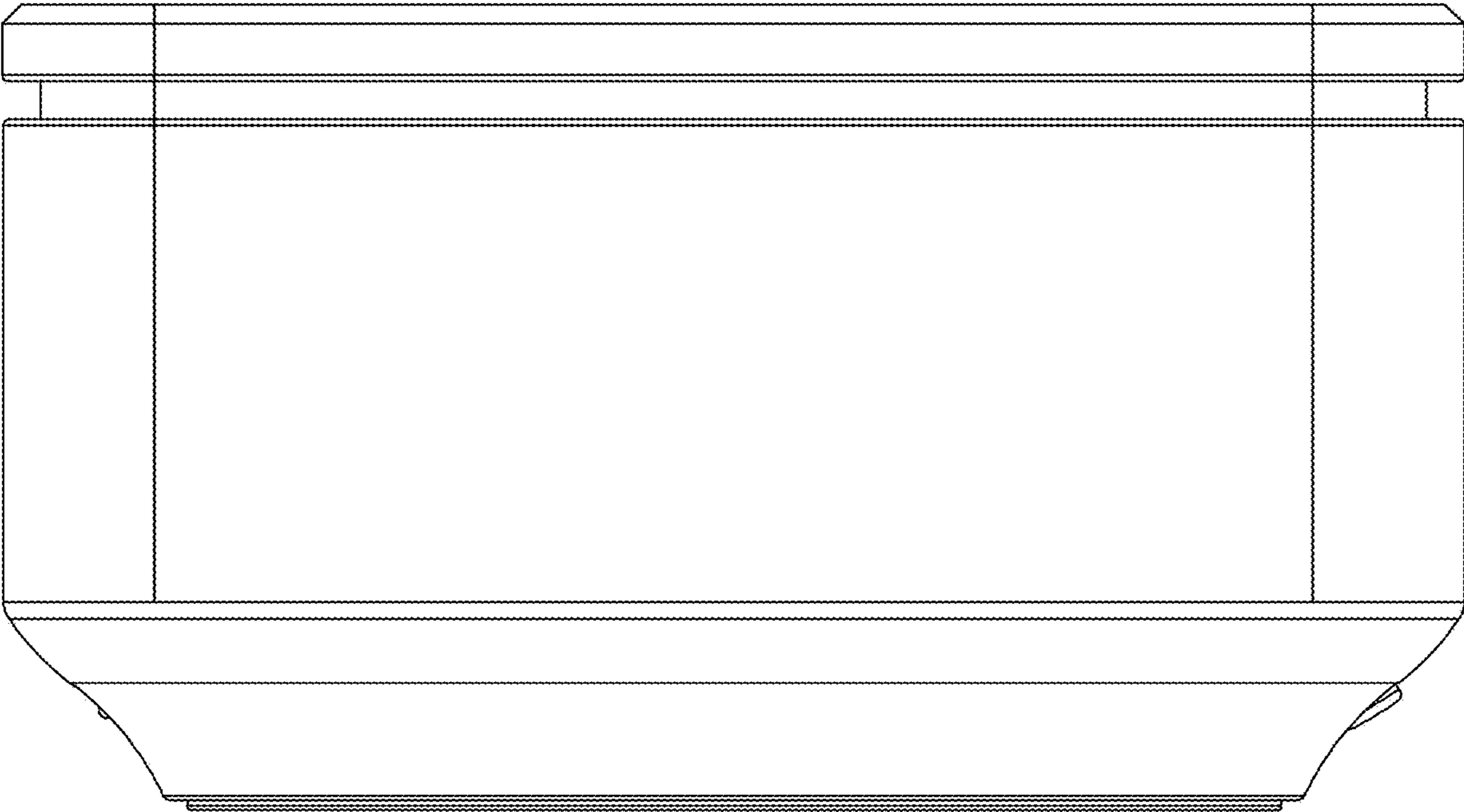

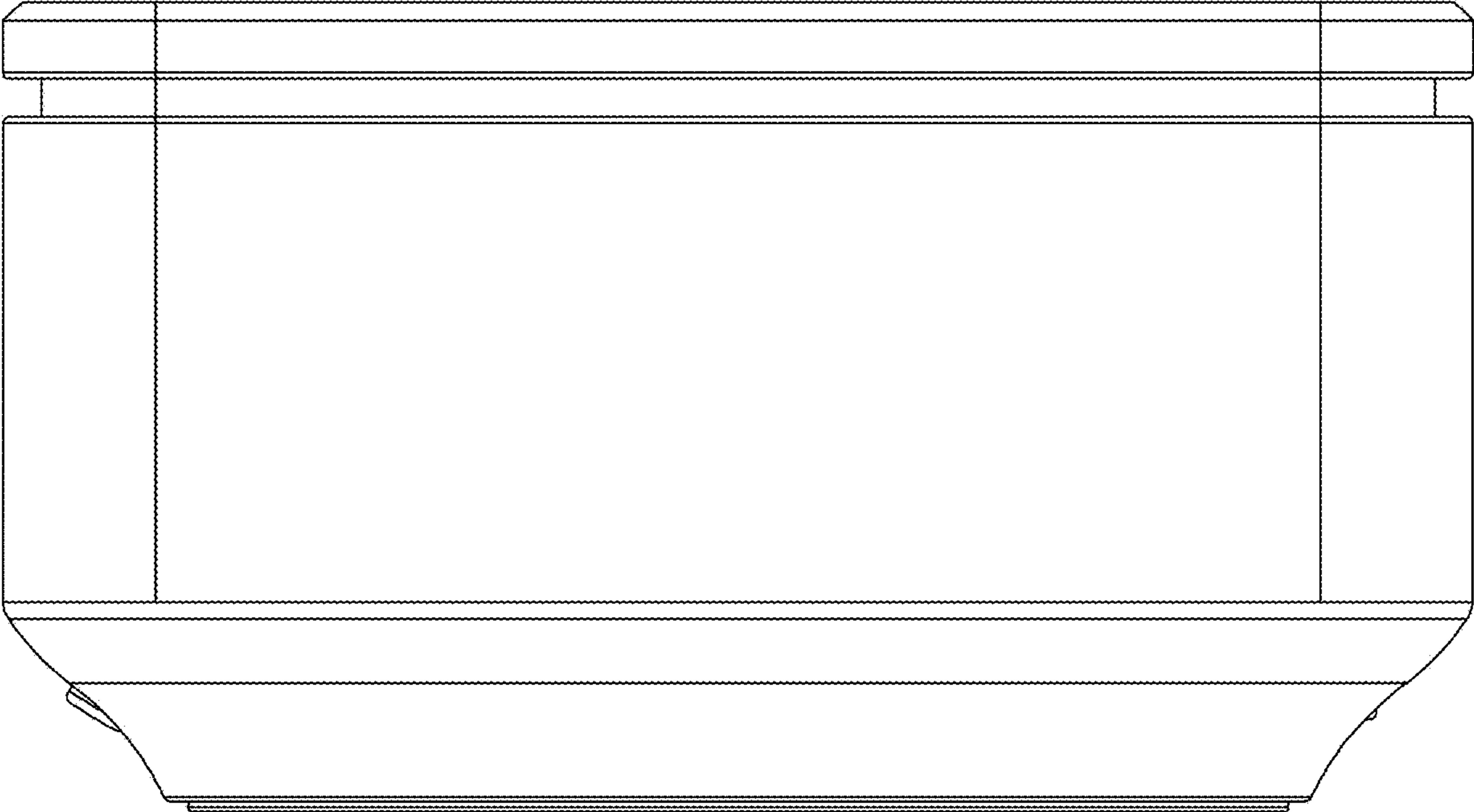

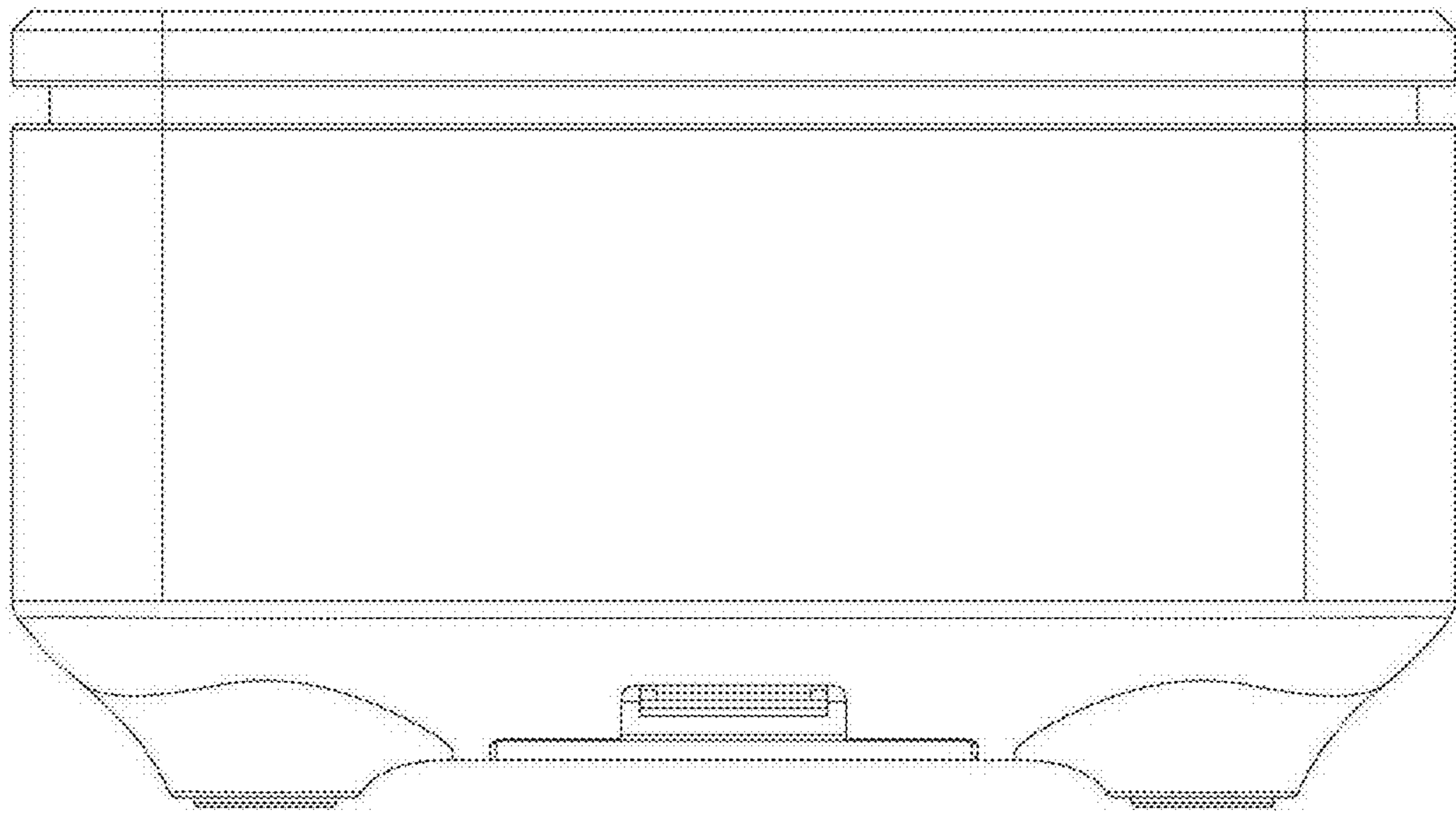

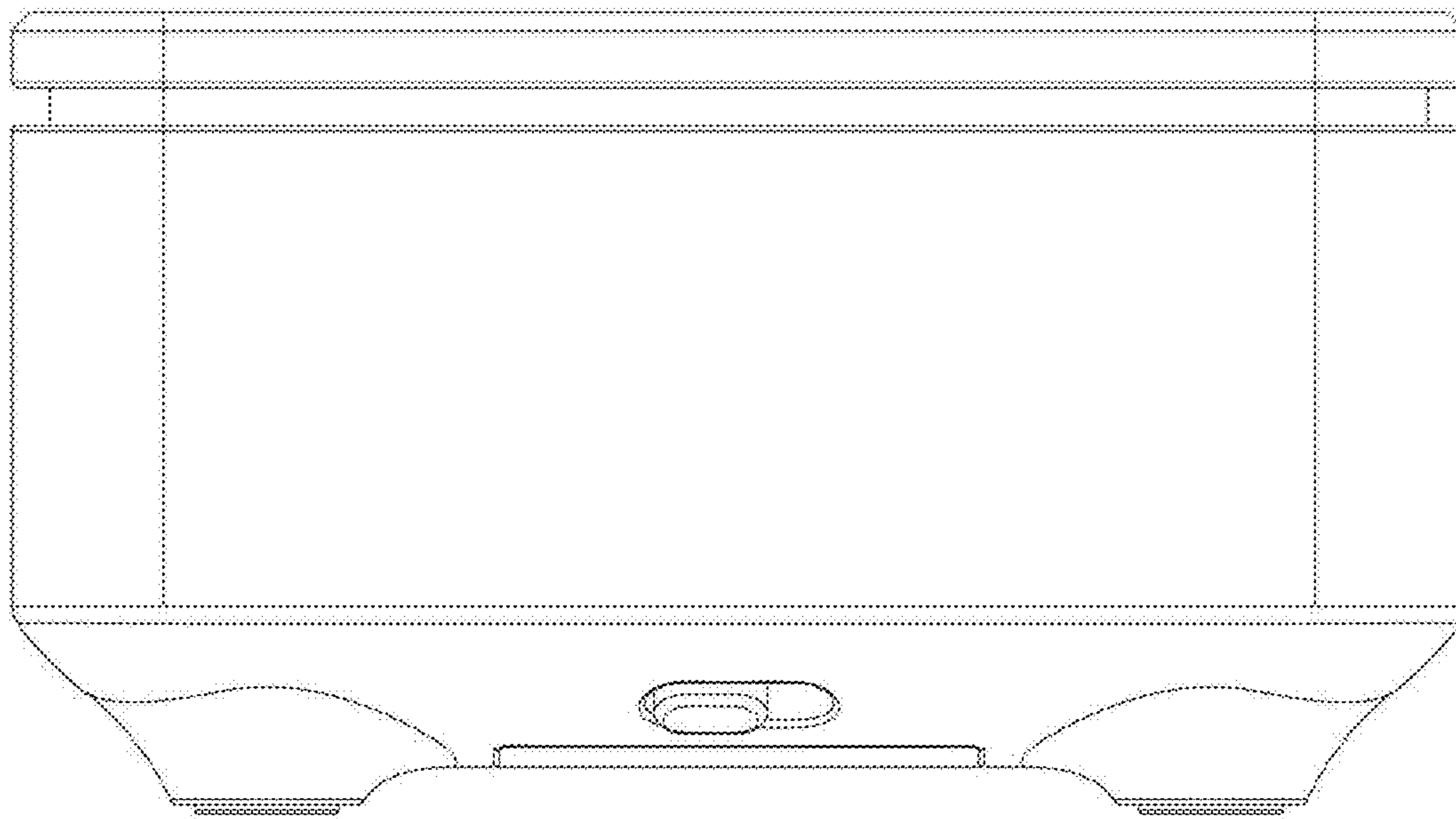

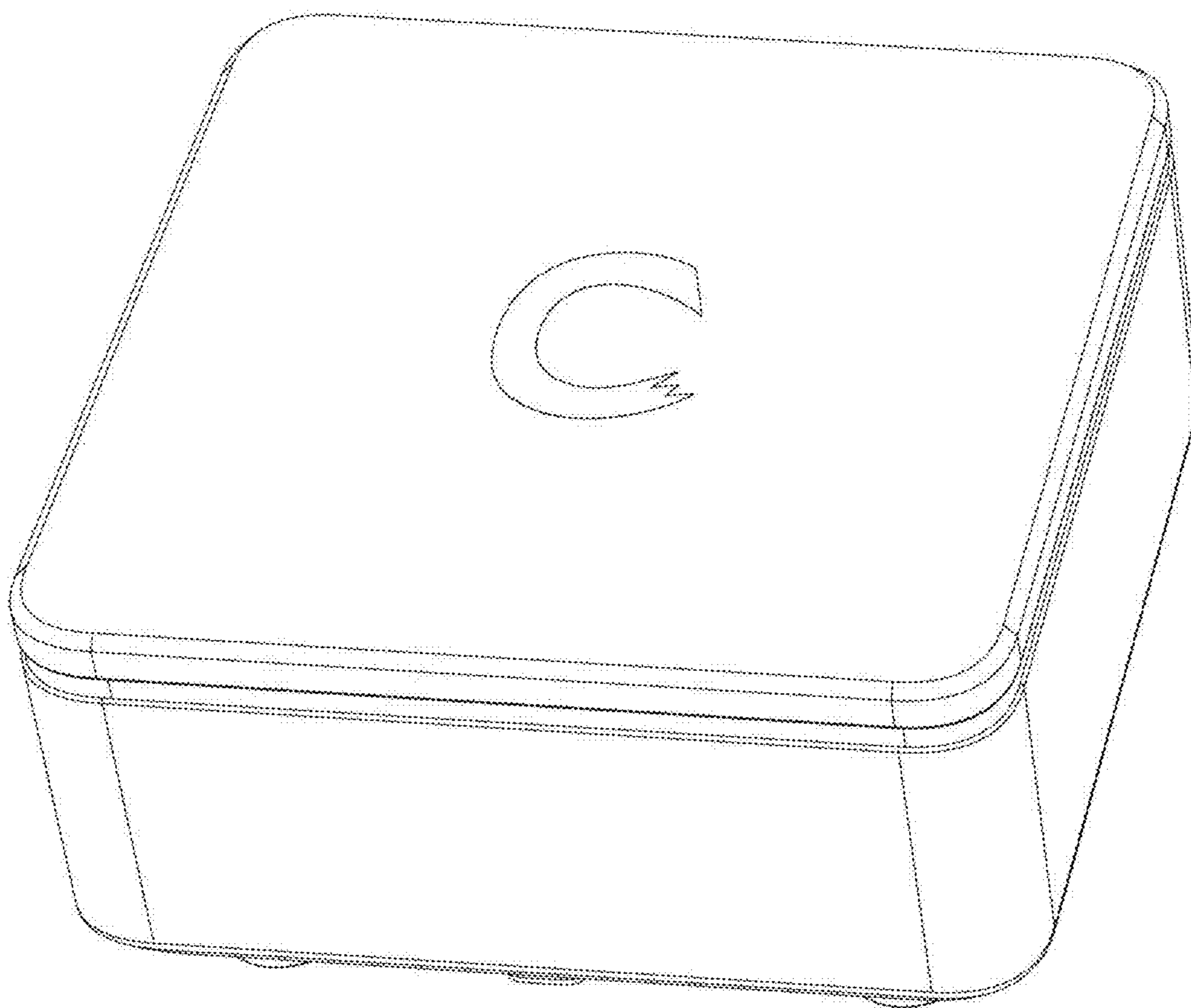

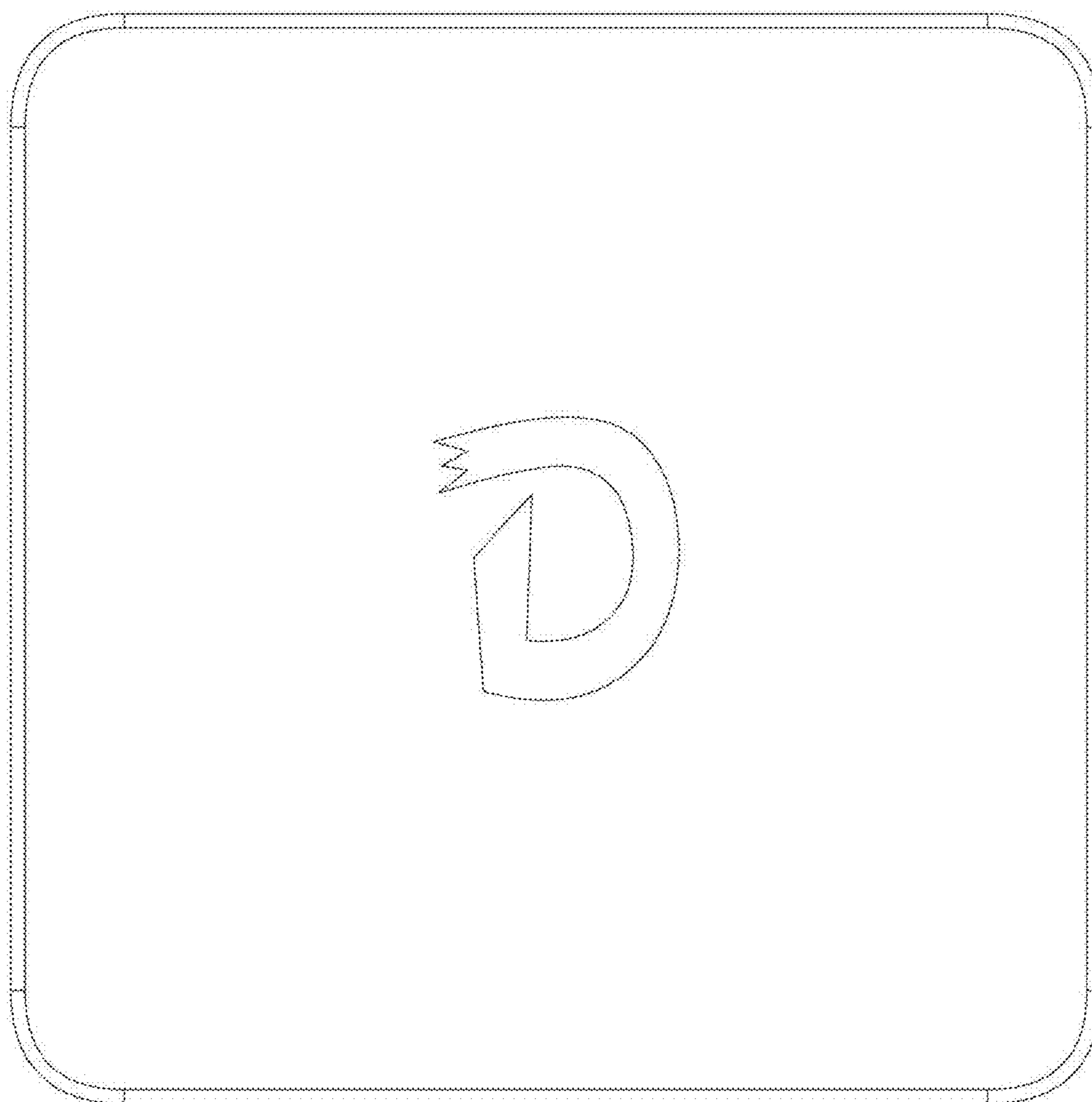

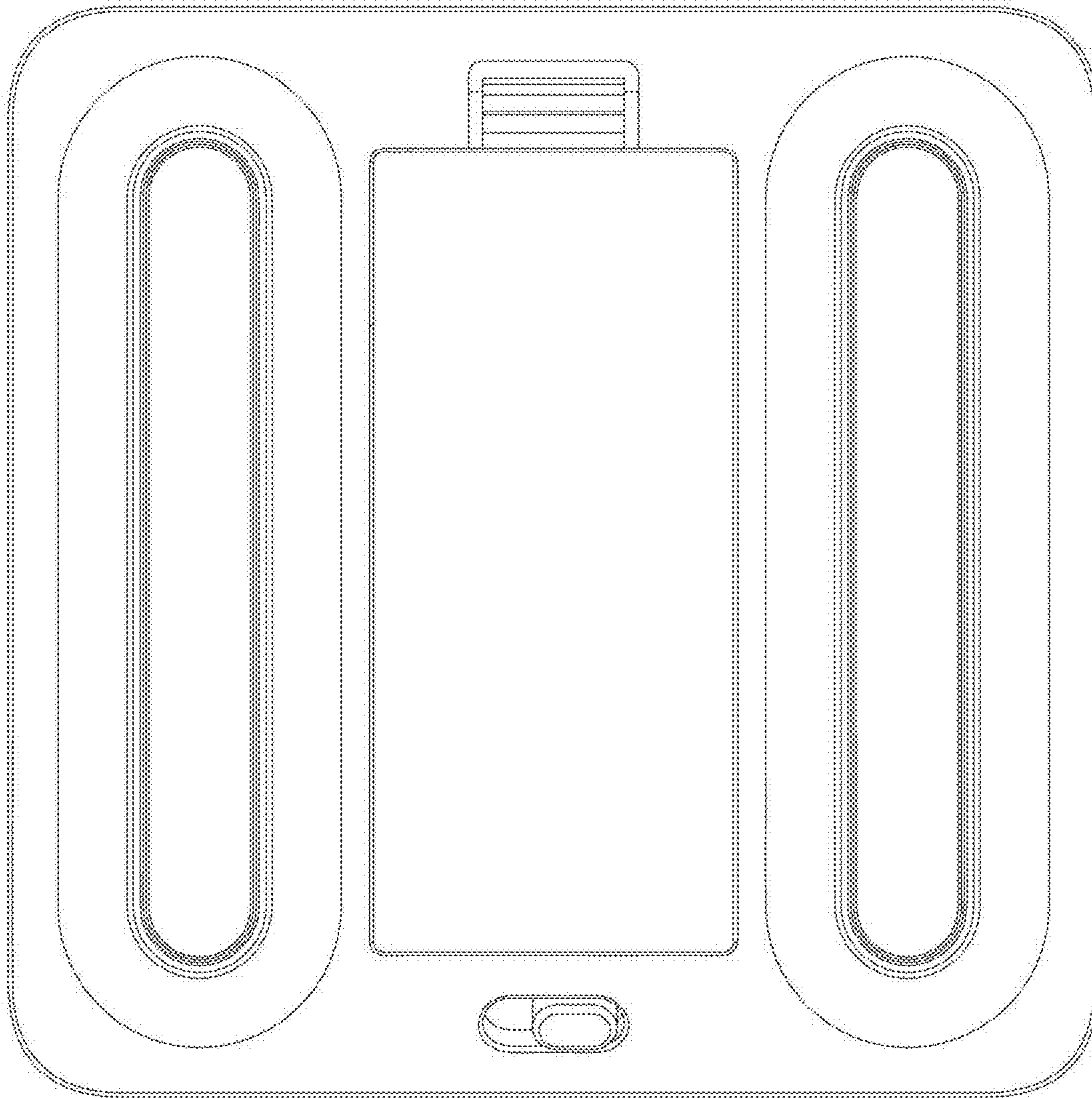

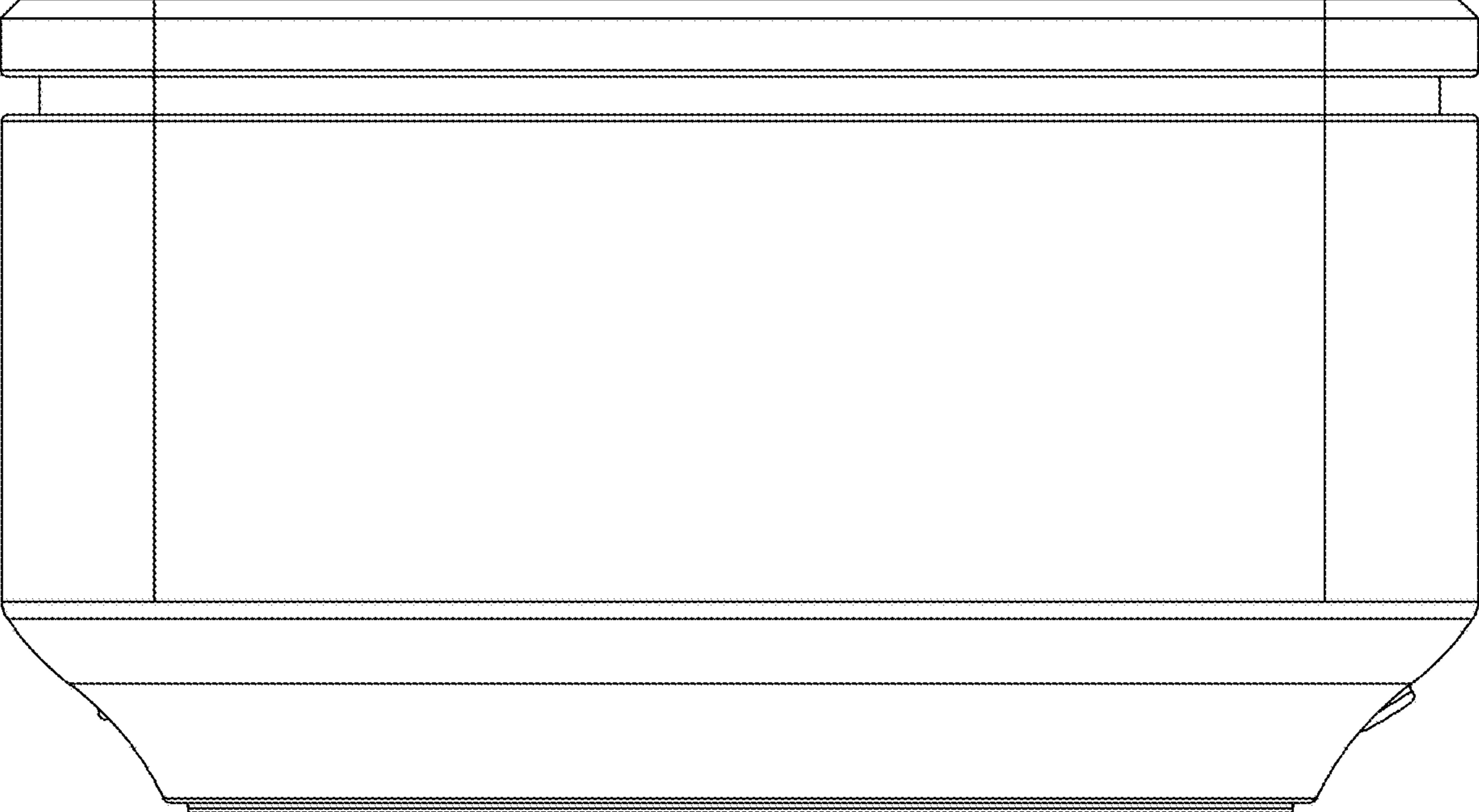

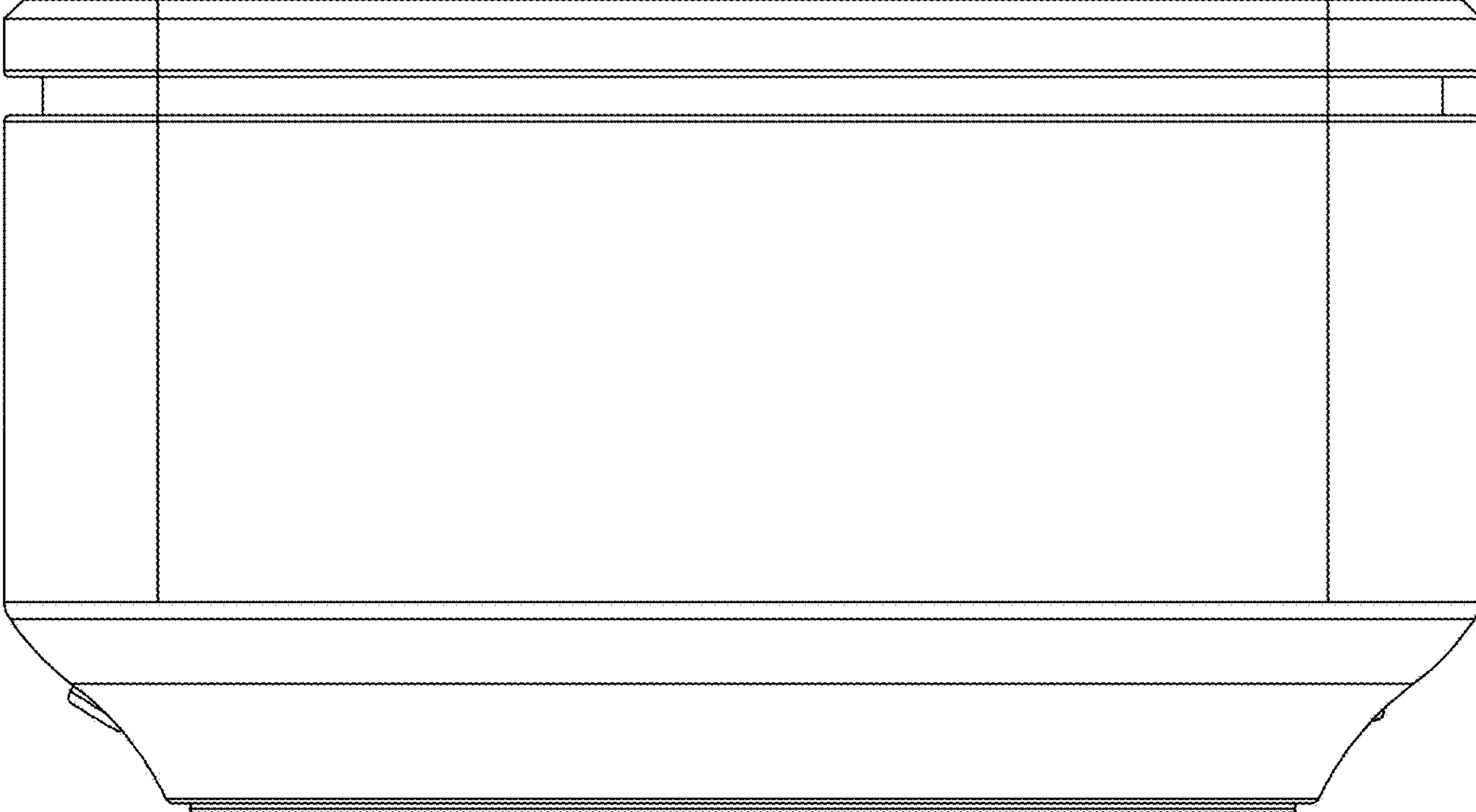
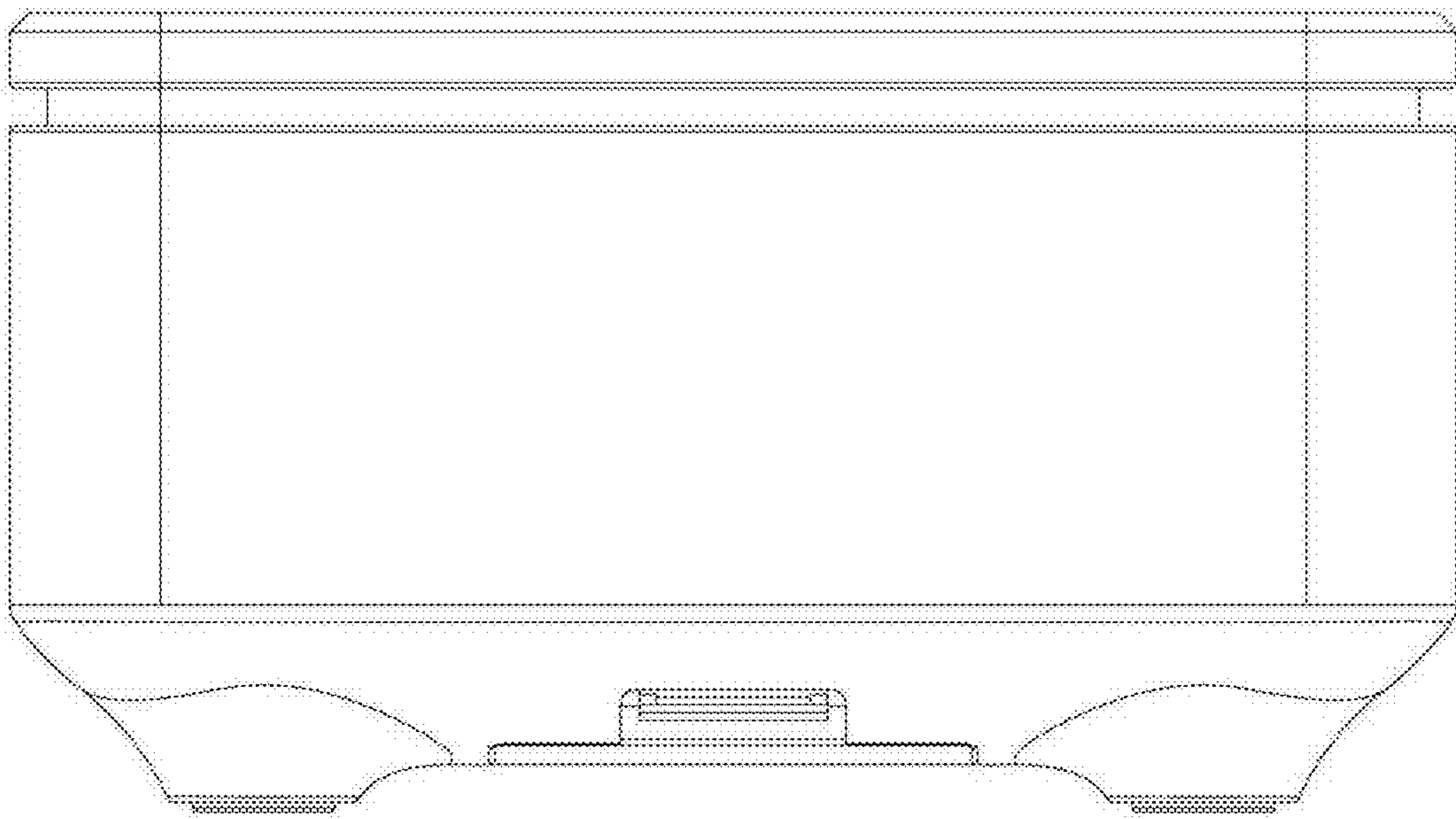

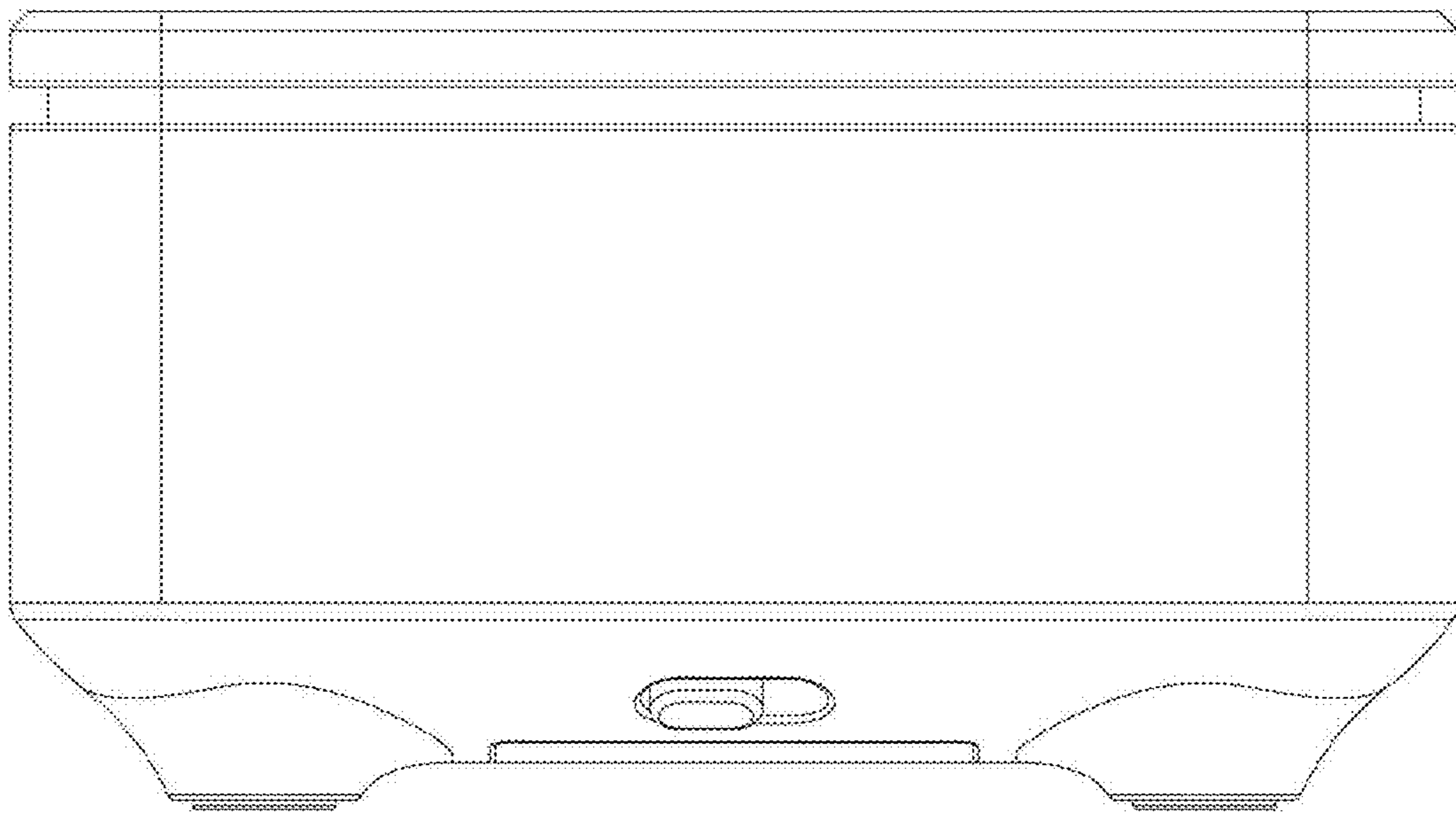

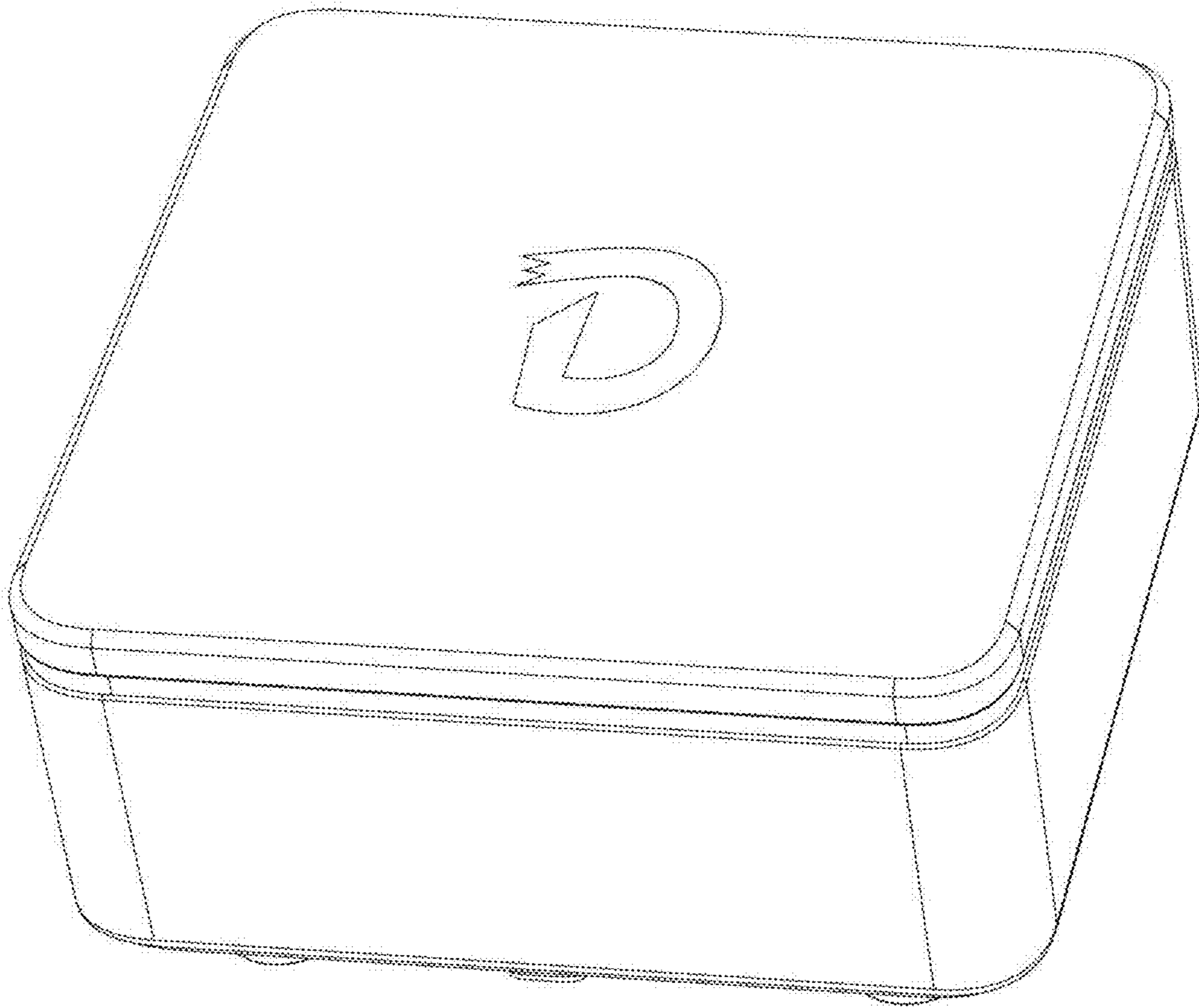

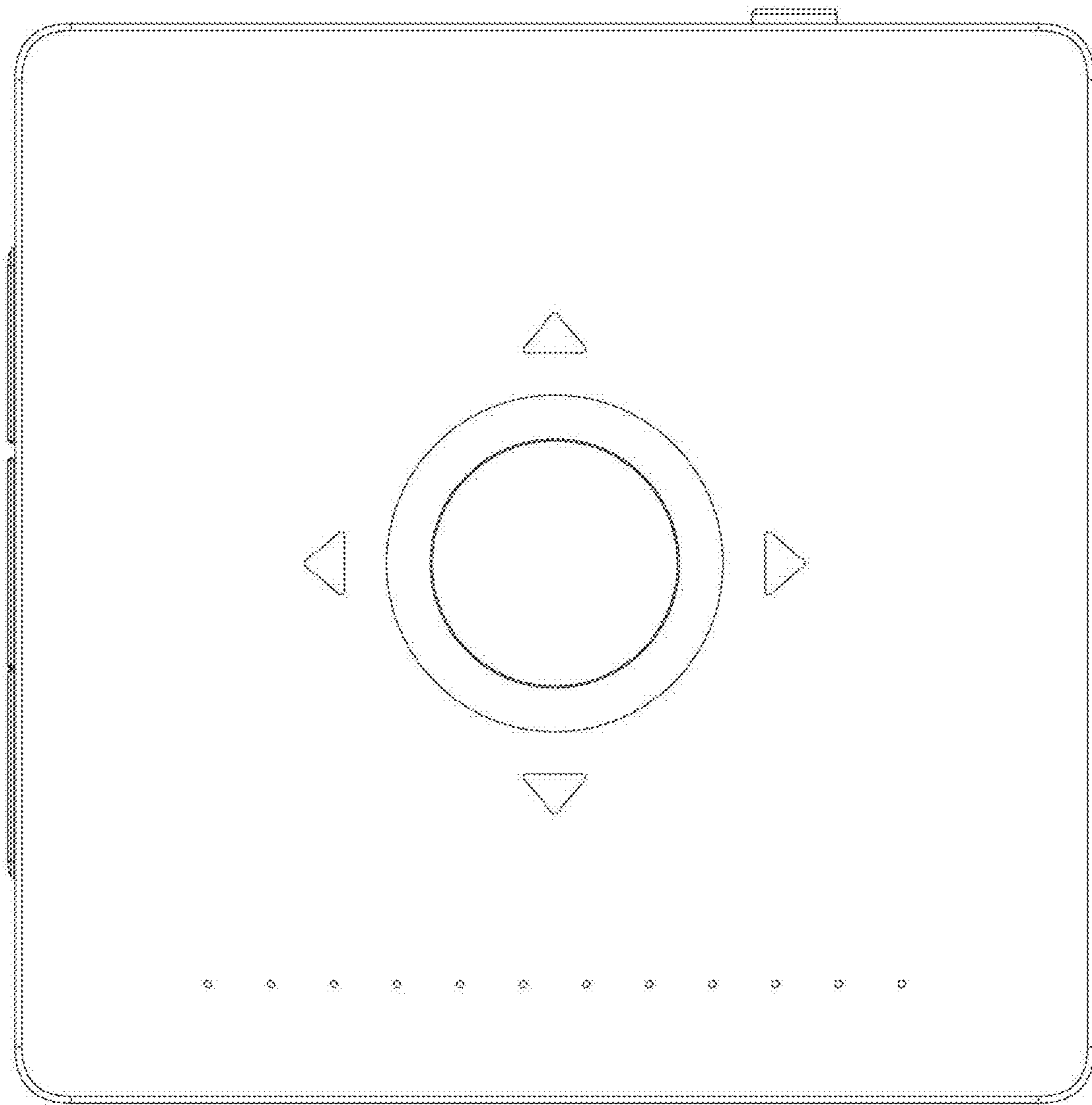

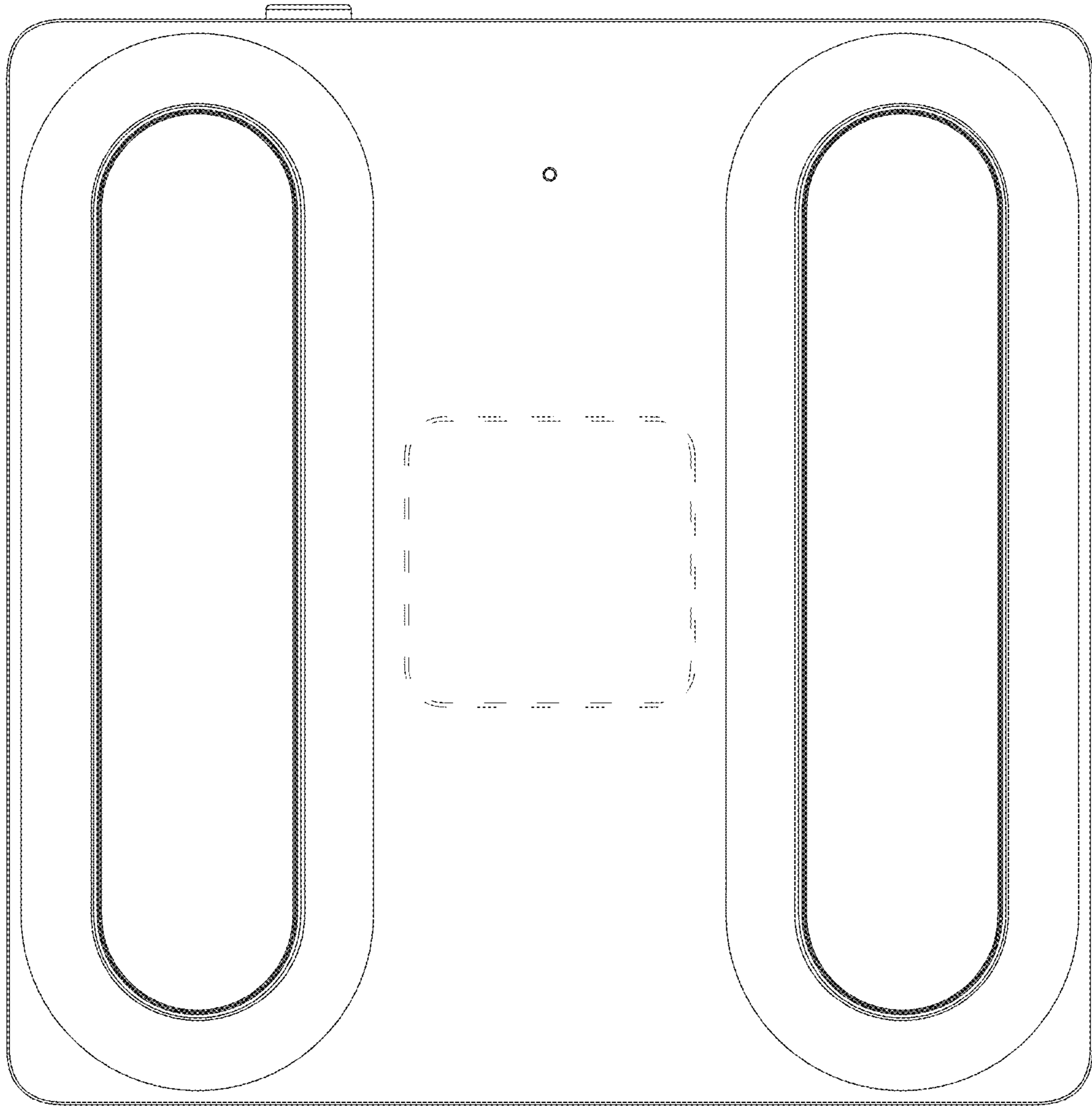

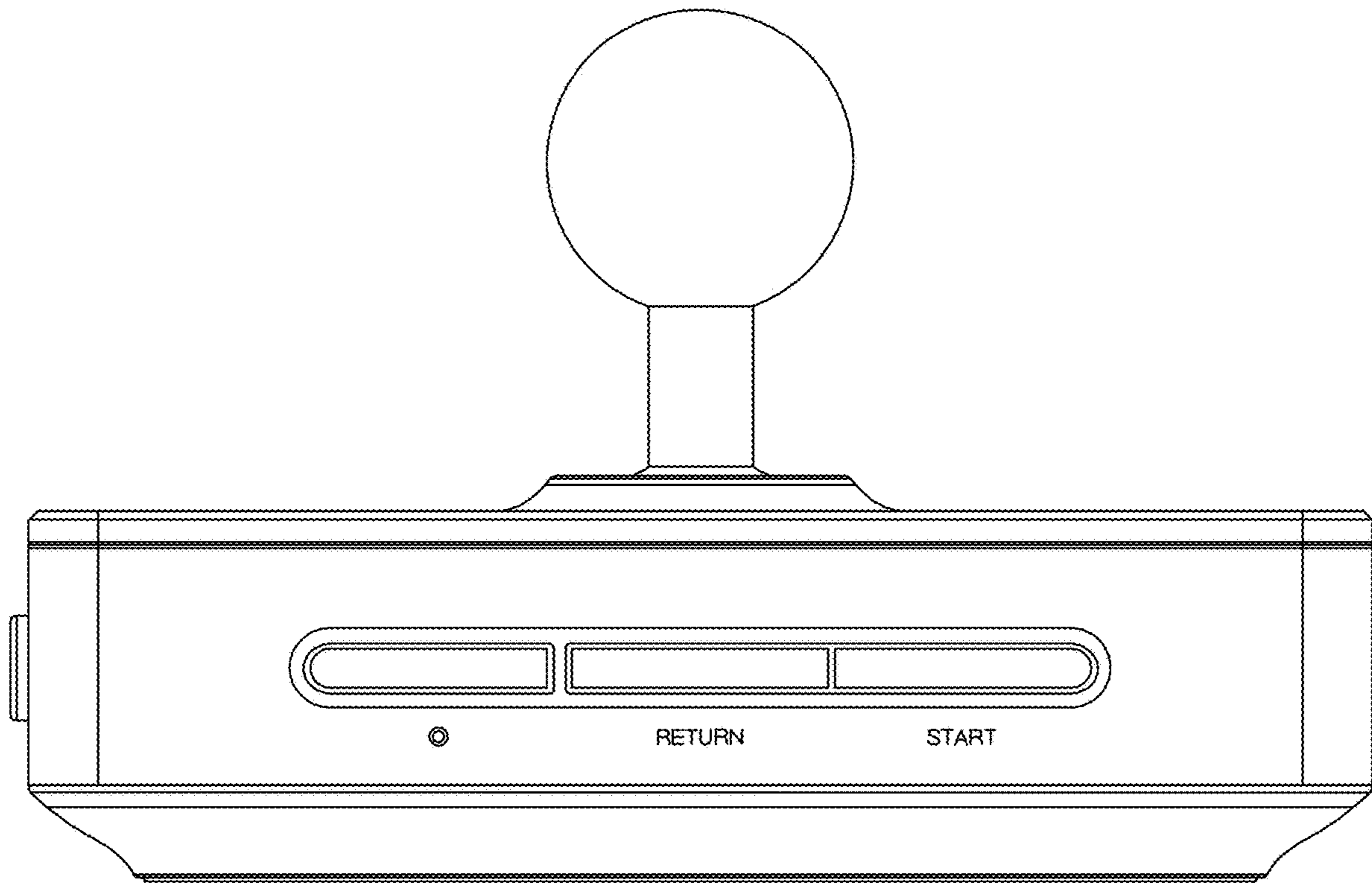

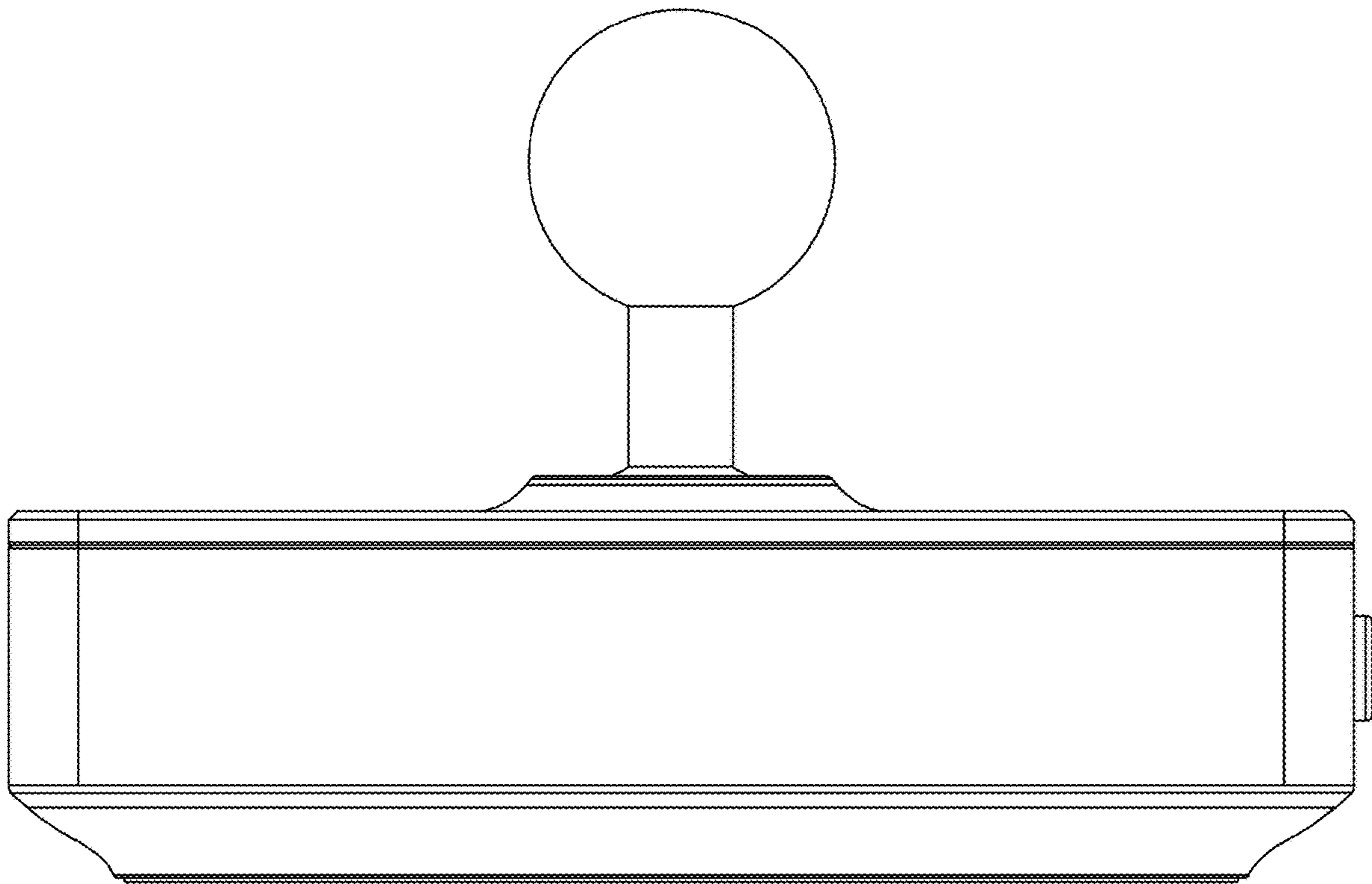

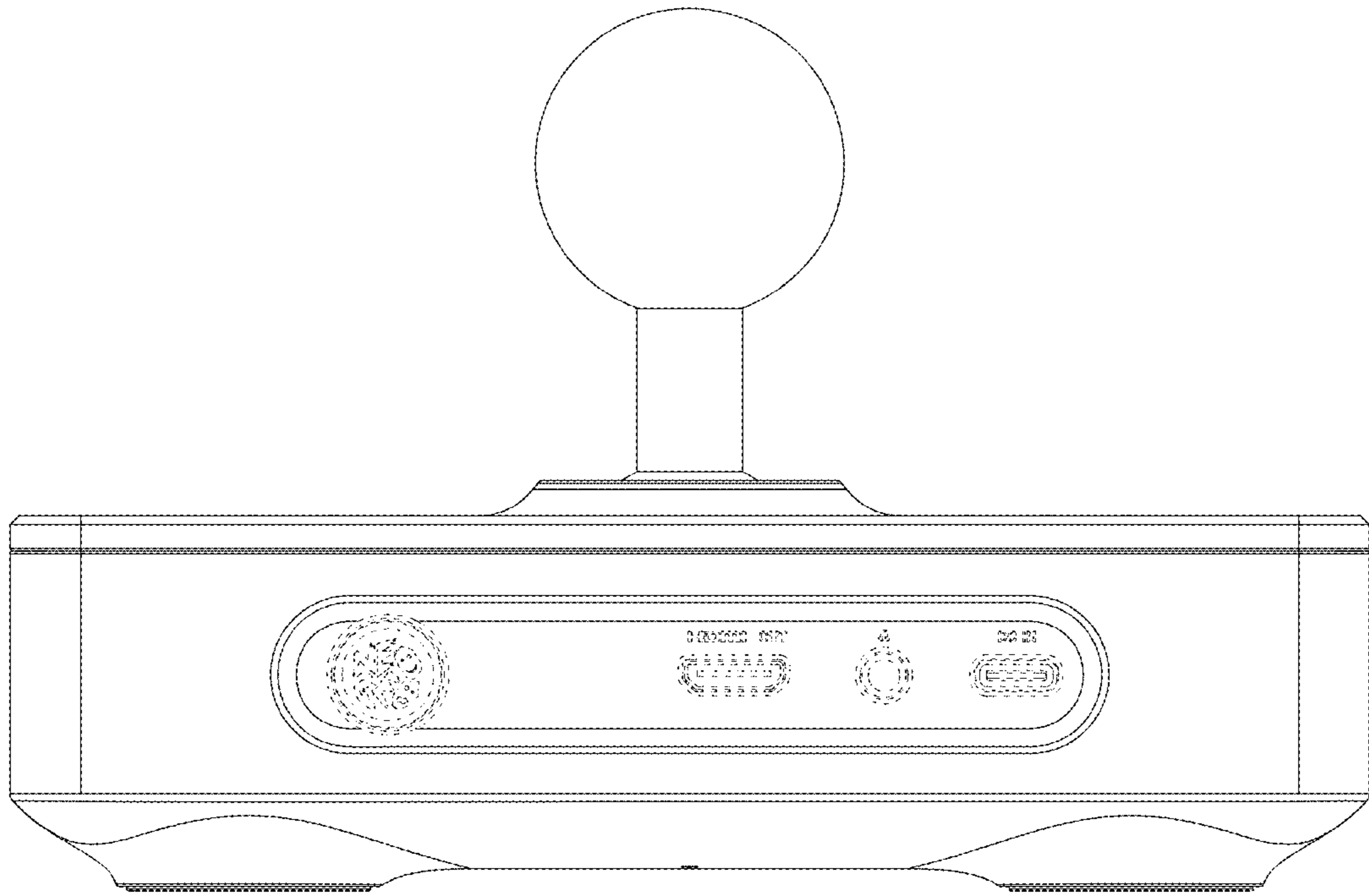

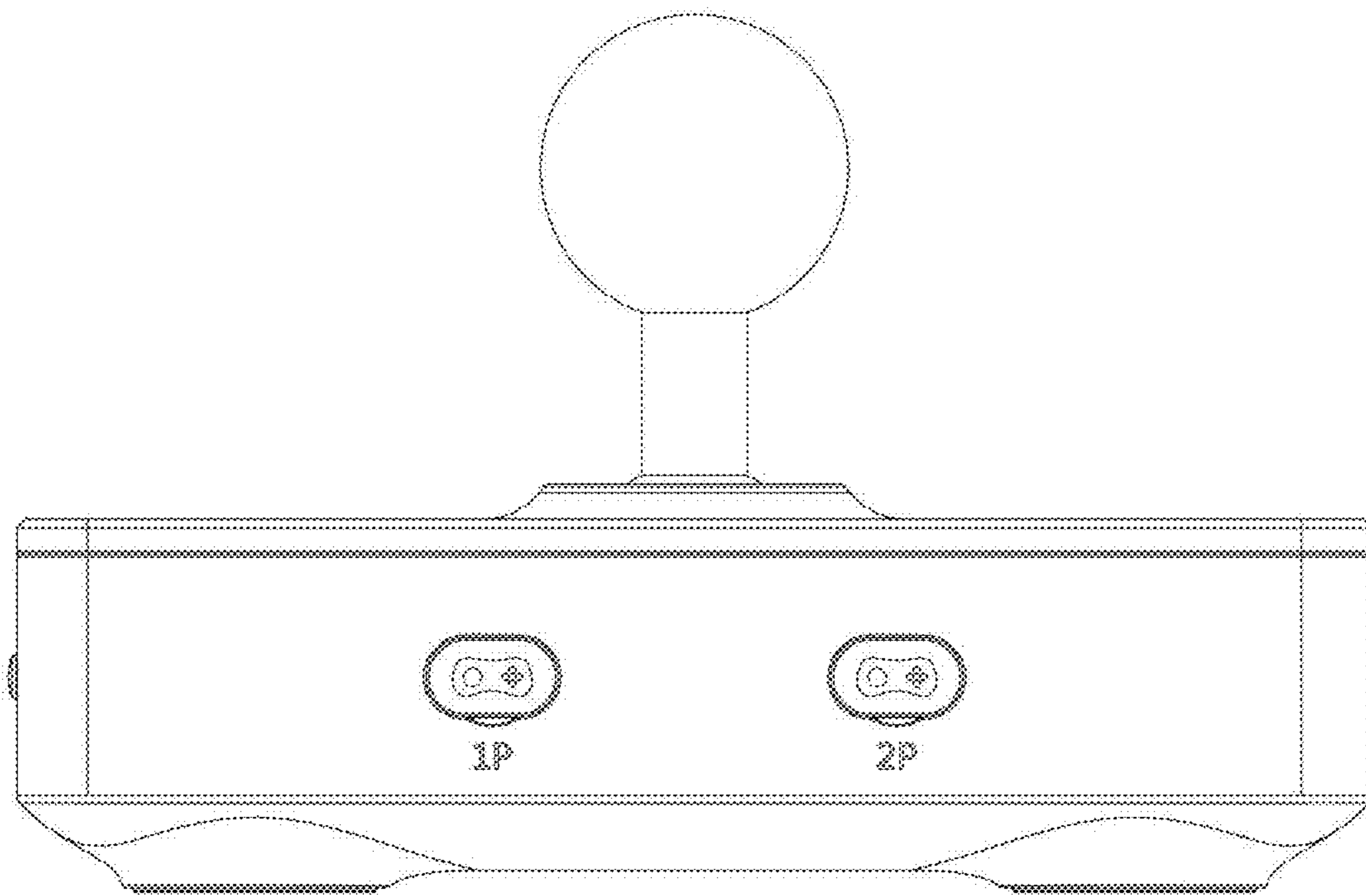

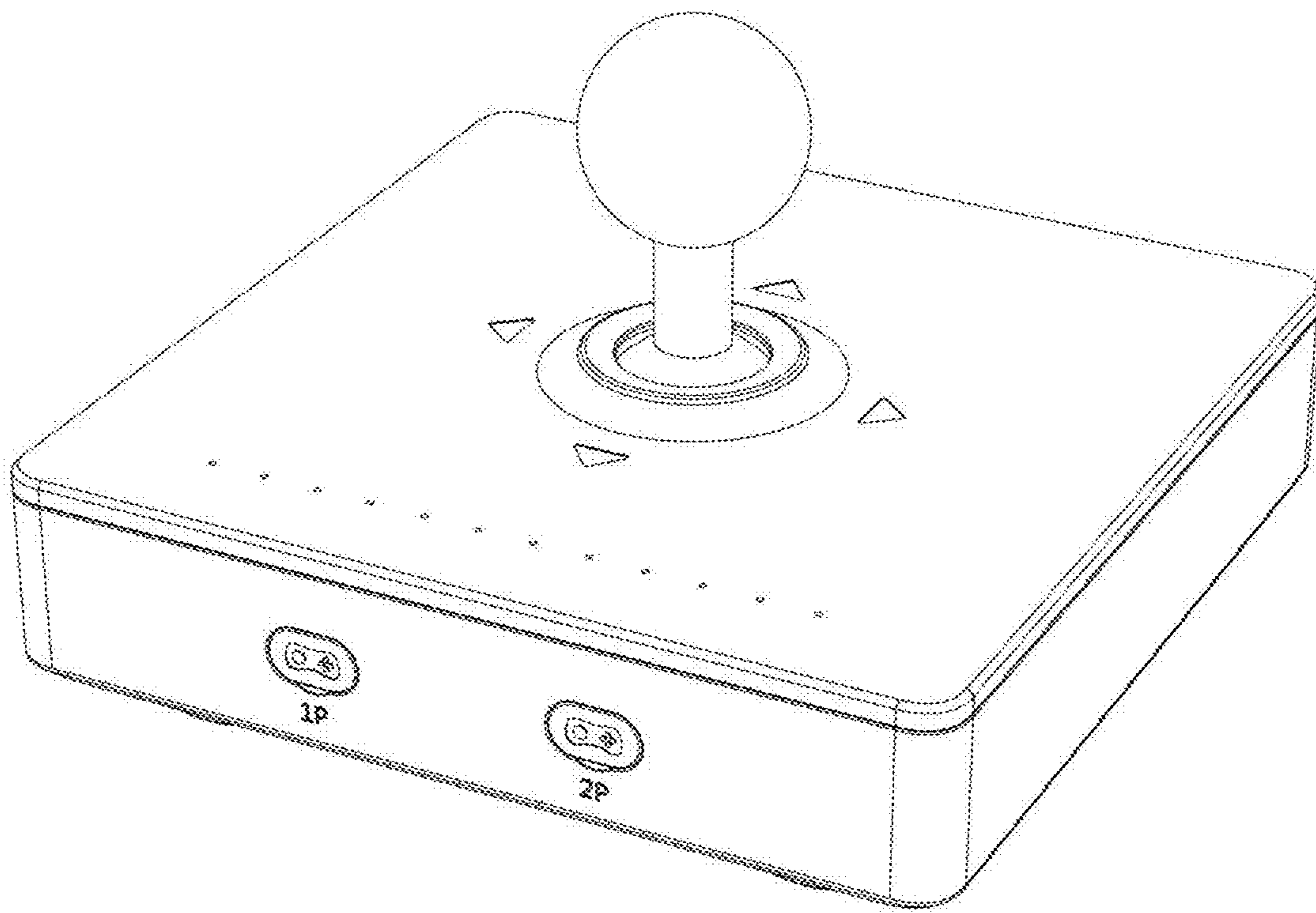
