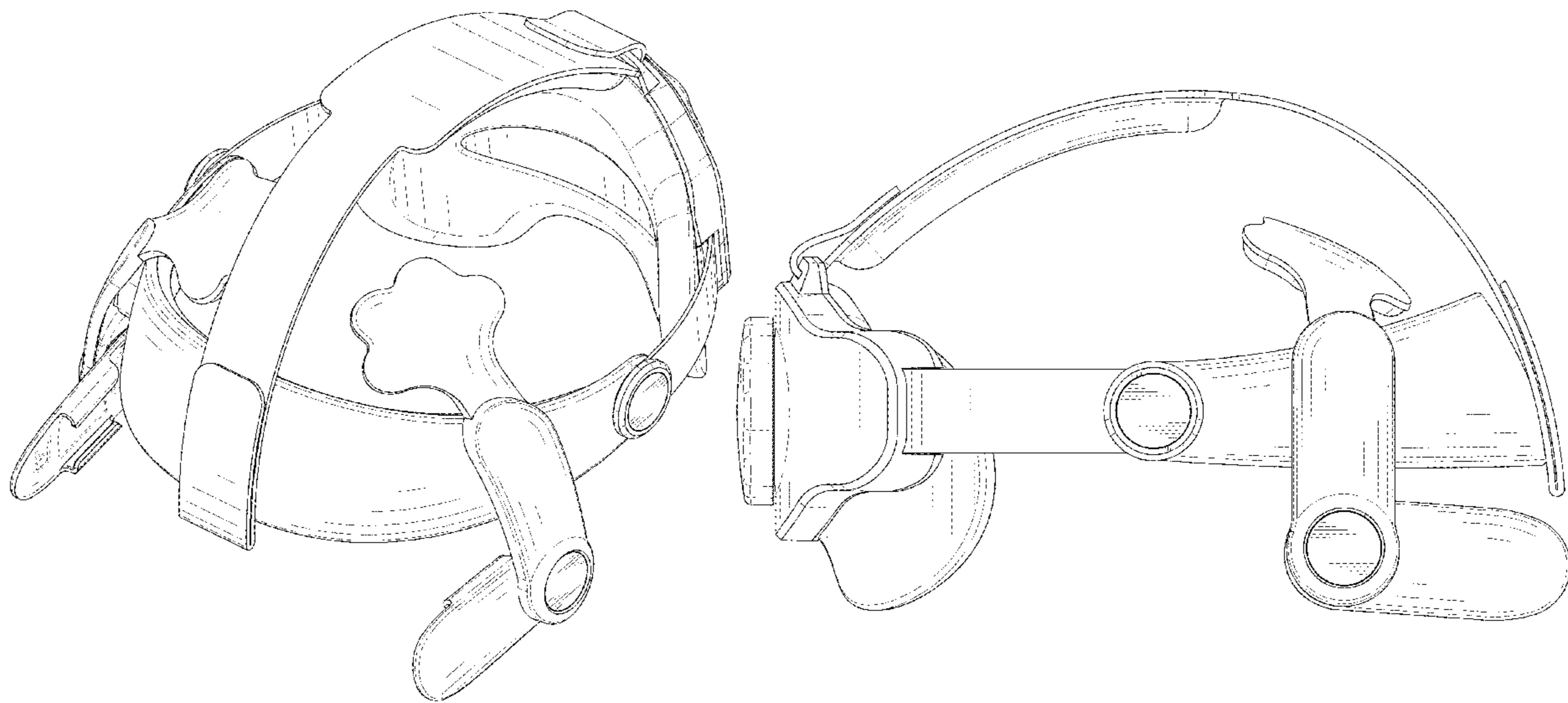
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a head strap showing my new design;
 FIG. 2 is another perspective view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a left side elevational view thereof;
 FIG. 6 is a right side elevational view thereof;

 FIG. 9 is a perspective view of the head strap where the head strap is in a configuration of use.

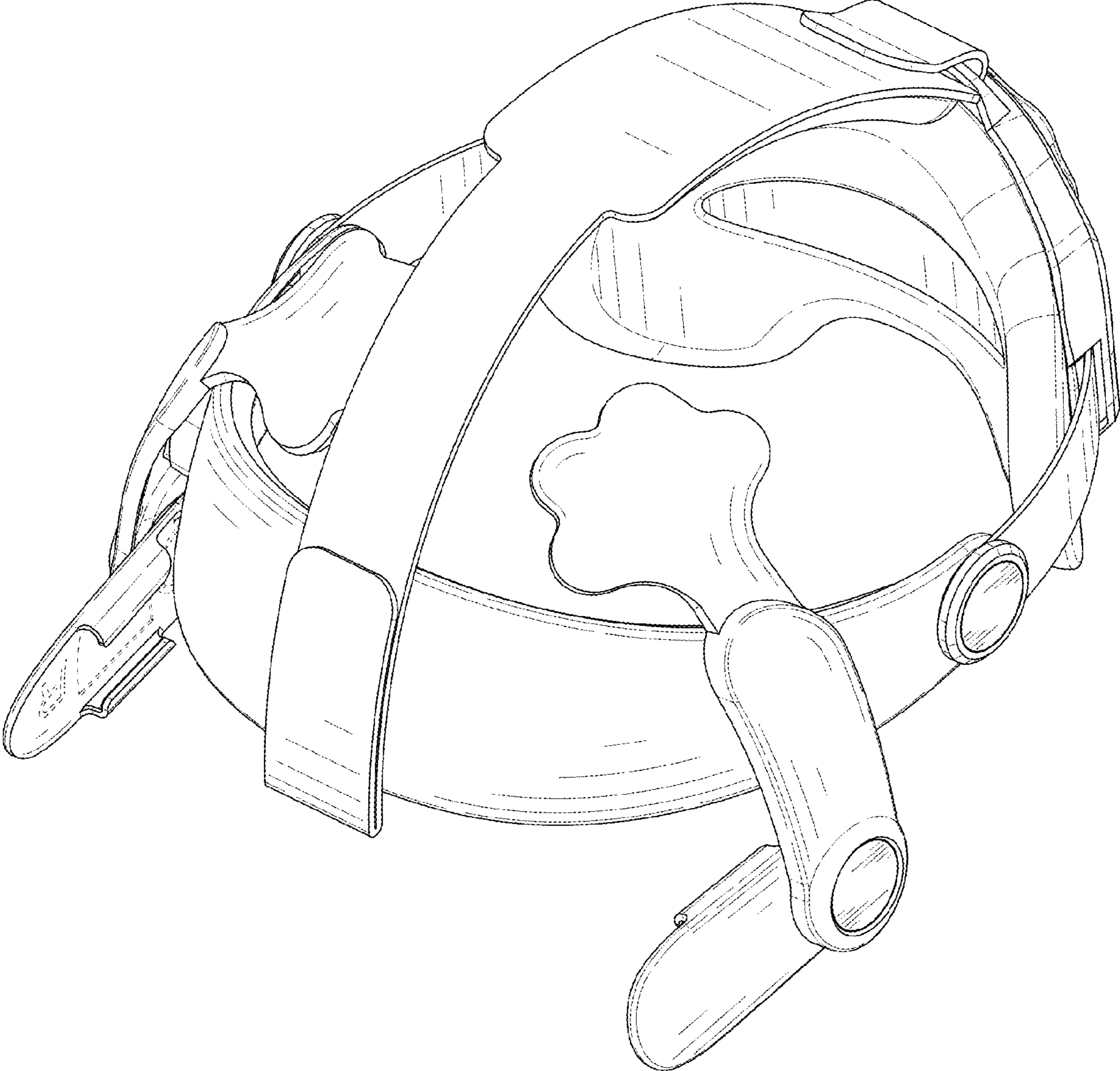

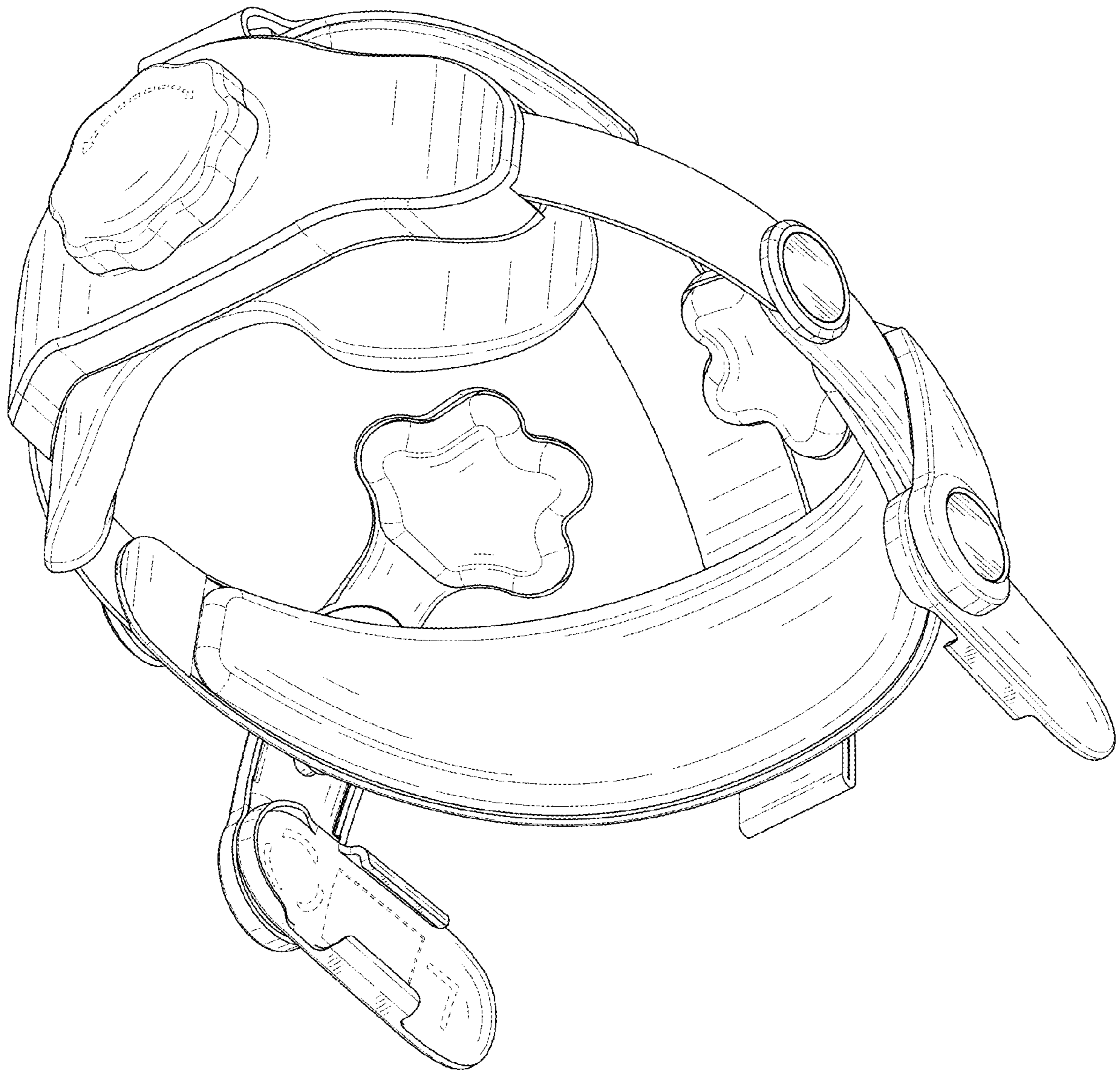

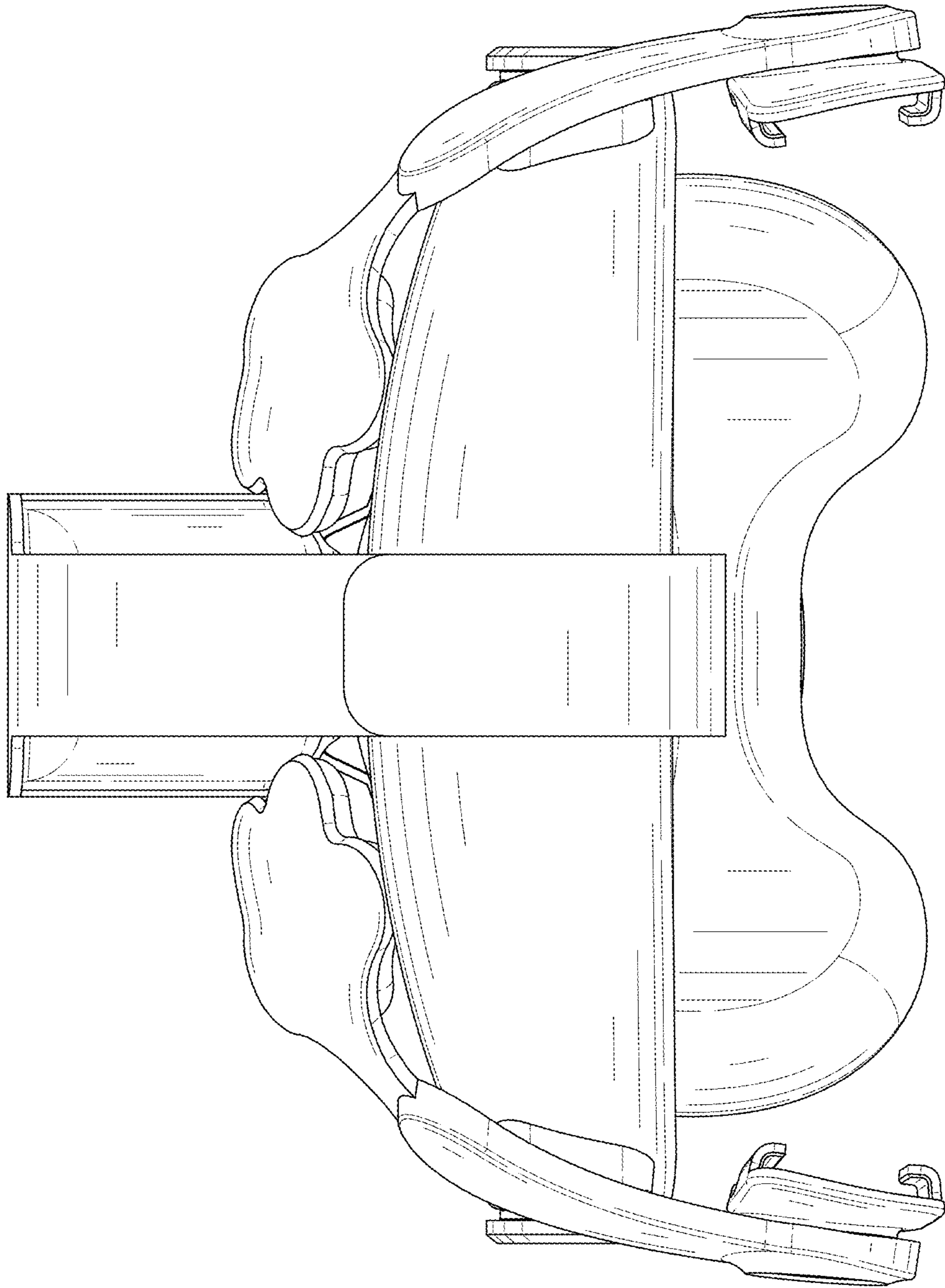

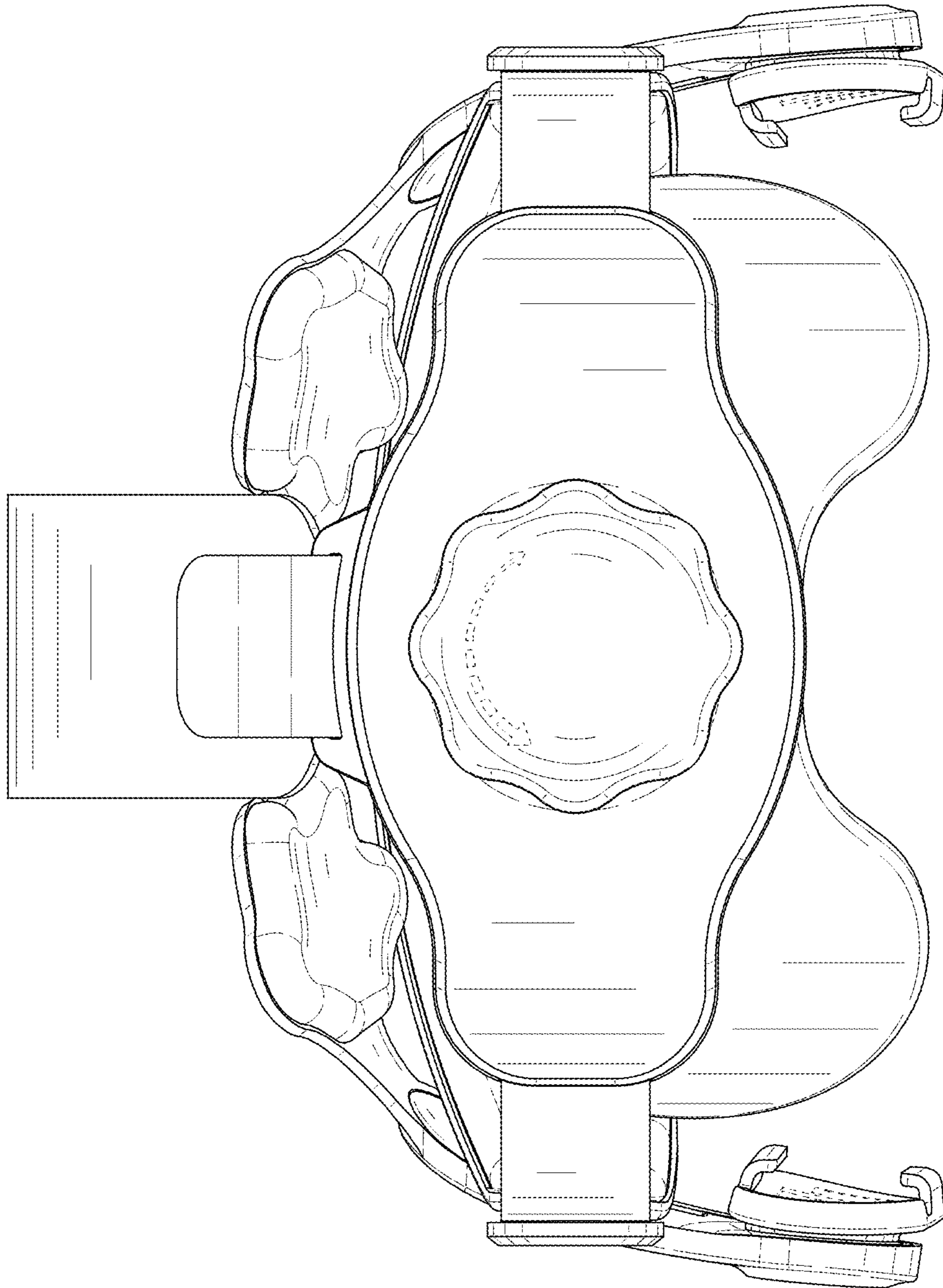

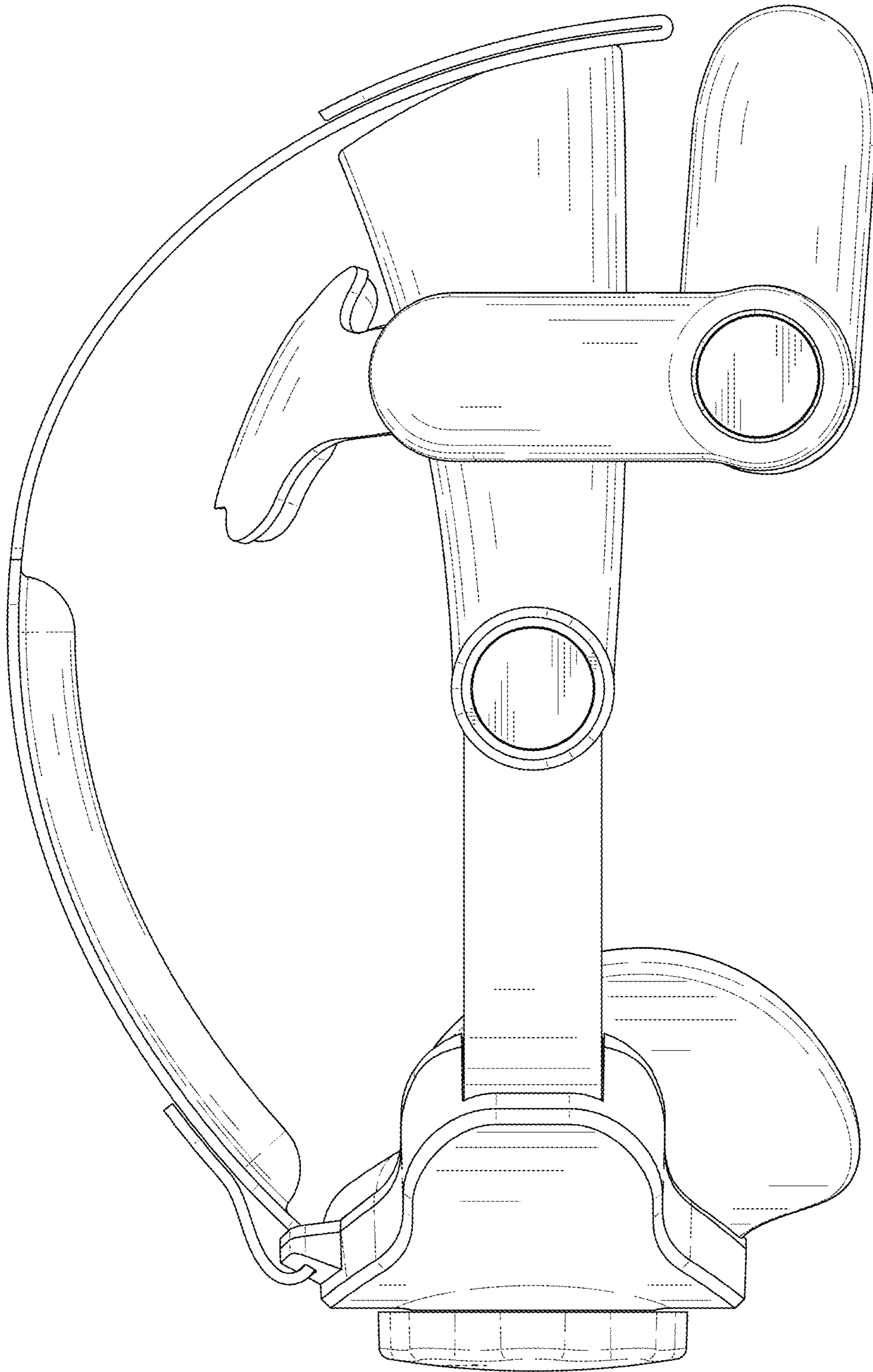

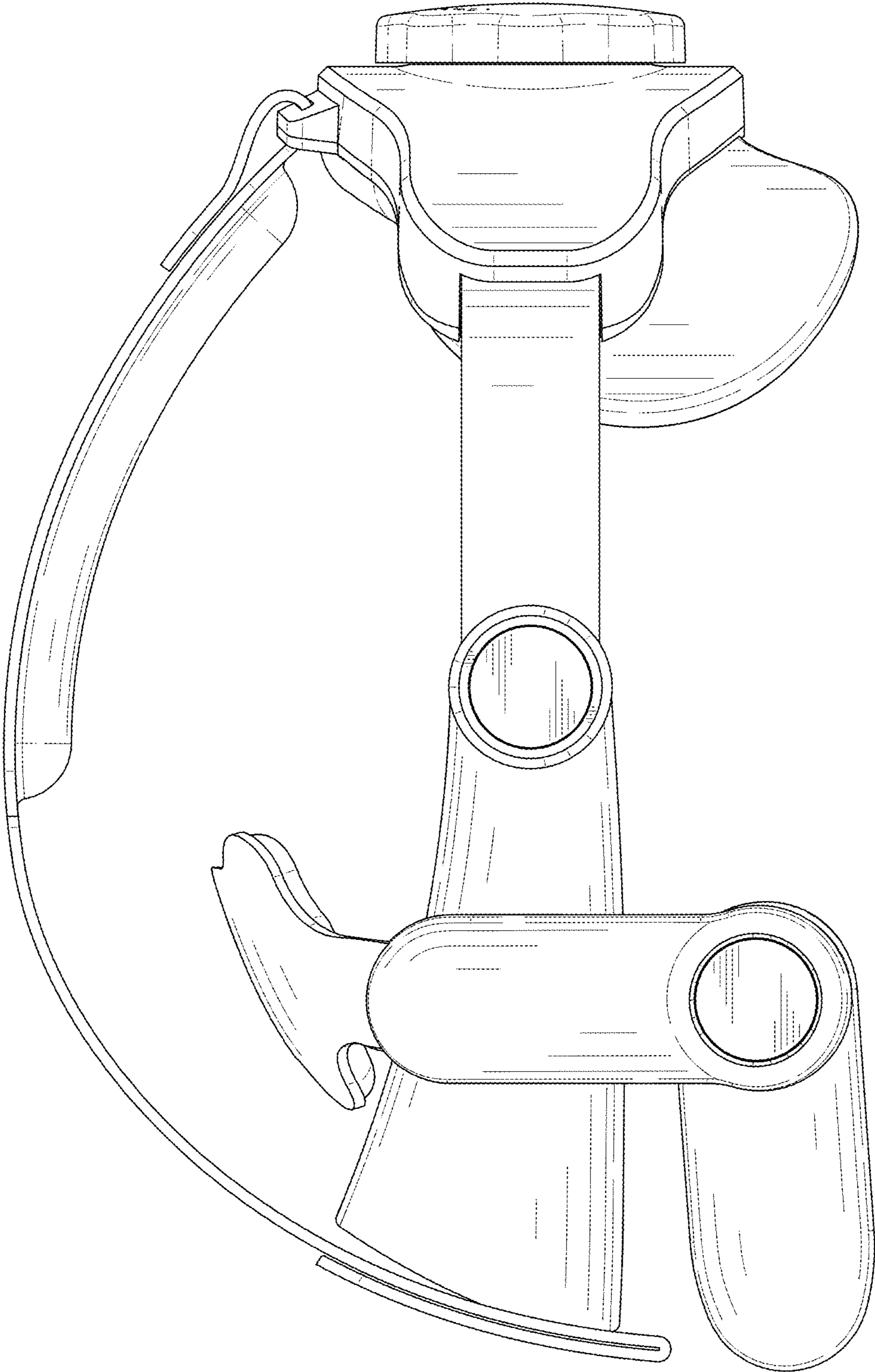

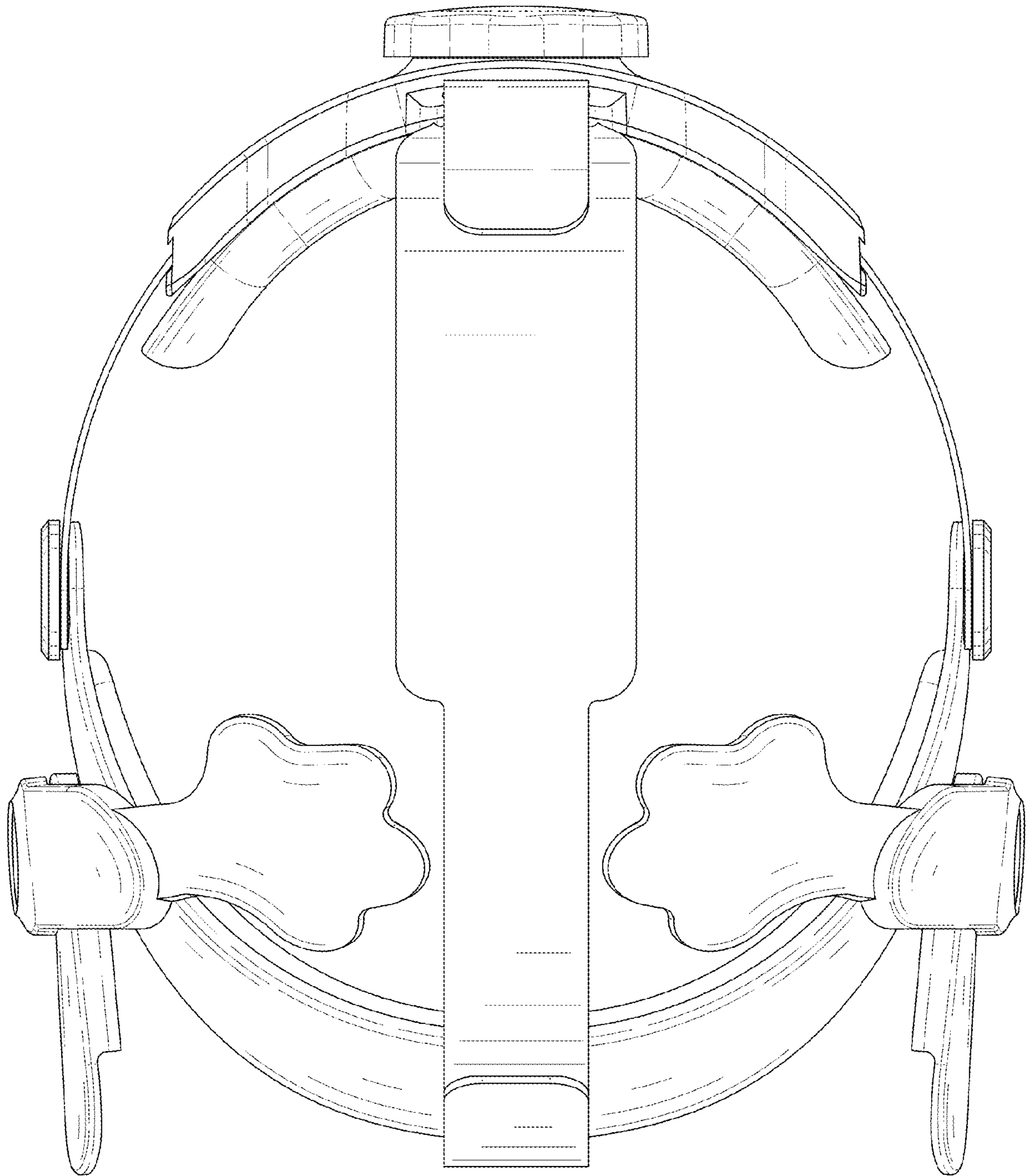

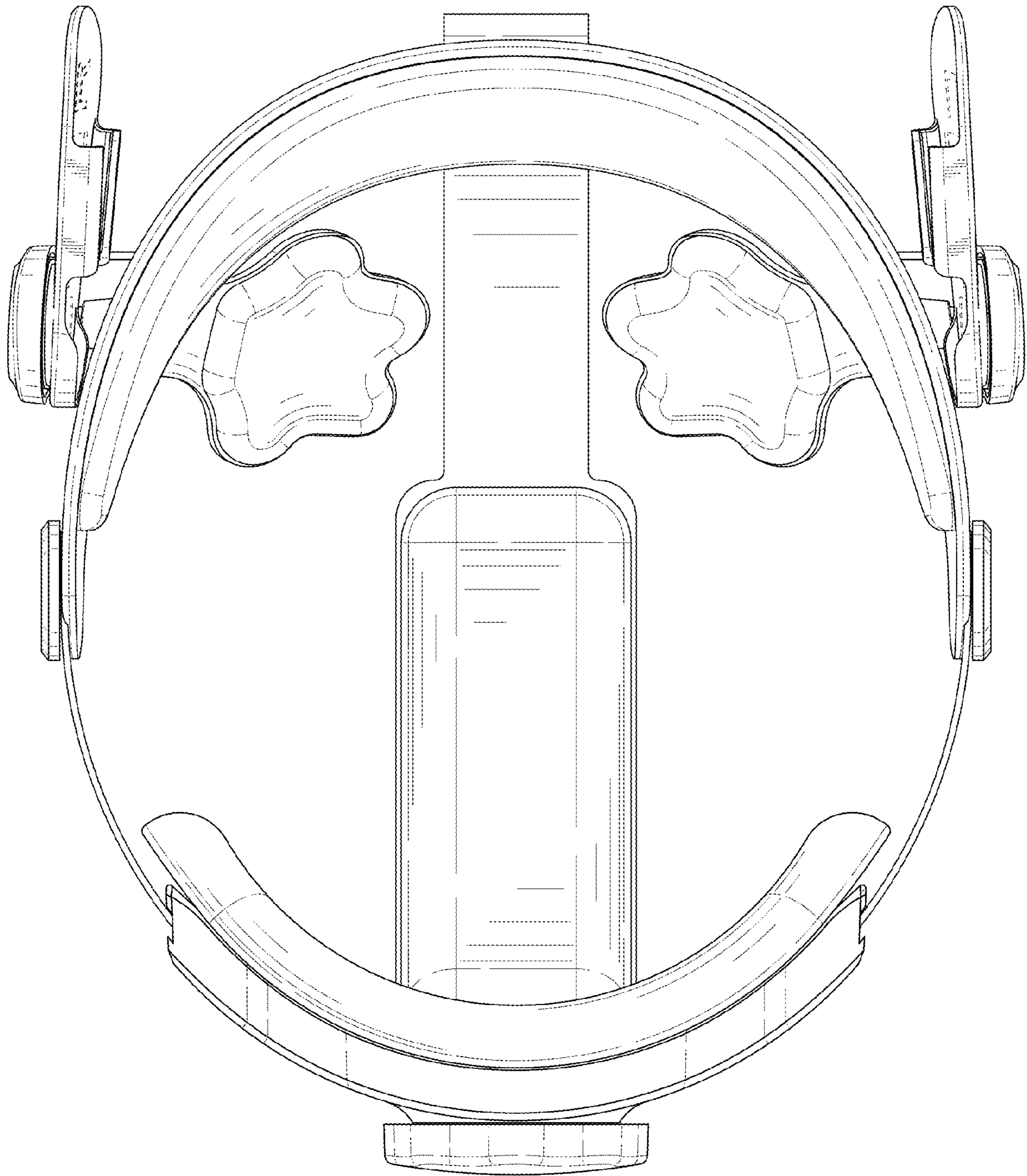

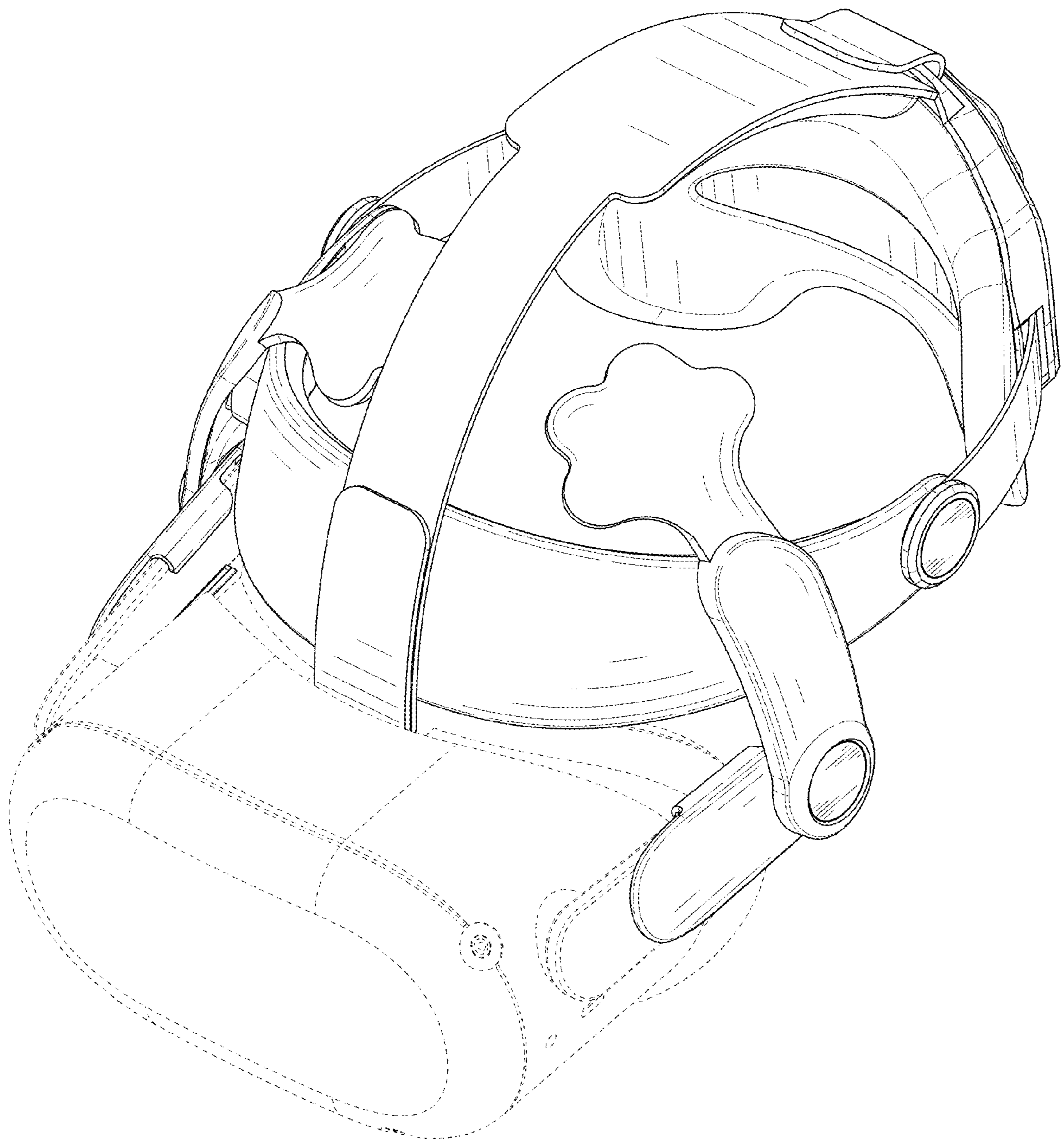
