FIG. 1 is a top plan view for a skin cover set for a game controller with through-voids showing my new design thereof;

FIG. 2 is a left side elevational view thereof;

FIG. 4 is a front elevation view thereof; and,

FIG. 5 is a rear elevational view thereof.

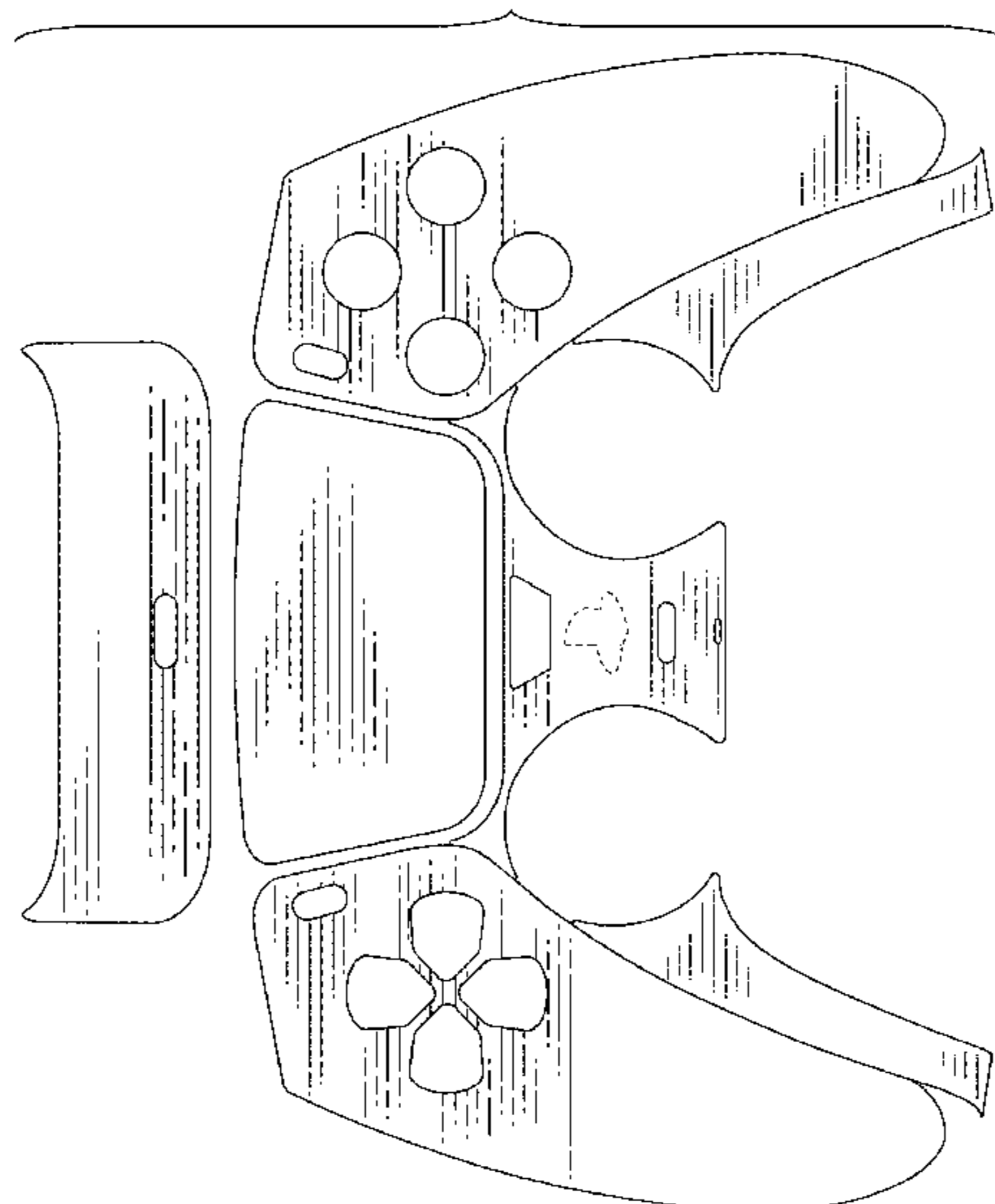
The broken lines in FIG. 1 show portions of the skin cover set for a game controller which form no part of the claimed design.

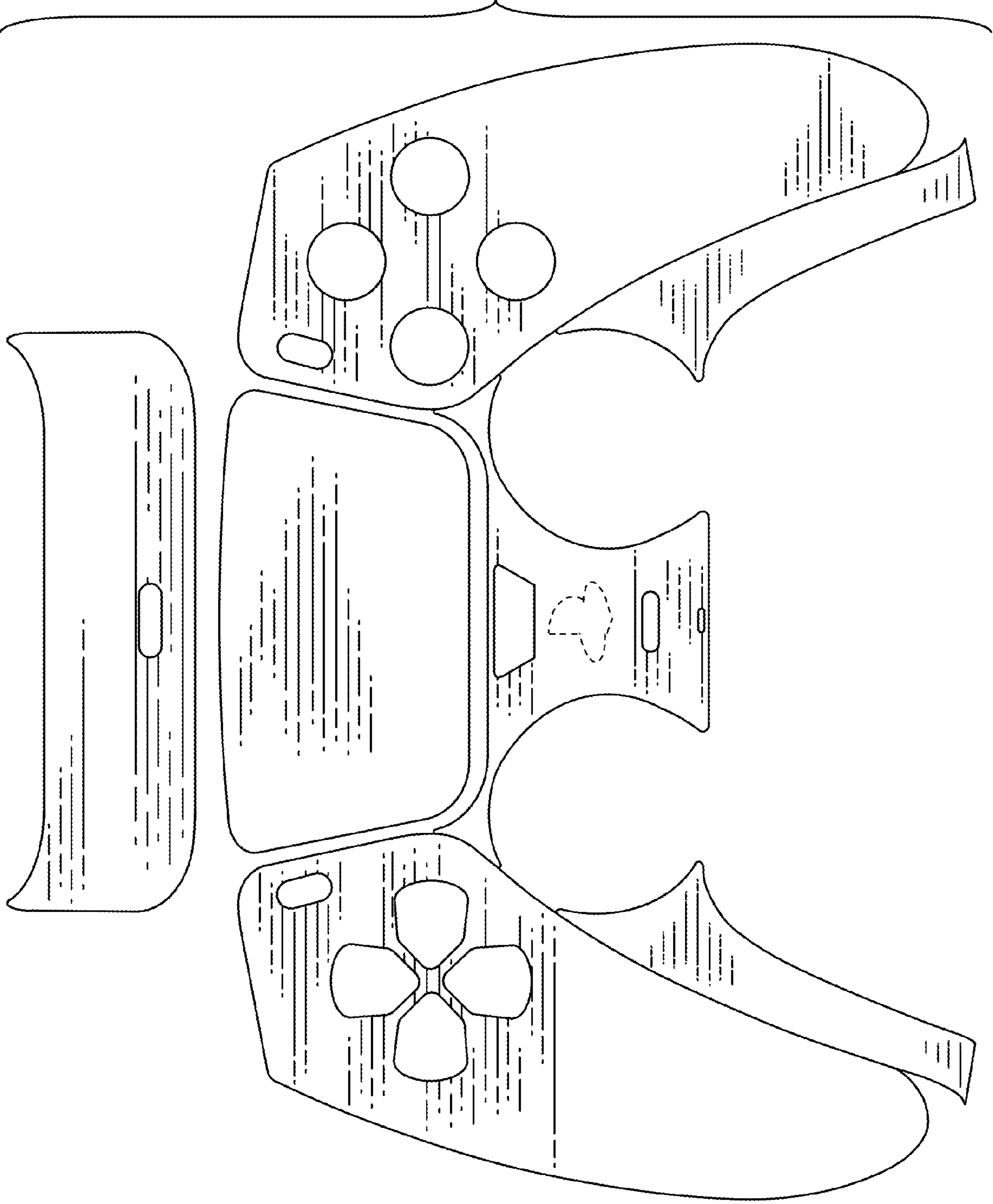

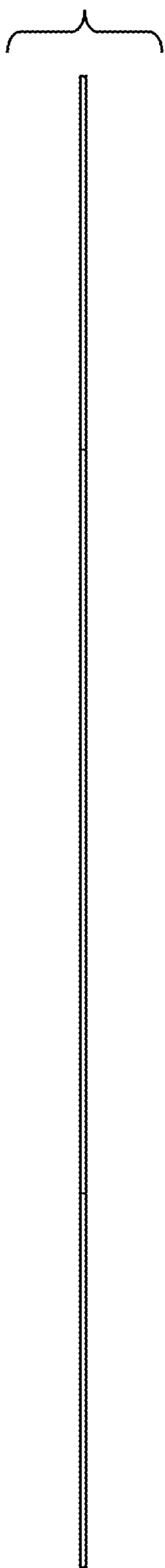

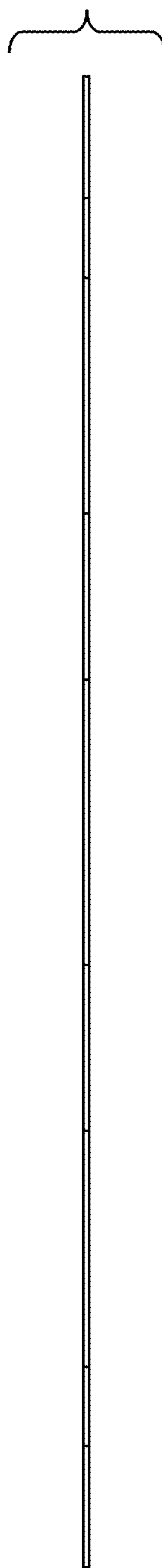

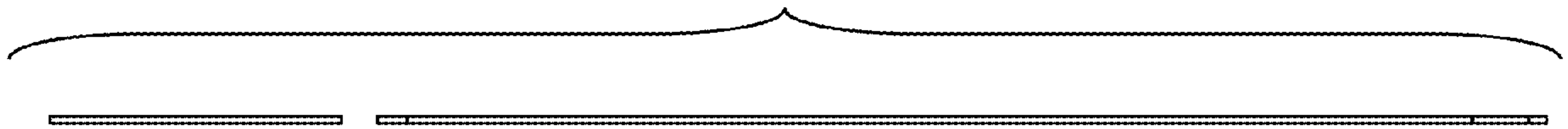
