The ornamental design for a slide member of an adjustable finger splint, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a slide member of an adjustable finger splint, taken from the back.

FIG. 2 is a front view thereof;

FIG. 3 is a back view thereof;

FIG. 4 is a left-side view thereof;

FIG. 5 is a right-side view thereof;

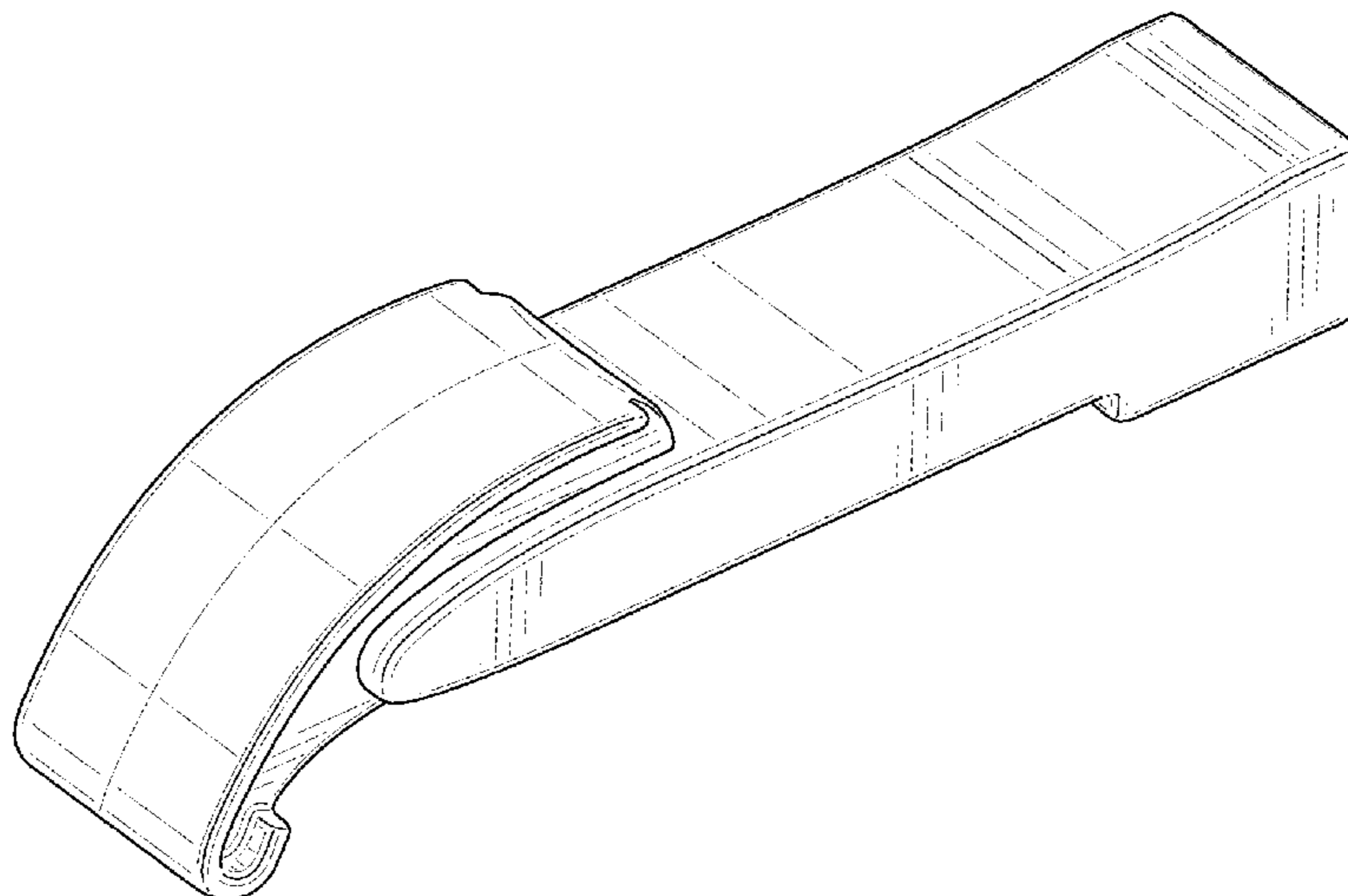
FIG. 6 is a top view thereof; and,

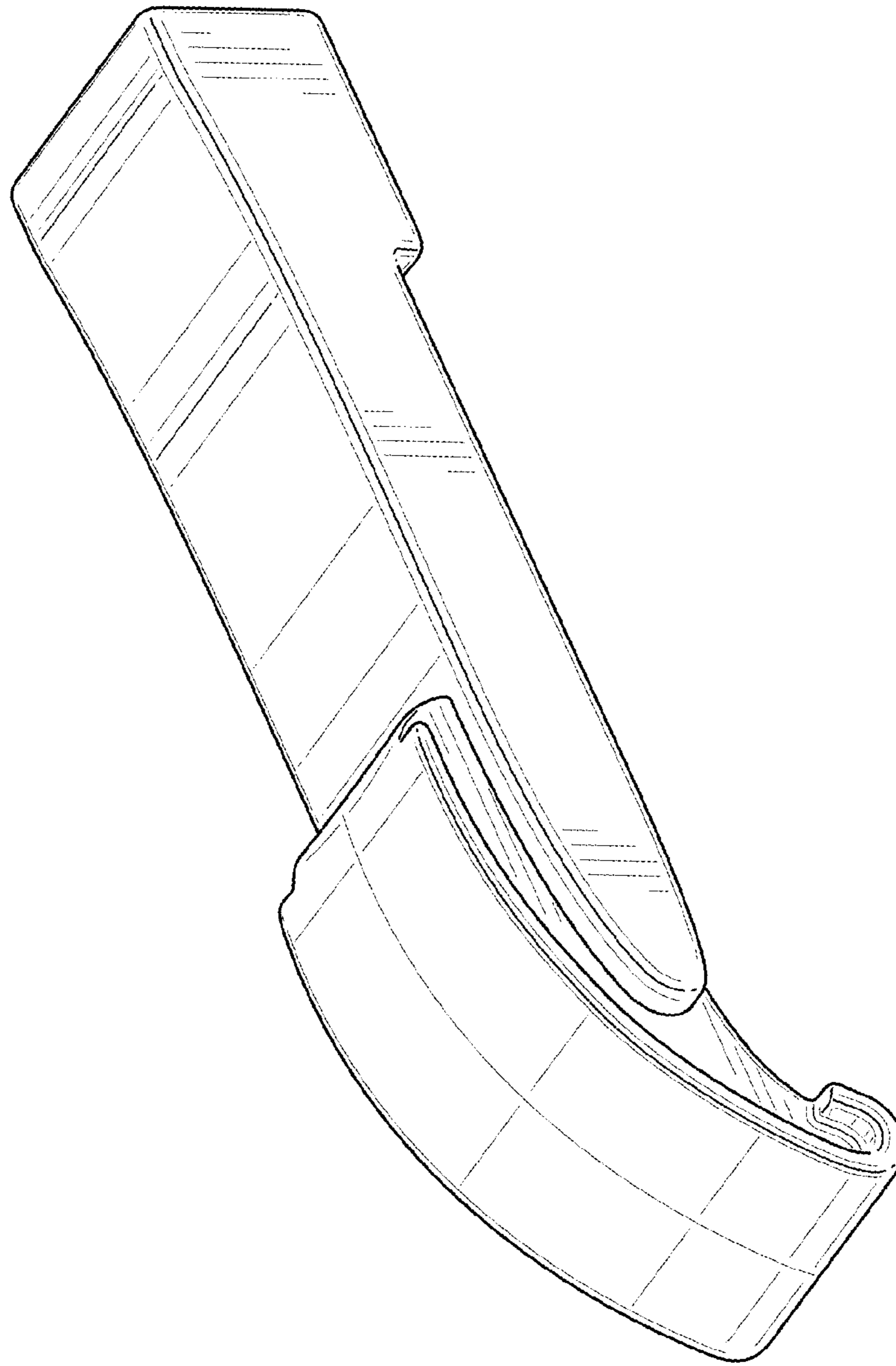

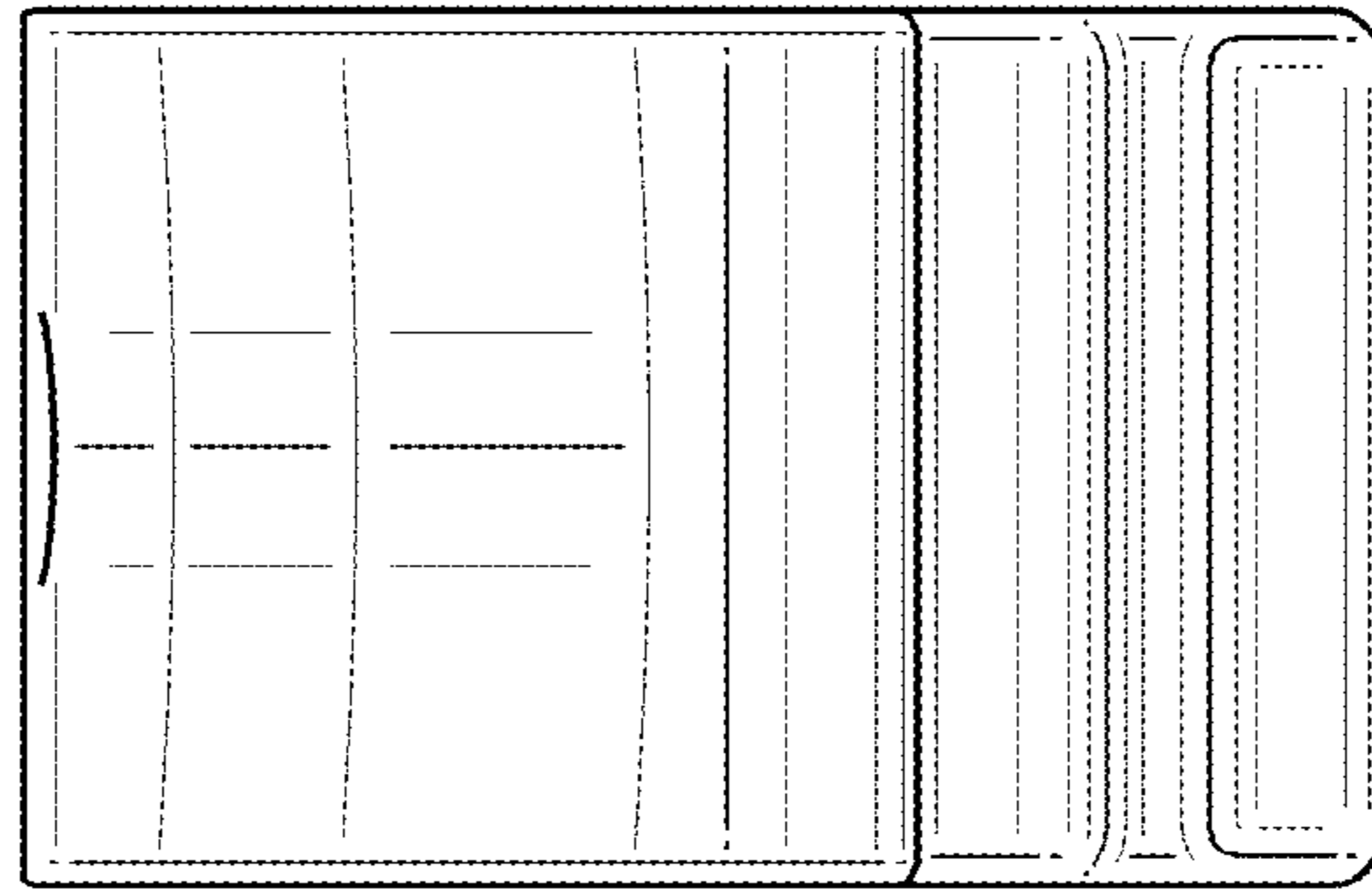

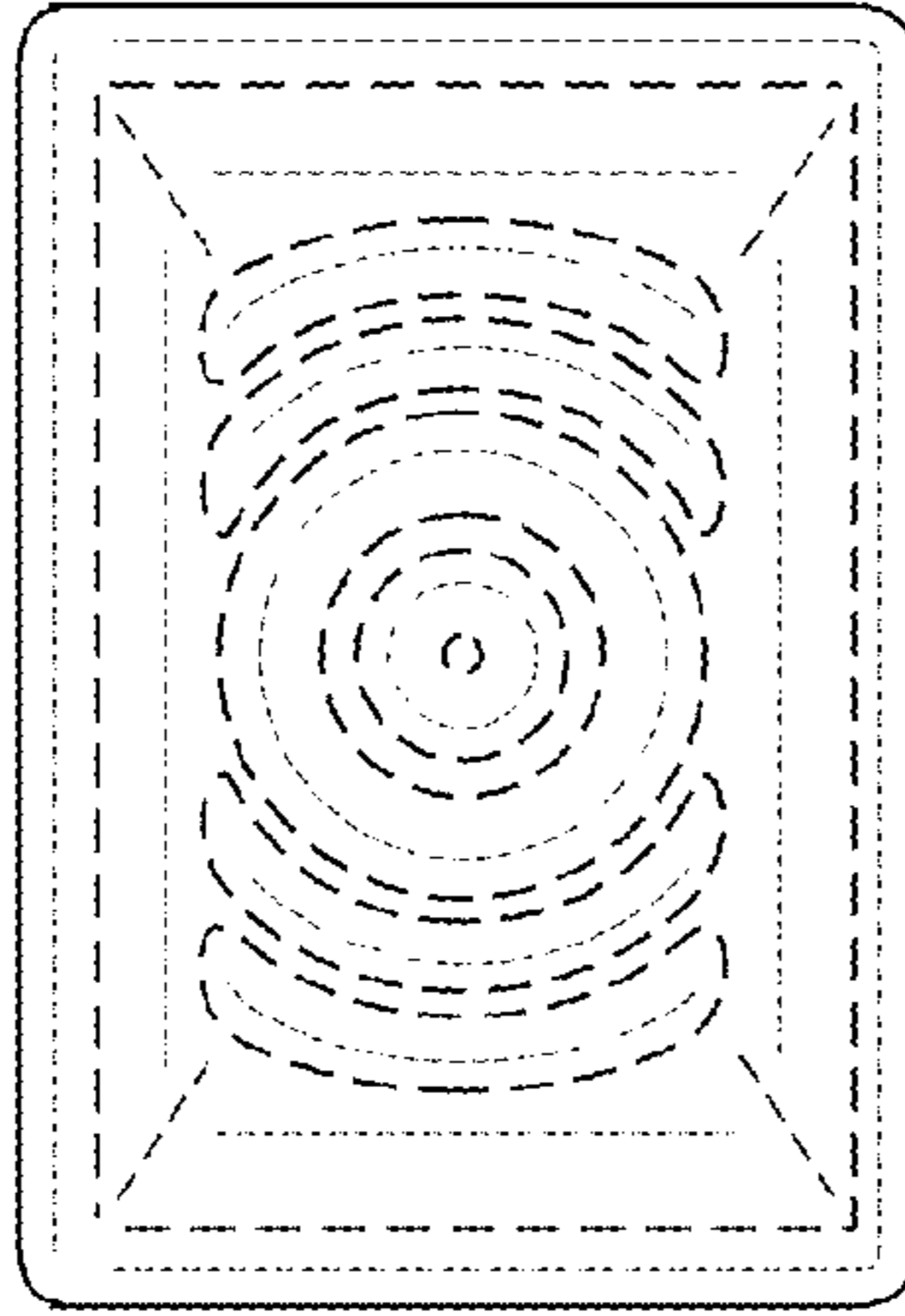

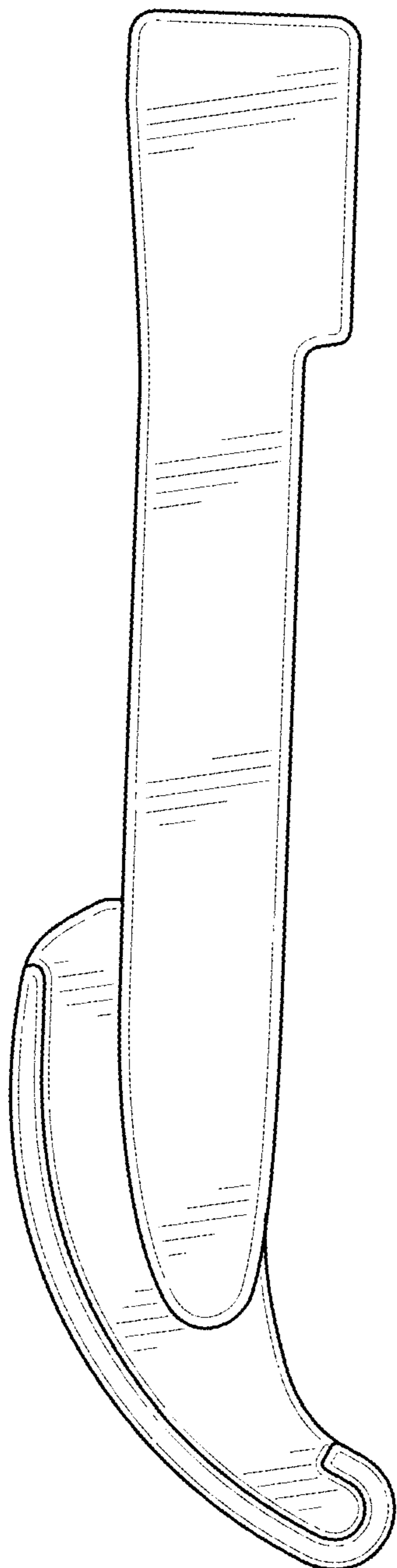

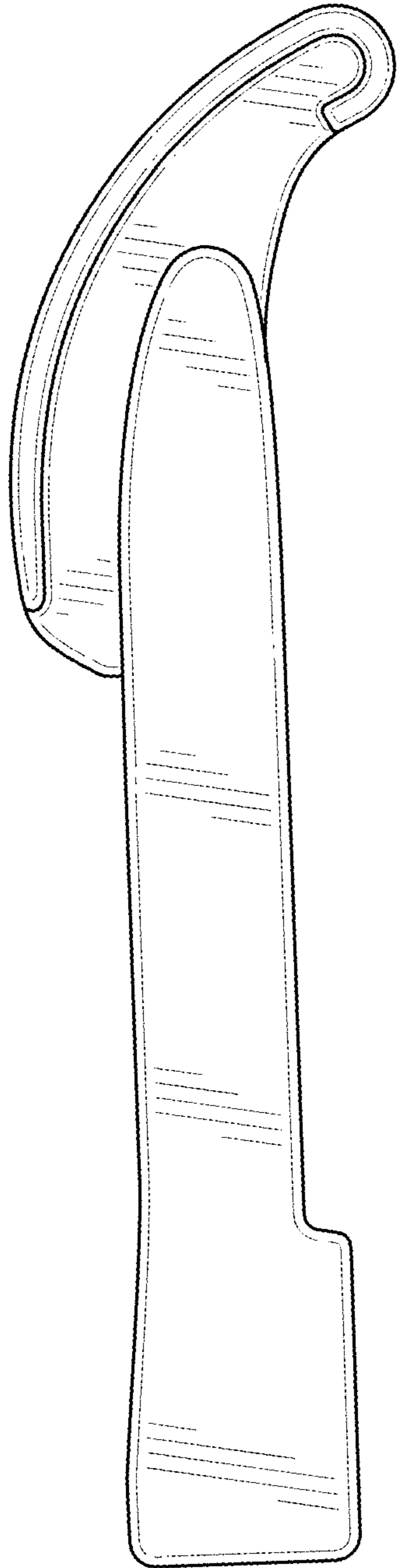

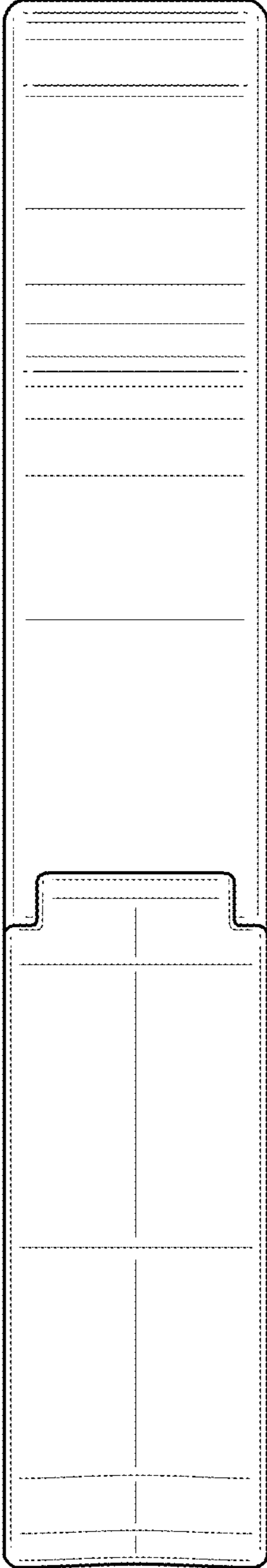

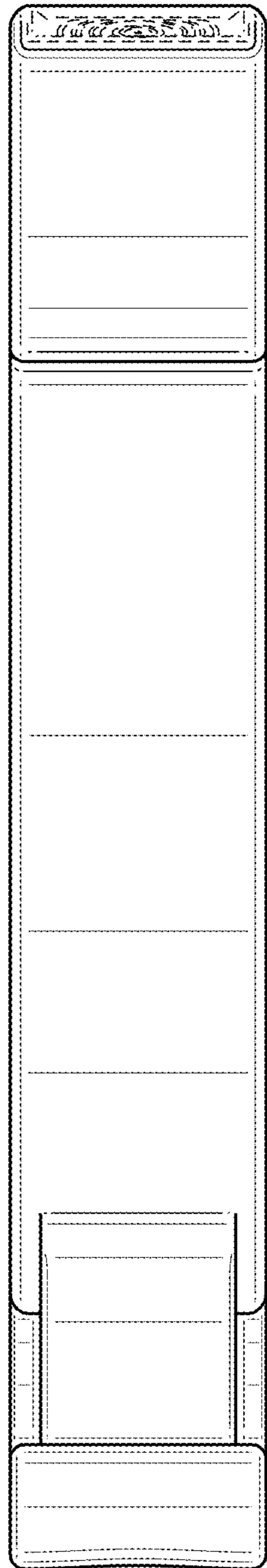
