FIG. 3 is a front perspective view of the maternity support shown in FIGS. 1 and 2, shown in a position of use.

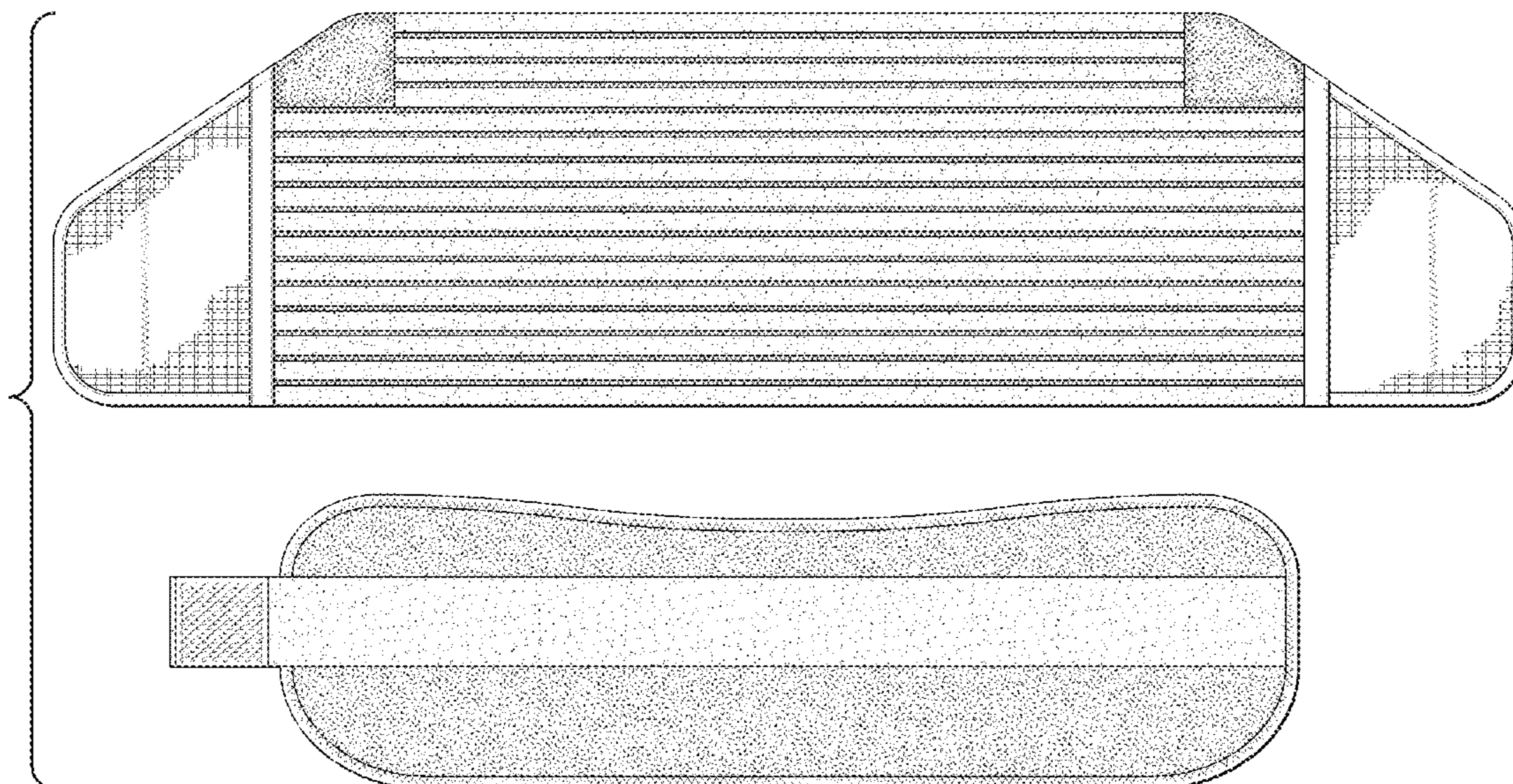
FIG. 4 is a front elevation view of the maternity support shown in FIG. 3;

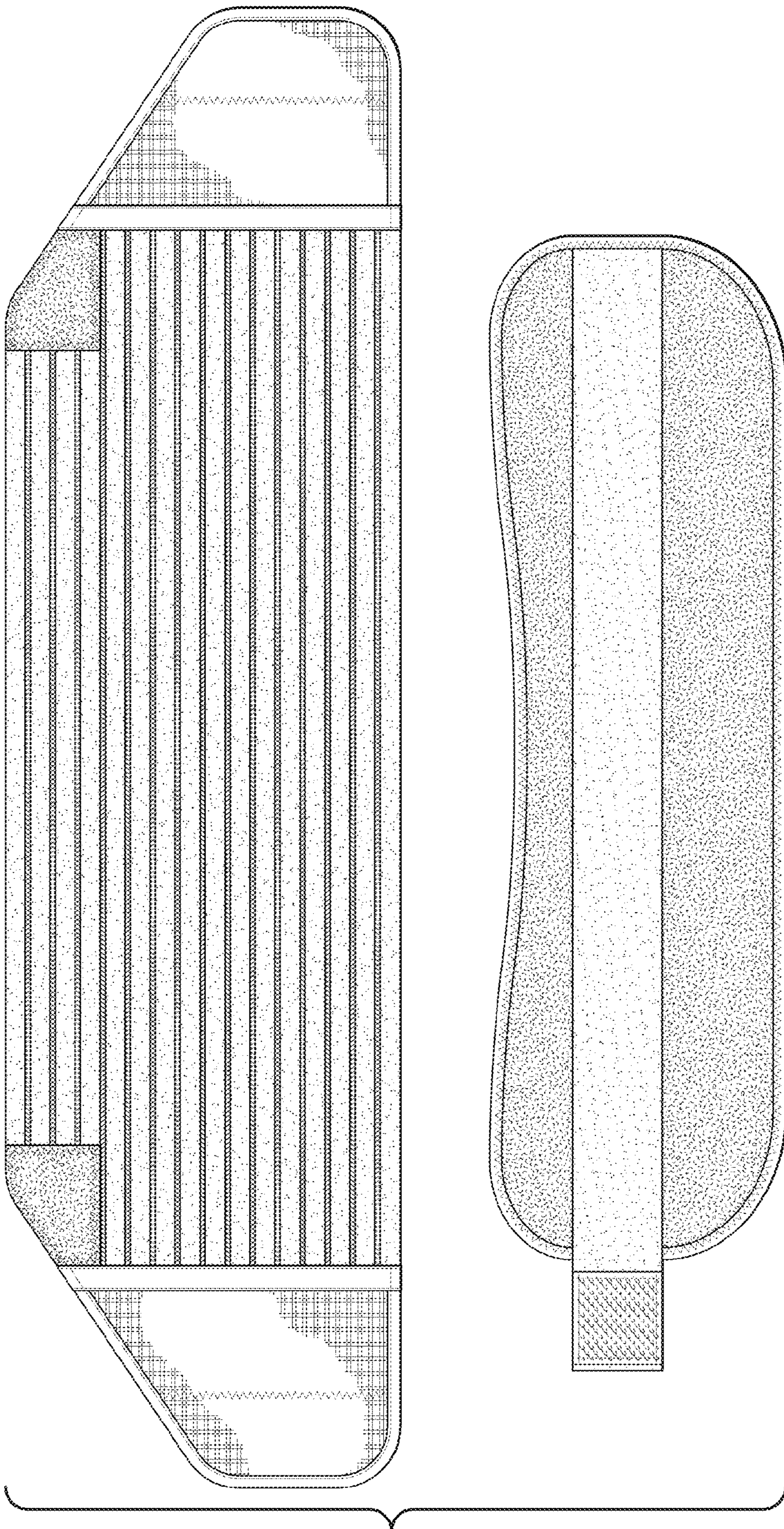

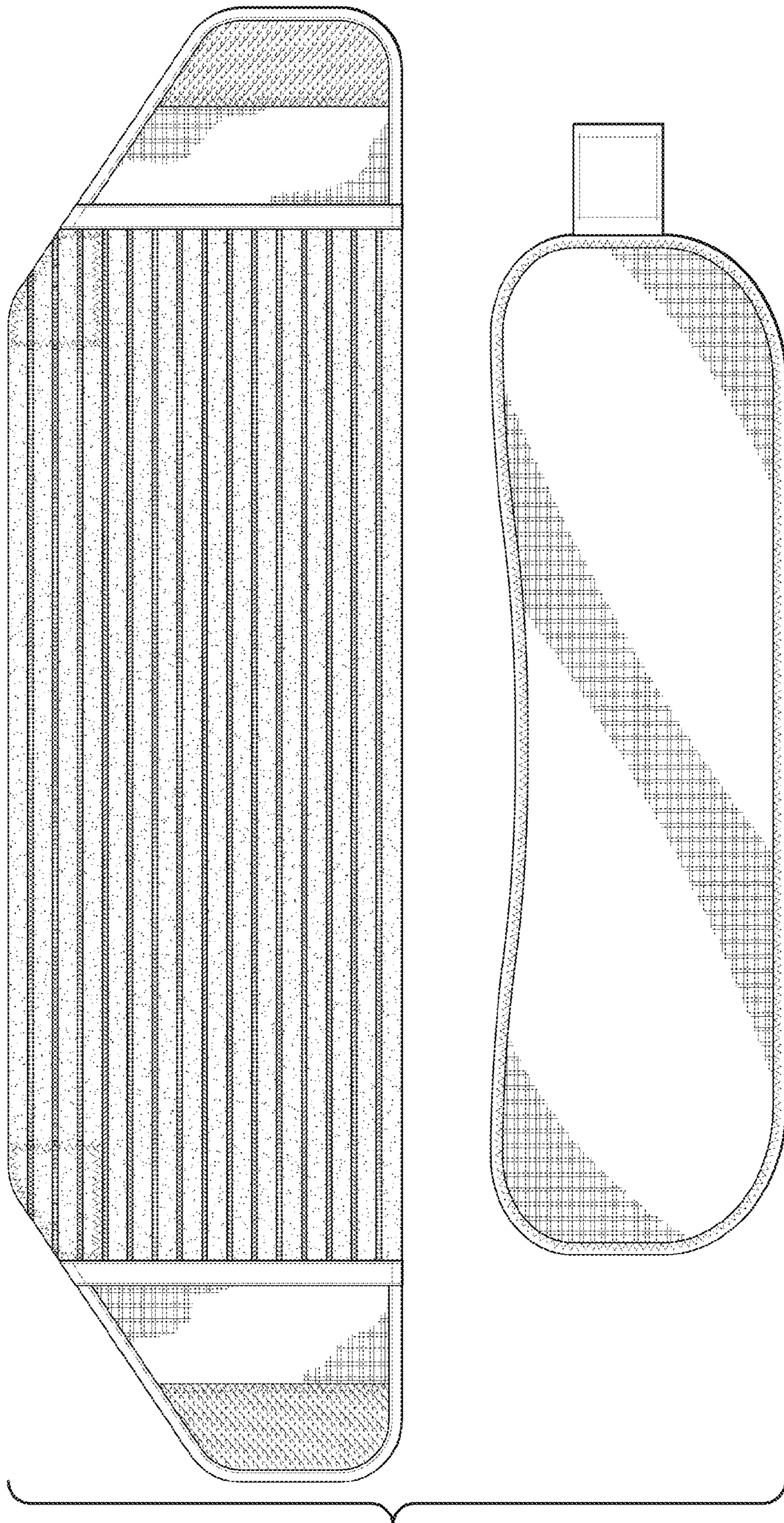

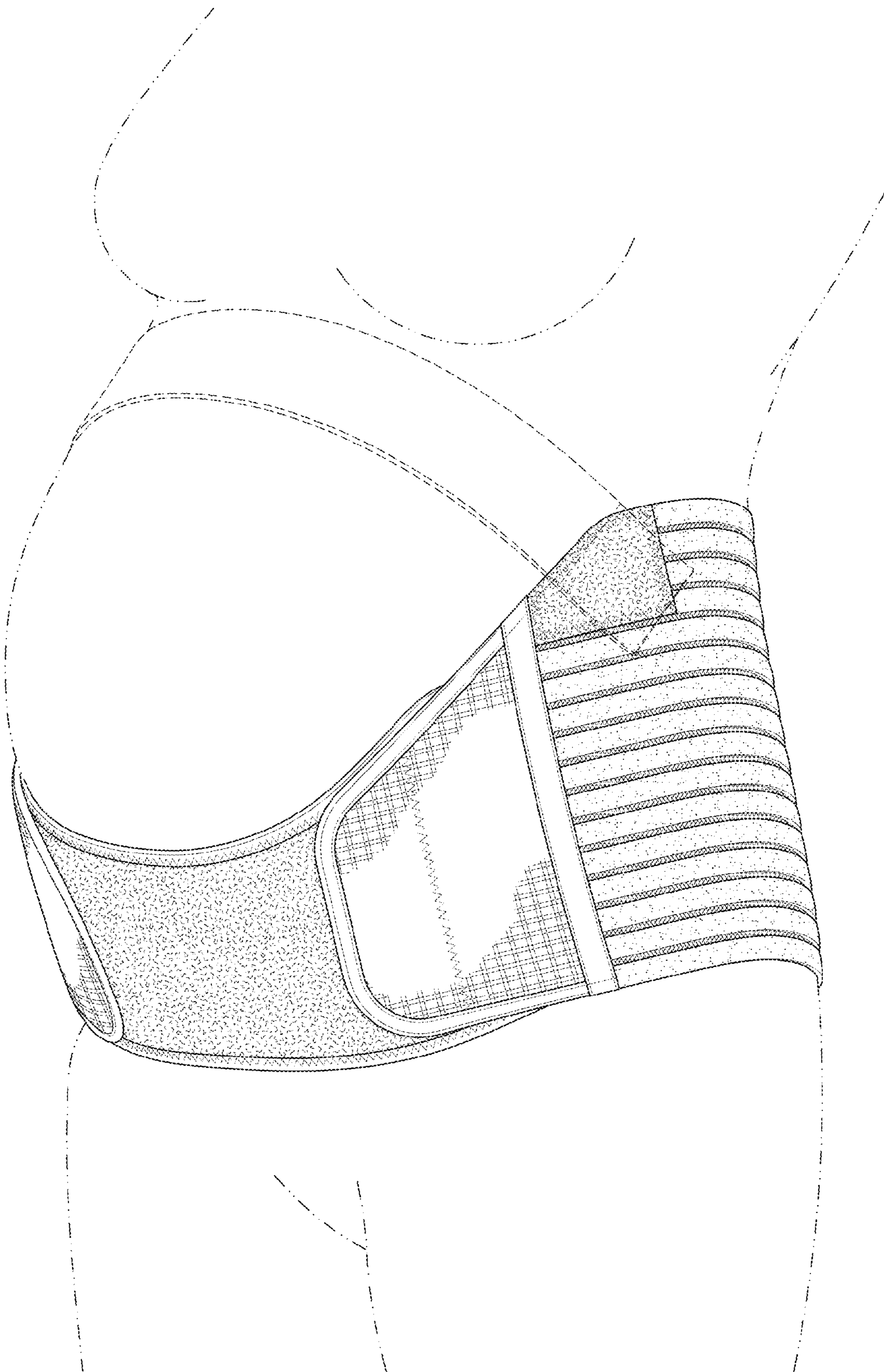

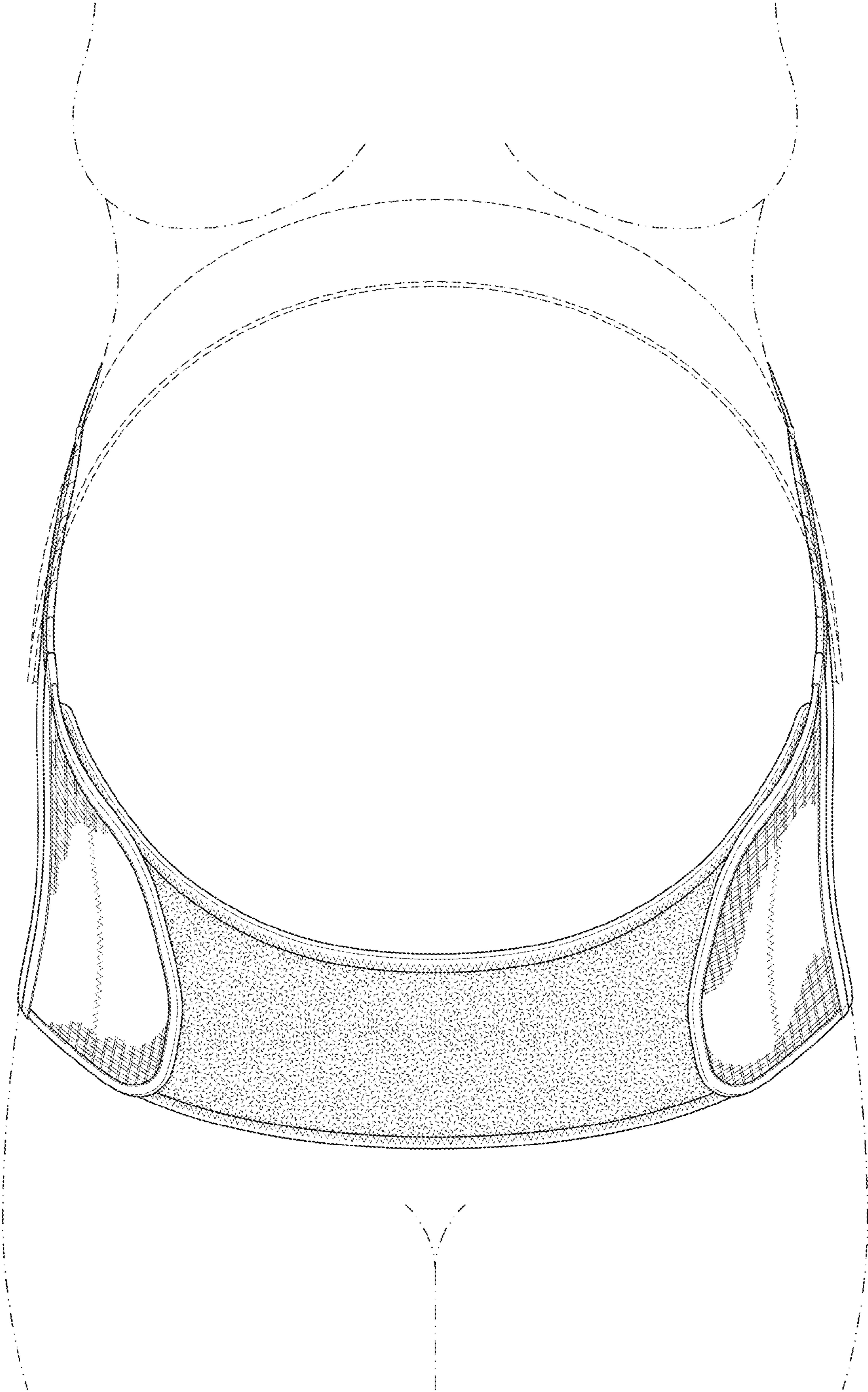

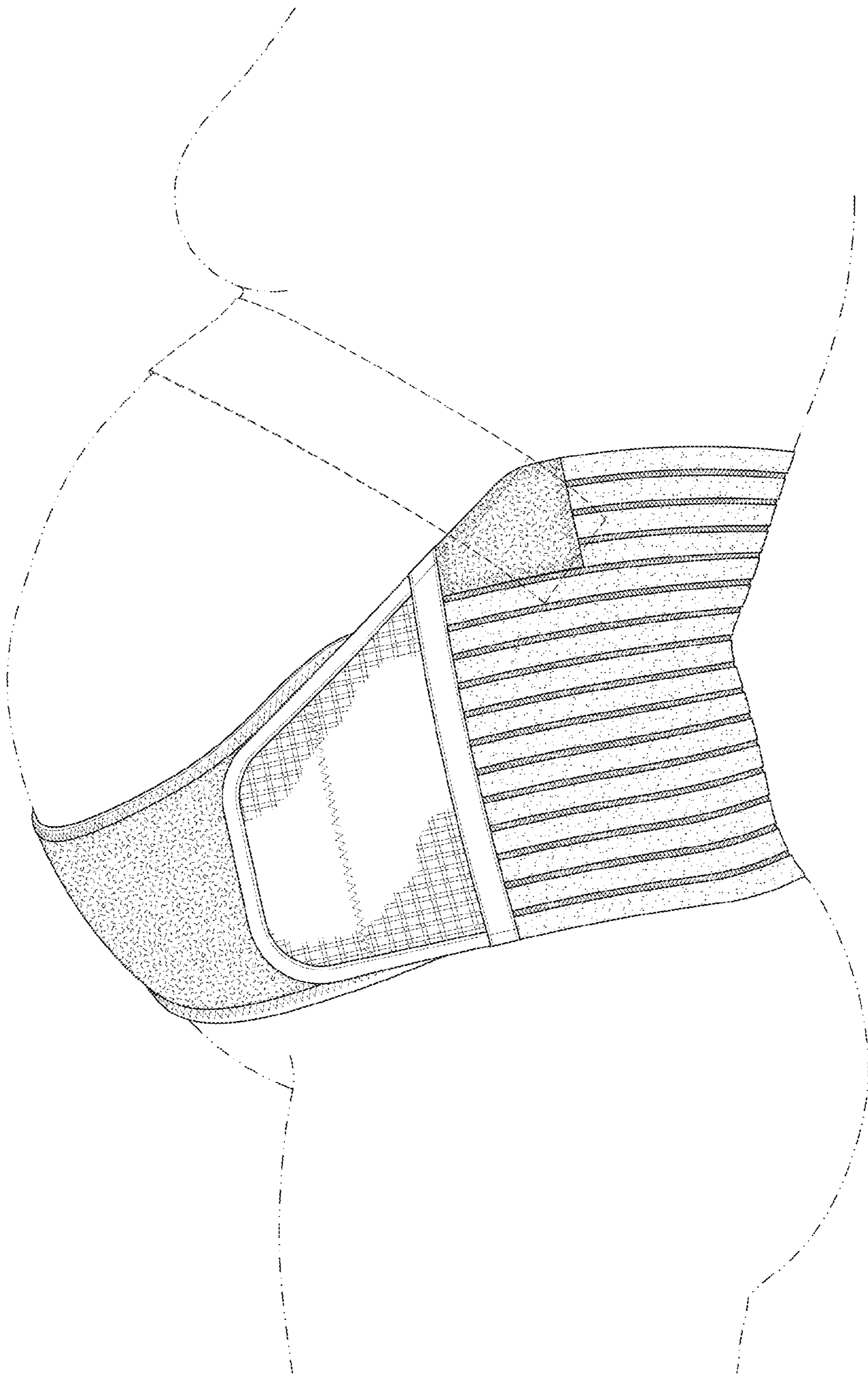

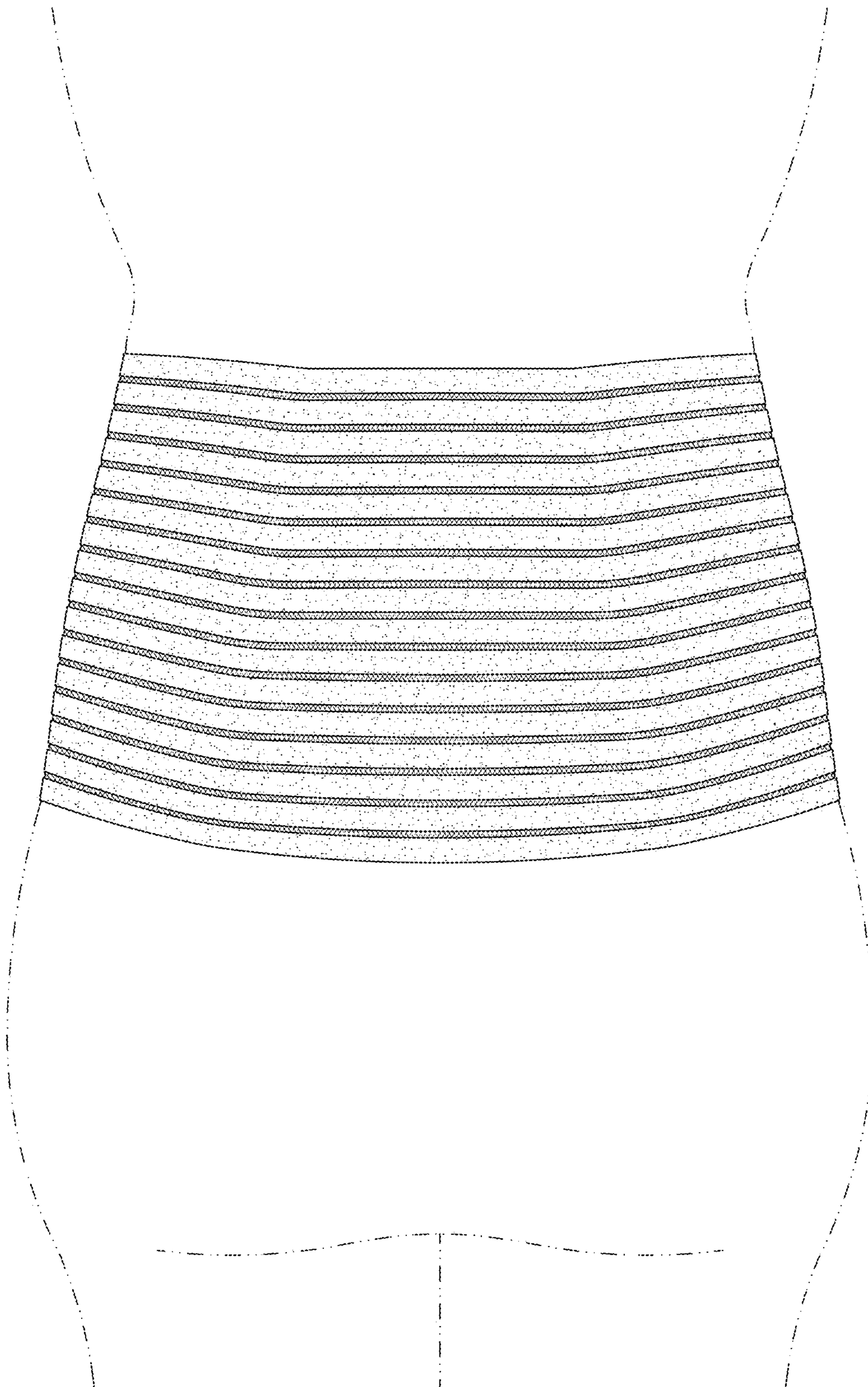
