(57) **CLAIM**

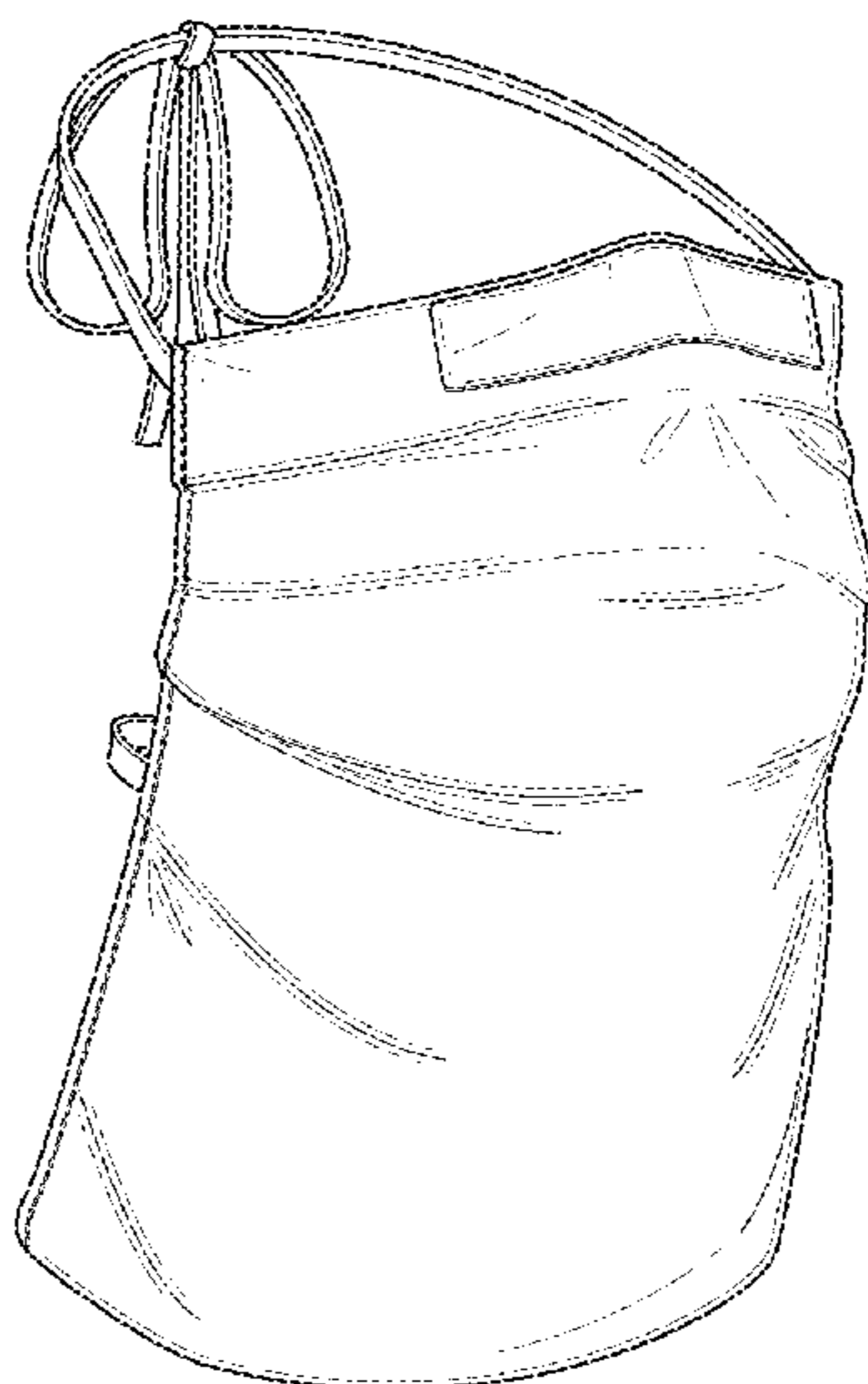
The ornamental design for a beard mask, as shown and described.

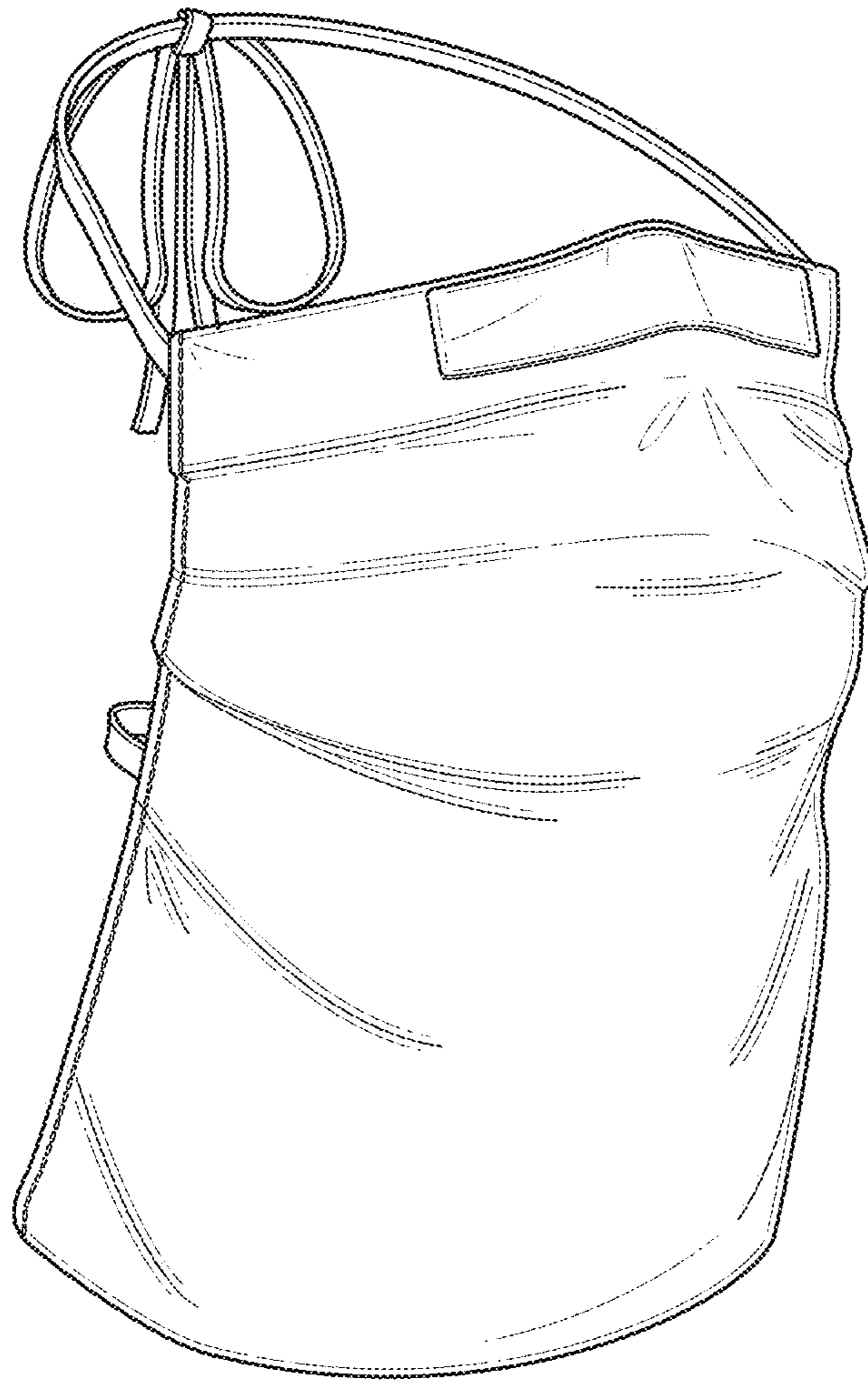

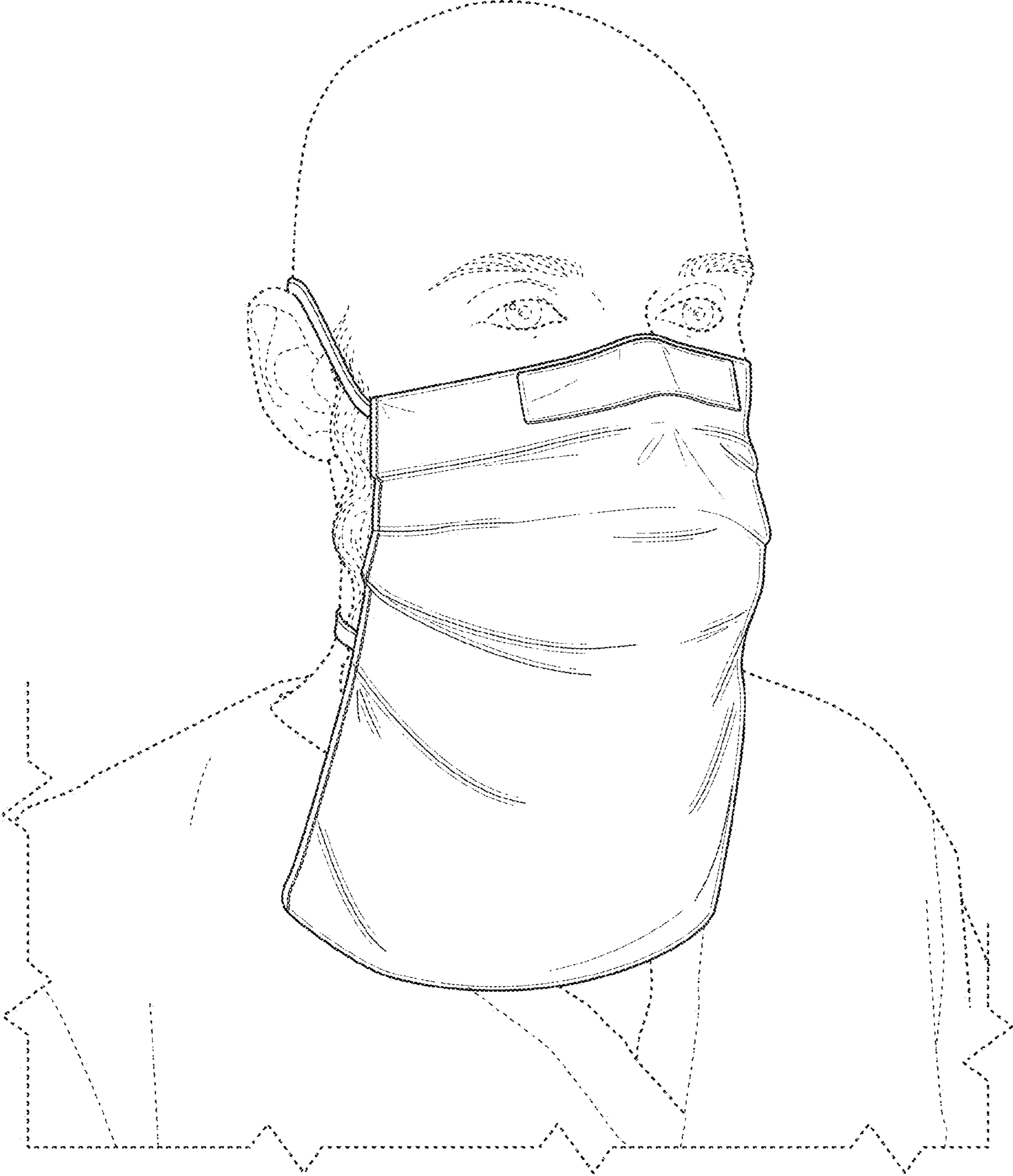

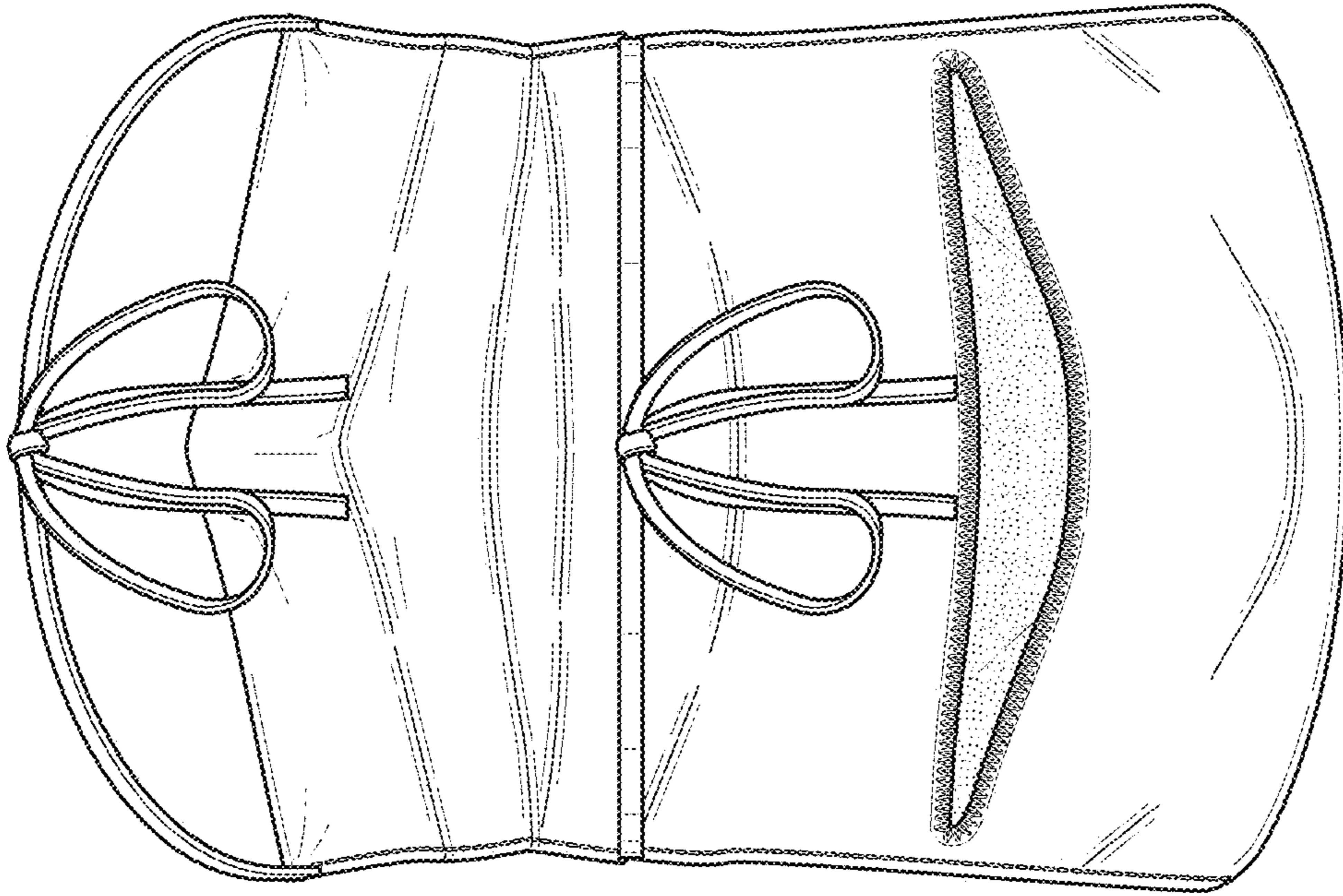

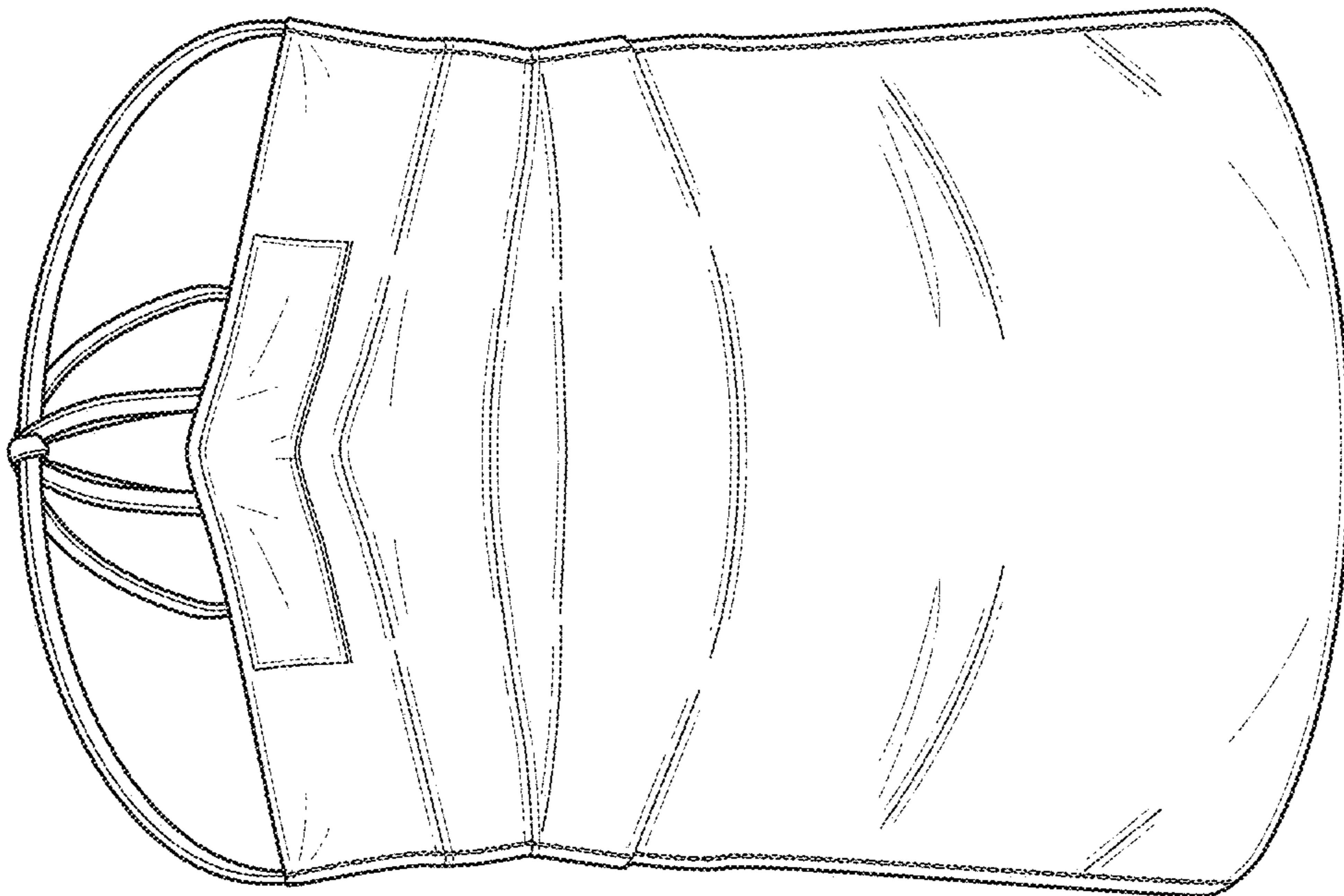

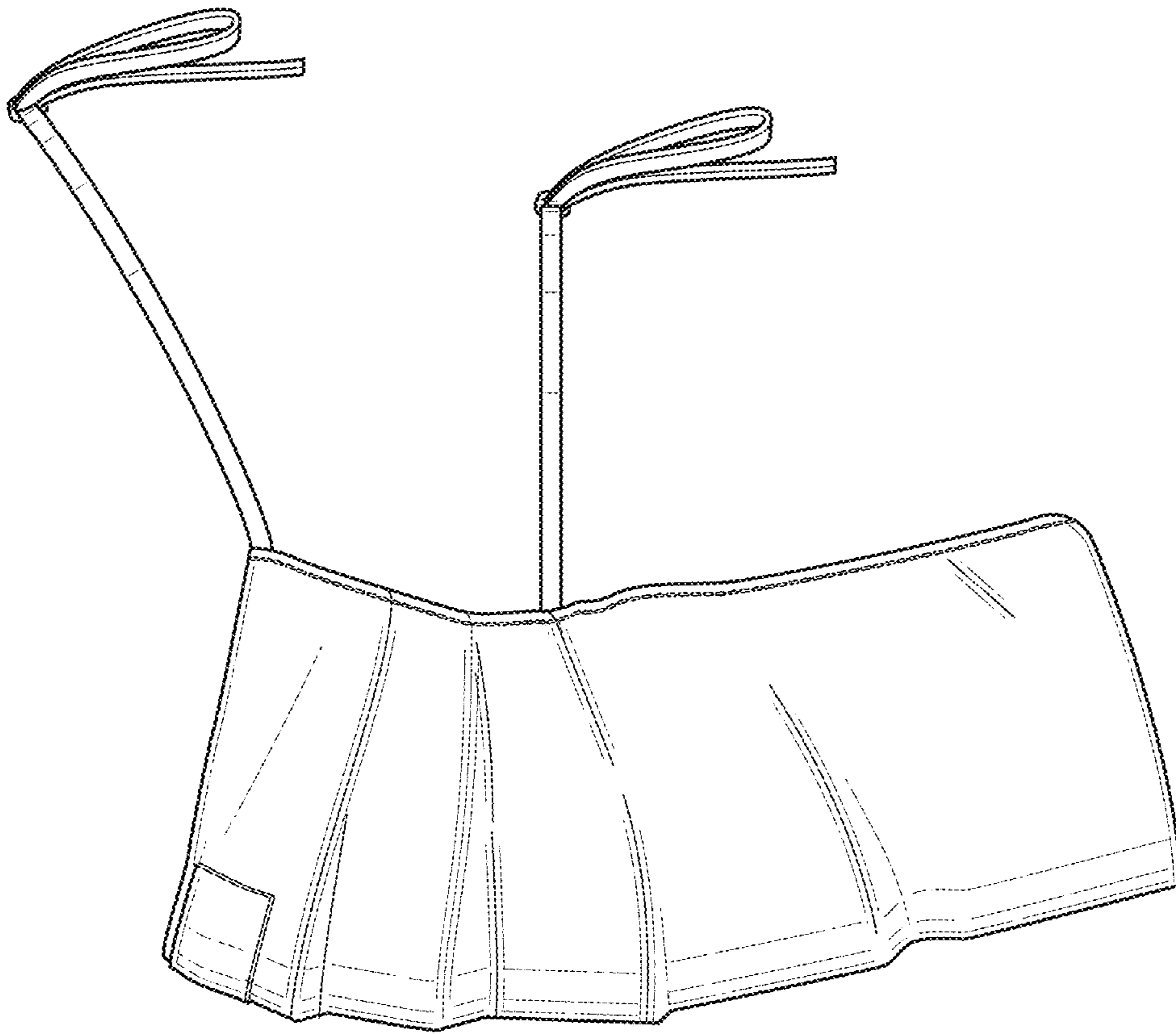

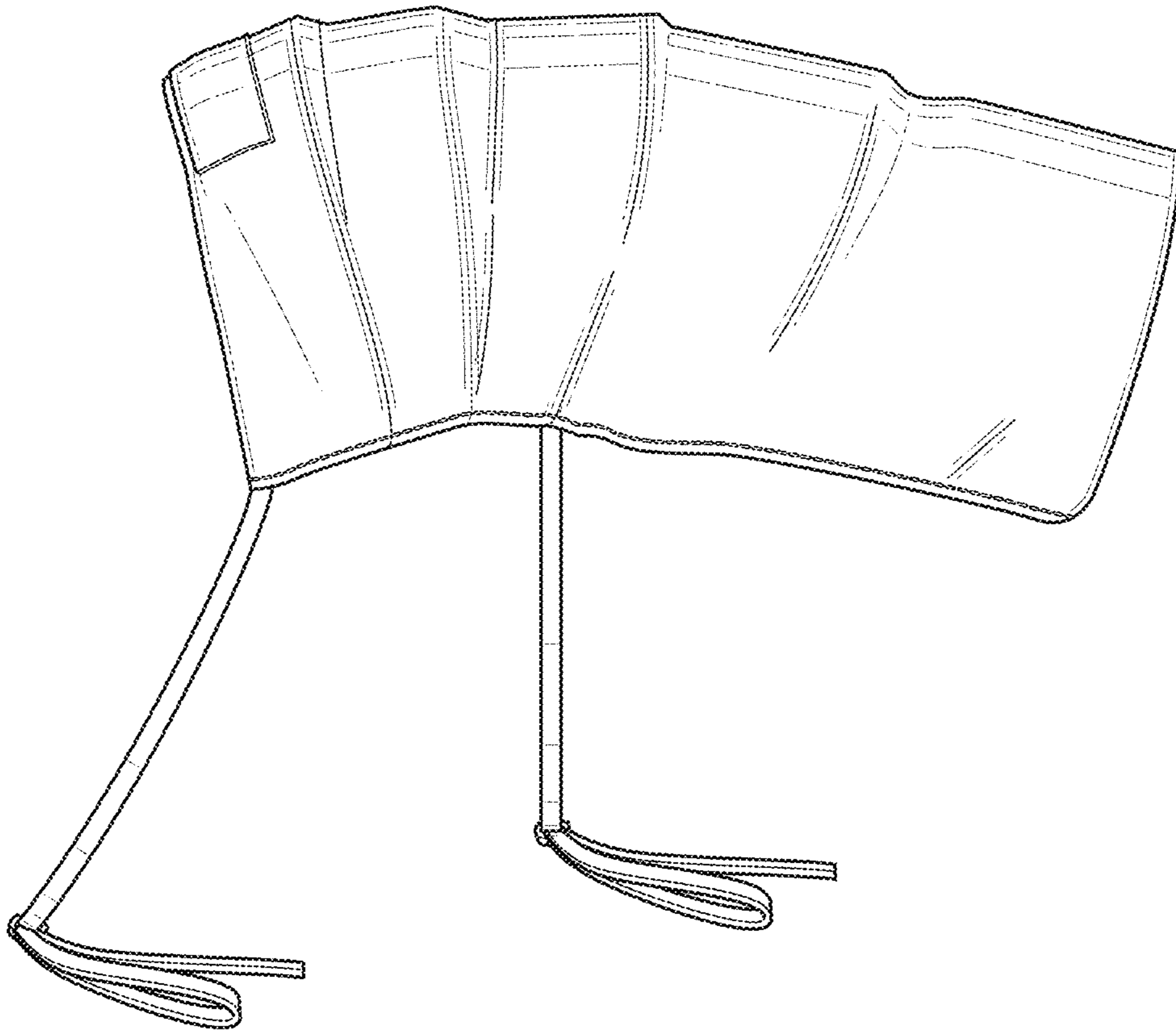

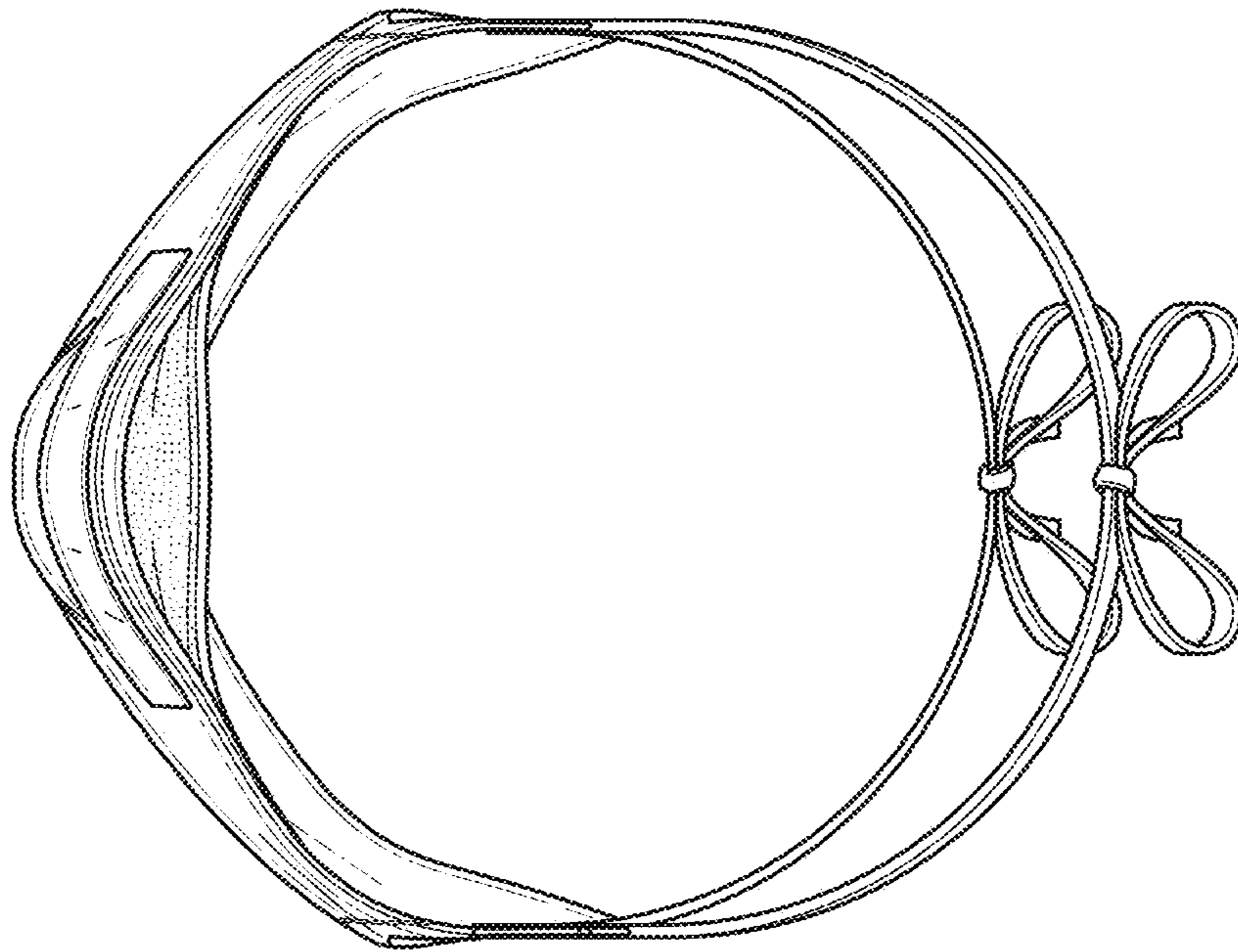

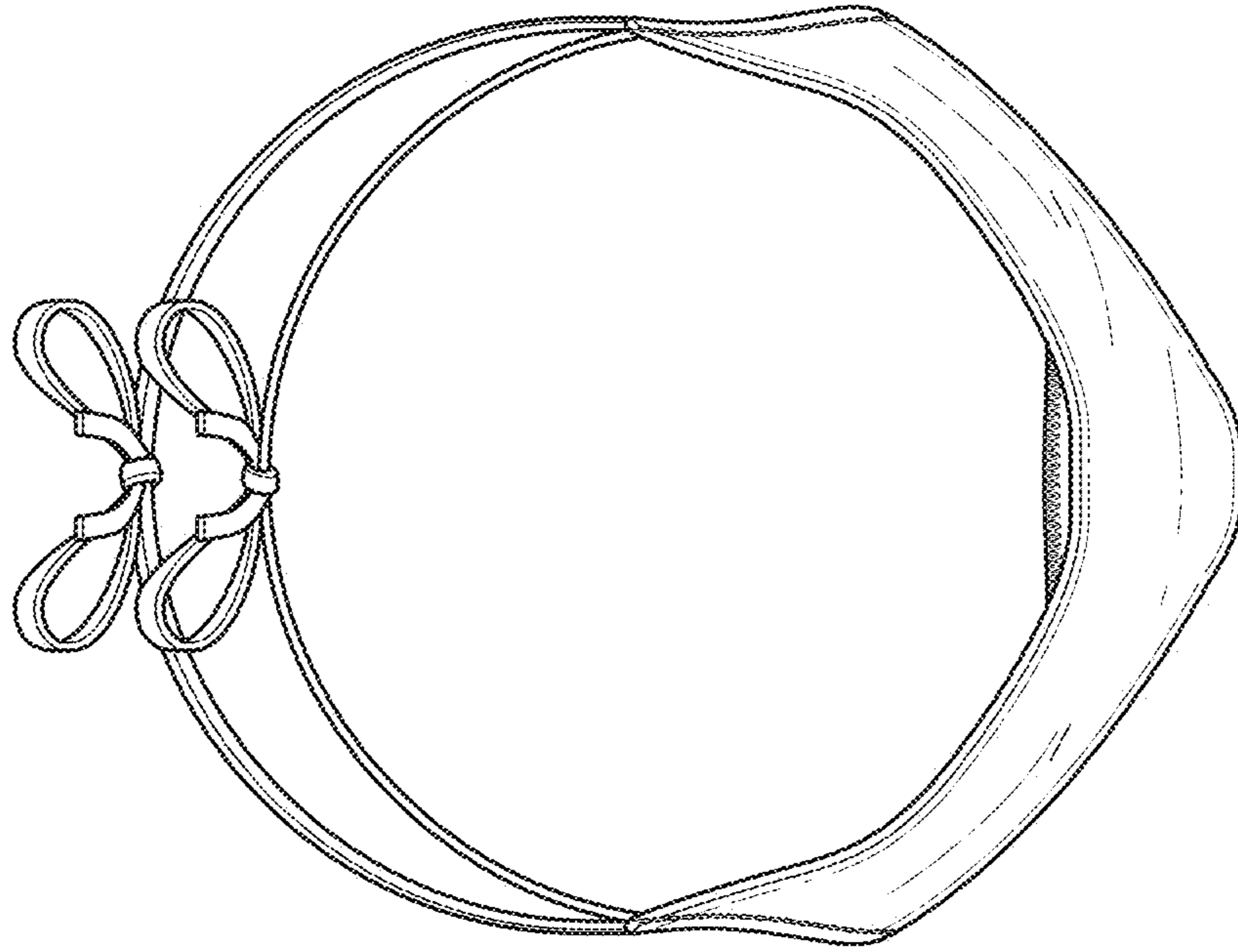
