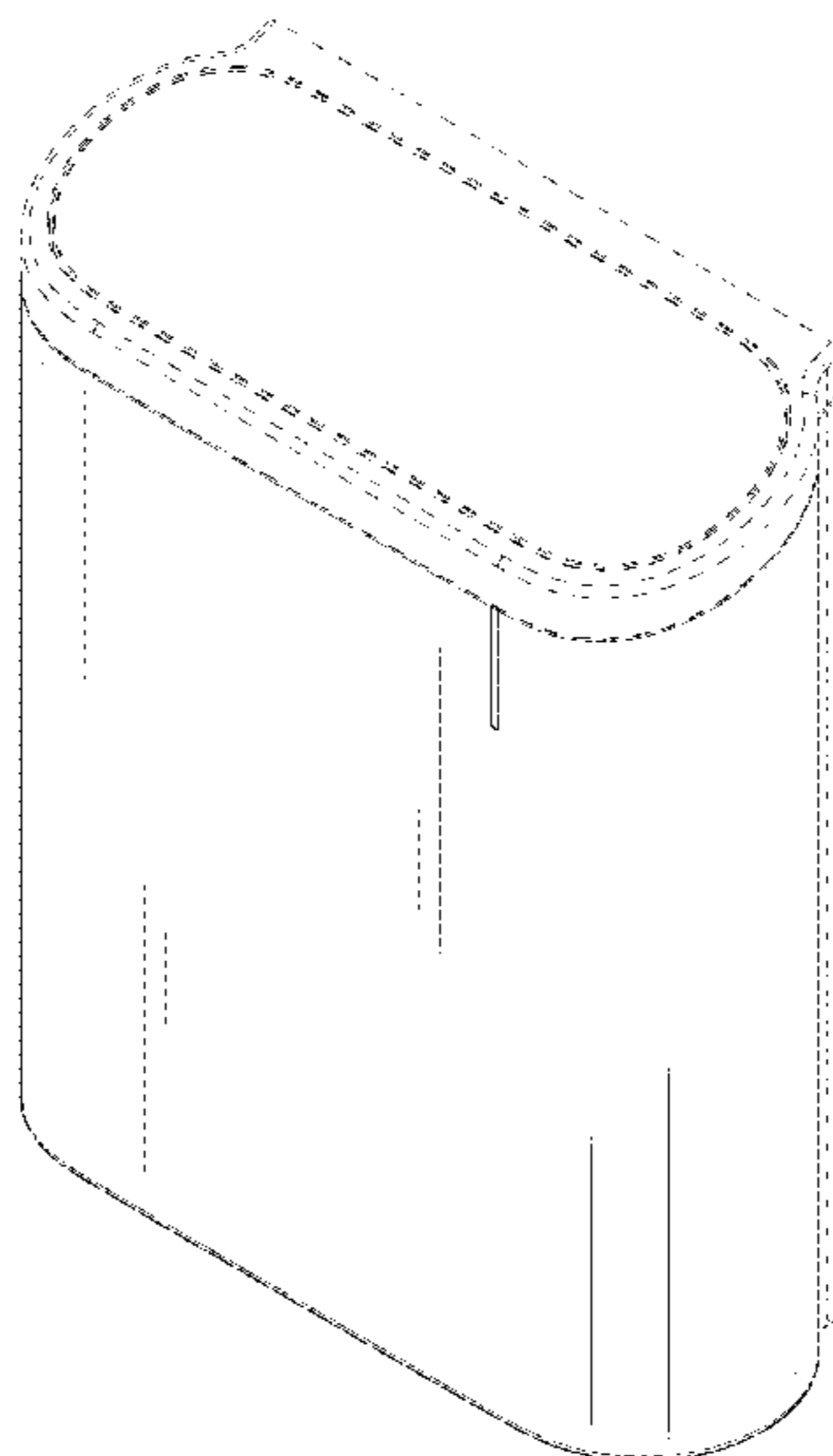
FIG. 12 is a right side view of the napkin disposal unit of FIG. 9;

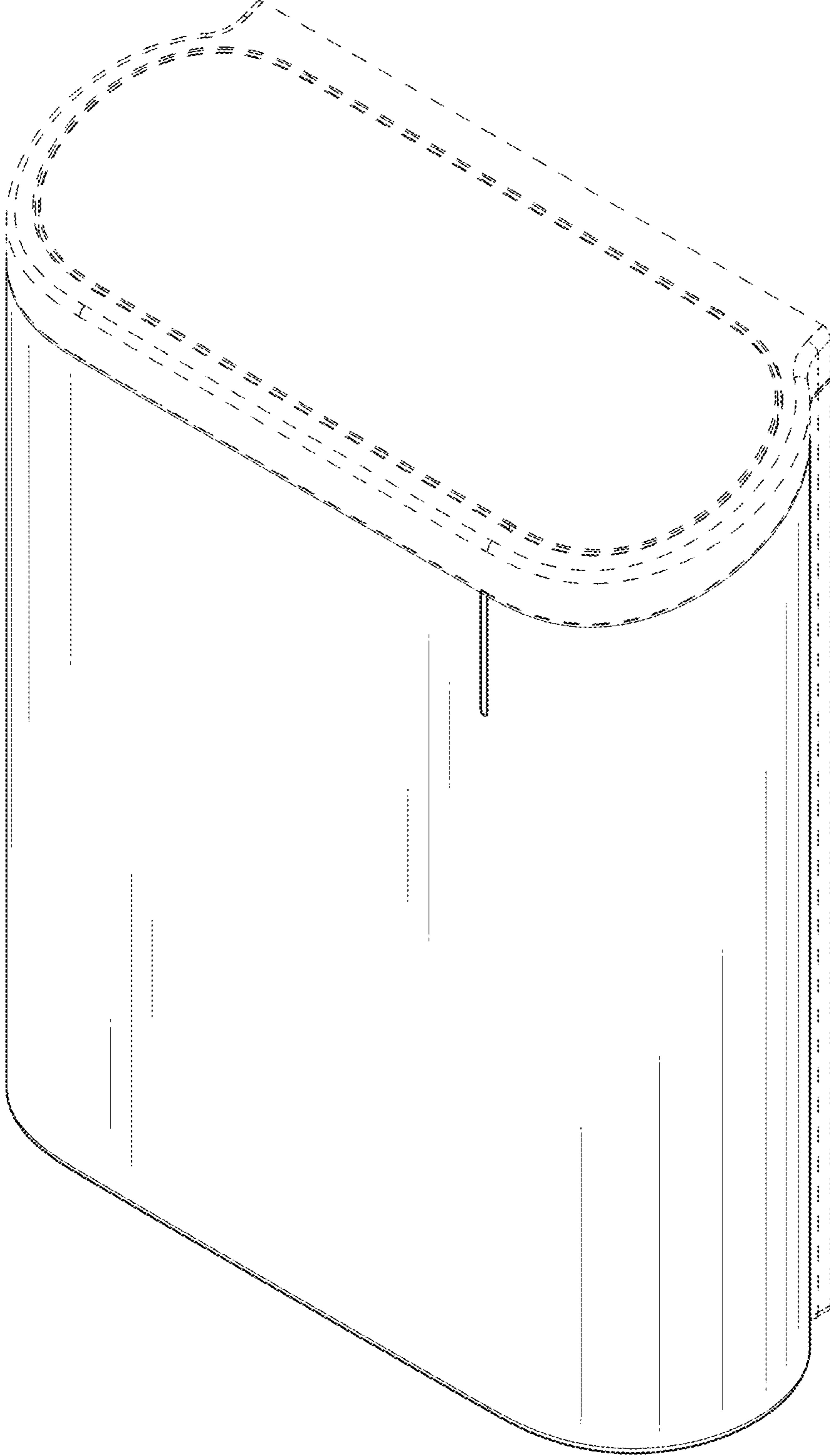

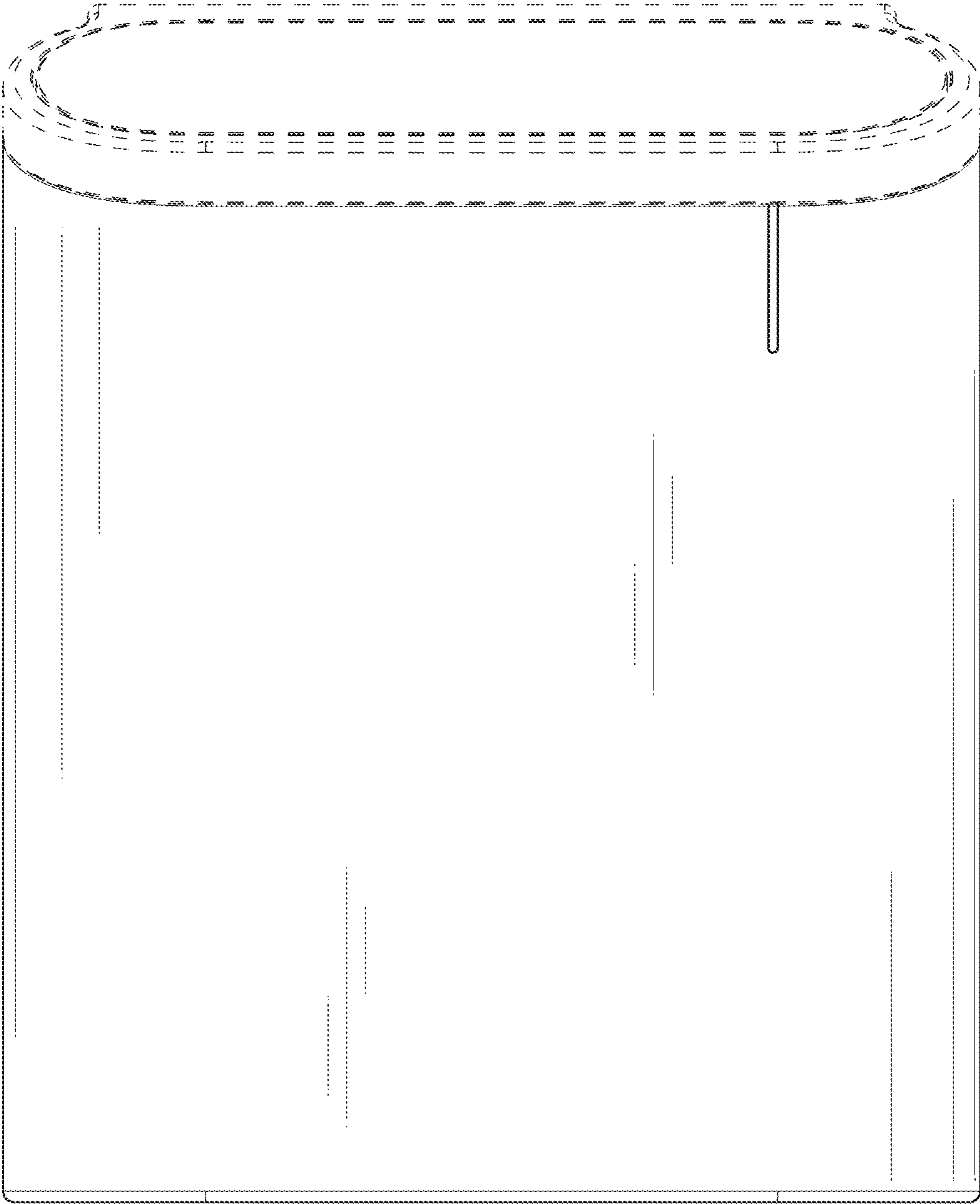

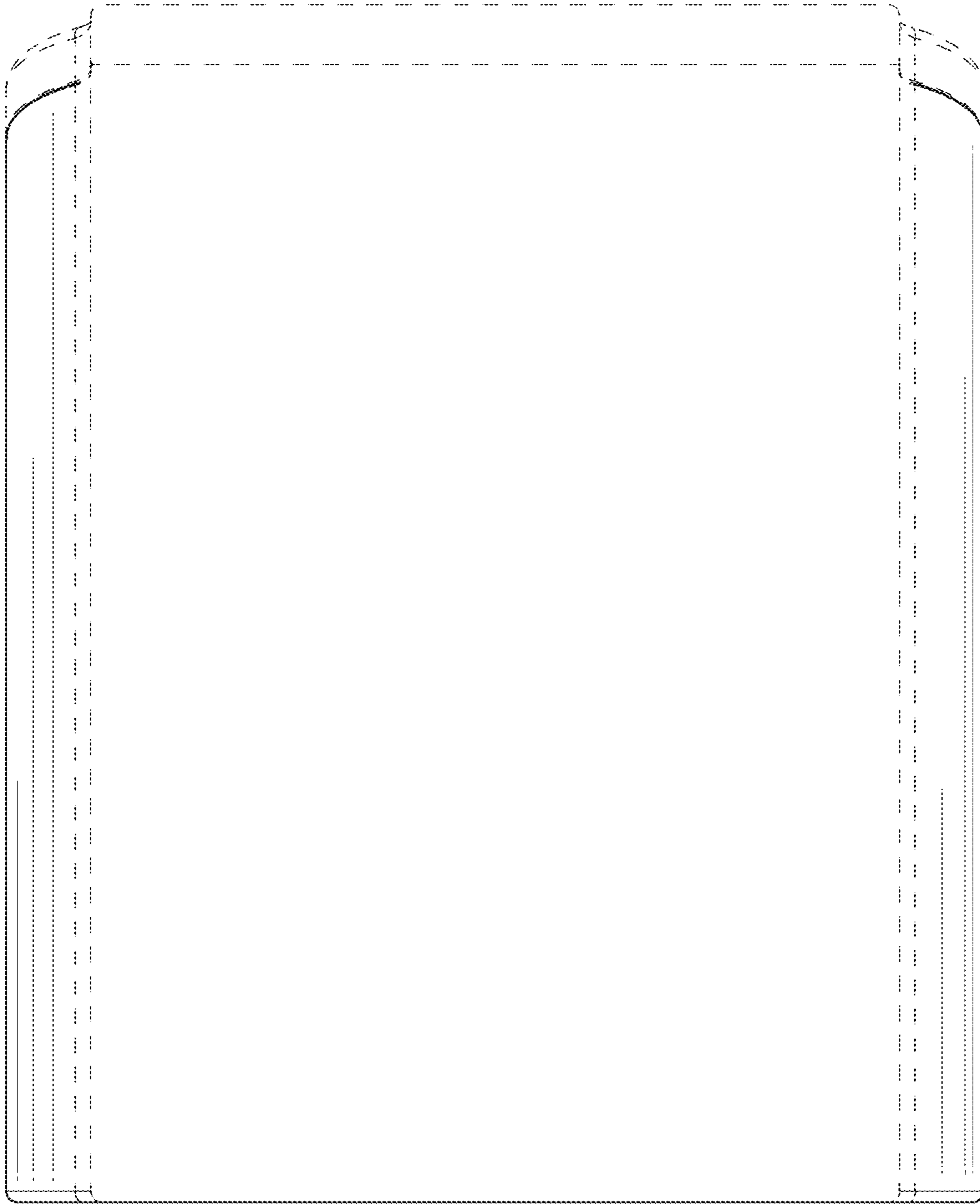

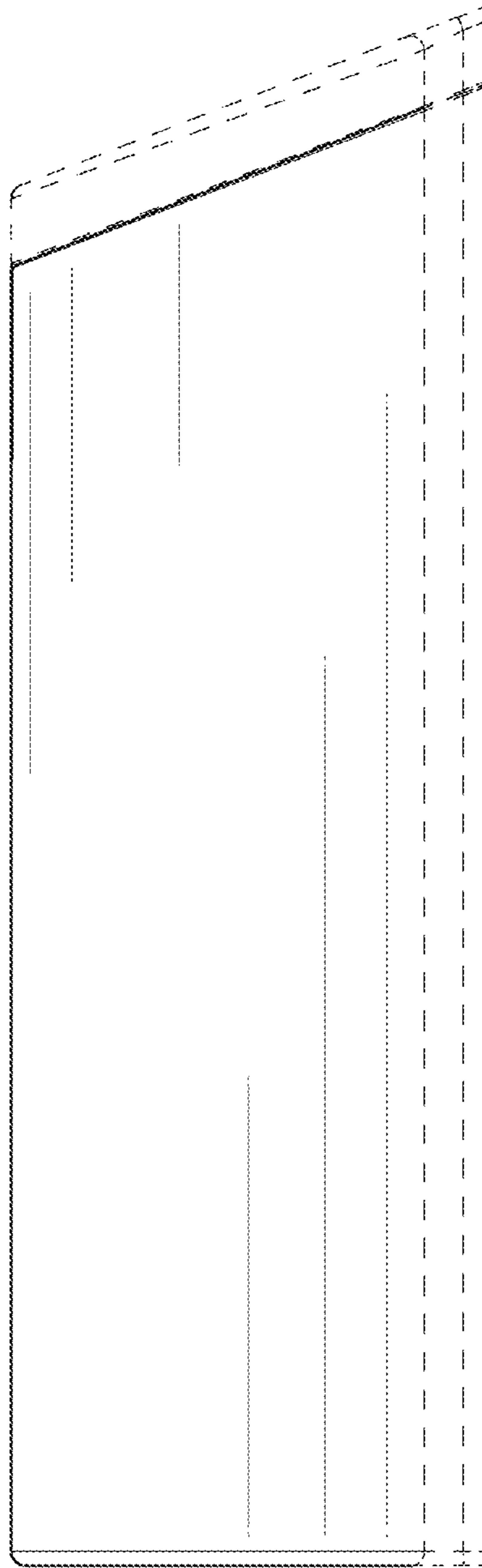

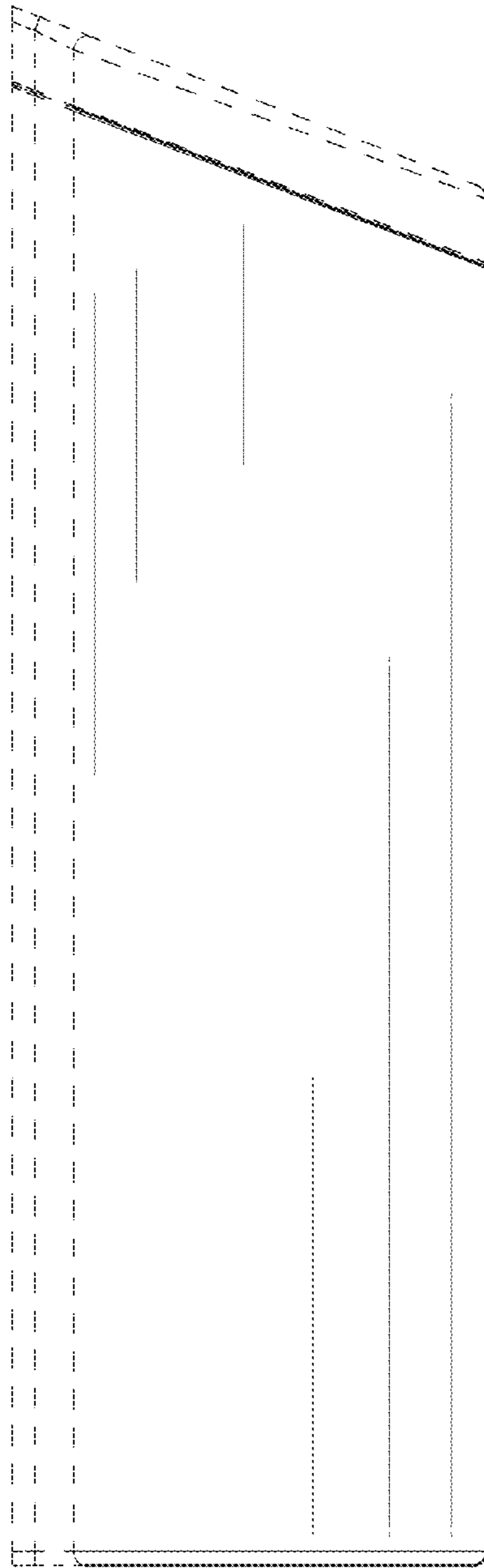

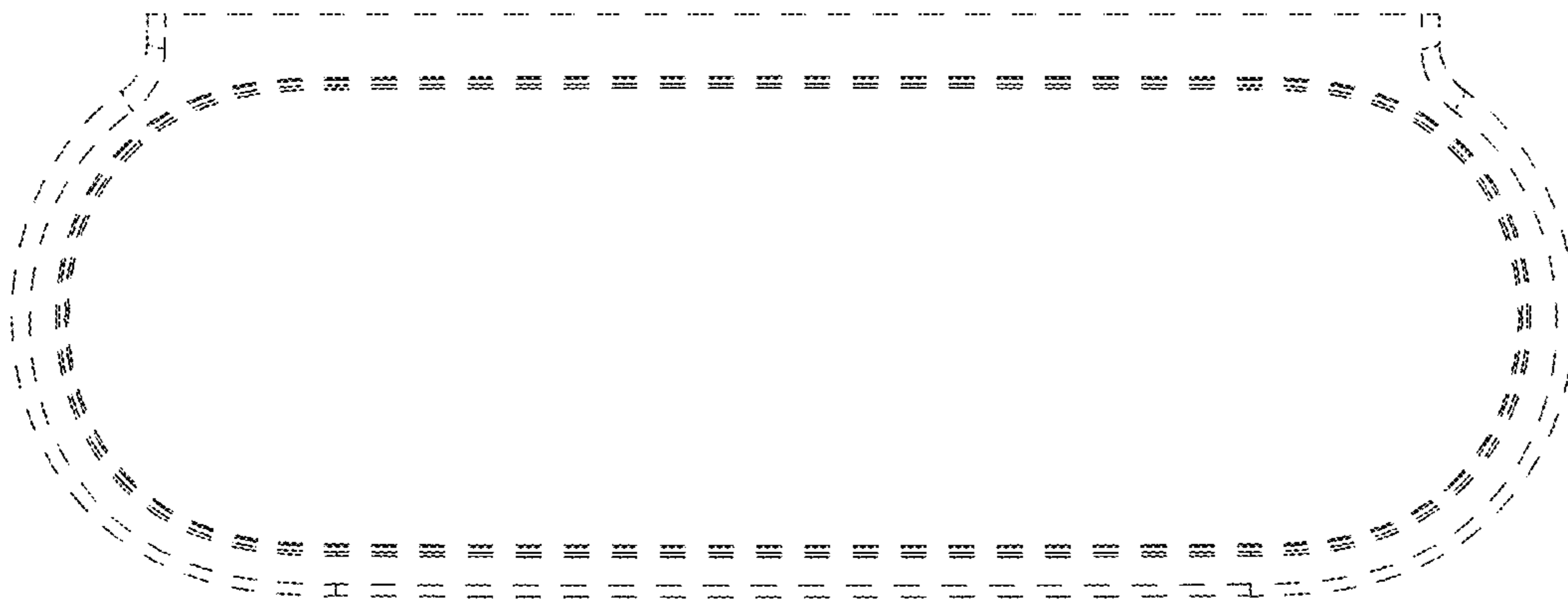

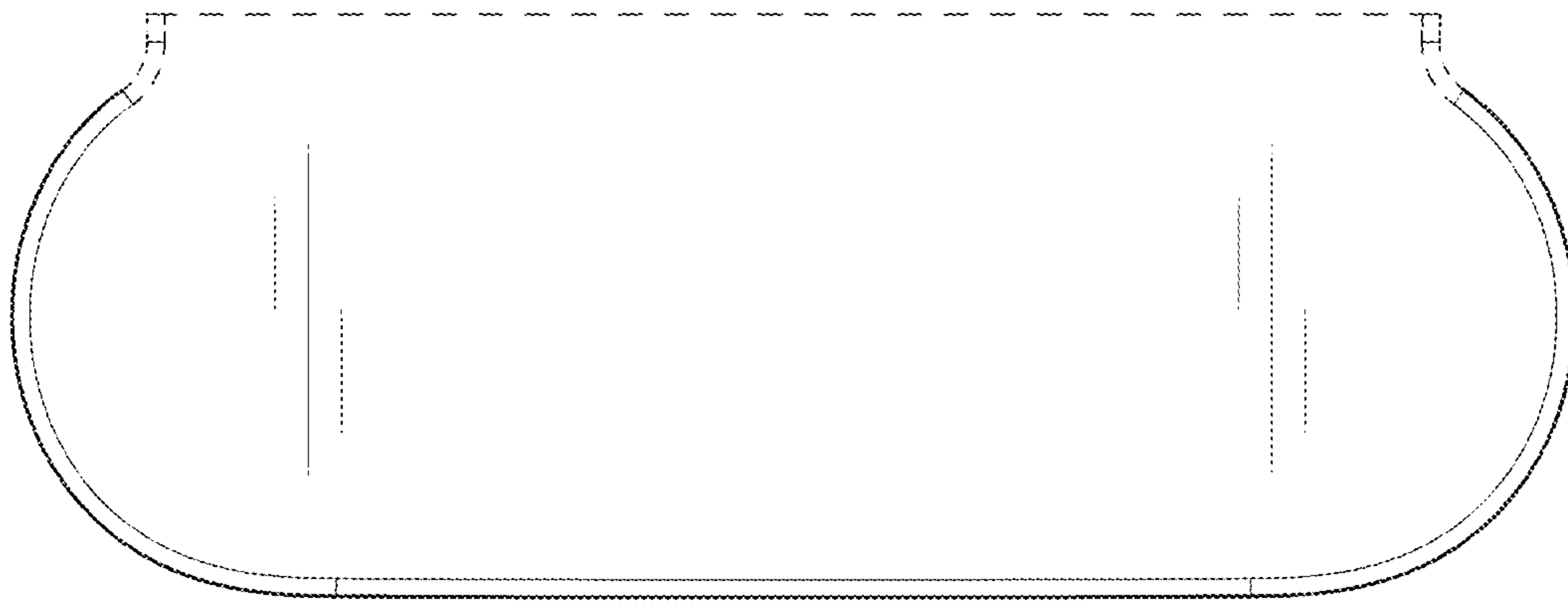

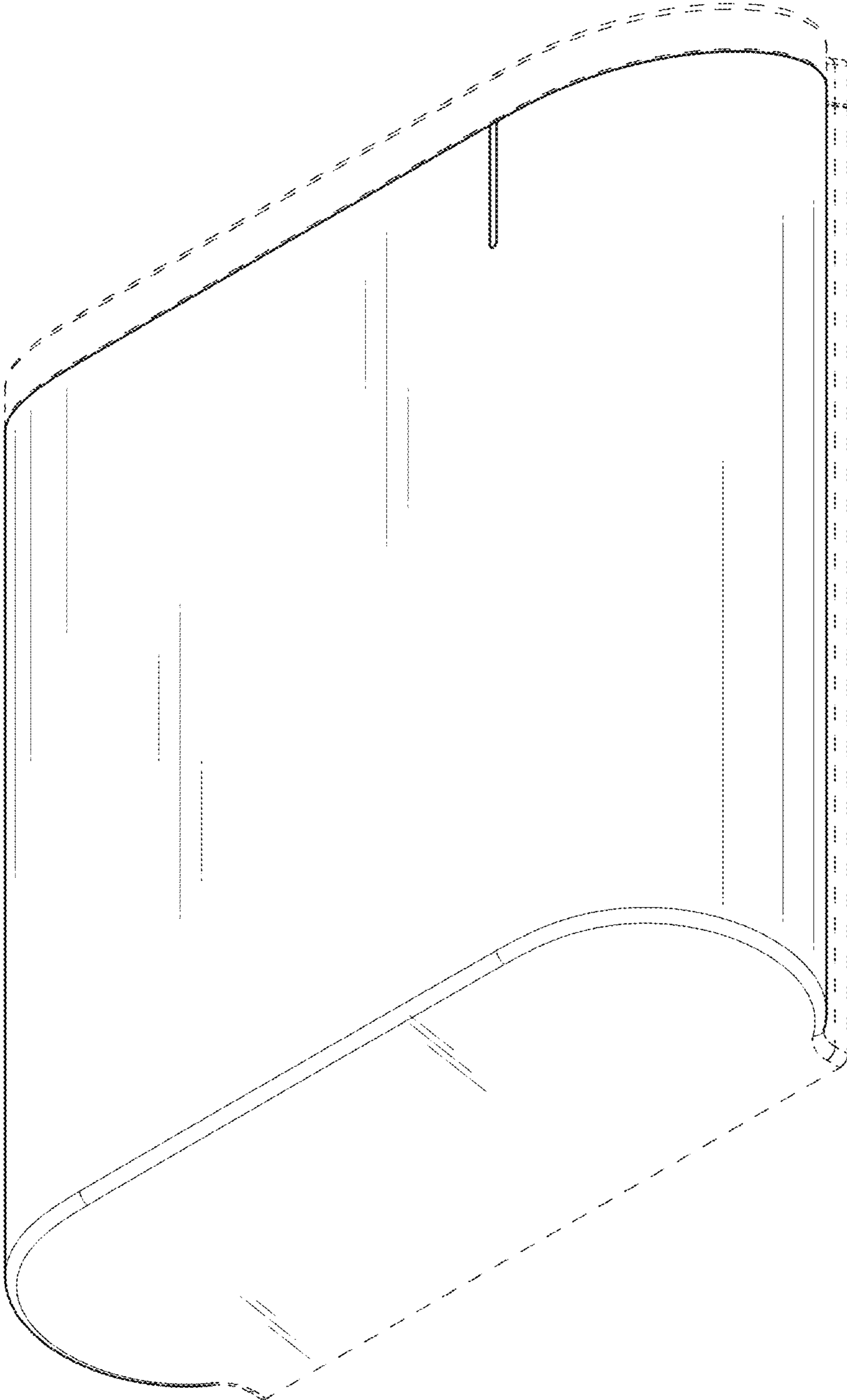

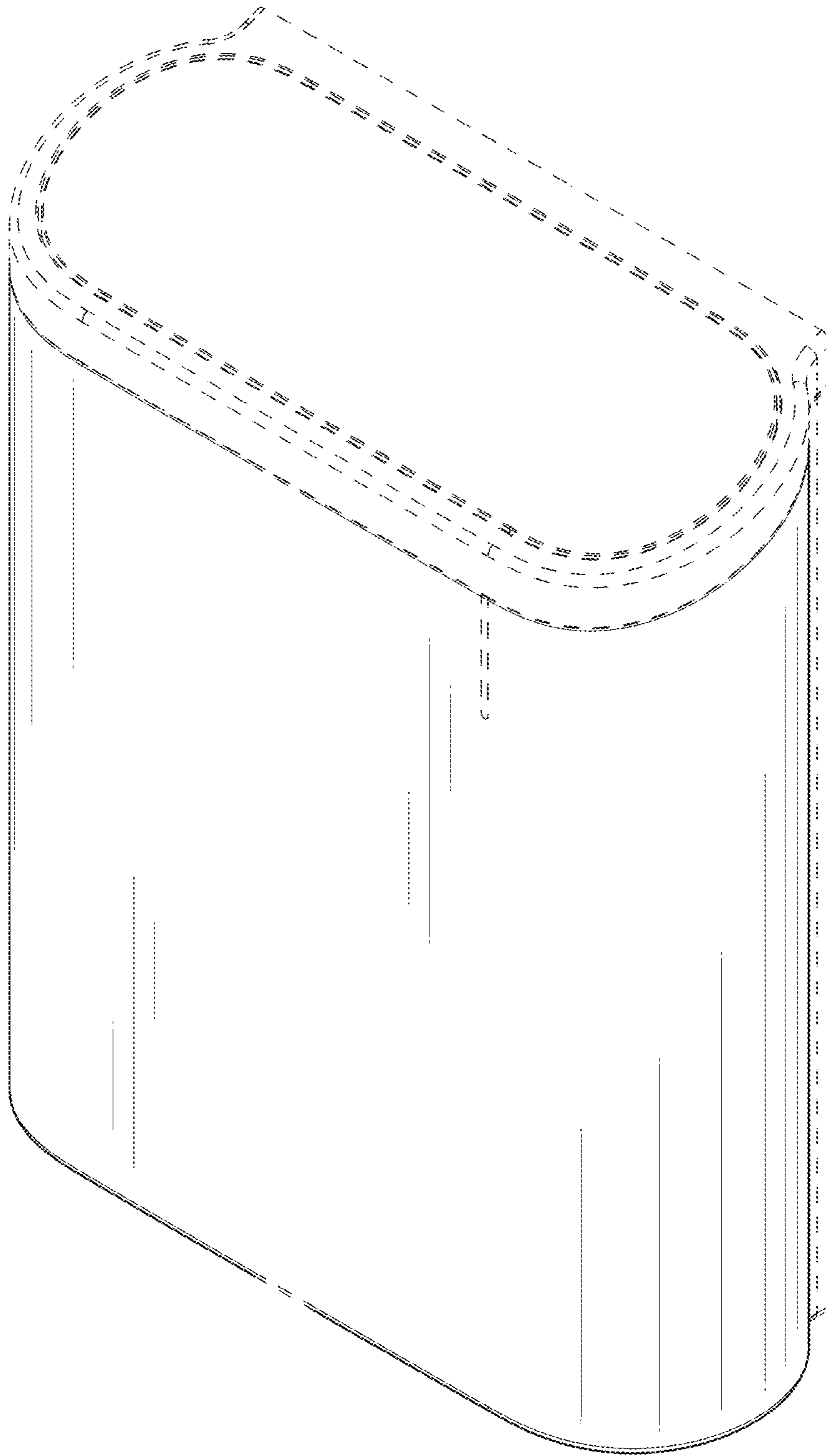

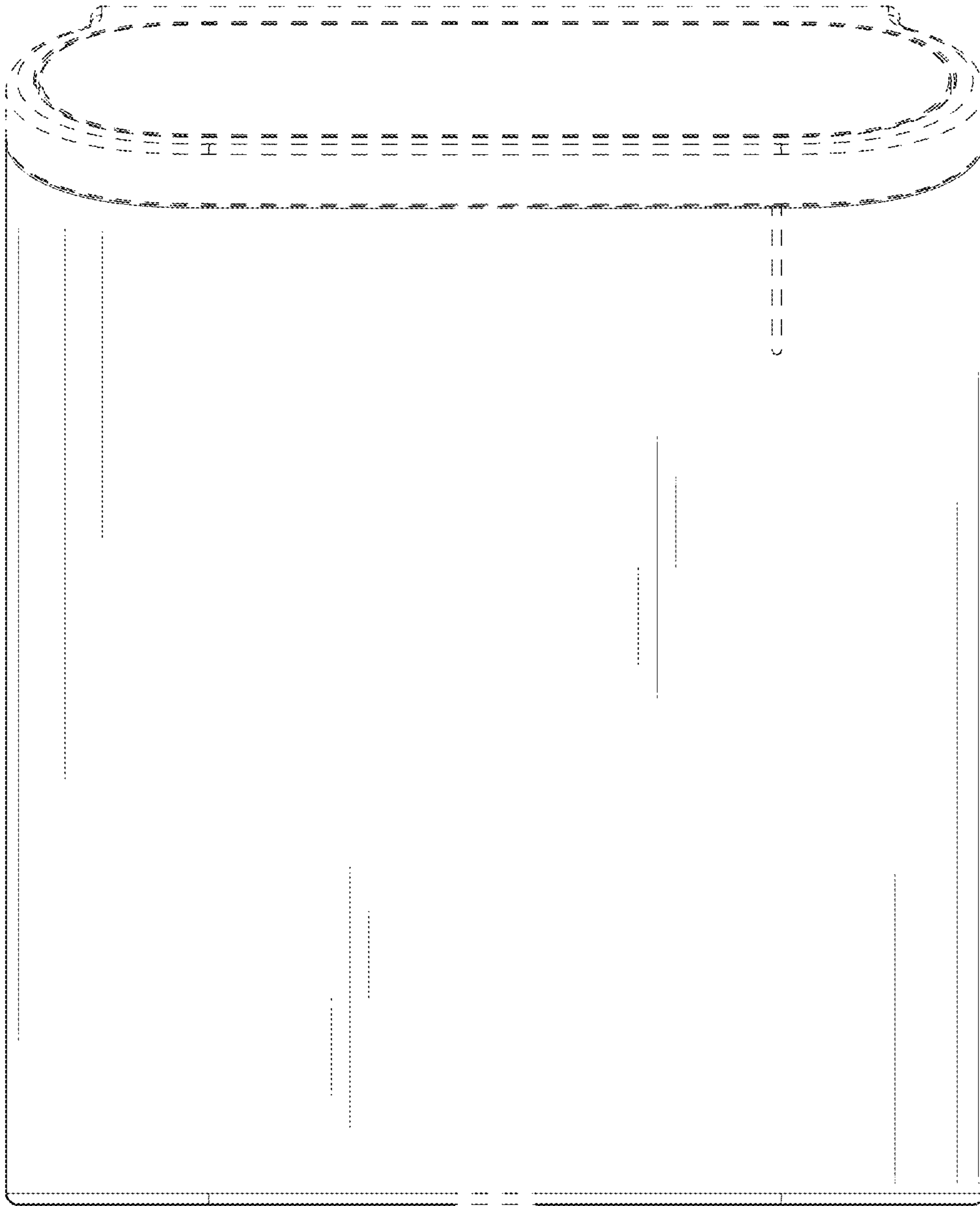

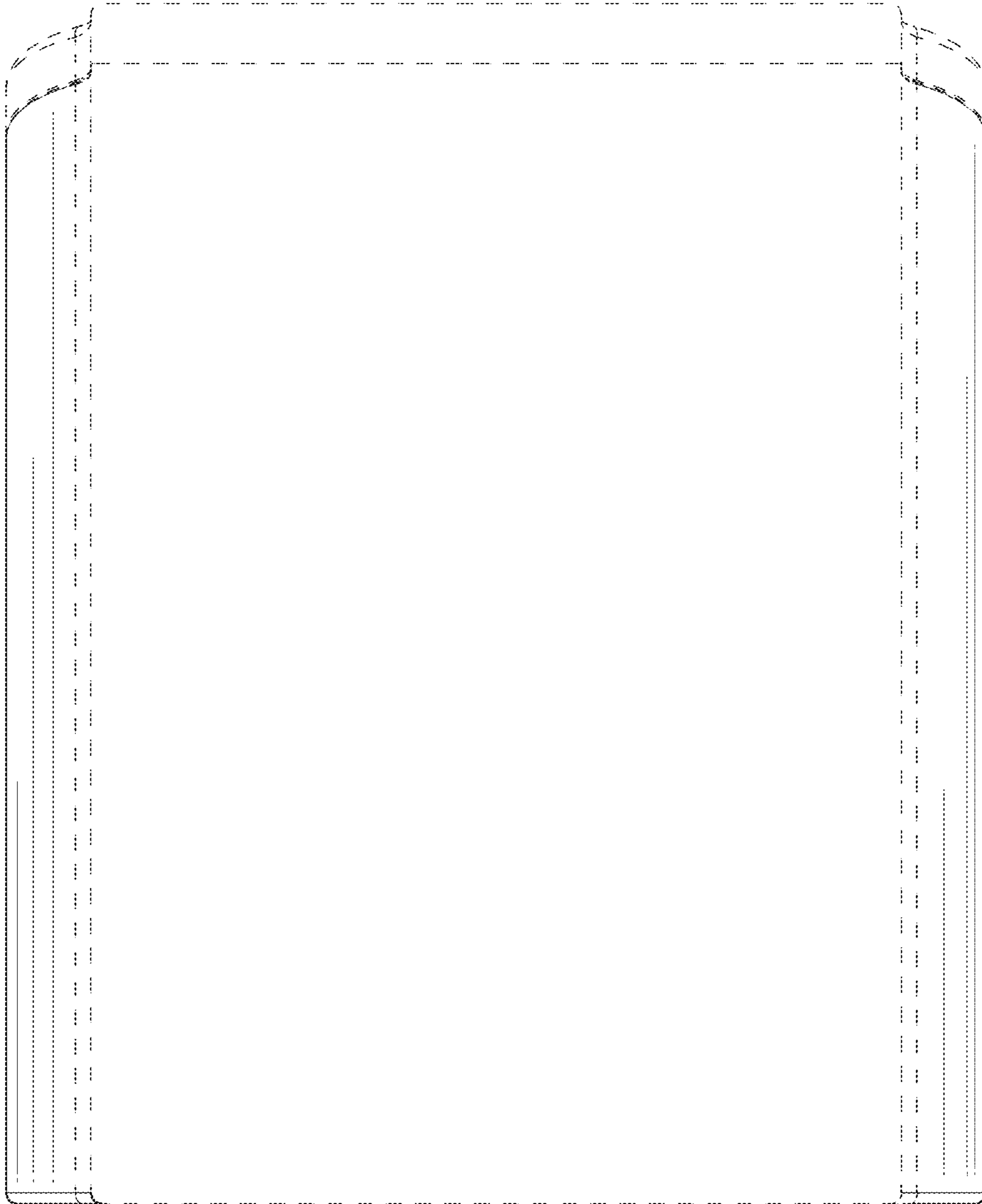

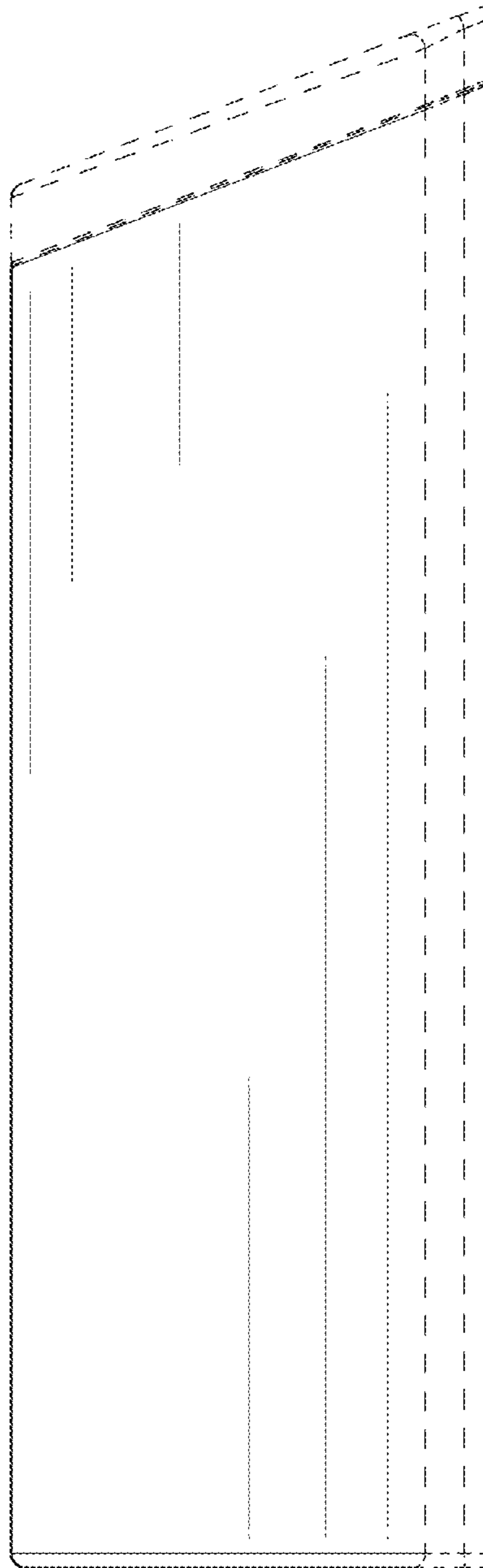

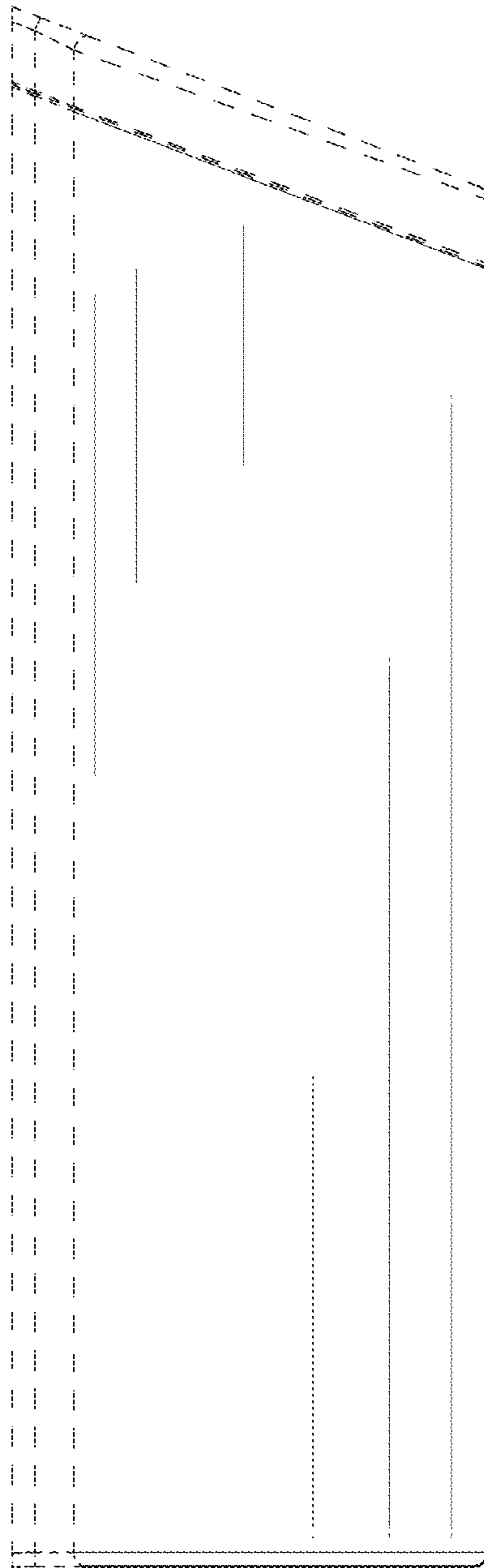

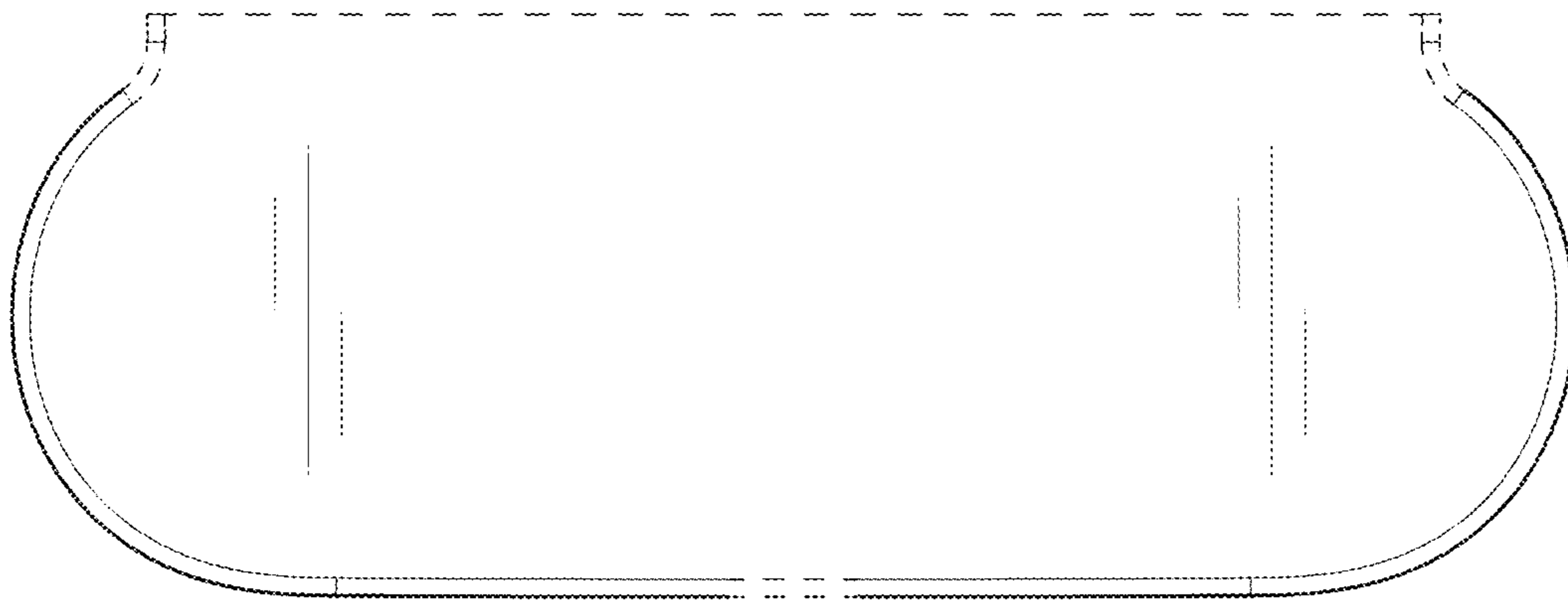

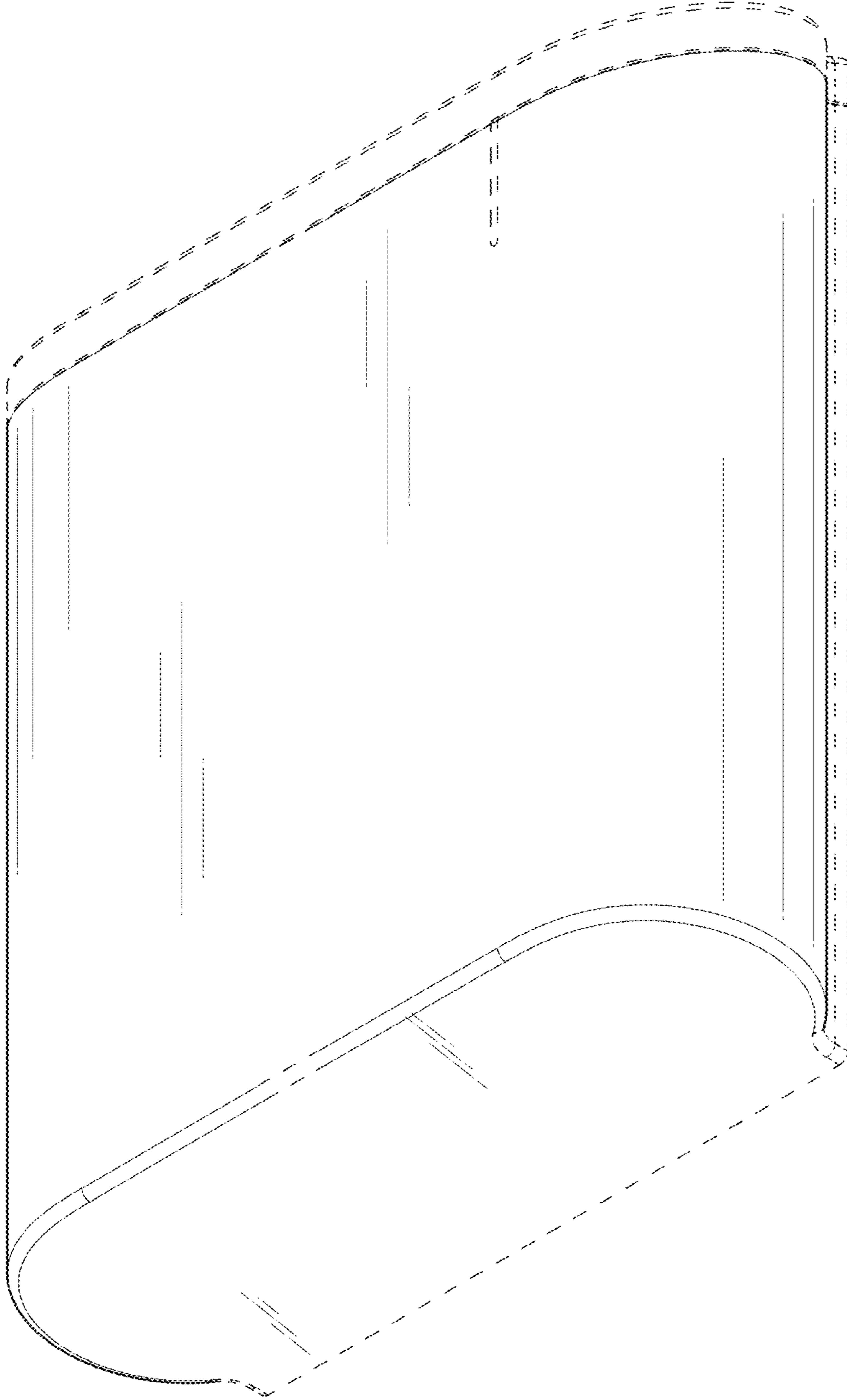
