**DESCRIPTION**

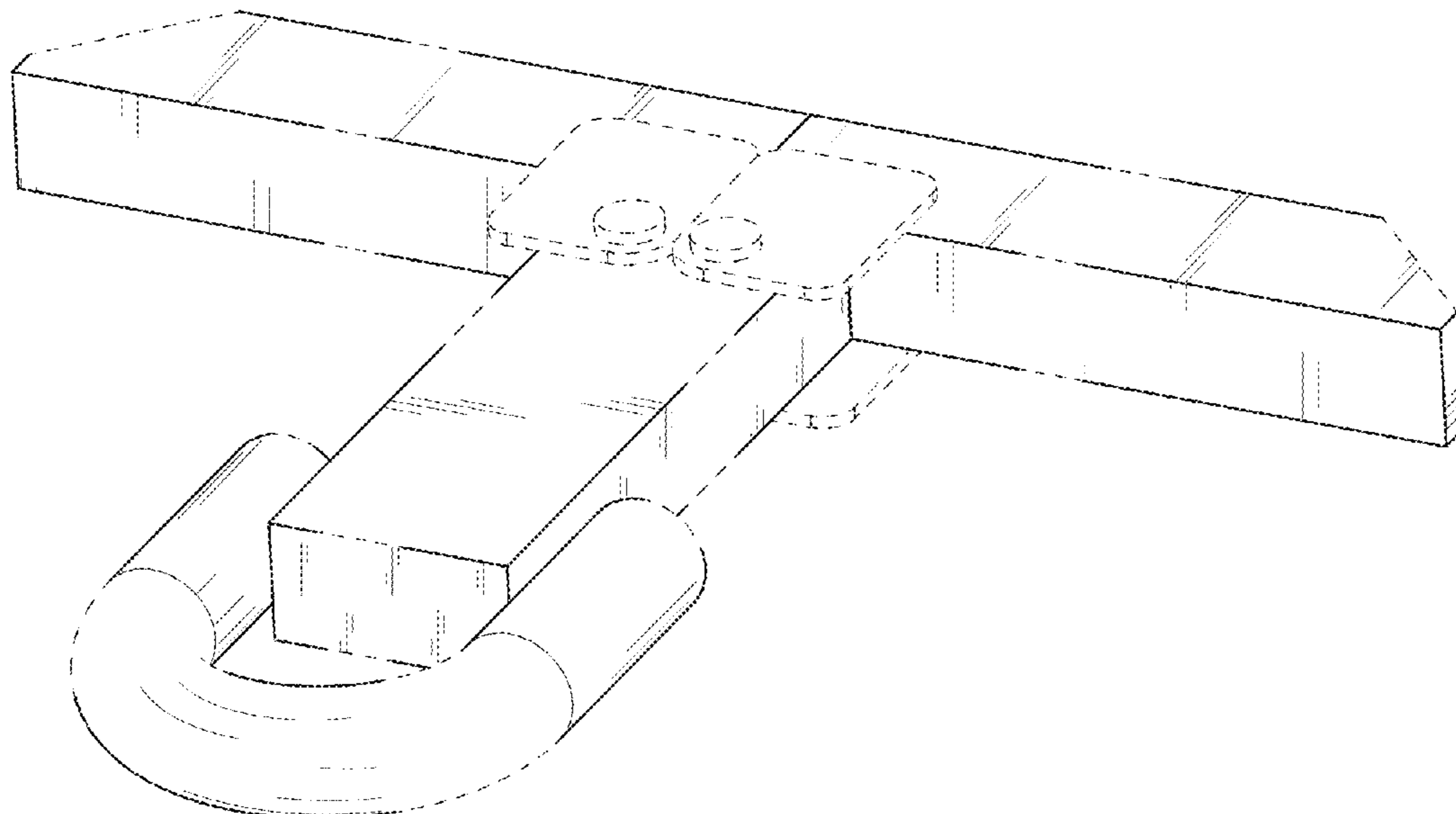
FIG. 1 is a perspective view of a rapid recovery grapple hook showing my new design;

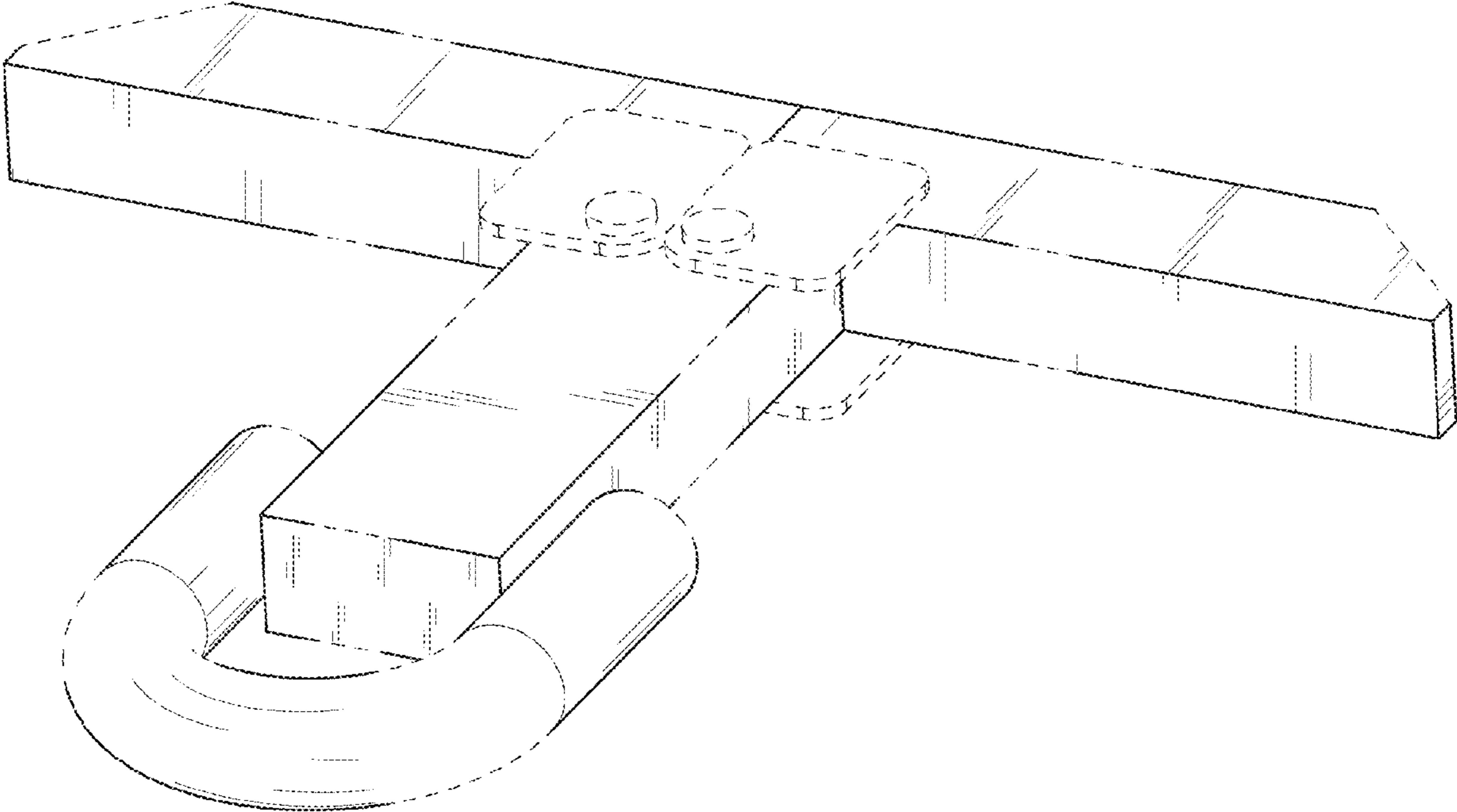

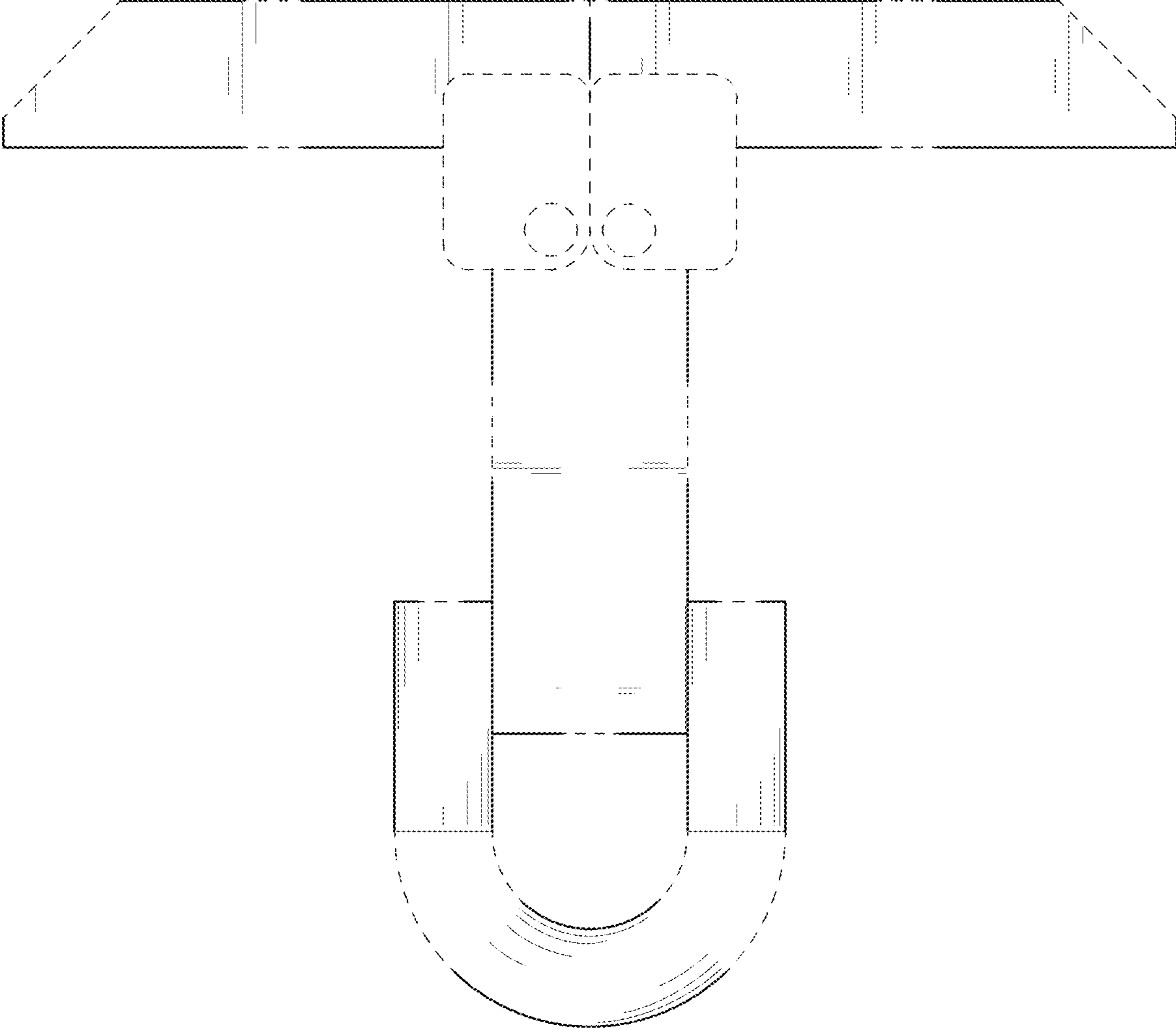

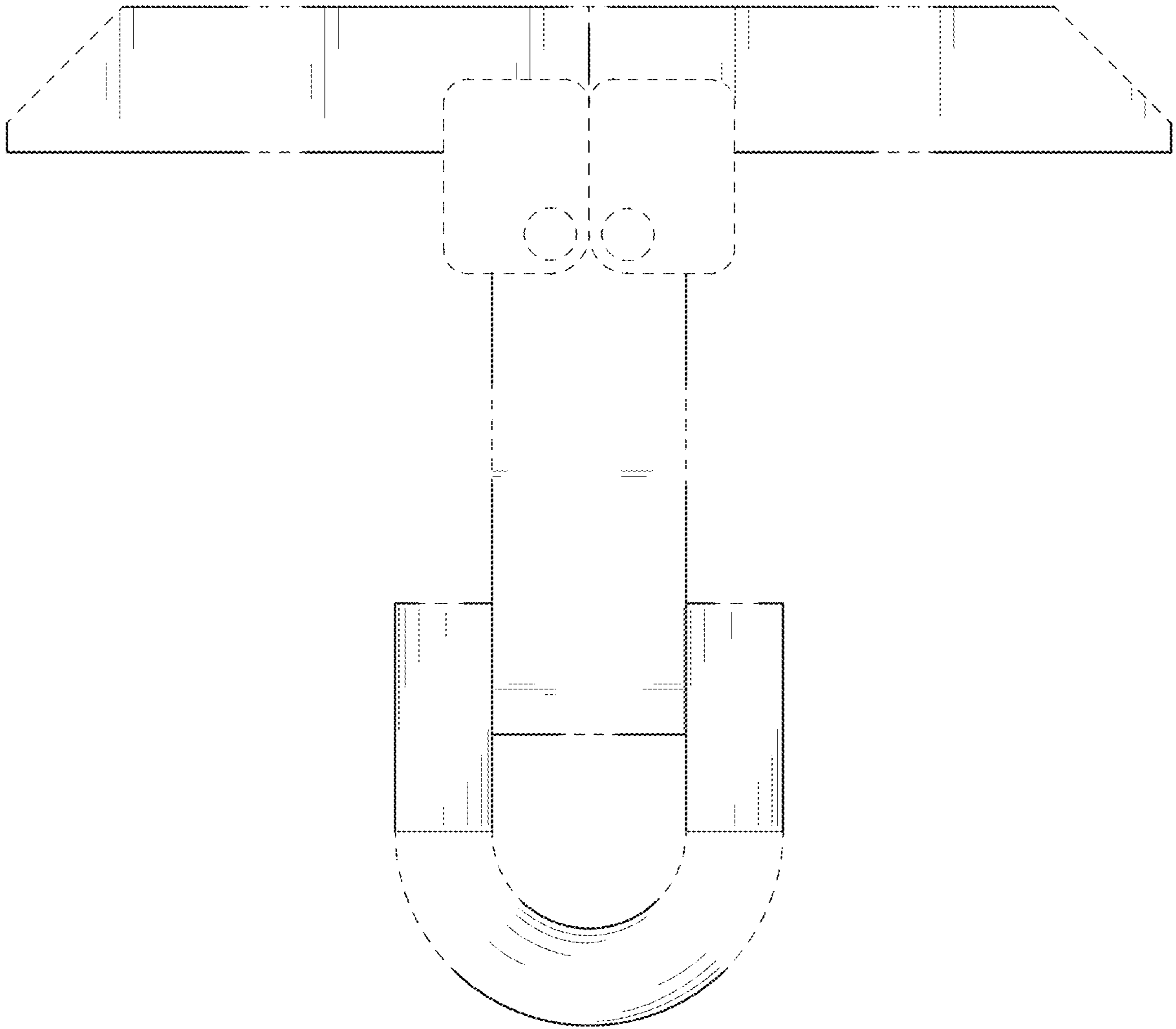

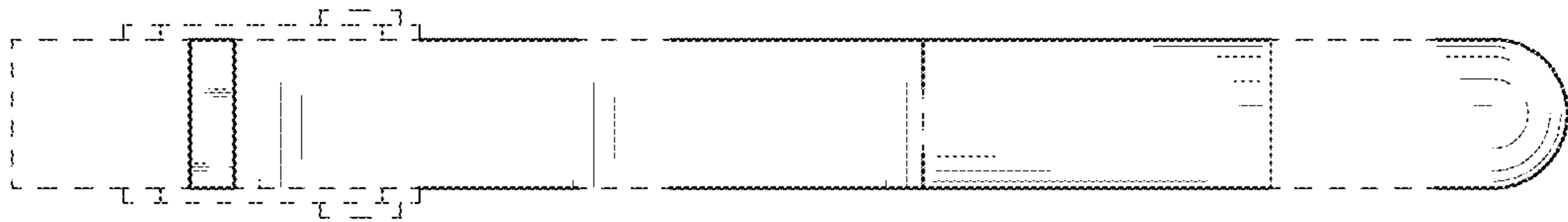

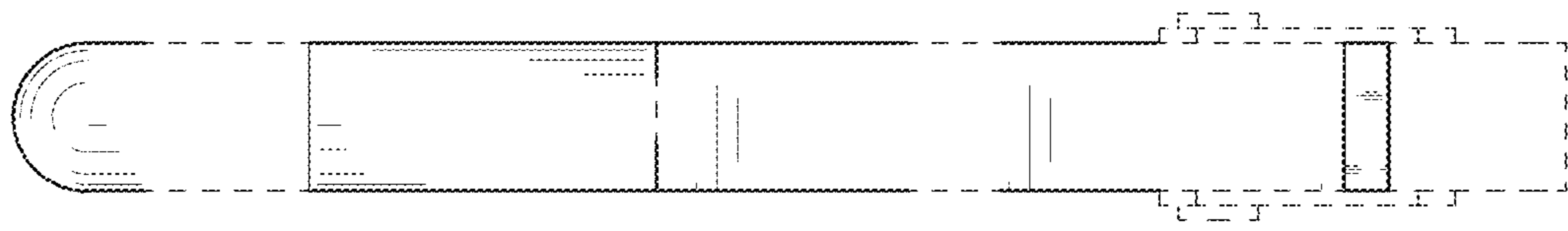

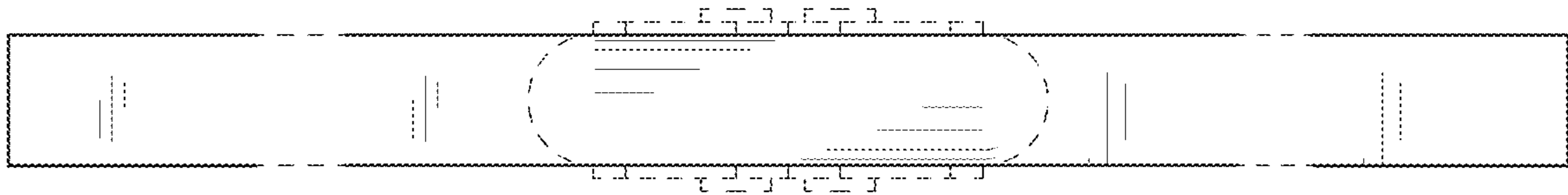

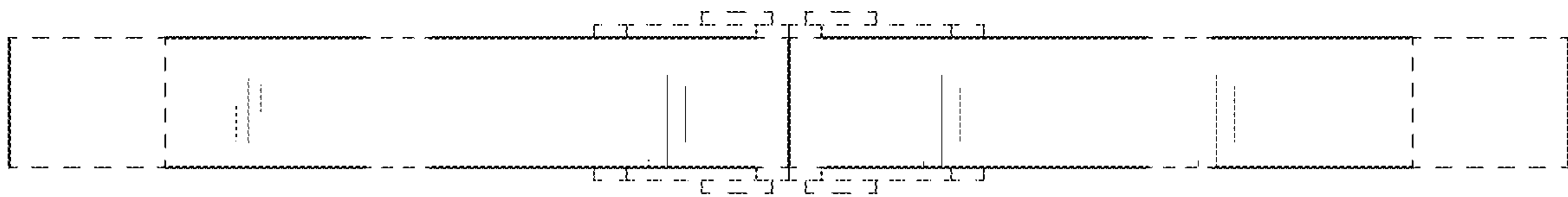
