(57) **CLAIM**

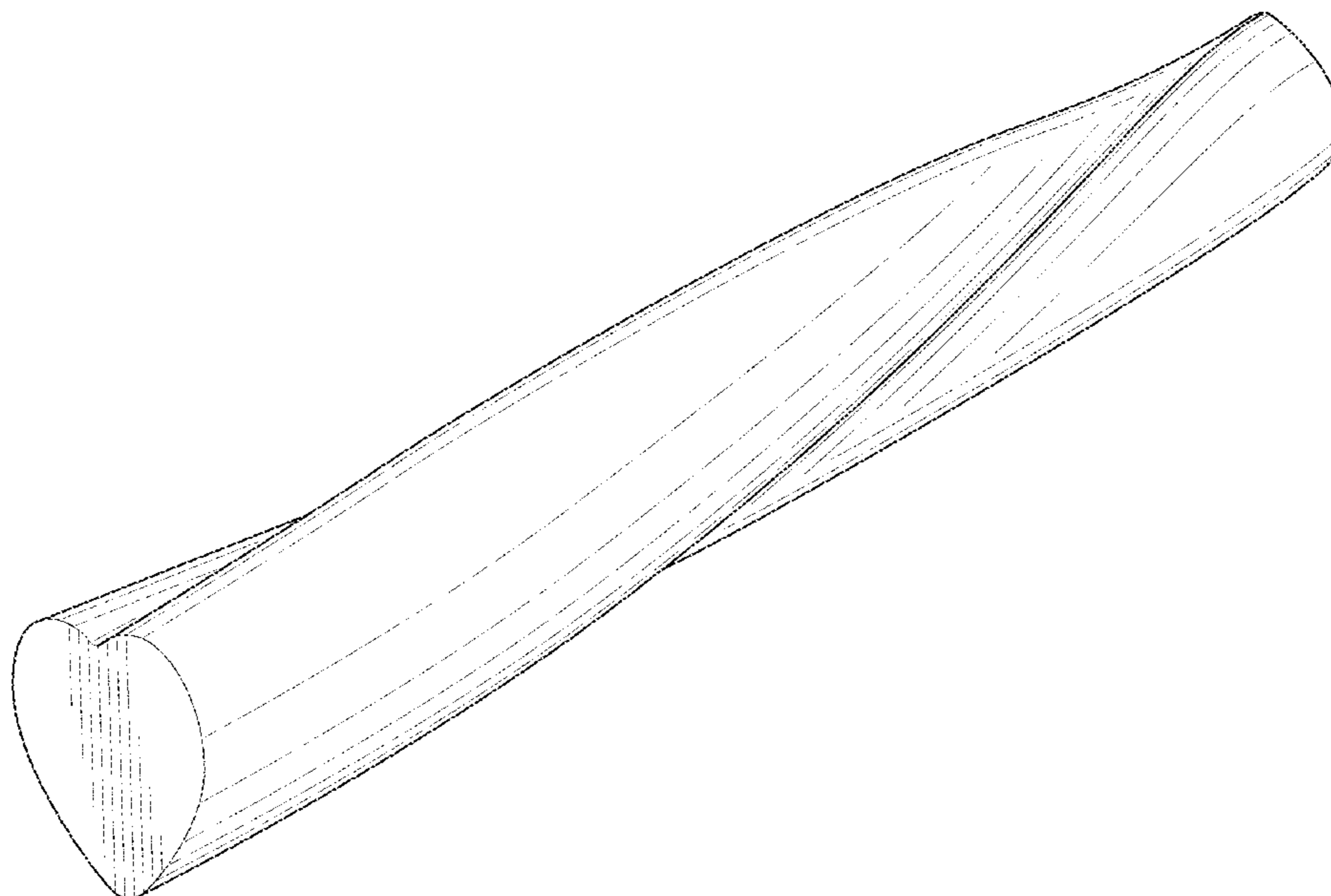
The ornamental design for a twisted pet treat, as shown and described.

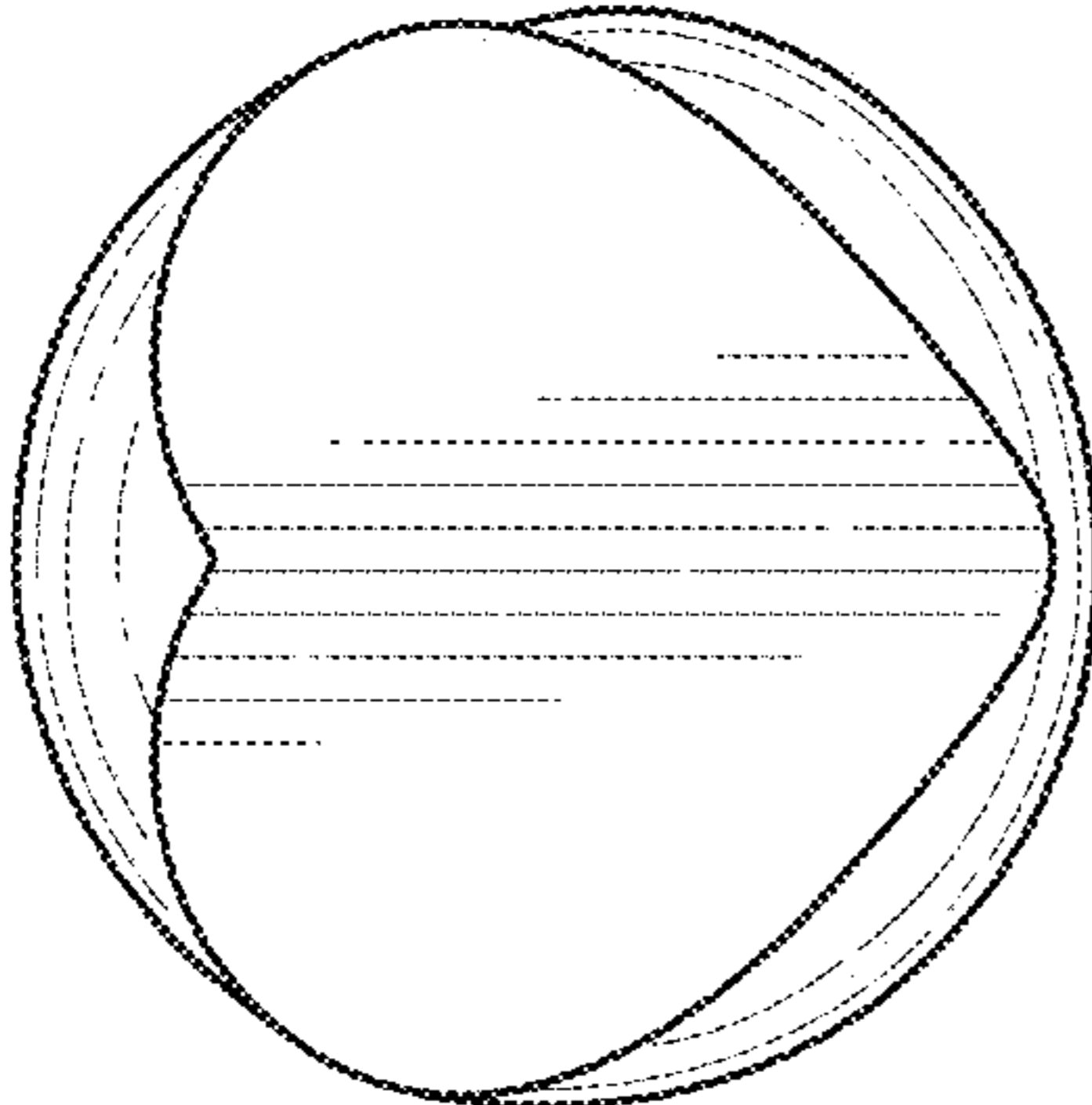

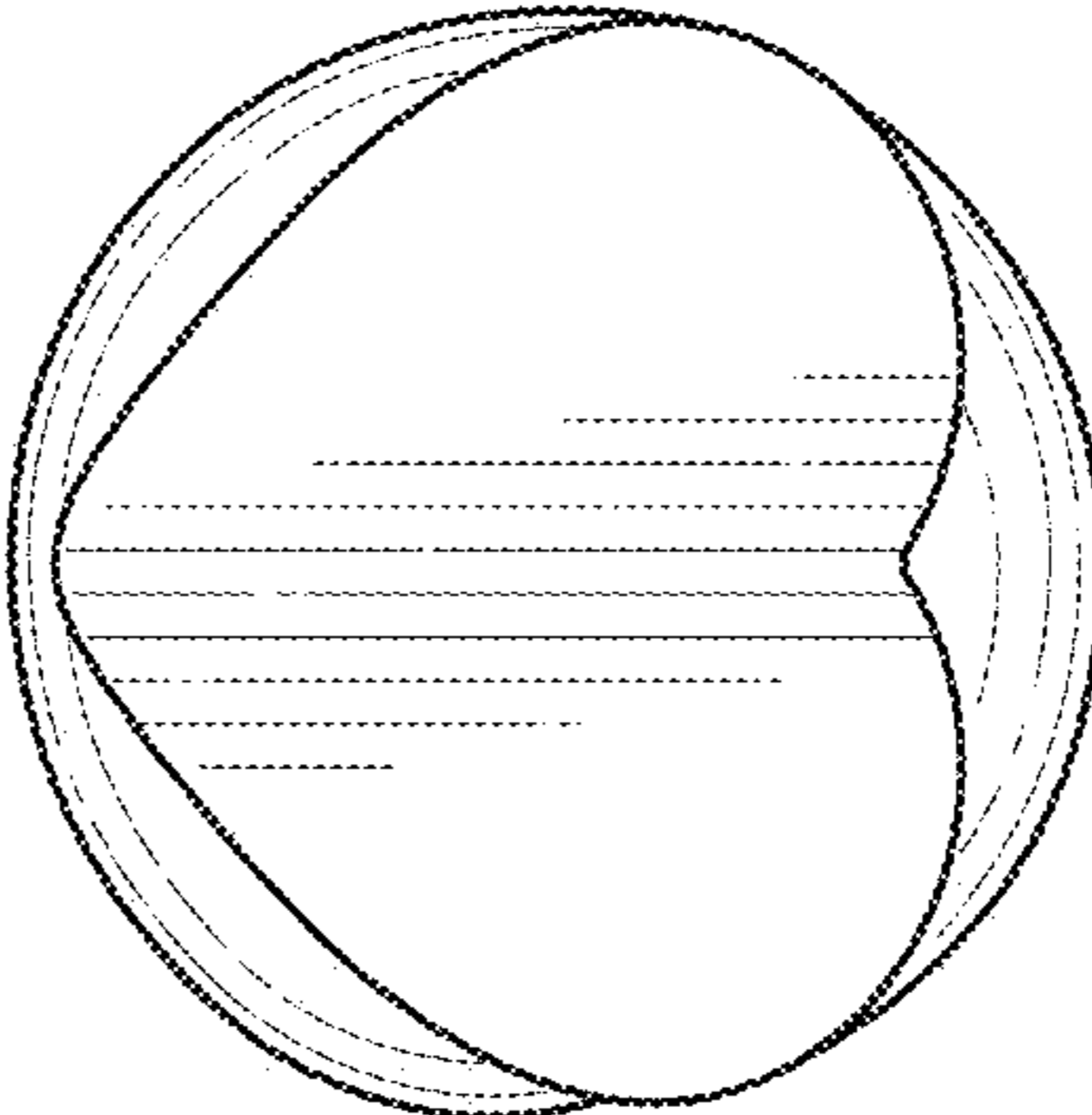

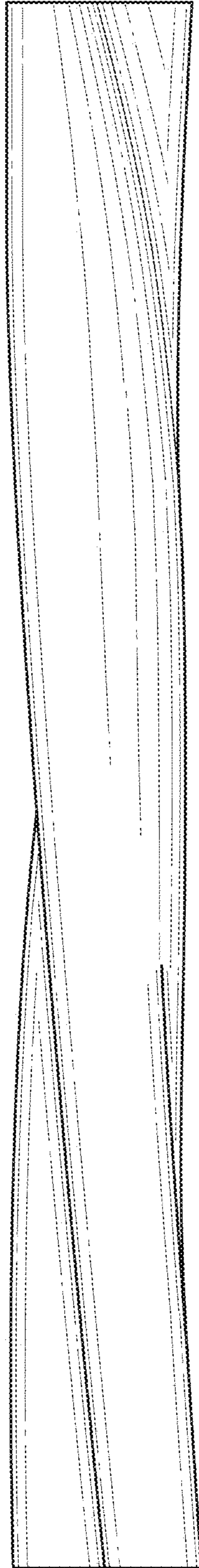

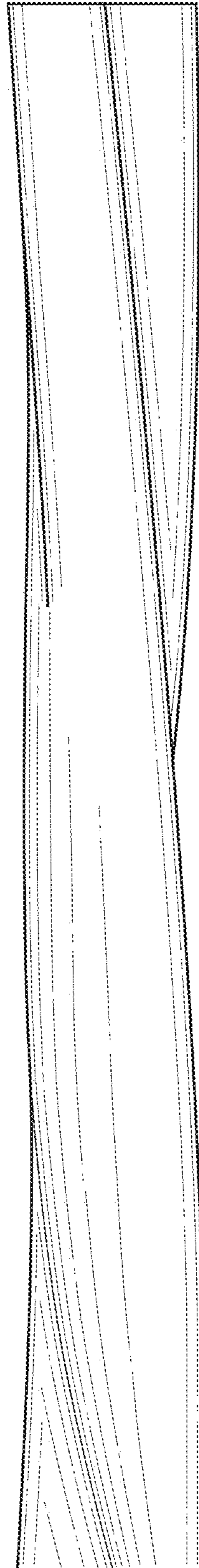

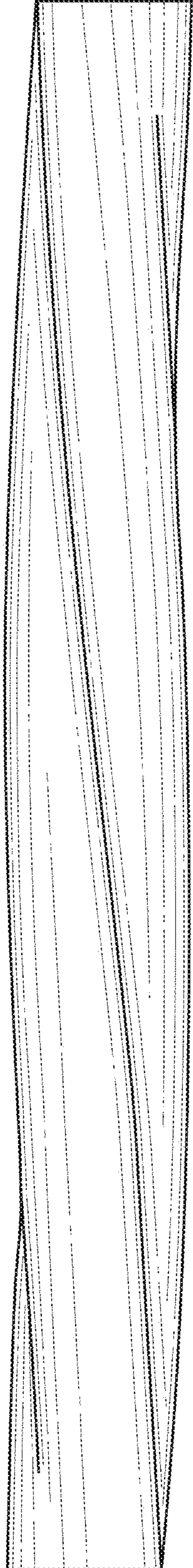

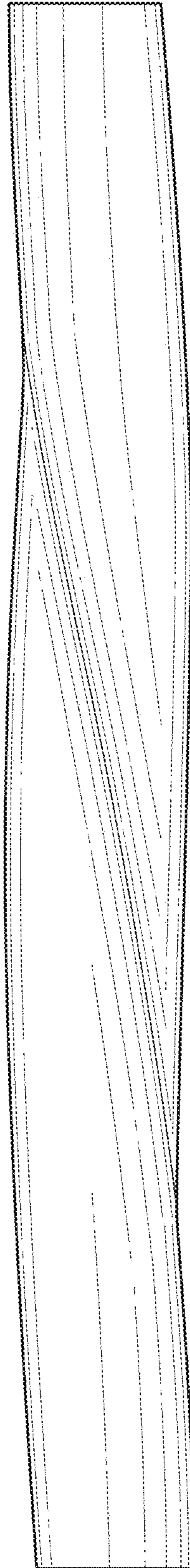

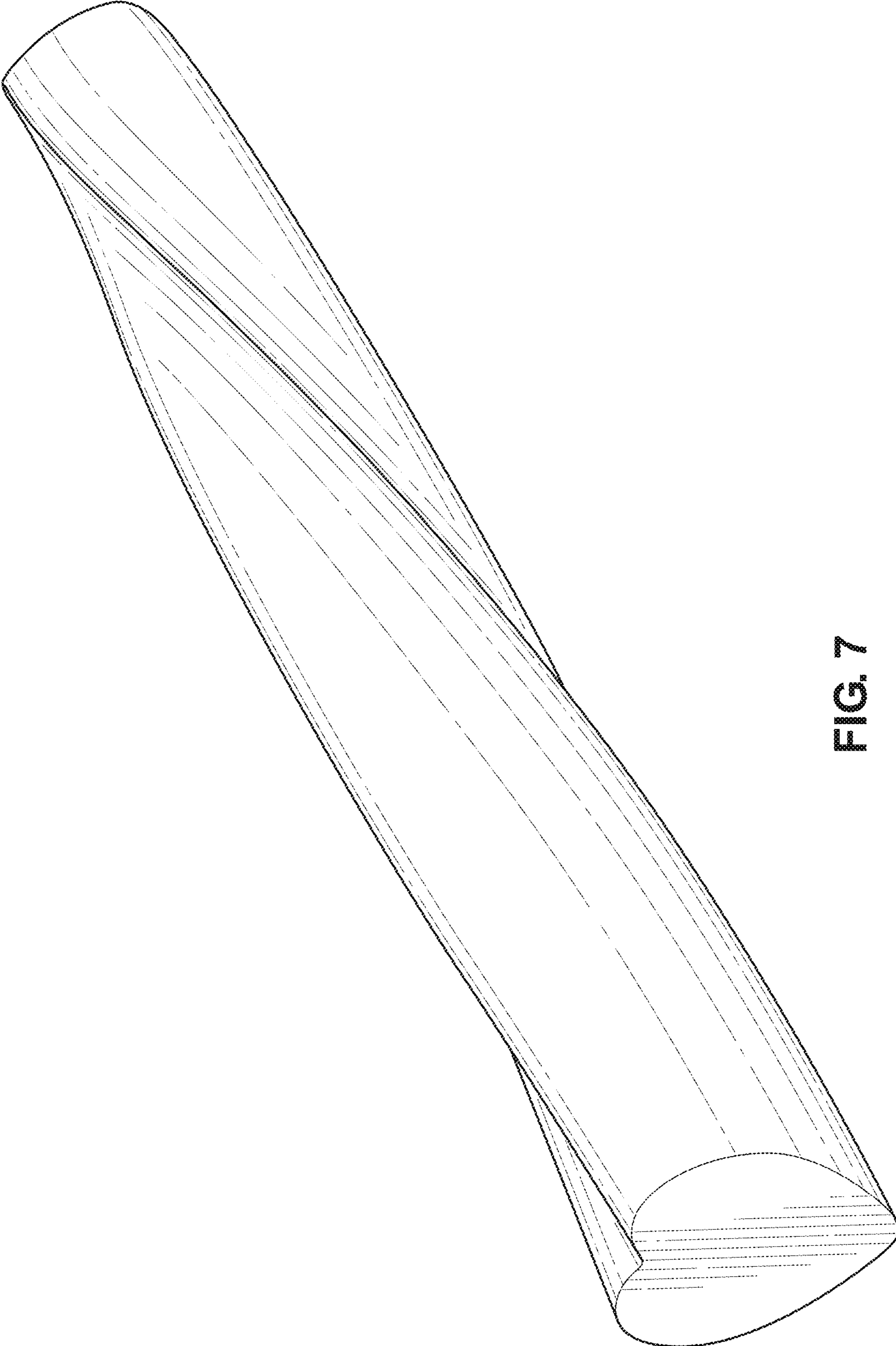

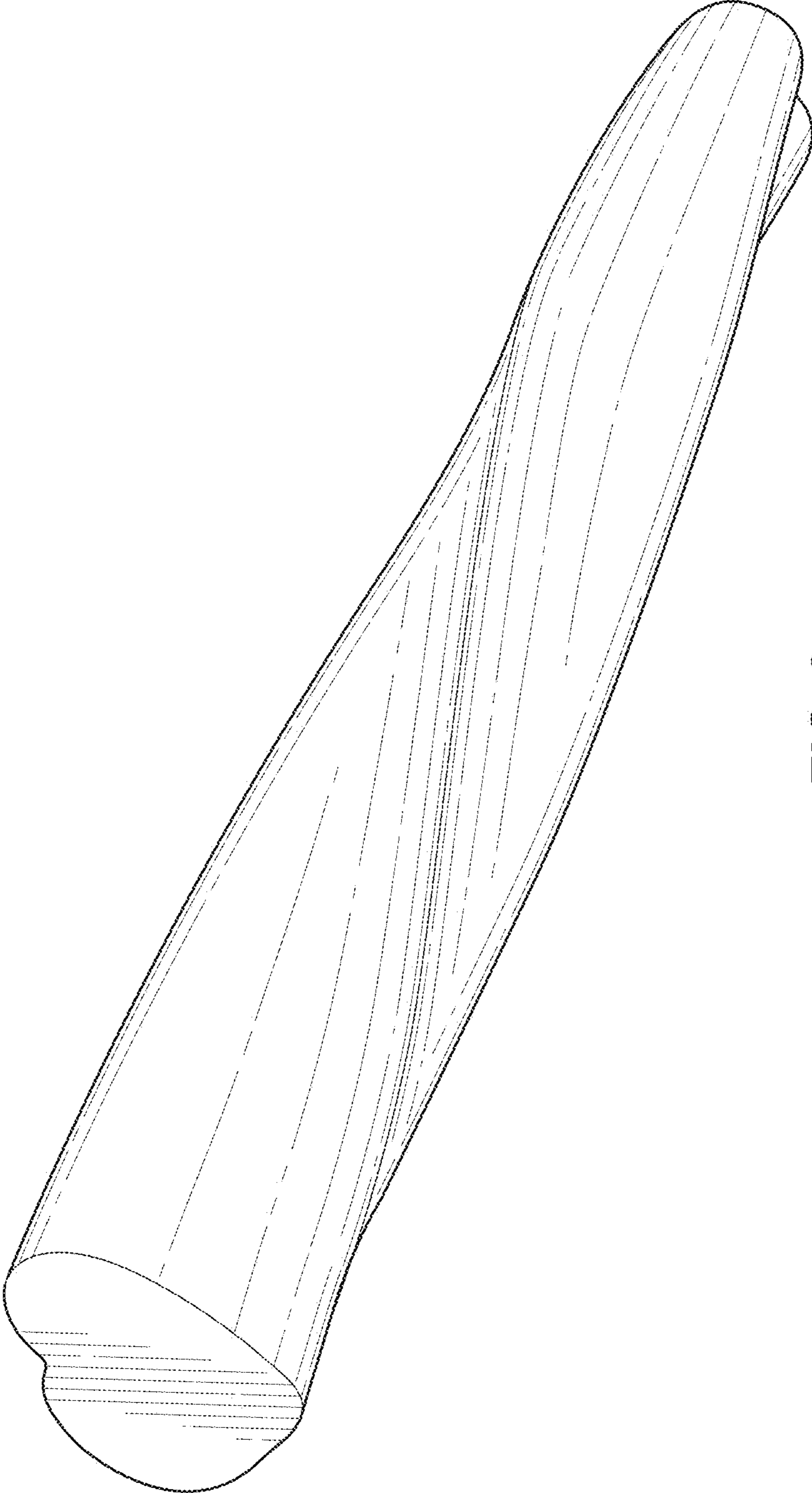
