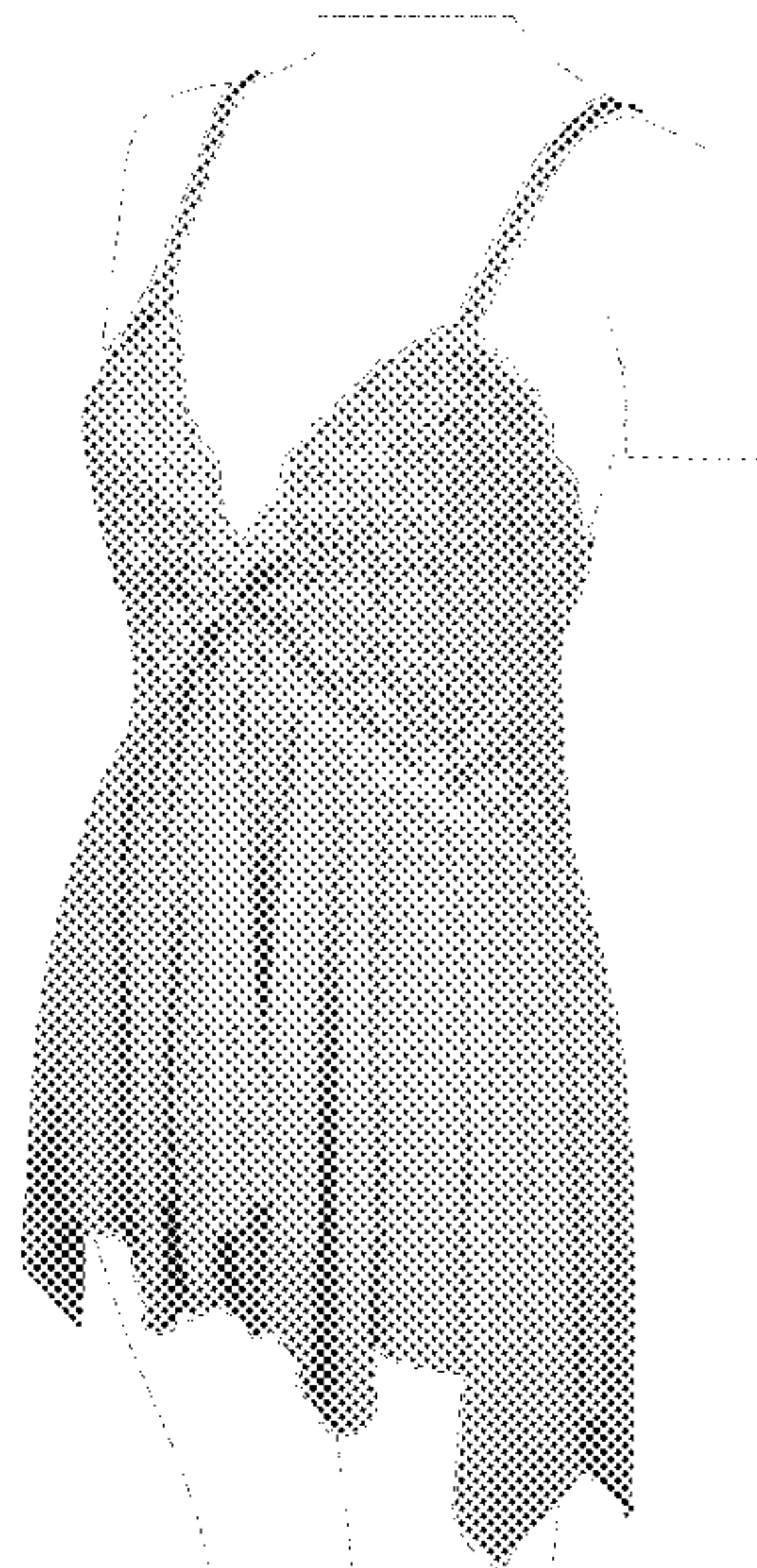
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front, left side, top perspective view of a woman sexy nightdress showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right side elevational view thereof; and, FIG. 5 is a left side elevational view thereof.
