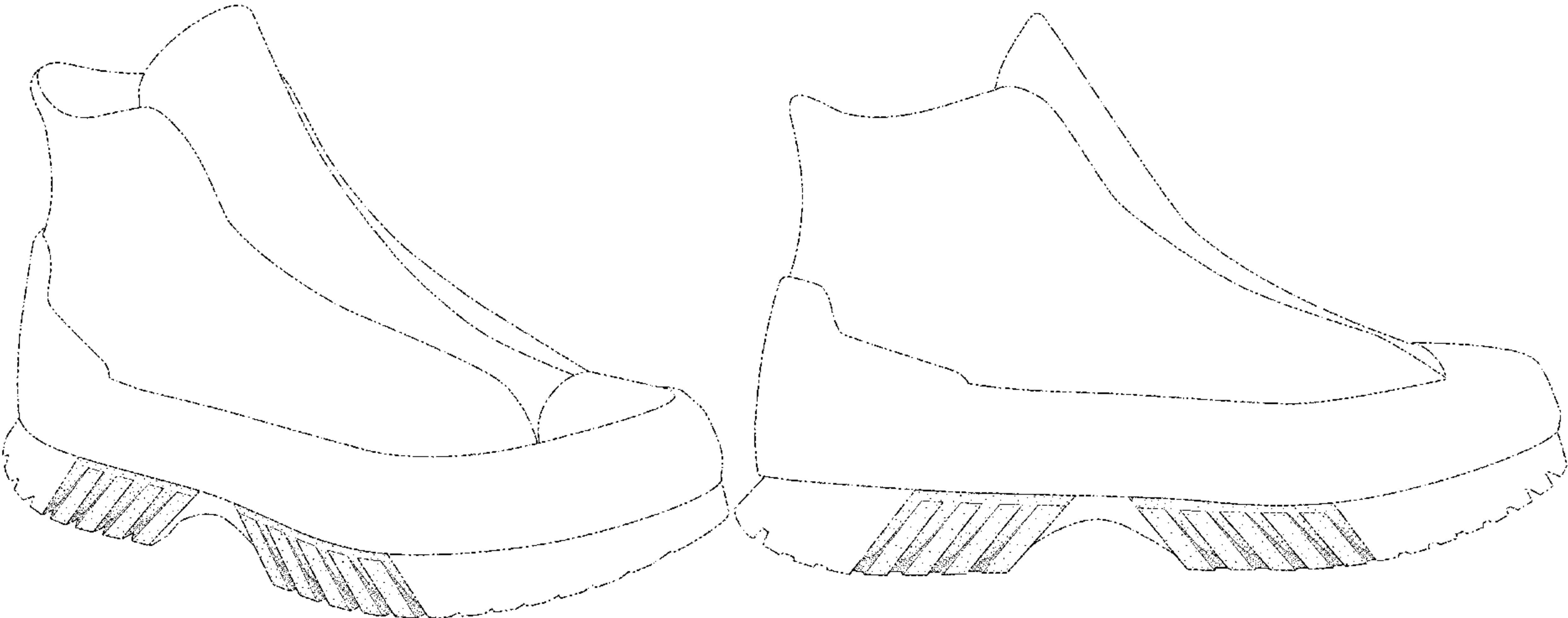
(57) CLAIM

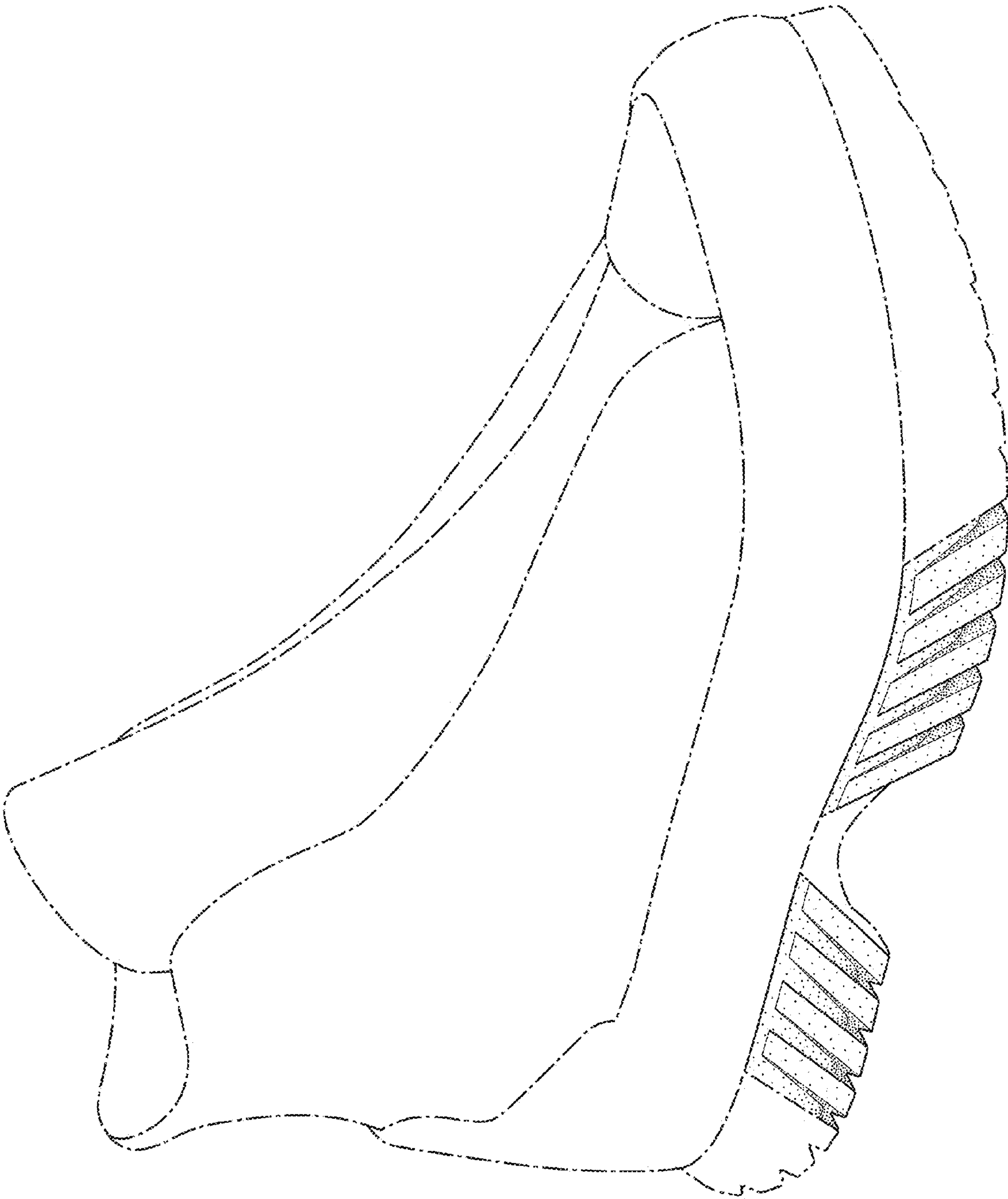

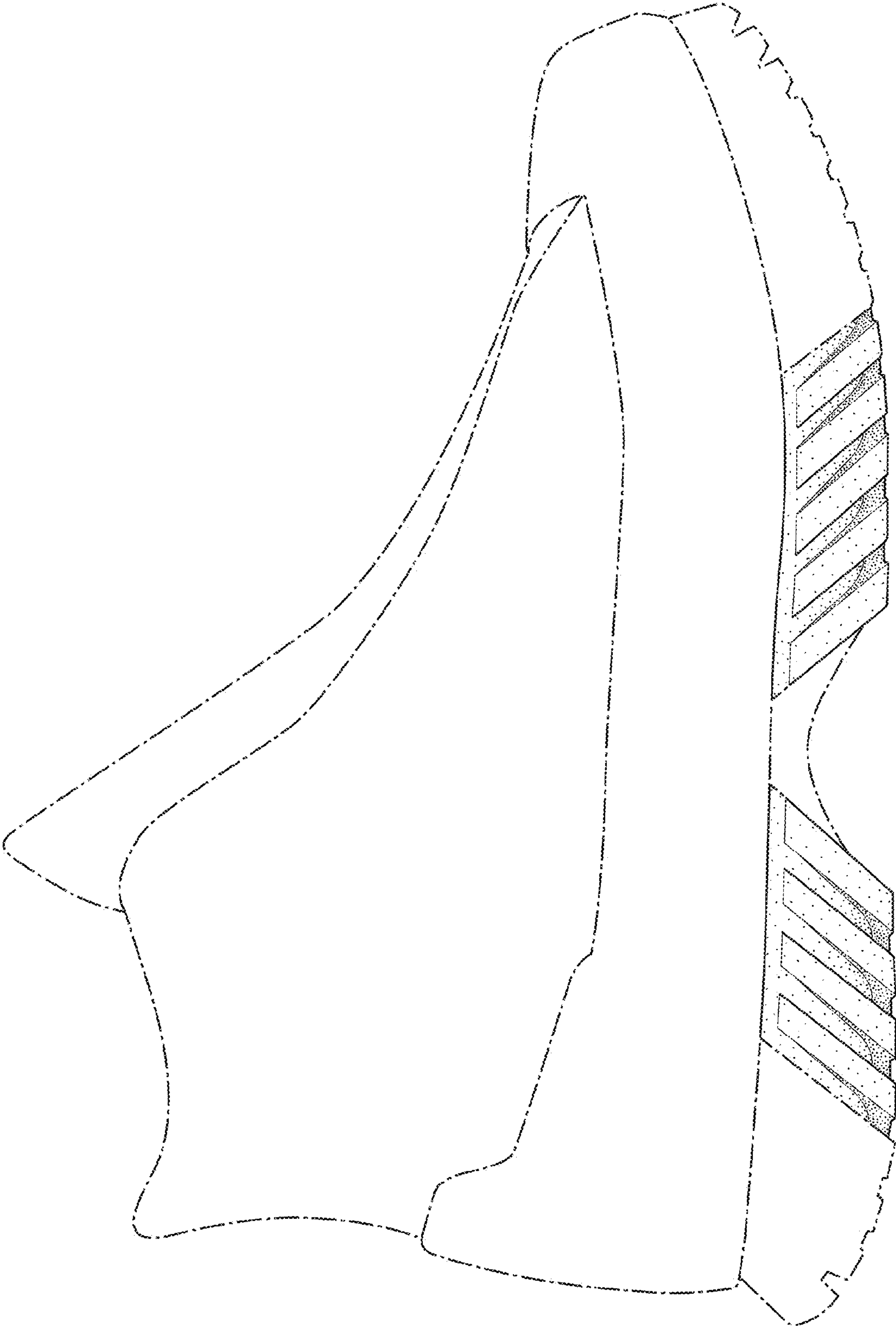
