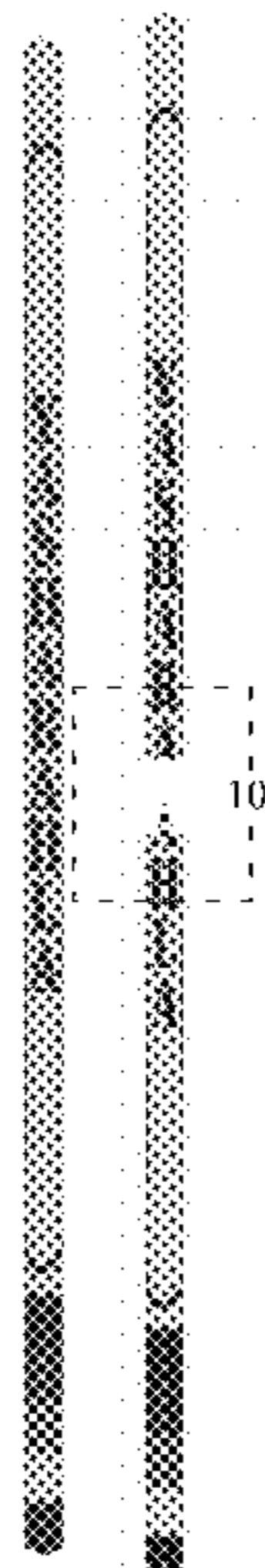
FIG. 1 is a top front perspective view of a modular staff showing my new design;

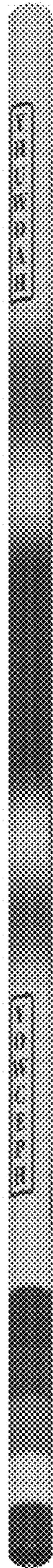

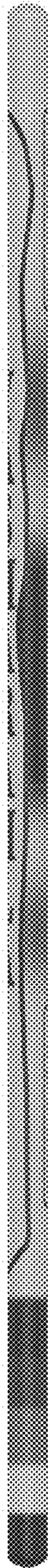

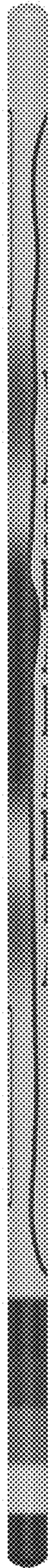

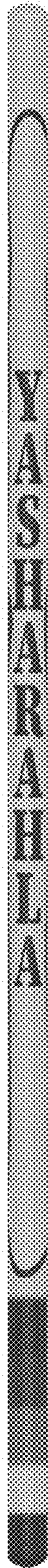

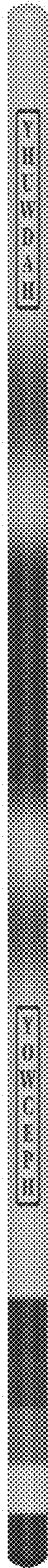

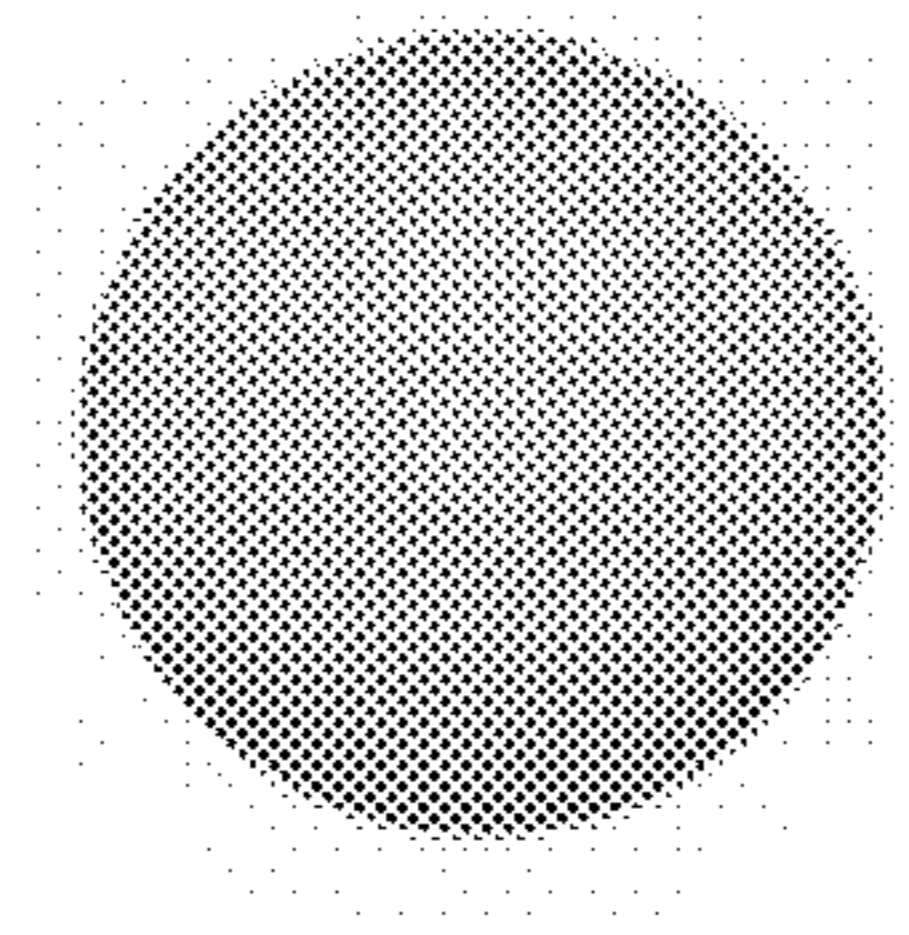

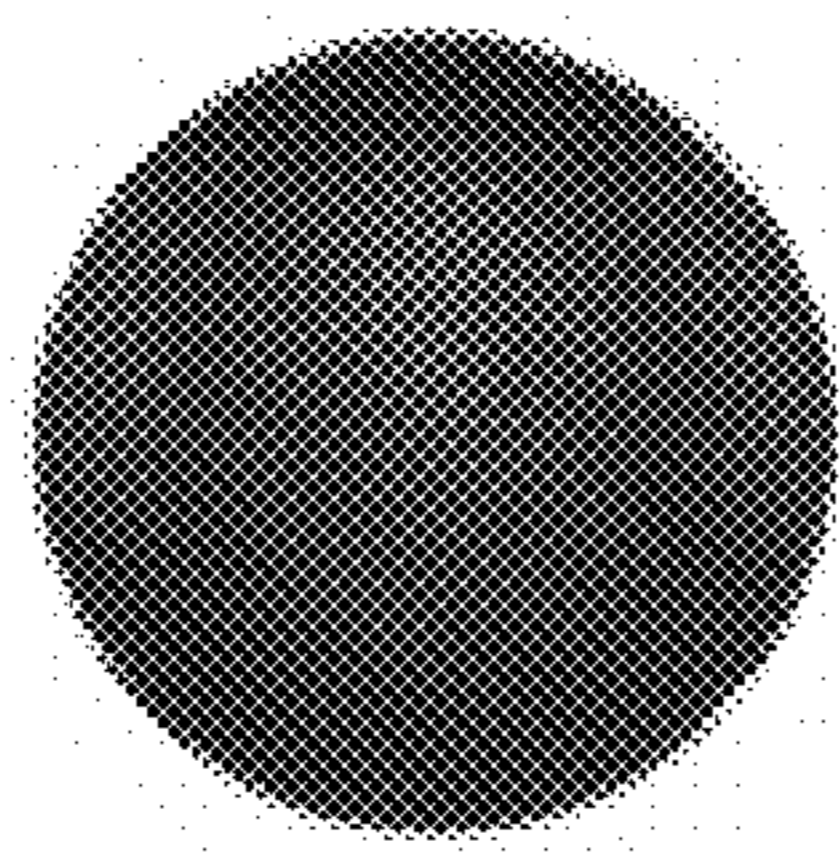

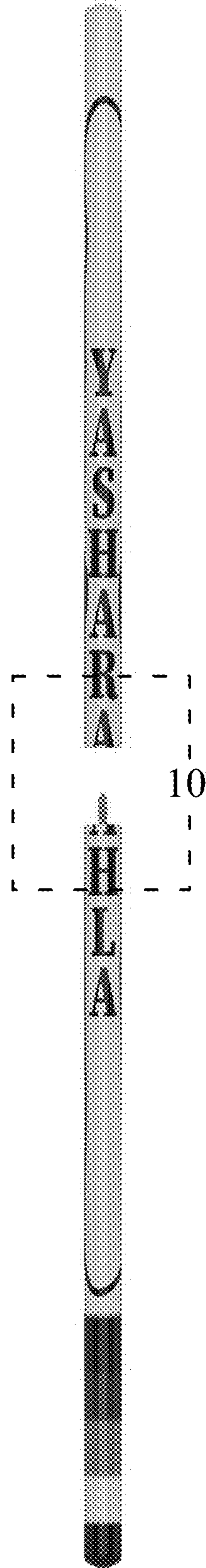
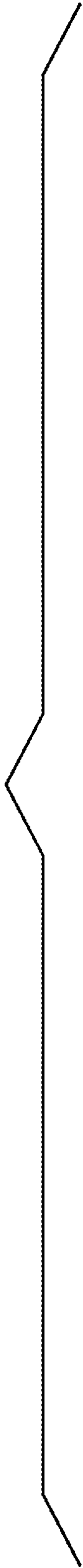

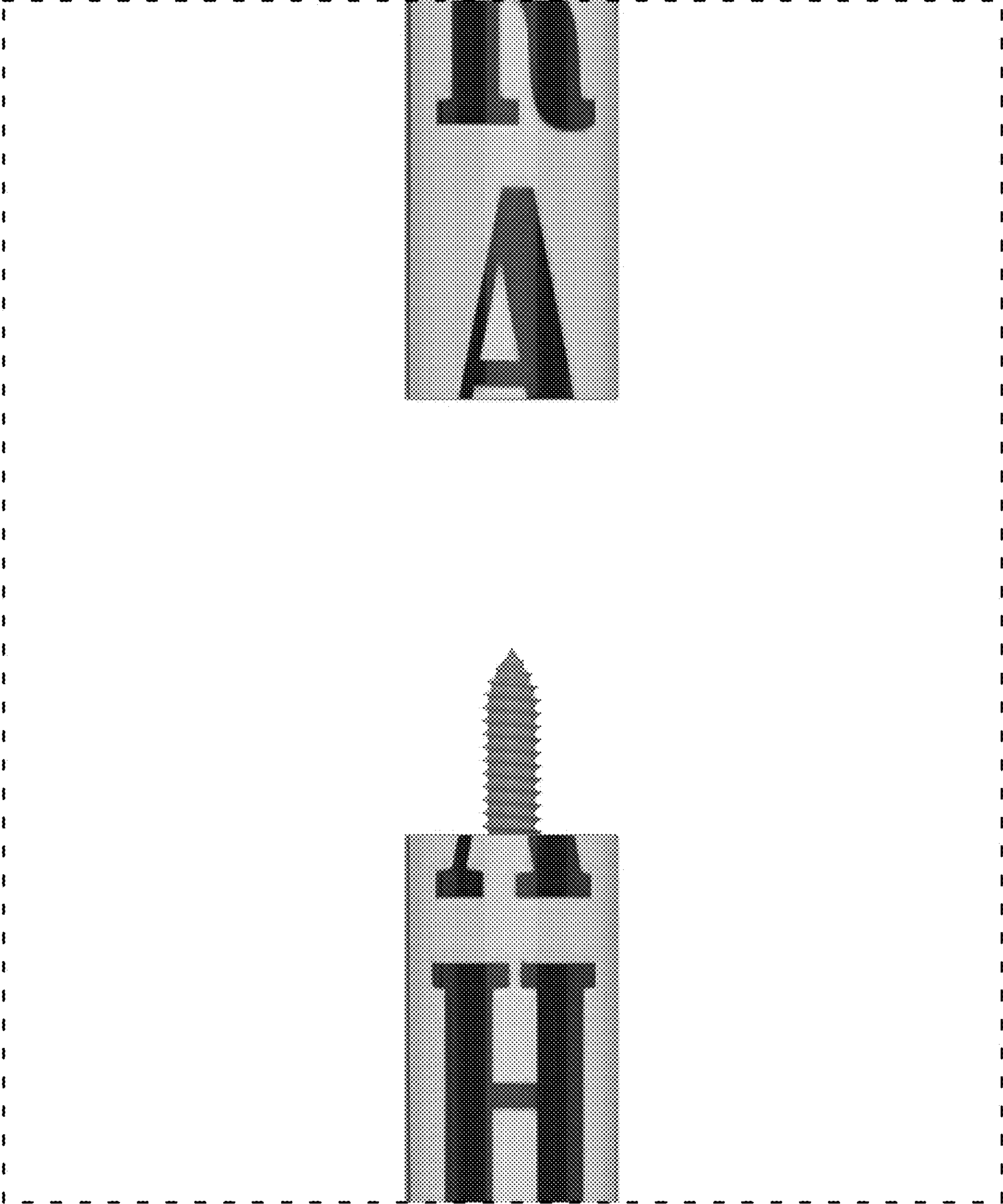
