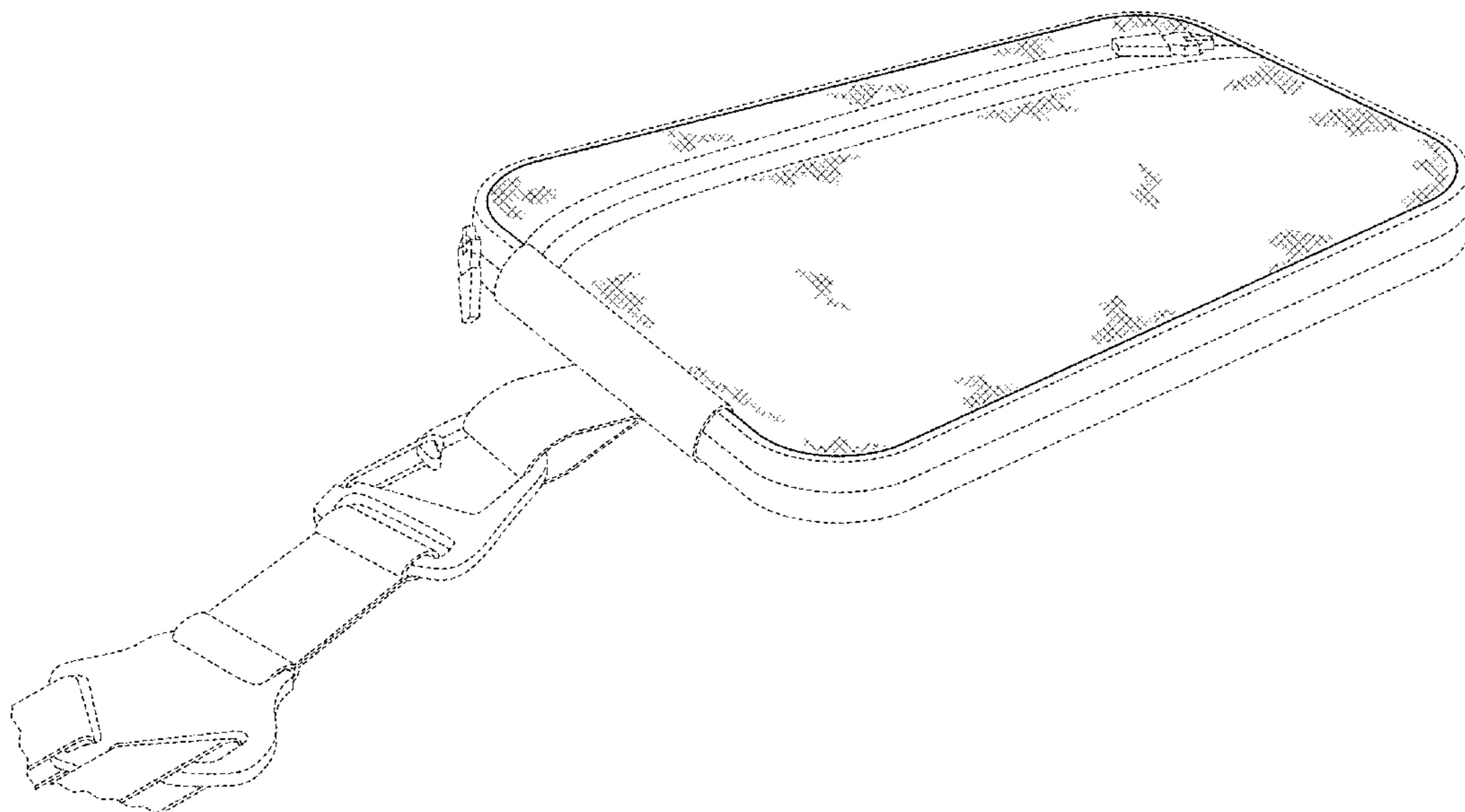

(57) **CLAIM**
The ornamental design for a satchel, as shown and described.

DESCRIPTION
FIG. 1 is an isometric view of a satchel in accordance with the present design;
FIG. 2 is a front elevational view of the satchel of FIG. 1;
FIG. 3 is a rear elevational view of the satchel of FIG. 1;
FIG. 4 is a left side elevational view of the satchel of FIG. 1;
FIG. 5 is a right side elevational view of the satchel of FIG. 1;
FIG. 6 is a top plan view of the satchel of FIG. 1;
FIG. 7 is a bottom plan view of the satchel of FIG. 1; and,
FIG. 8 is an isometric view of the satchel of FIG. 1, showing how a strap may be connected to the satchel.

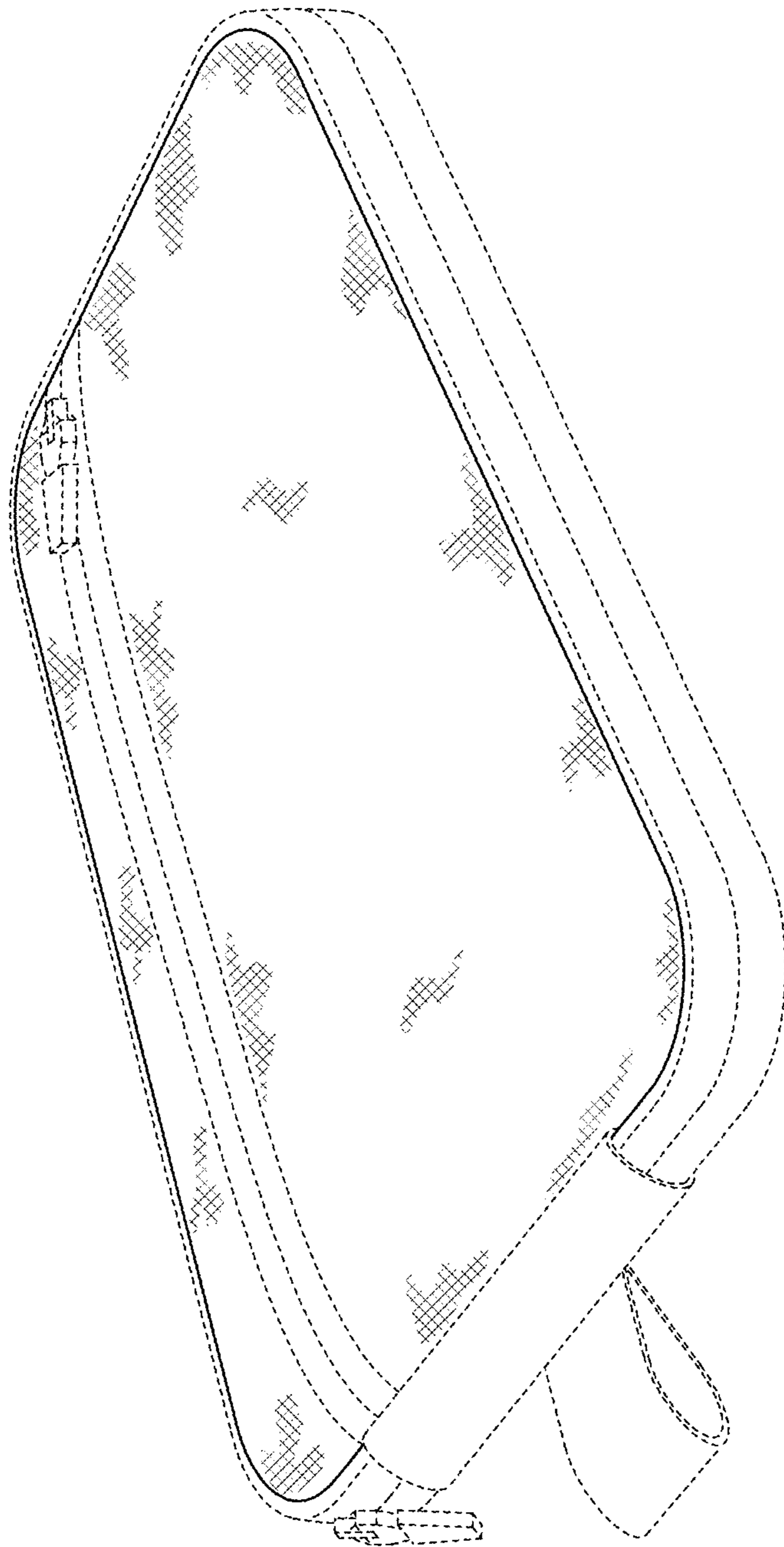

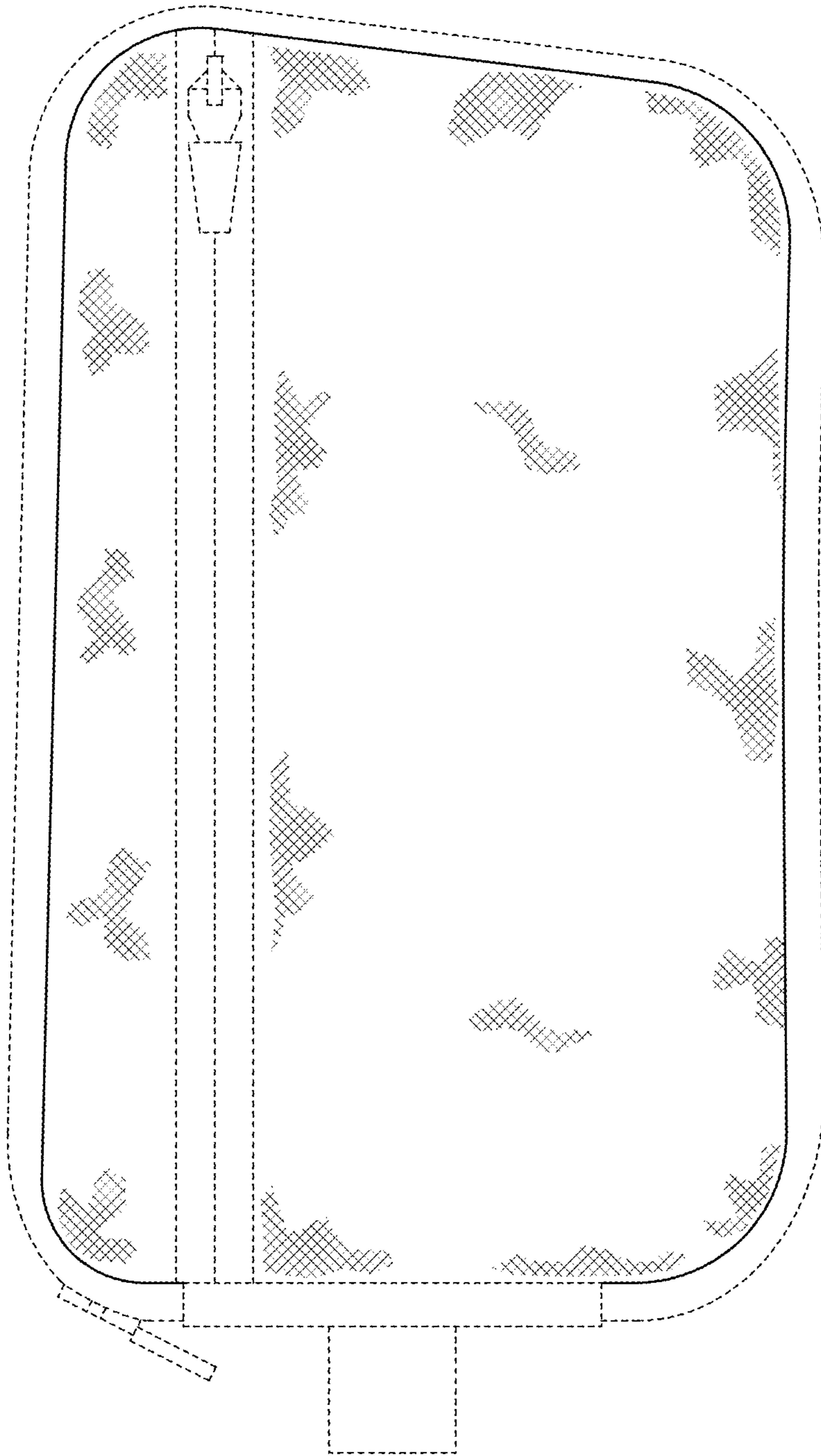

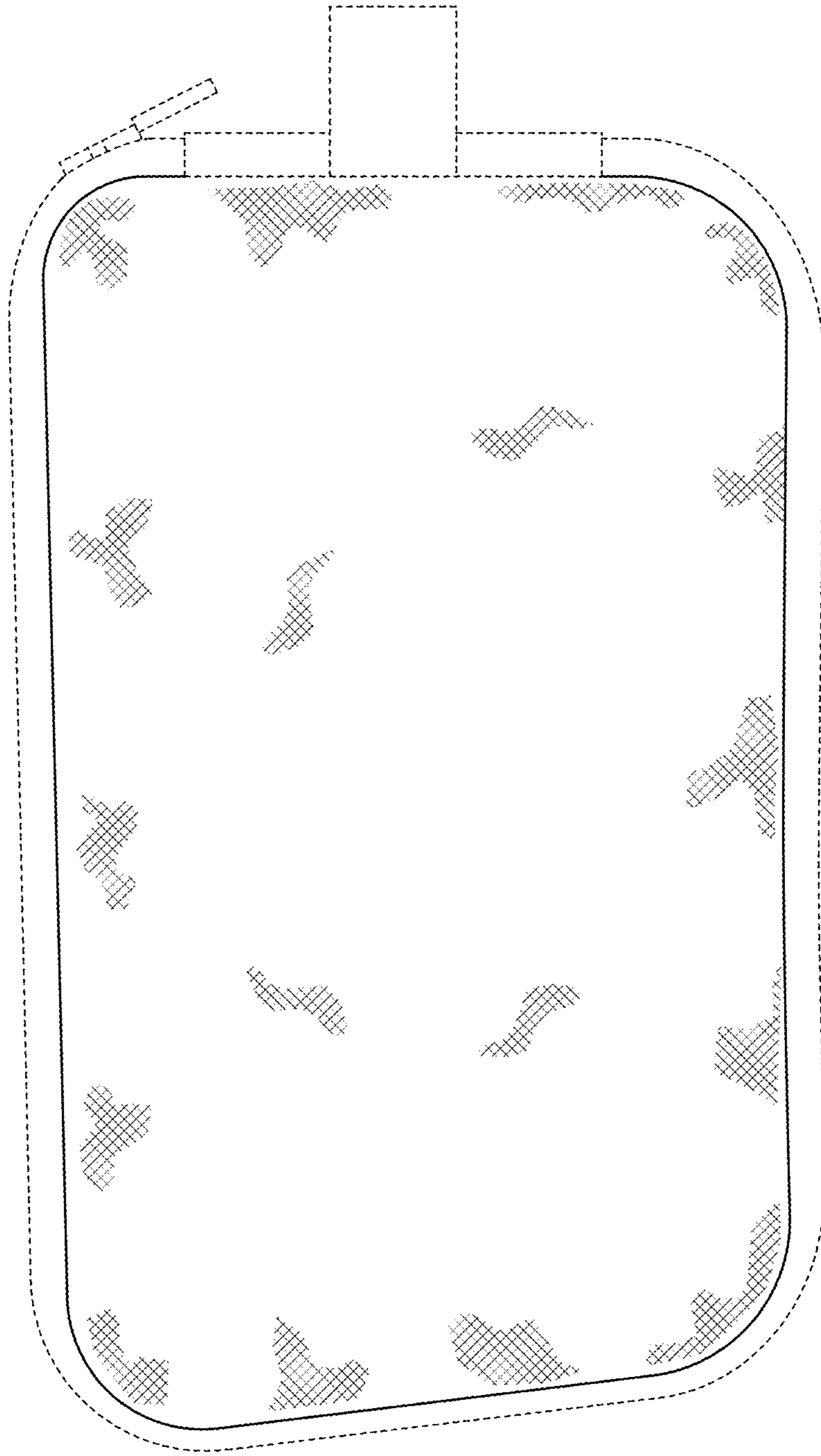

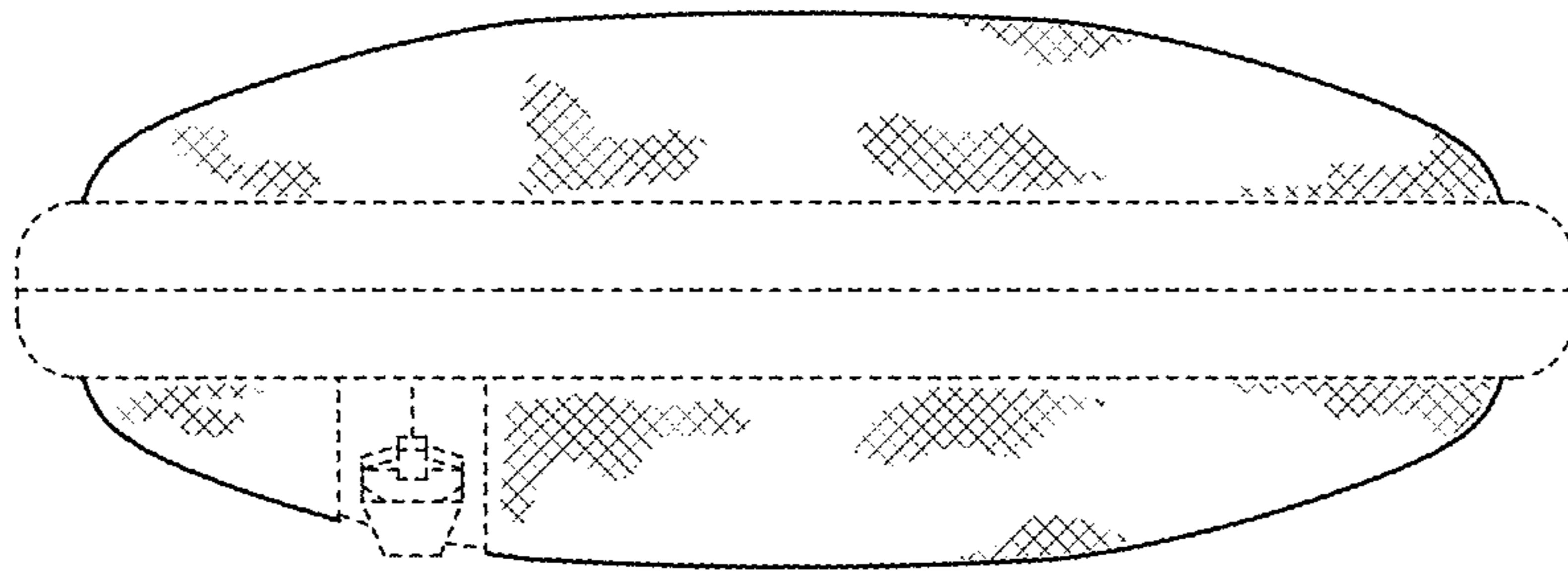

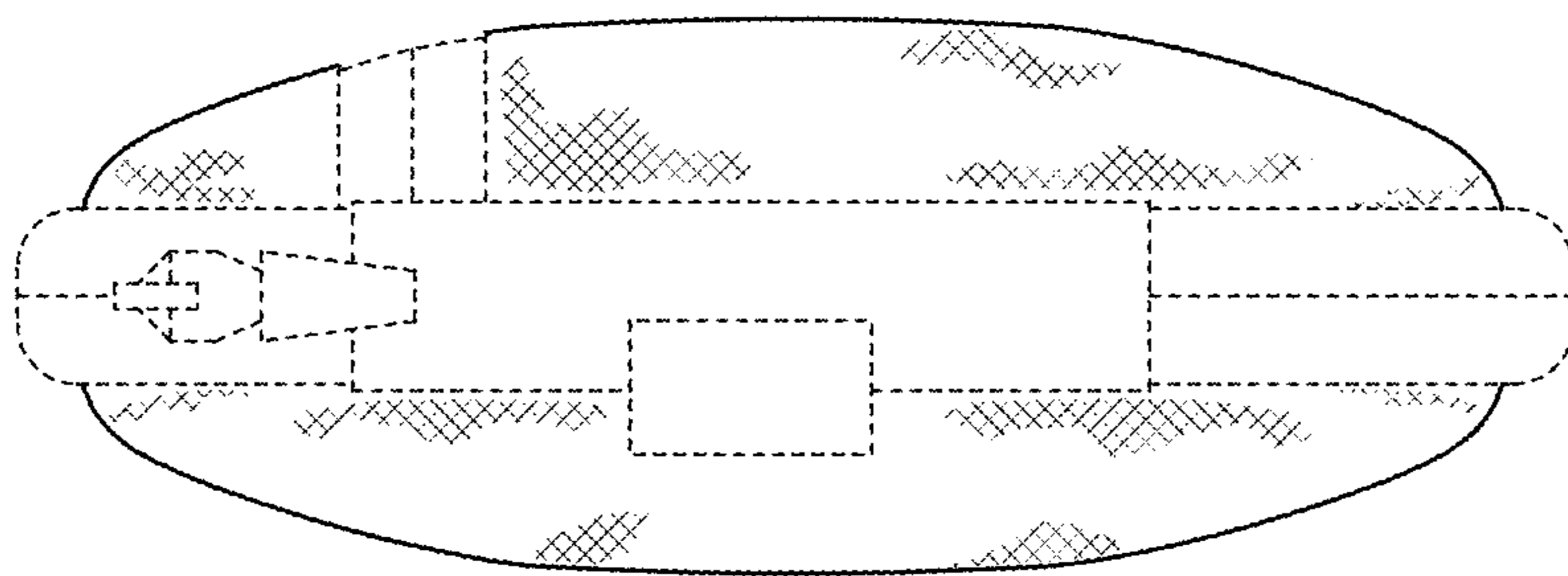

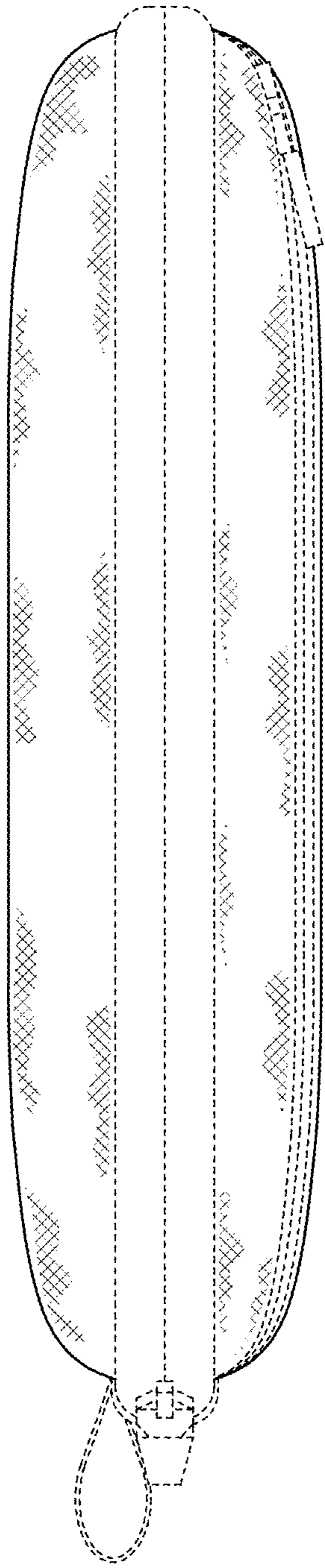

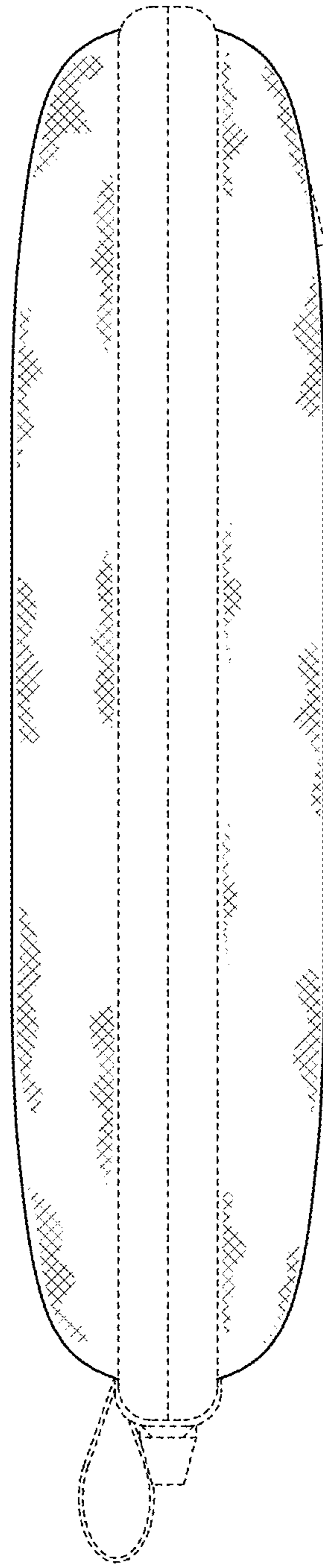

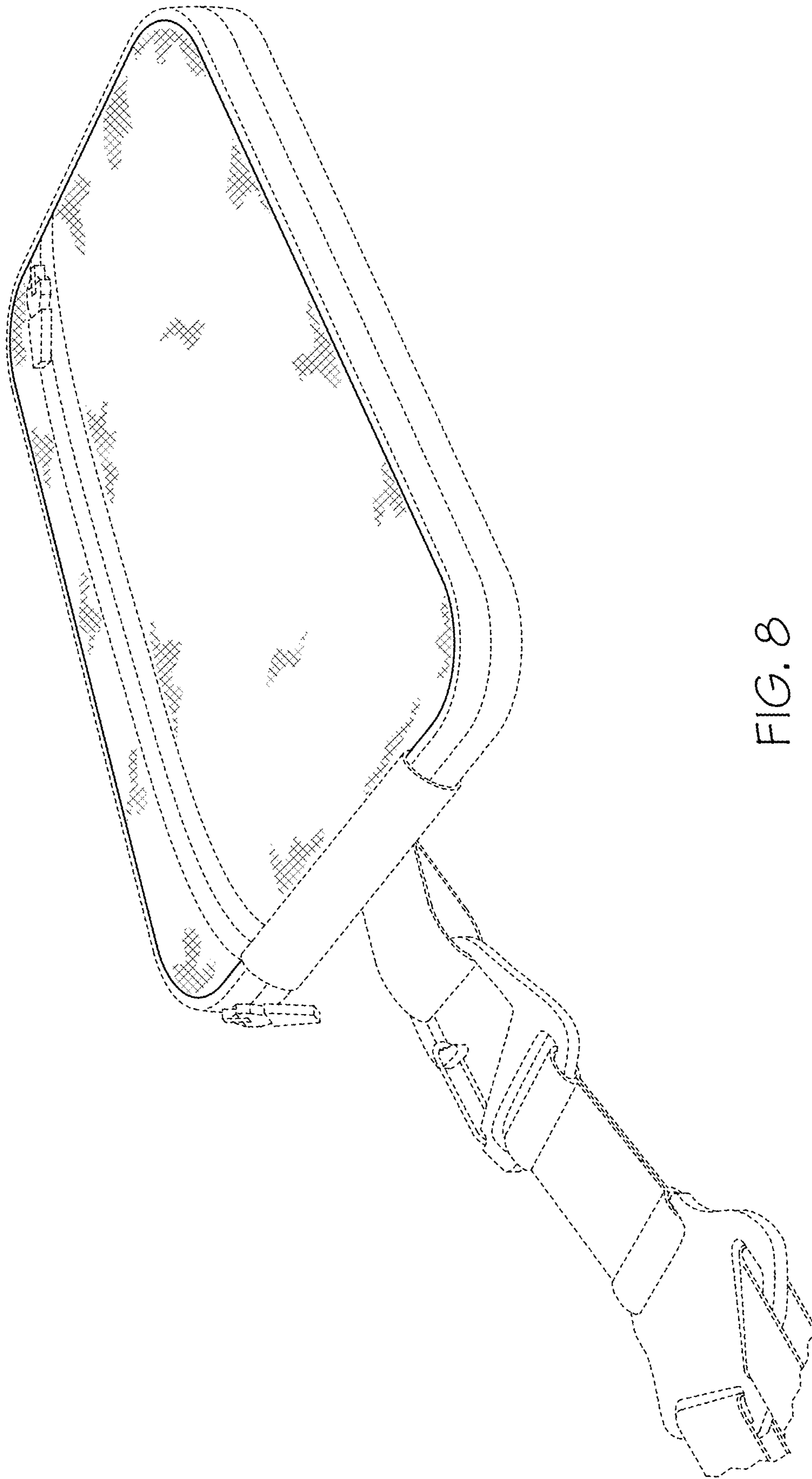
