DESCRIPTION

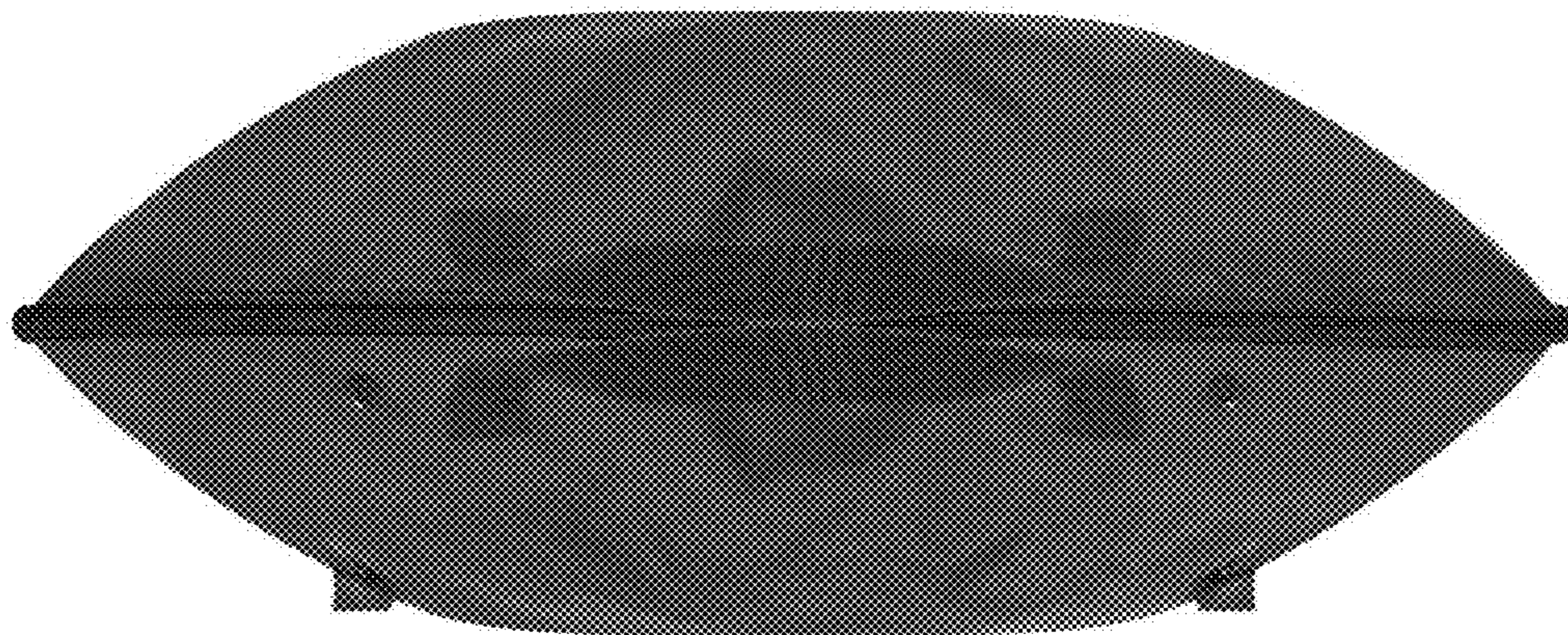
