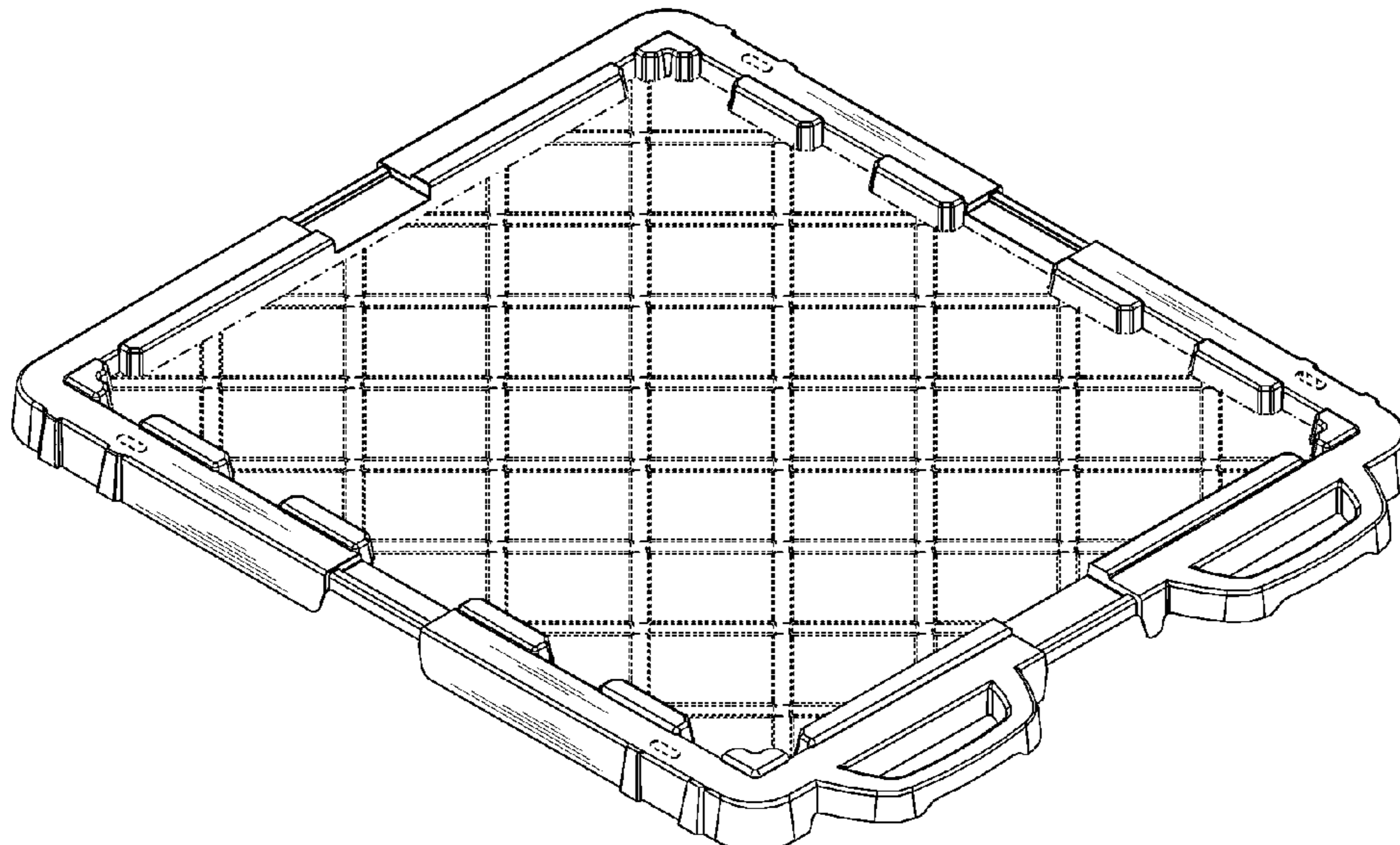
(57) **CLAIM**

The ornamental design for a lid for extra large tote with wheels, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a lid for extra large tote with wheels;  
FIG. 2 is a front elevational view of the lid for extra large tote with wheels shown in FIG. 1;  
FIG. 3 left side elevational view thereof;  
FIG. 4 is a top plan view thereof; and,  
FIG. 5 is a rear elevational view thereof.  
A right side elevational view of the lid for extra large tote with wheels is not shown because it is a mirror image of the left side elevational view of the lid for extra large tote with wheels that is shown in FIG. 3. The dash-dot-dash broken lines in the drawings depict the claim boundary. Any portions of the article inside of the claim boundary form no part of the claimed design. The evenly dashed broken lines depict portions of the article and form no part of the claim. The bottom portion of the lid for extra large tote with wheels which is not shown in the drawings or described in the specification forms no part of the claim.

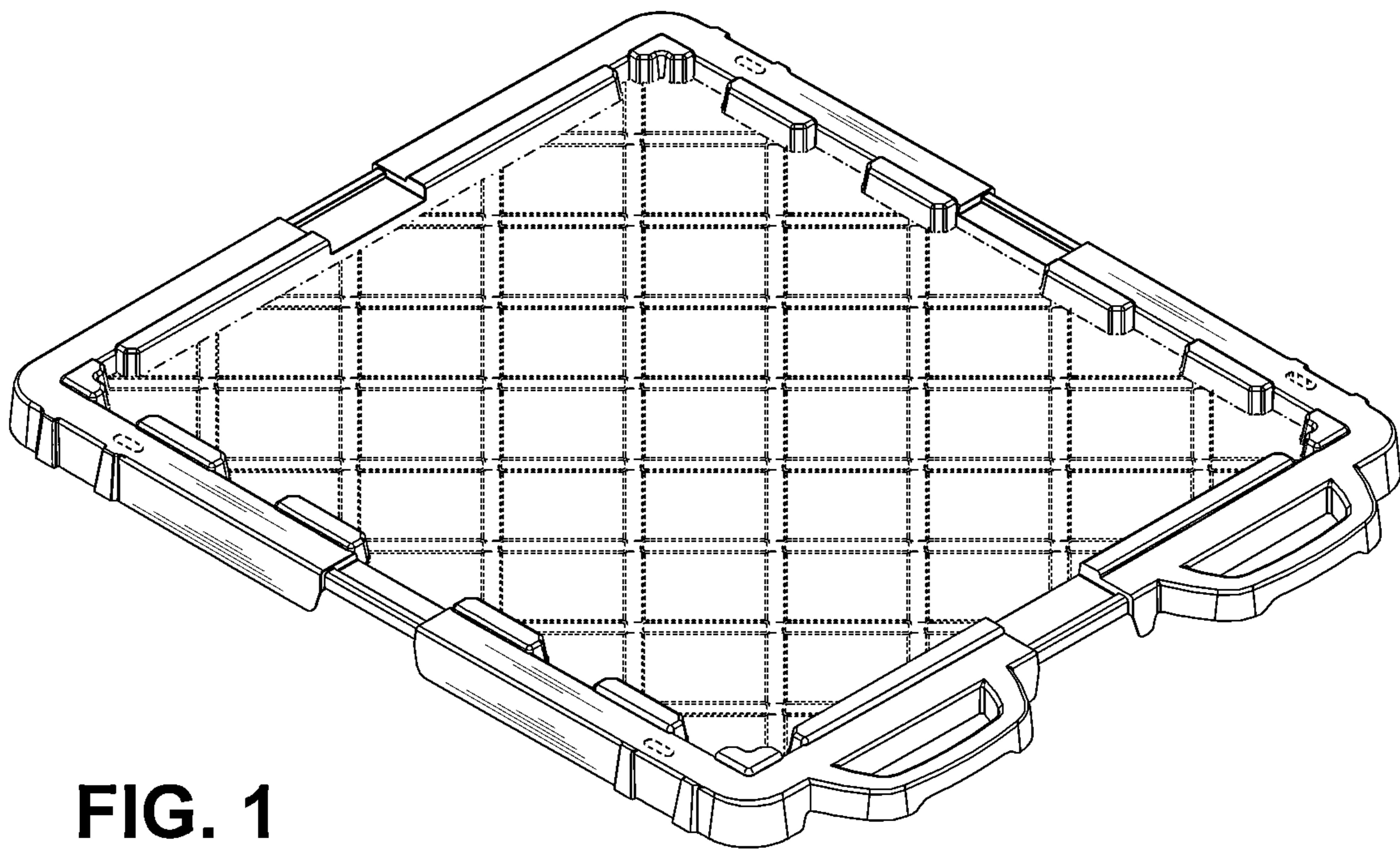

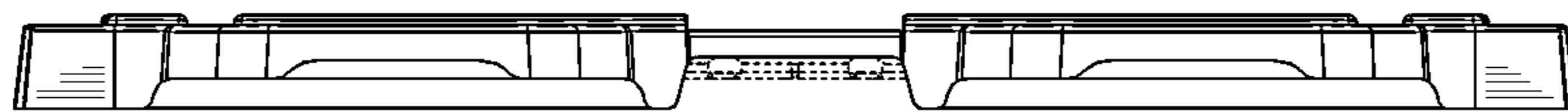

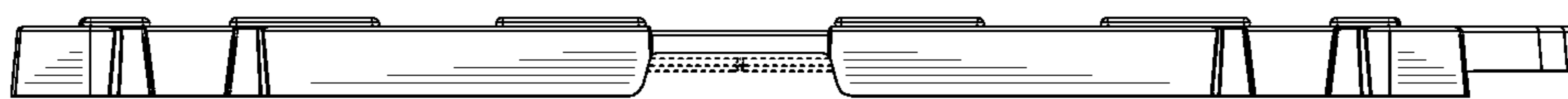

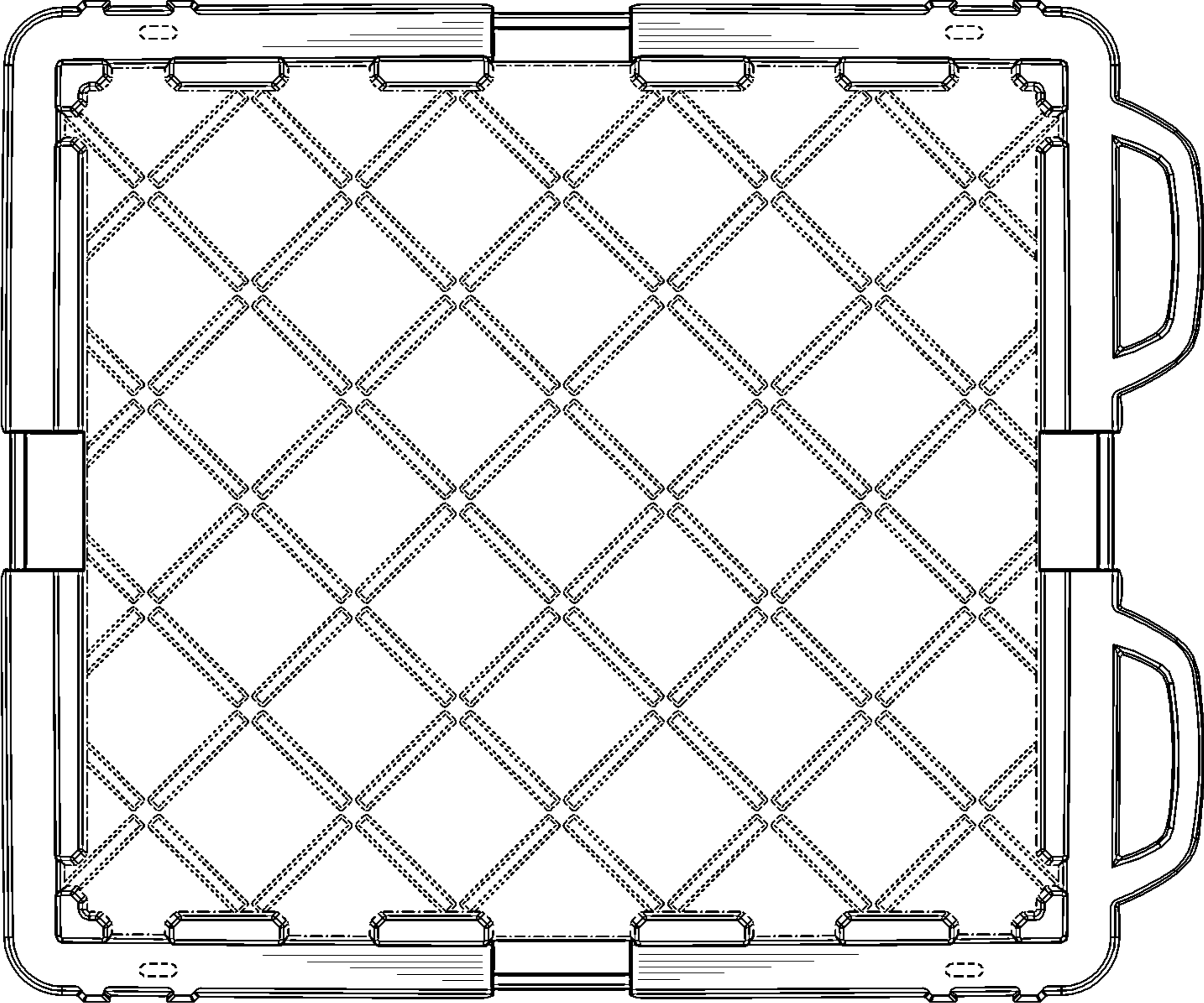

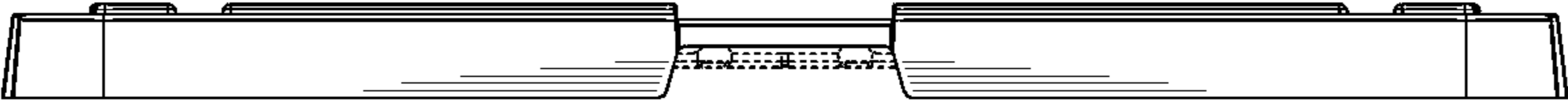
