The ornamental design for an automatic vending machine for hot beverages, as shown and described.

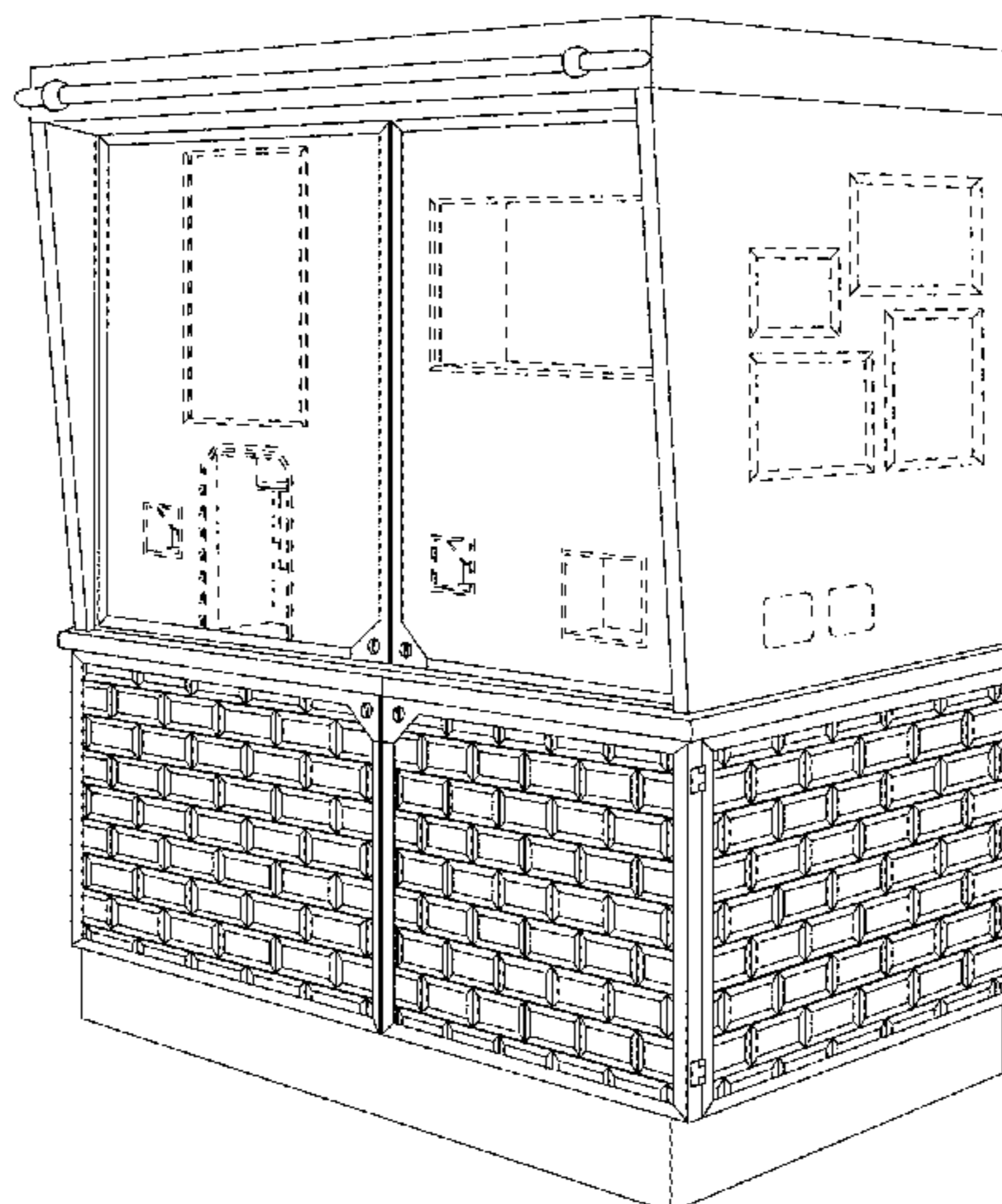
DESCRIPTION

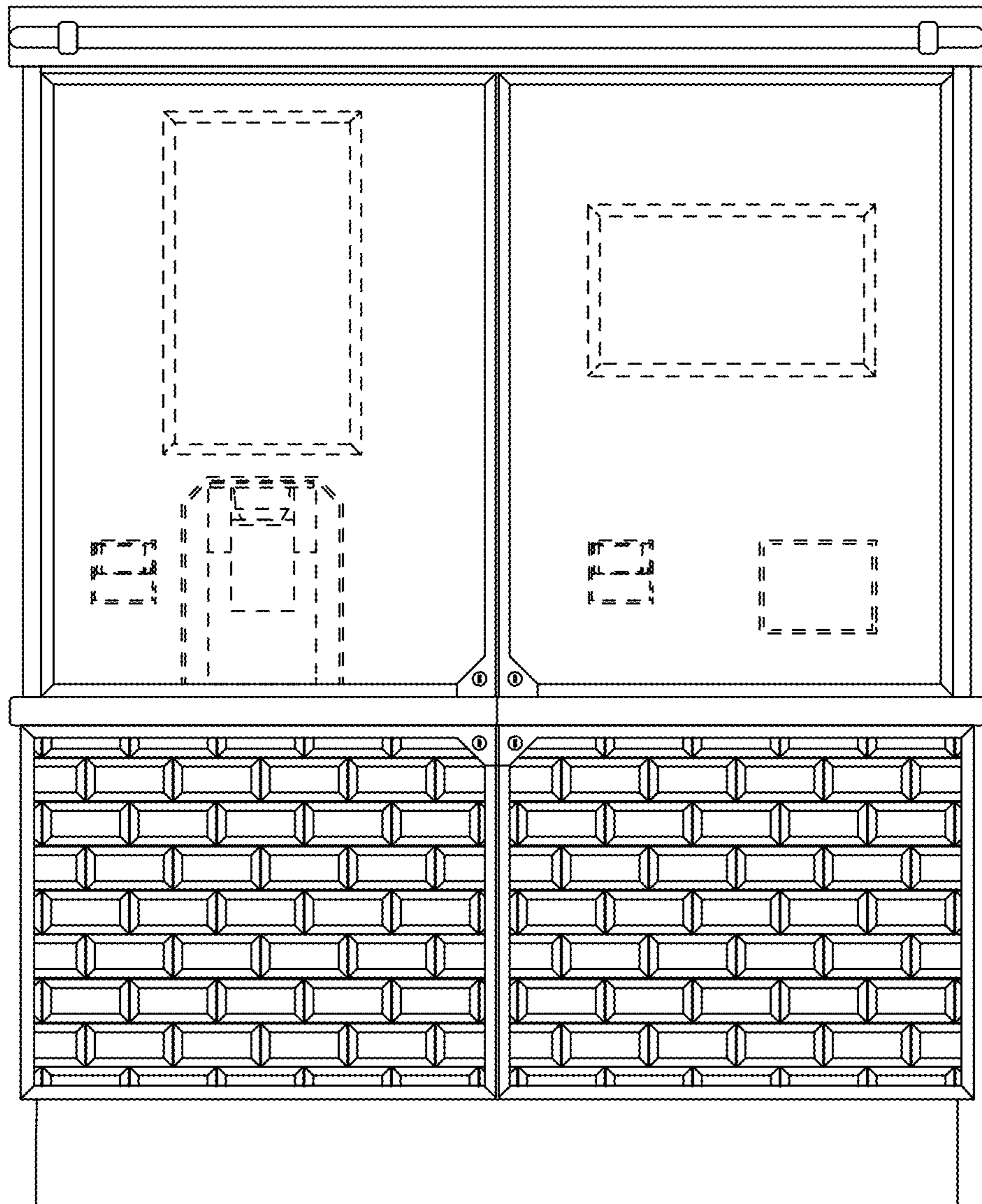

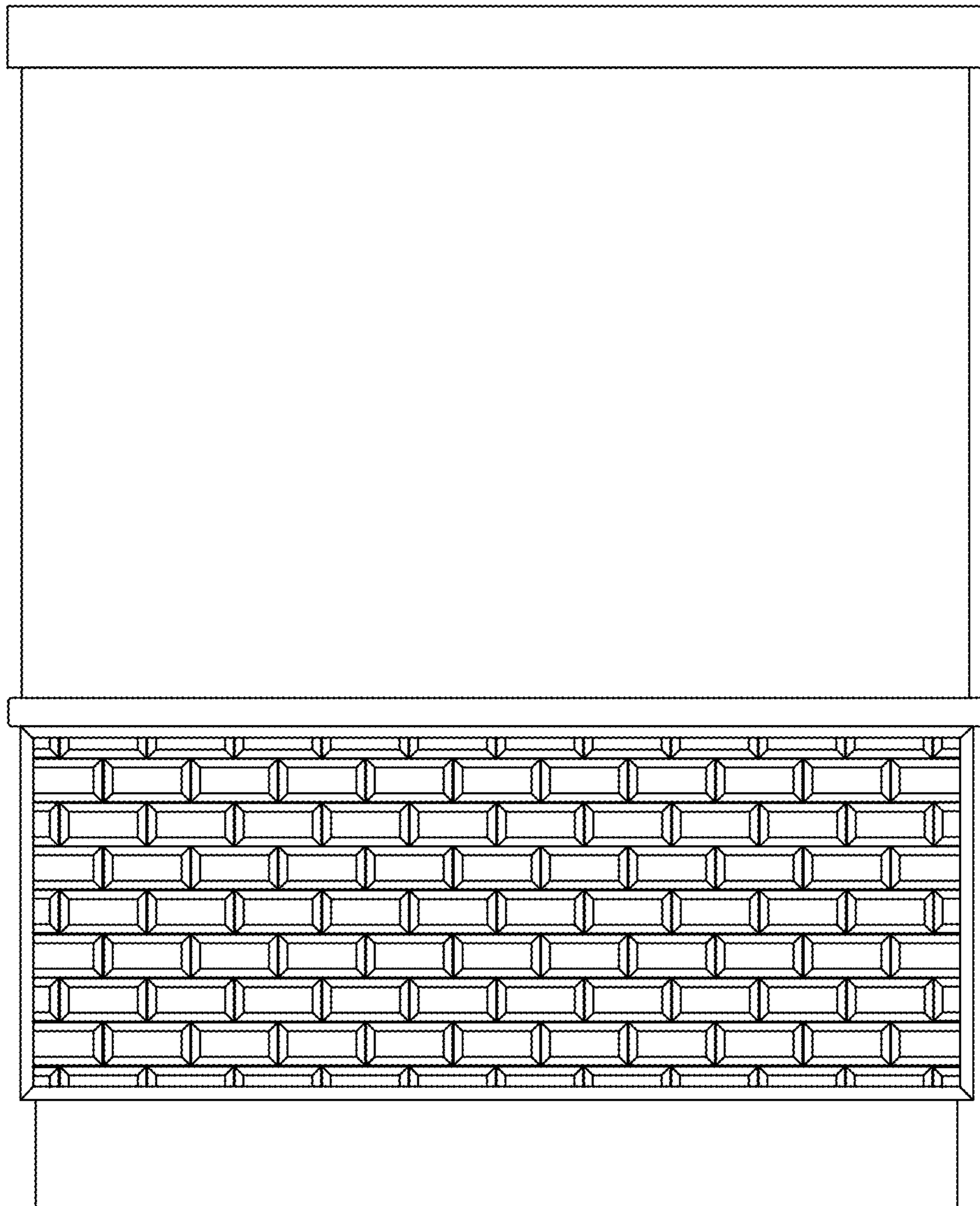

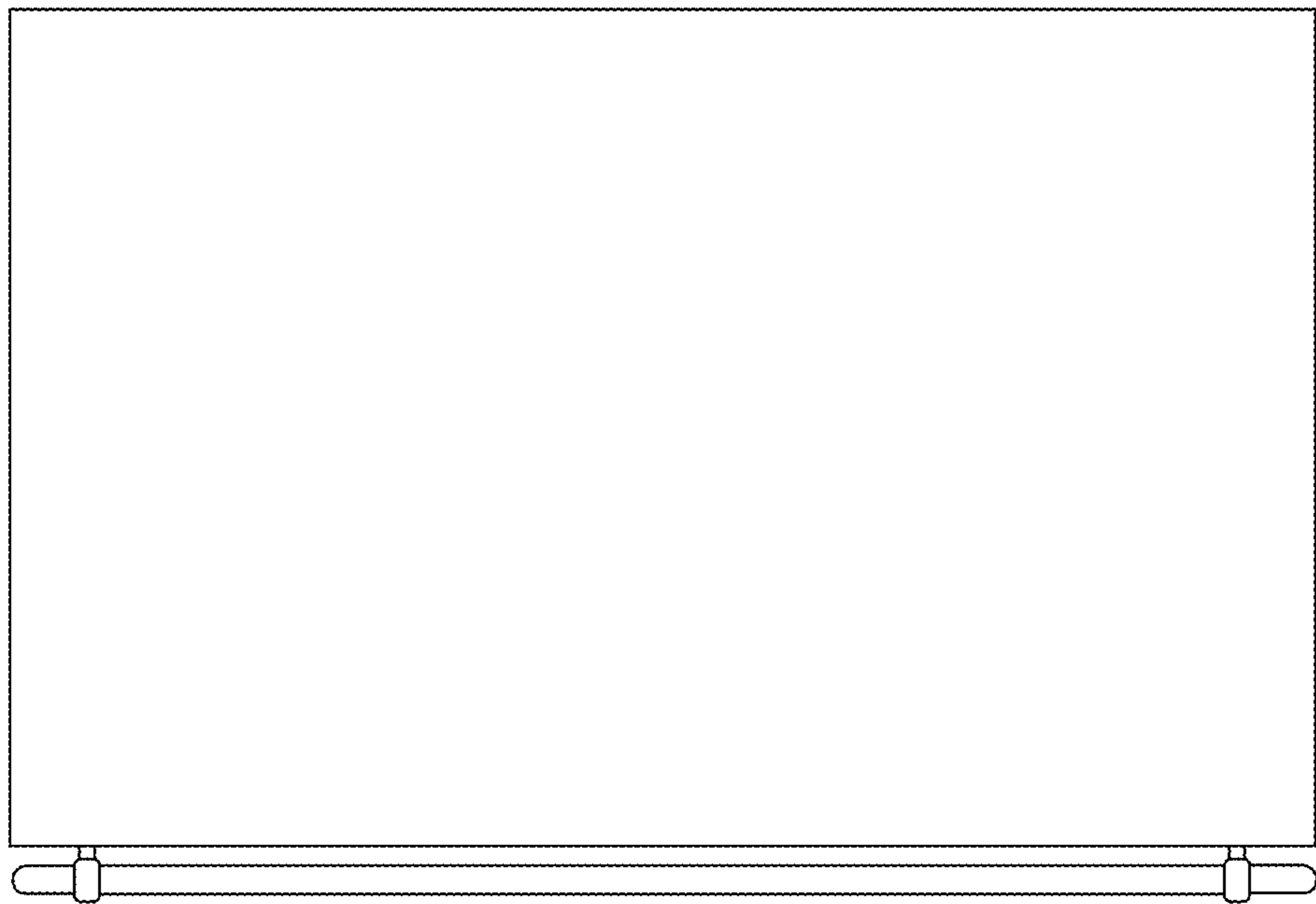

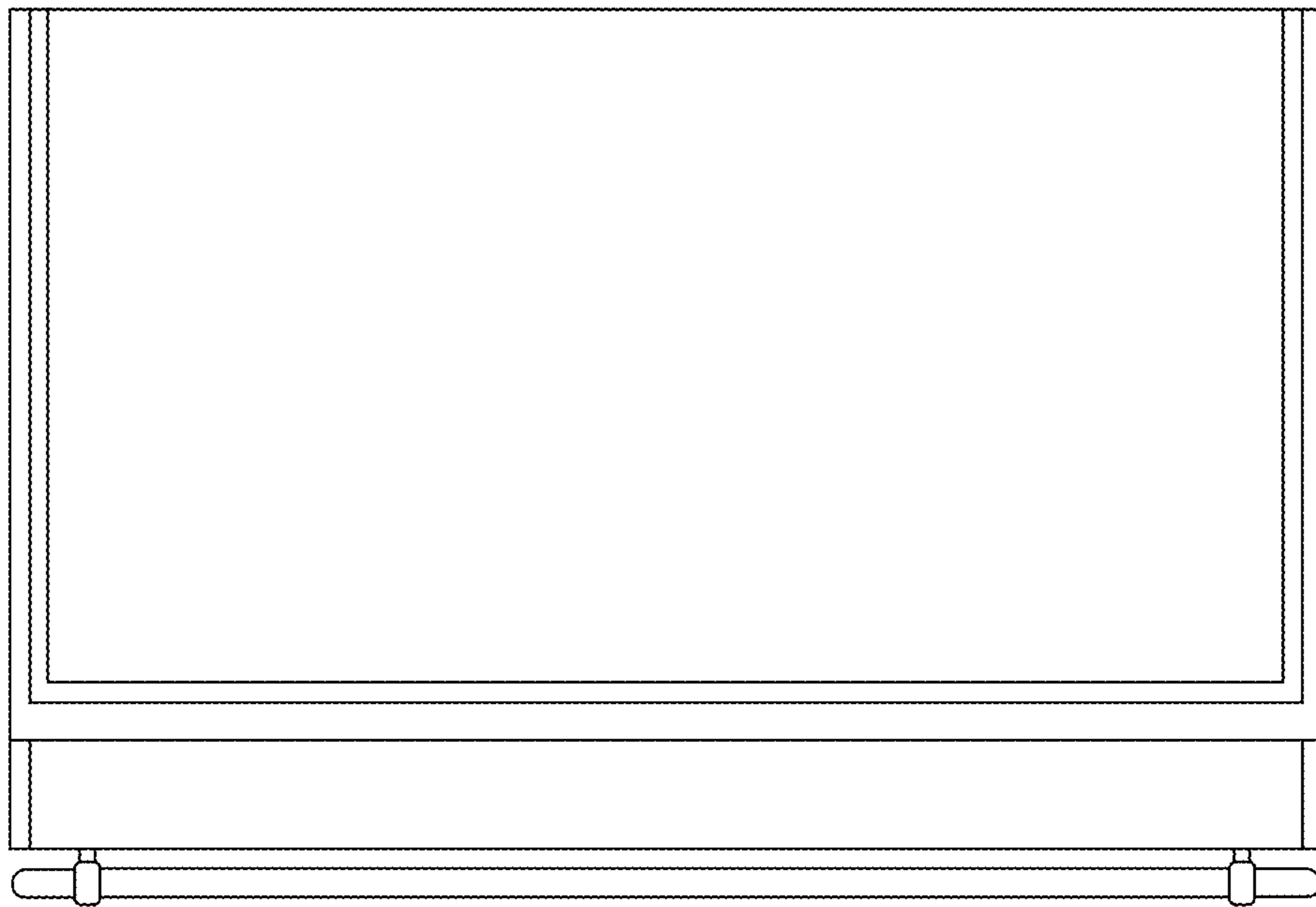

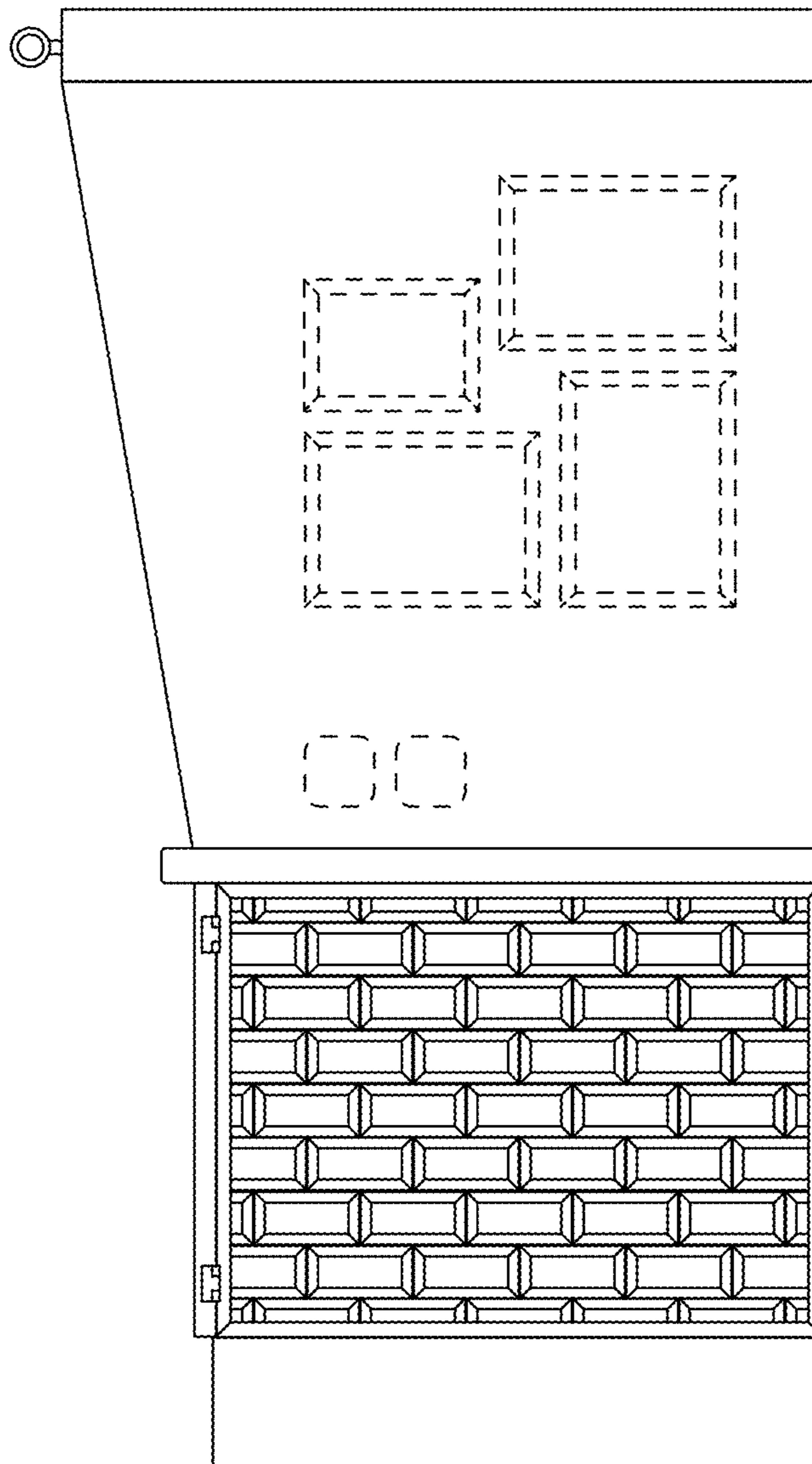

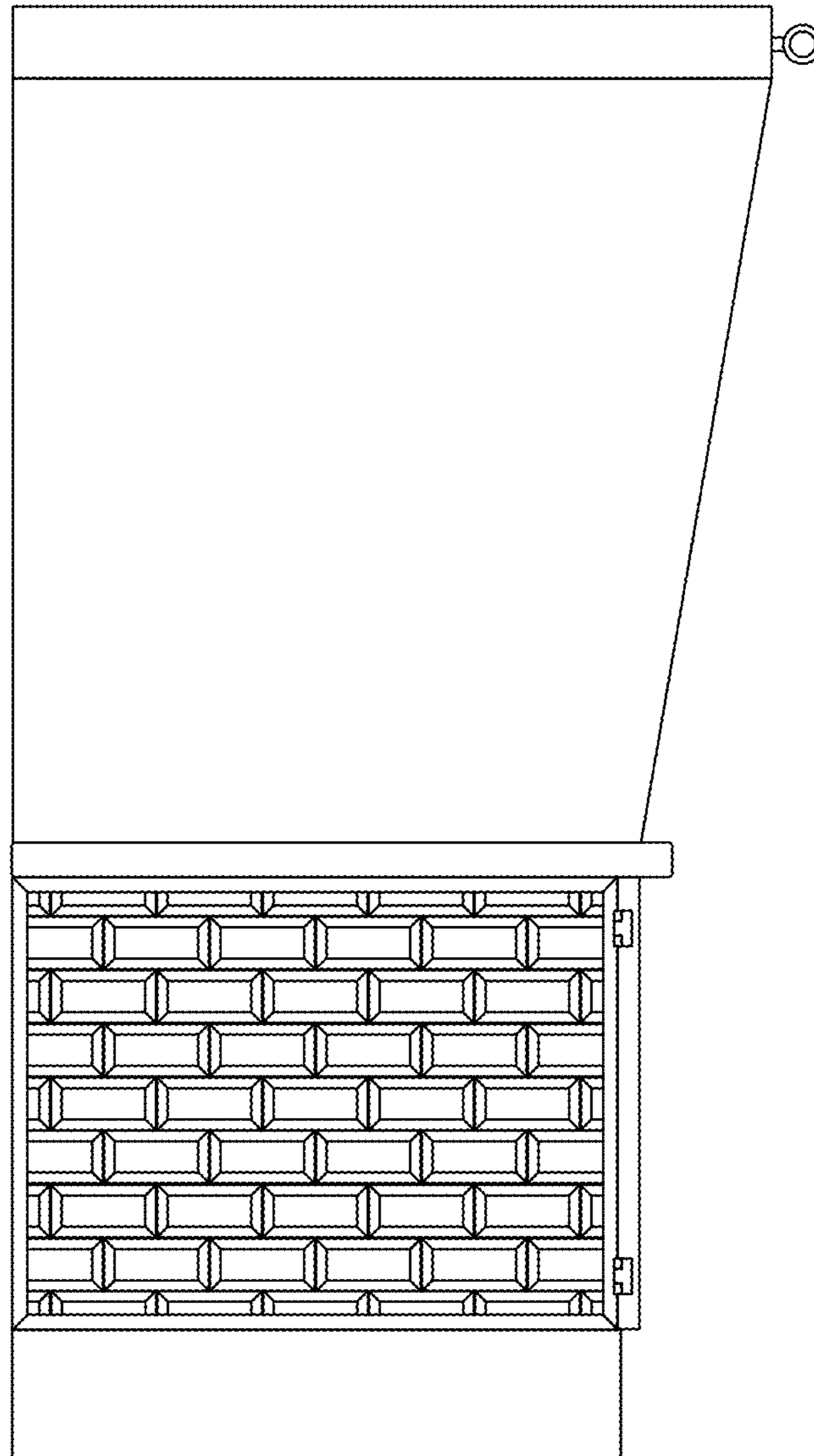
